(57) **CLAIM**

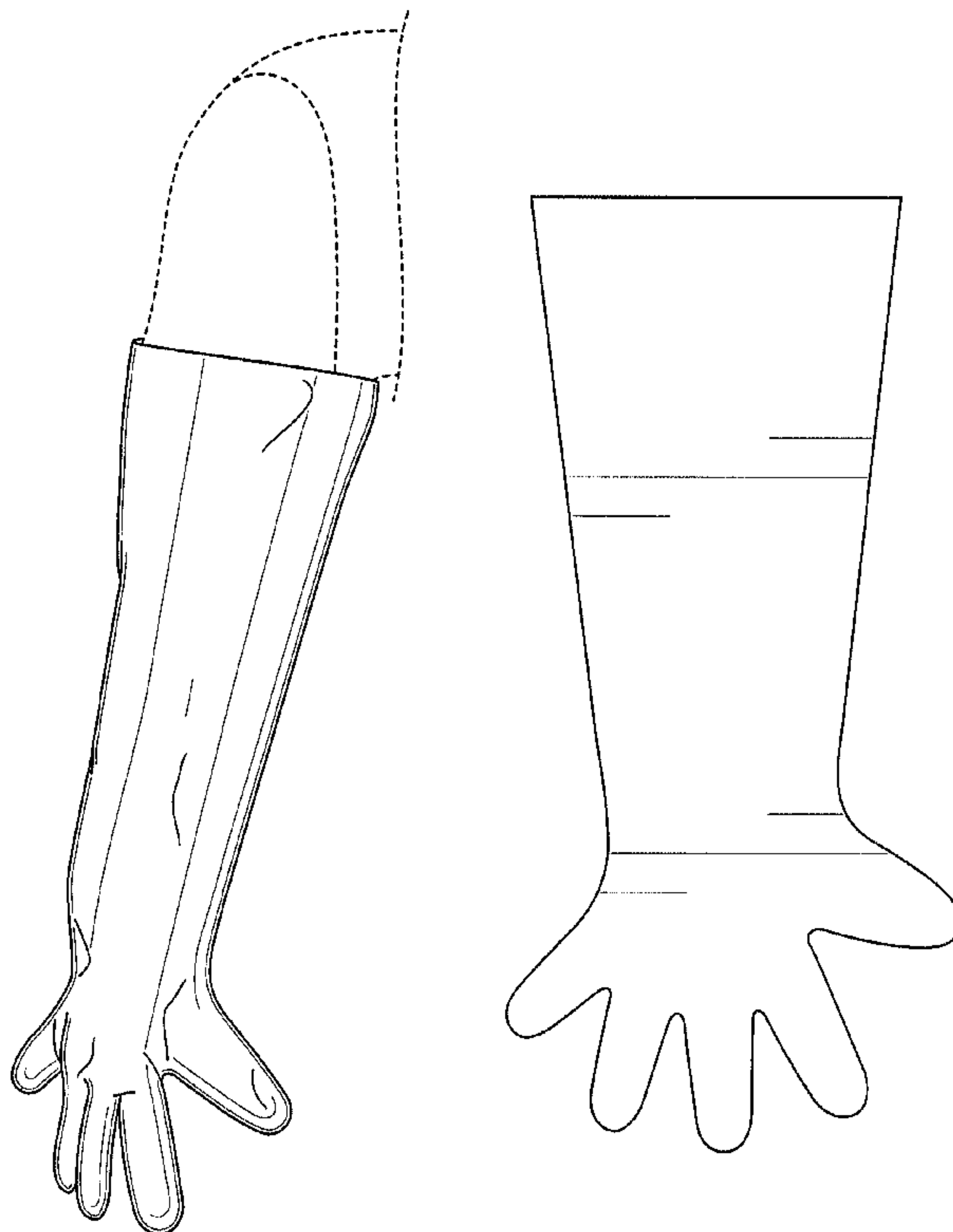
The ornamental design for a pet waste disposal glove, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the left-hand pet waste disposal glove on man's hand, showing the new design; FIG. 2 is a side view of the left-hand pet waste disposal glove on man's hand; FIG. 3 is a top view of the left-hand pet waste disposal glove on man's hand; FIG. 4 is a top view of the right-hand pet waste disposal glove on man's hand; FIG. 5 is a rear view of the right-hand pet waste disposal glove on man's hand; FIG. 6 is a front view of the right-hand pet waste disposal glove on man's hand; and, FIG. 7 is a top view of the left-hand pet waste disposal glove without man's hand.

The broken lines showing the human form in FIGS. 1-6 are included for the purpose of illustrating the design in use and form no part of the claimed design.

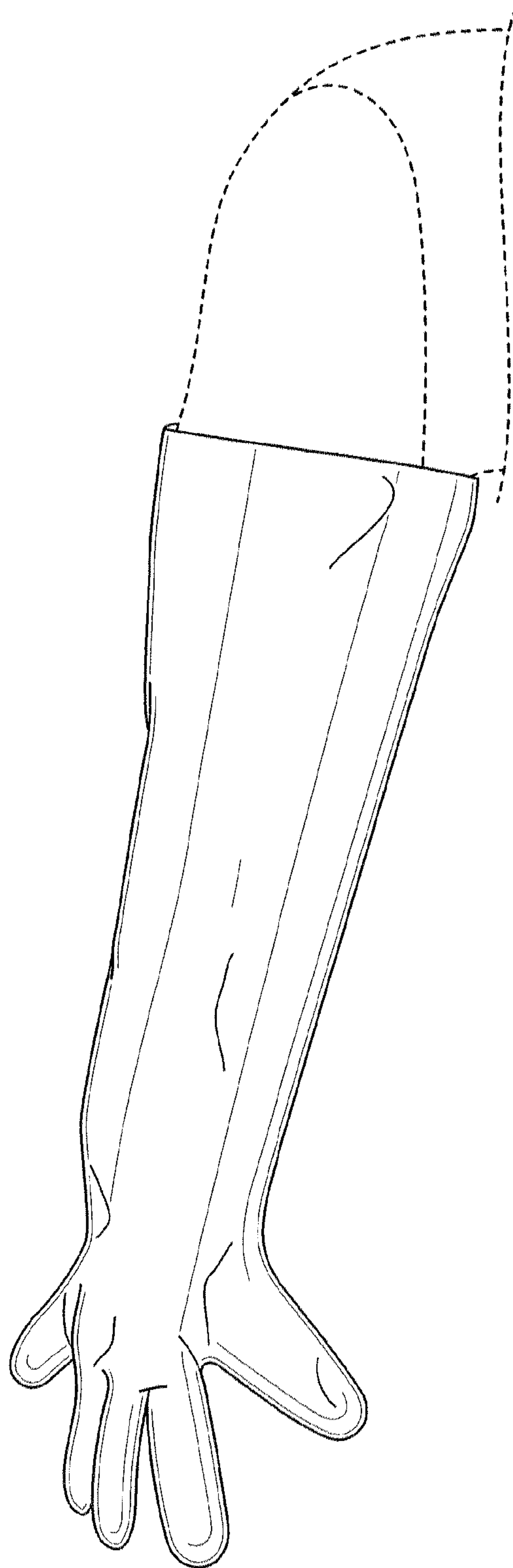

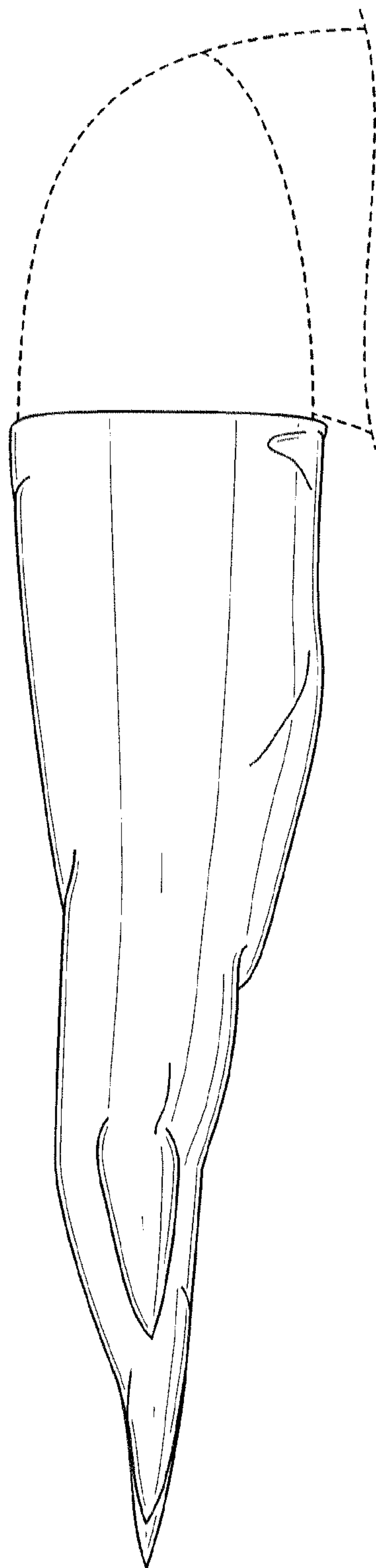

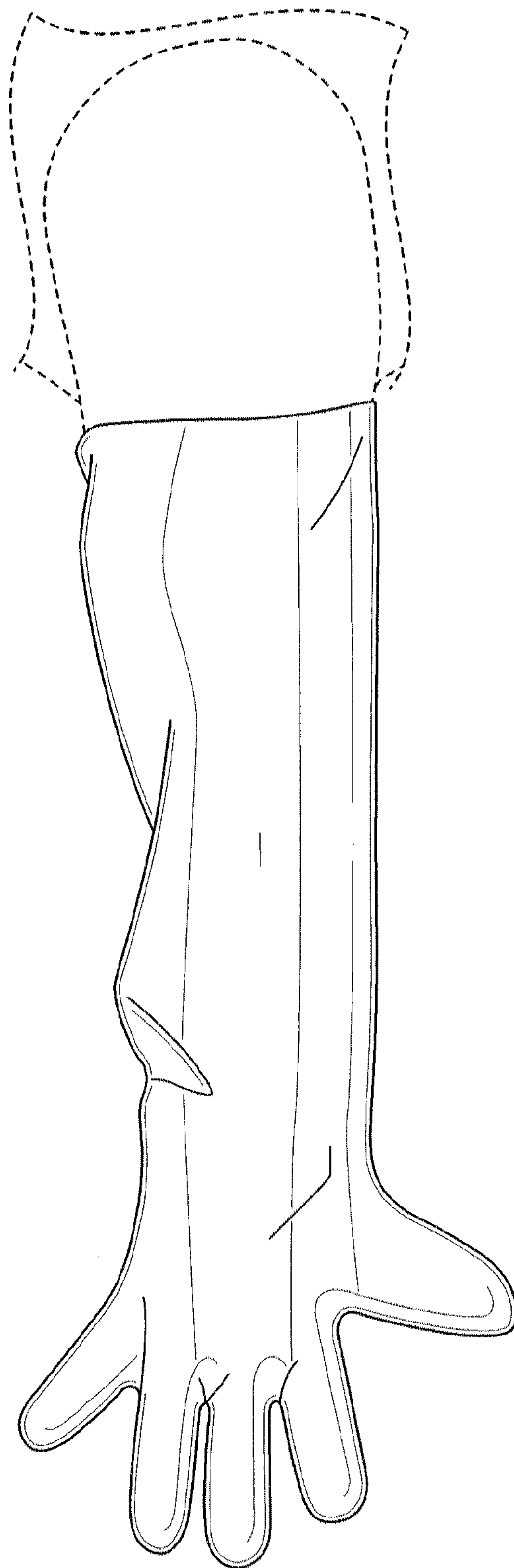

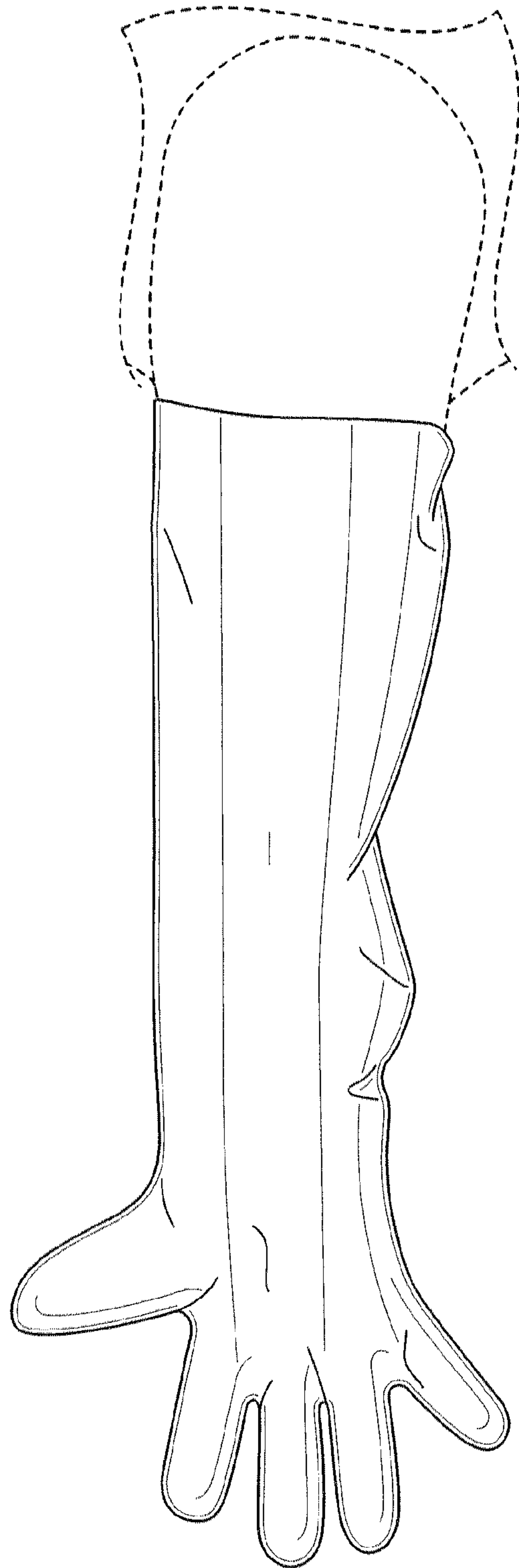

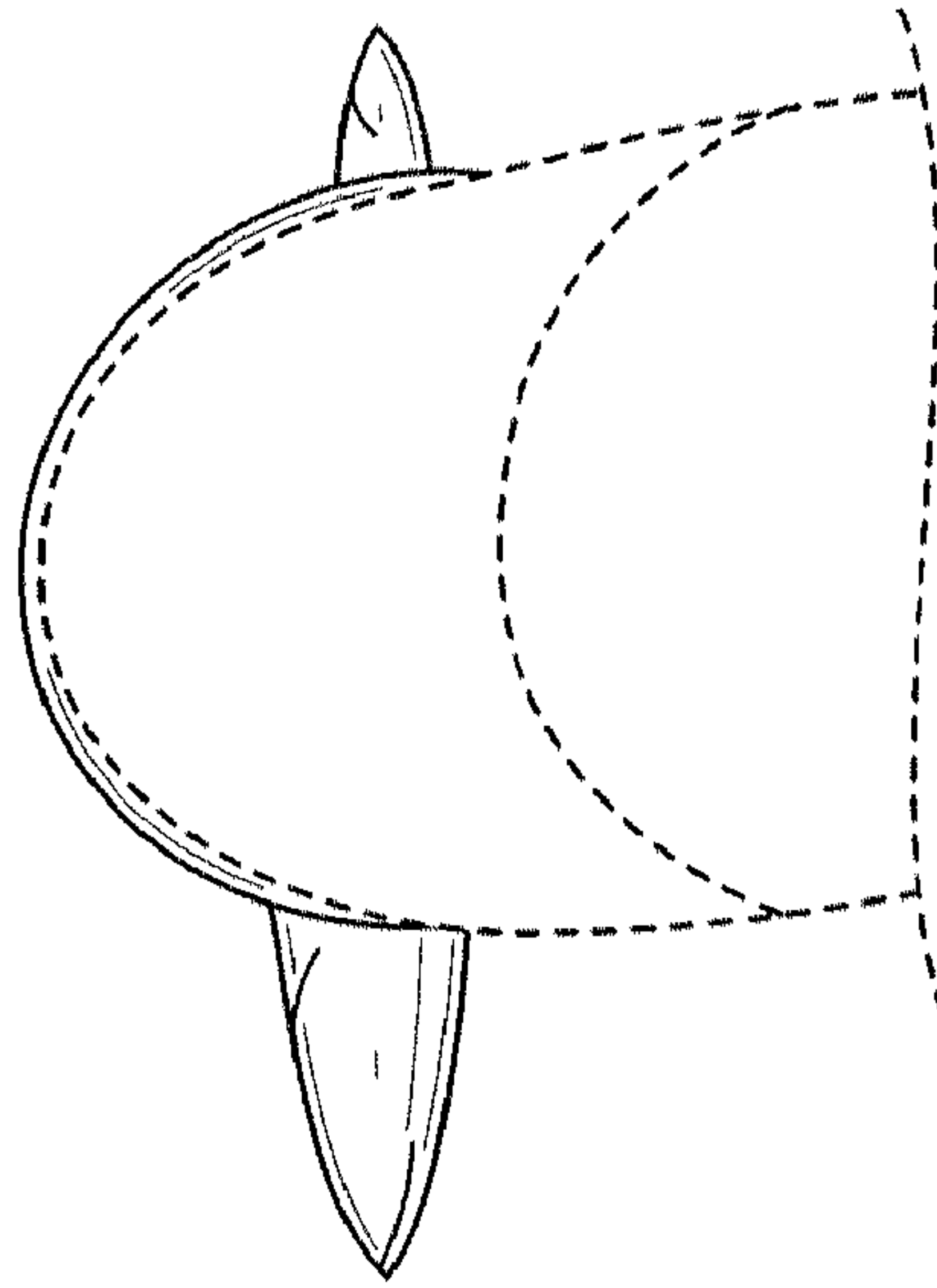

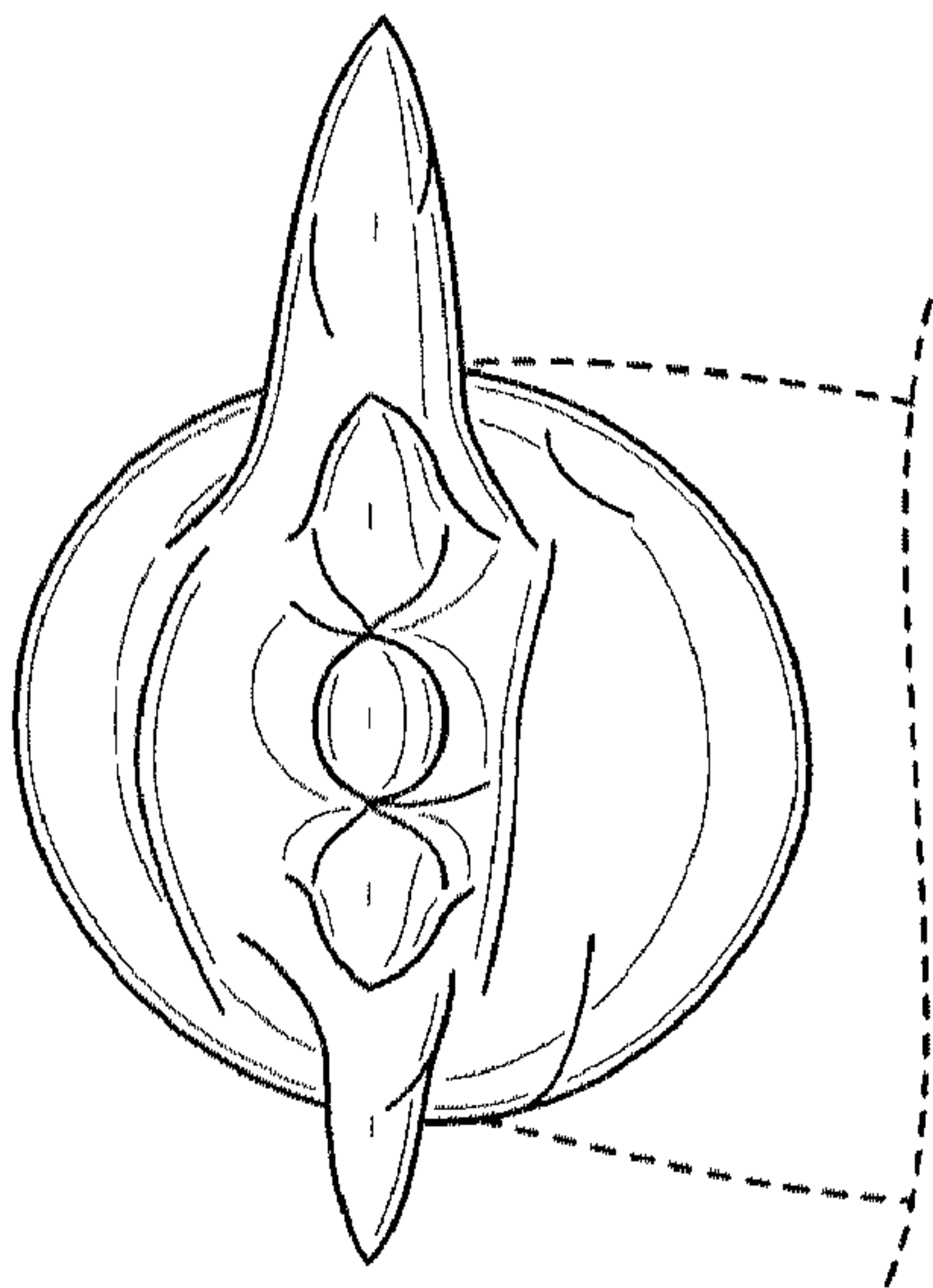

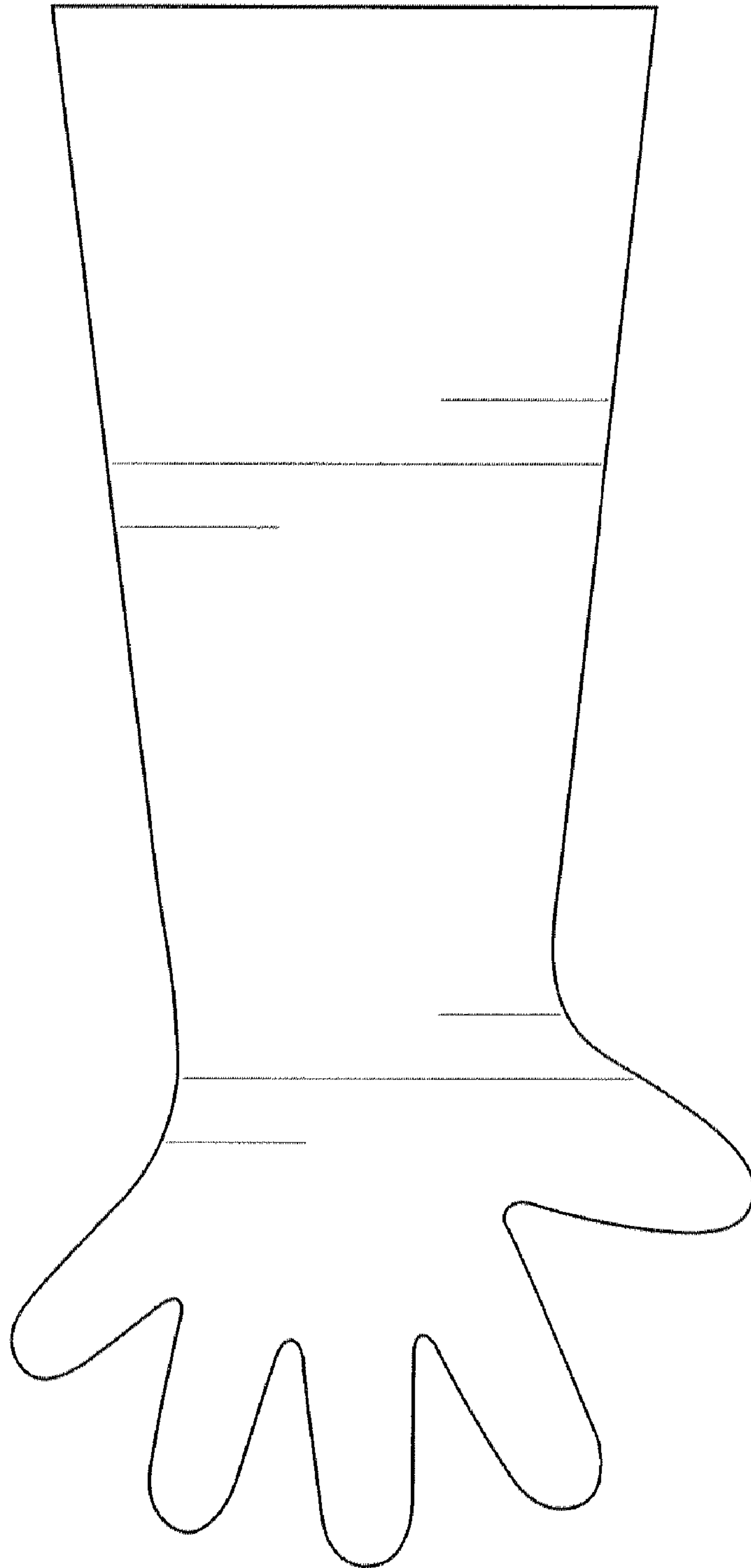
