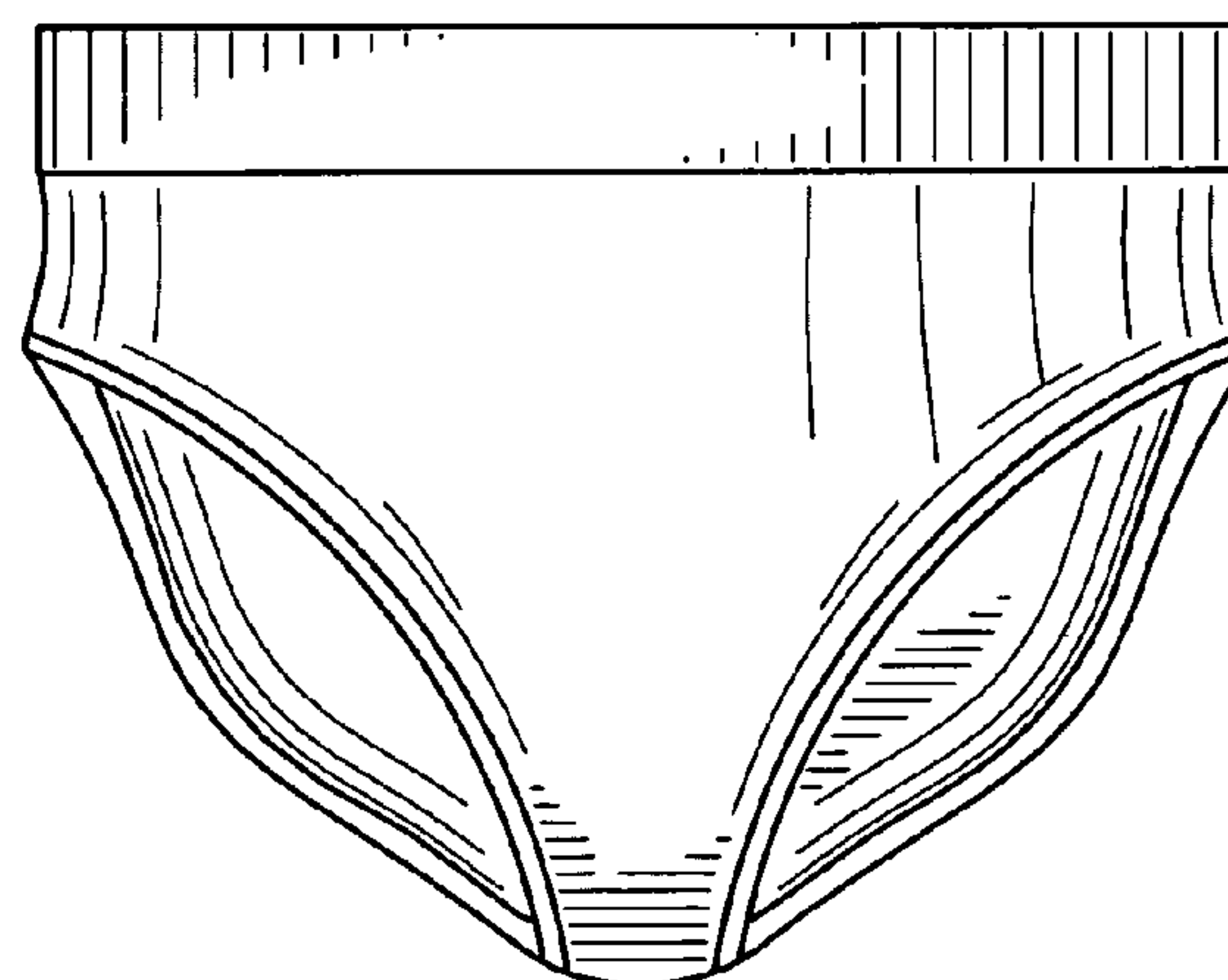
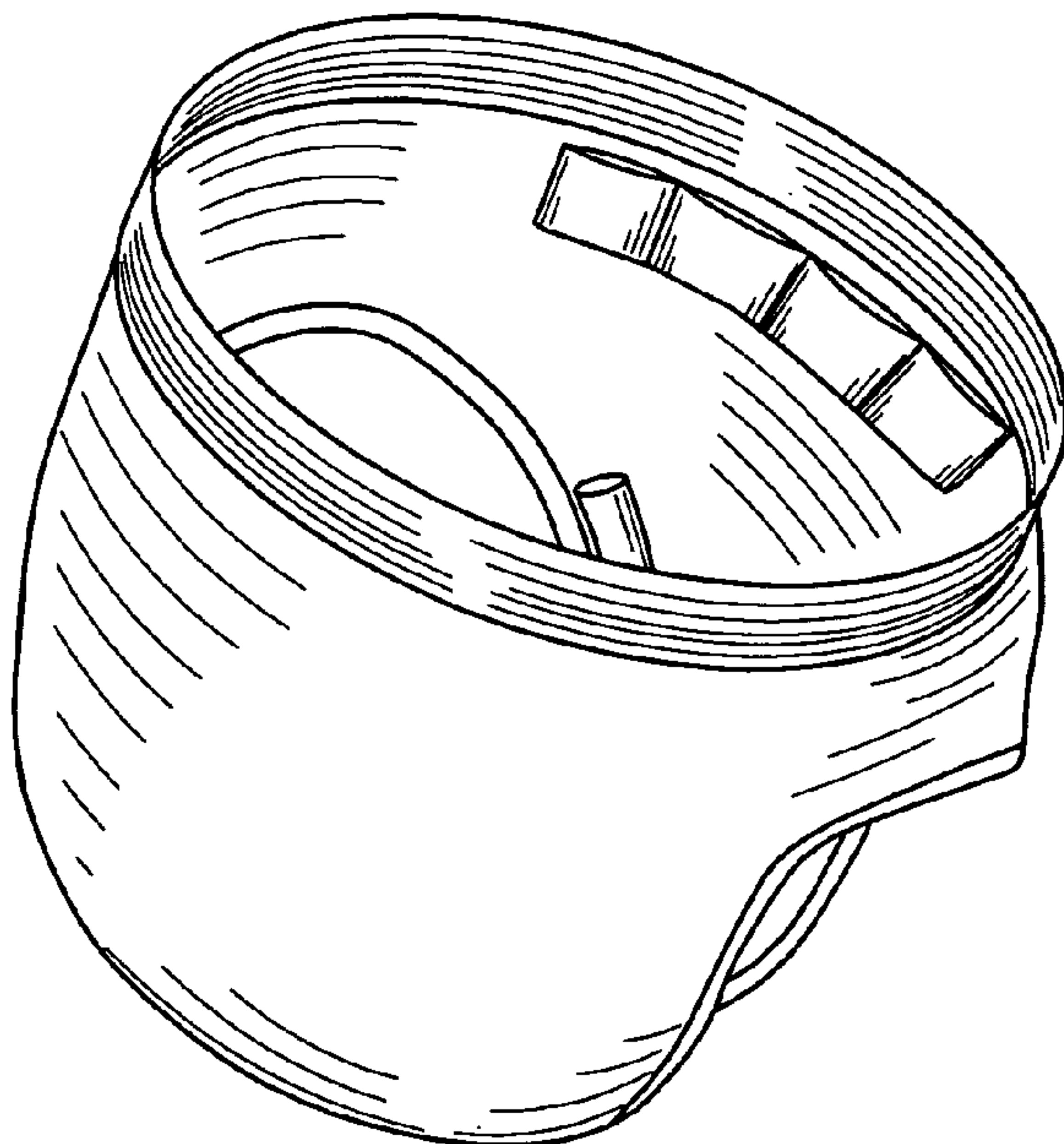
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a women's panty with pockets showing our new design;

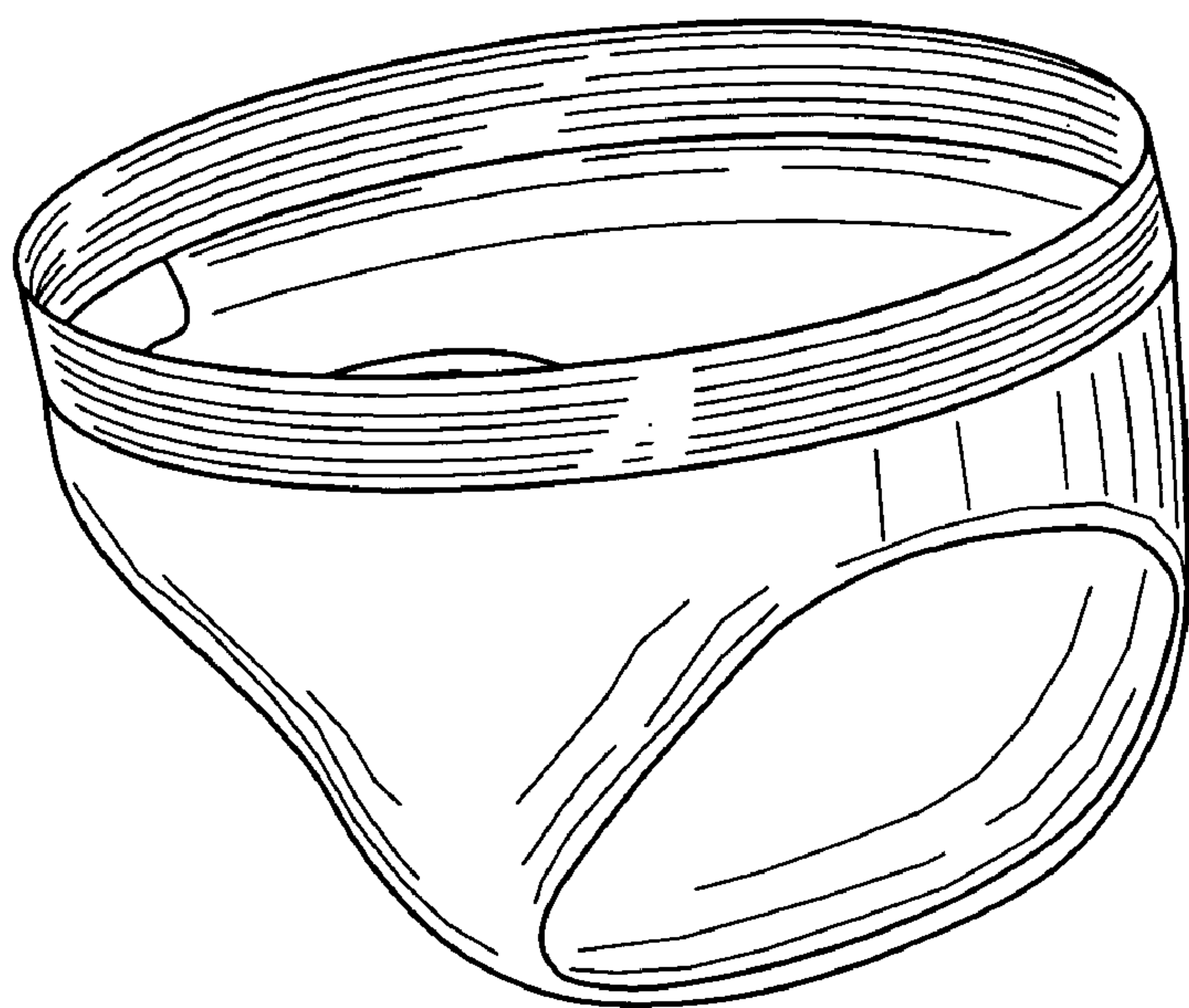

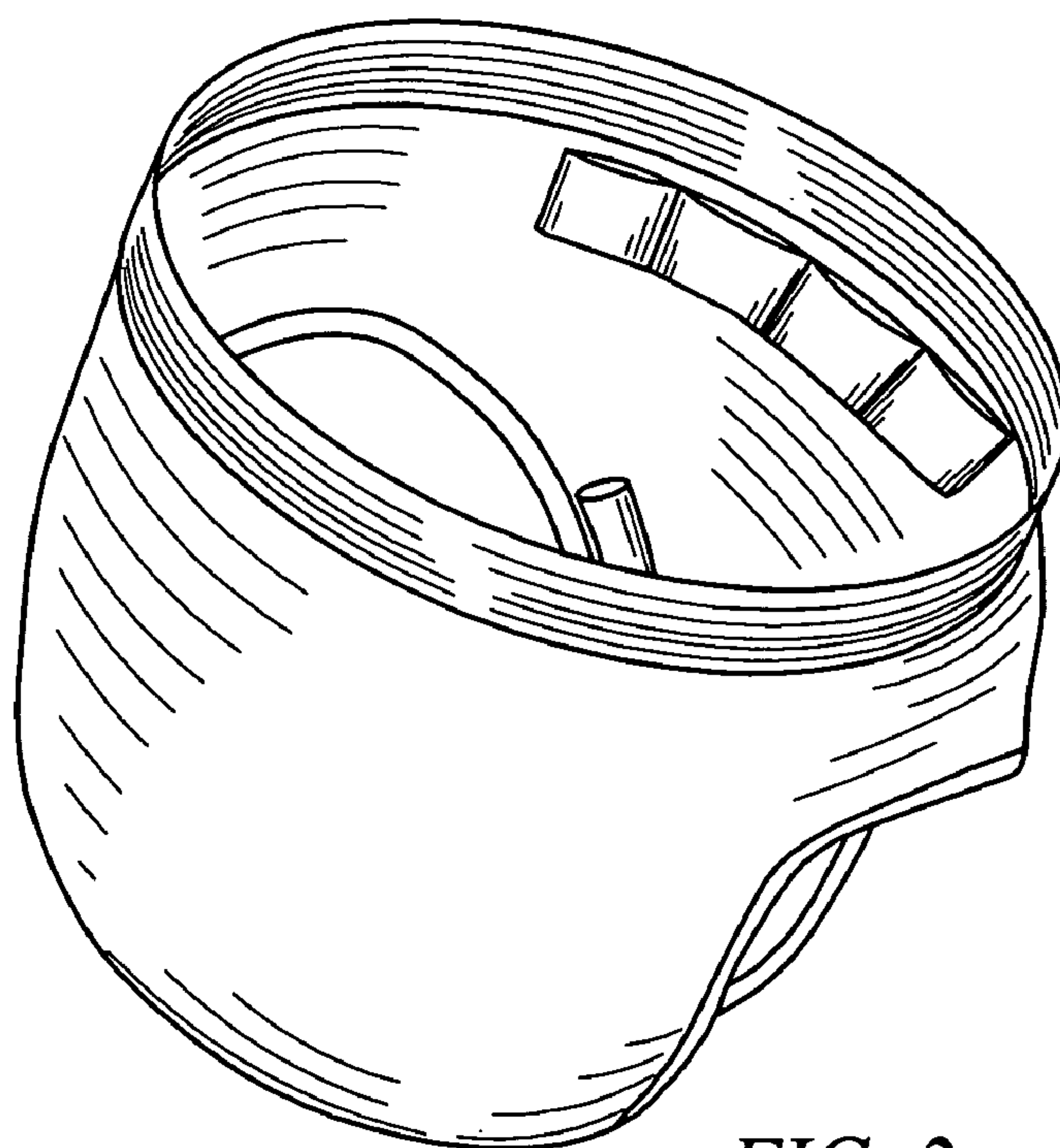

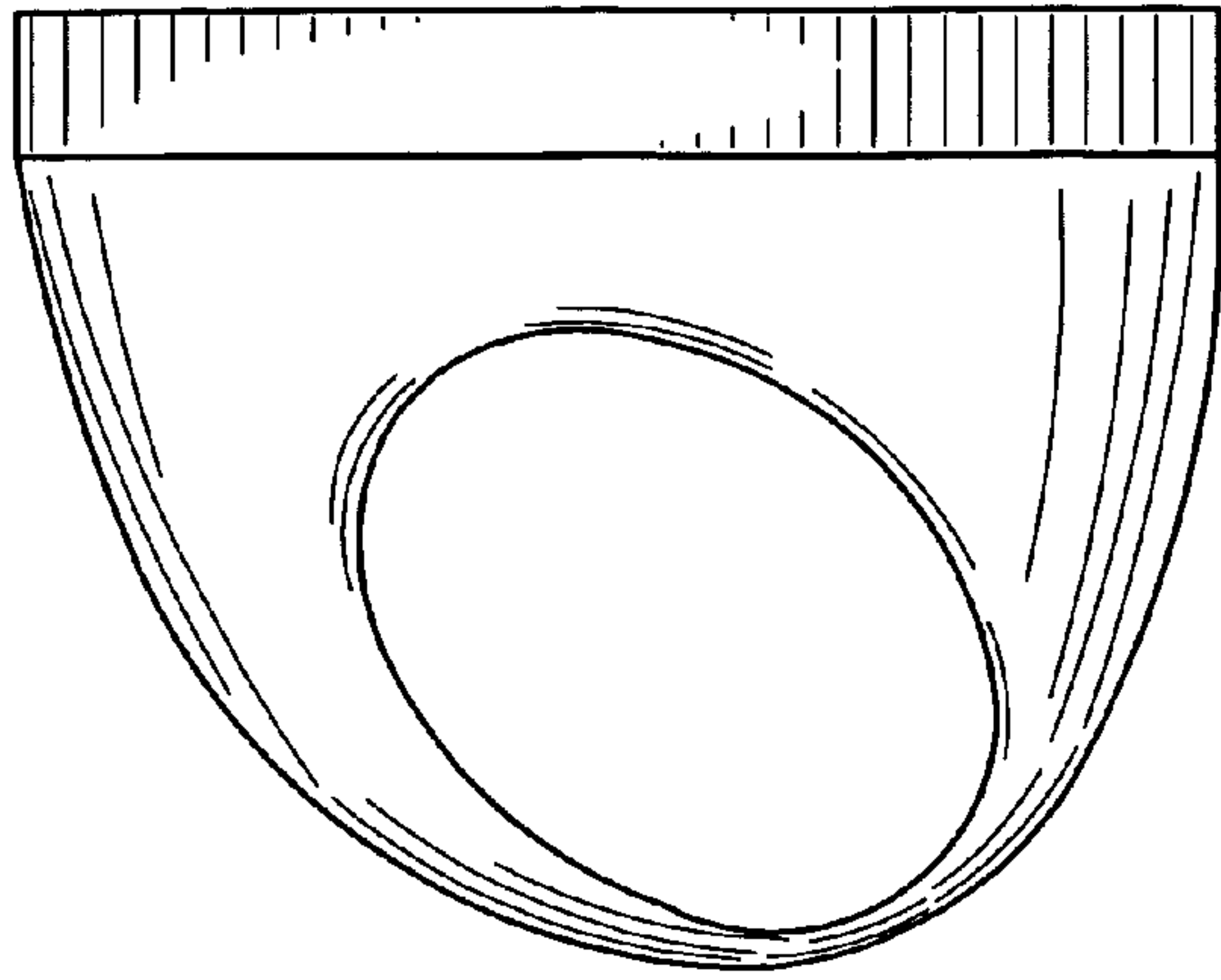

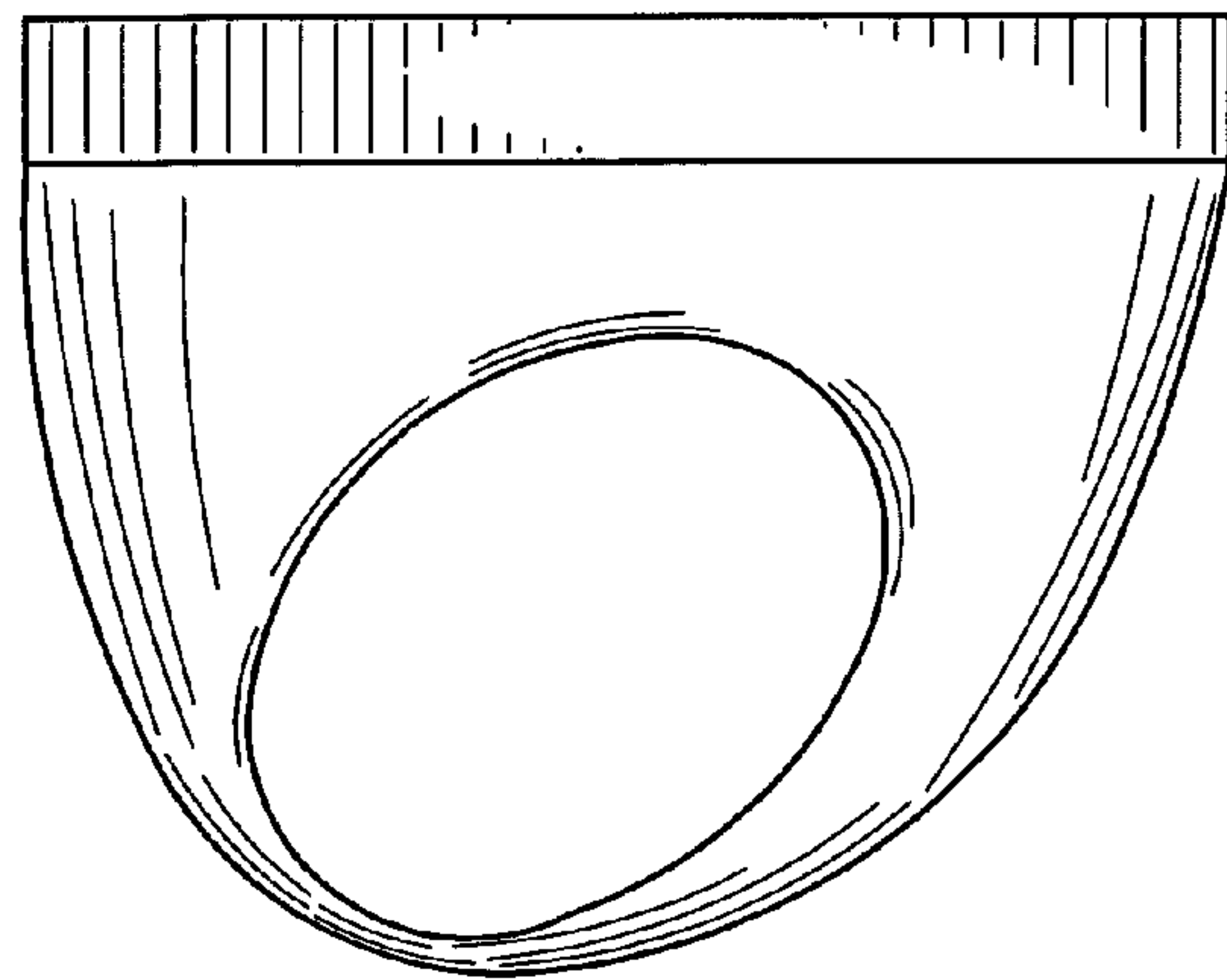

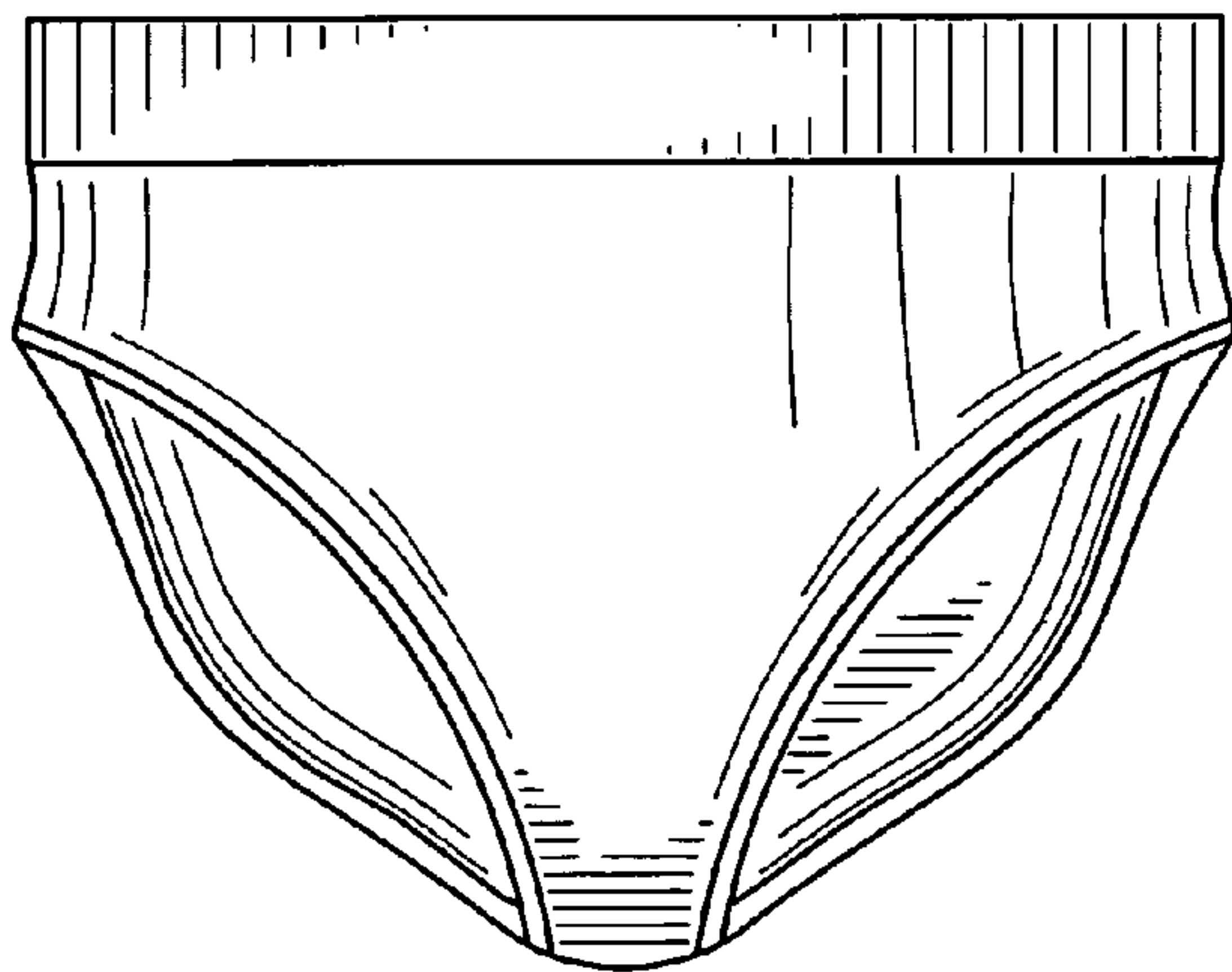

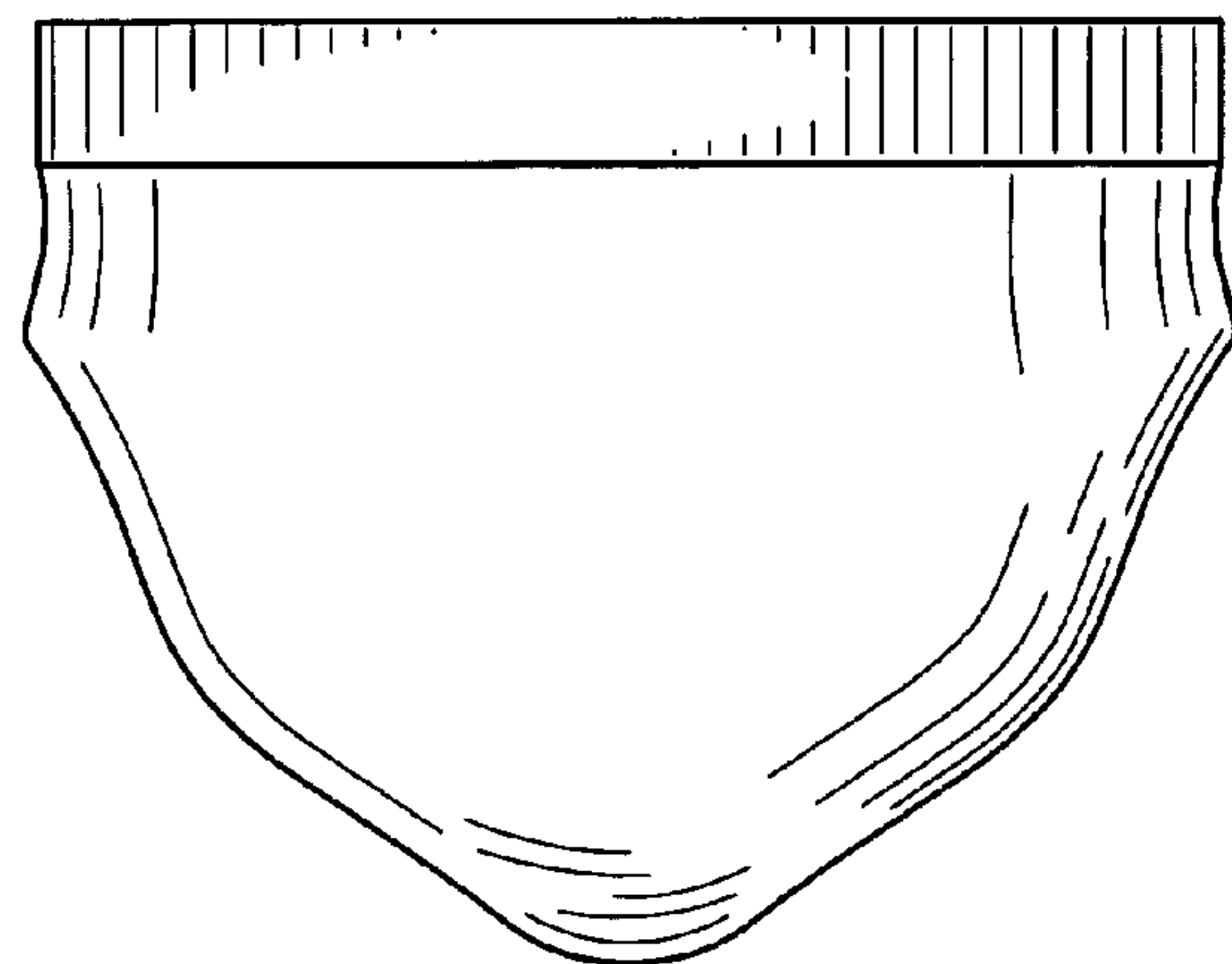

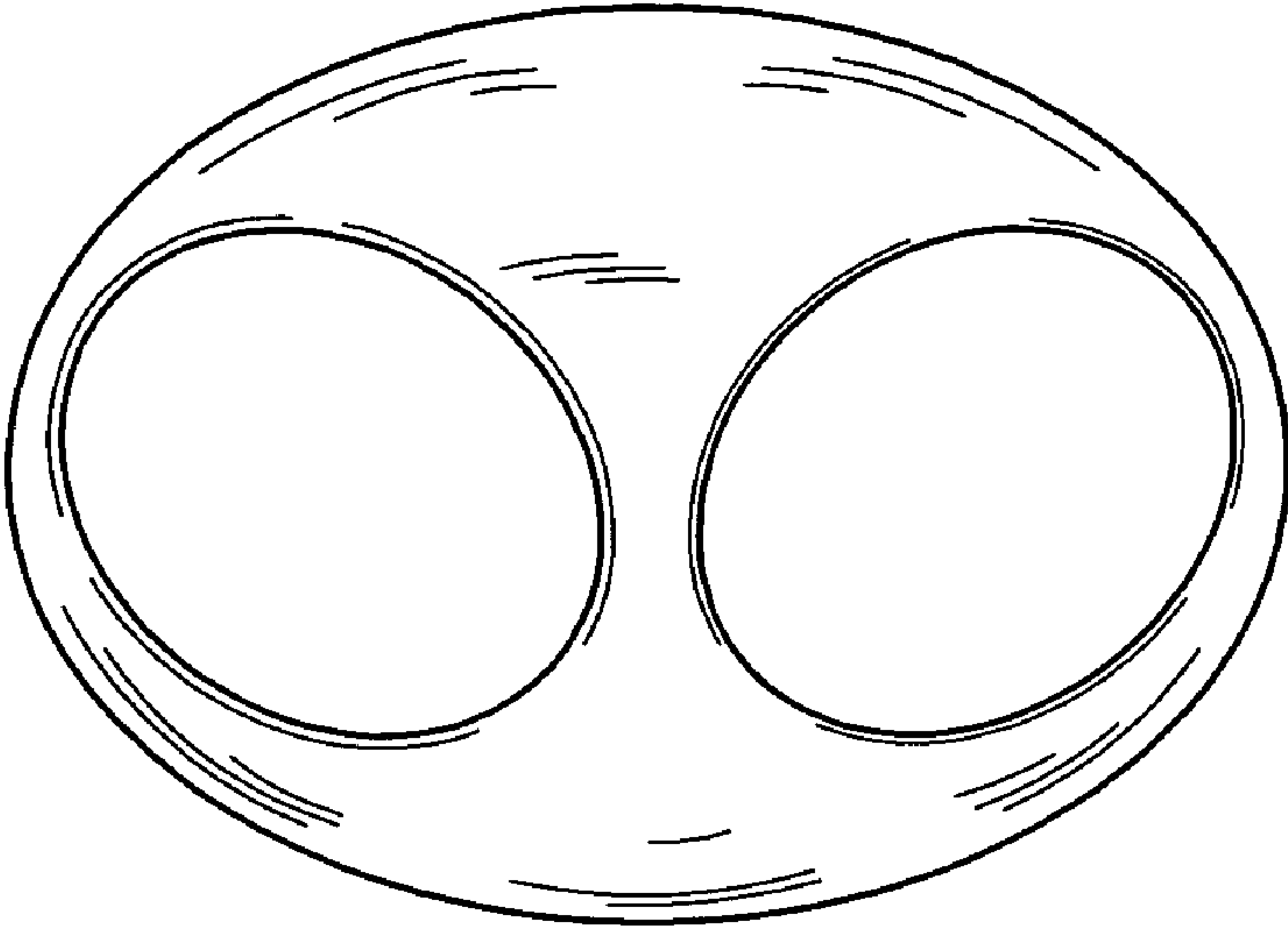

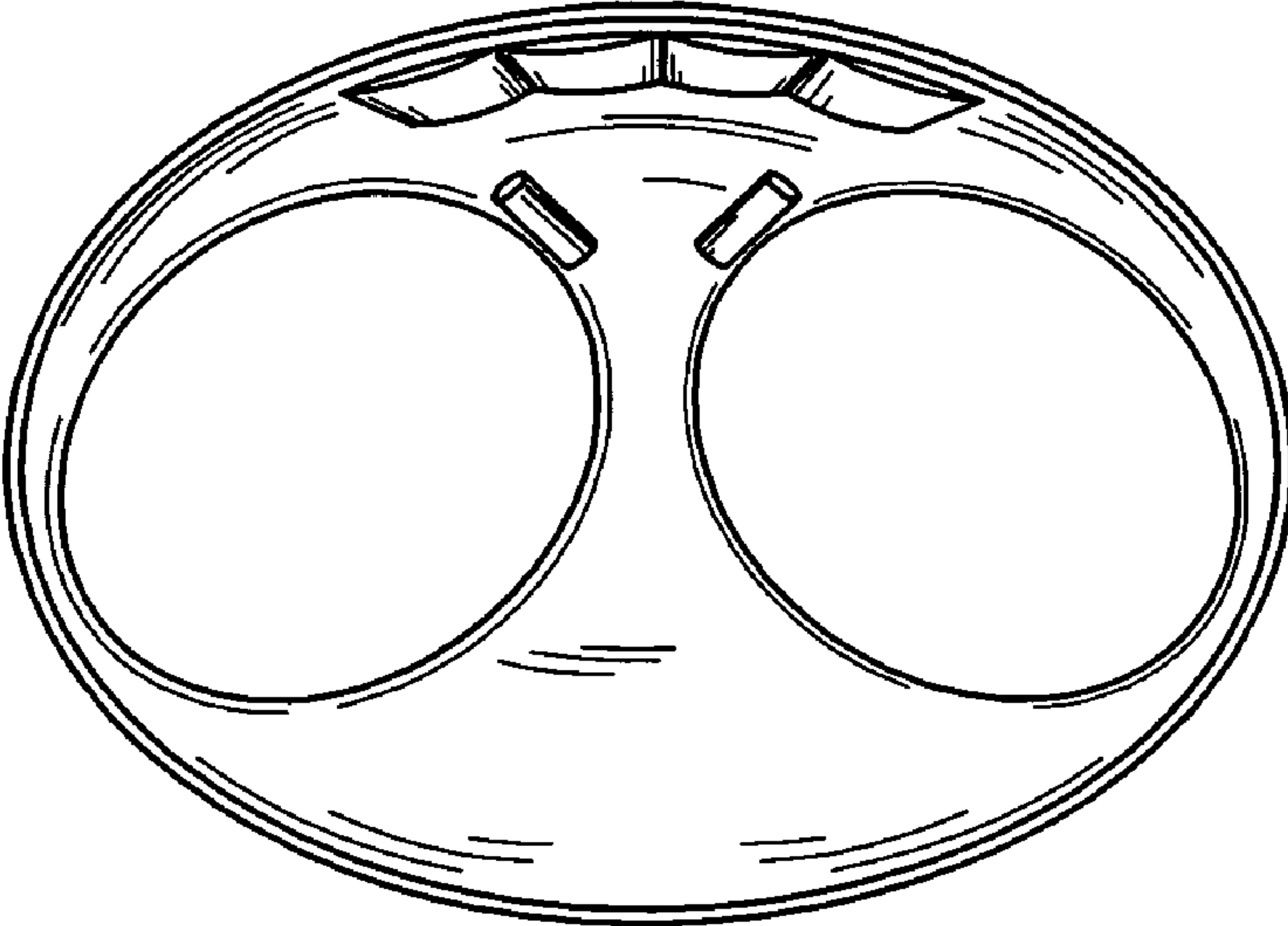
