(57) **CLAIM**

The ornamental design for a candle novelty headwear, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the candle novelty headwear showing my new design.

FIG. 2 is a top plan view of the design of FIG. 1.

FIG. 3 is a left side elevation view of the design of FIG. 1.

FIG. 4 is a rear elevation view of the design of FIG. 1.

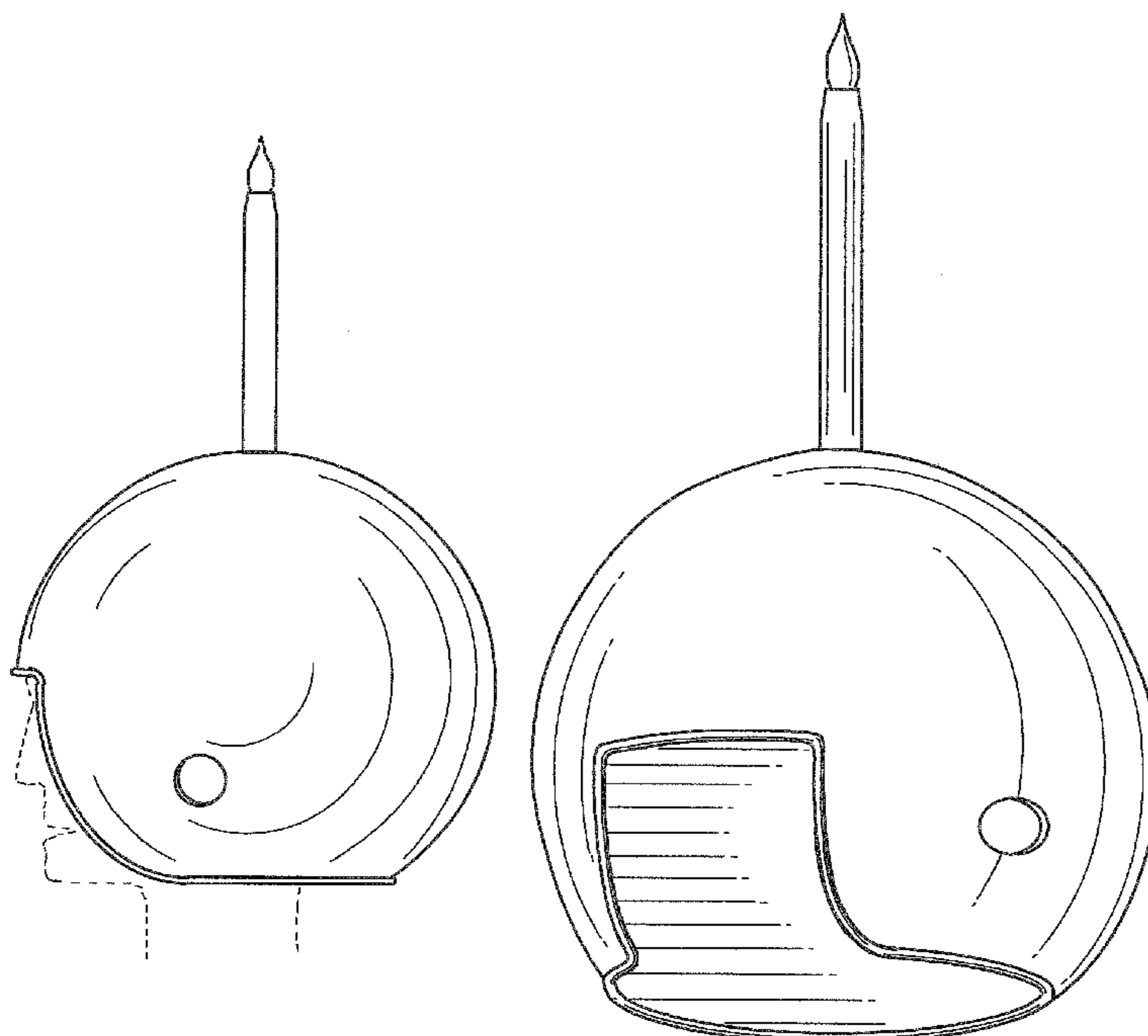
FIG. 5 is a right side elevation view of the design of FIG. 1.

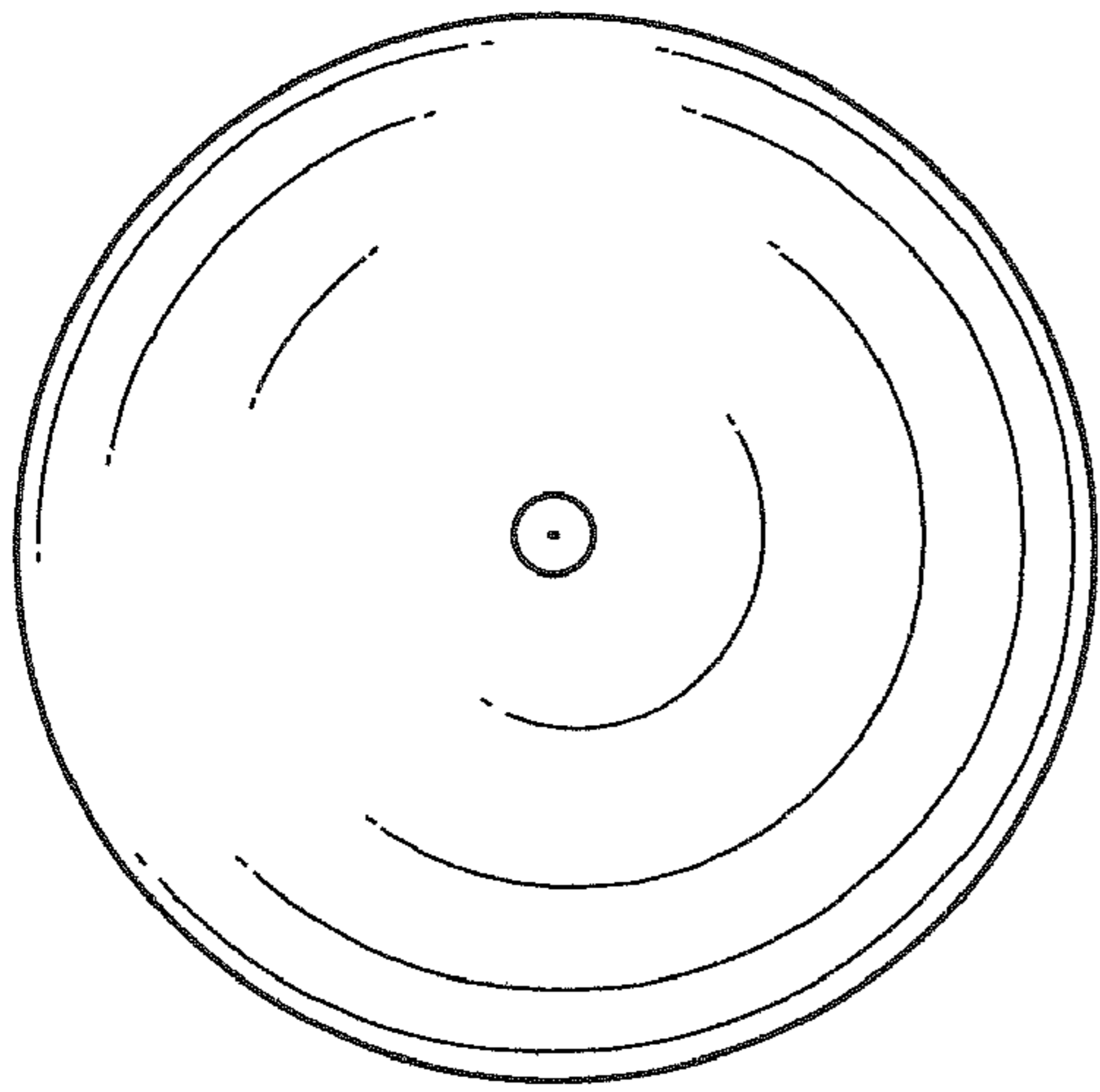

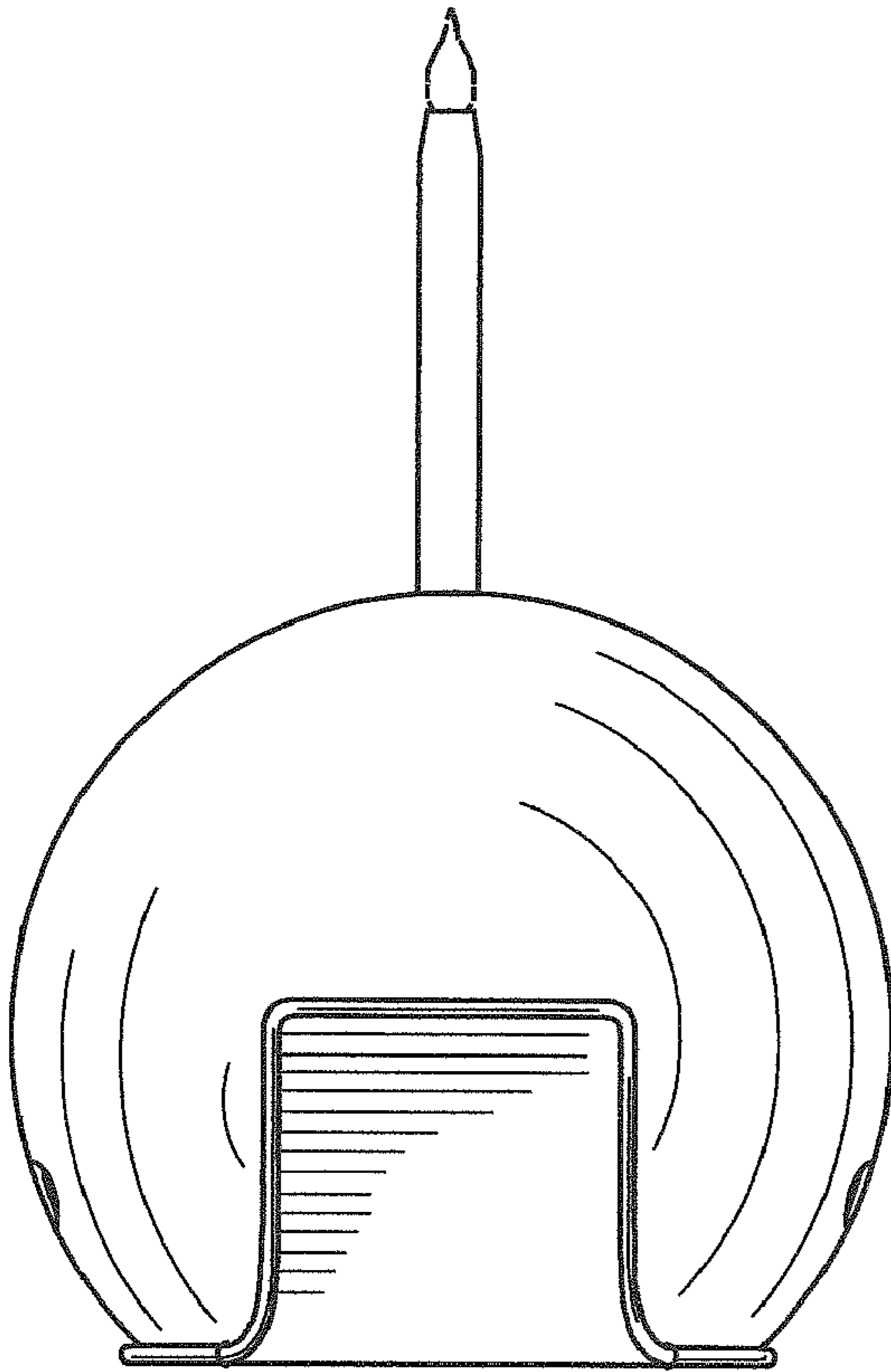

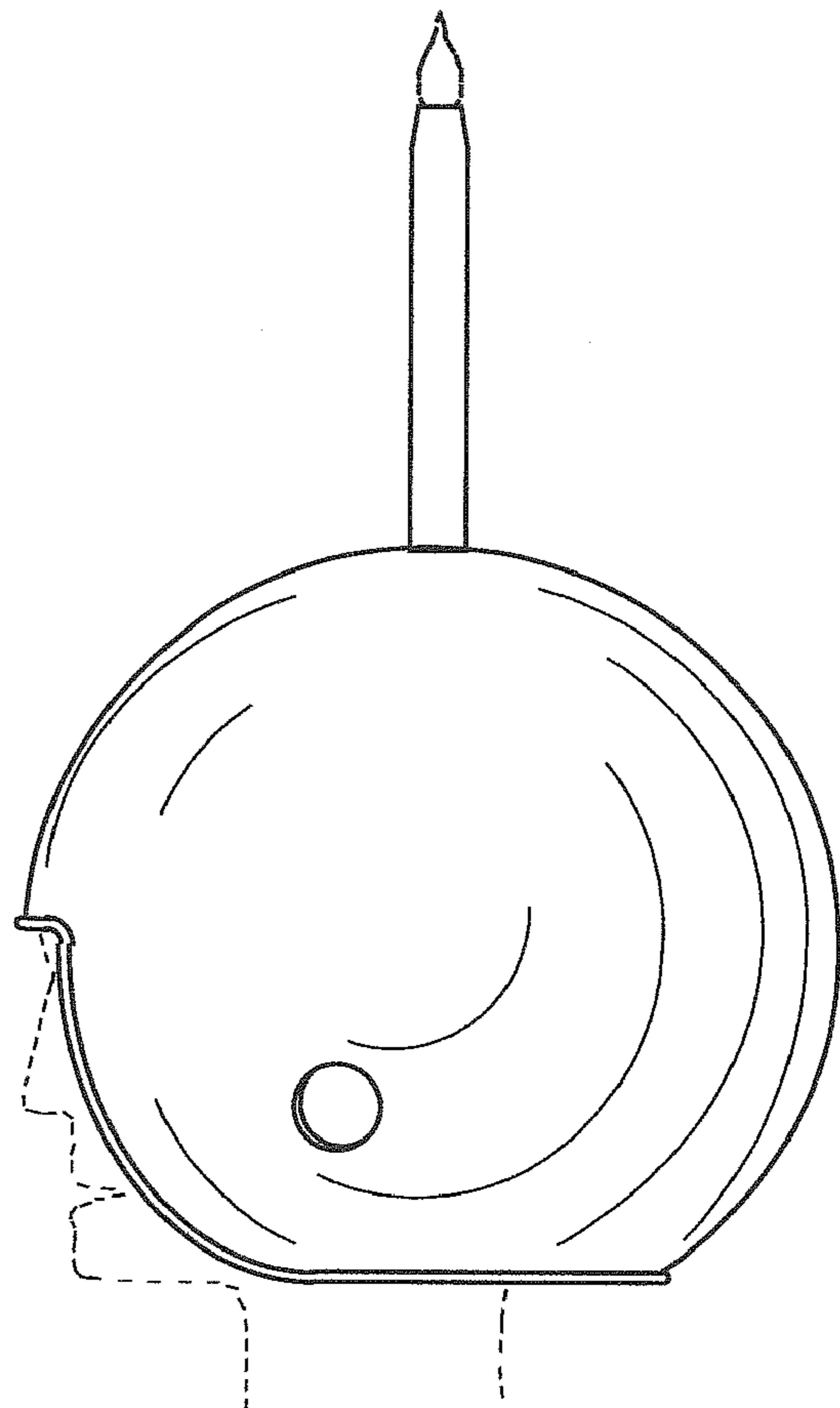

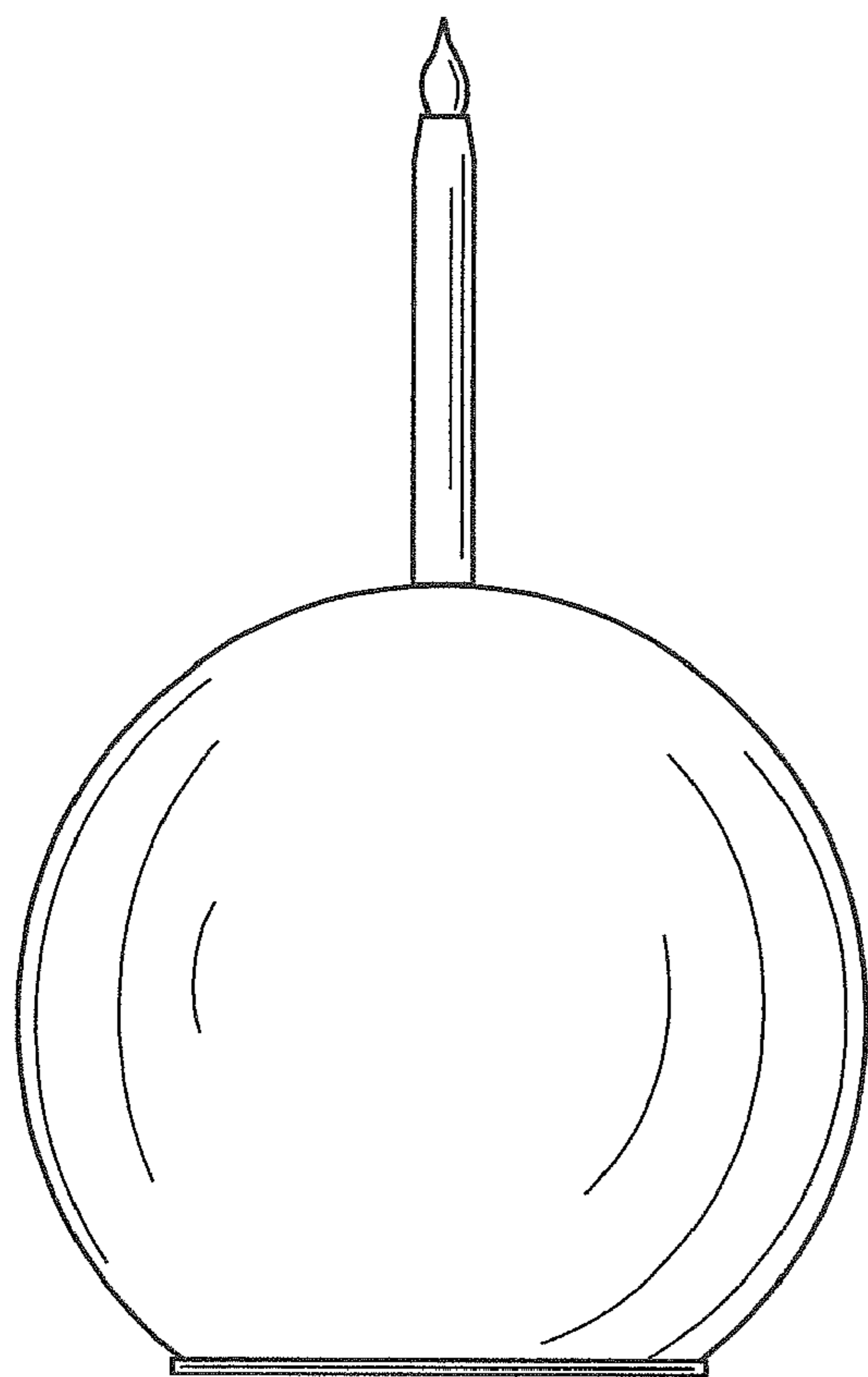

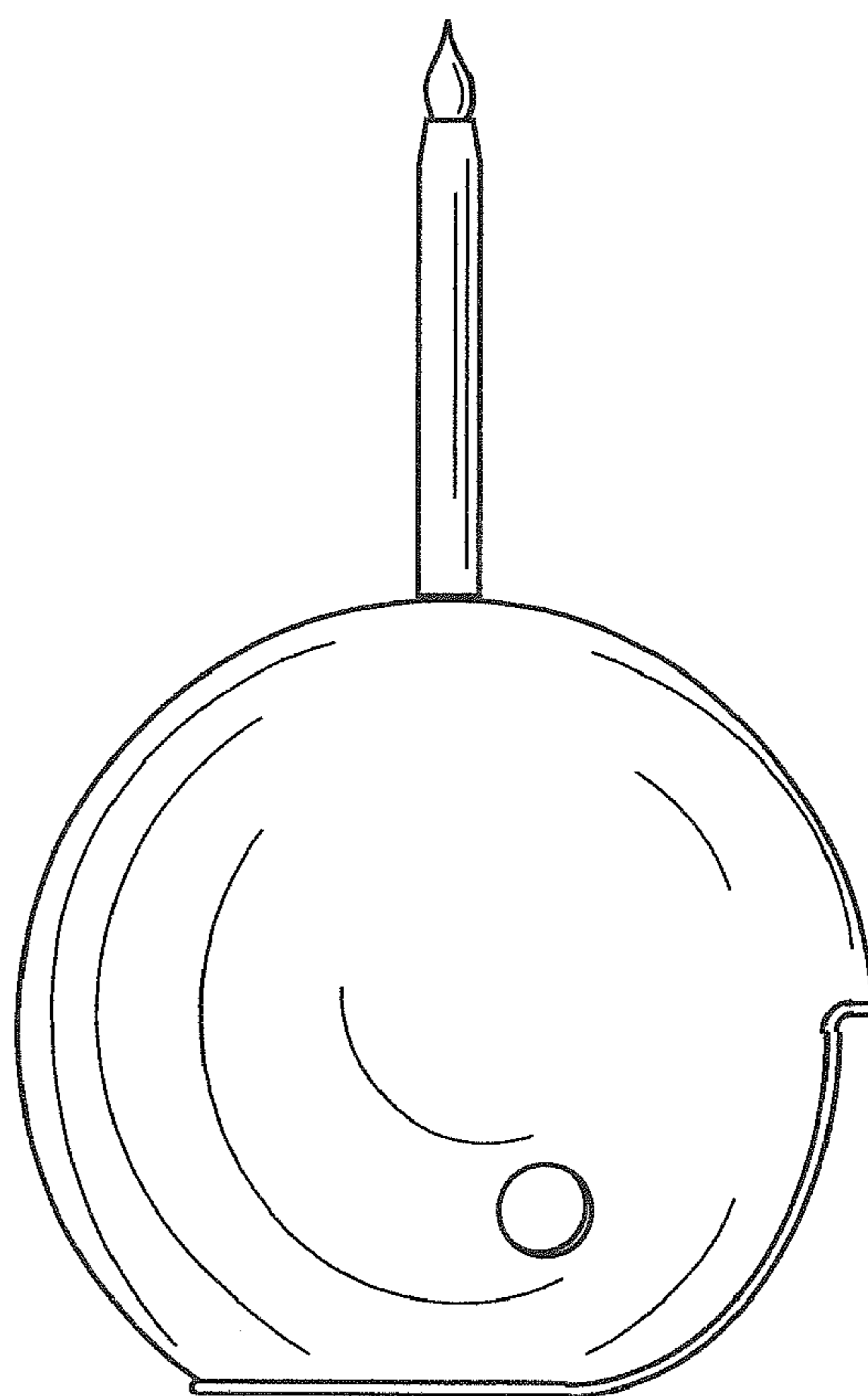

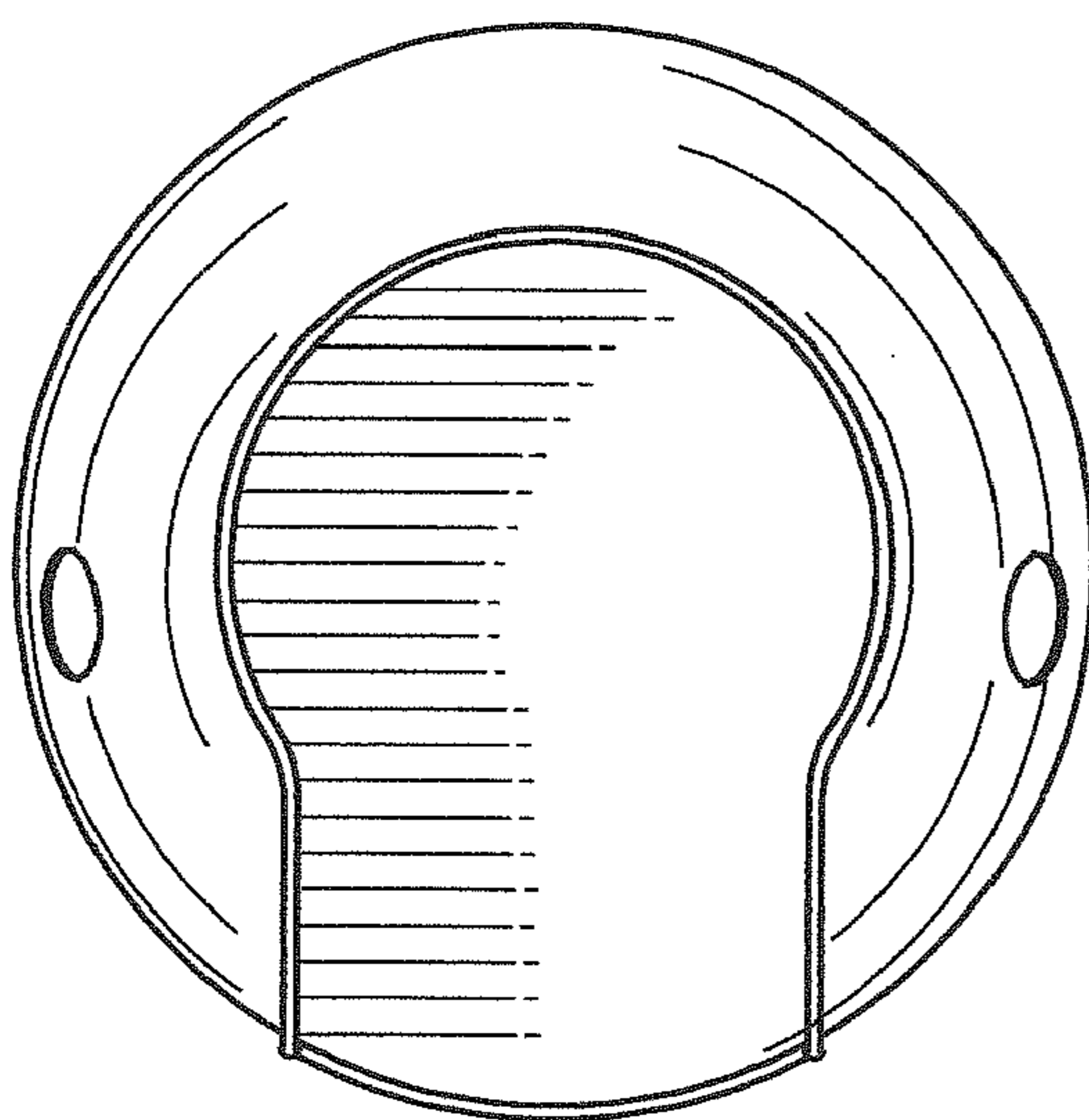

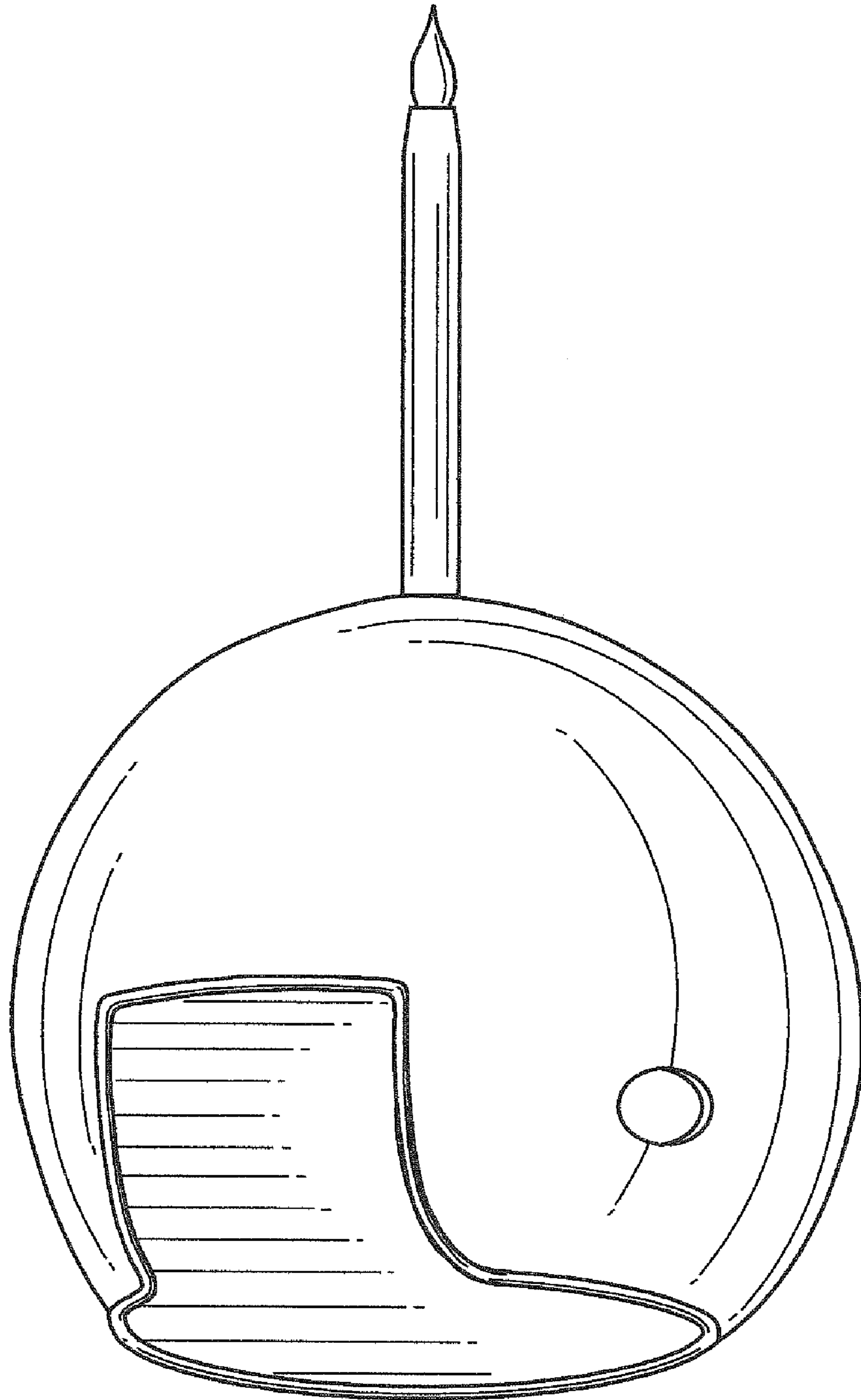
