(57) **CLAIM**

I claim the ornamental design for the customizable baseball hat having snap-on decorative pendant, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of the customizable baseball hat, with the snap-on decorative pendant not shown for clarity of illustration;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a front elevation view thereof;

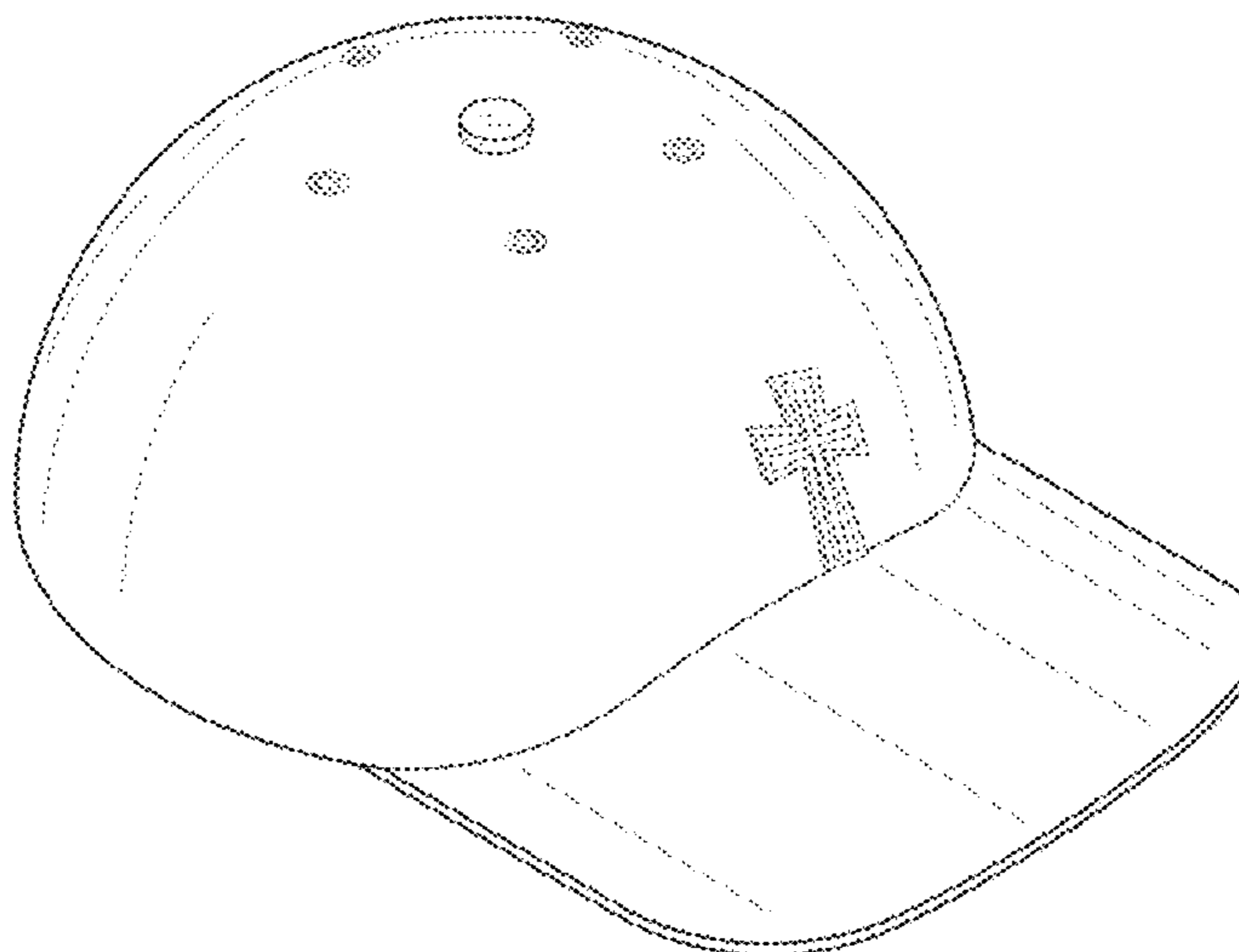
FIG. 4 is a top plan view thereof;

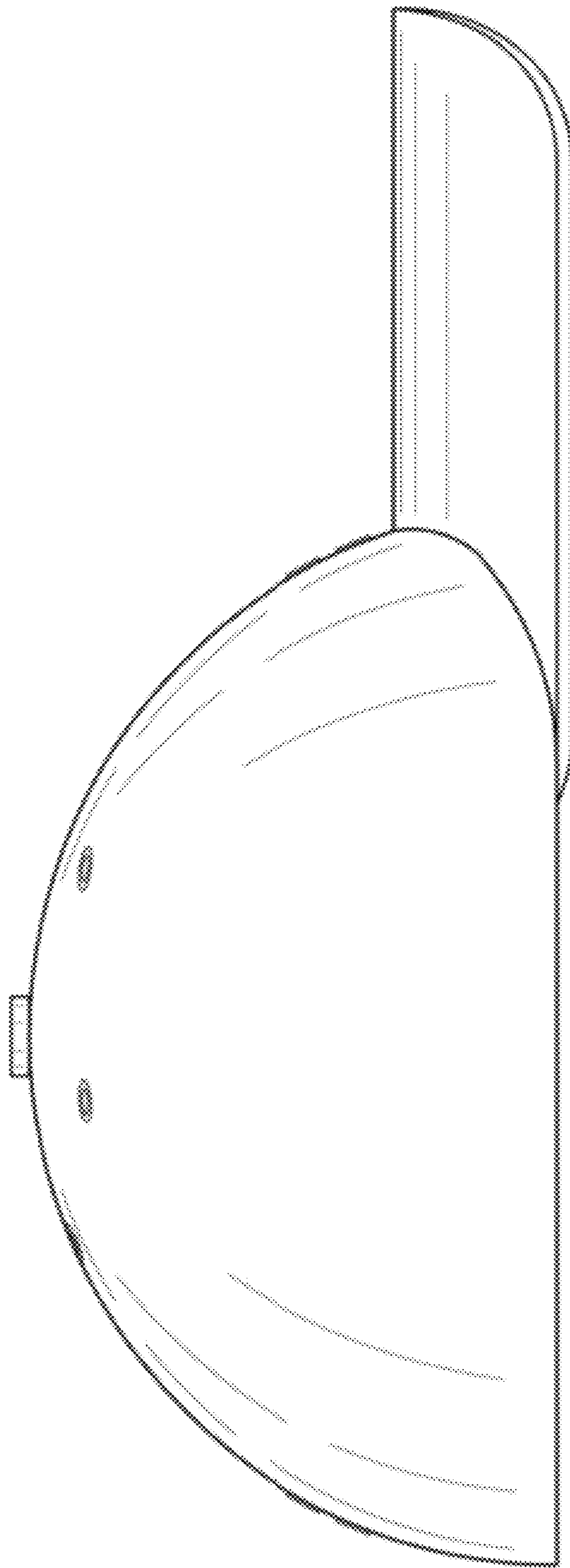

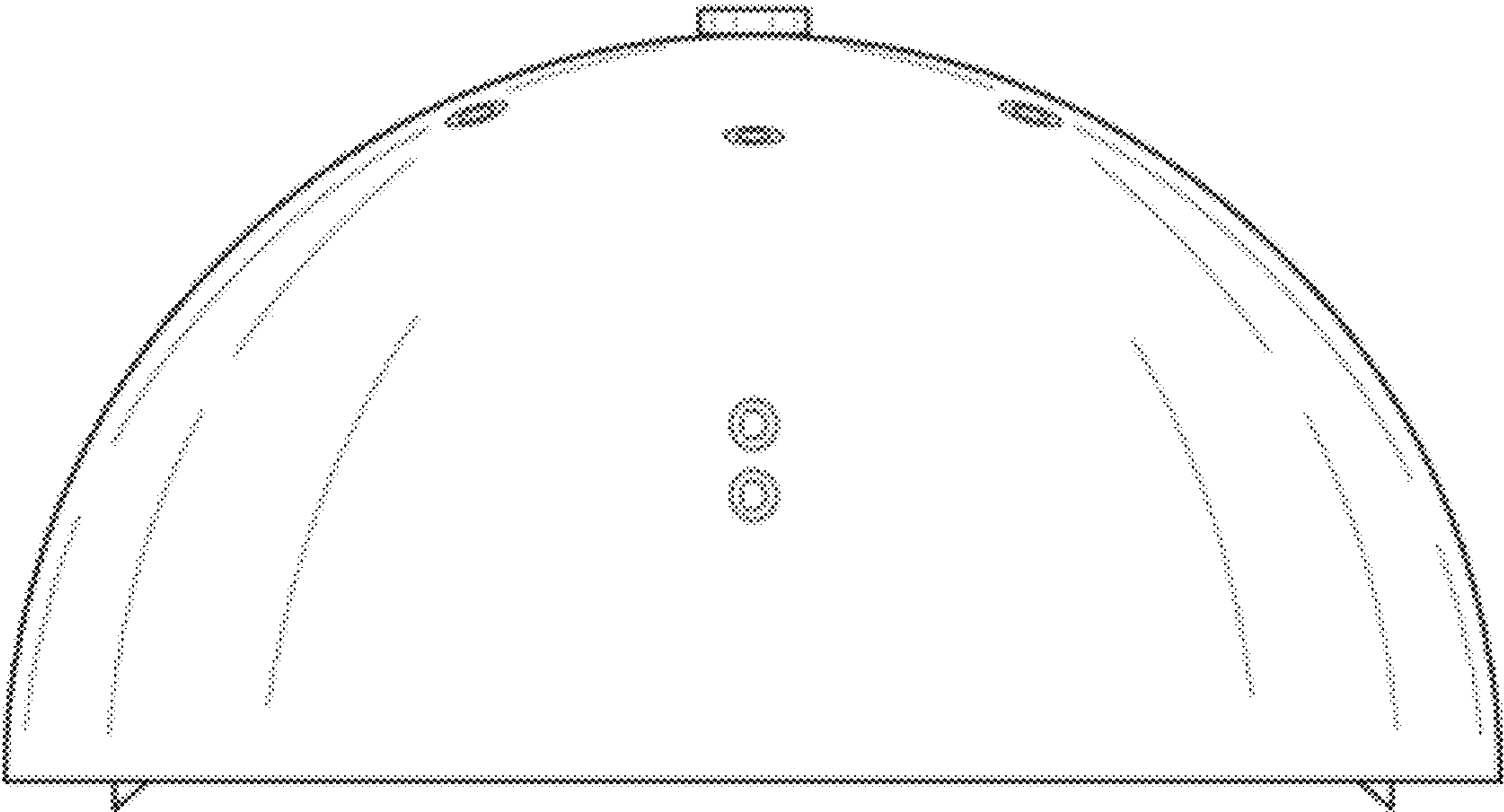

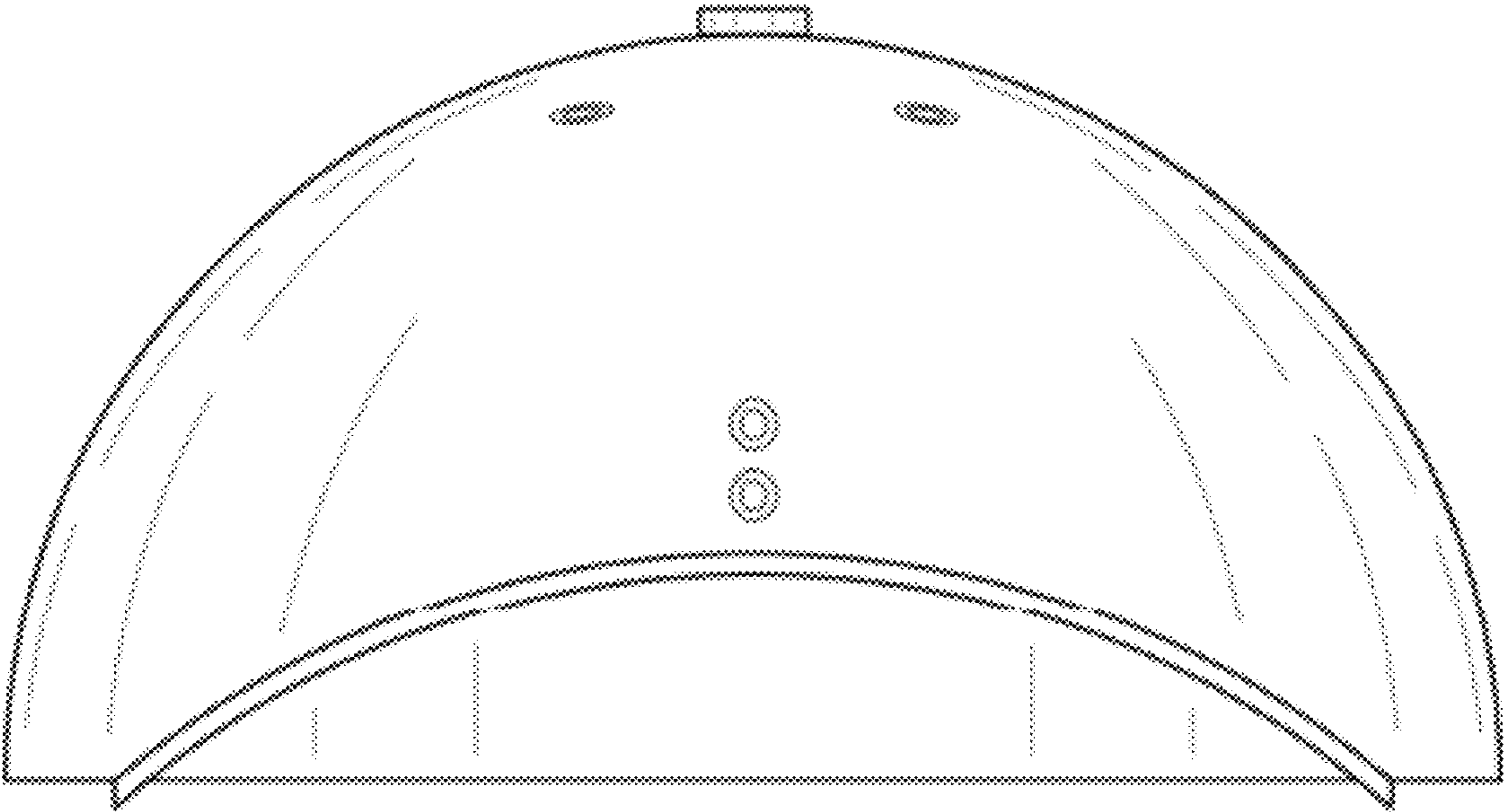

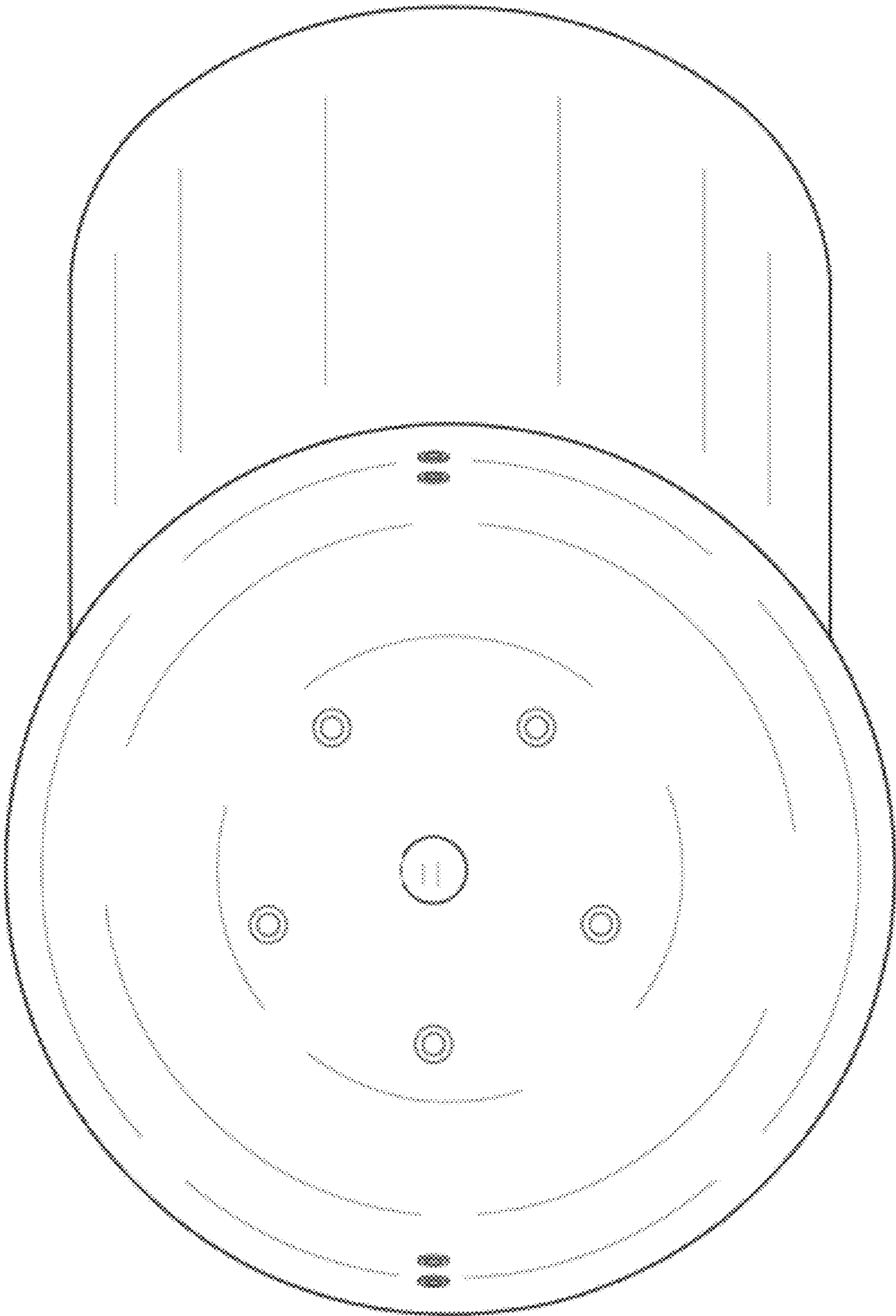

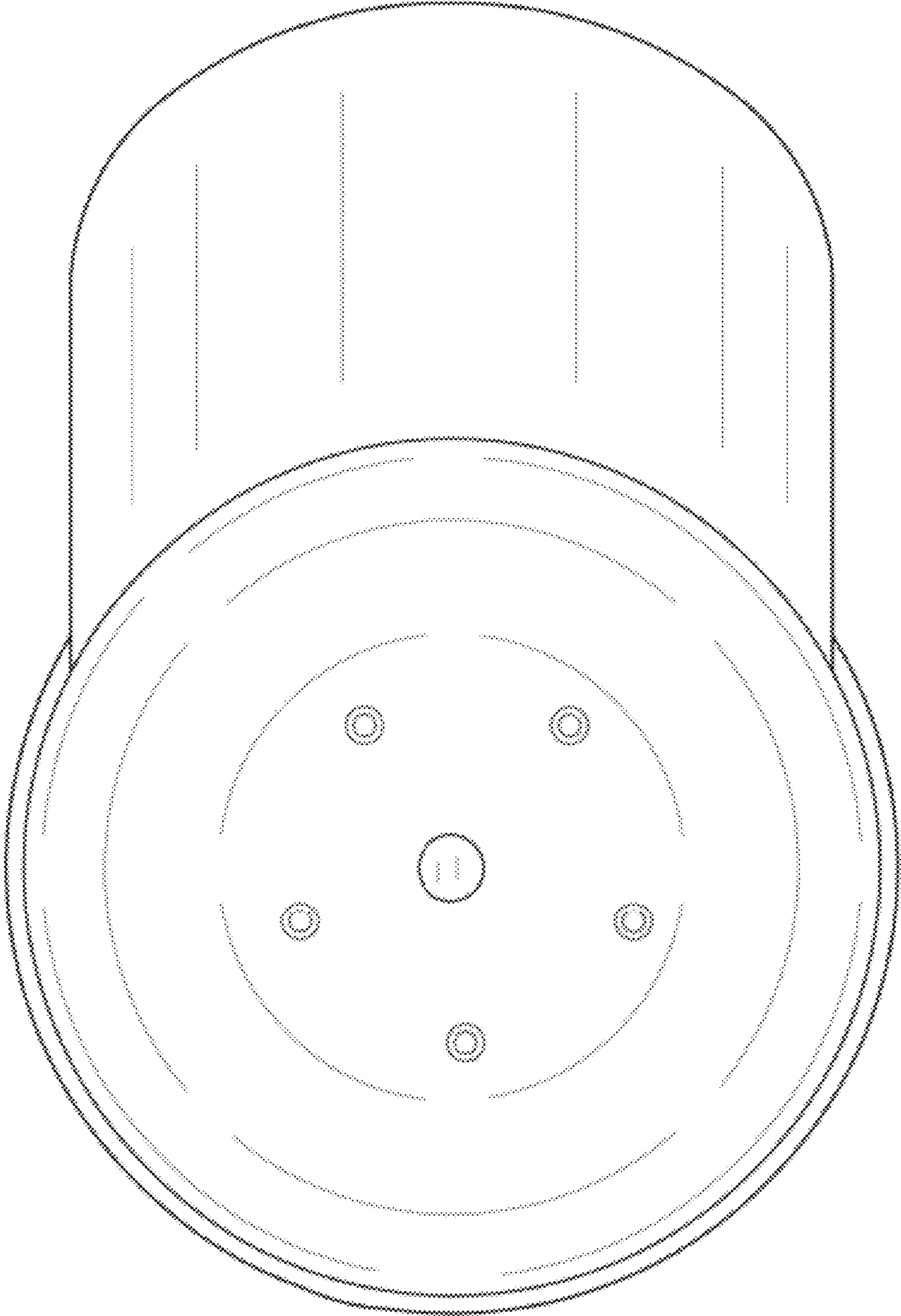
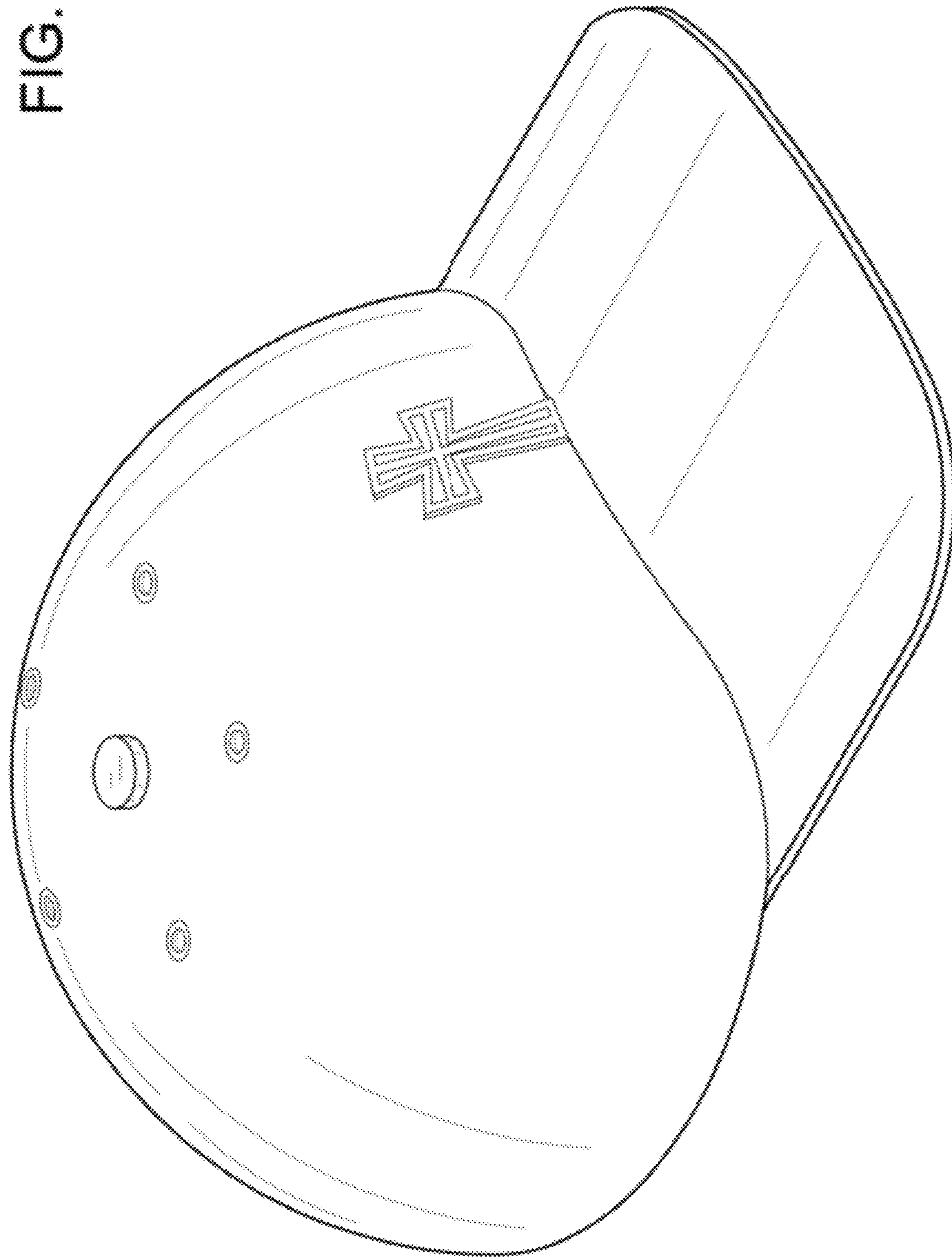

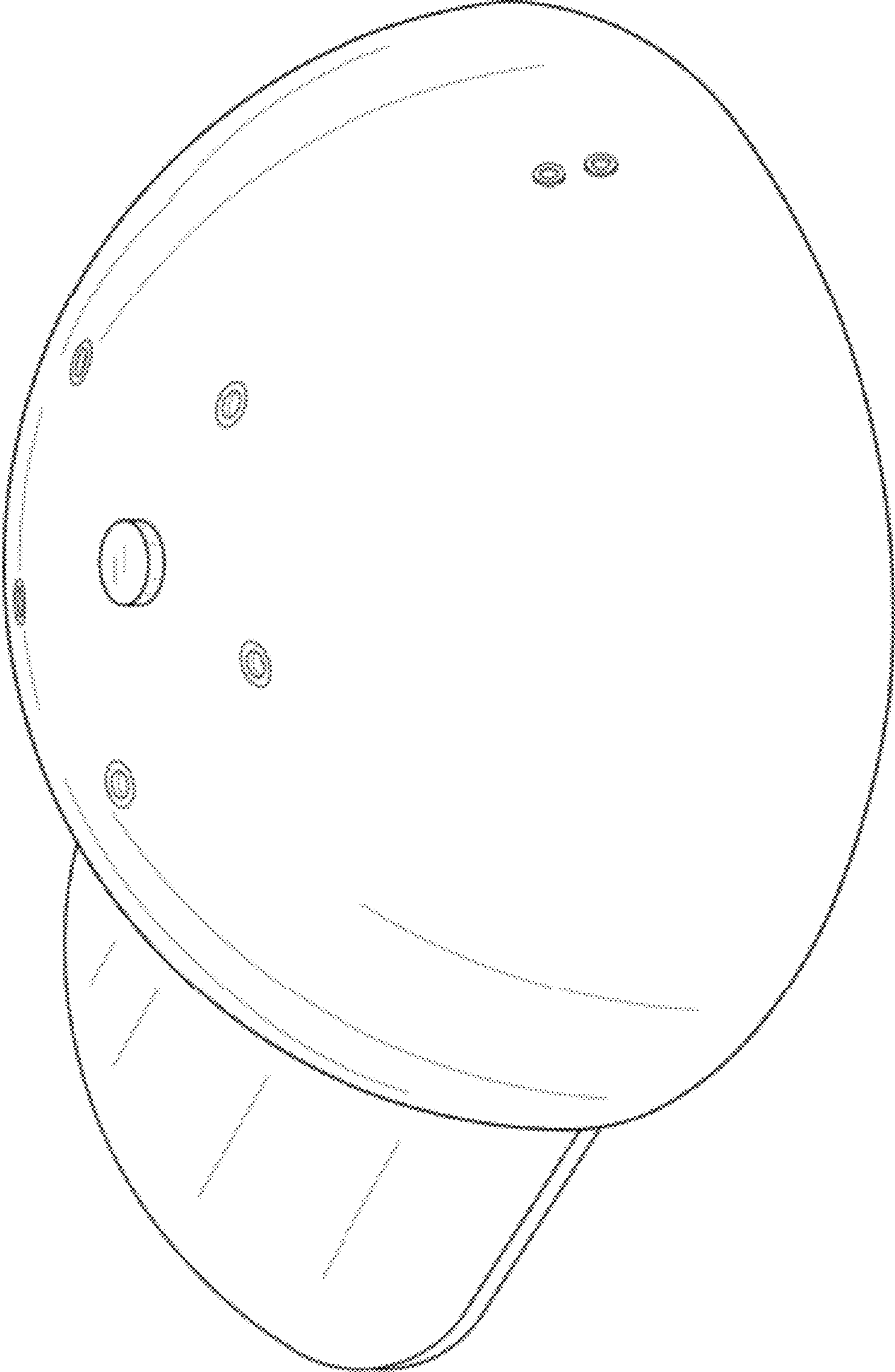
