(57) **CLAIM**

I claim the ornamental design for a detachable carrying case, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a detachable carrying case, showing the new design;
FIG. 2 is a rear perspective view of a pouch portion thereof;

FIG. 3 is a front elevational view of FIG. 1;

FIG. 4 is a front perspective view of an elastic band portion thereof;

FIG. 5 is a rear elevational view of FIG. 1;

FIG. 6 is an exploded left-side elevational view of FIG. 1;

FIG. 7 is a right-side elevational view of FIG. 1;

FIG. 8 is a top plan view of FIG. 1;

FIG. 9 is a bottom plan view of FIG. 1;

FIG. 10 is a front perspective view of a second embodiment thereof;

FIG. 11 is a front elevational view of FIG. 10;

FIG. 12 is a rear elevational view of FIG. 10;

FIG. 13 is an exploded left-side elevational view of FIG. 10;

FIG. 14 is a right-side elevational view of FIG. 10;

FIG. 15 is a top plan view of FIG. 10;

FIG. 16 is a bottom plan view of FIG. 10;

FIG. 17 is a front perspective view of a third embodiment thereof;

FIG. 18 is a front elevational view of FIG. 17;

FIG. 19 is a rear elevational view of FIG. 17;

FIG. 20 is an exploded left-side elevational view of FIG. 17;

FIG. 21 is a right-side elevational view of FIG. 17;

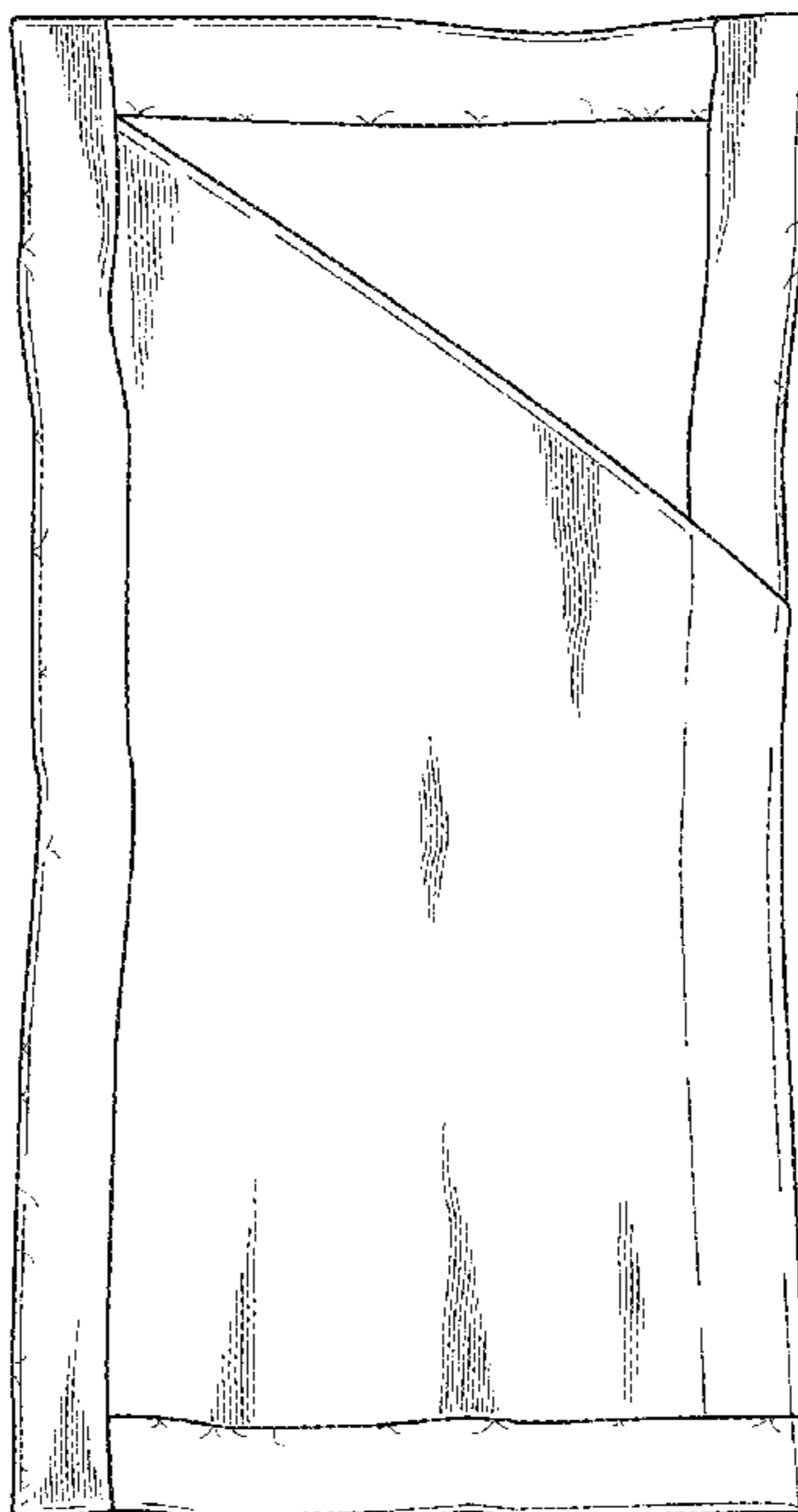
FIG. 22 is a top plan view of FIG. 17;

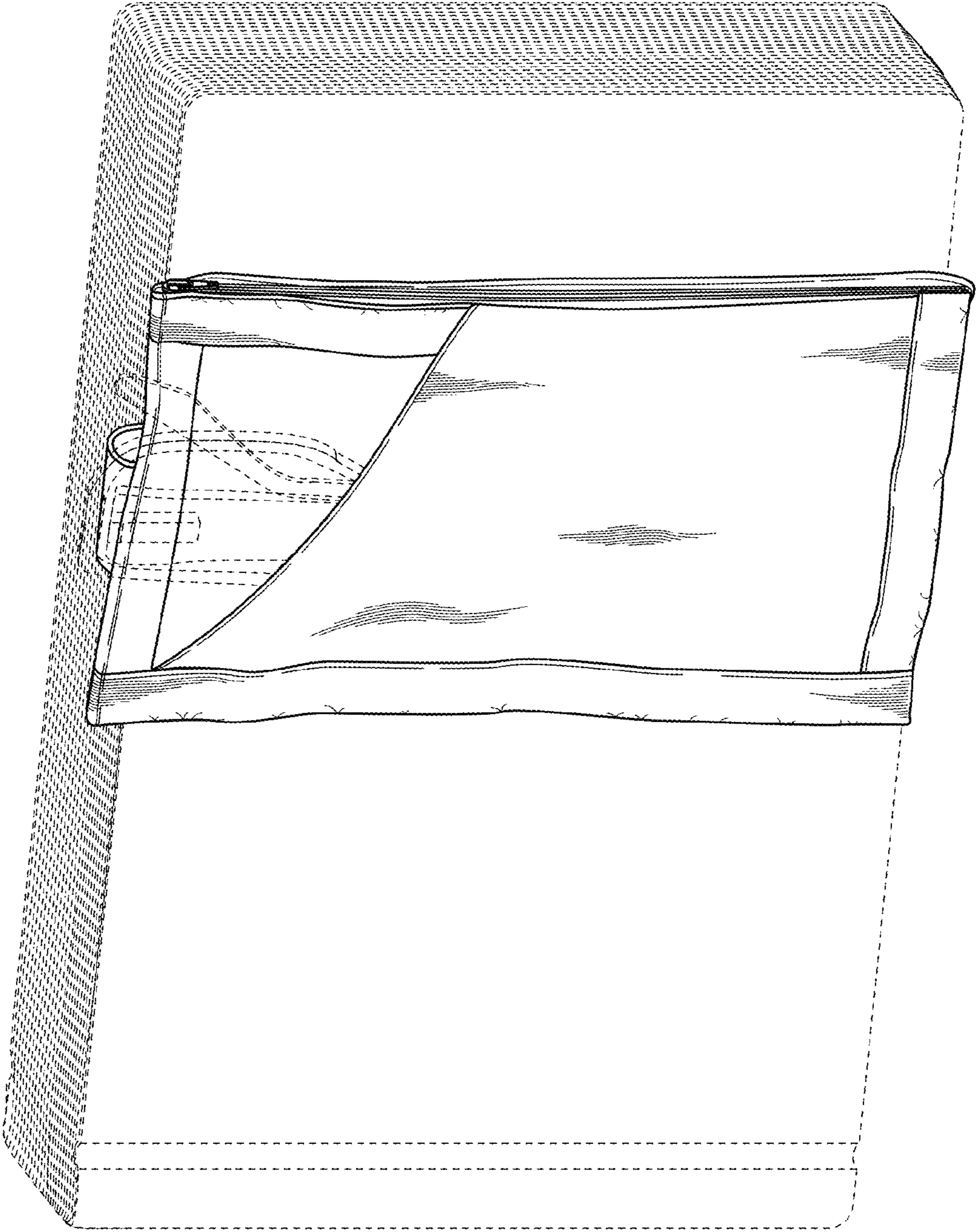

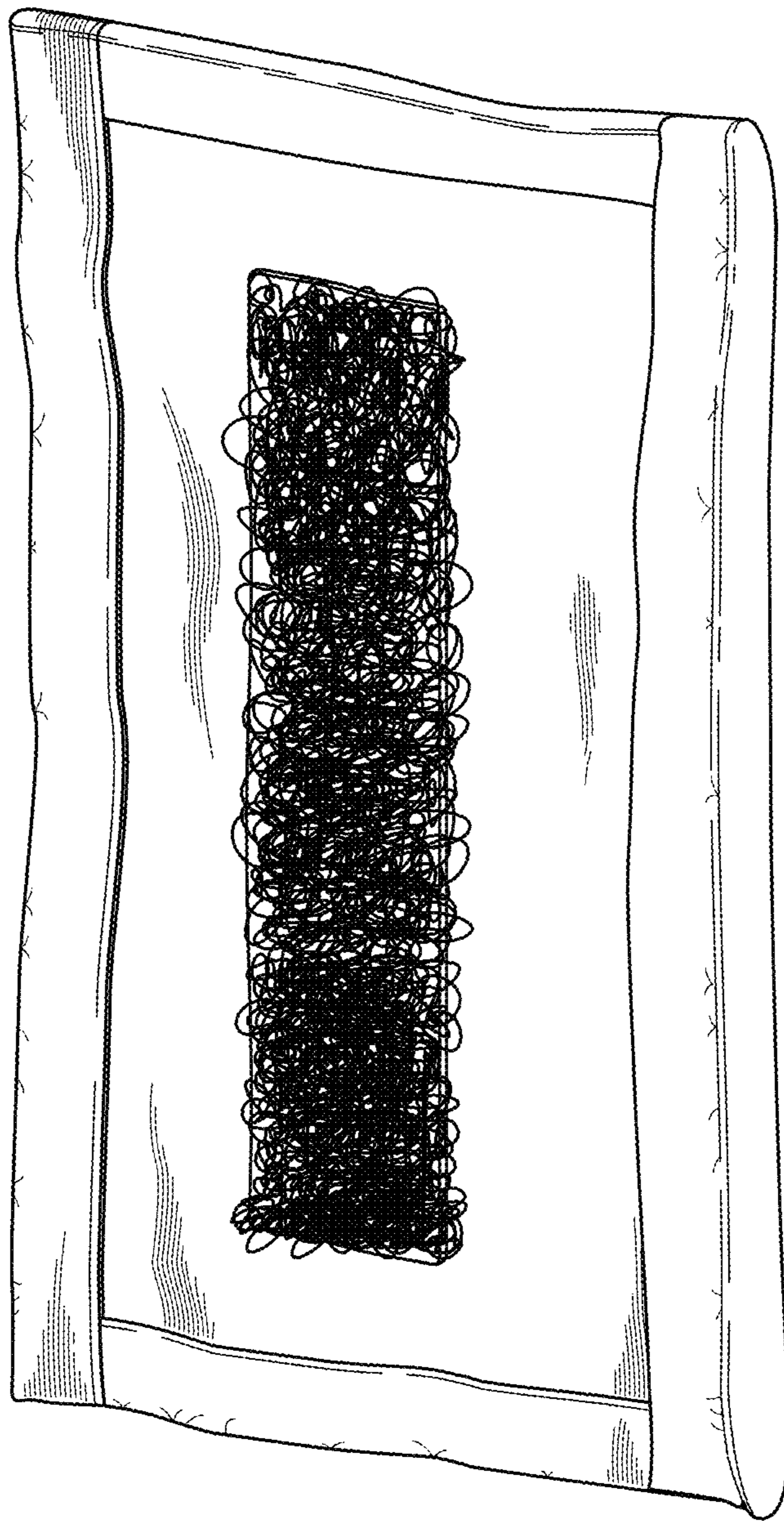

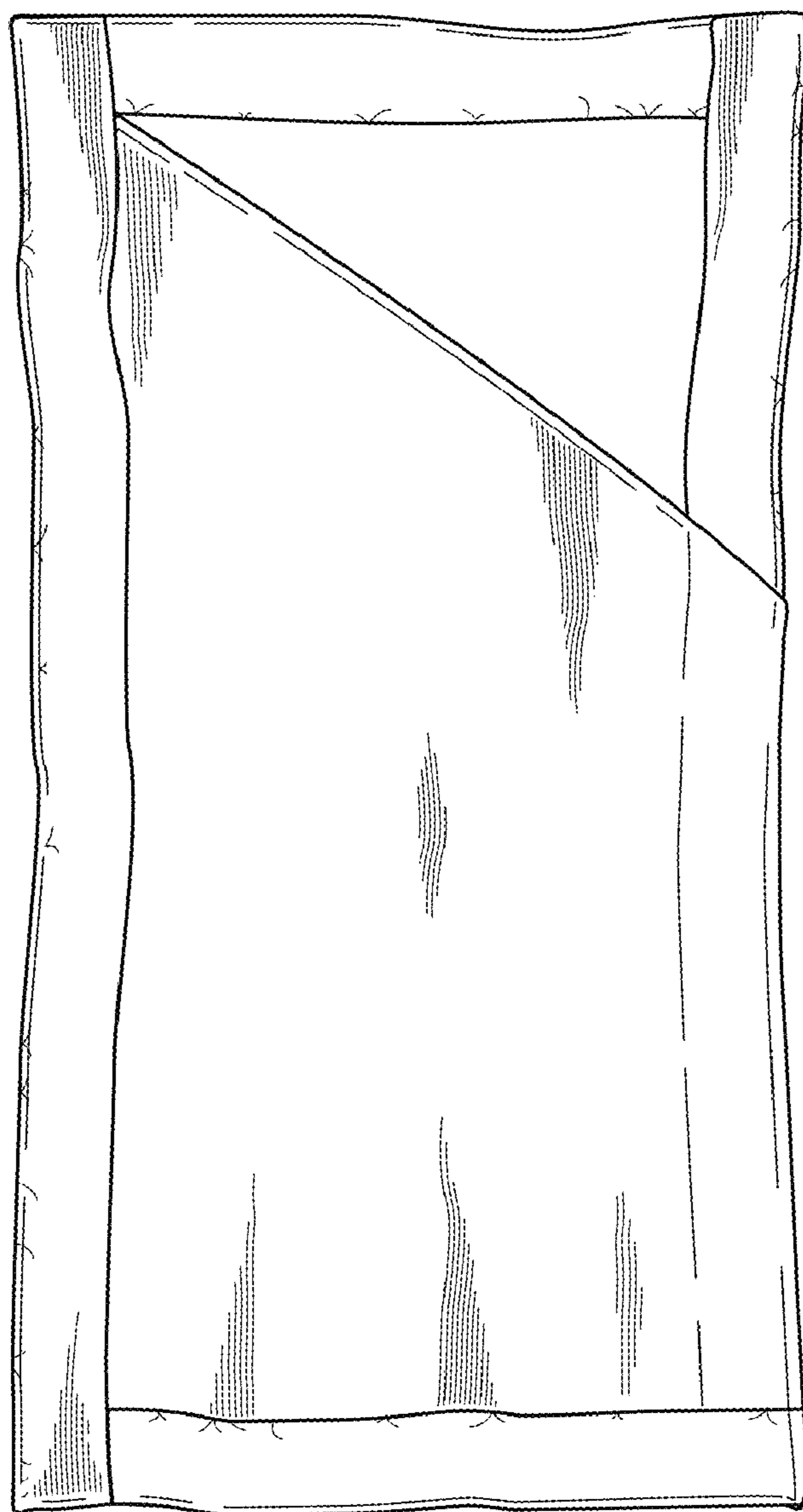

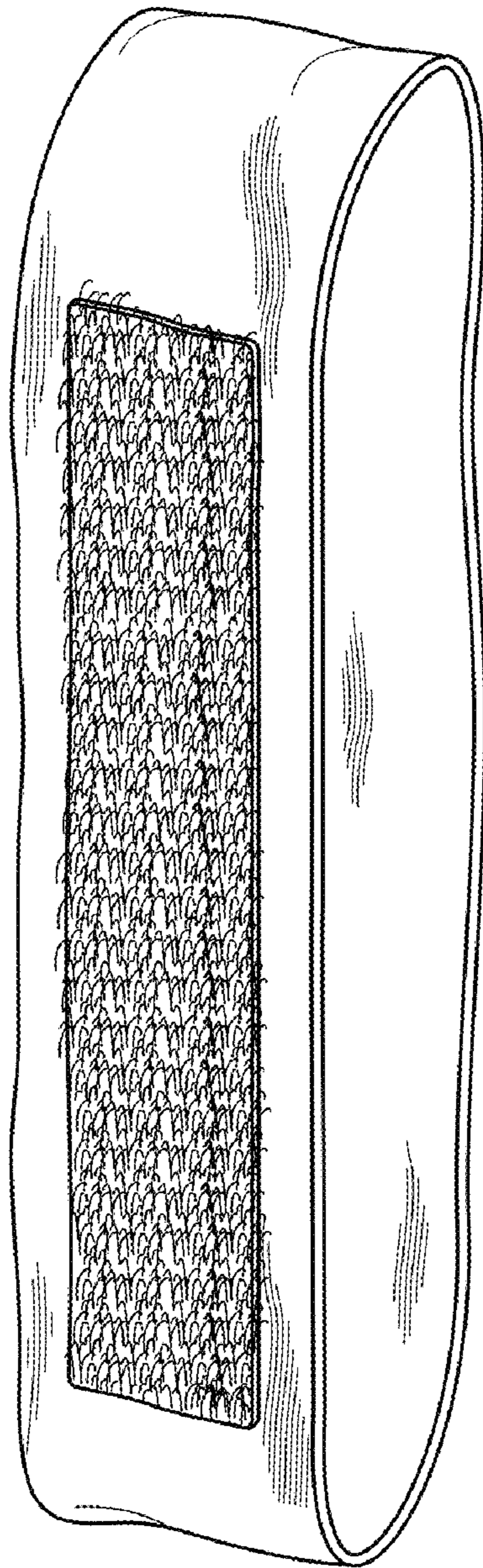

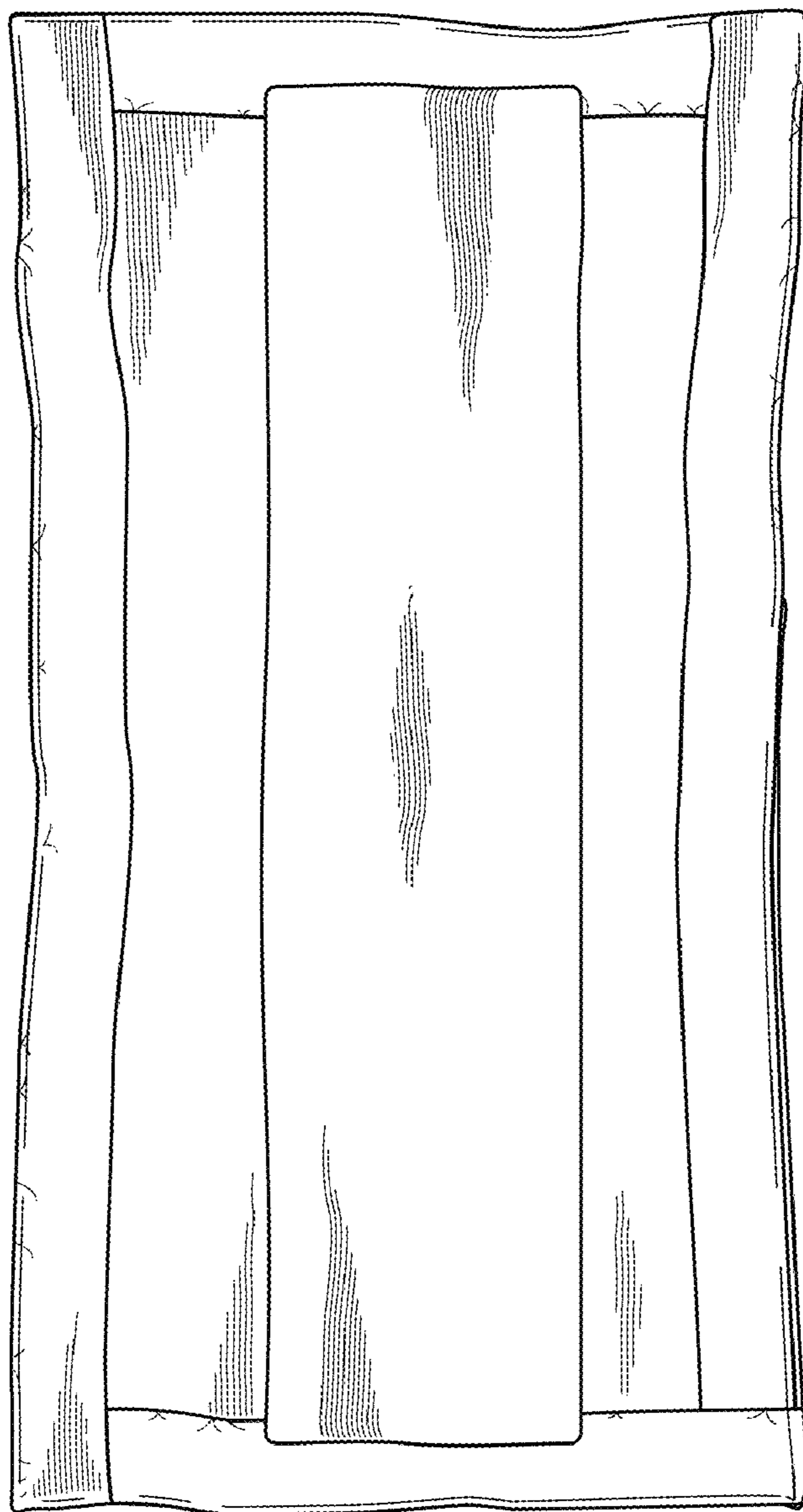

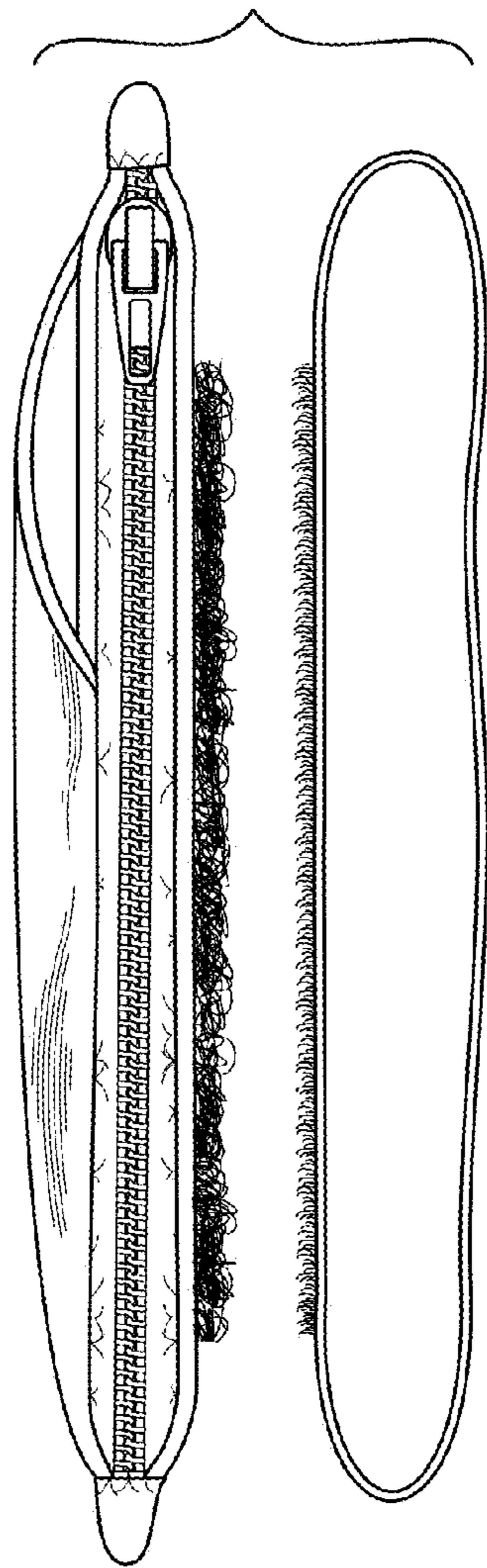

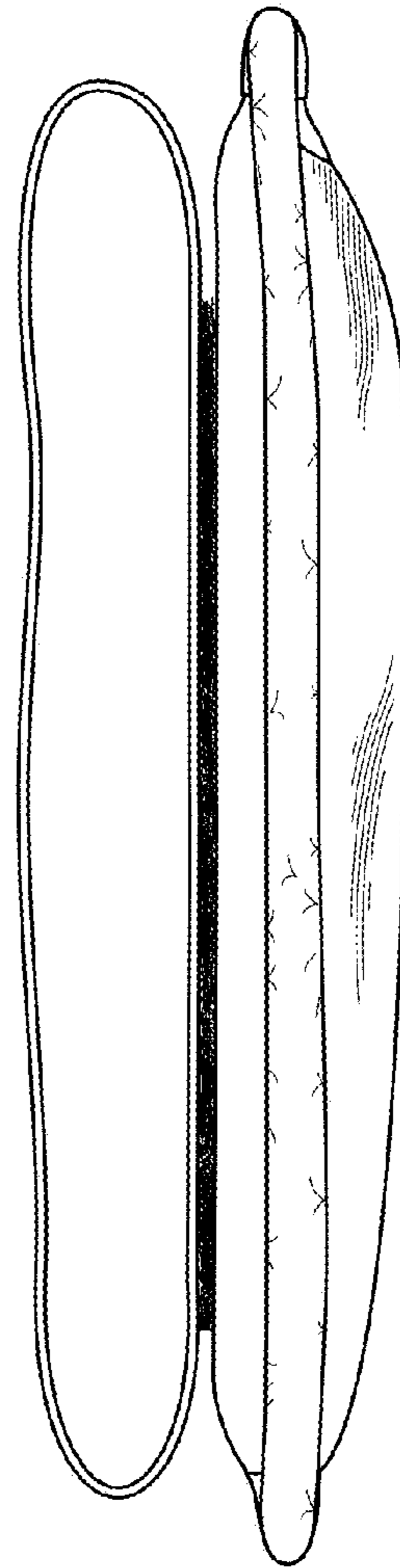

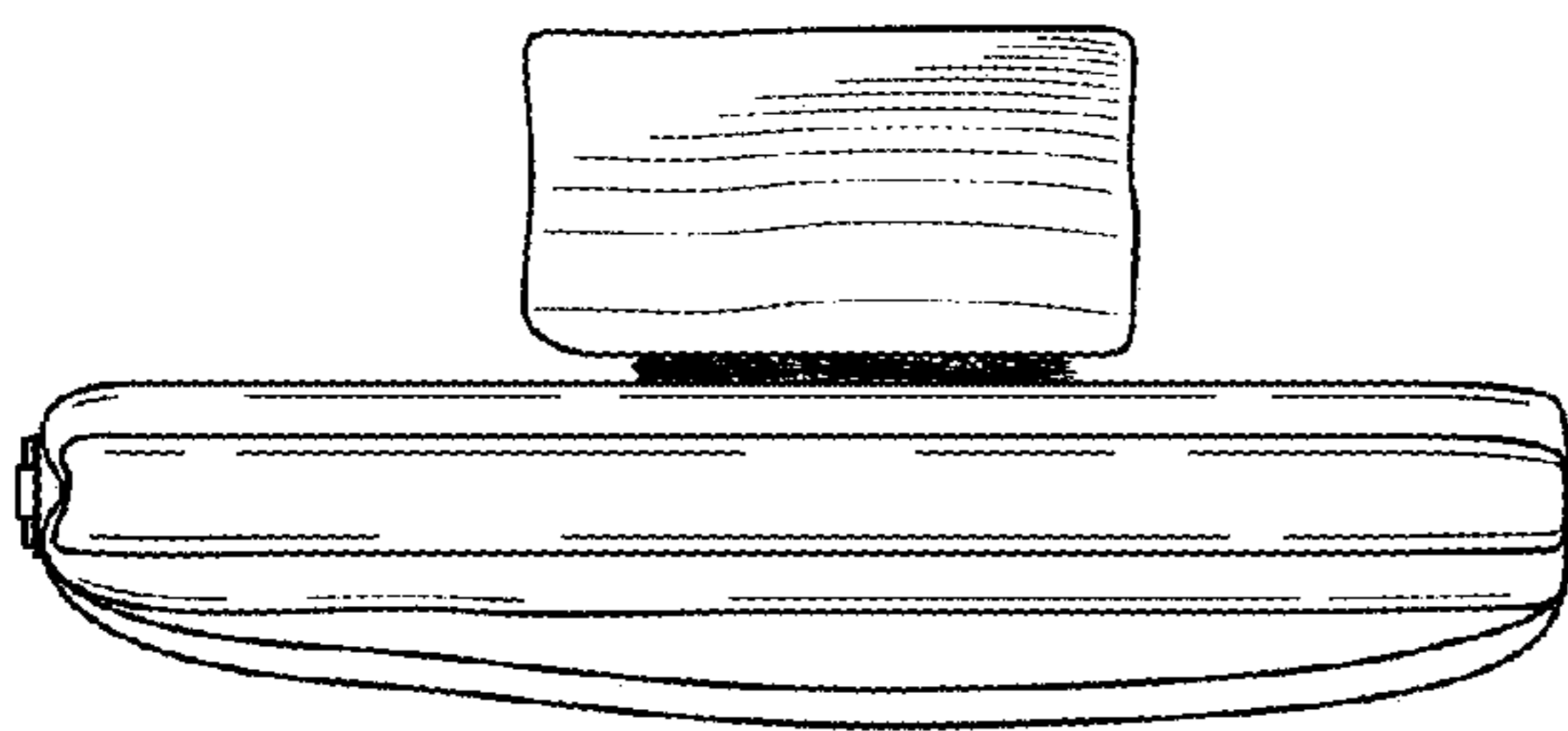

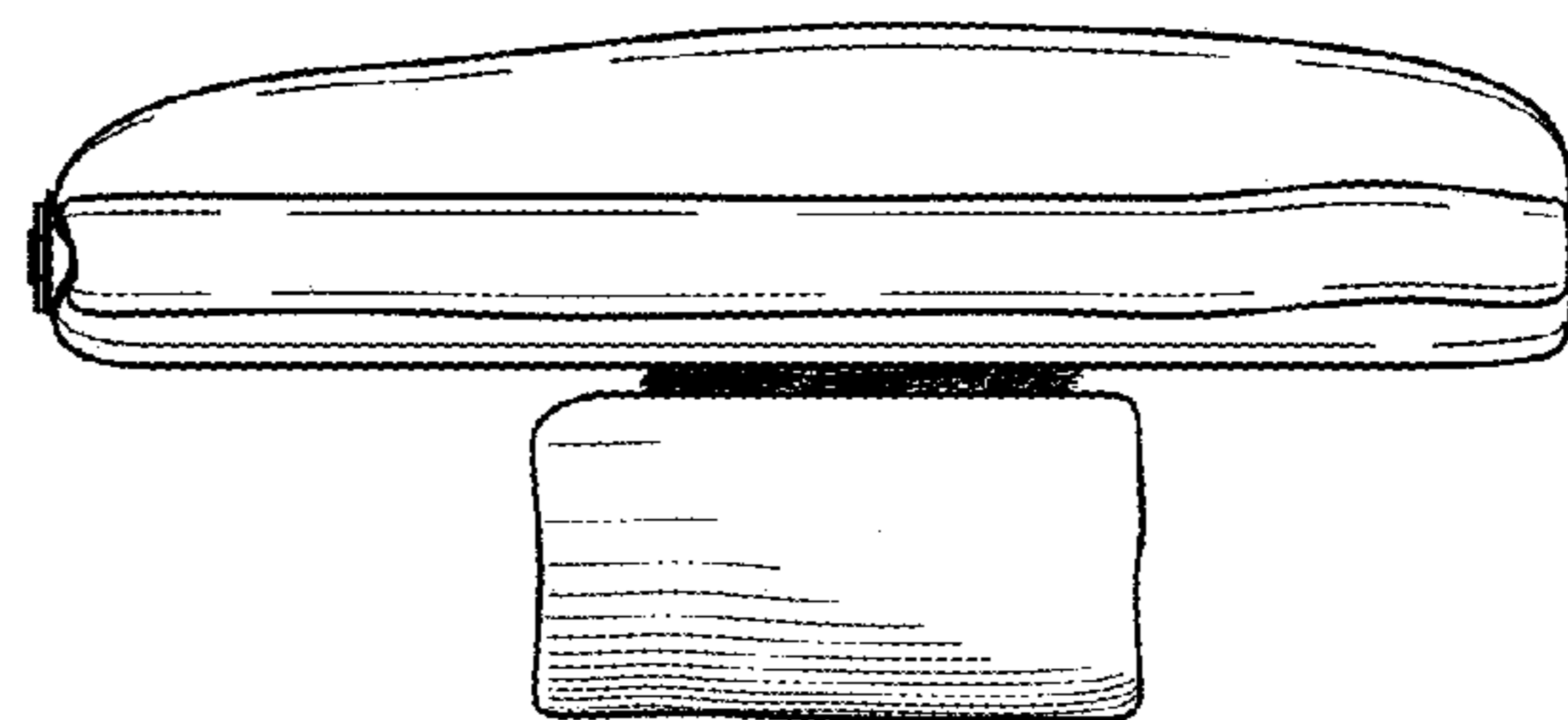

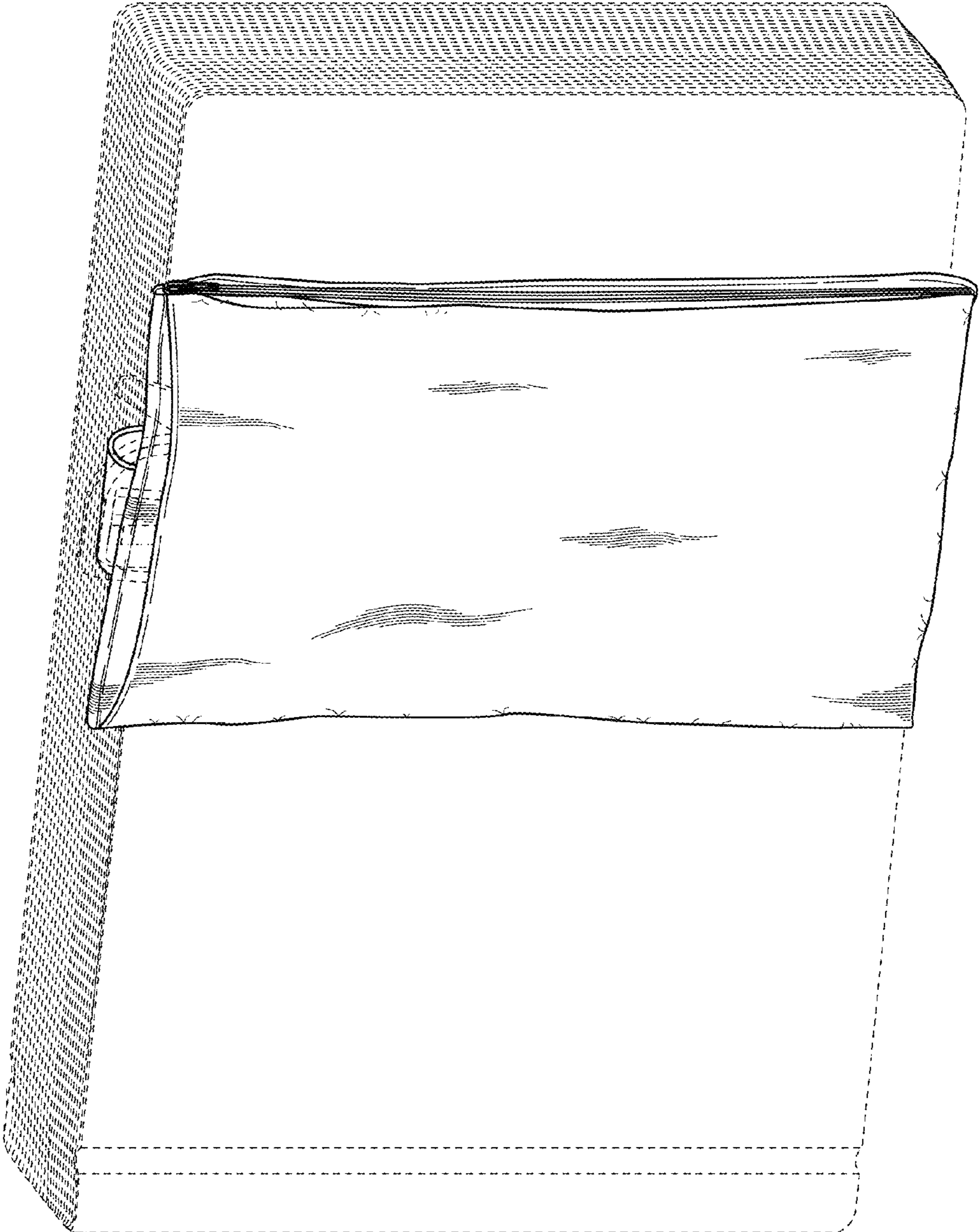

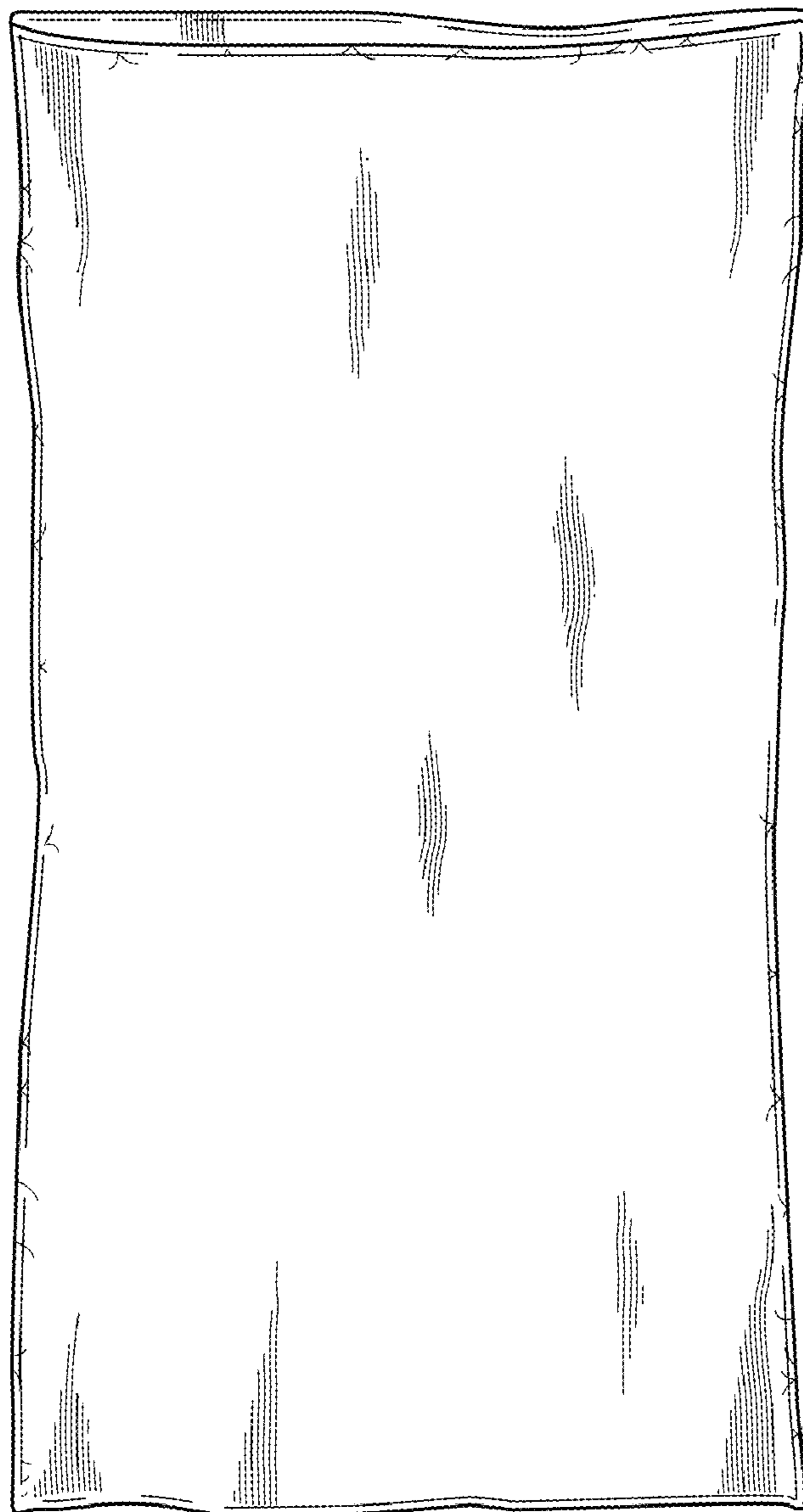

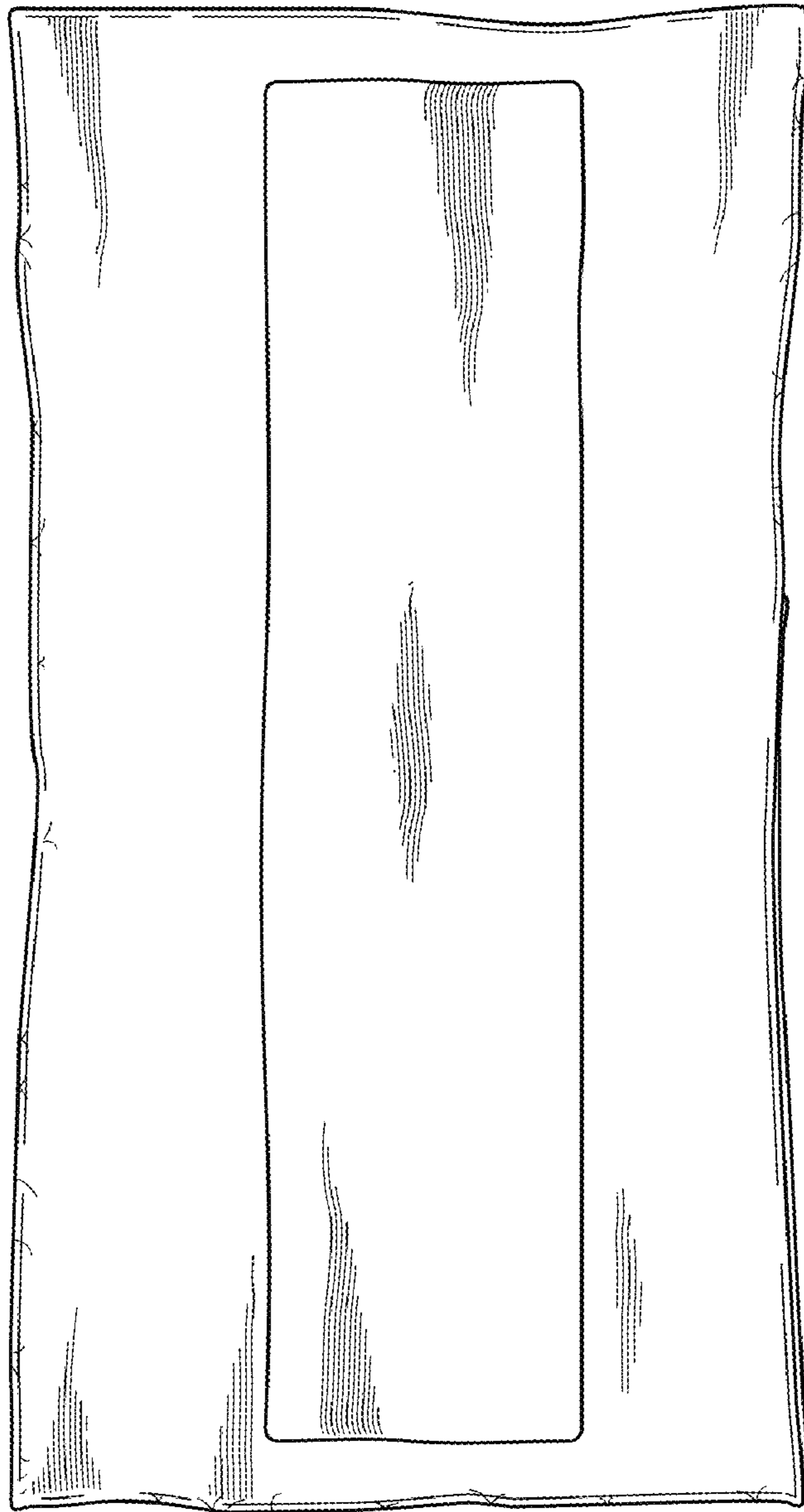

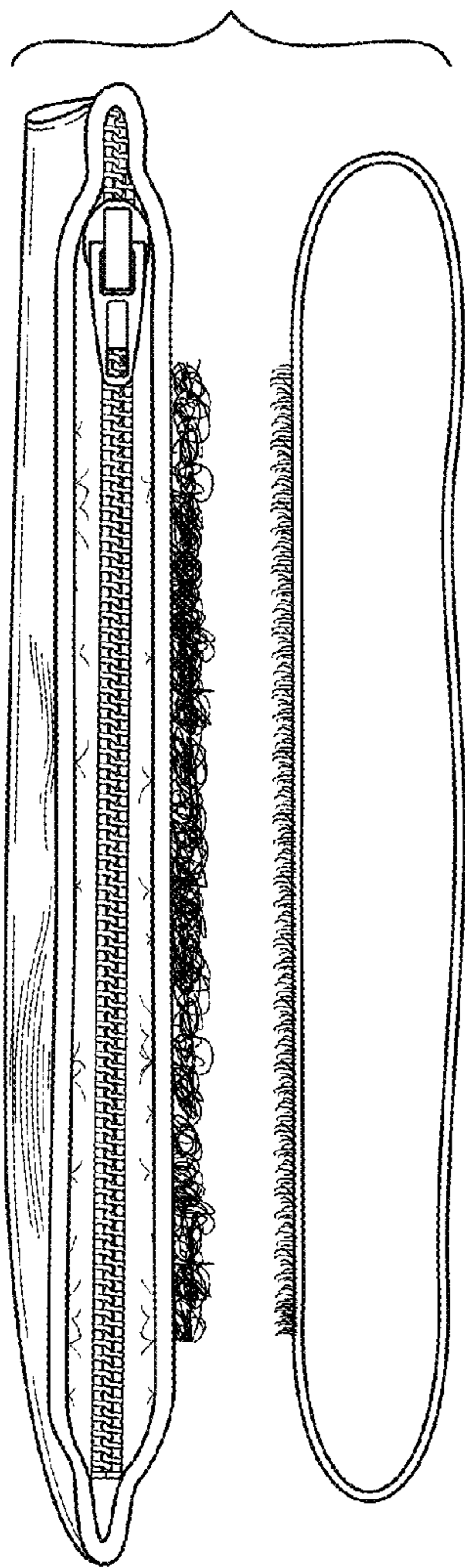

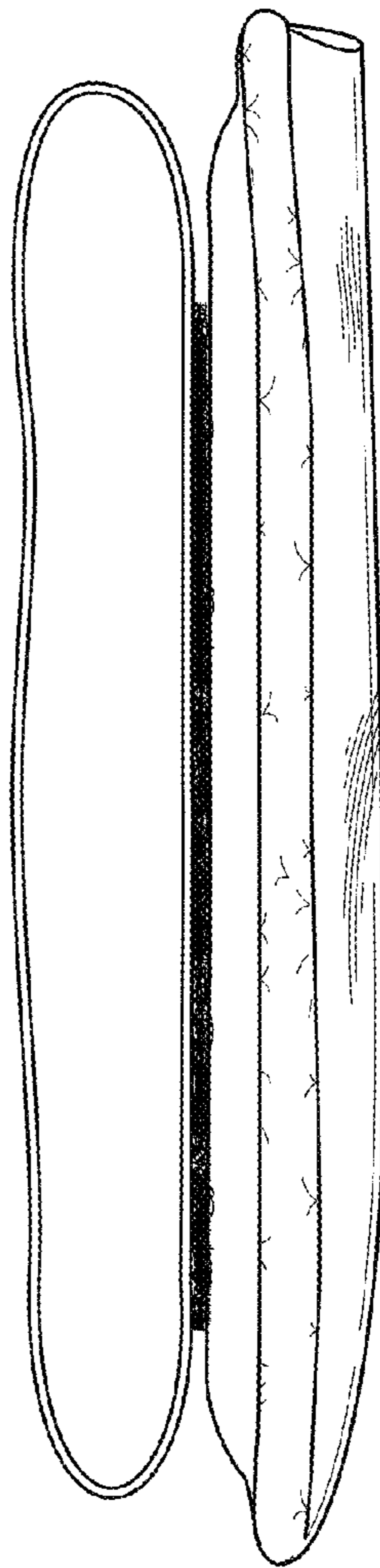

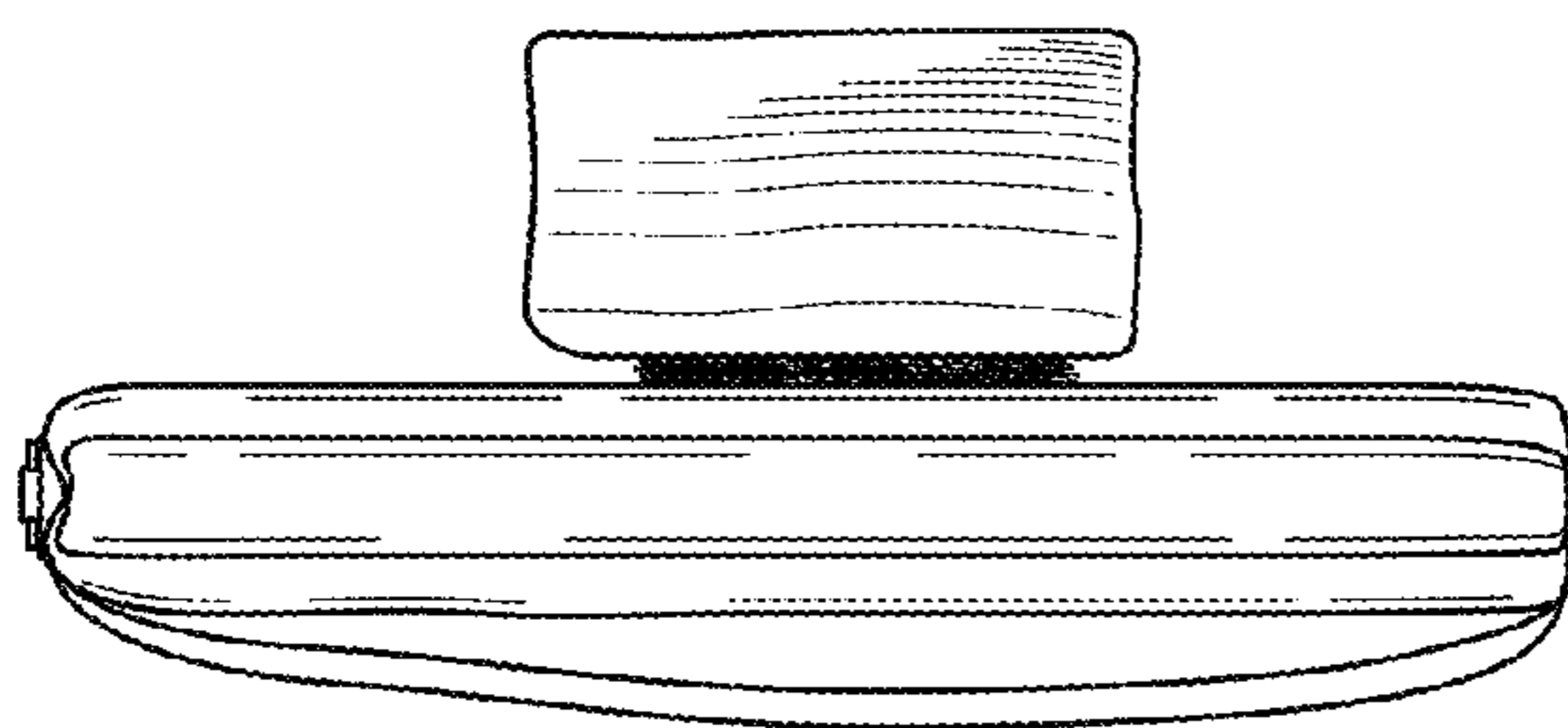

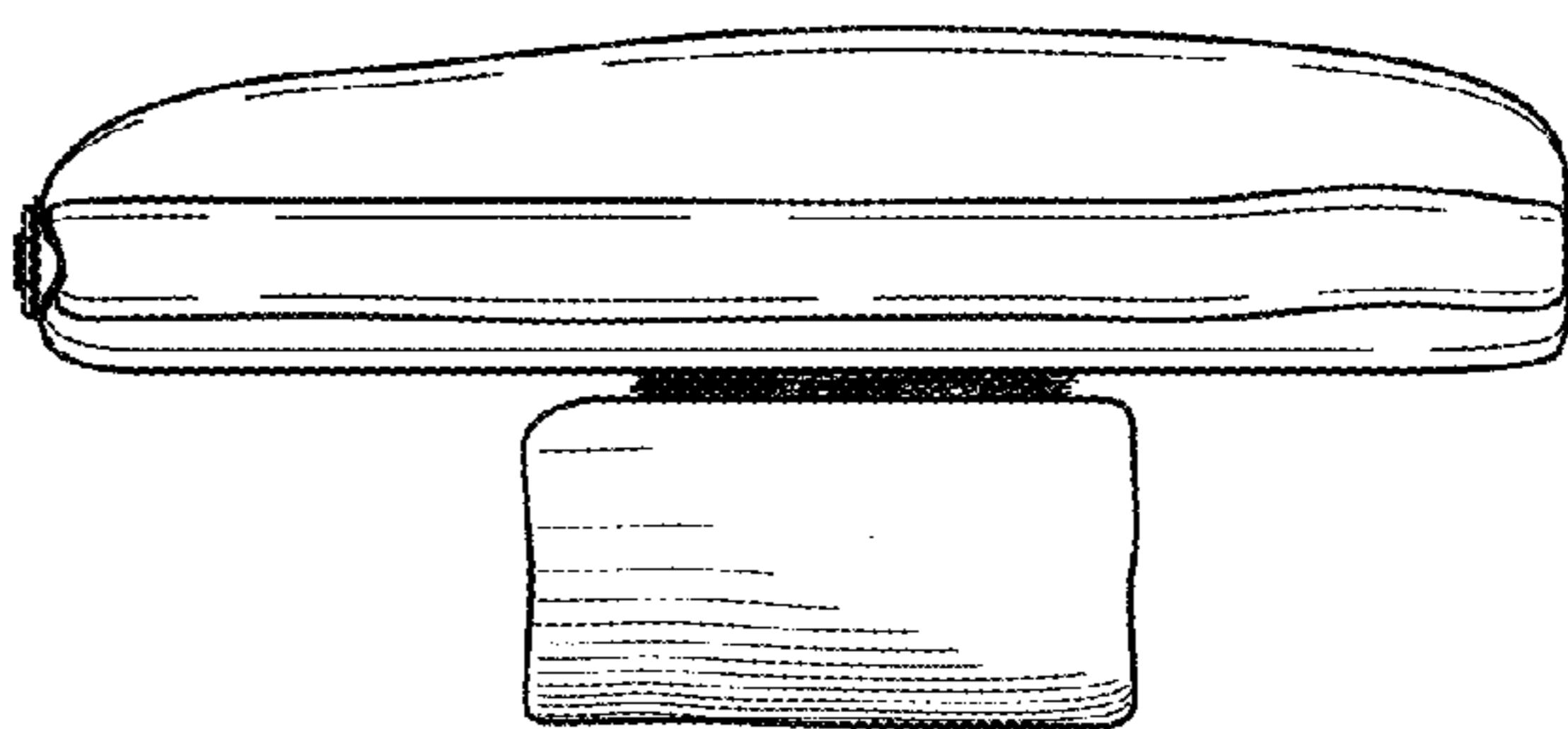

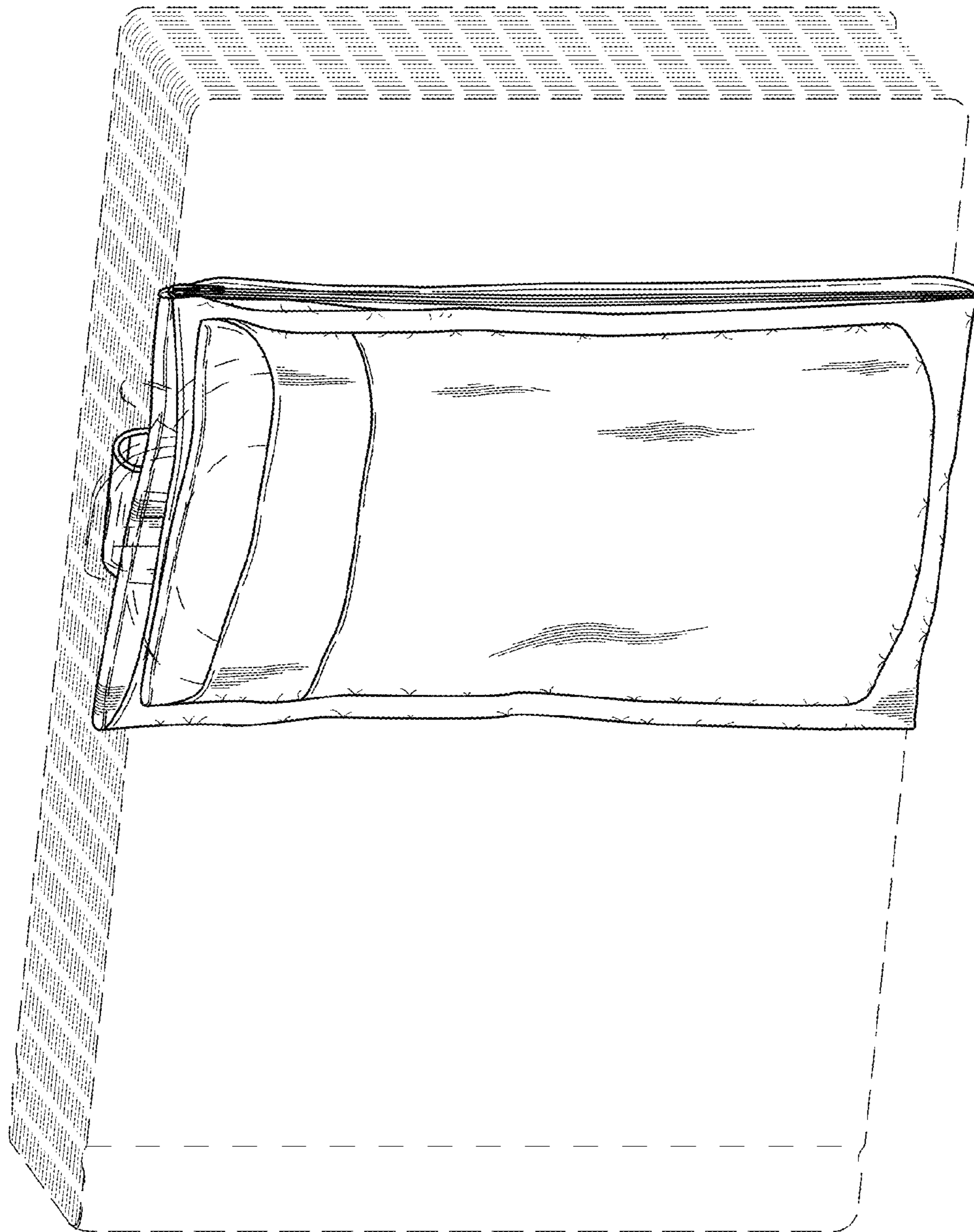

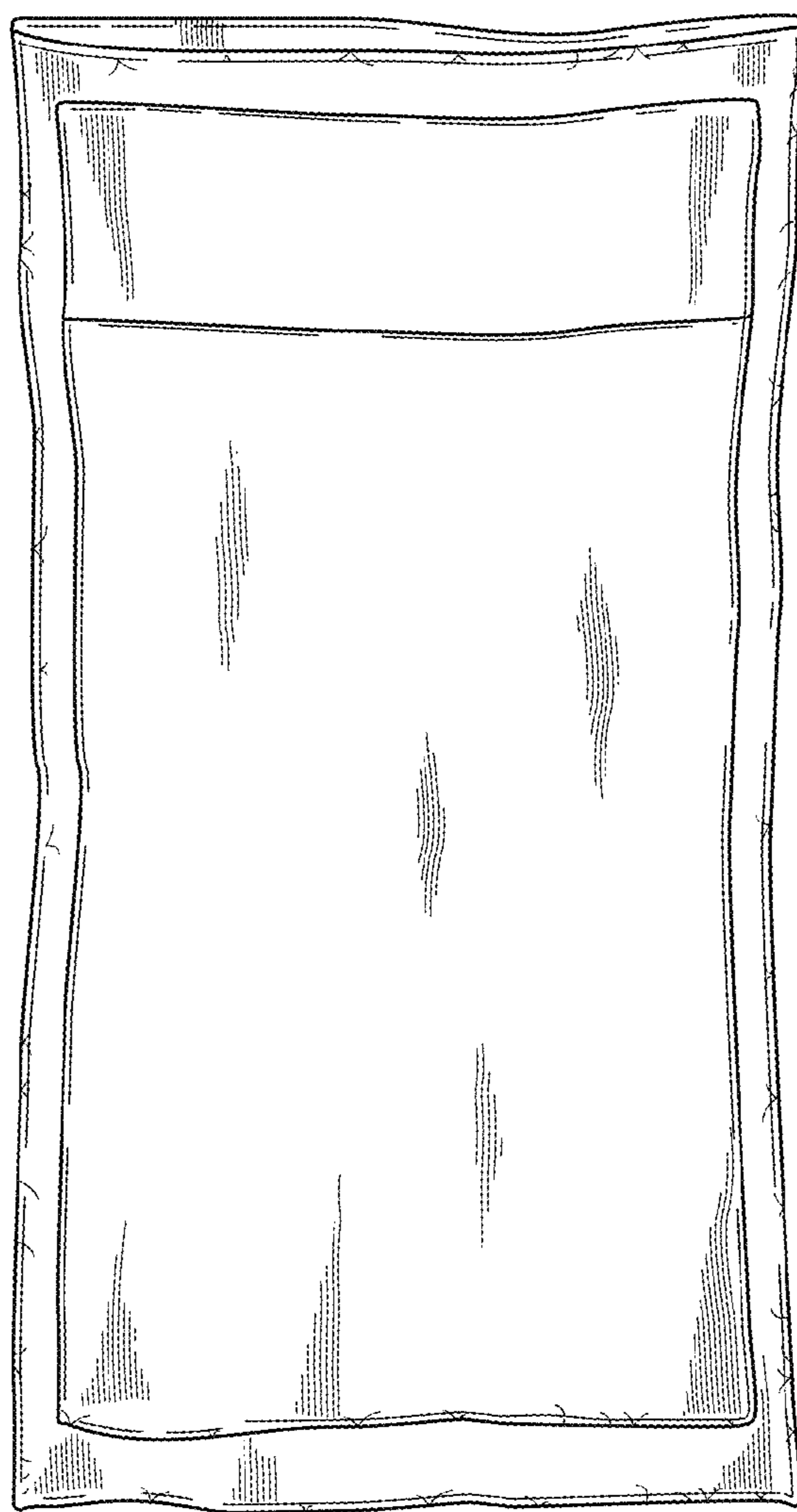

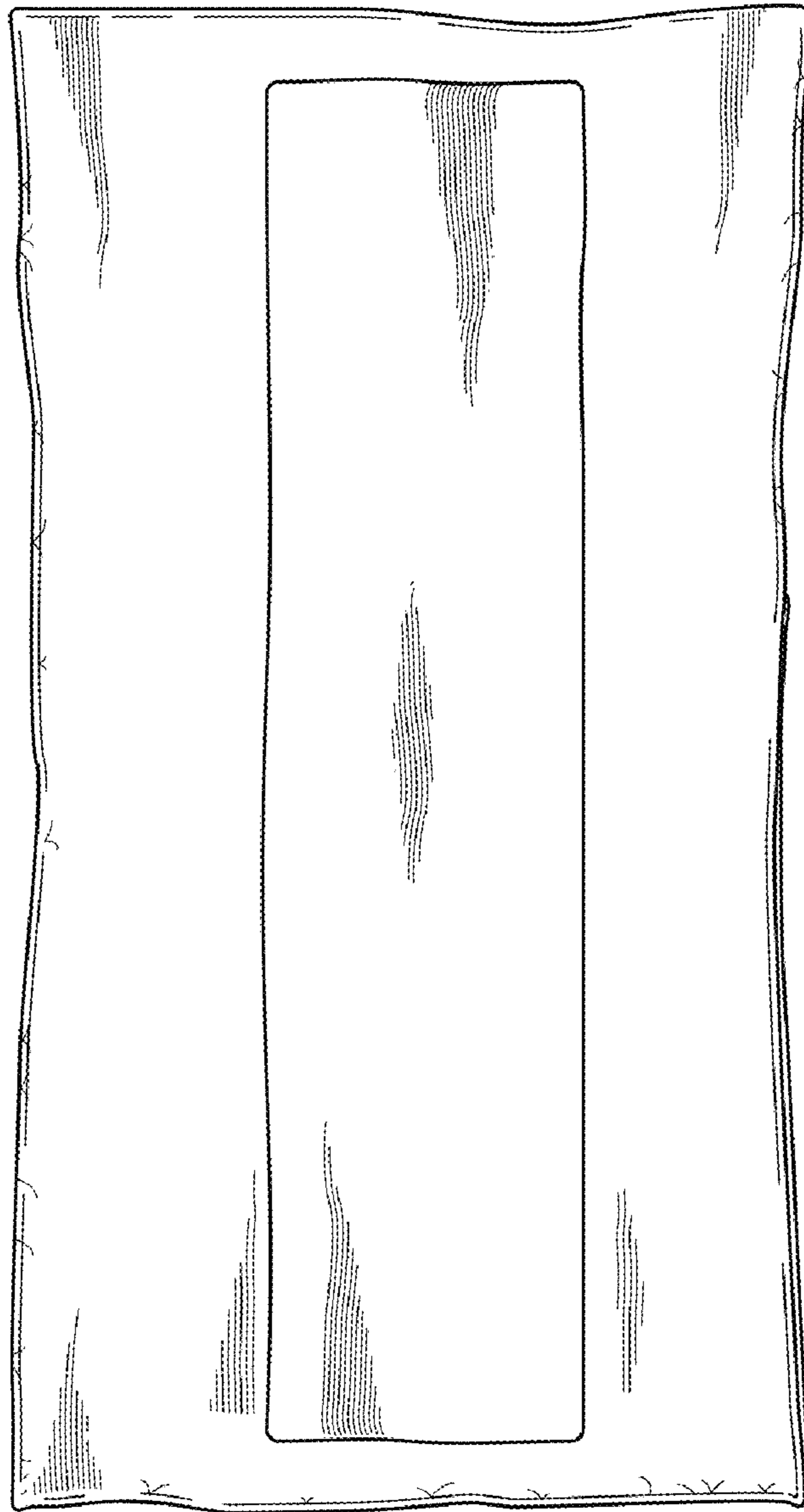

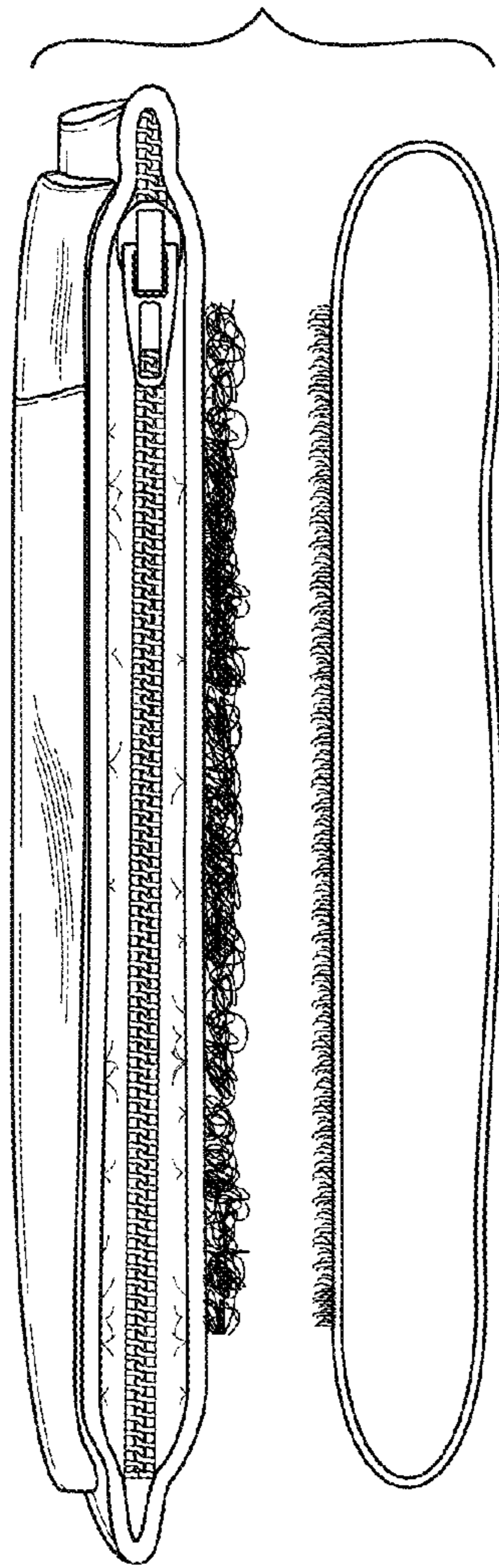

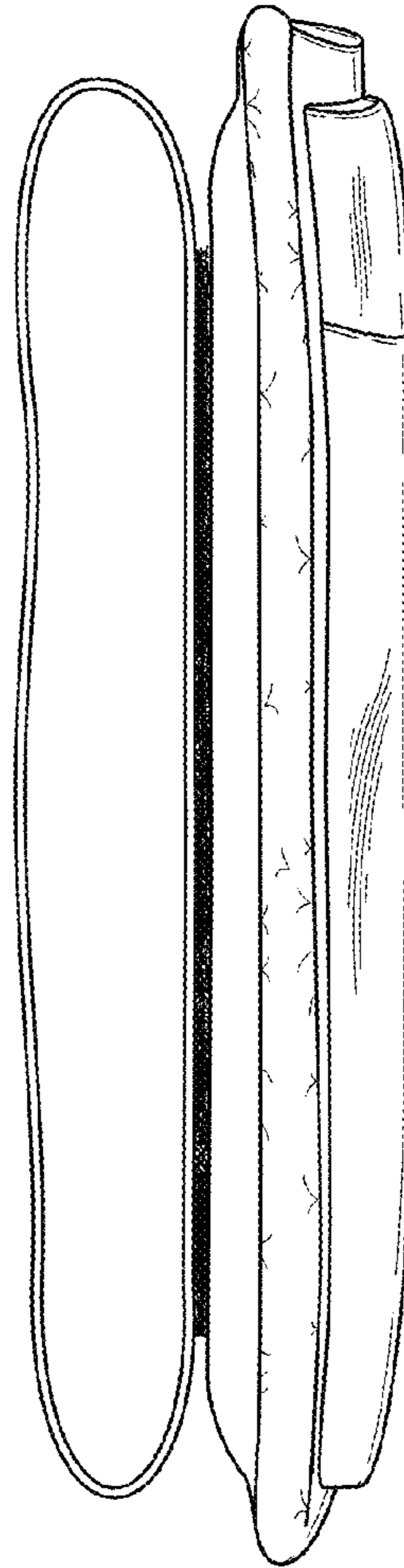

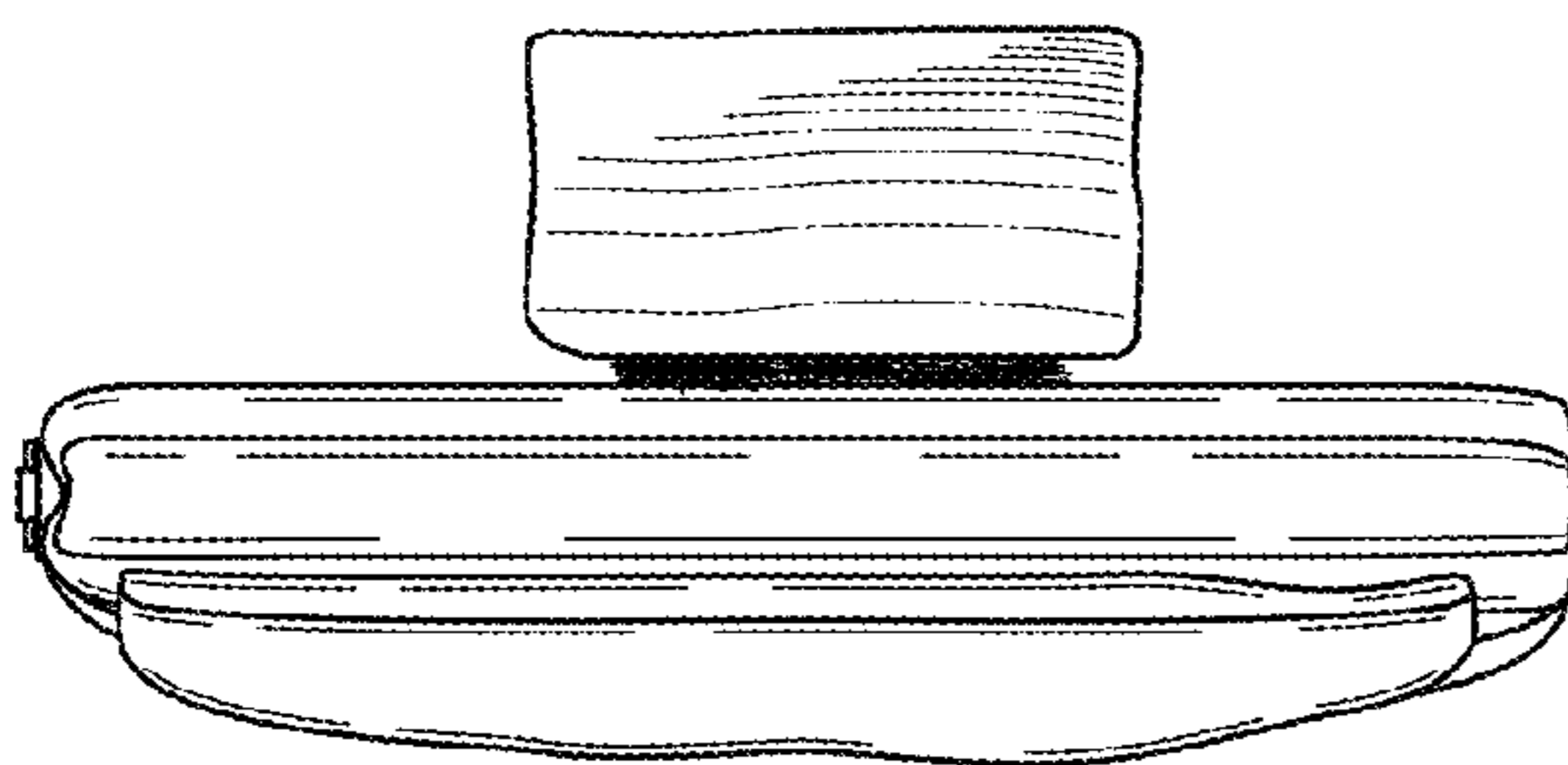

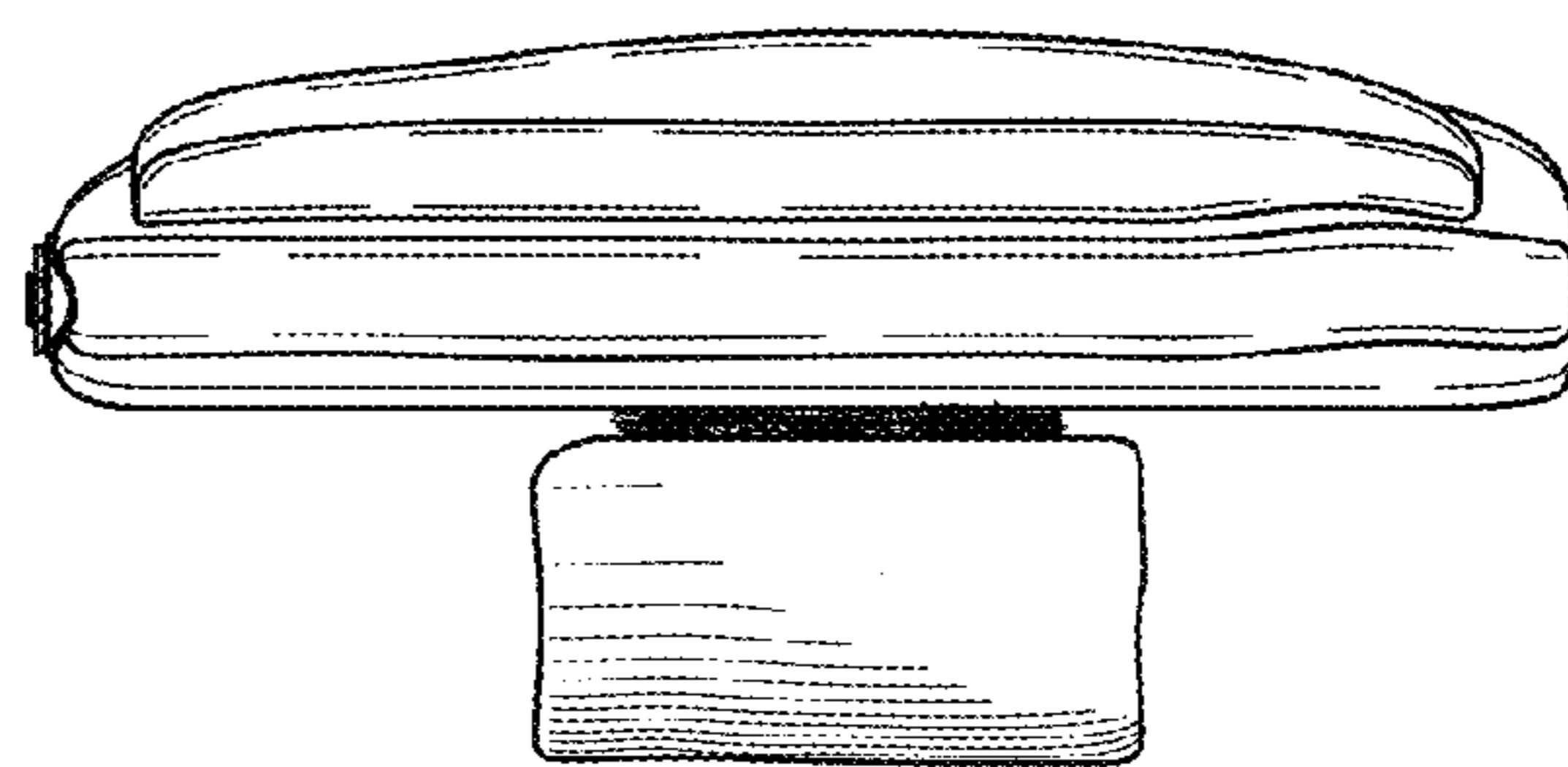

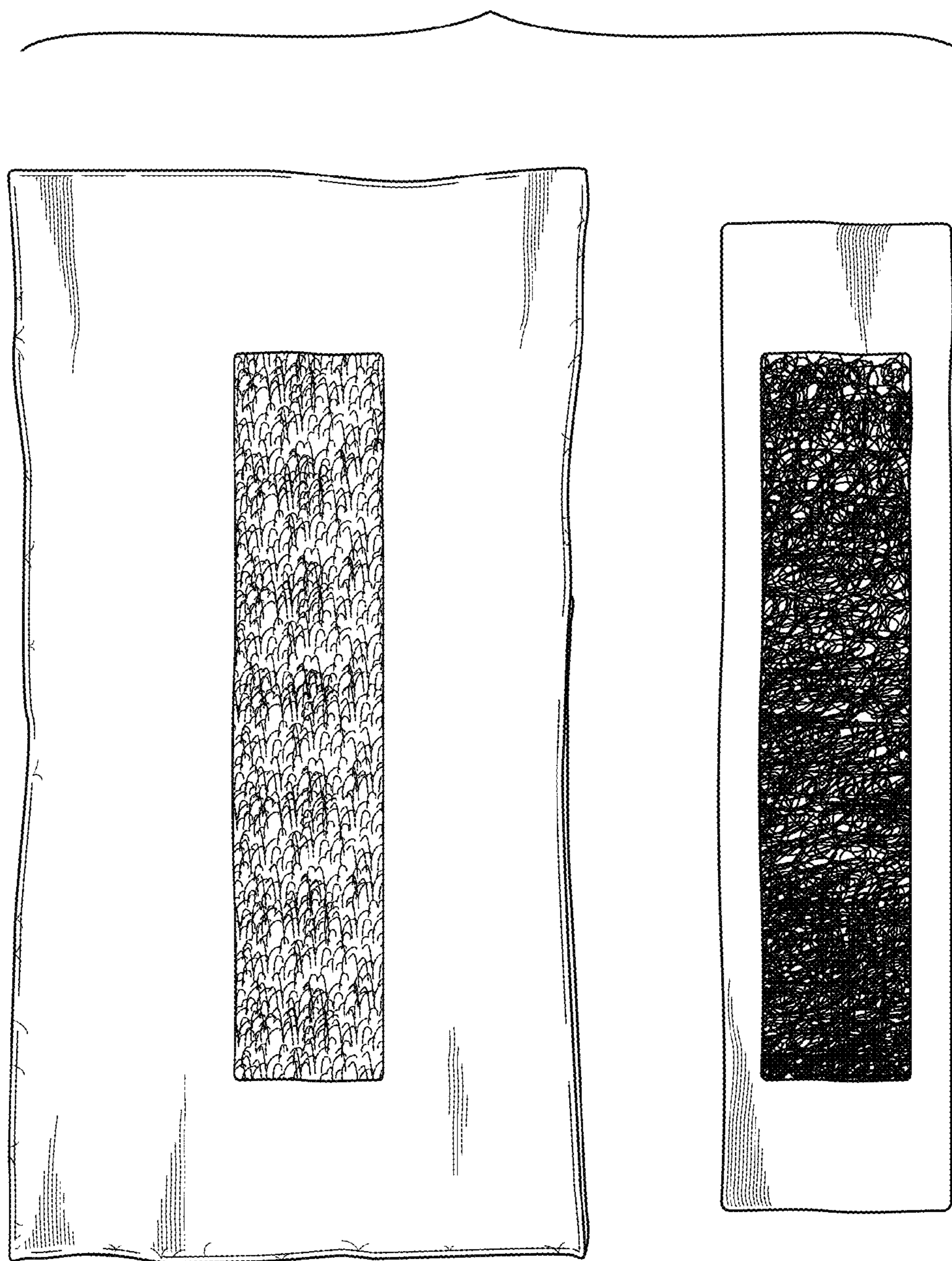
