**DESCRIPTION**

FIG. 1 is an upper right perspective view showing the top, front and left side of the case of my new design;

FIG. 2 is a top view thereof, the bottom view being the mirror image thereof;

FIG. 3 is a side view thereof, all side views being identical thereto;

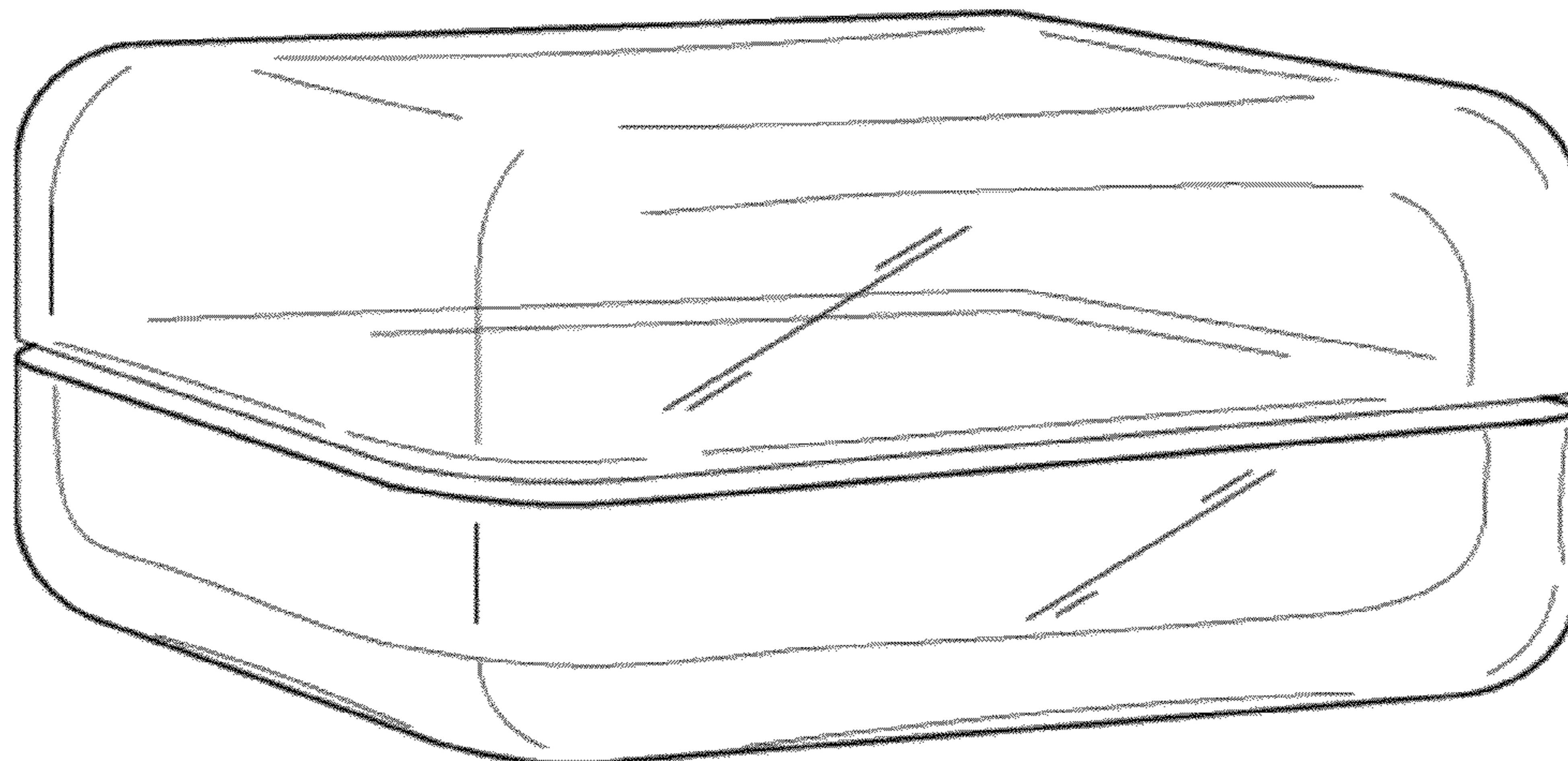
FIG. 4 is an upper right perspective view showing the top, front and left side of an alternate embodiment of the case of my new design, wherein the base is solid and not transparent;

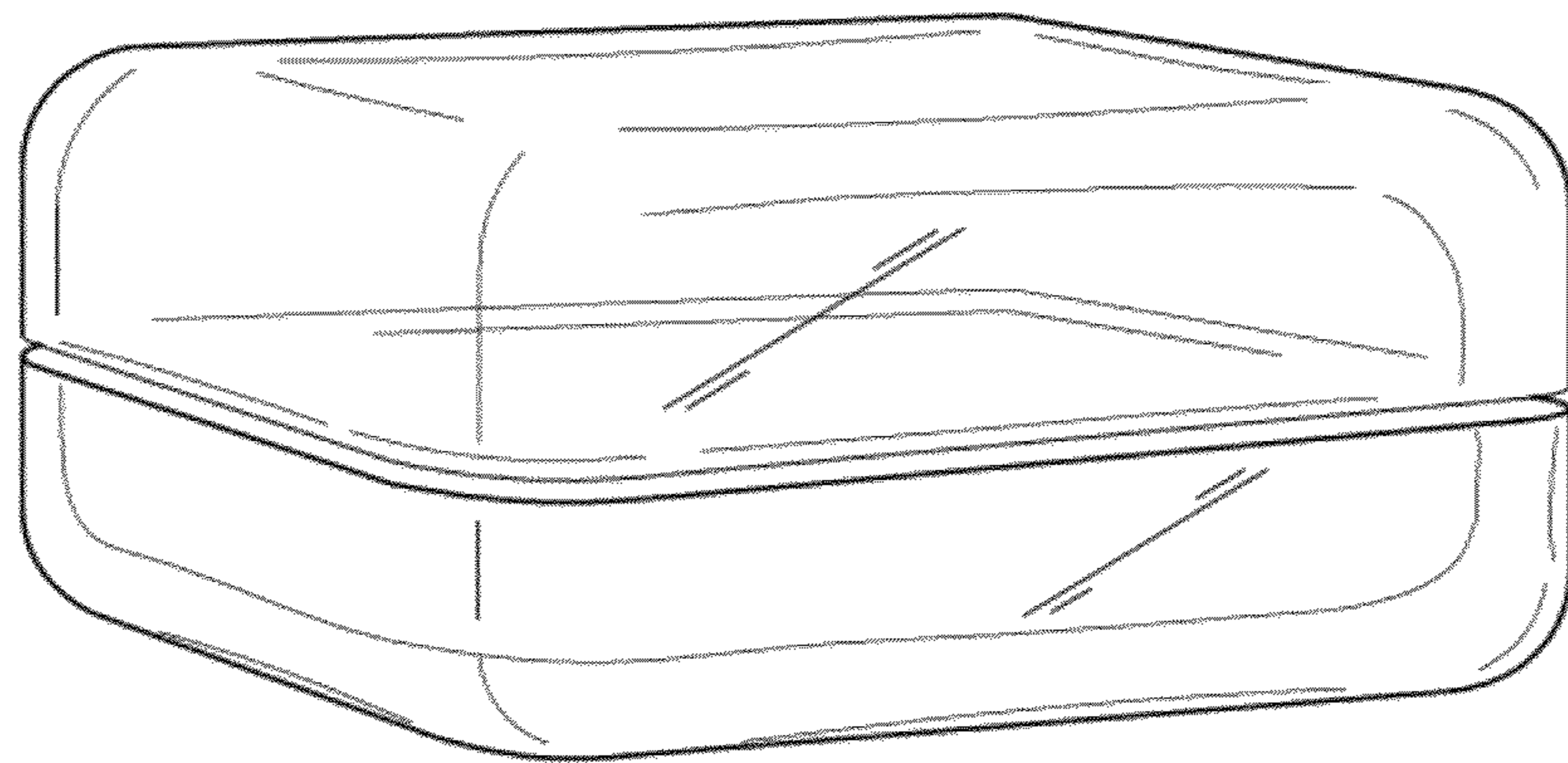
FIG. 5 is a top view thereof;

FIG. 6 is a side view thereof, all side views being identical thereto; and,

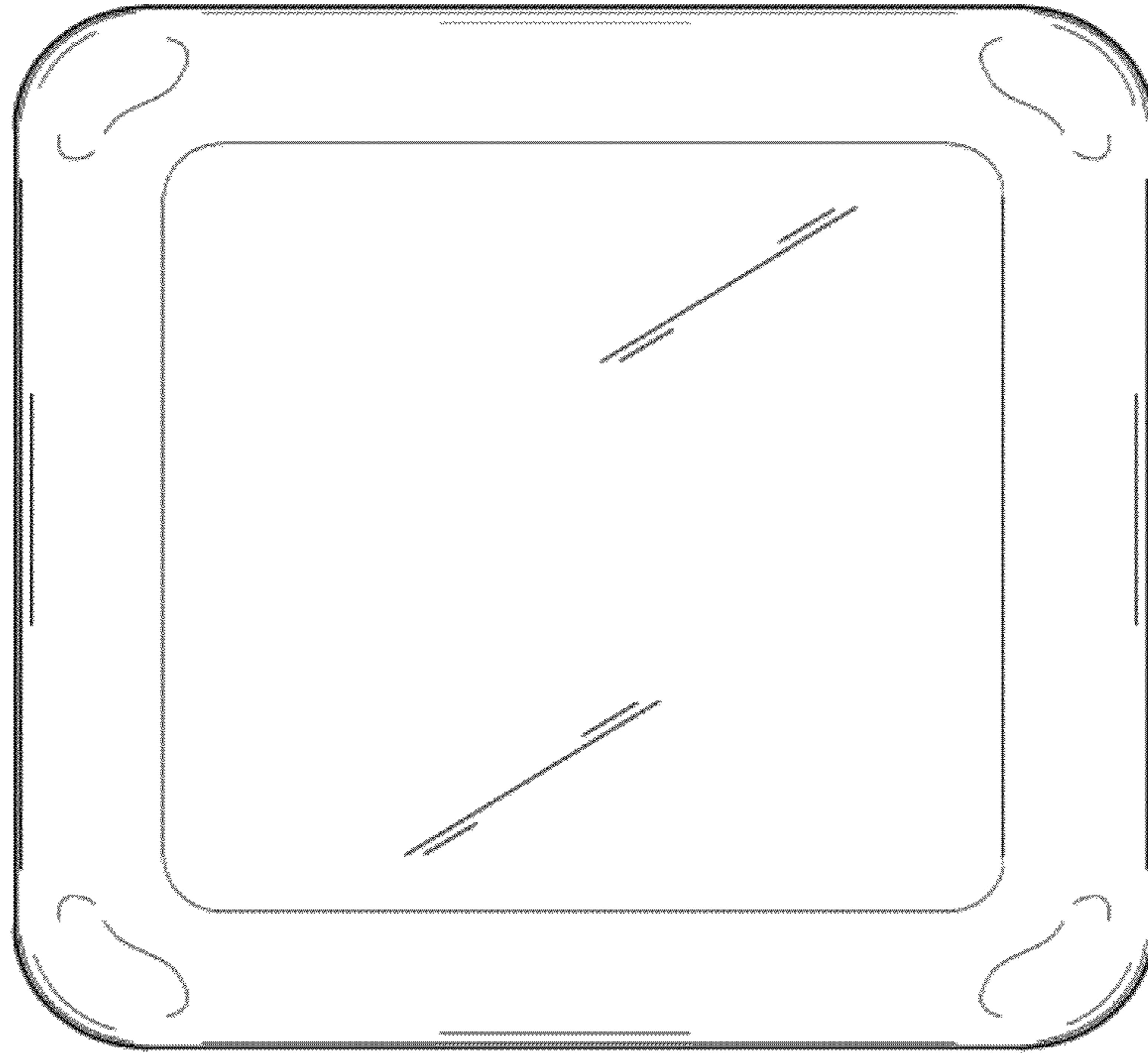
FIG. 7 is a bottom view thereof.

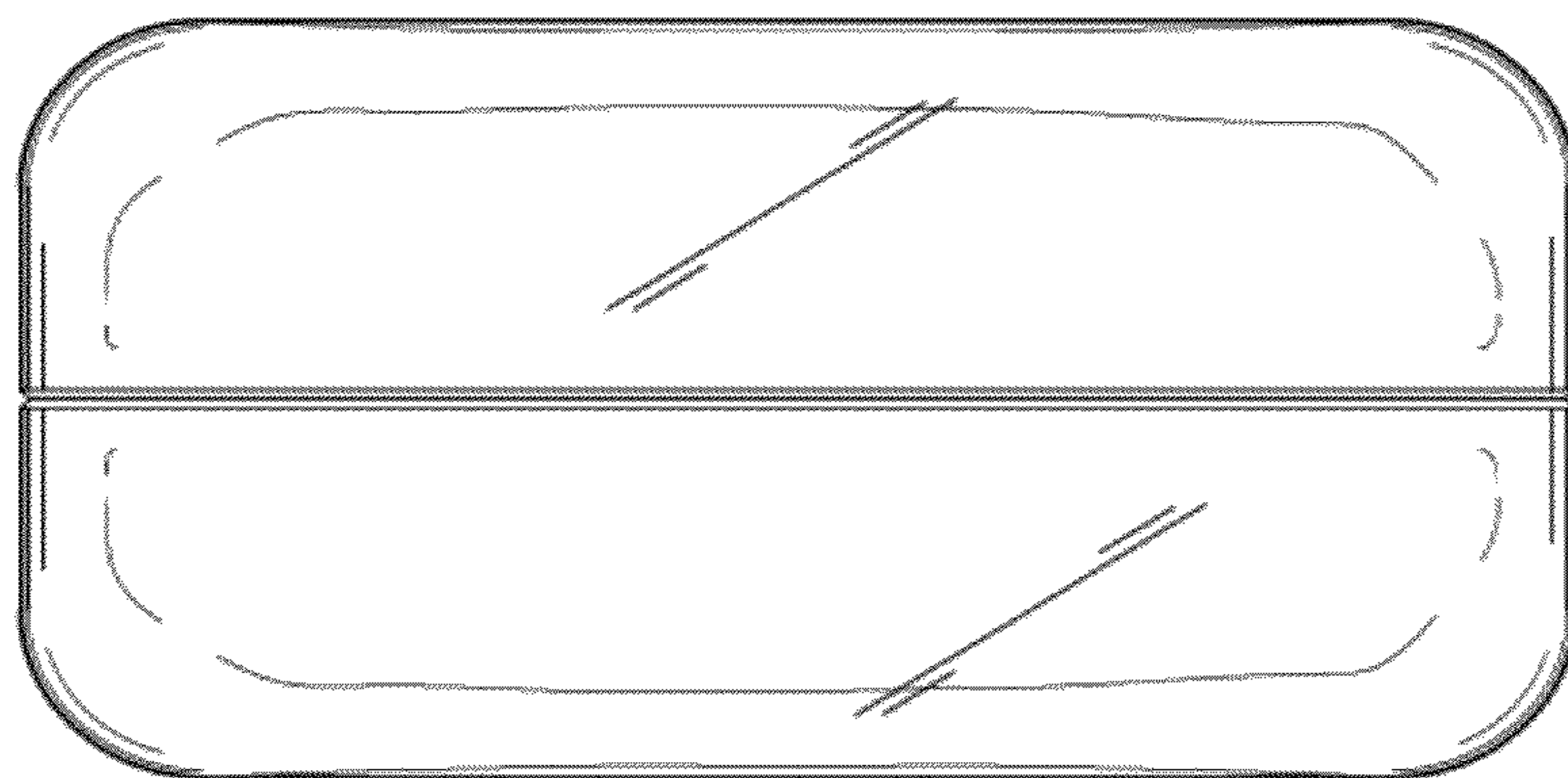




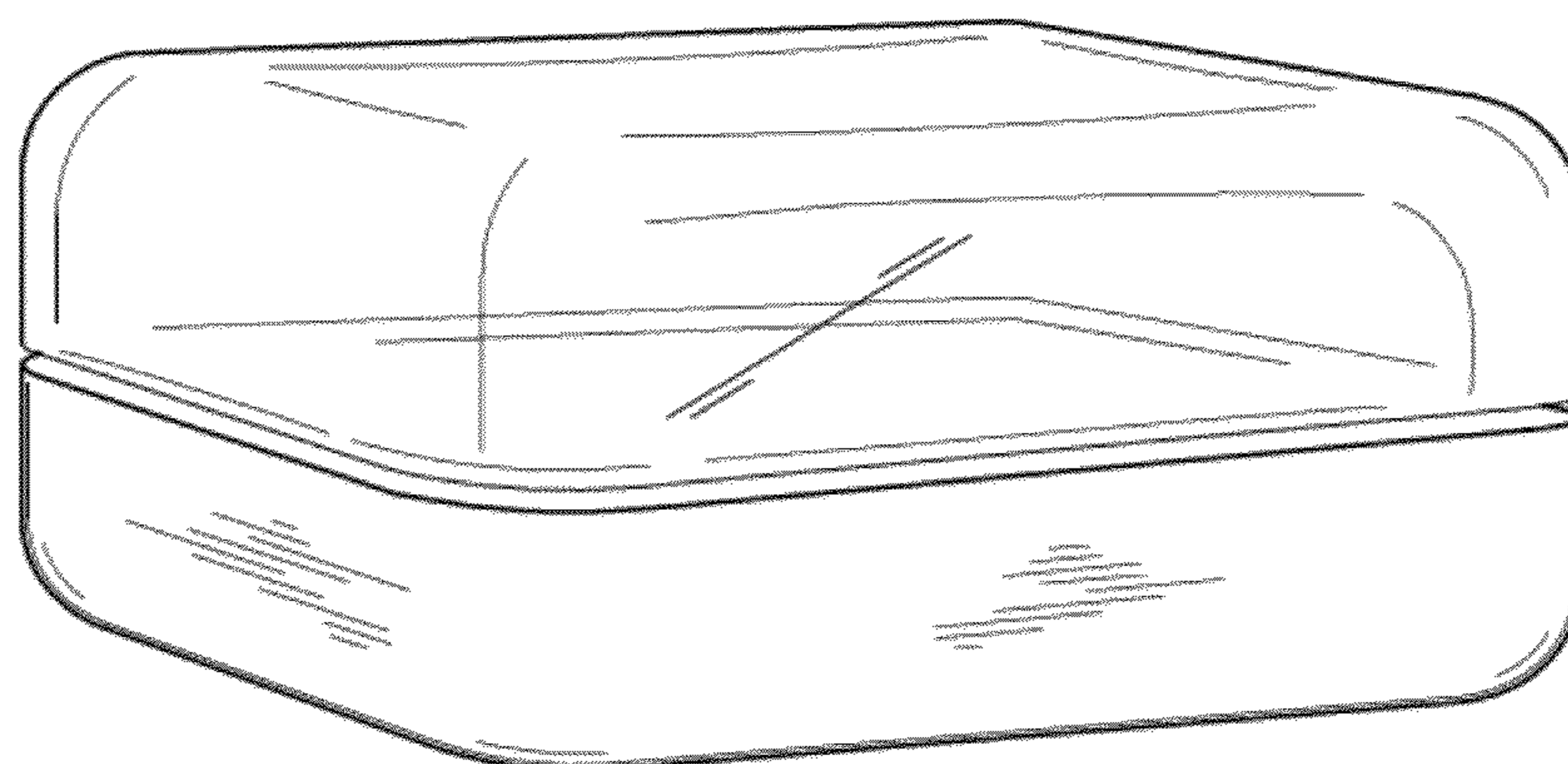

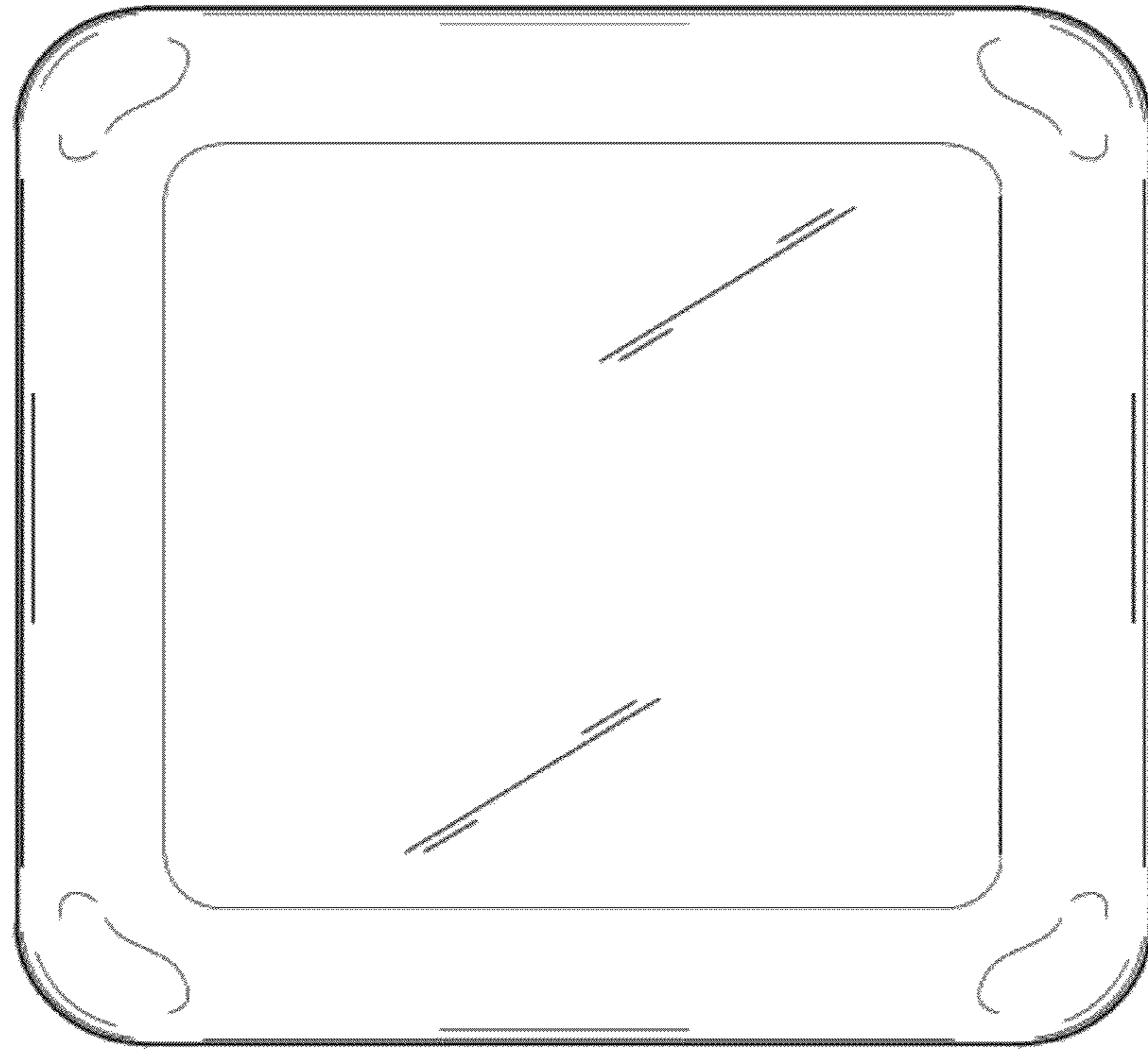

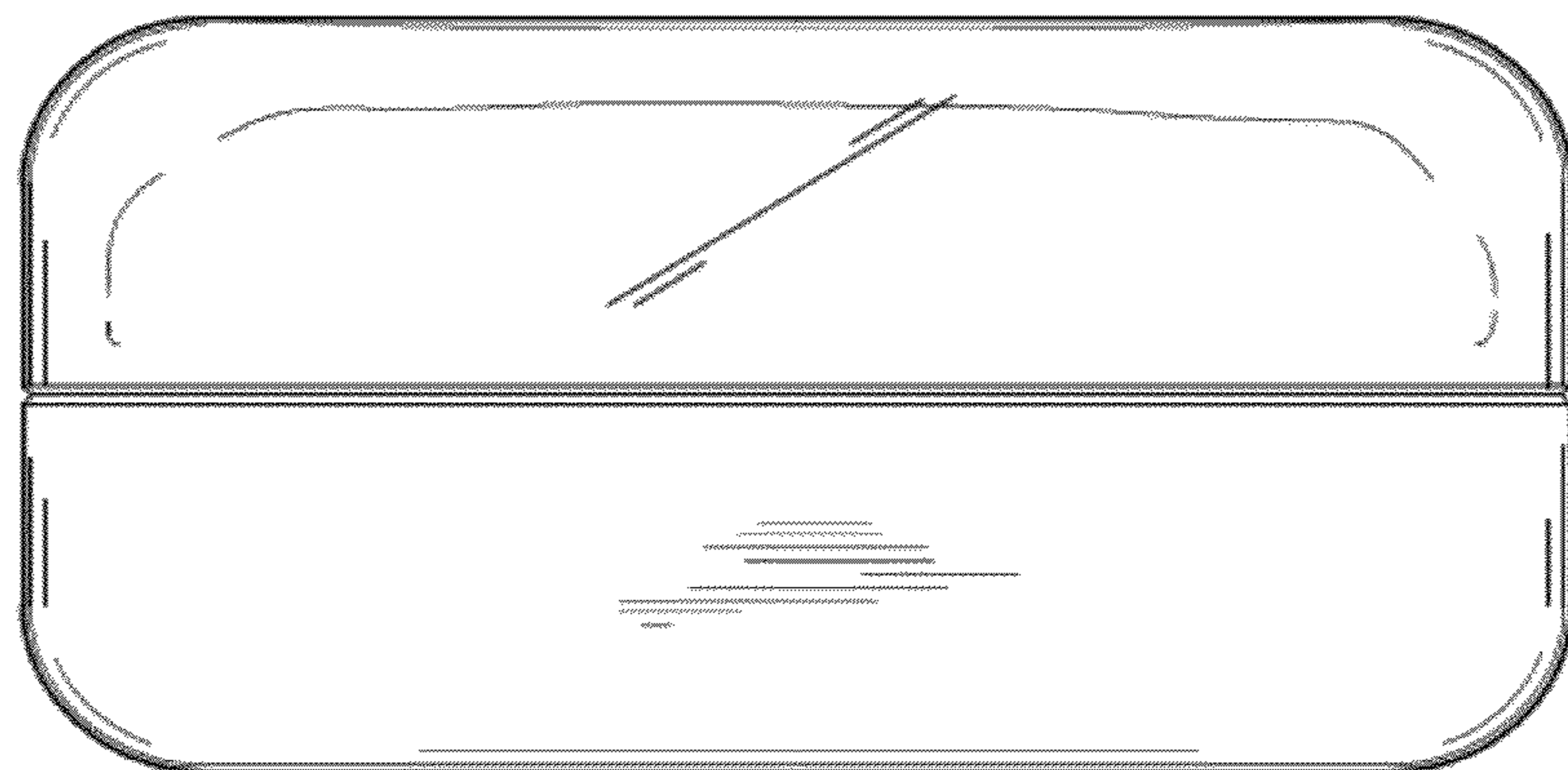
