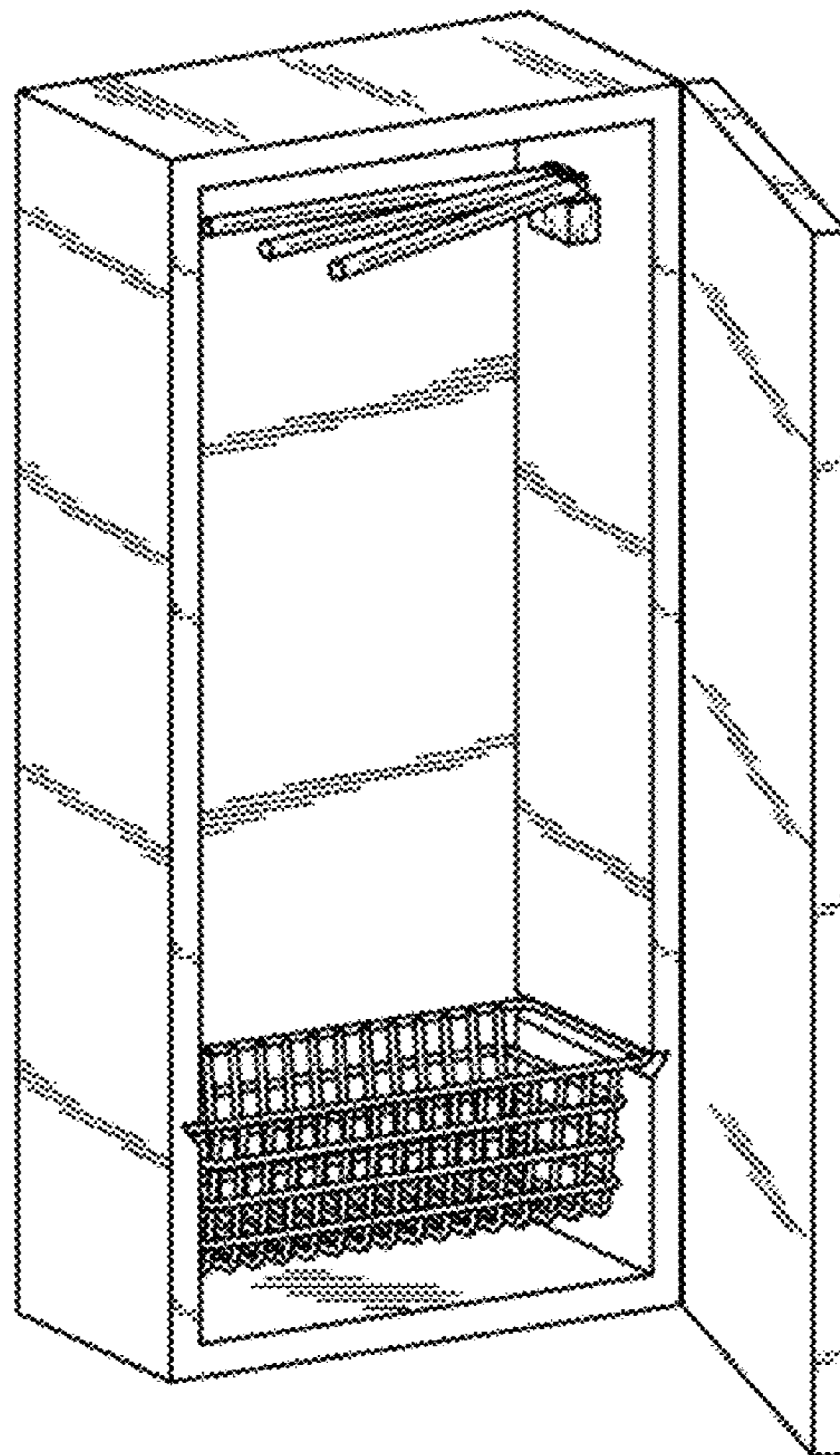
(57) **CLAIM**

I claim the ornamental design for a towel cabinet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a towel cabinet showing my new design in a partially open position; FIG. 2 is a front elevational view of FIG. 1; FIG. 3 is a rear elevational view of FIG. 1; FIG. 4 is a left-side elevational view of FIG. 1; FIG. 5 is a top plan view of FIG. 1; FIG. 6 is a bottom plan view of FIG. 1; FIG. 7 is a right-side elevational view of FIG. 1; and, FIG. 8 is a perspective view thereof, illustrated in a closed position.

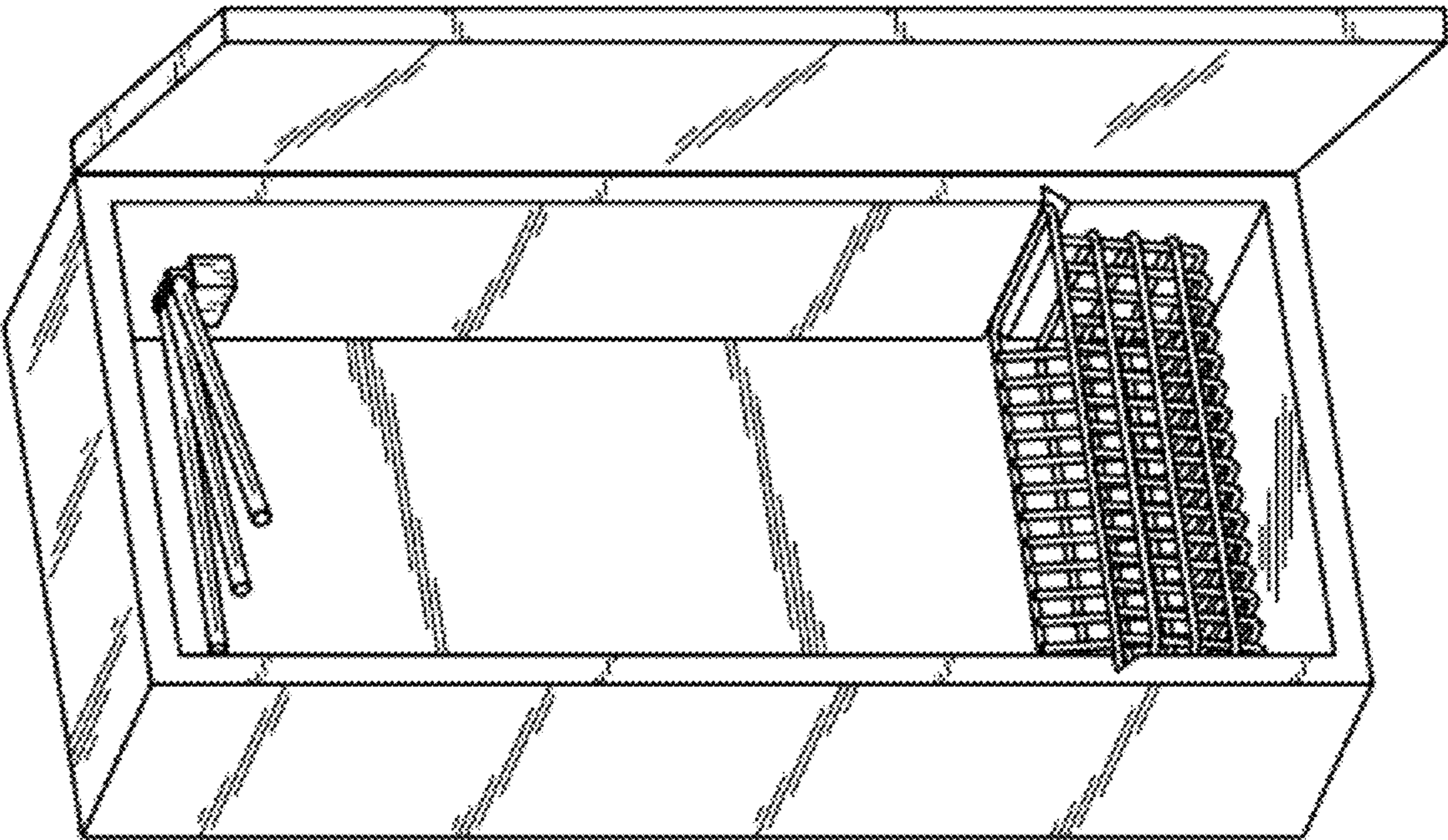

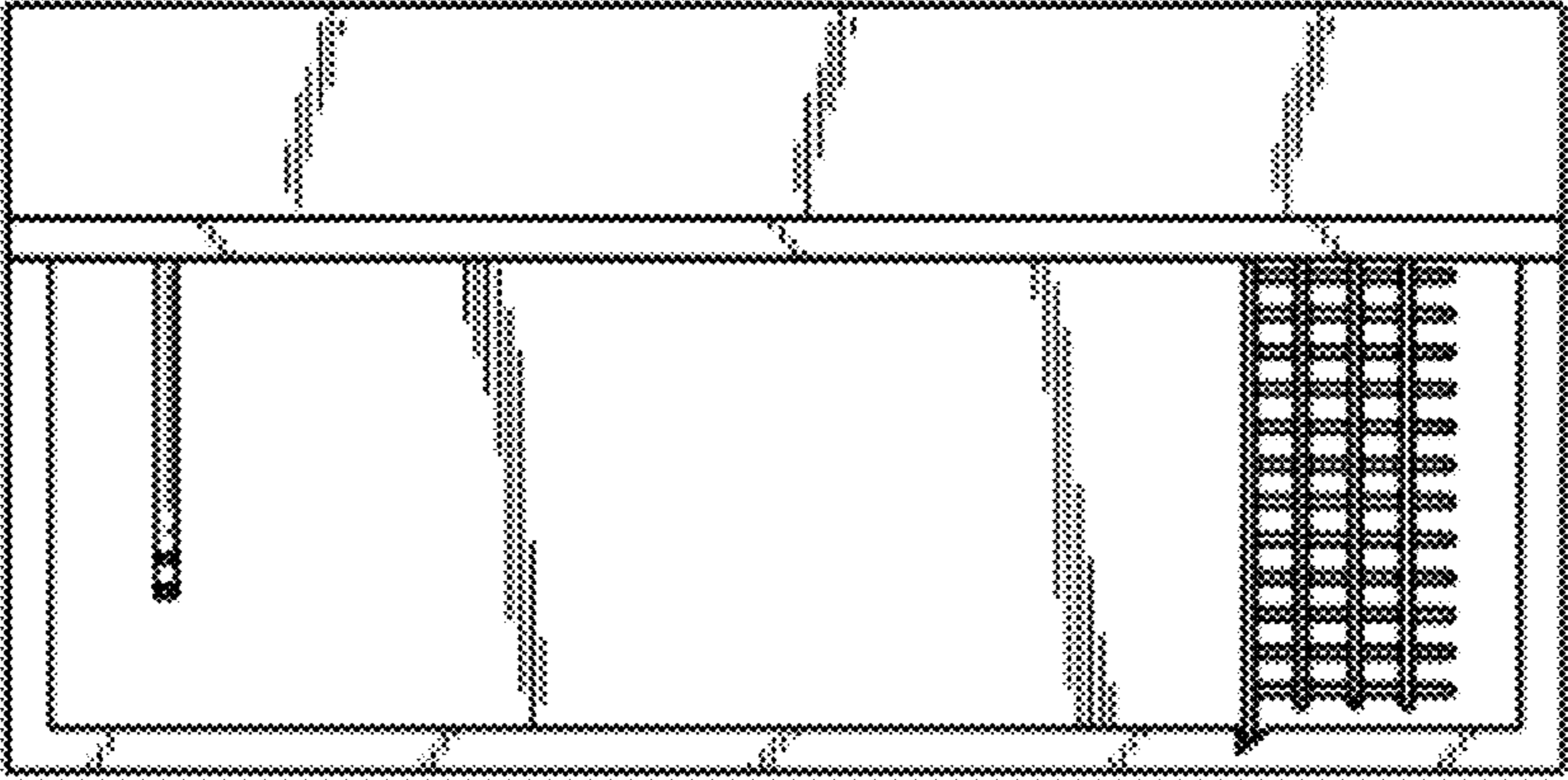

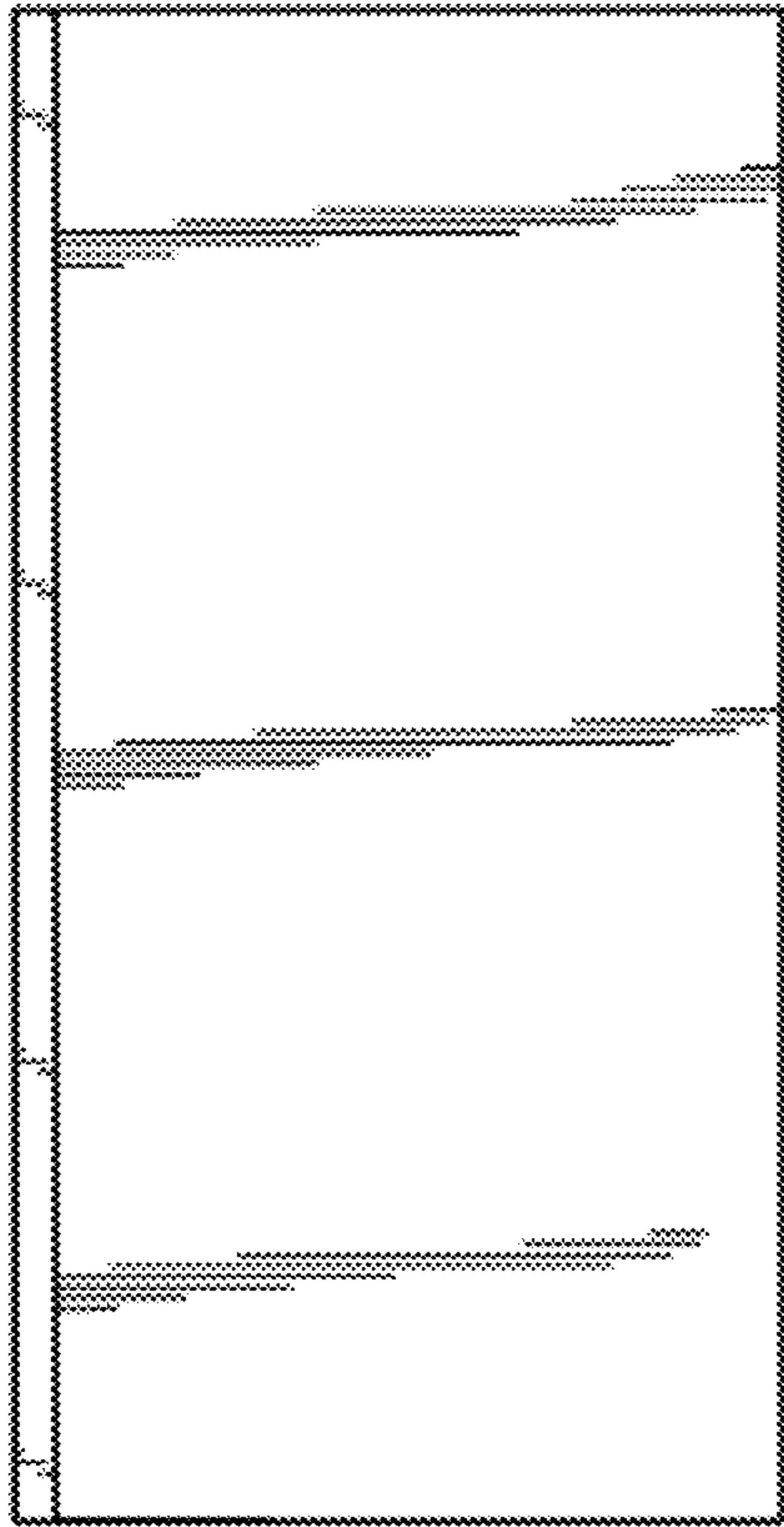

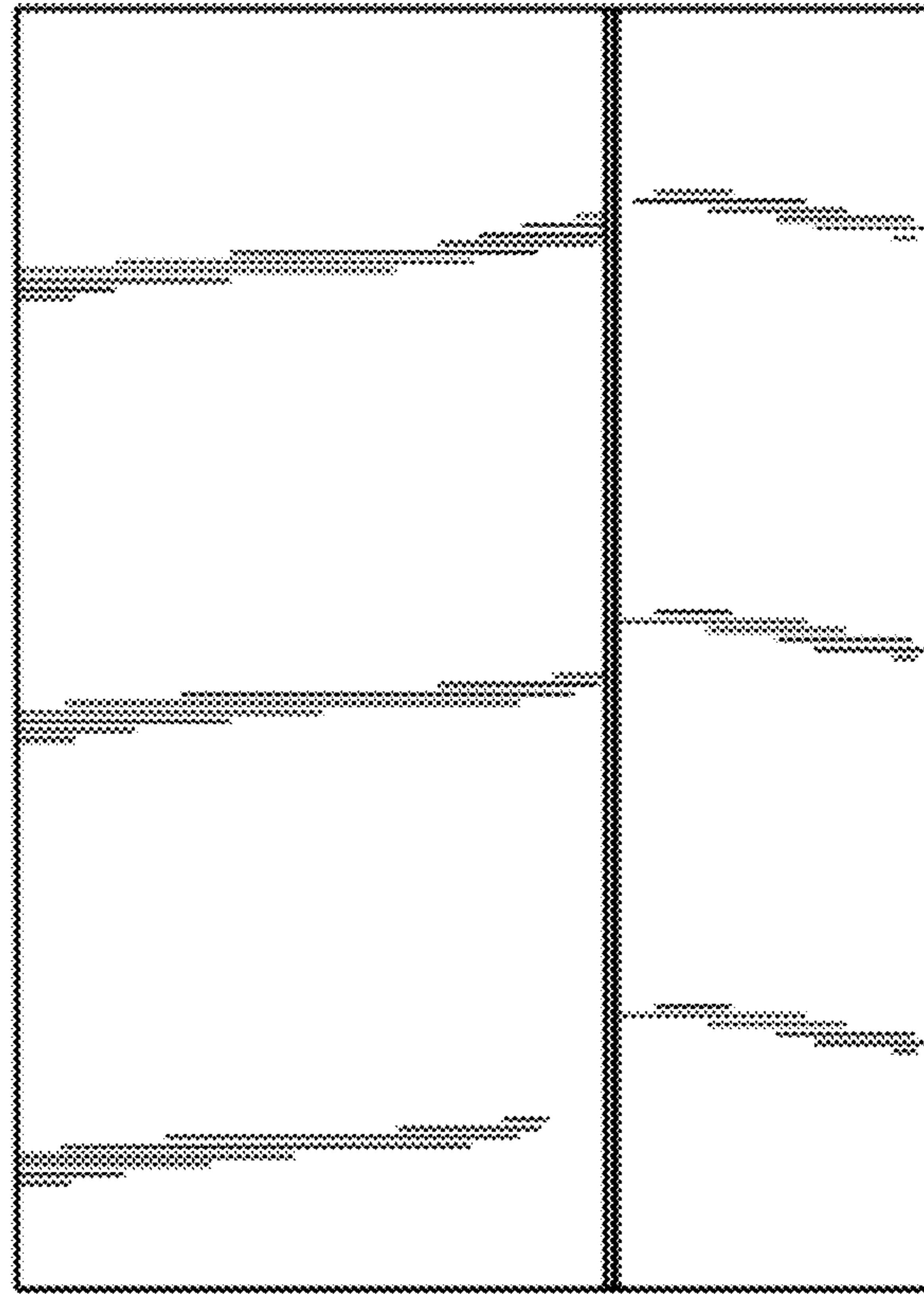

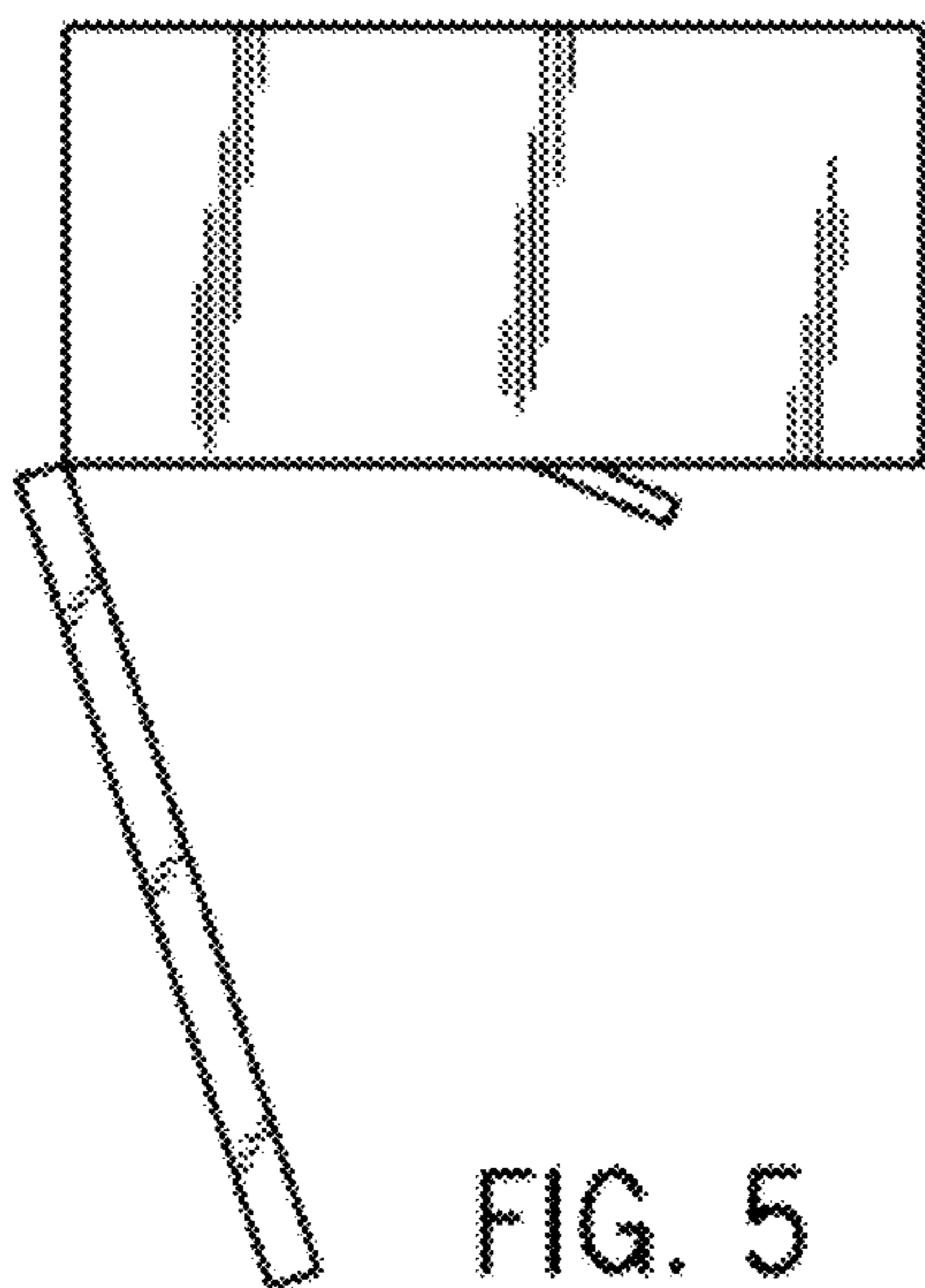

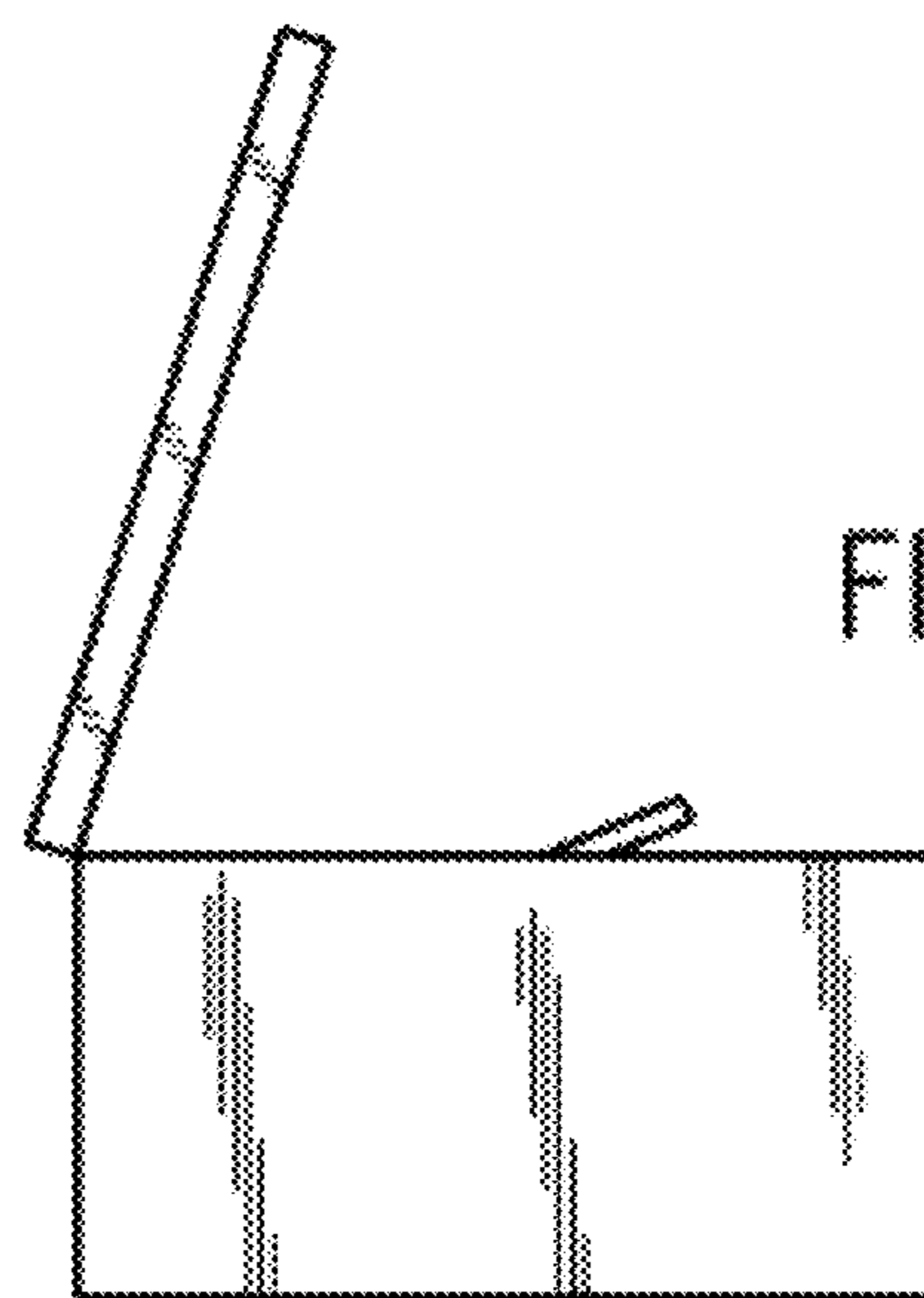

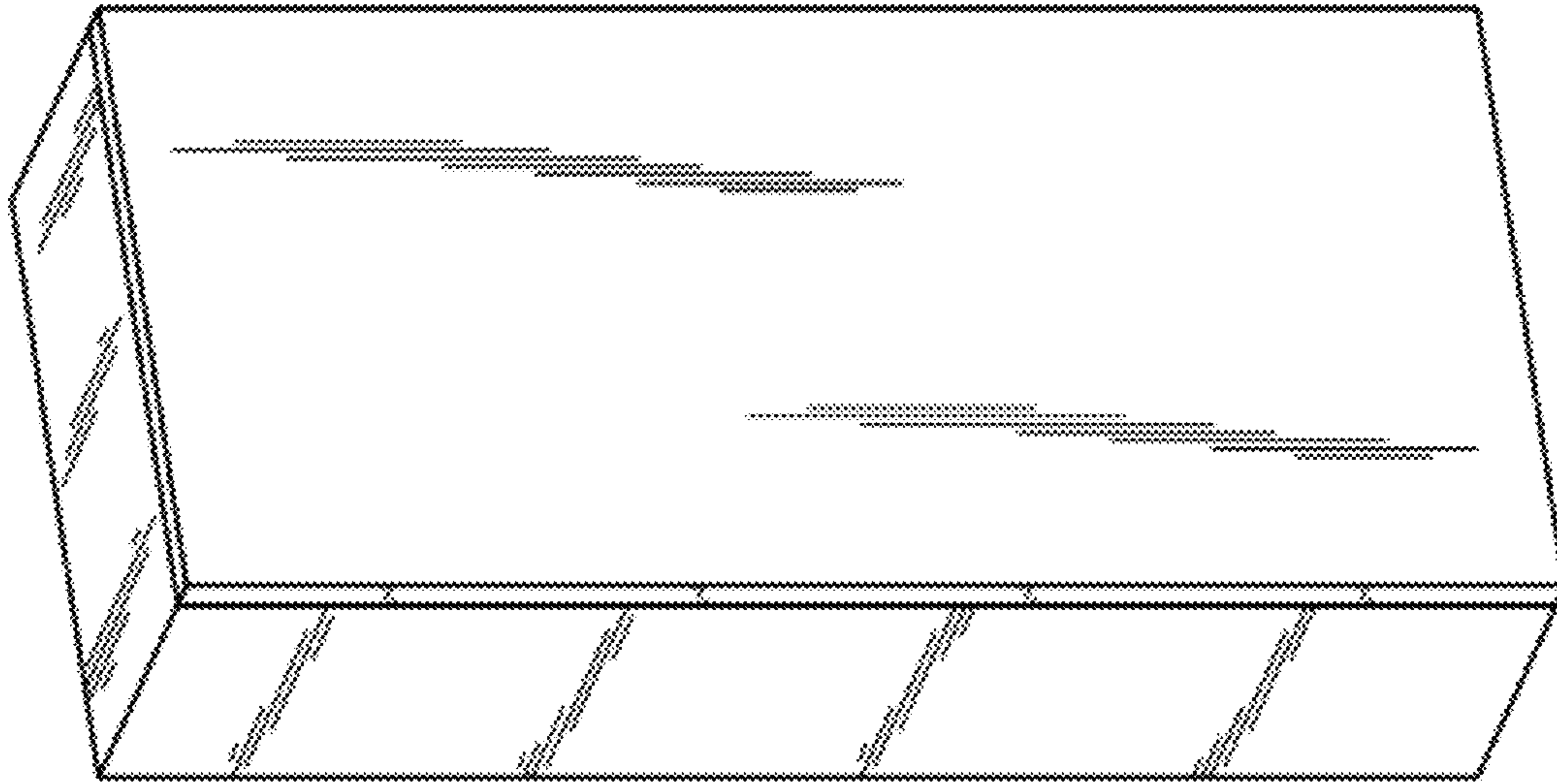

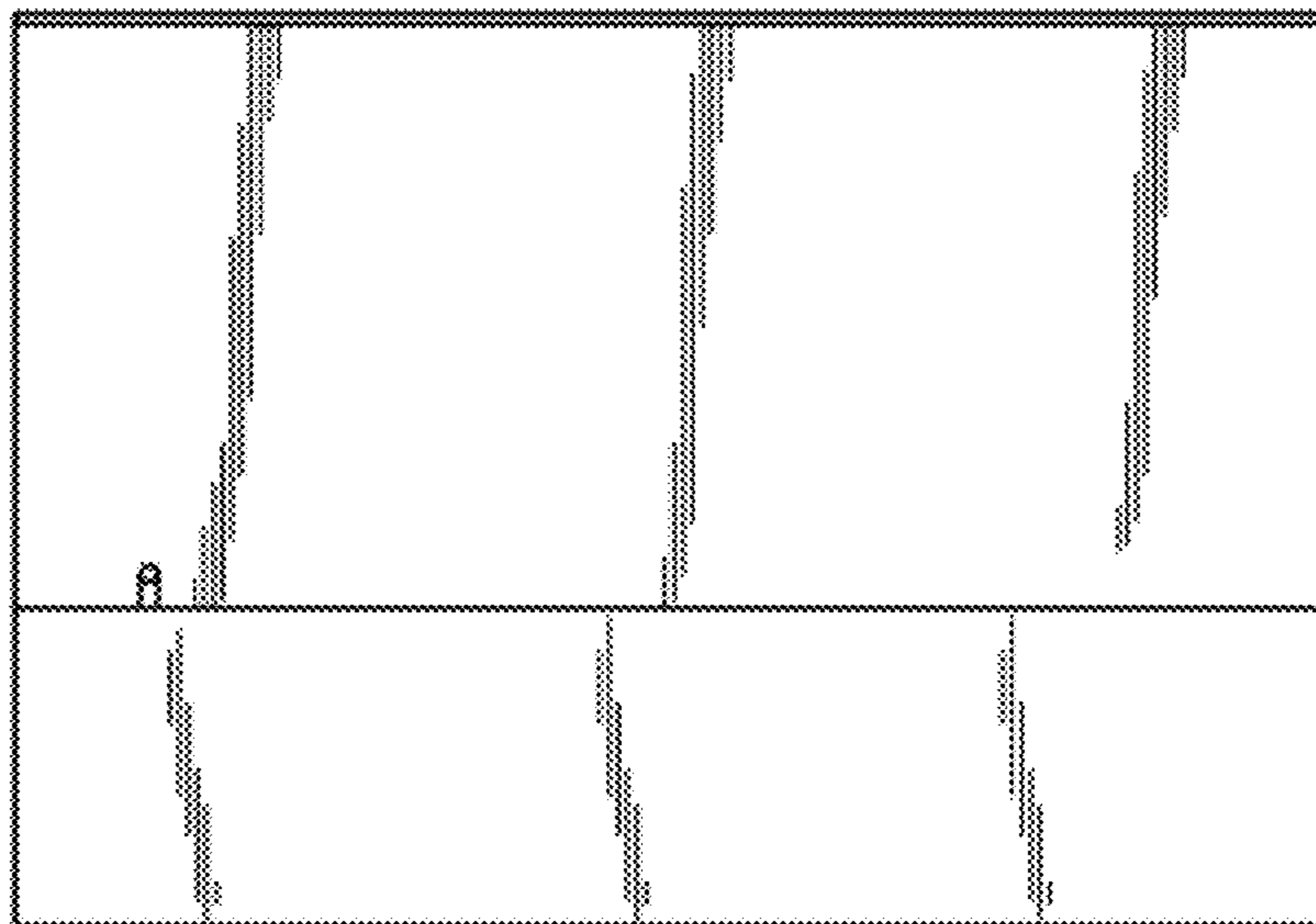
