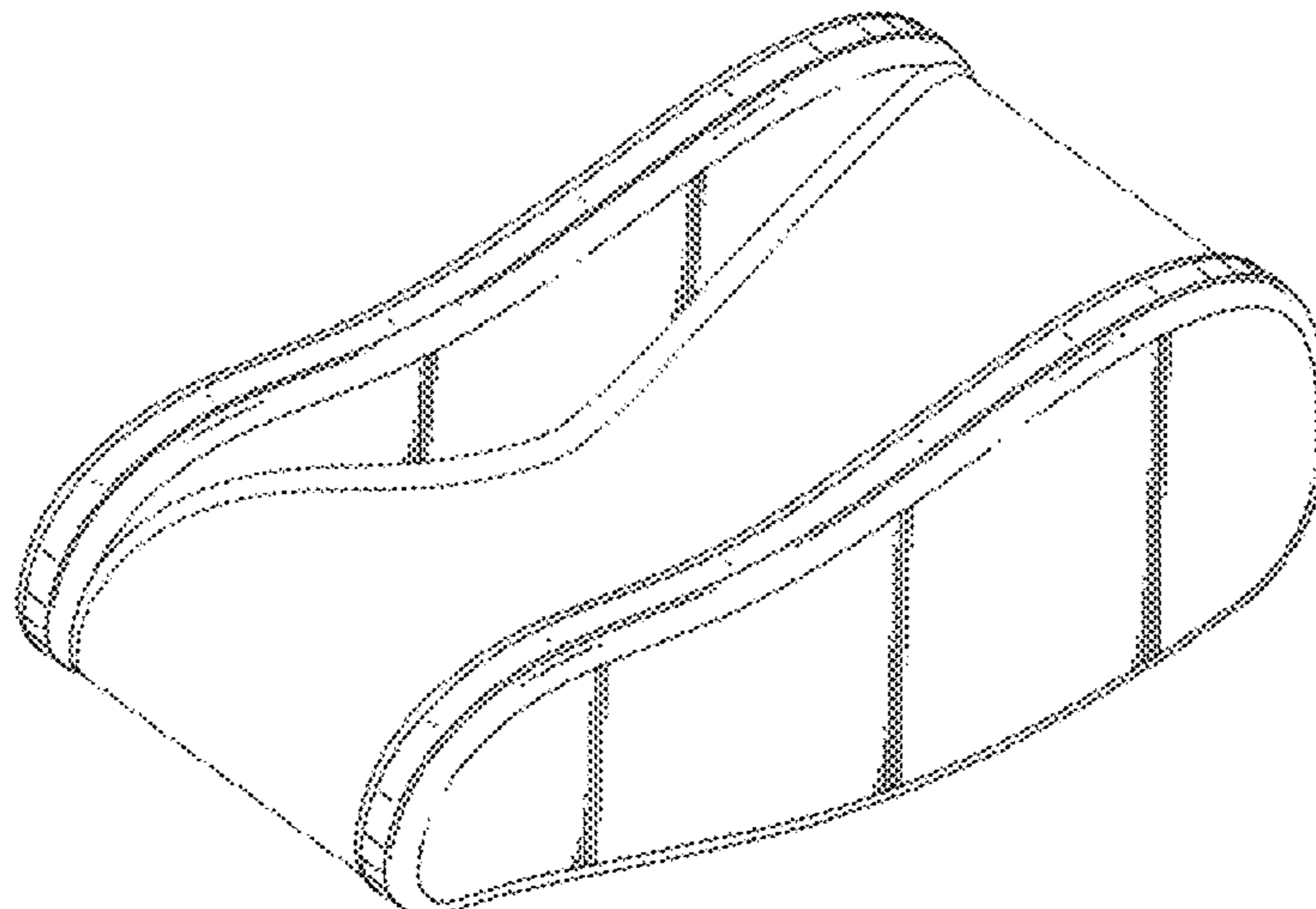
(57) **CLAIM**

The ornamental design for an infant lounger, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an infant lounger showing my new design;  
FIG. 2 is a side view of the infant lounger of FIG. 1, the opposite side being substantially a mirror image thereof;  
FIG. 3 is a front view of the infant lounger of FIG. 1;  
FIG. 4 is a top view of the infant lounger of FIG. 1;  
FIG. 5 is a back view of the infant lounger of FIG. 1; and,  
FIG. 6 is a bottom view of the infant lounger of FIG. 1.

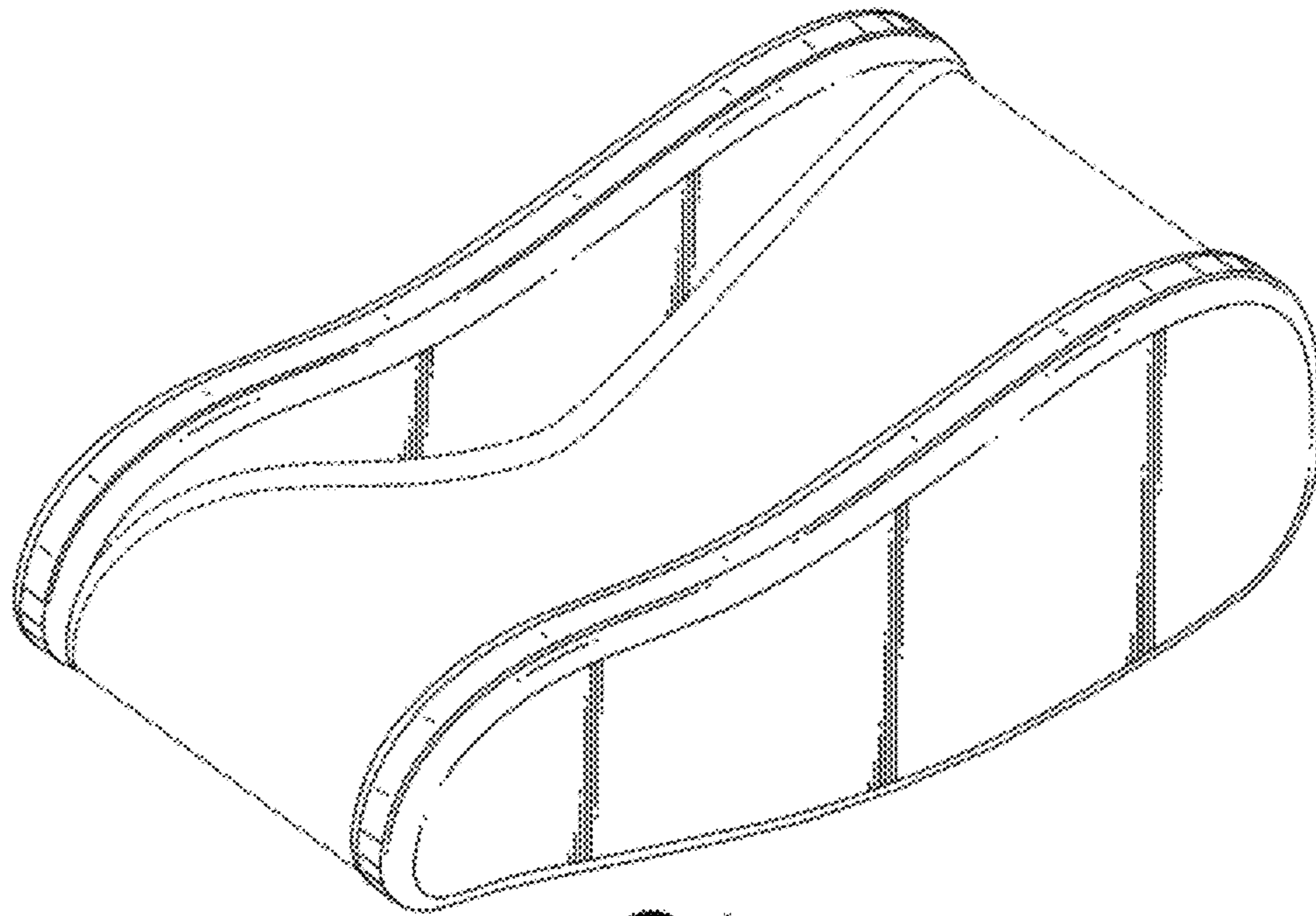

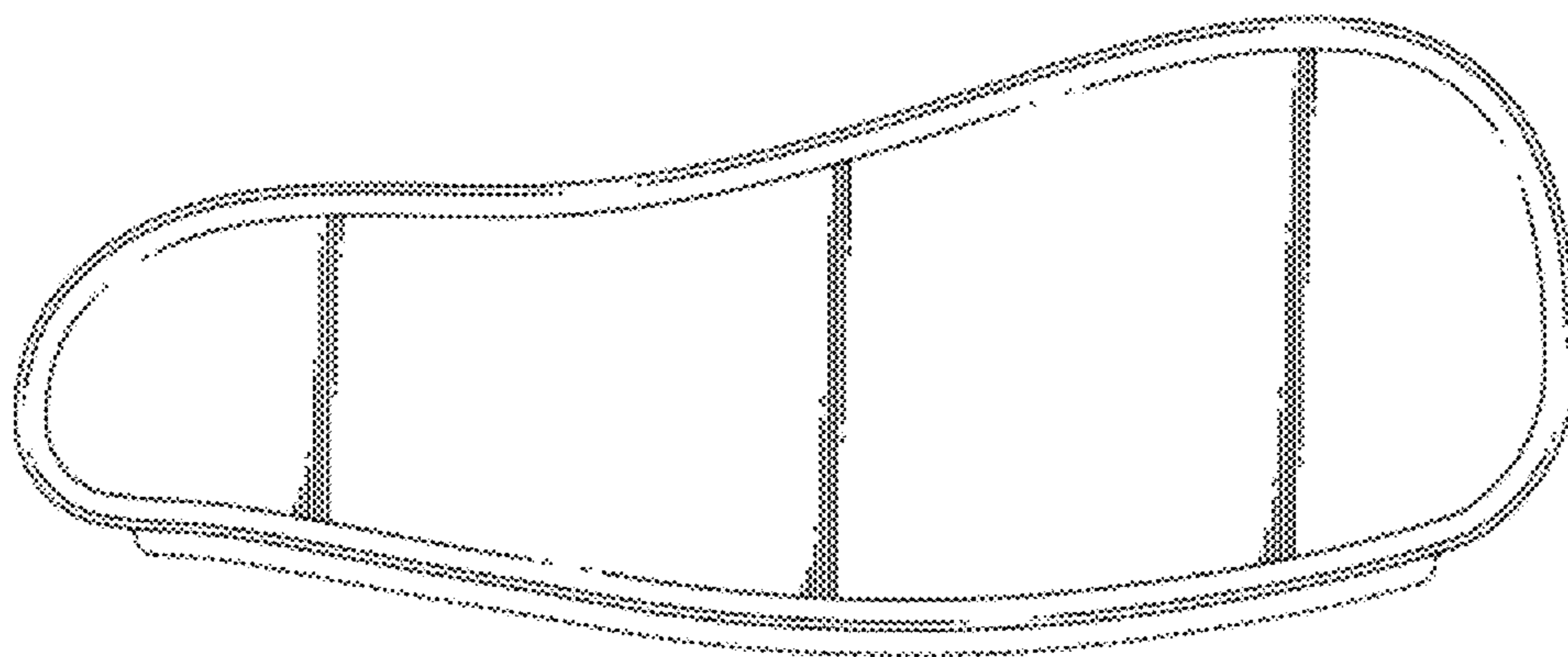

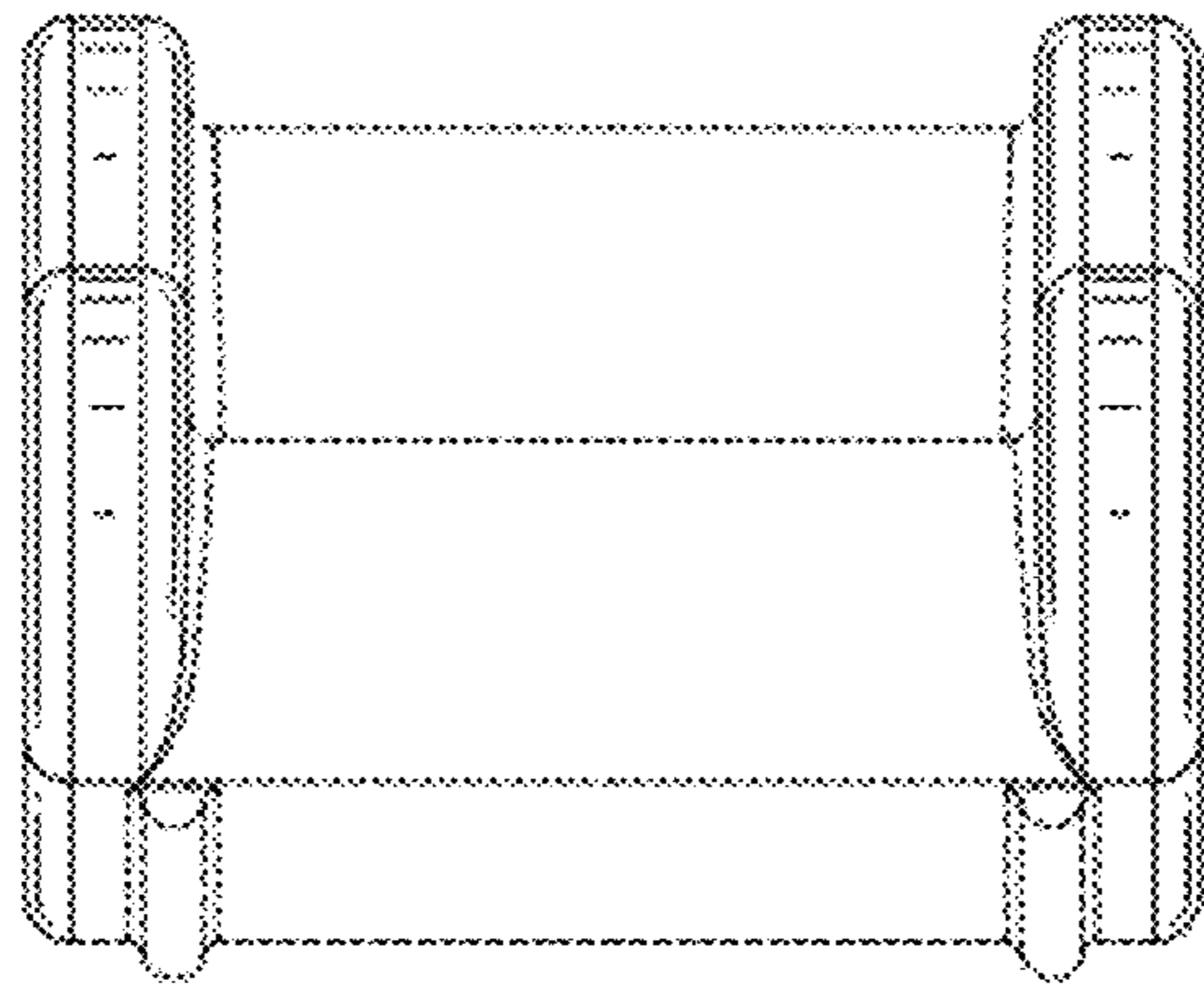

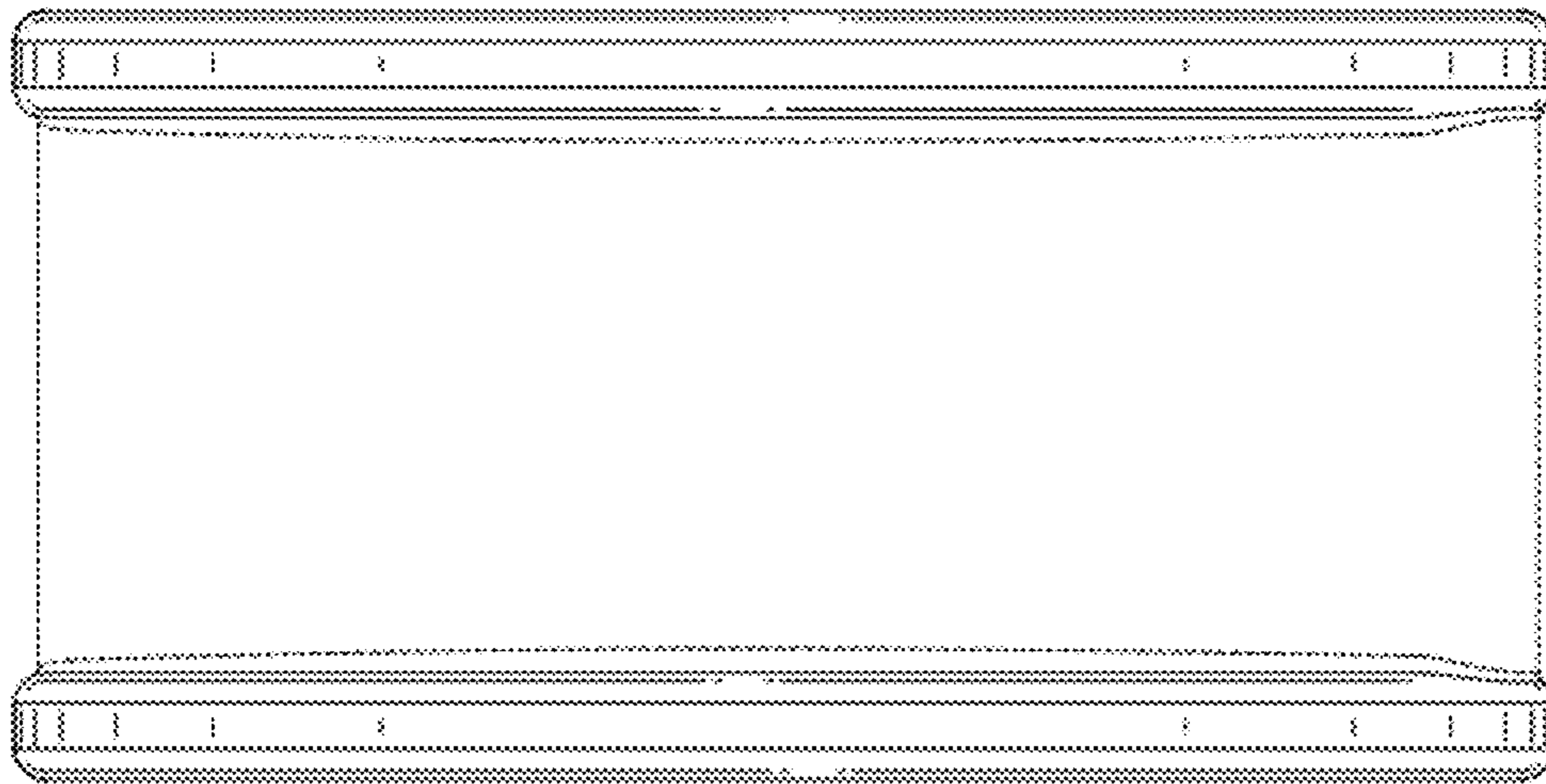

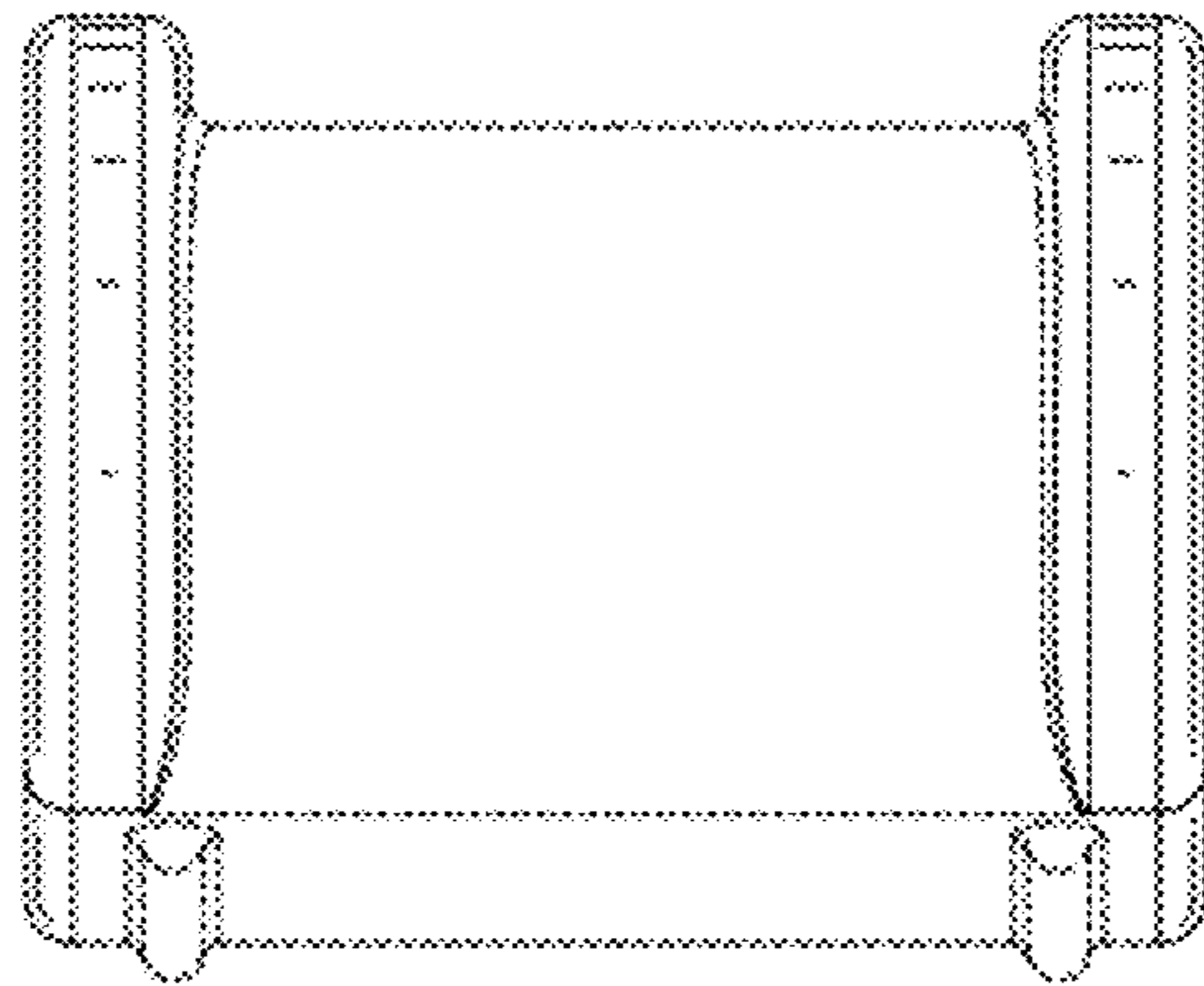
