(57) **CLAIM**

I claim the ornamental design for deep fryer, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a deep fryer according to an embodiment of the invention.

FIG. 2 is a front view of the deep fryer depicted in FIG. 1.

FIG. 3 is a right side view of the deep fryer depicted in FIG. 1.

FIG. 4 is a rear view of the deep fryer depicted in FIG. 1.

FIG. 5 is a left side view of the deep fryer depicted in FIG. 1.

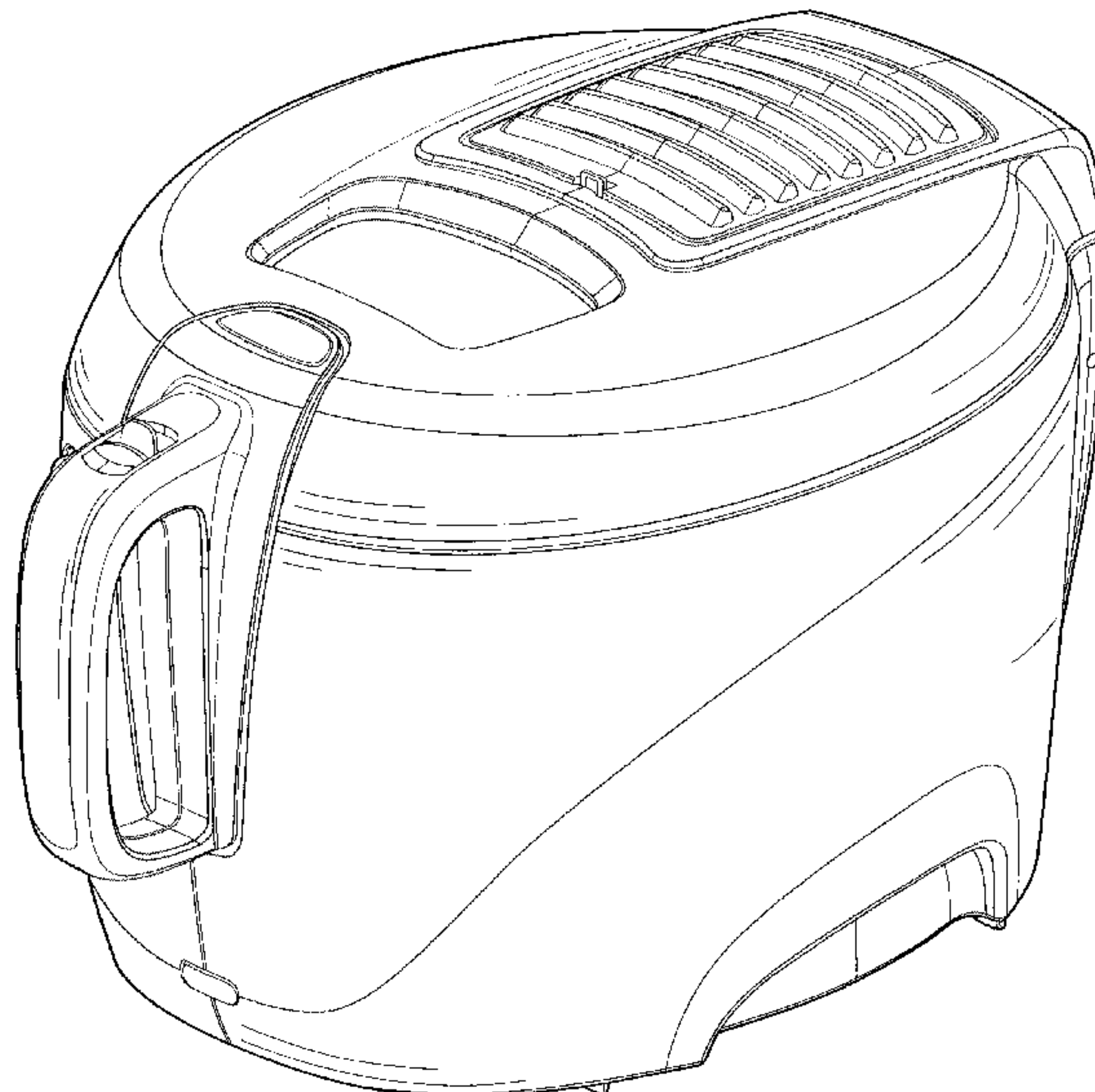
FIG. 6 is a bottom view of the deep fryer depicted in FIG. 1.

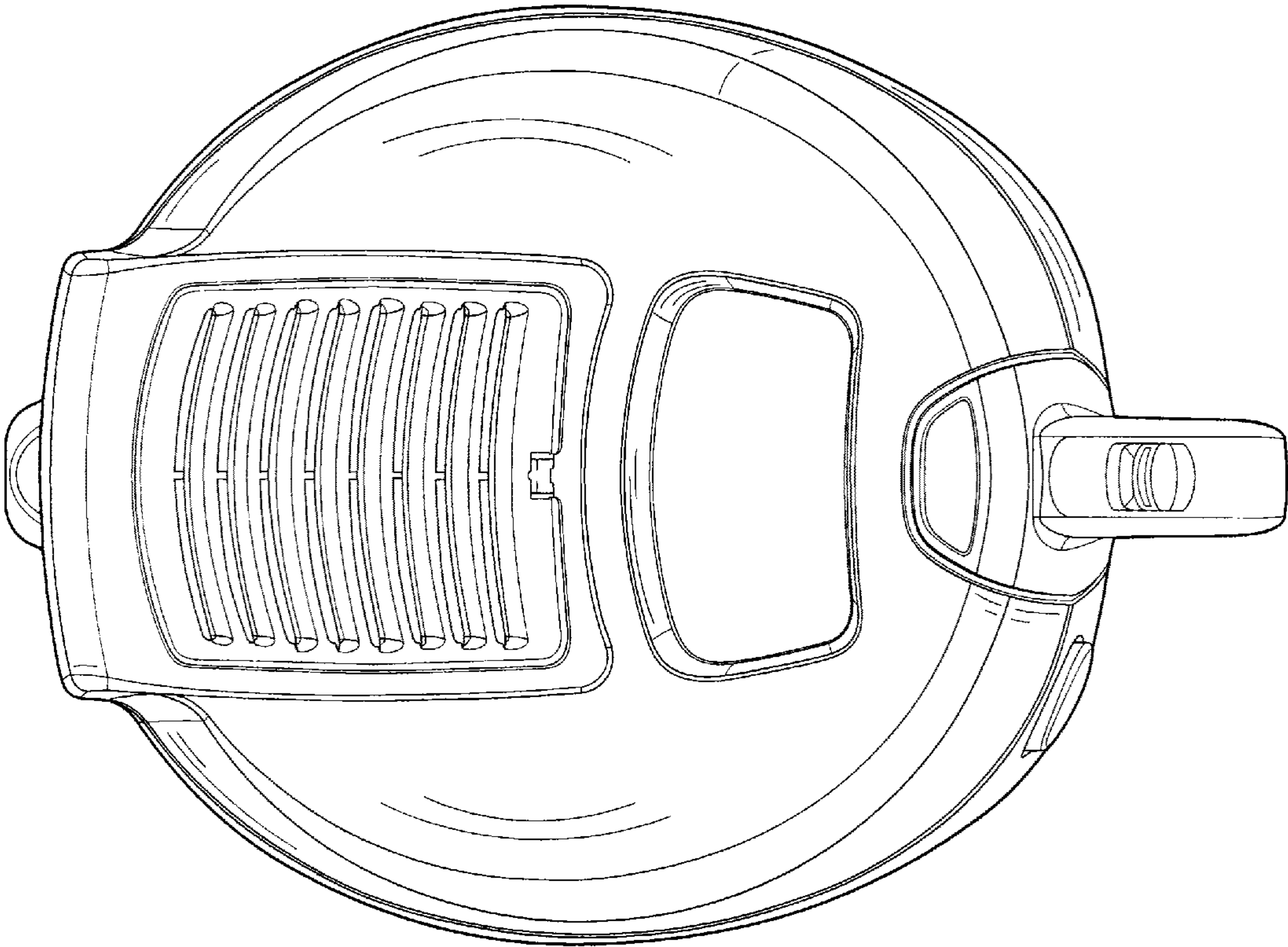

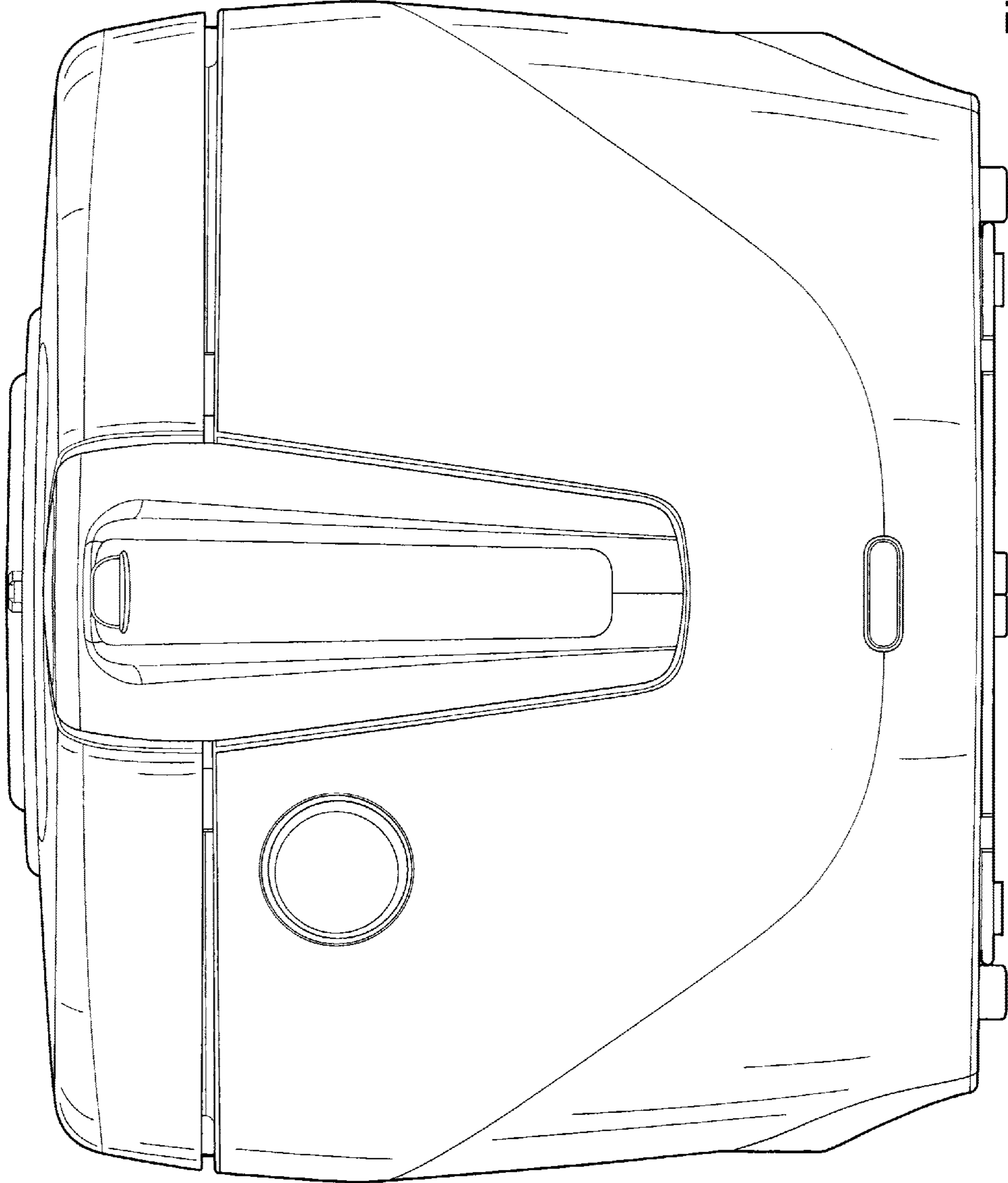

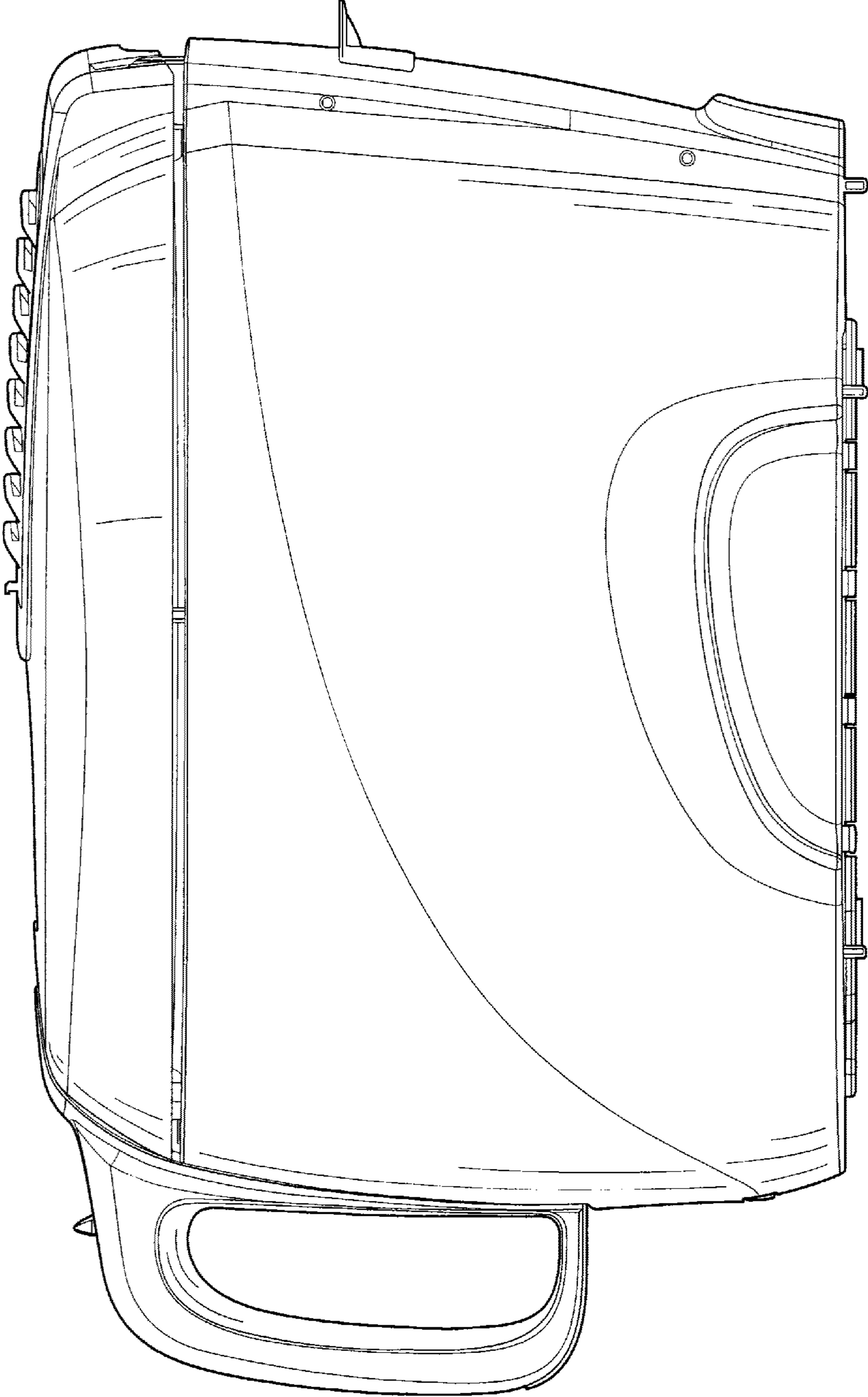

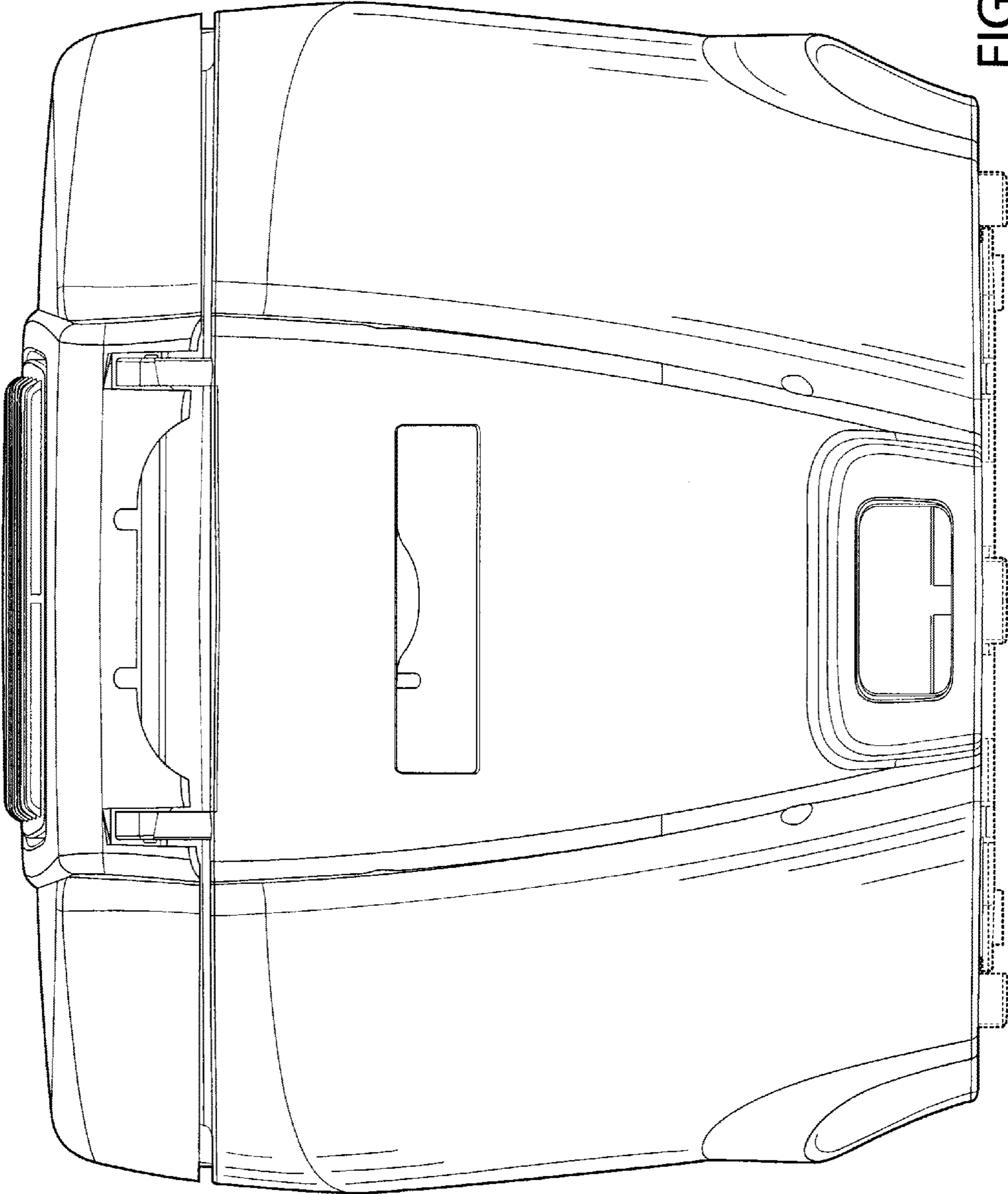

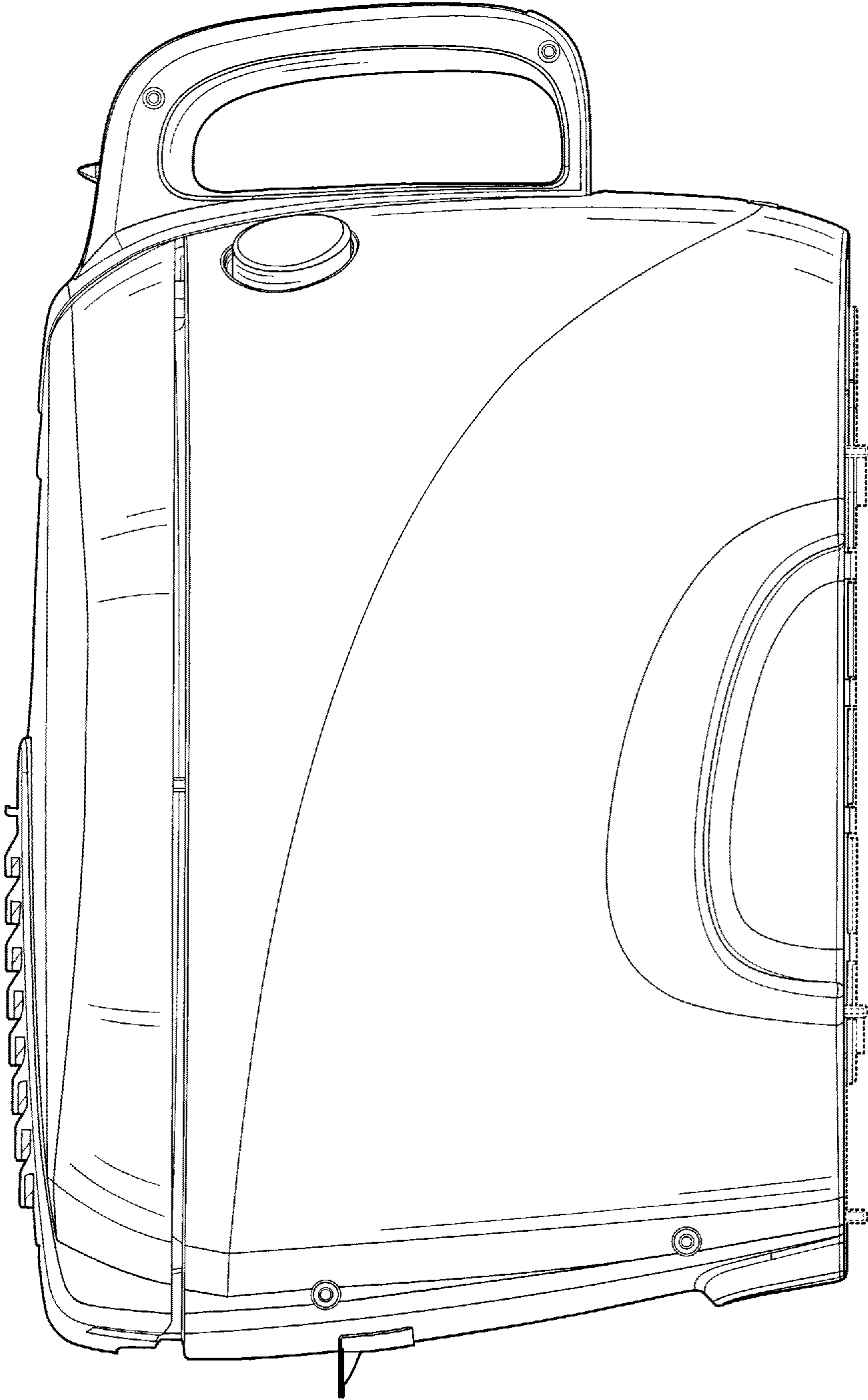

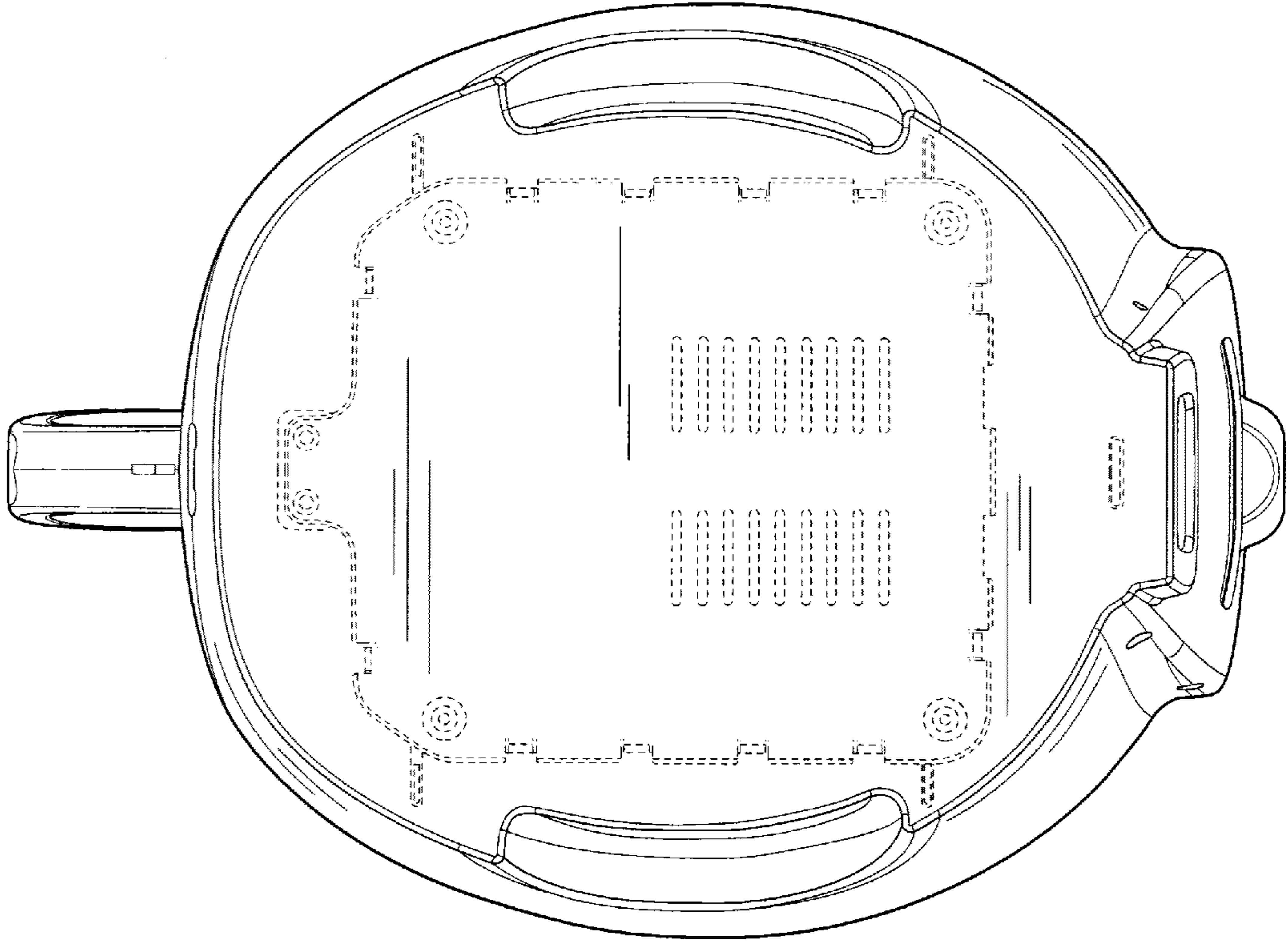

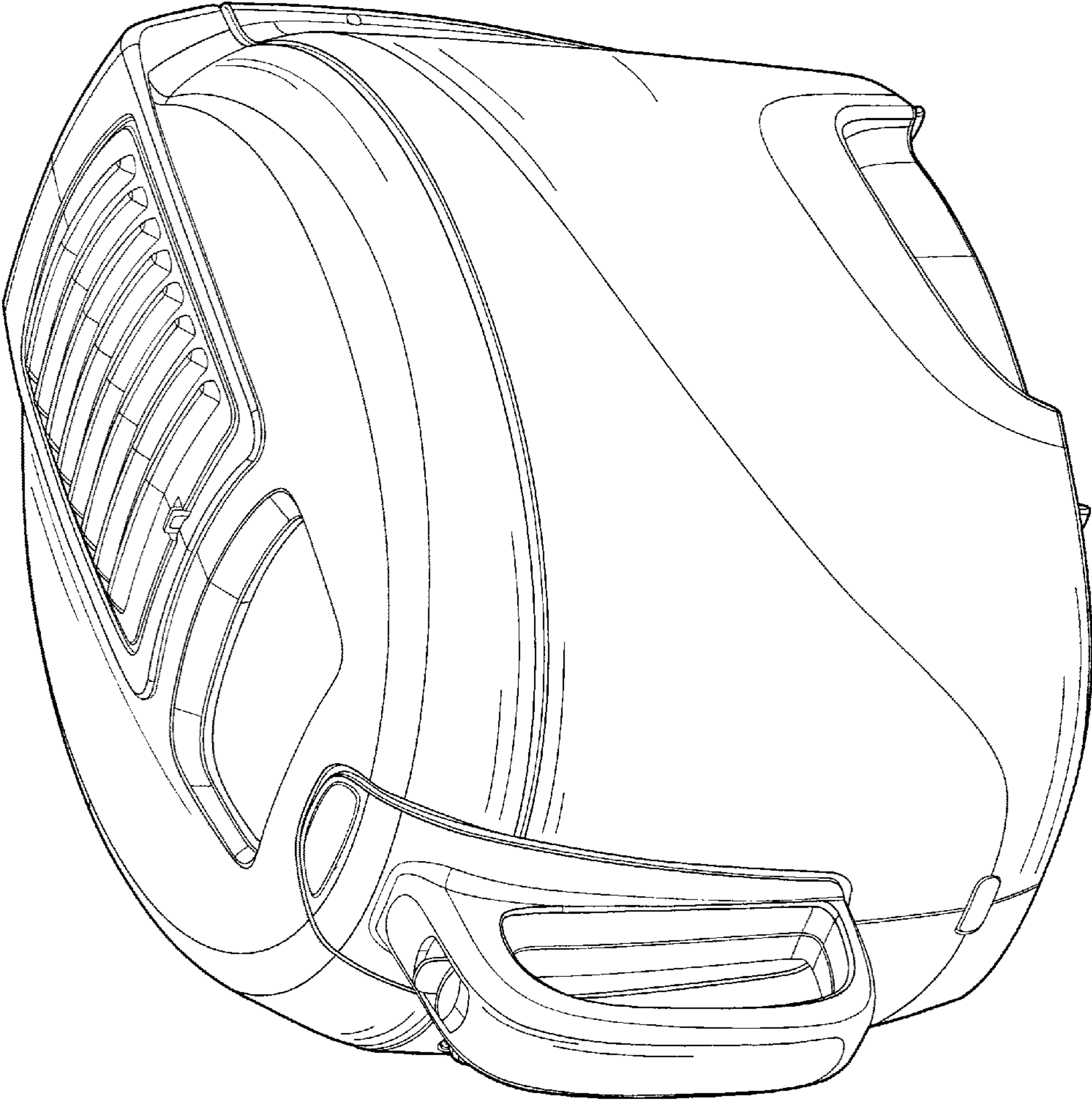
