DESCRIPTION

FIG. 1 is a perspective view of a container showing our new design;

FIG. 2 is a front view thereof;

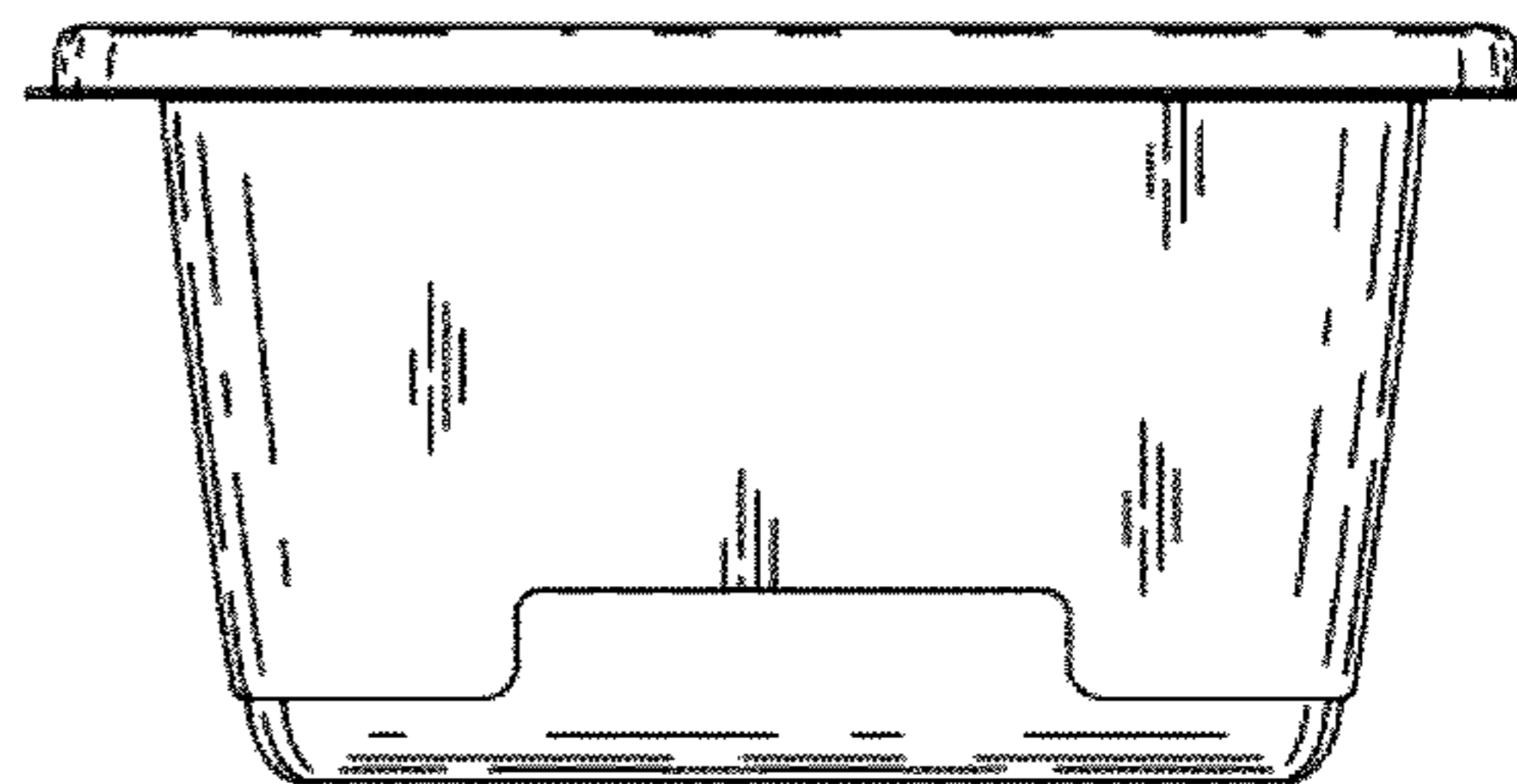
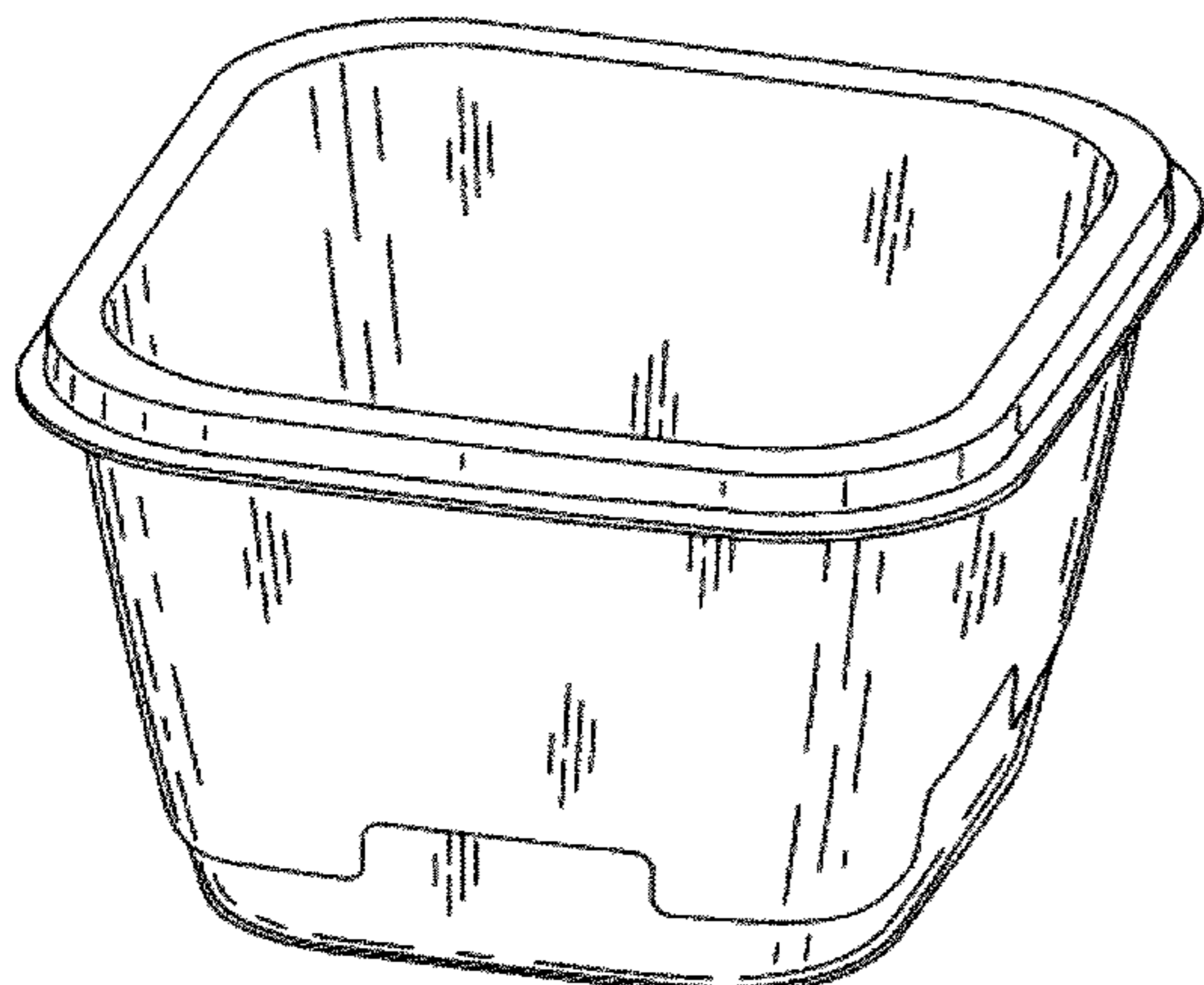

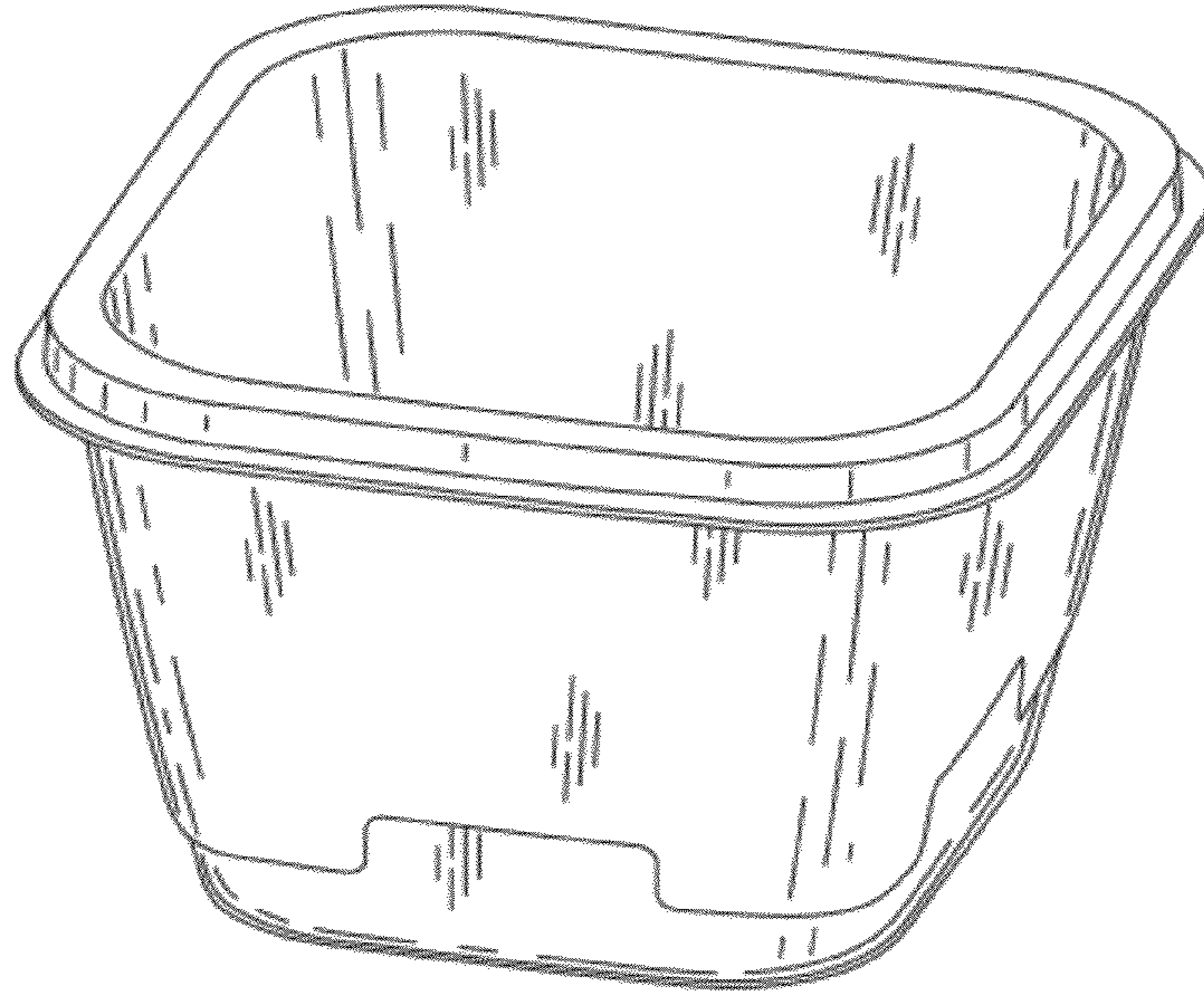

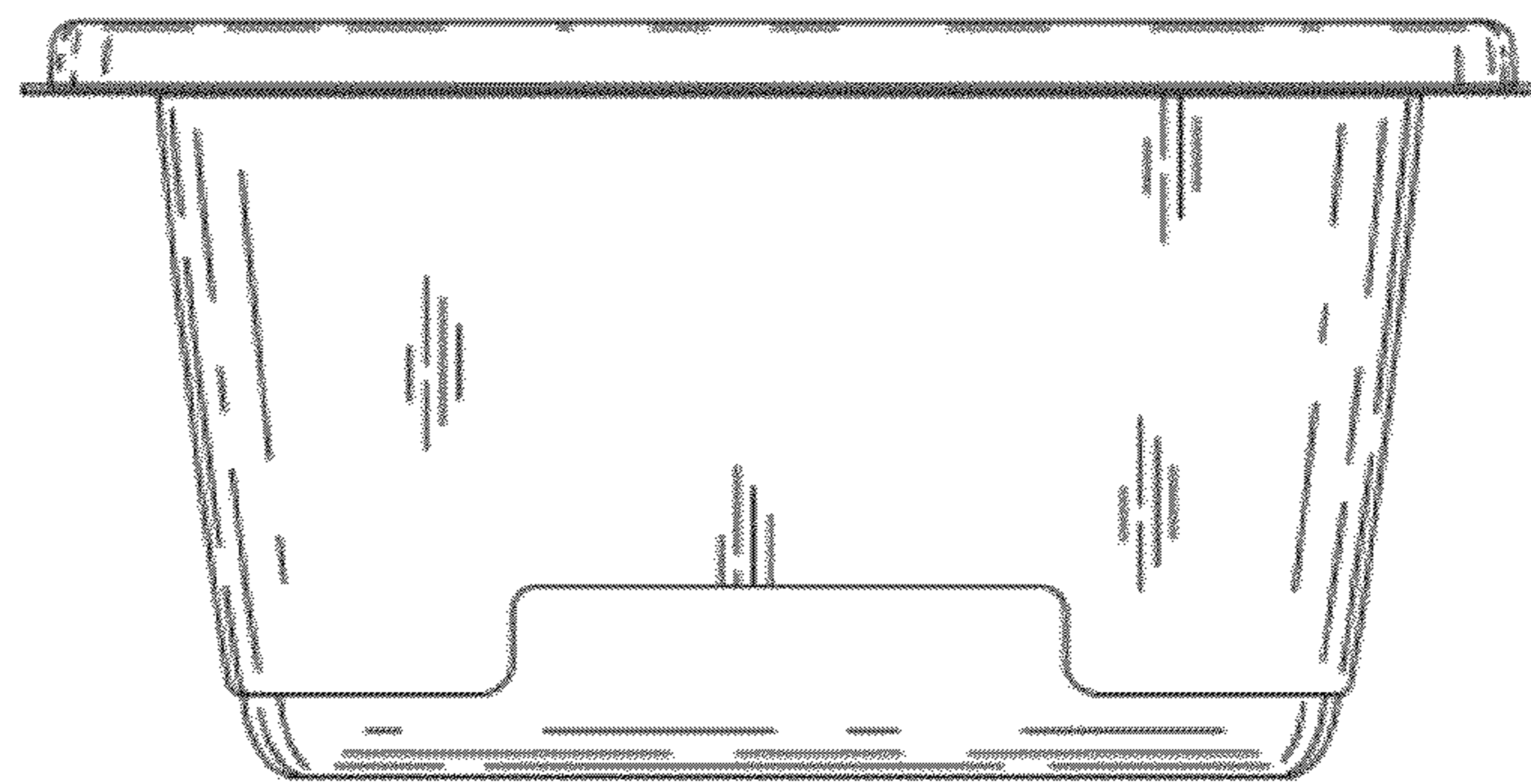

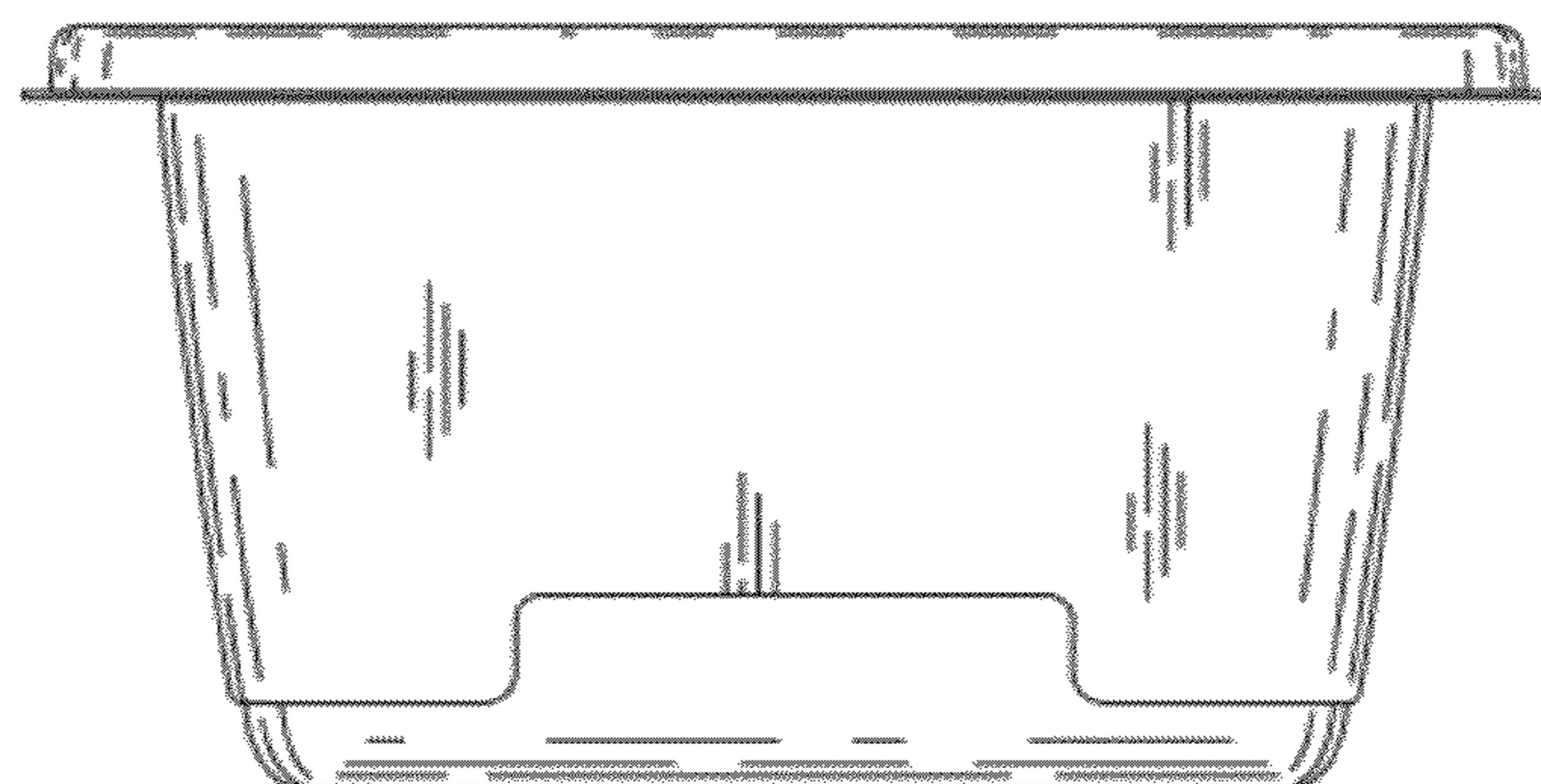

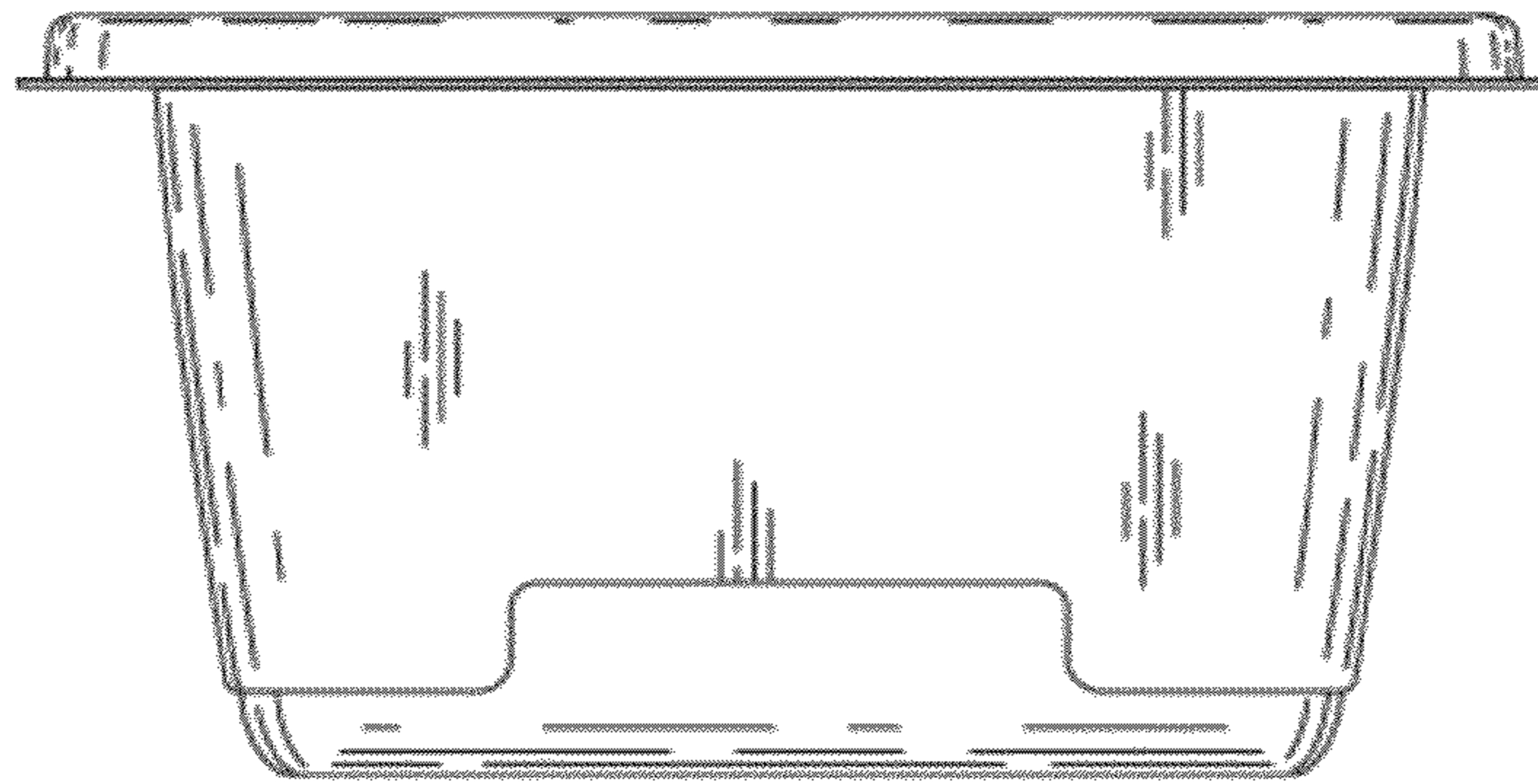

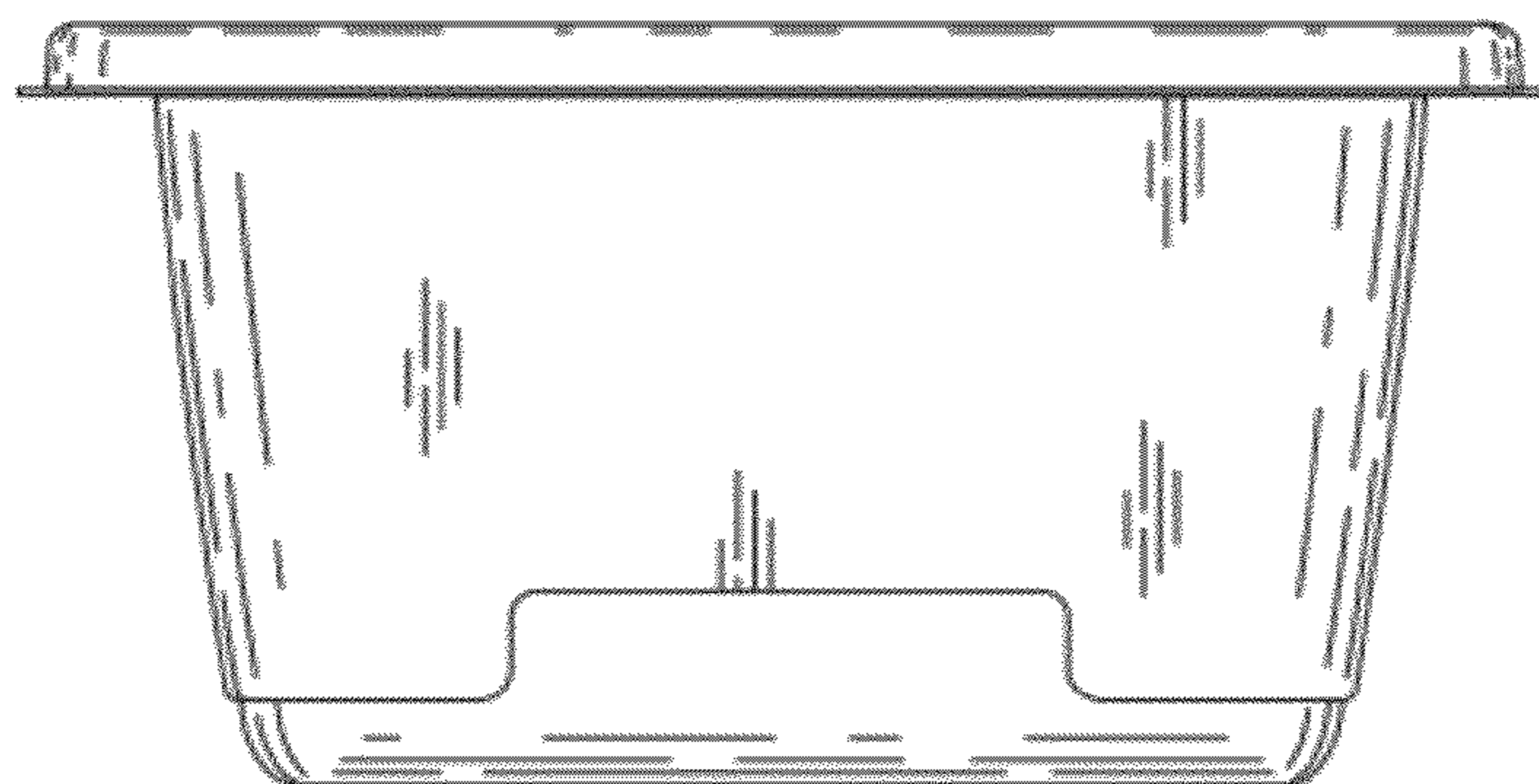

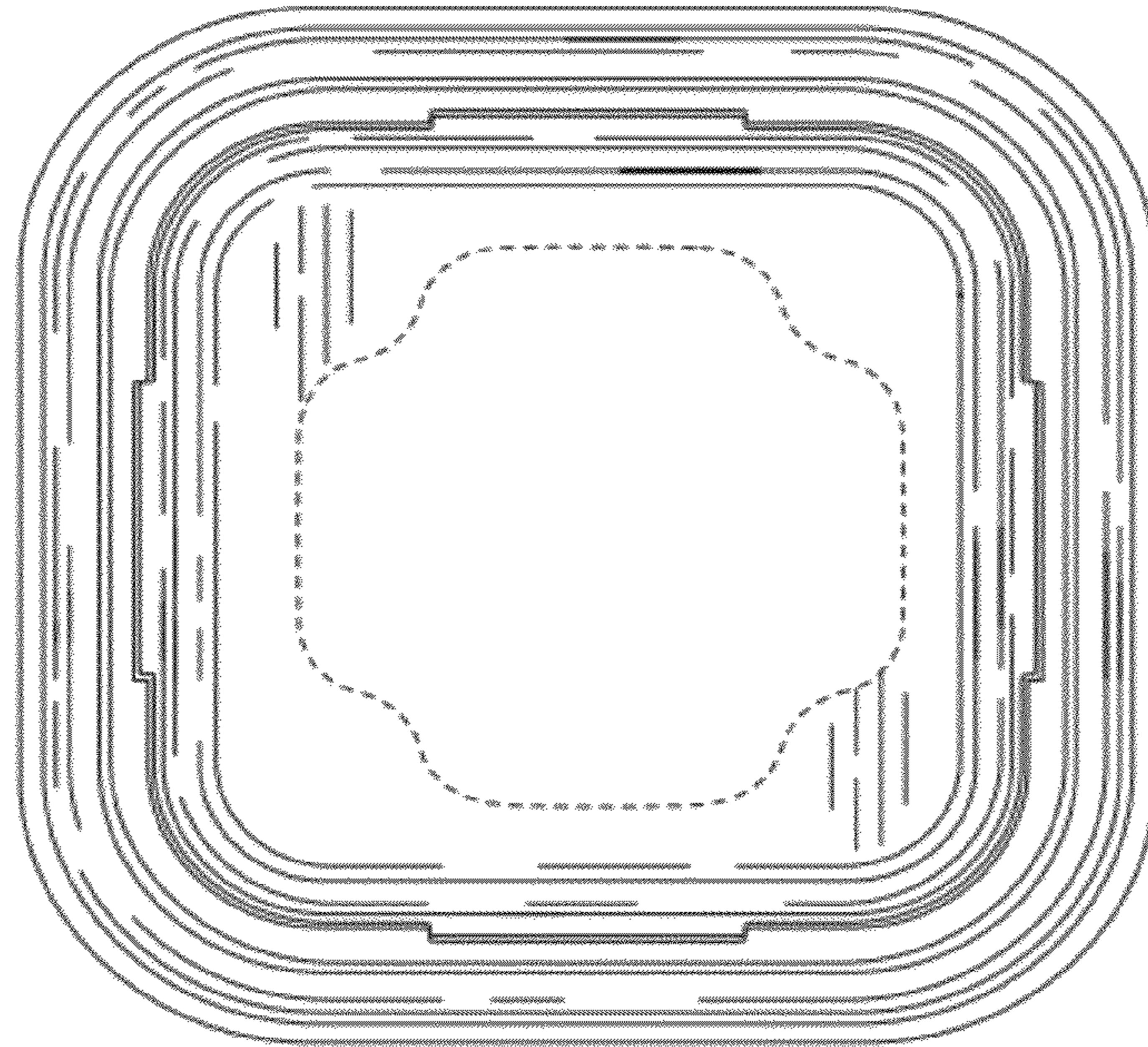
