The ornamental design for a peeler, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left side perspective view of a peeler showing our new design, the broken lines shown in the drawings represent portions of the peeler that form no part of the claimed design;

FIG. 2 is a front elevational view thereof;

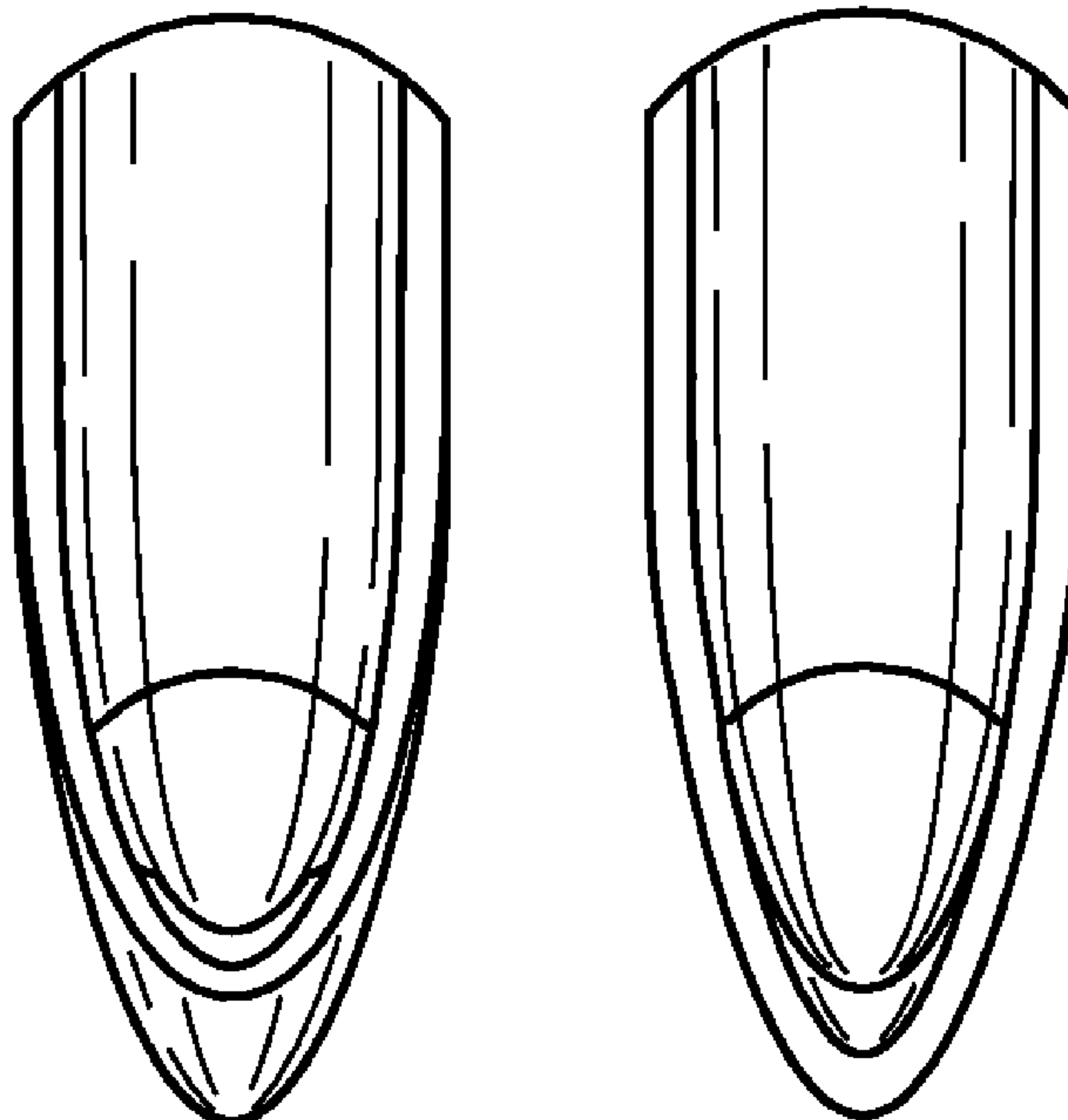
FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof, the right side being a mirror image of that shown;

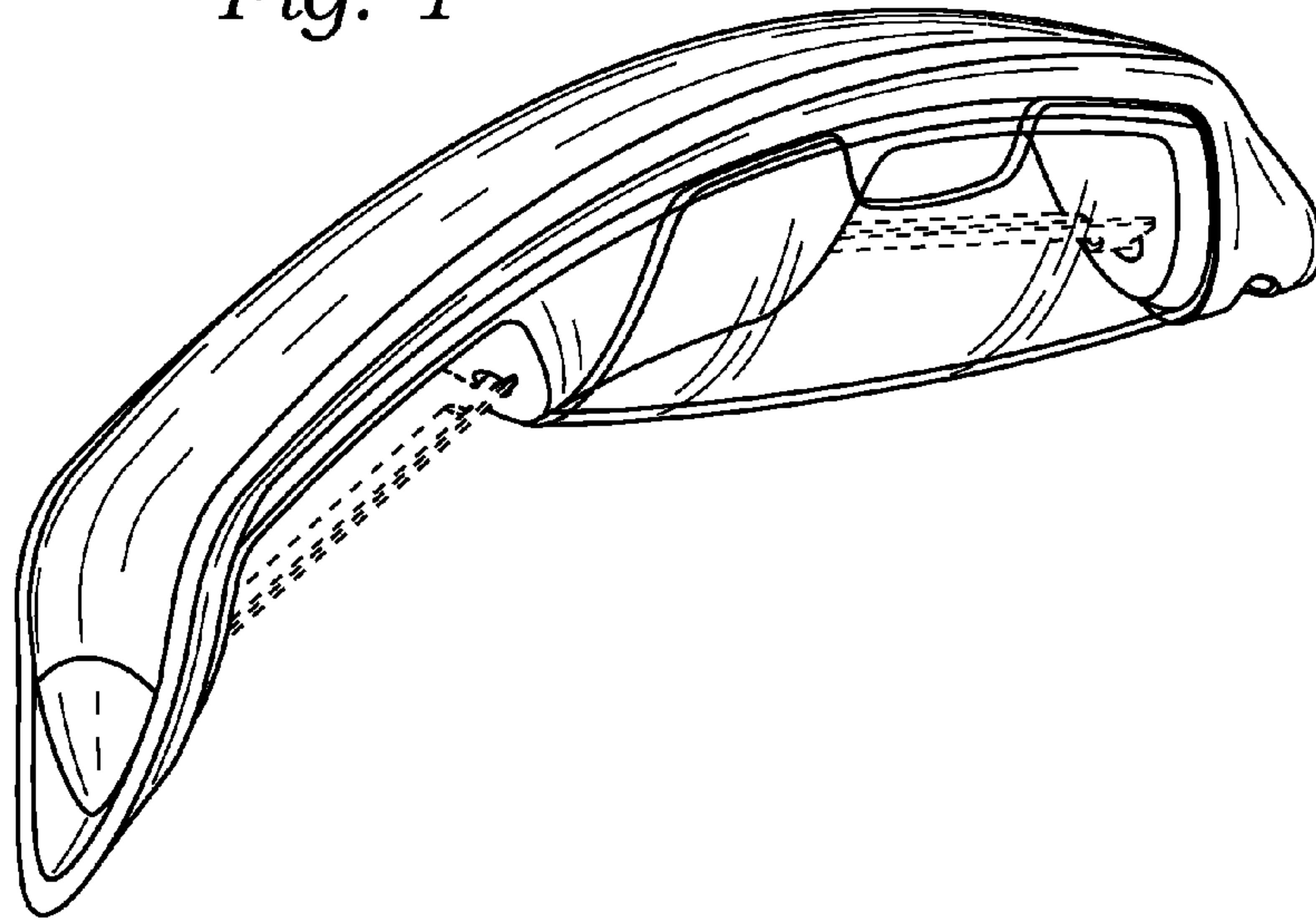
FIG. 5 is a top plan view thereof; and,

FIG. 6 is a bottom plan view thereof.

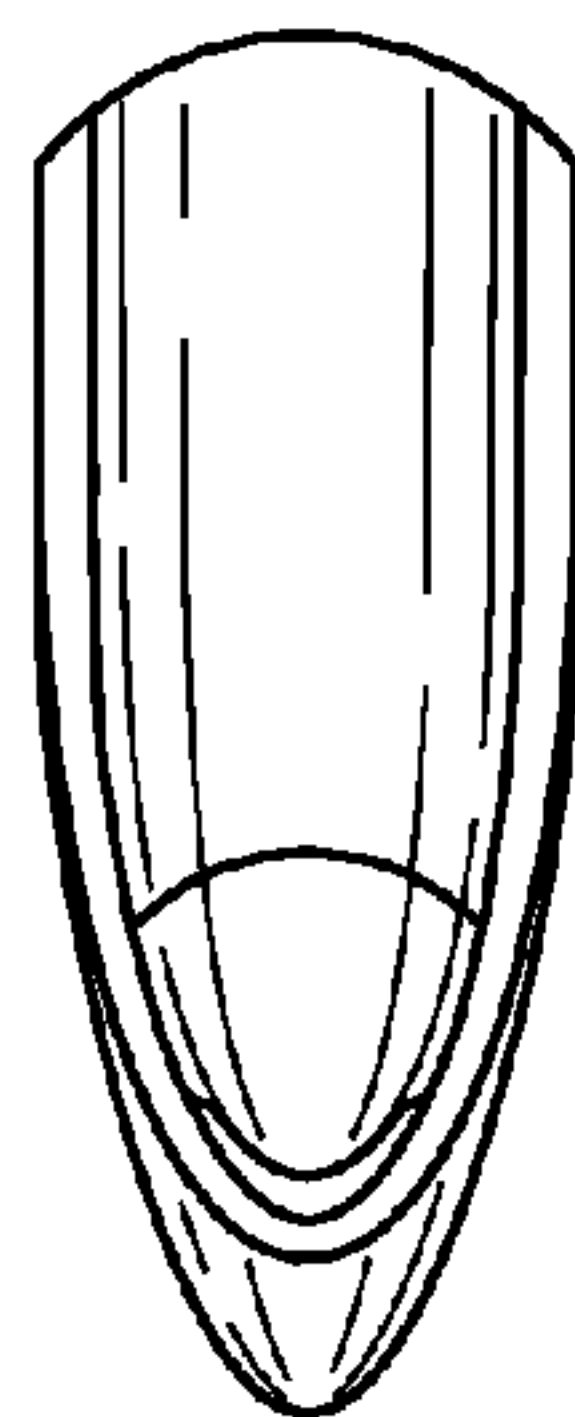

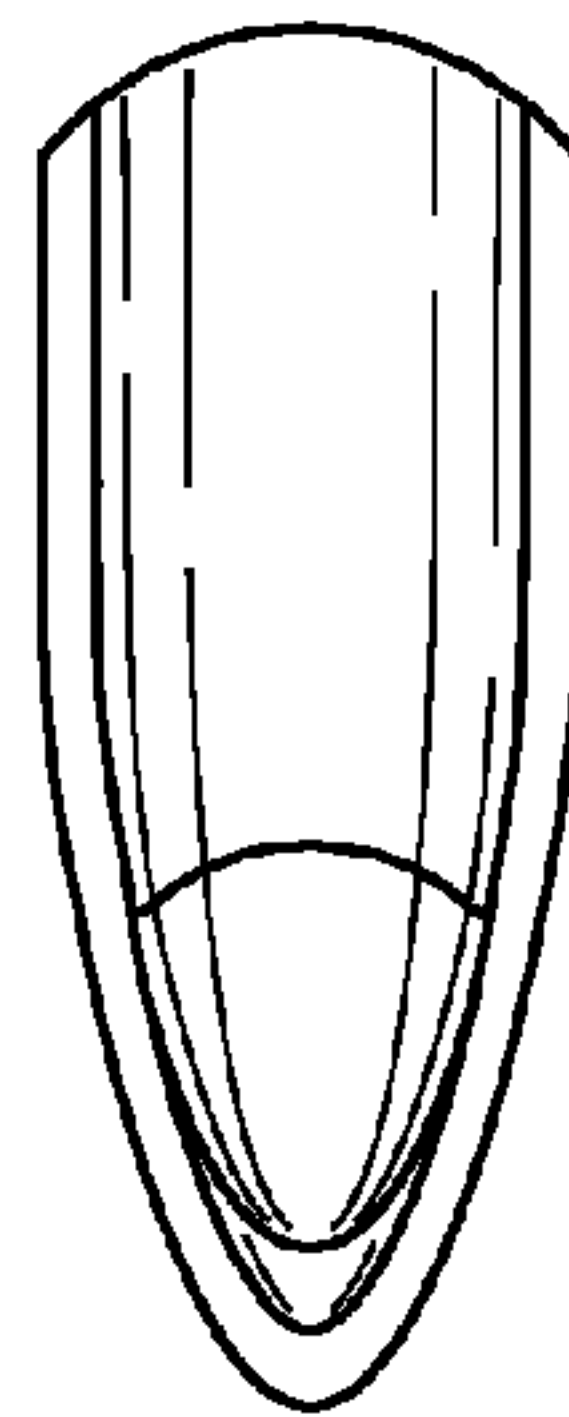

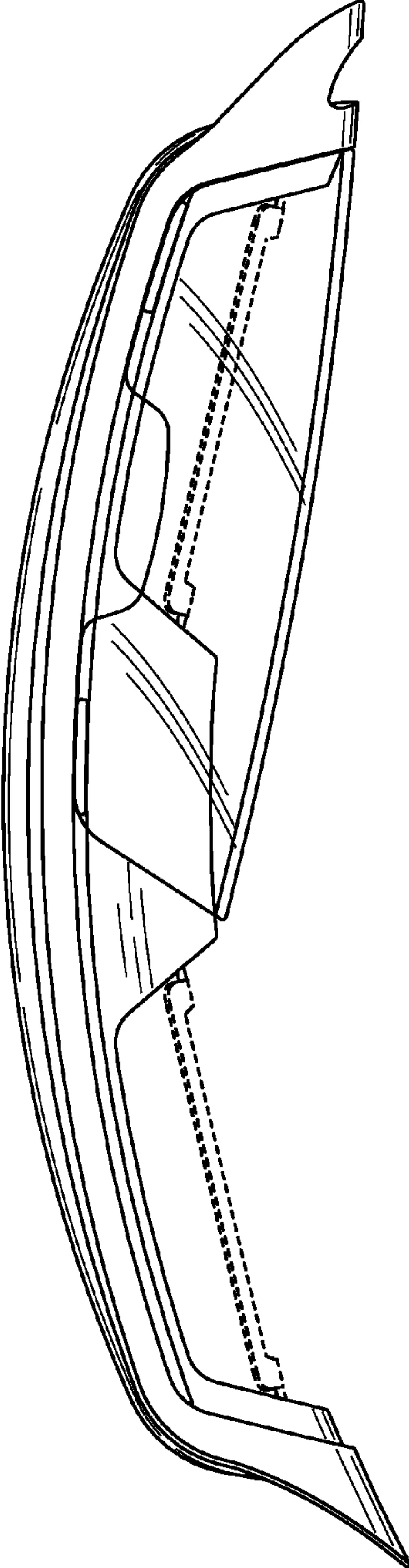

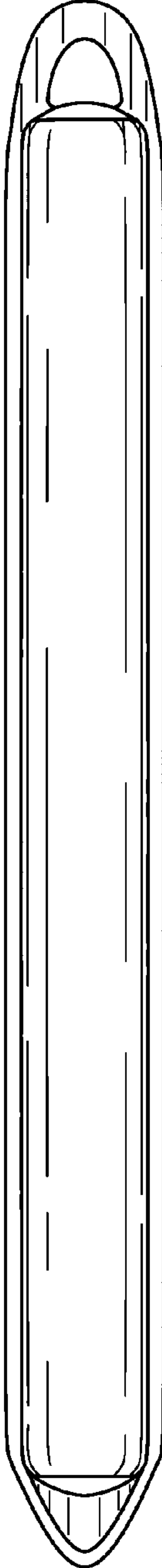
