FIG. 4 is a rear elevated view thereof;

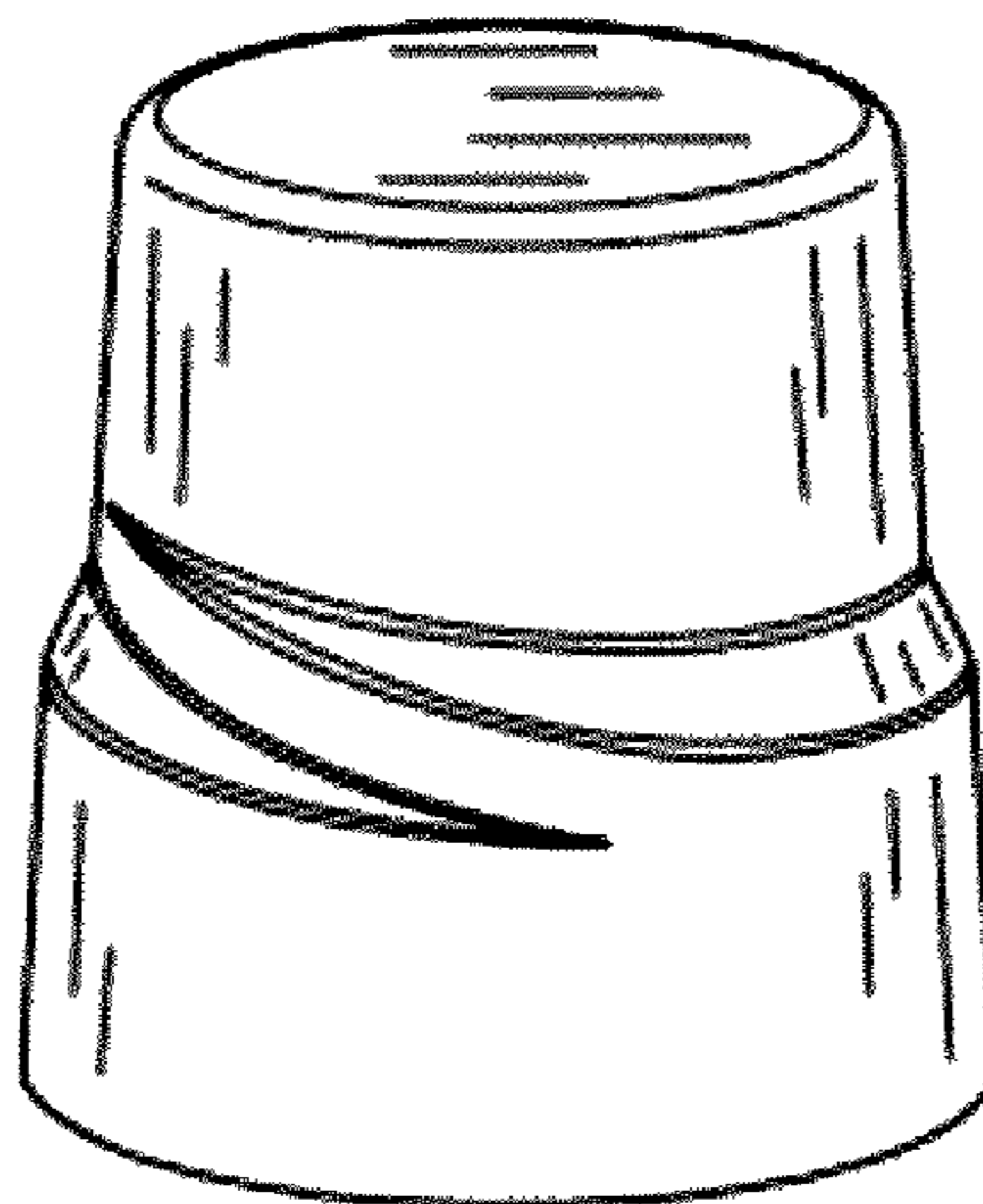
FIG. 5 is a side view thereof;

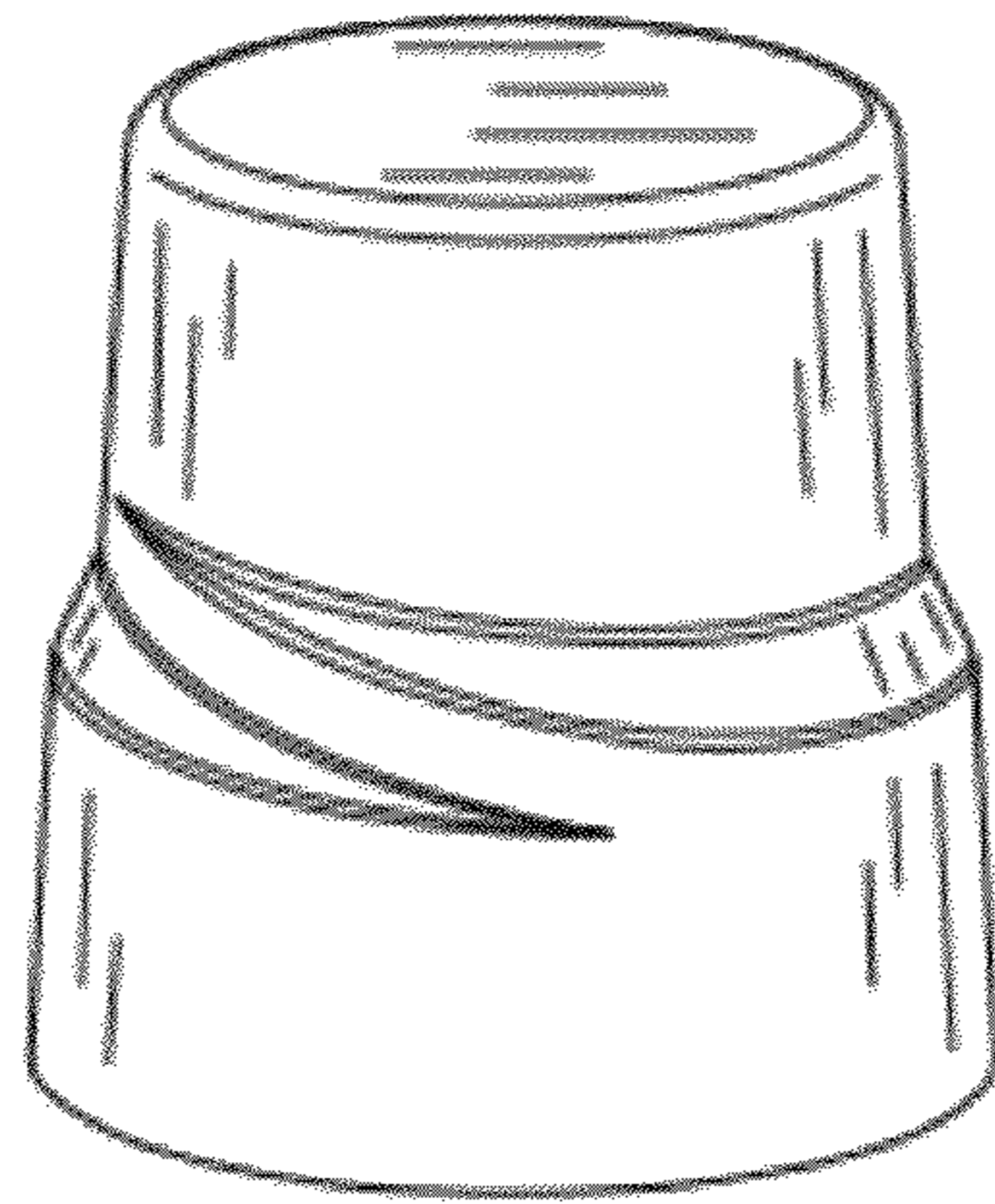

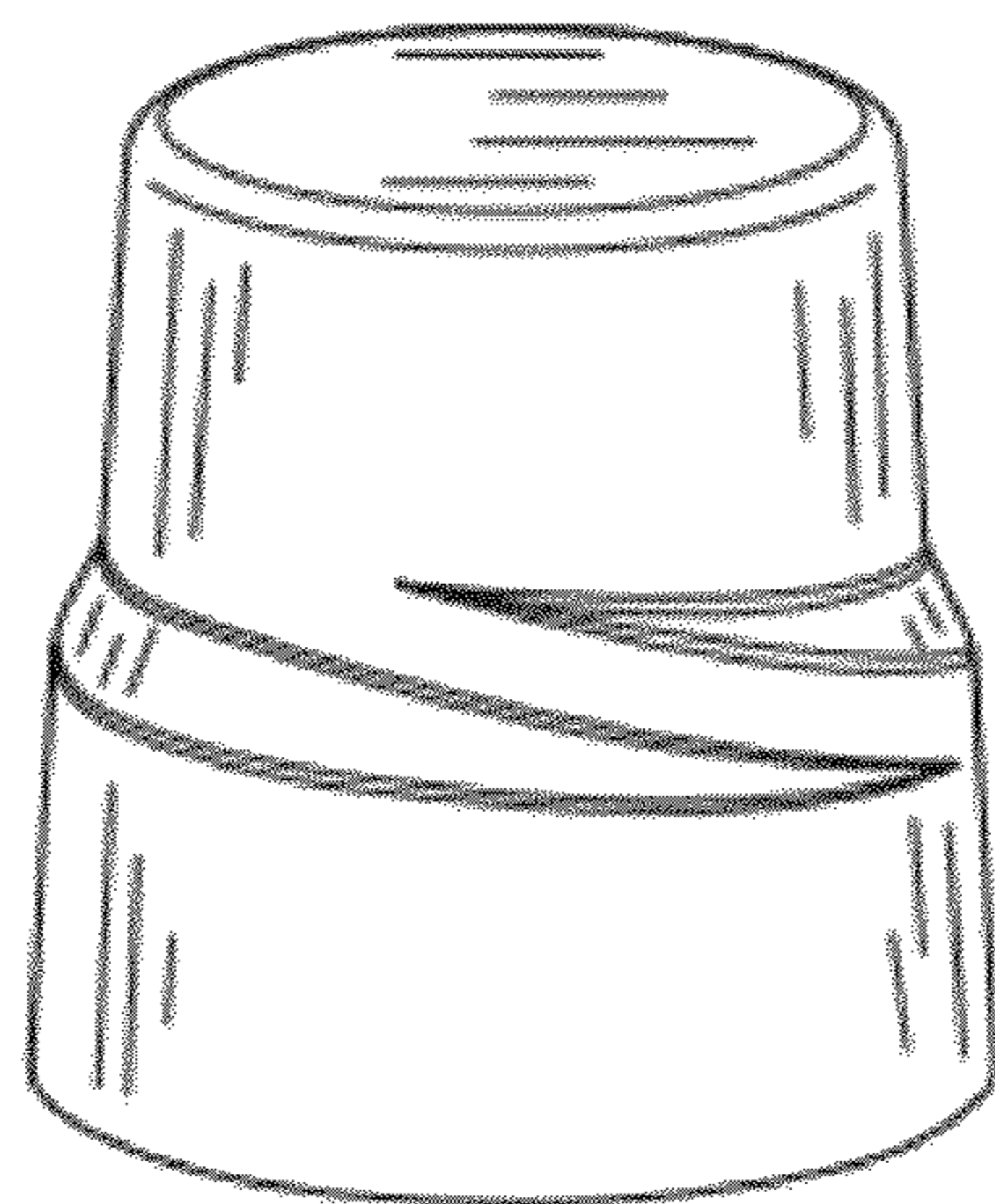

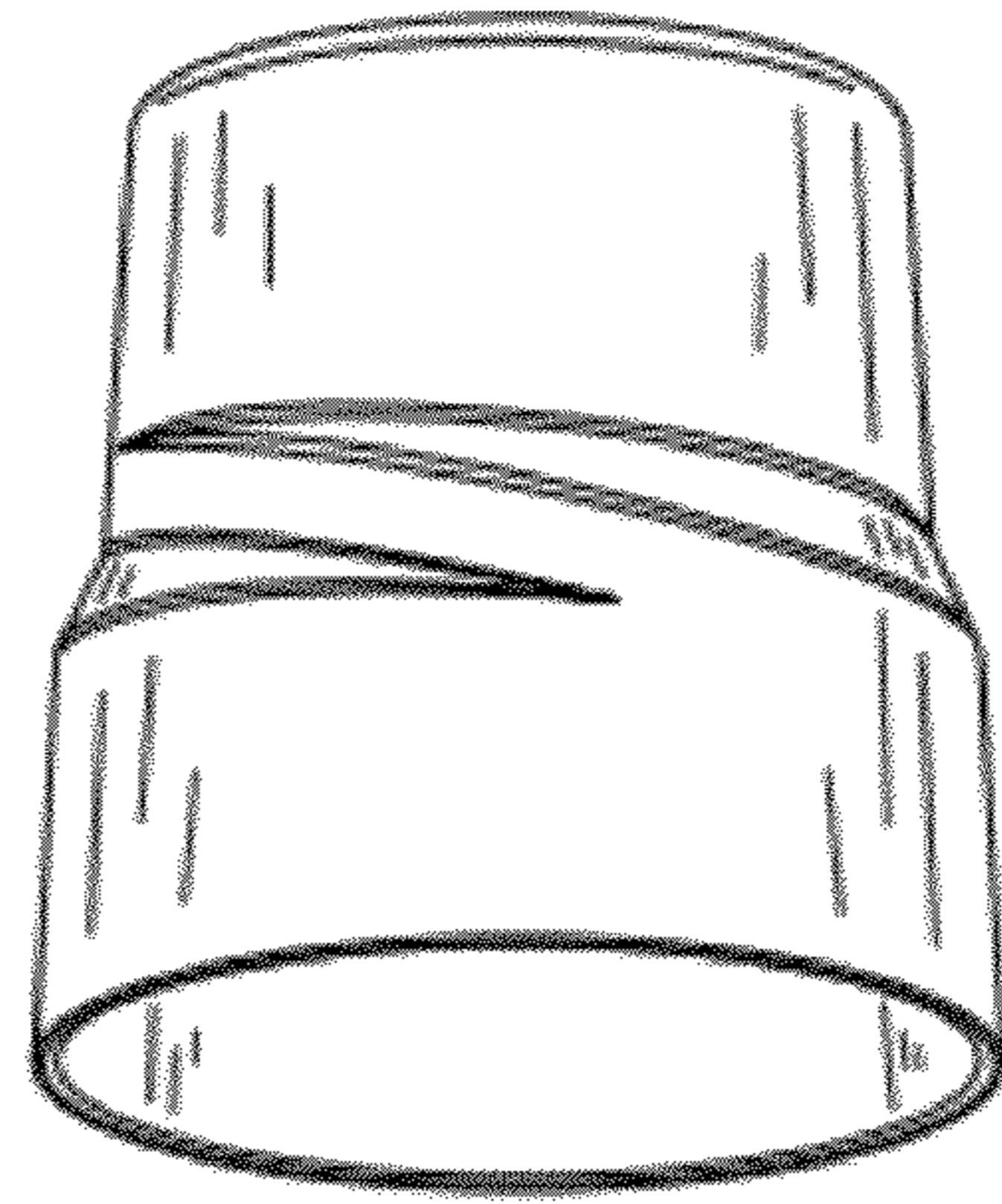

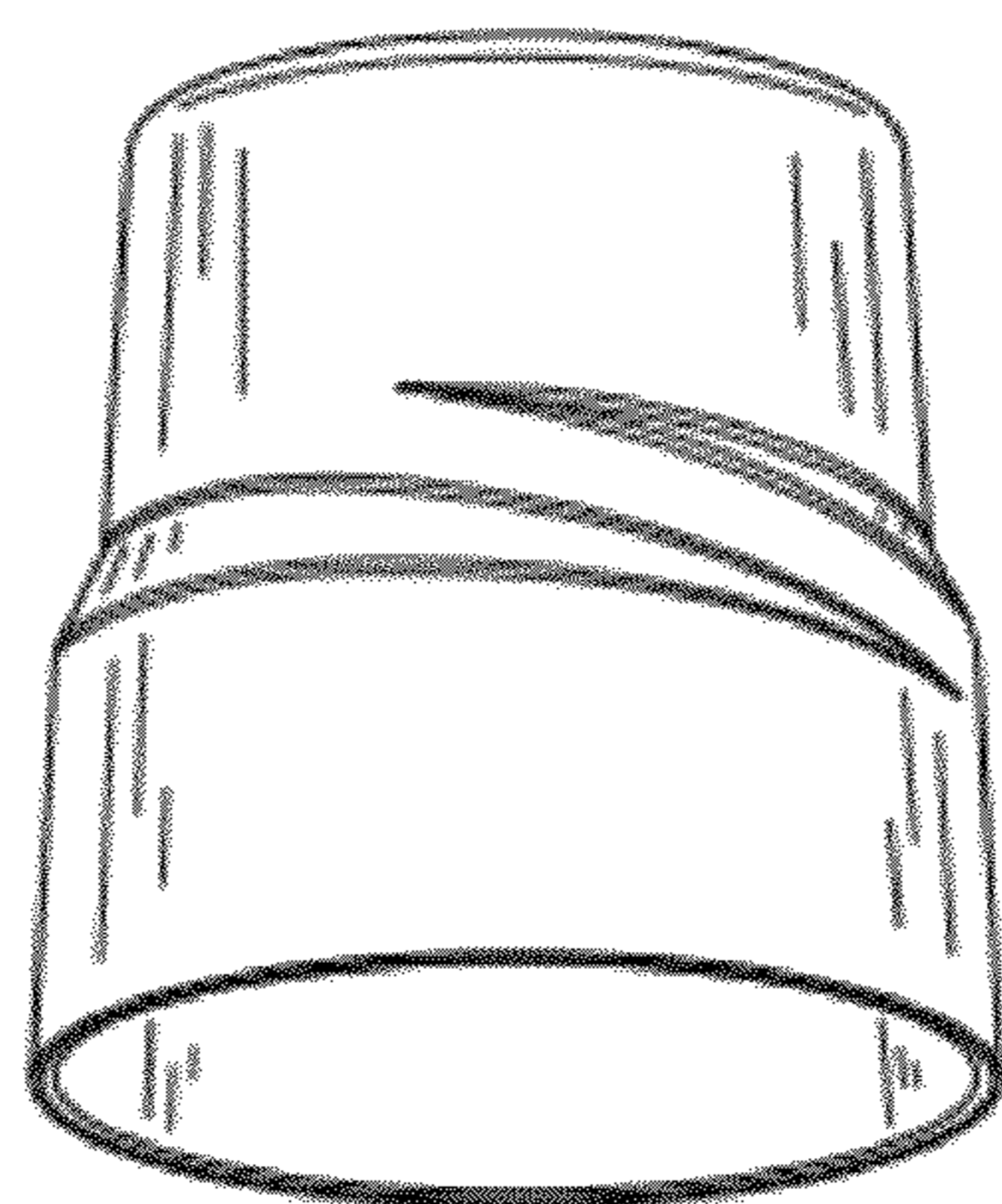

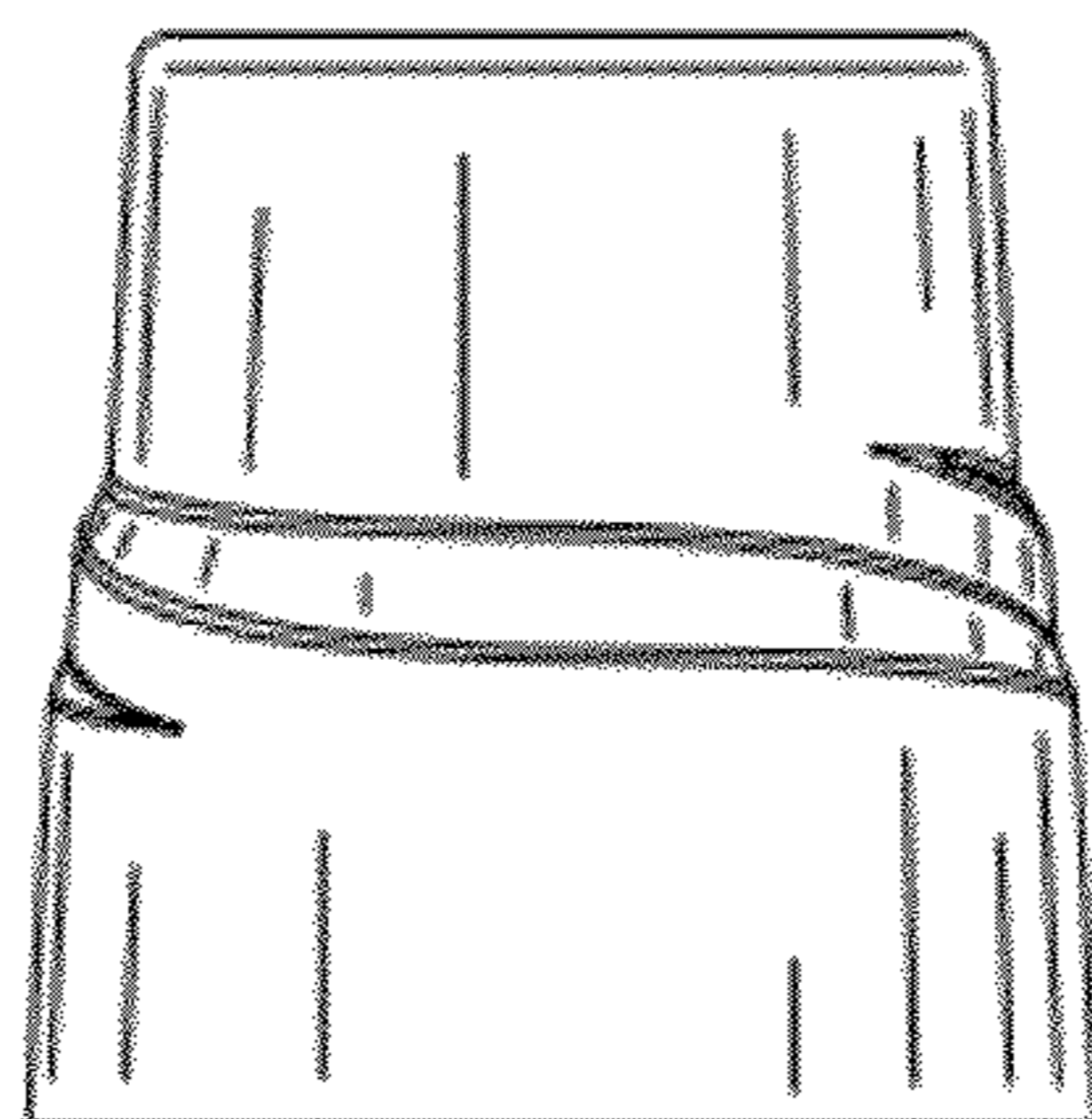

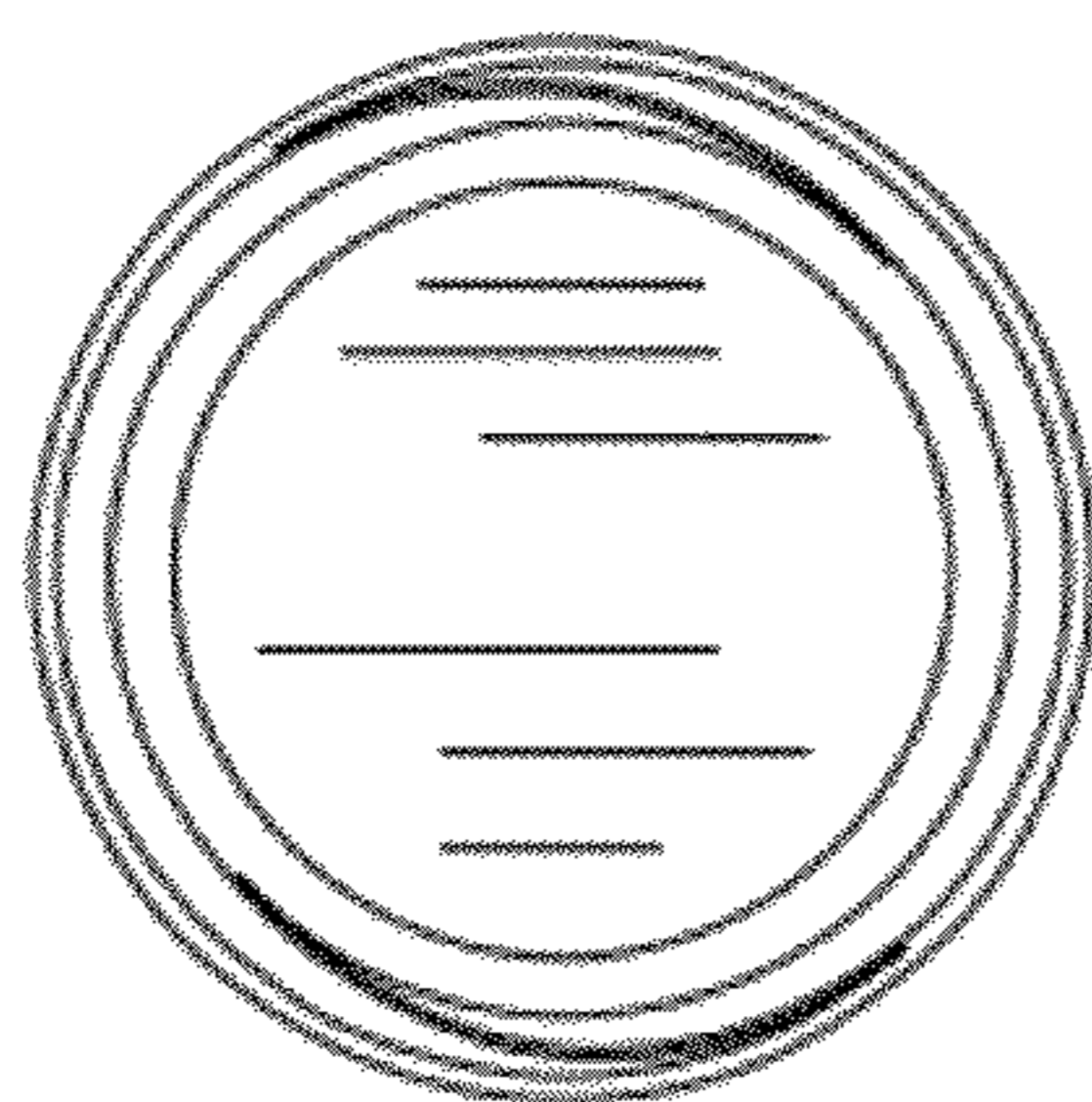

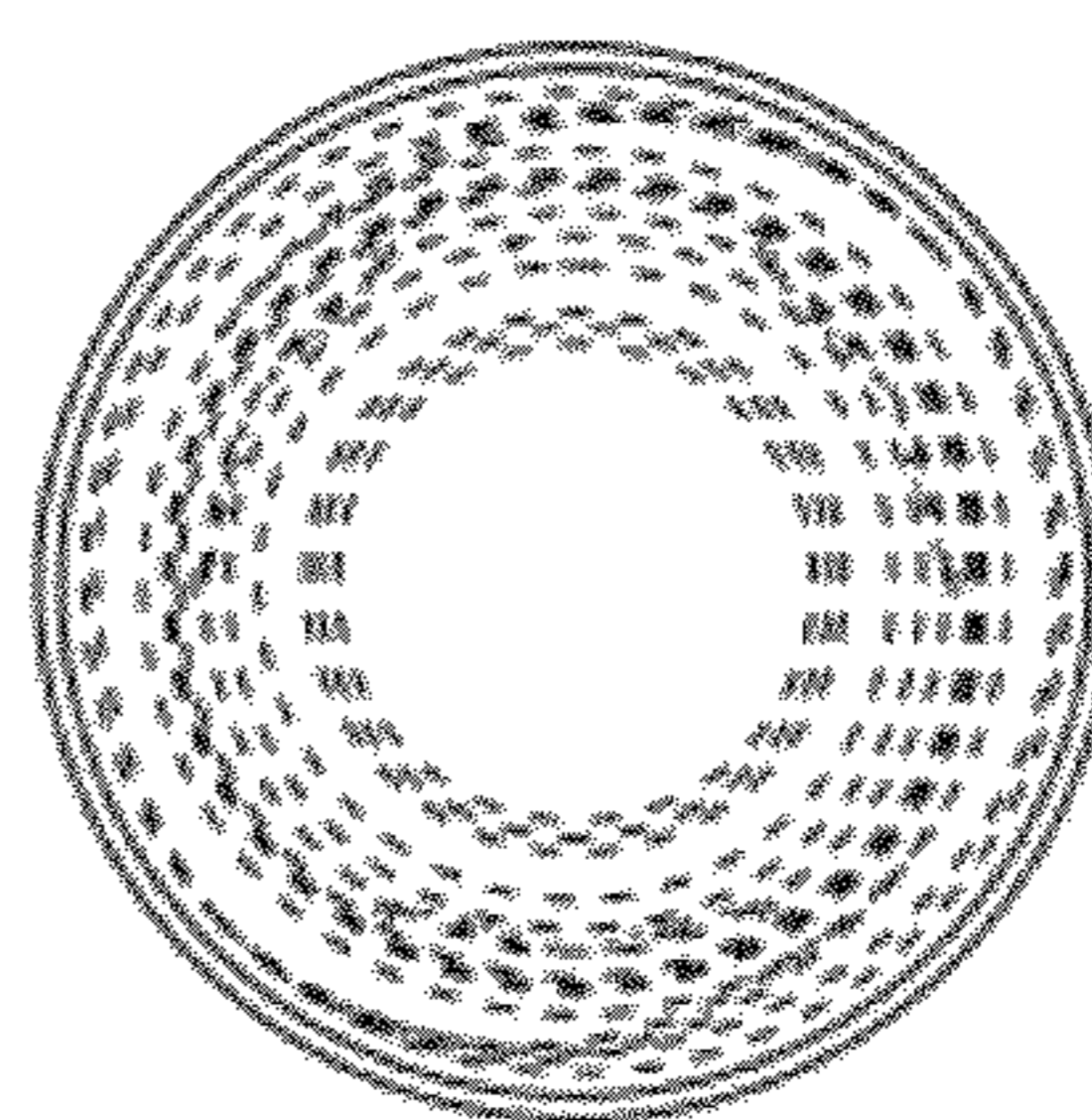
