**DESCRIPTION**

FIG. 1 is an enlarged top view of a first embodiment of the ring;

FIG. 2 is an enlarged bottom view of the ring illustrated in FIG. 1;

FIG. 10 is a right elevational view of the ring illustrated in FIG. 8;

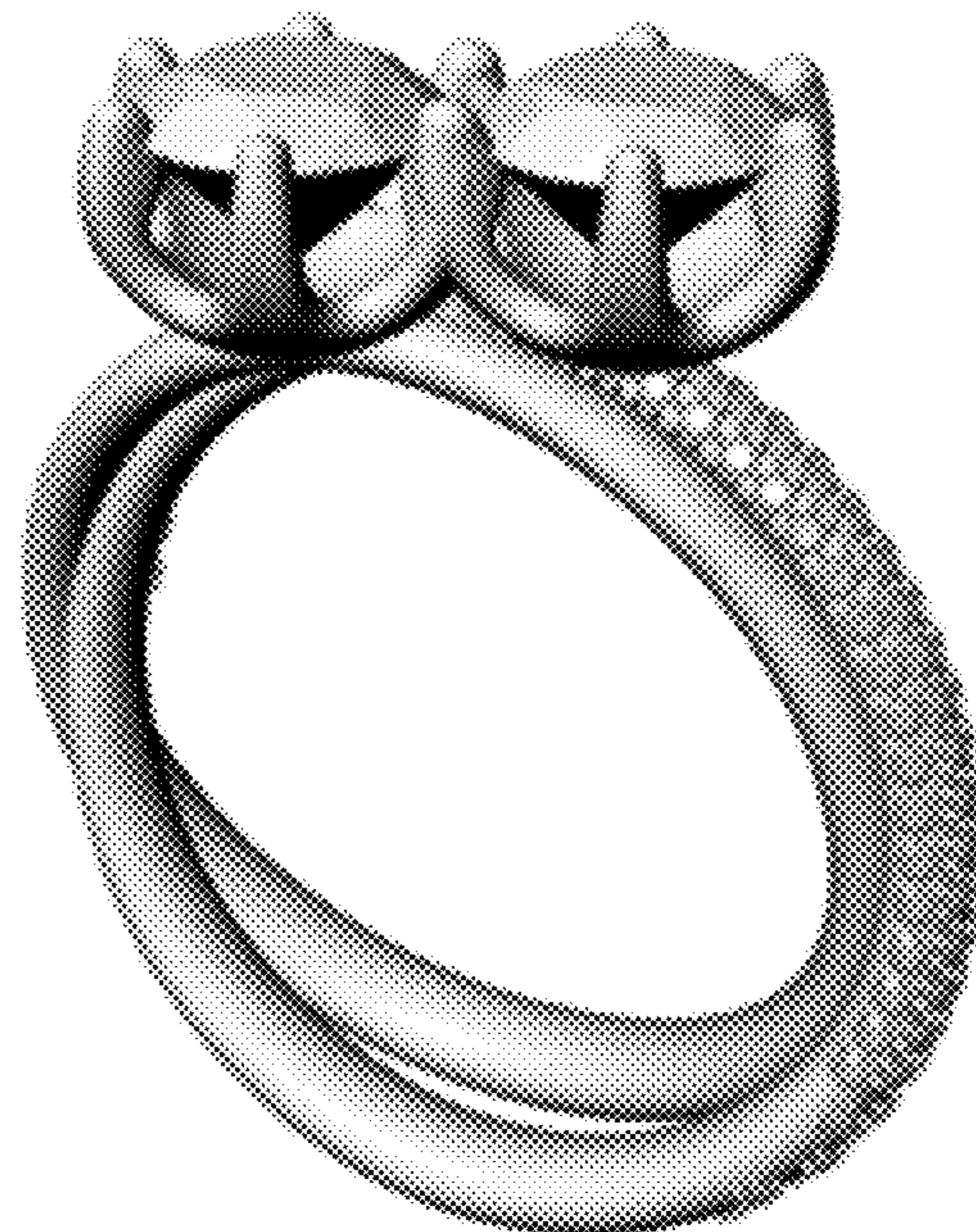
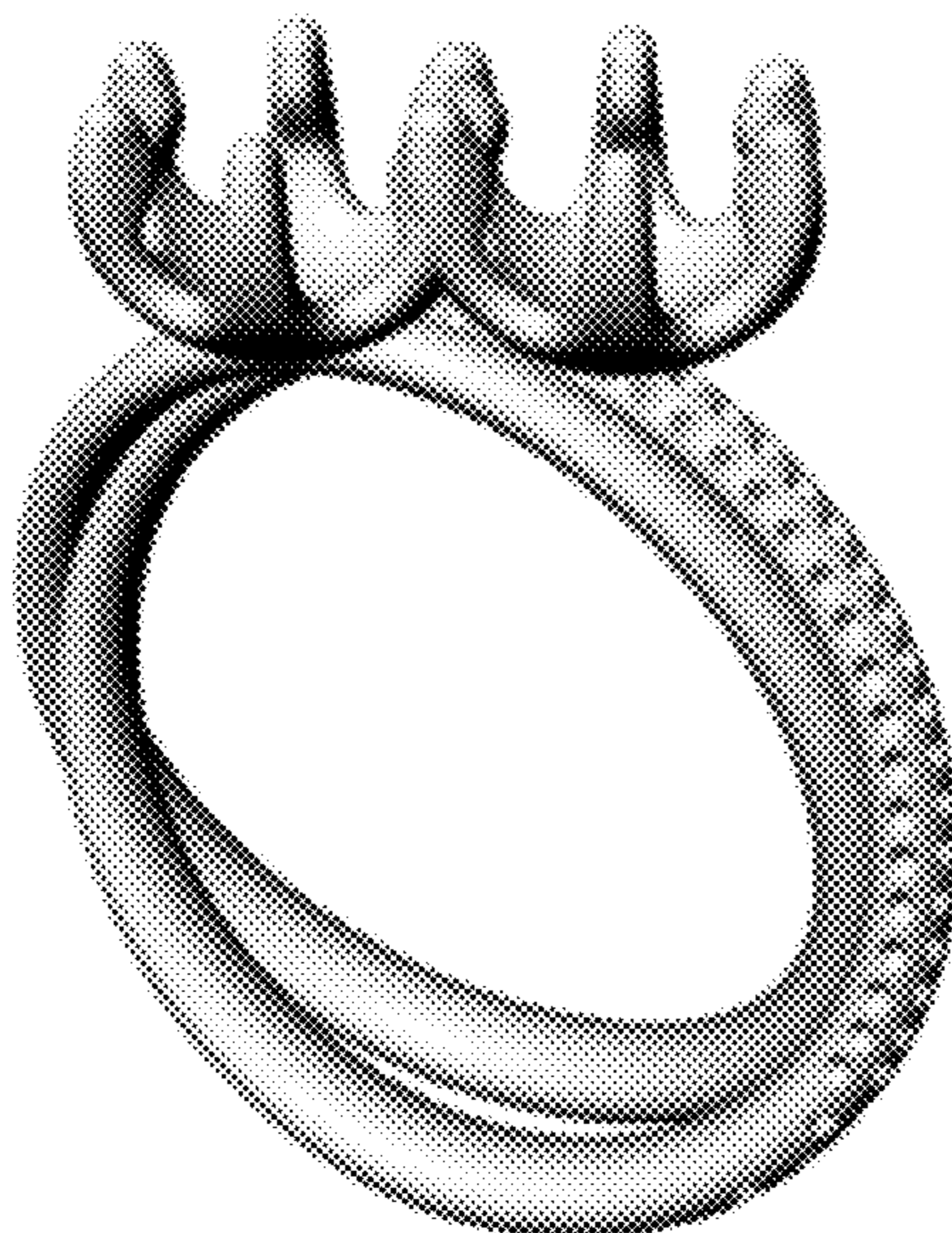
FIG. 11 is a left elevational view of the ring illustrated in FIG. 8;

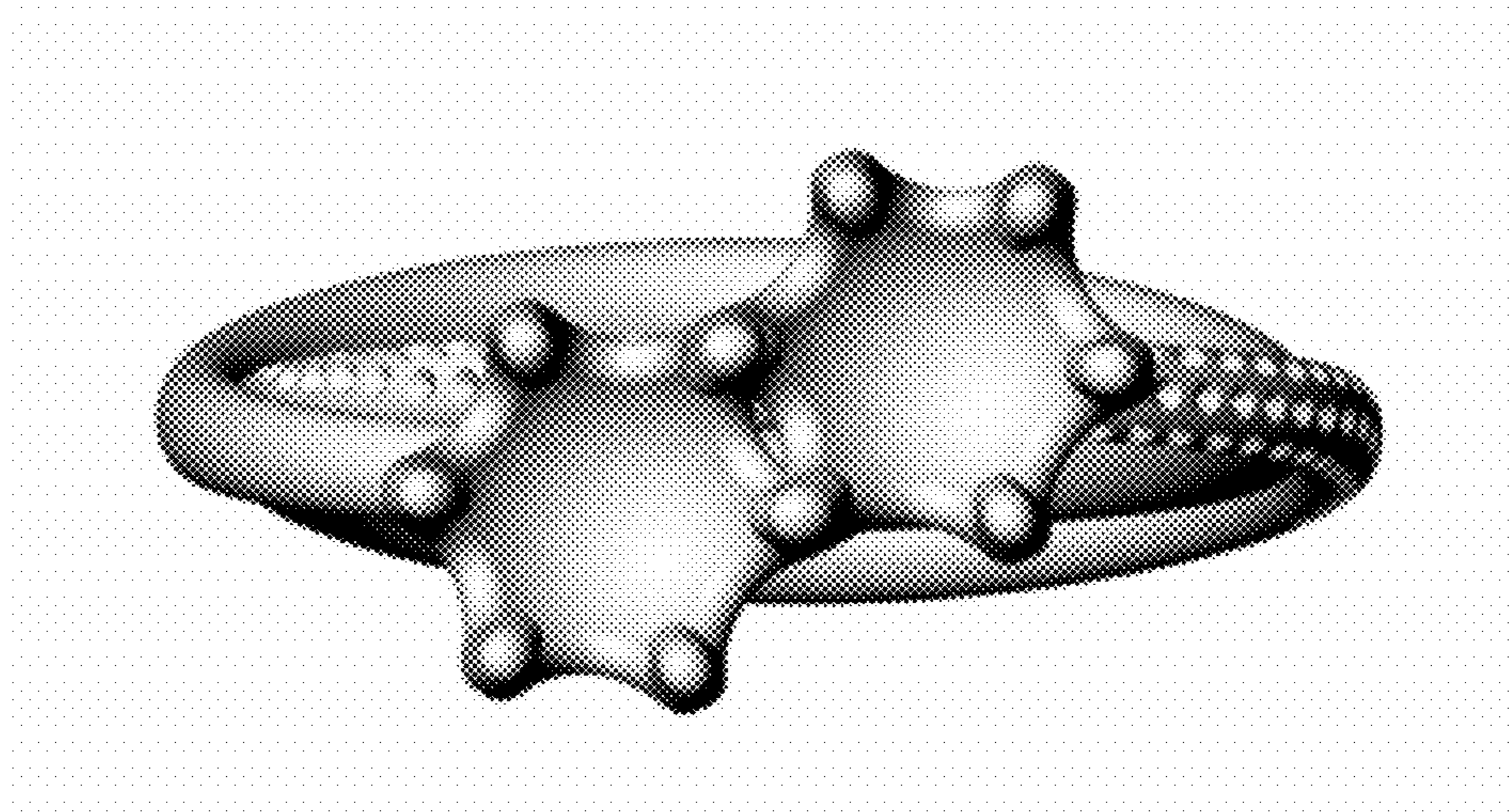

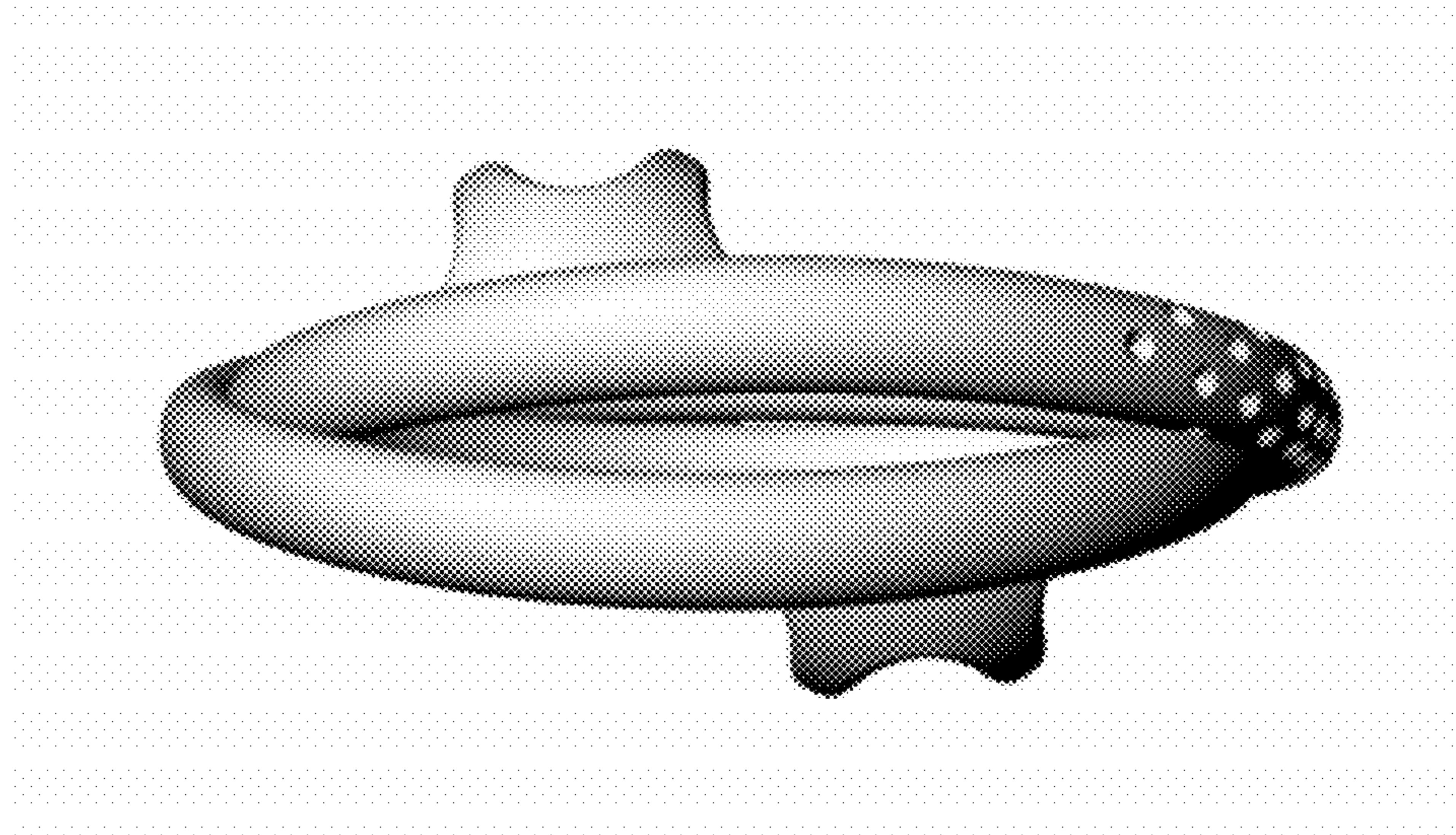

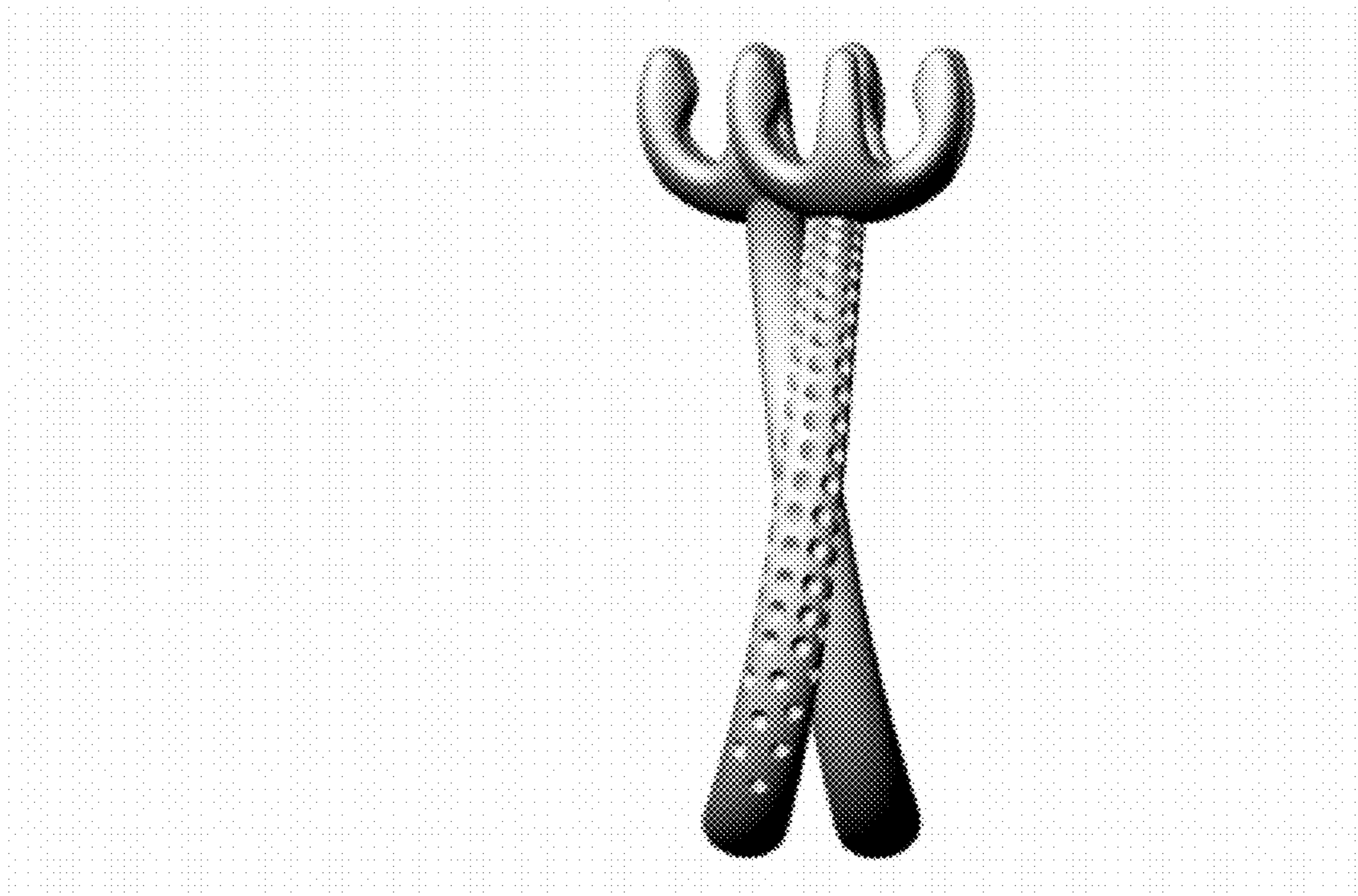

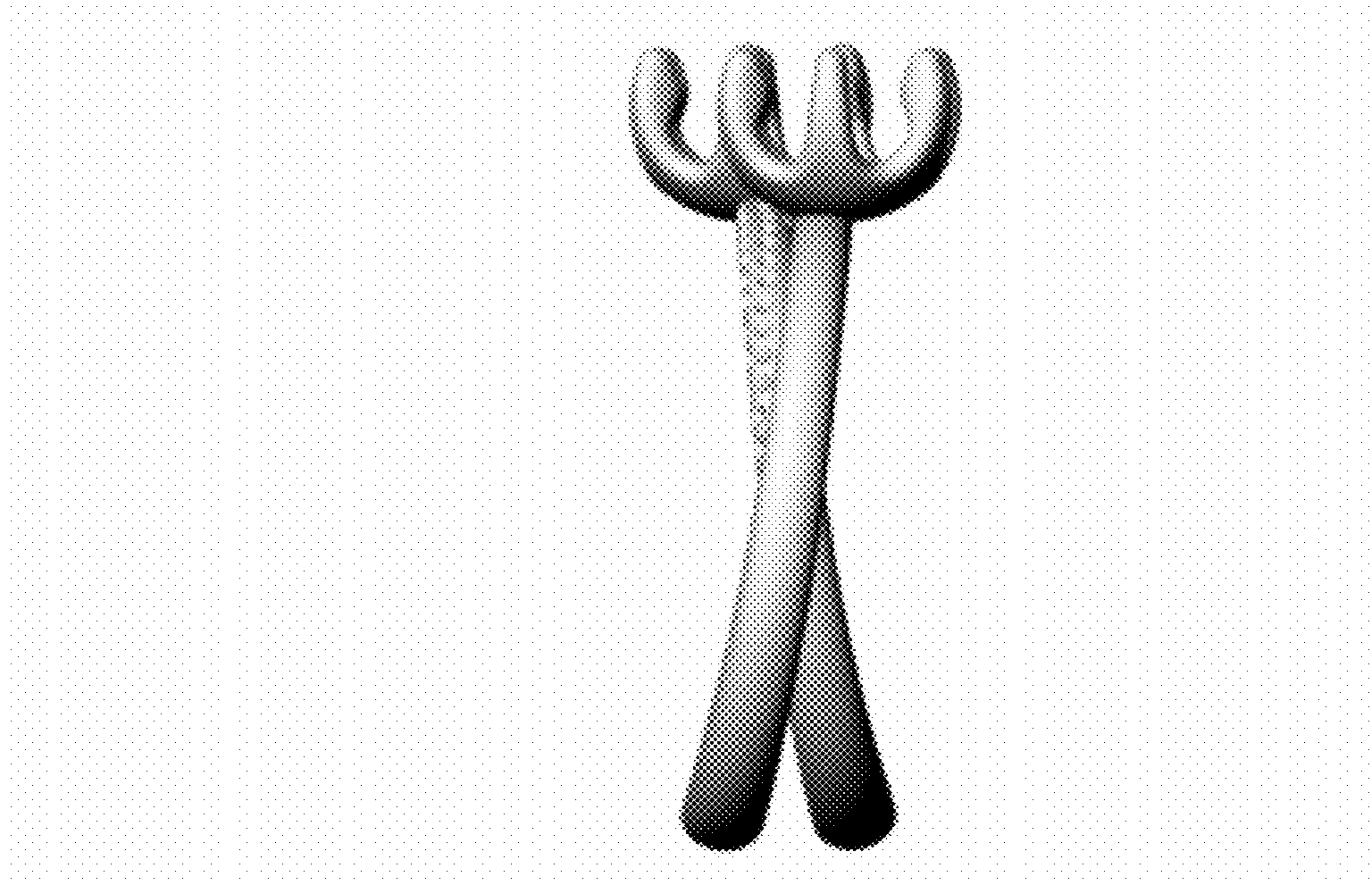

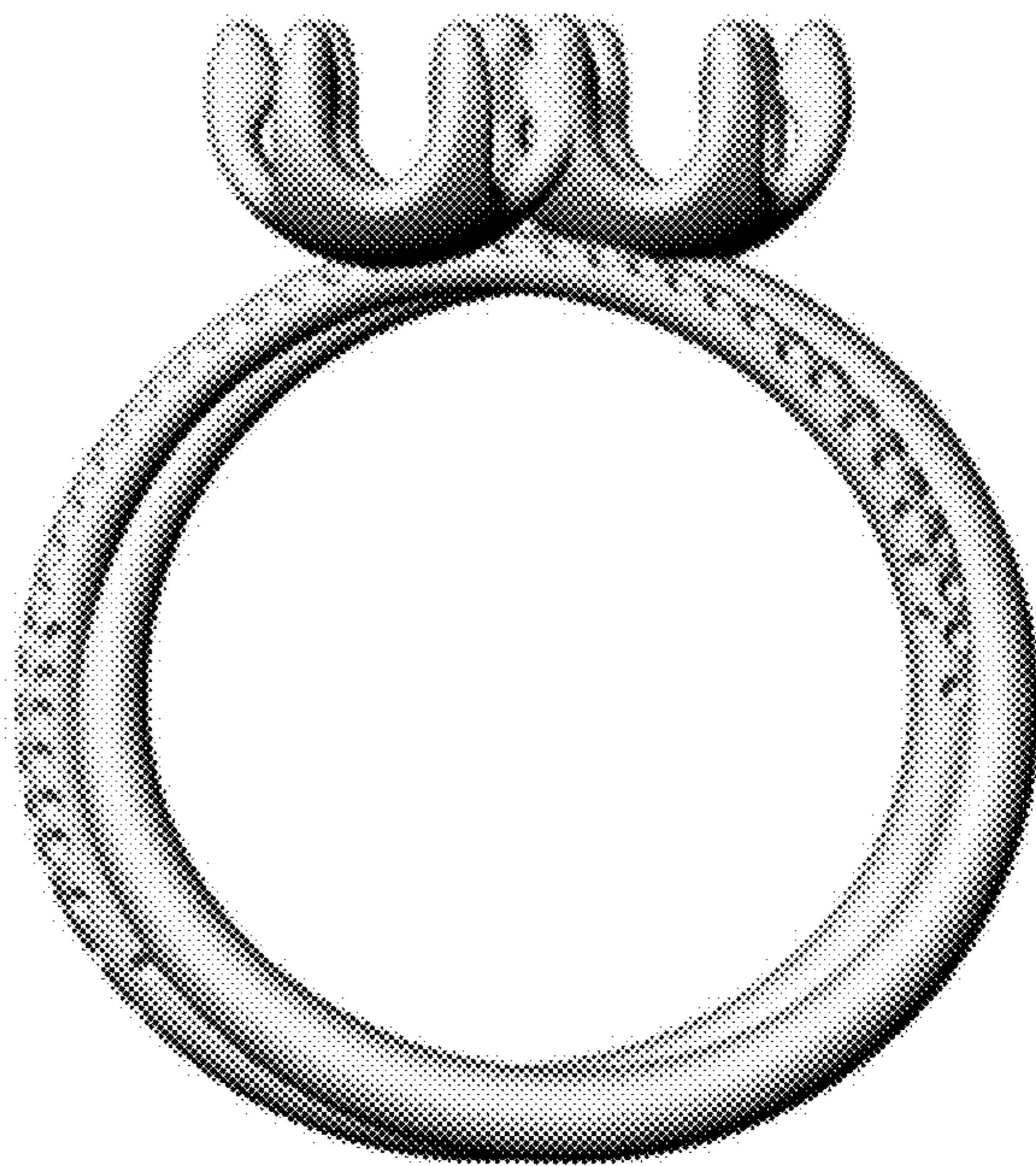

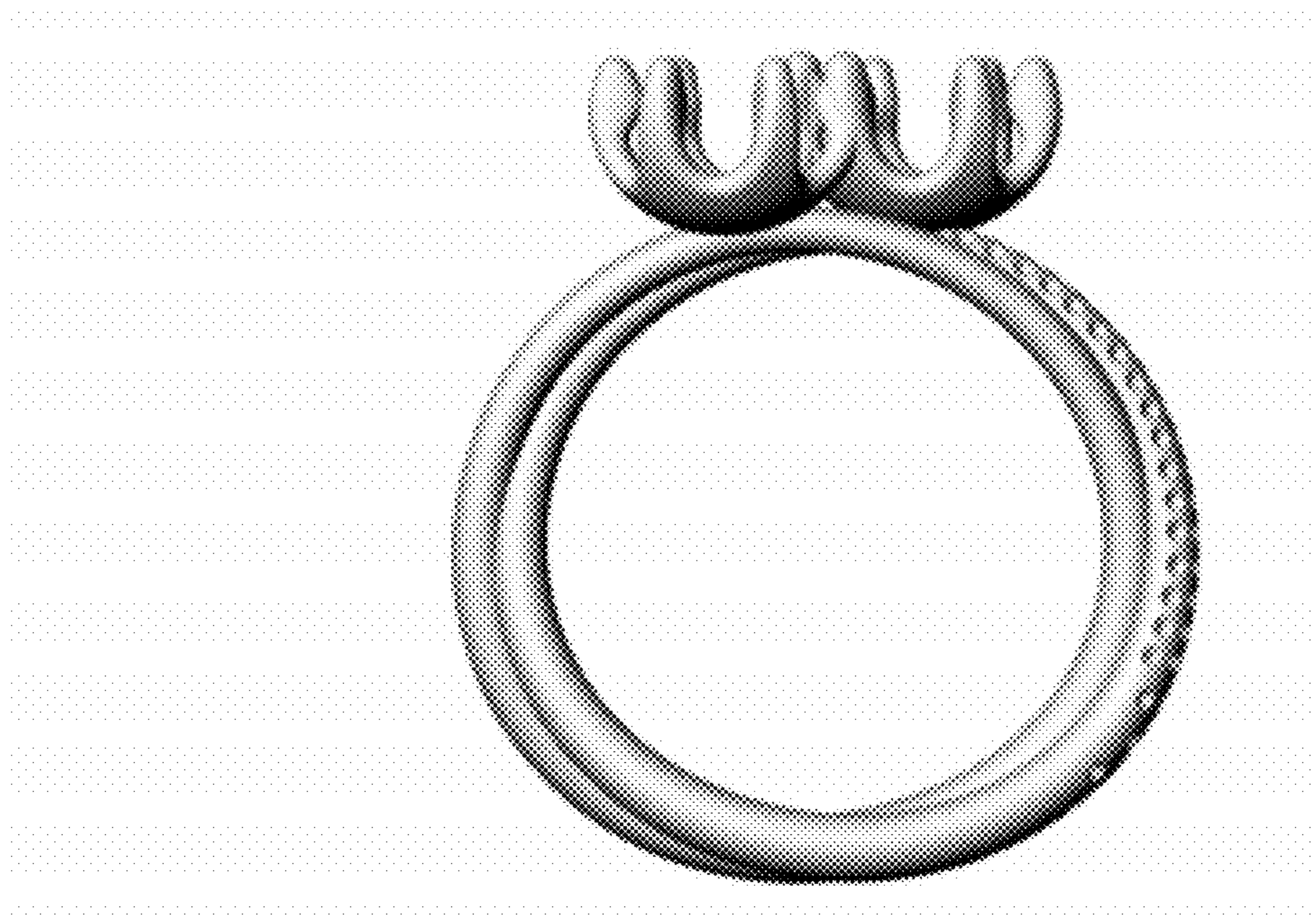

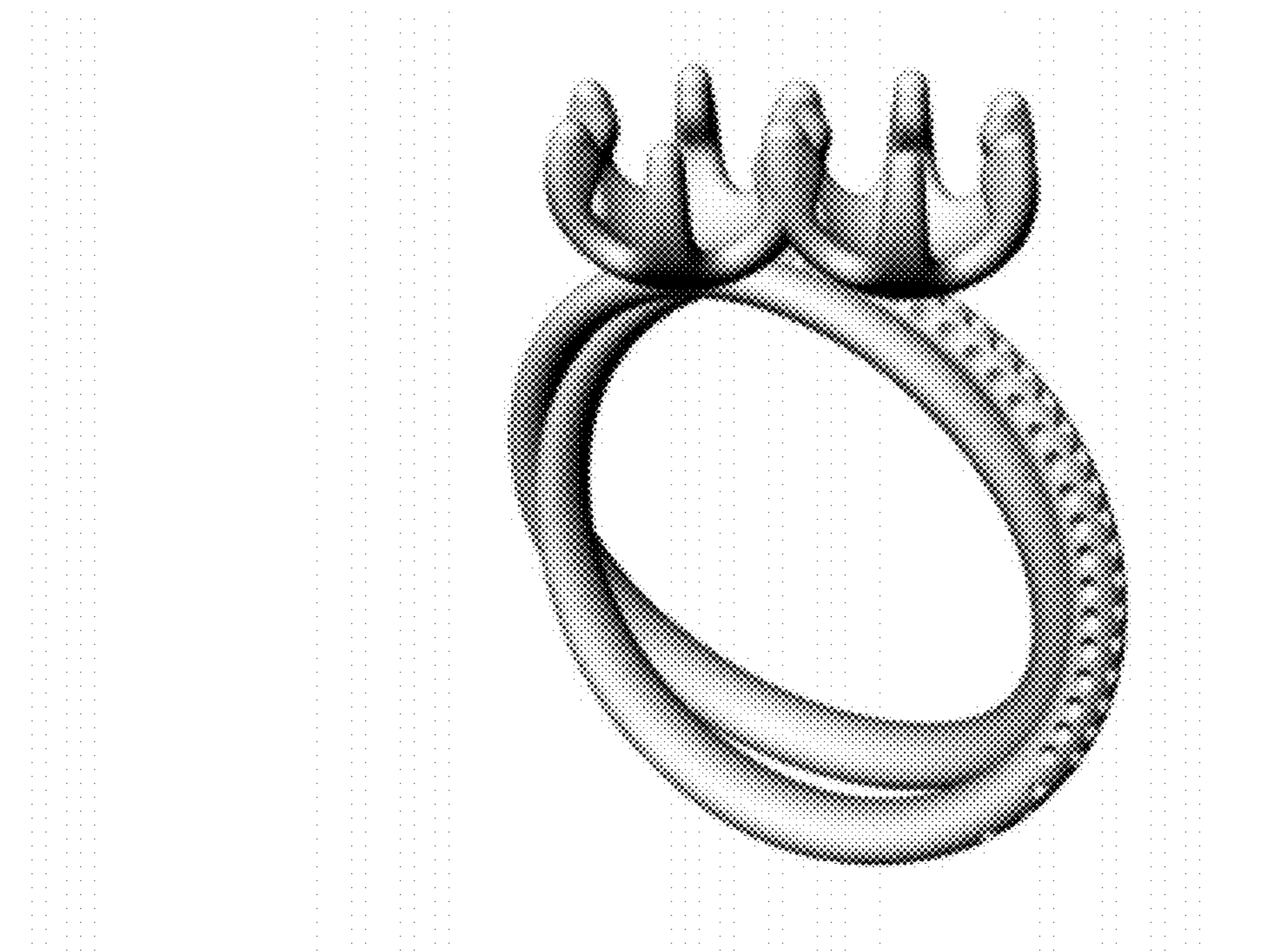

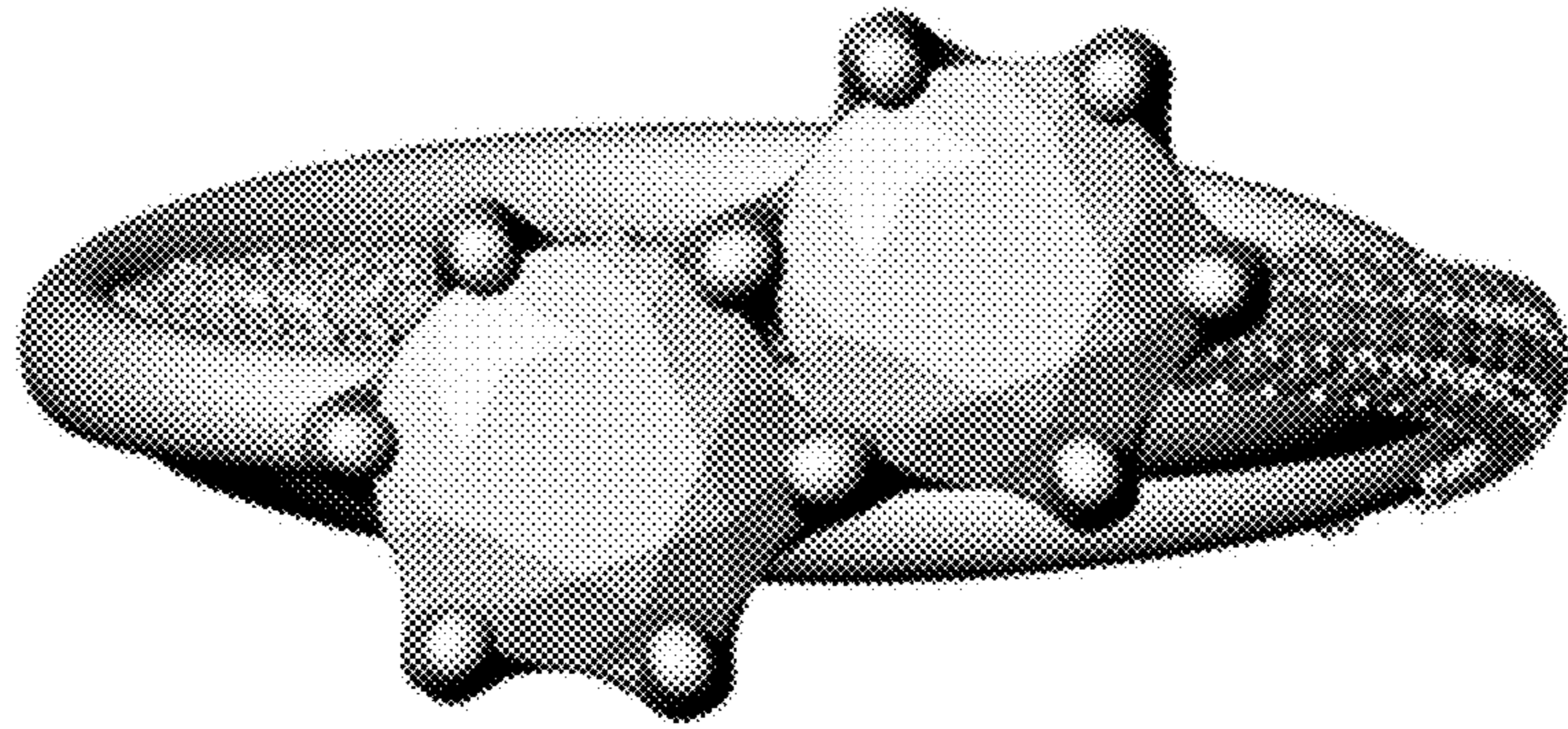

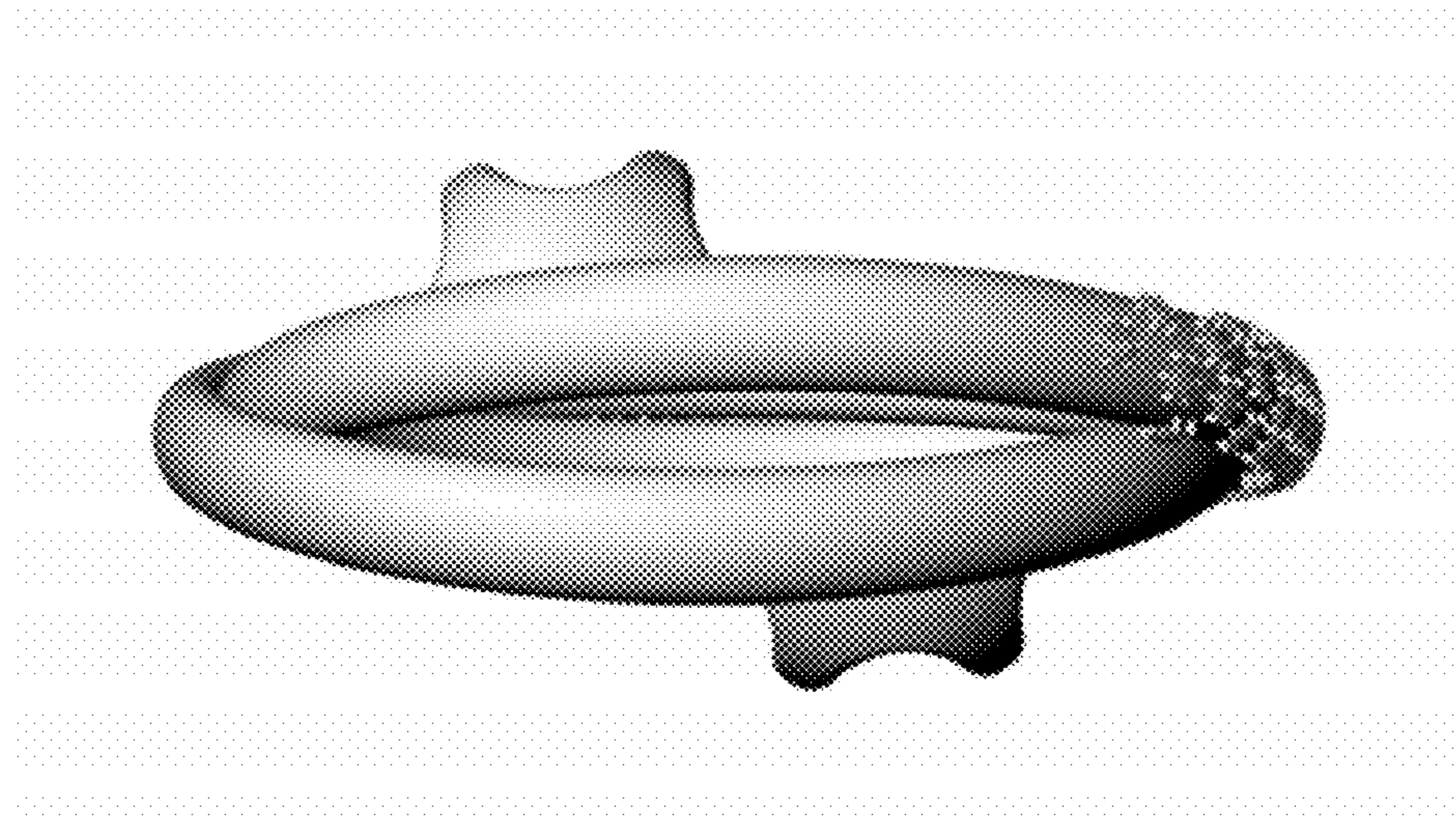

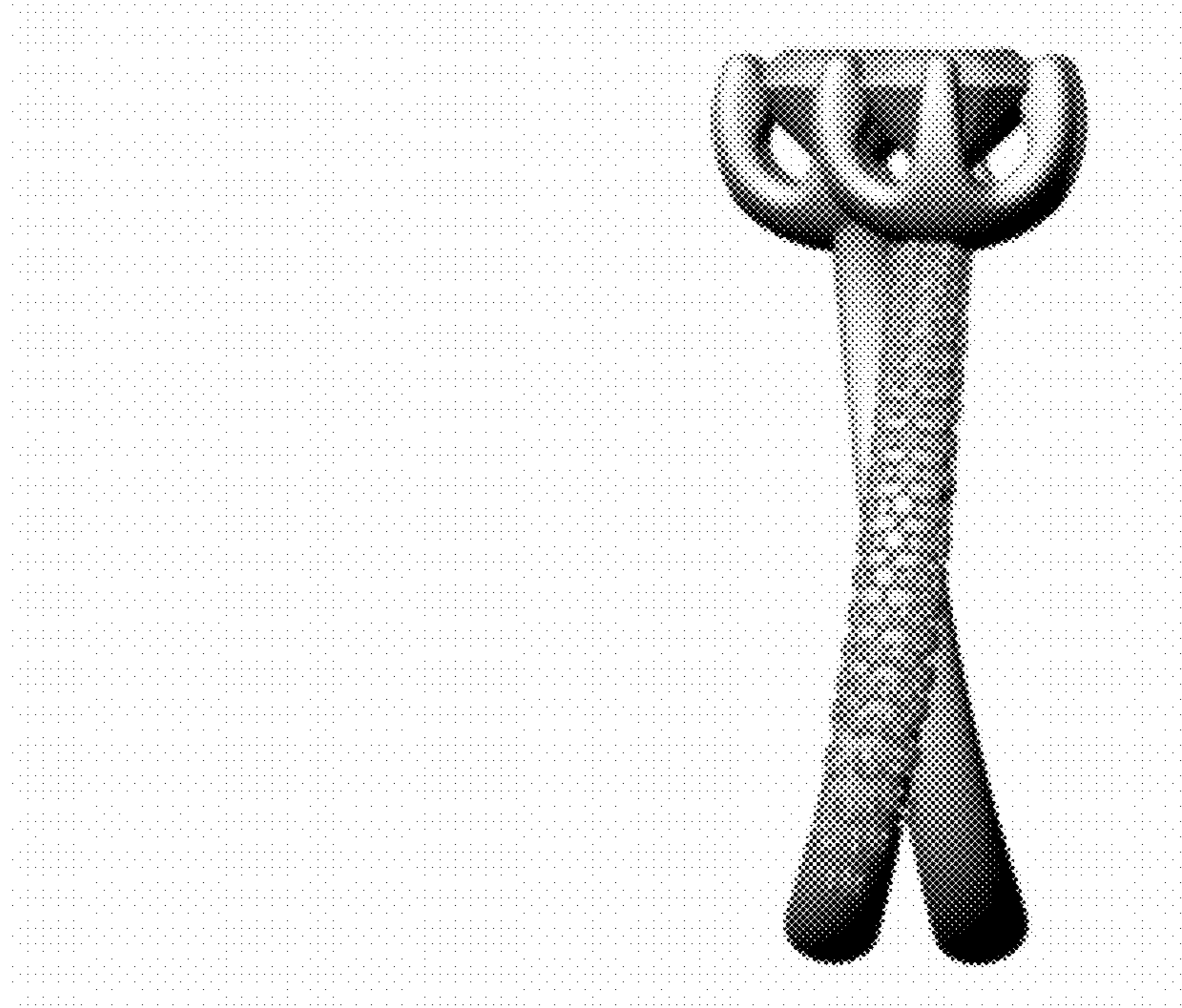

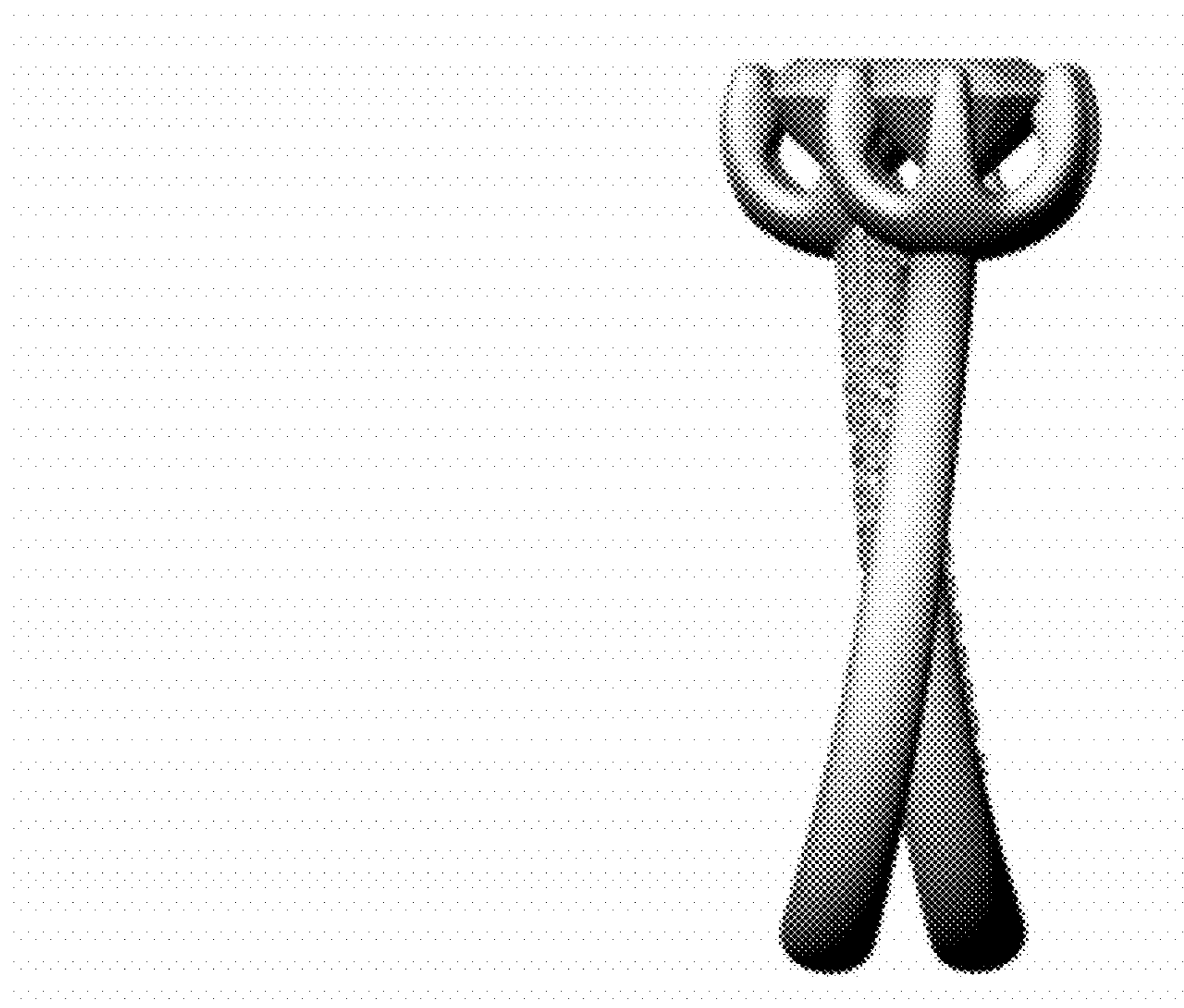

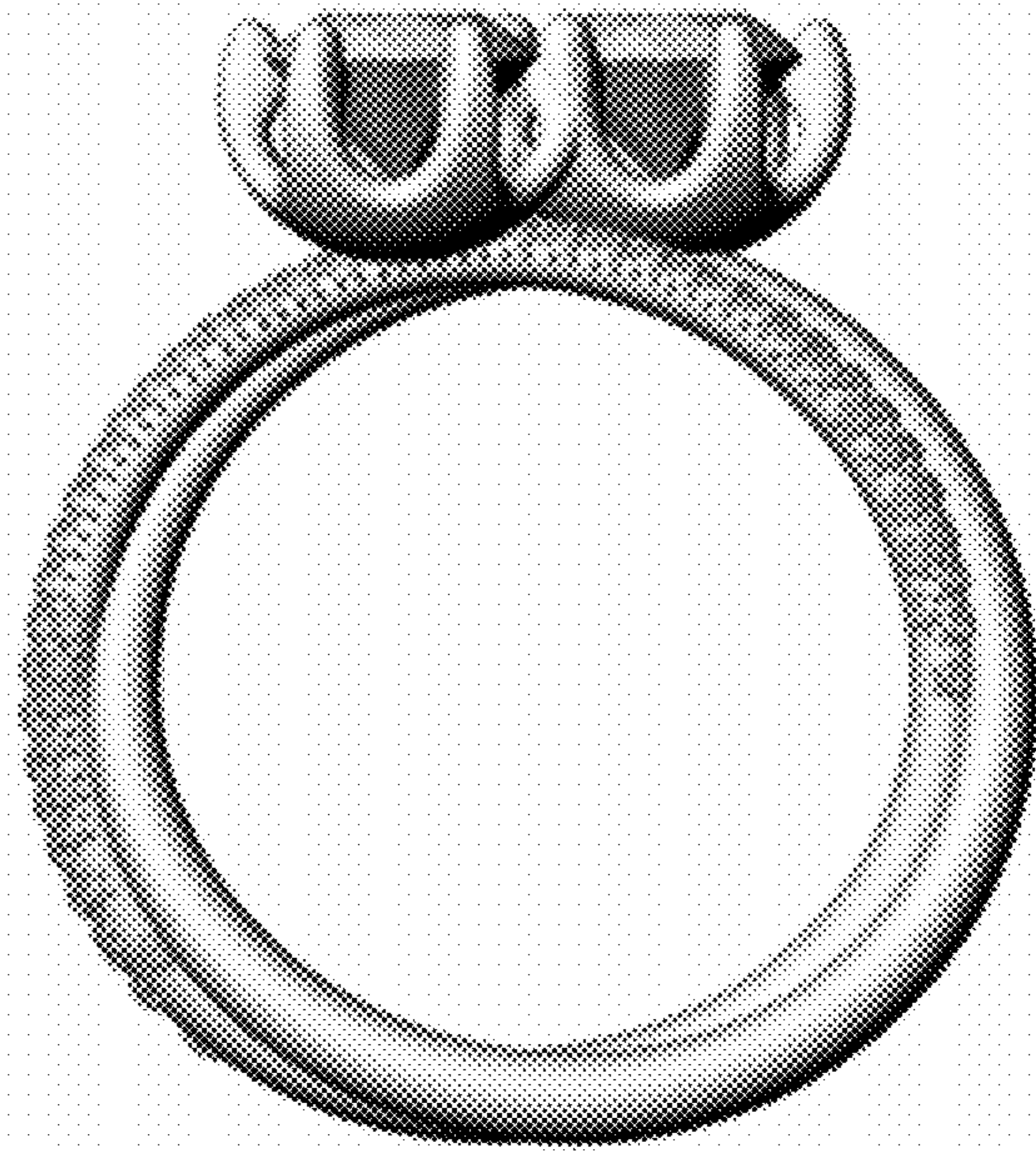

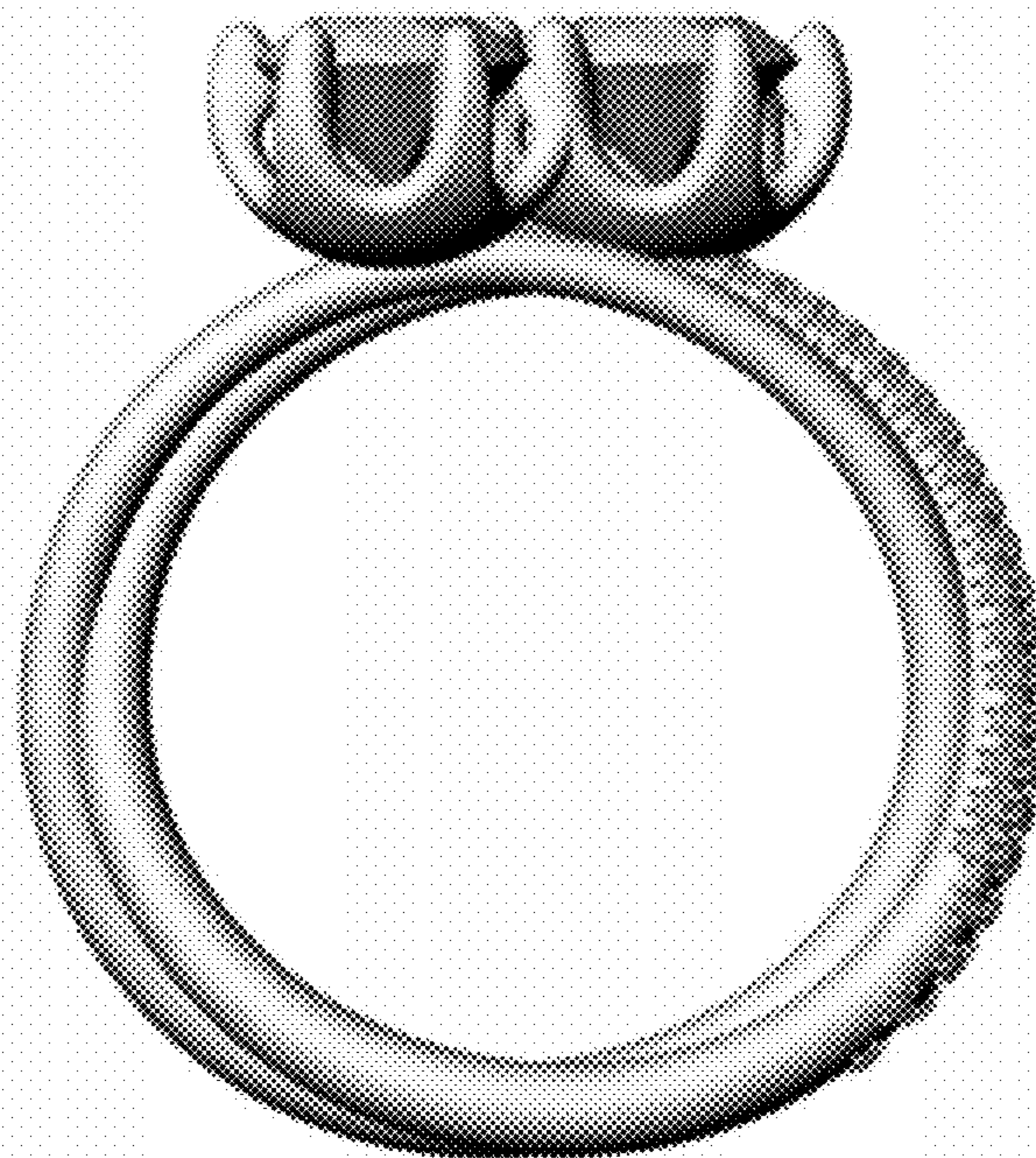
