(57) **CLAIM**

The ornamental design for a tread portion of an automobile tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tread portion of an automobile tire according to a first embodiment of the invention; FIG. 2 is a front view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a fragmentary enlarged view showing the details of the tread portion thereof; FIG. 5 is an end view taken along the lines 5-5 in FIG. 4; and, FIG. 6 is an end view taken along line 6-6 in FIG. 4. Broken lines in the drawing figures are used to show portions of the tire that are not claimed, and thus form no part of the claimed invention.

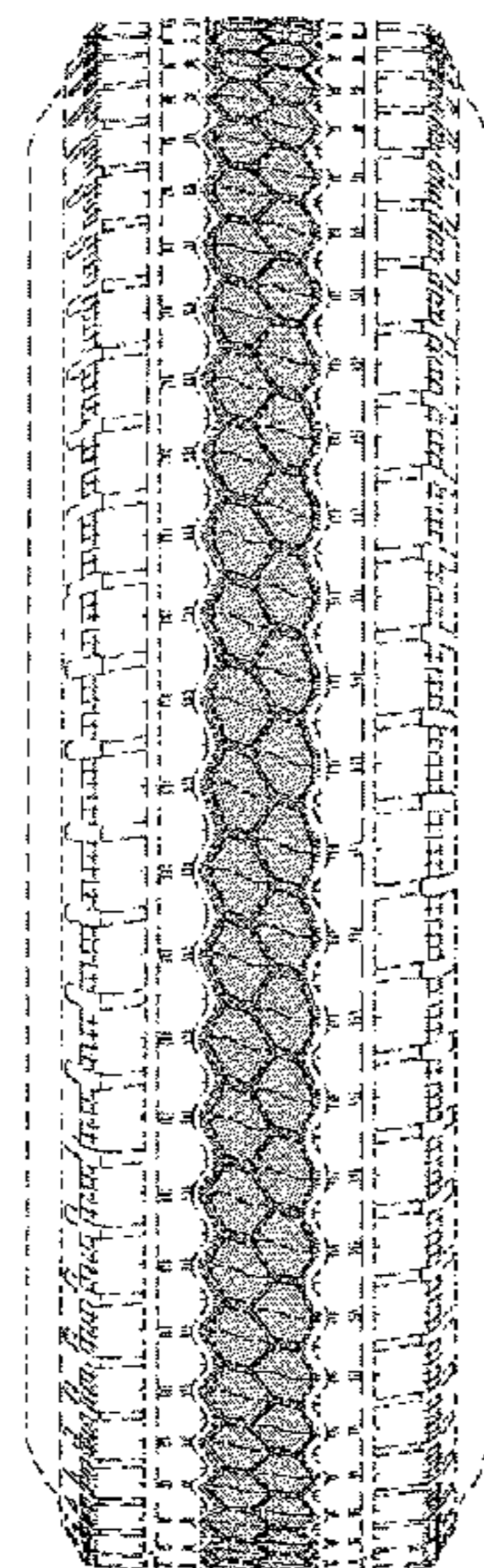
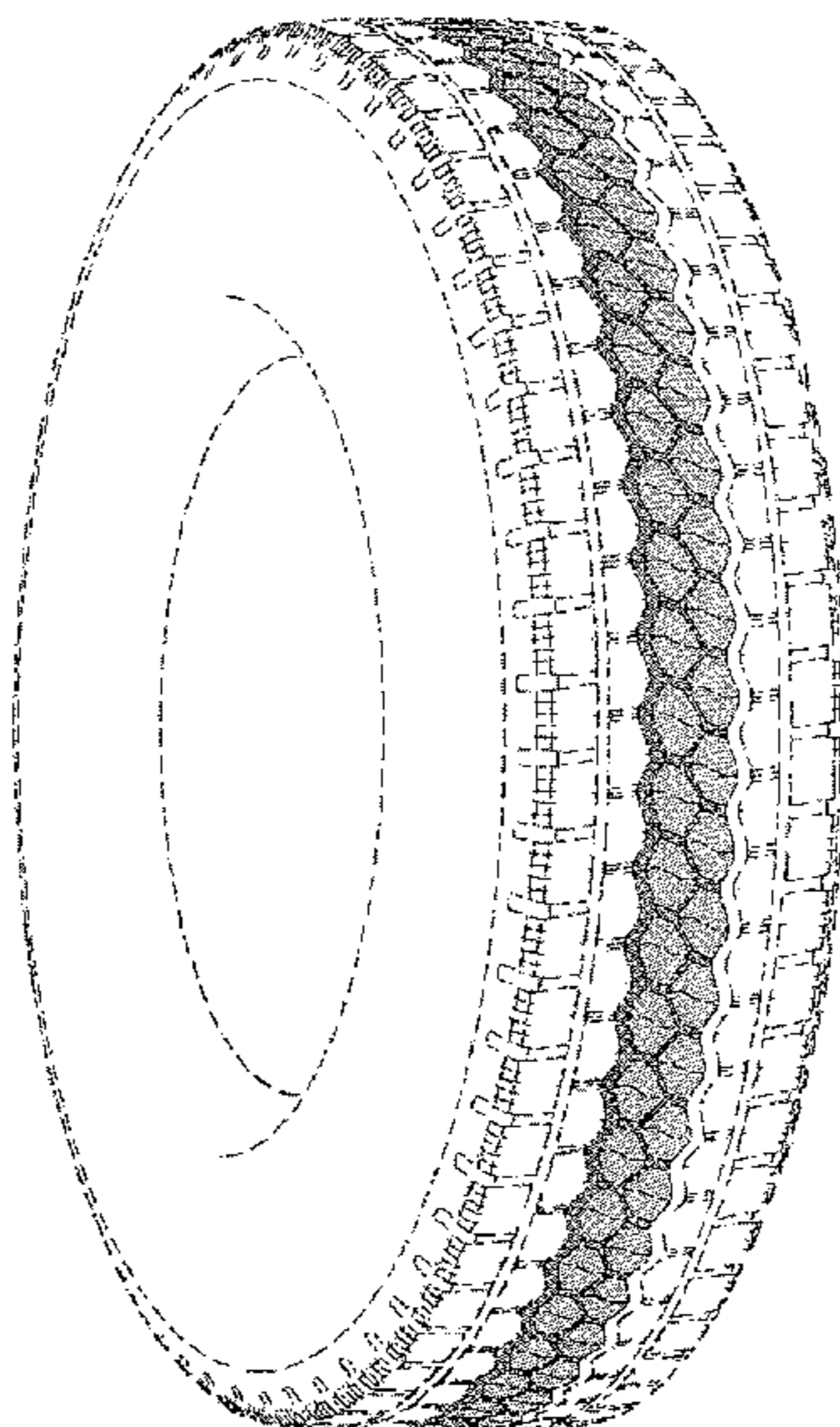

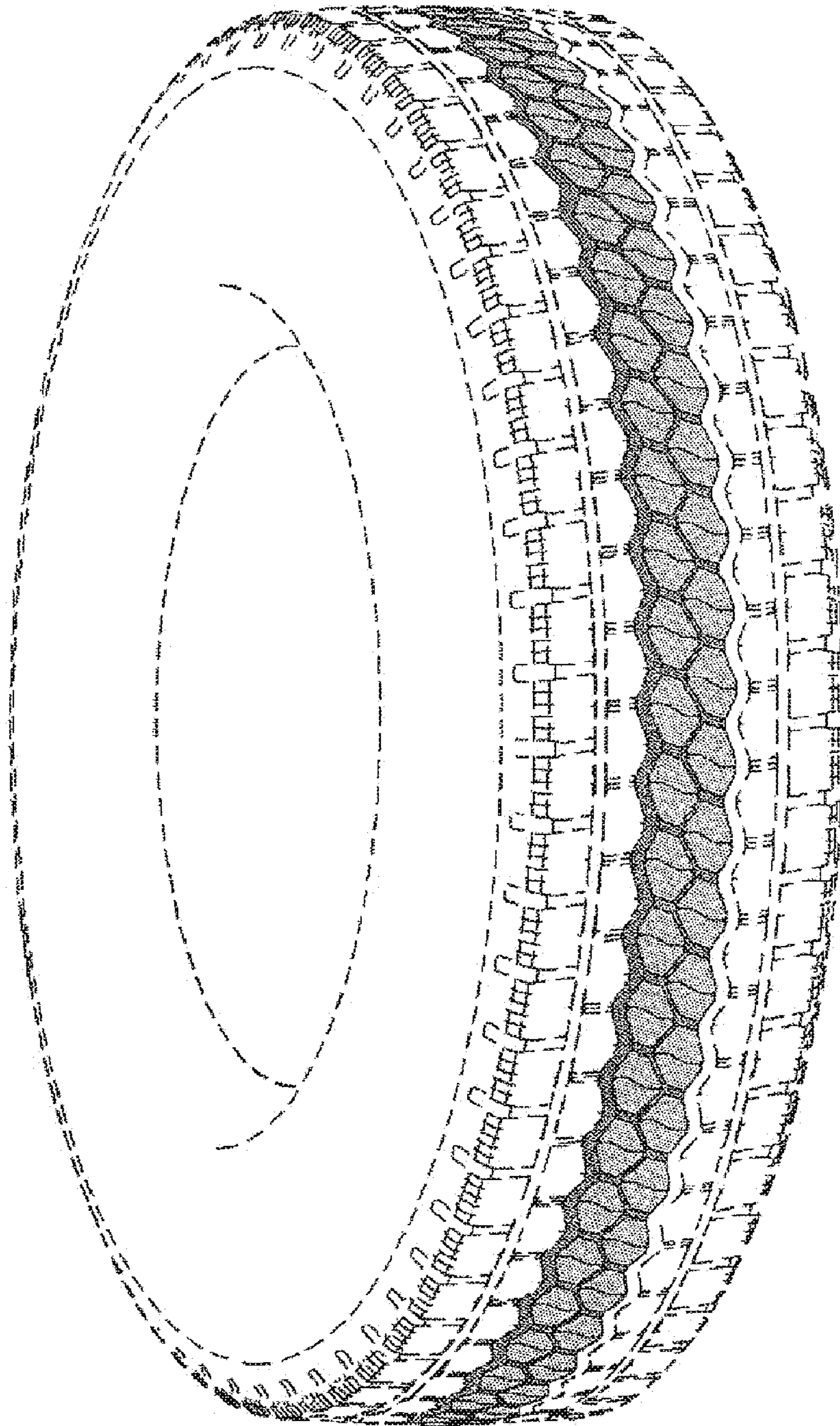

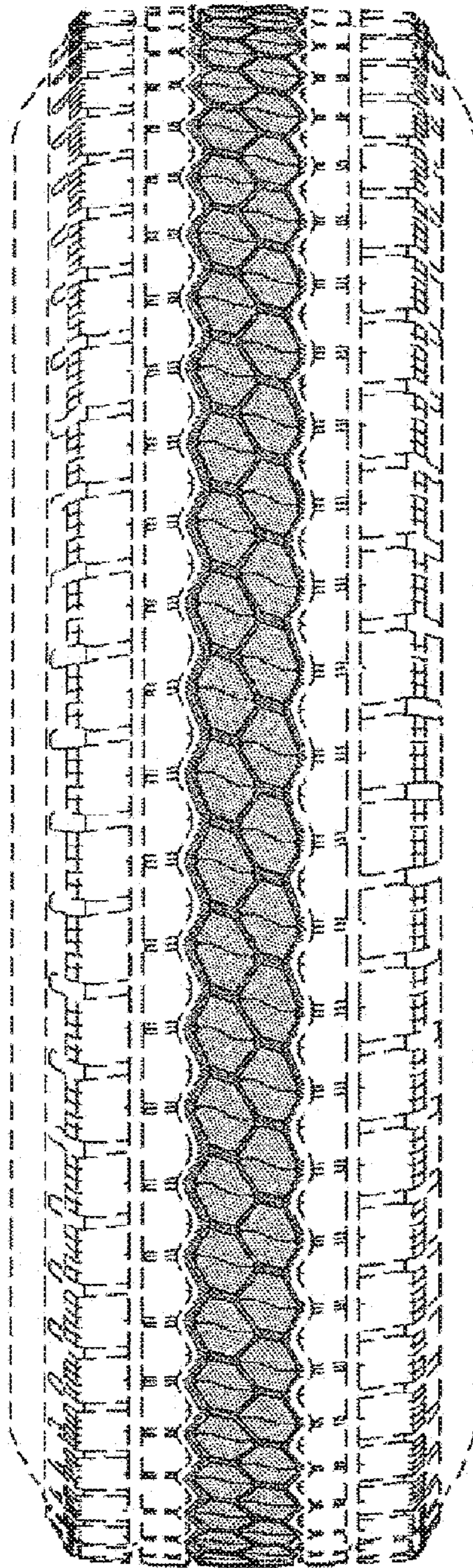

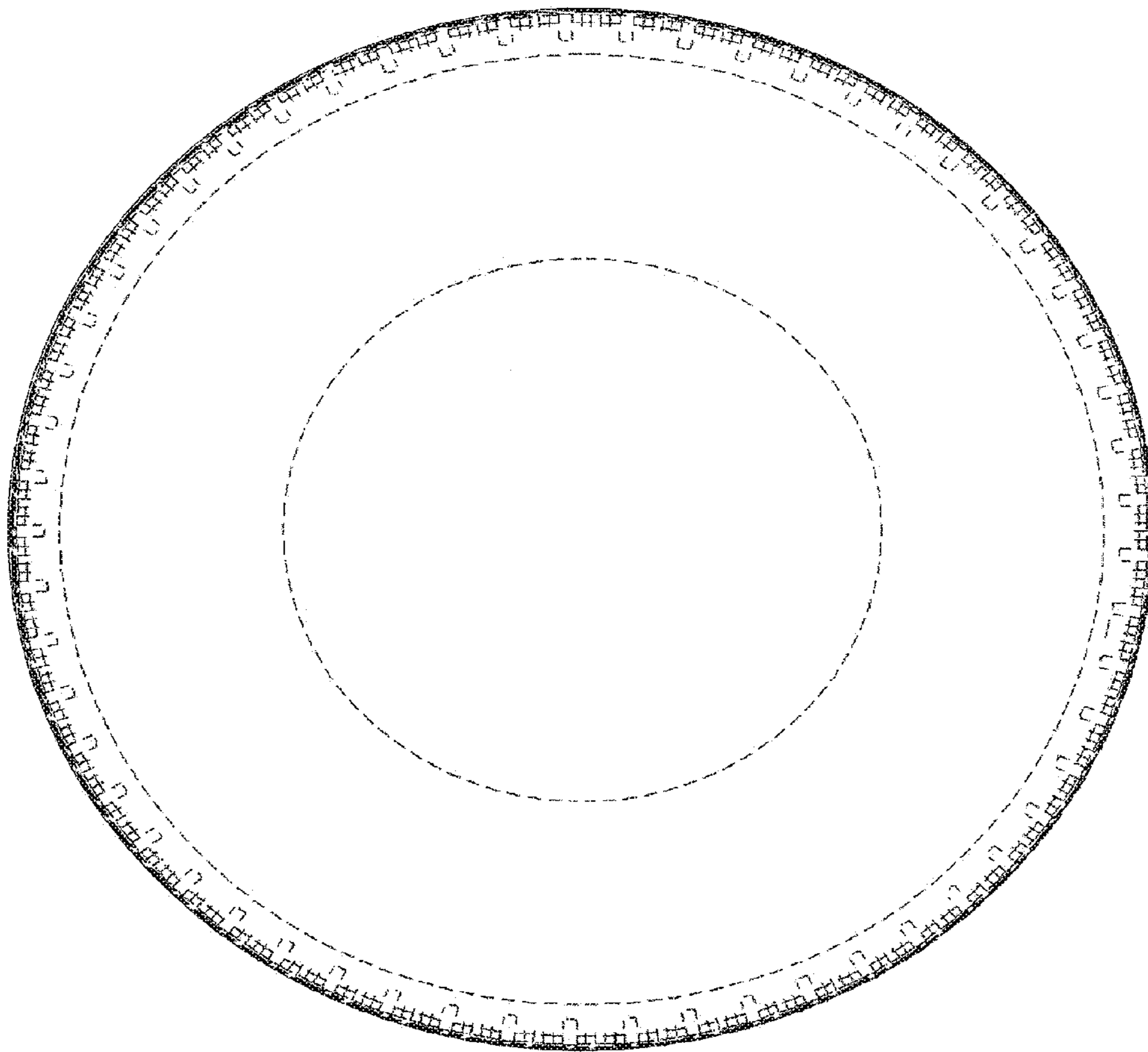

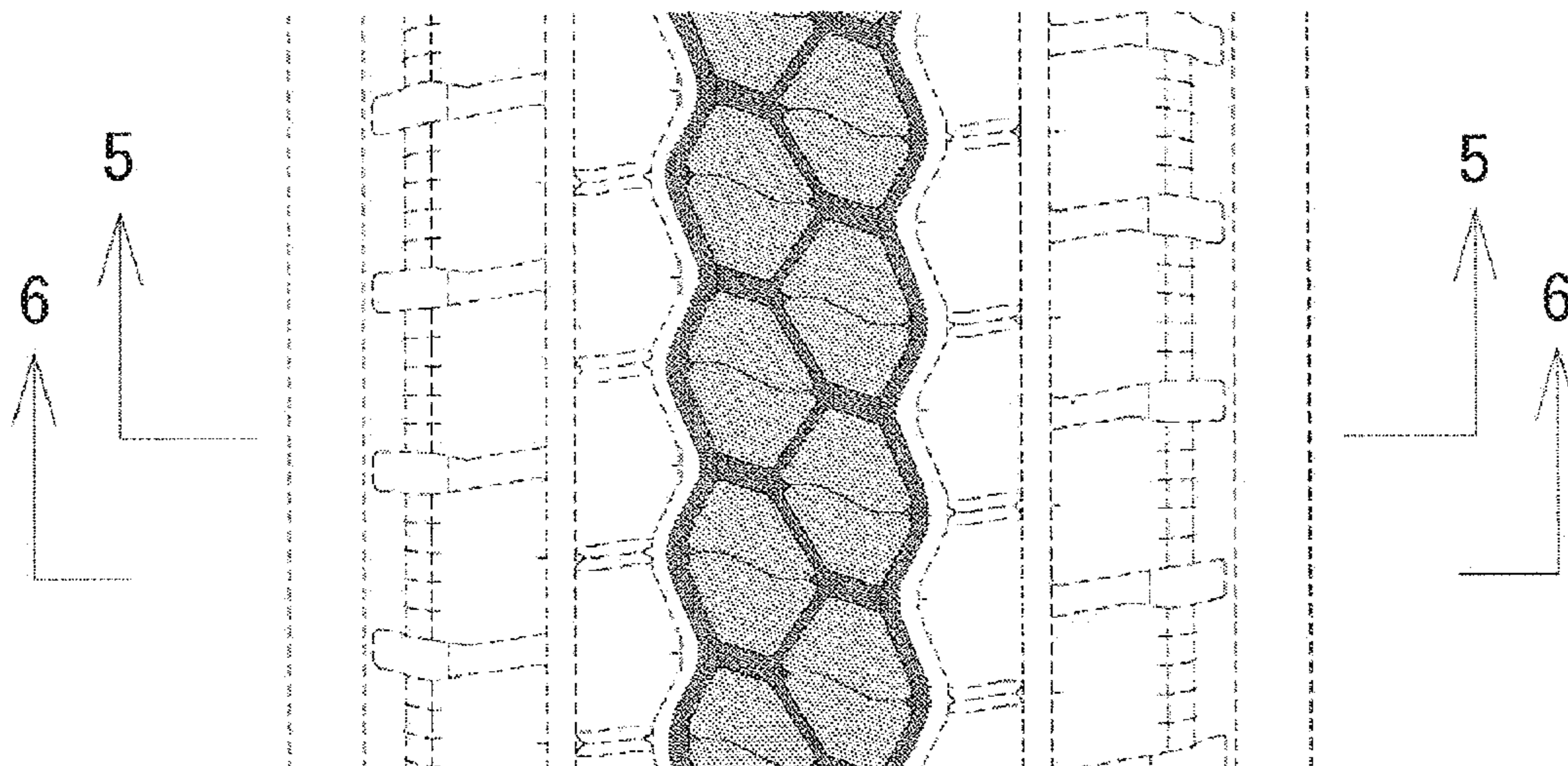

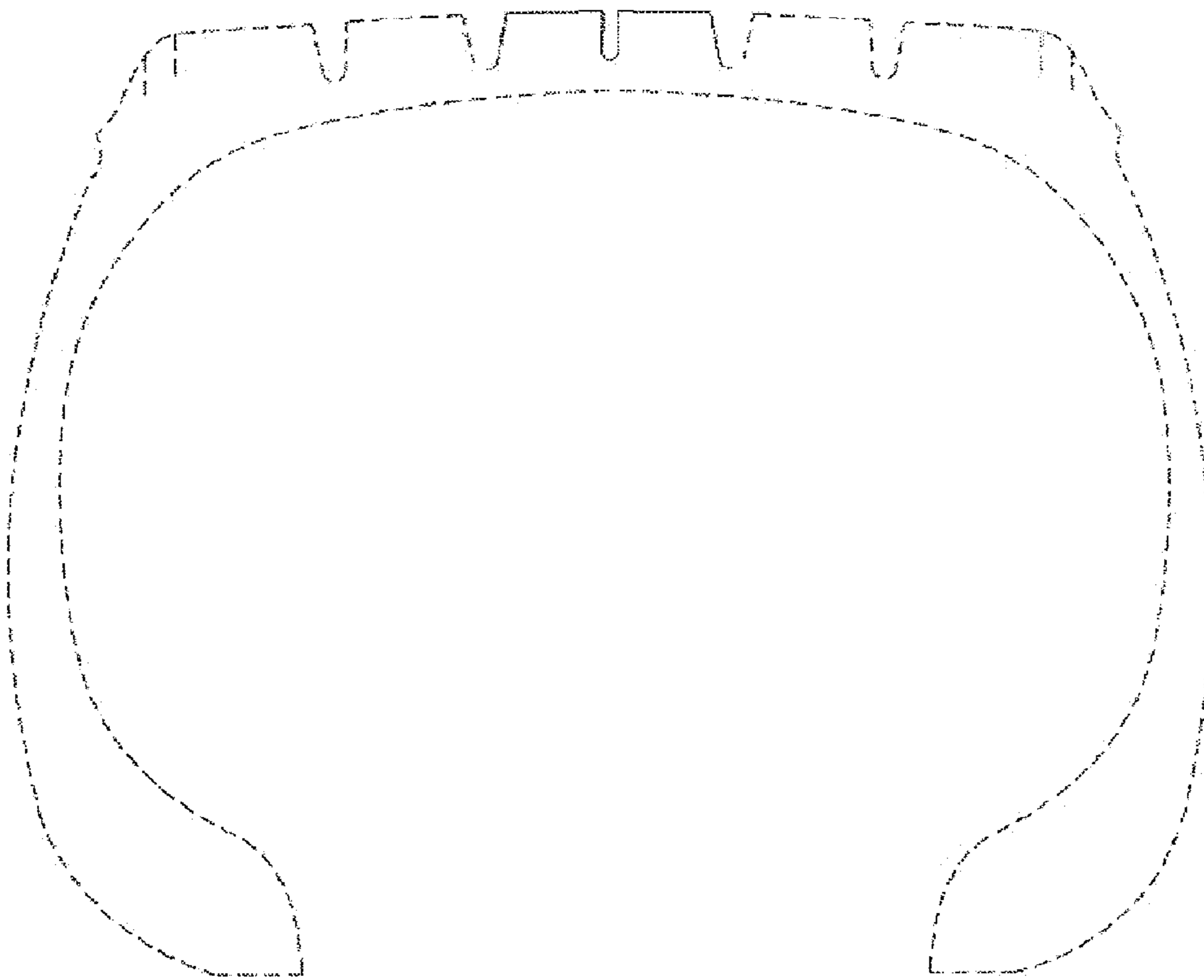
