The ornamental design for a metal transaction card, as shown and described.

**DESCRIPTION**

FIG. 11 depicts a top plan view of the metal transaction card of FIG. 7, the bottom plan view being the mirror image thereof.




FIG. 12 depicts a left elevation view of the metal transaction card of FIG. 7, the right elevation view being the mirror image thereof.

The broken lines in the drawings illustrate environmental structure on the article and form no part of the claimed design.






































































