The ornamental design for hand sign, as shown and described.

**DESCRIPTION**

FIG. 1 is a right-side elevational view of a first embodiment of a left-hand hand sign according to the invention;

FIG. 2 is a left side elevational view of a left-hand hand sign of FIG. 1;

FIG. 3 is an enlarged front-side elevational view of the left-hand hand sign of FIG. 1;

FIG. 4 is an enlarged rear-side elevational view of the left-hand hand sign of FIG. 1;

FIG. 5 is a reduced scale top-side elevational view of the left-hand hand sign of FIG. 1;

FIG. 6 is a reduced scale bottom-side elevational view of the left-hand hand sign of FIG. 1;

FIG. 7 is a perspective view from below the front of the right-side of the left-hand hand sign of FIG. 1;

FIG. 8. is a perspective view from the rear of right side of the left-hand hand sign of FIG. 1;

FIG. 9 is a left-side elevational view of a second embodiment of a right-hand hand sign according to the invention;

FIG. 10 is a right side elevational view of the right-hand hand sign of FIG. 9;

FIG. 11 is an enlarged front-side elevational view of the right-hand hand sign of FIG. 9;

FIG. 12 is an enlarged rear-side elevational view of the right-hand hand sign of FIG. 9;

FIG. 13 is a reduced scale top-side elevational view of the right-hand hand sign of FIG. 9;

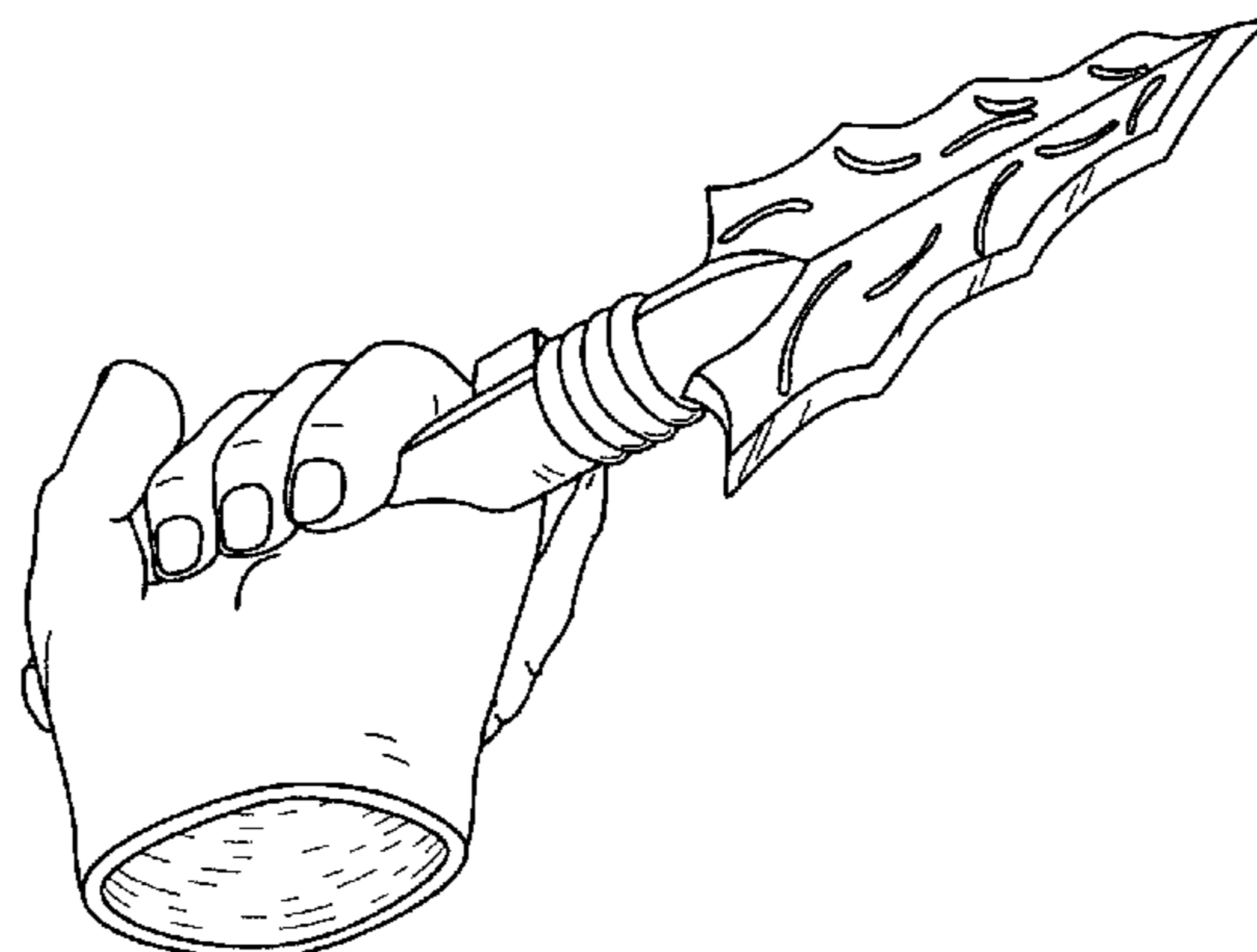
FIG. 14 is a reduced scale bottom-side elevational view of the right-hand hand sign of FIG. 9;

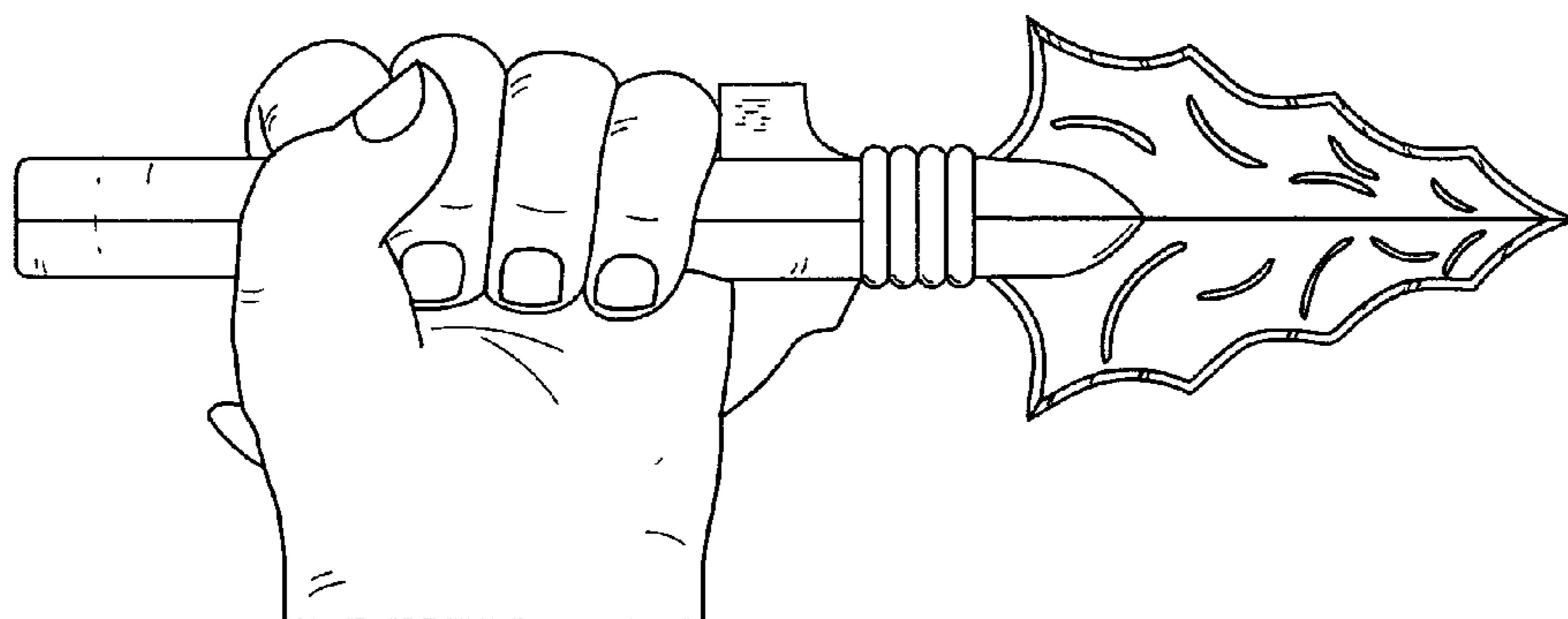

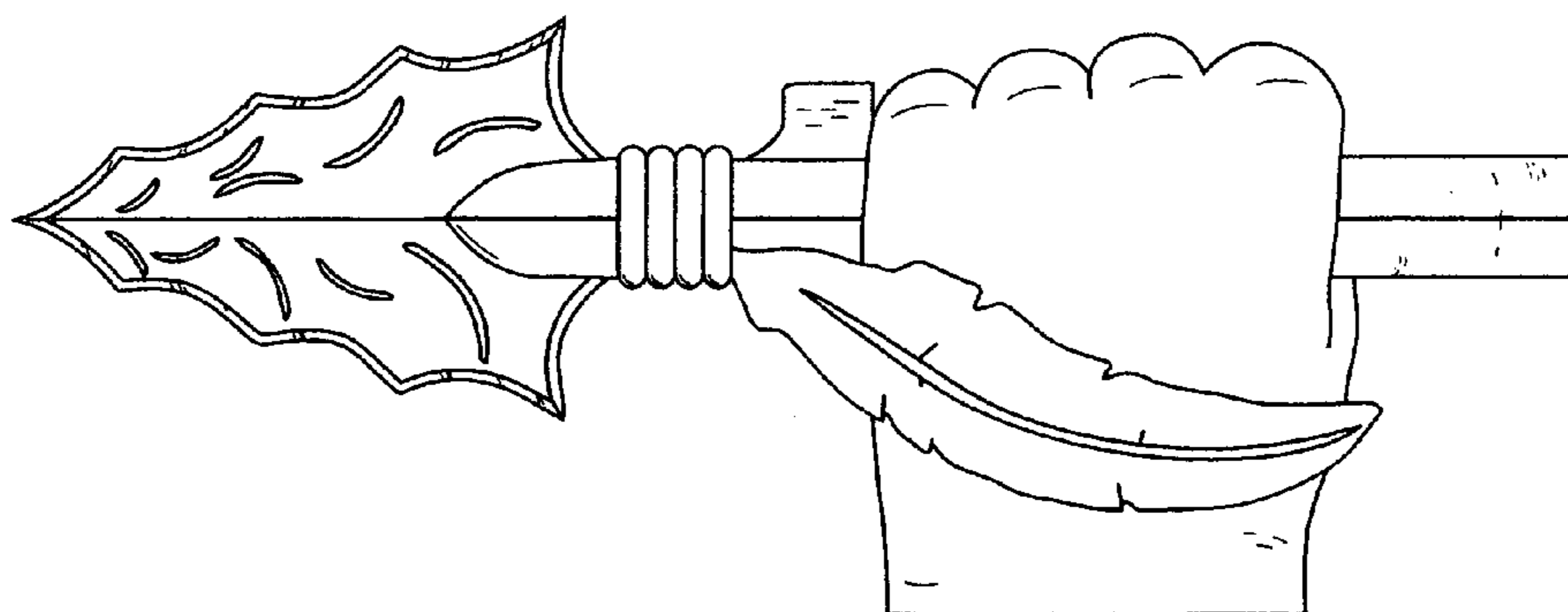

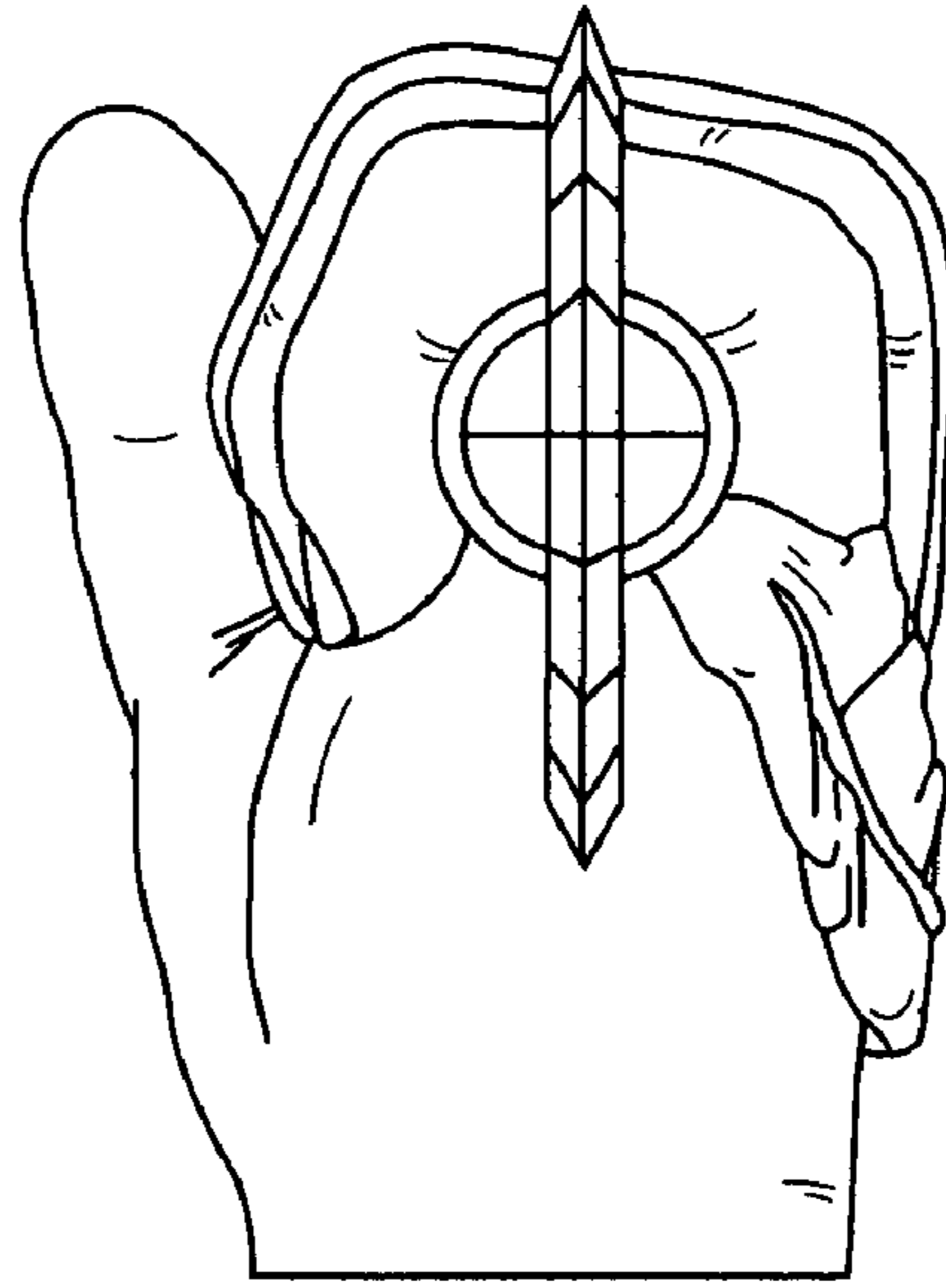

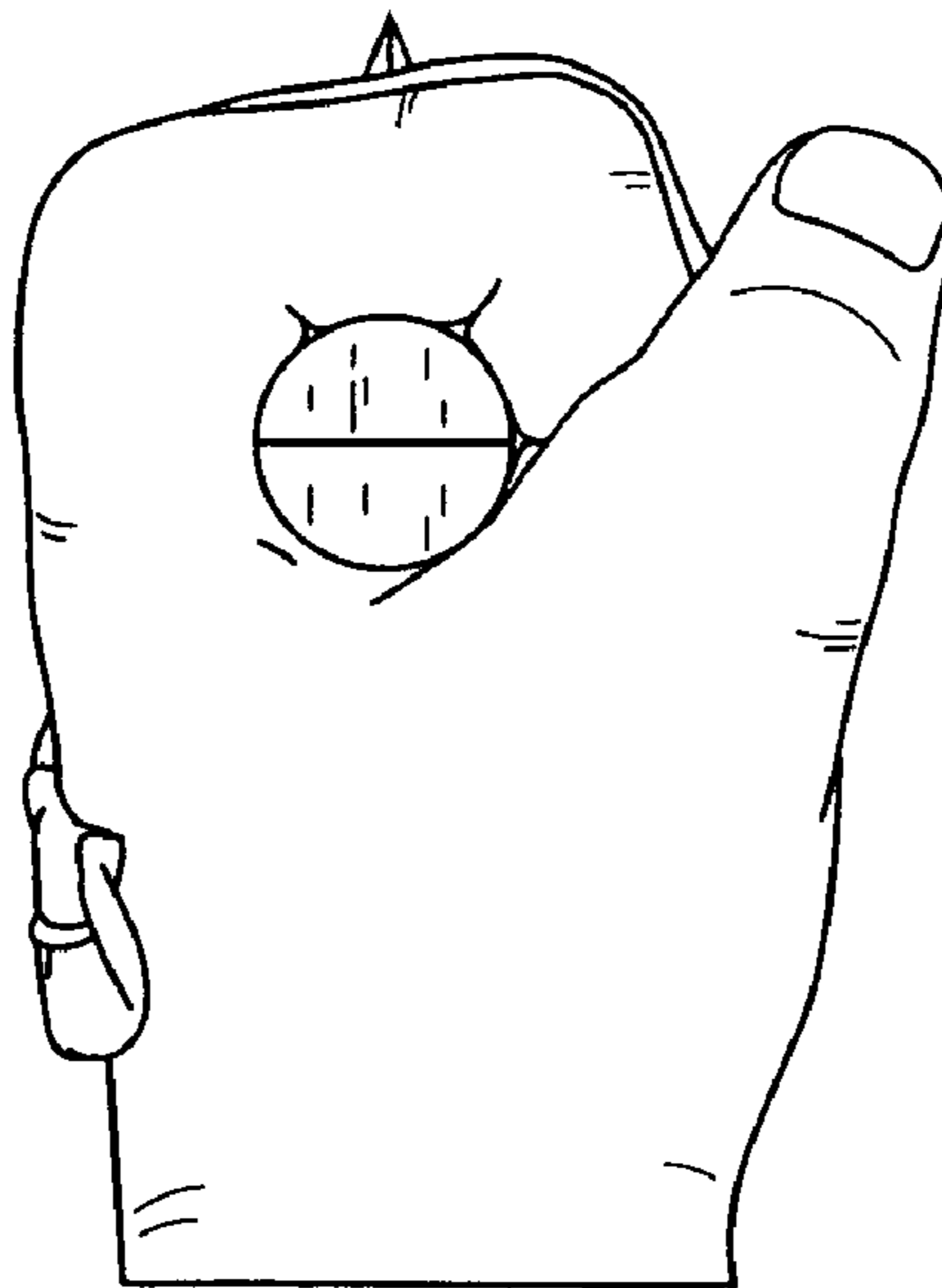

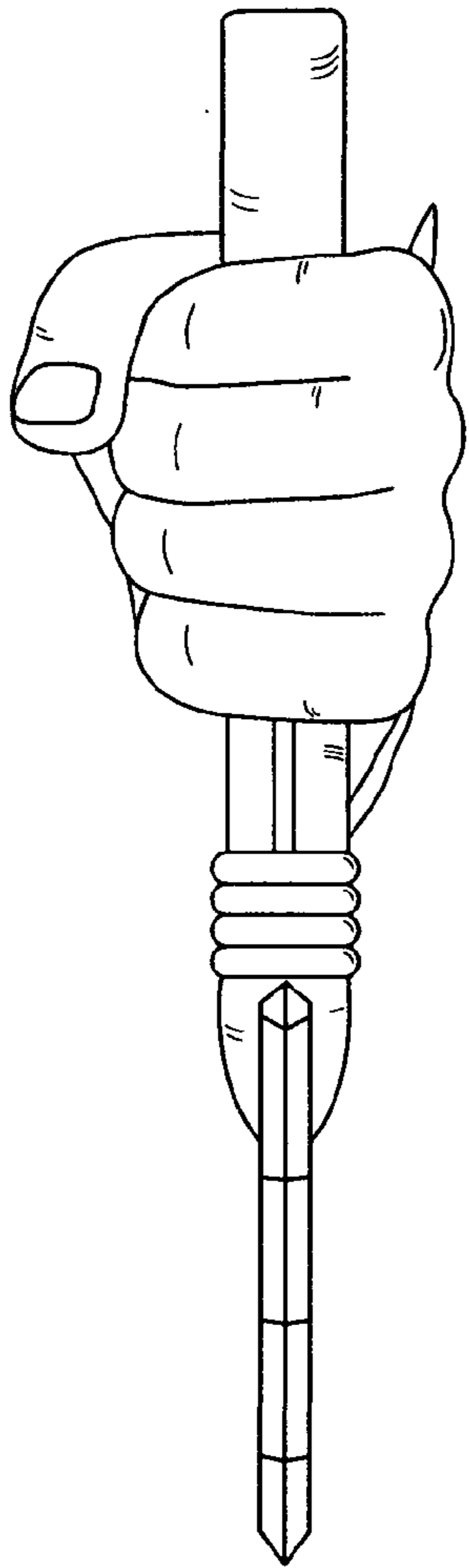

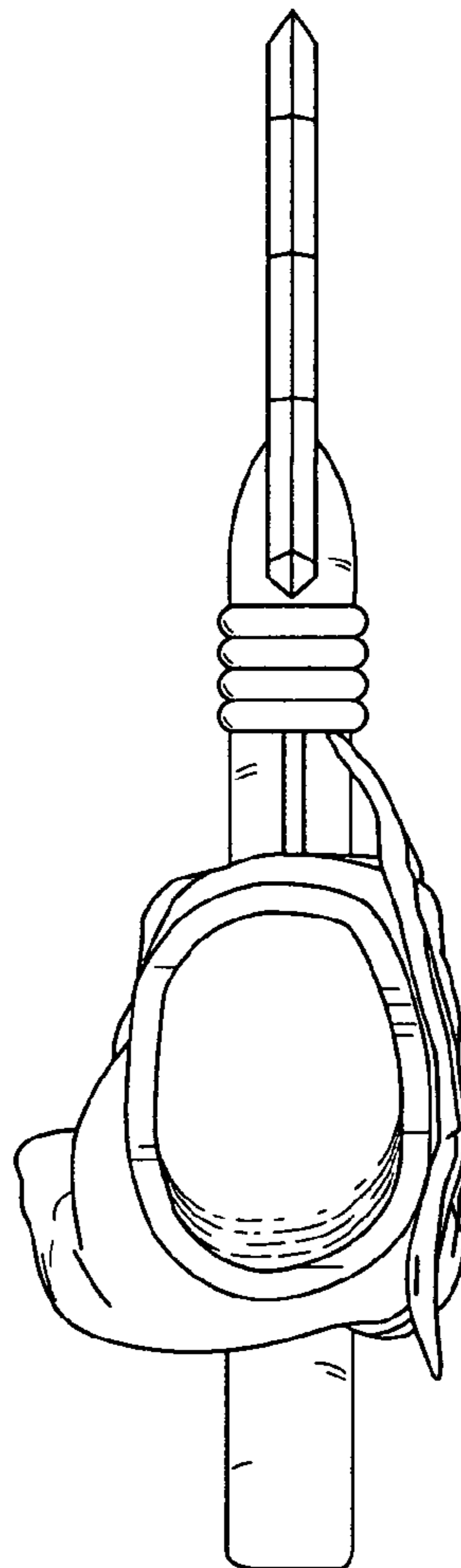

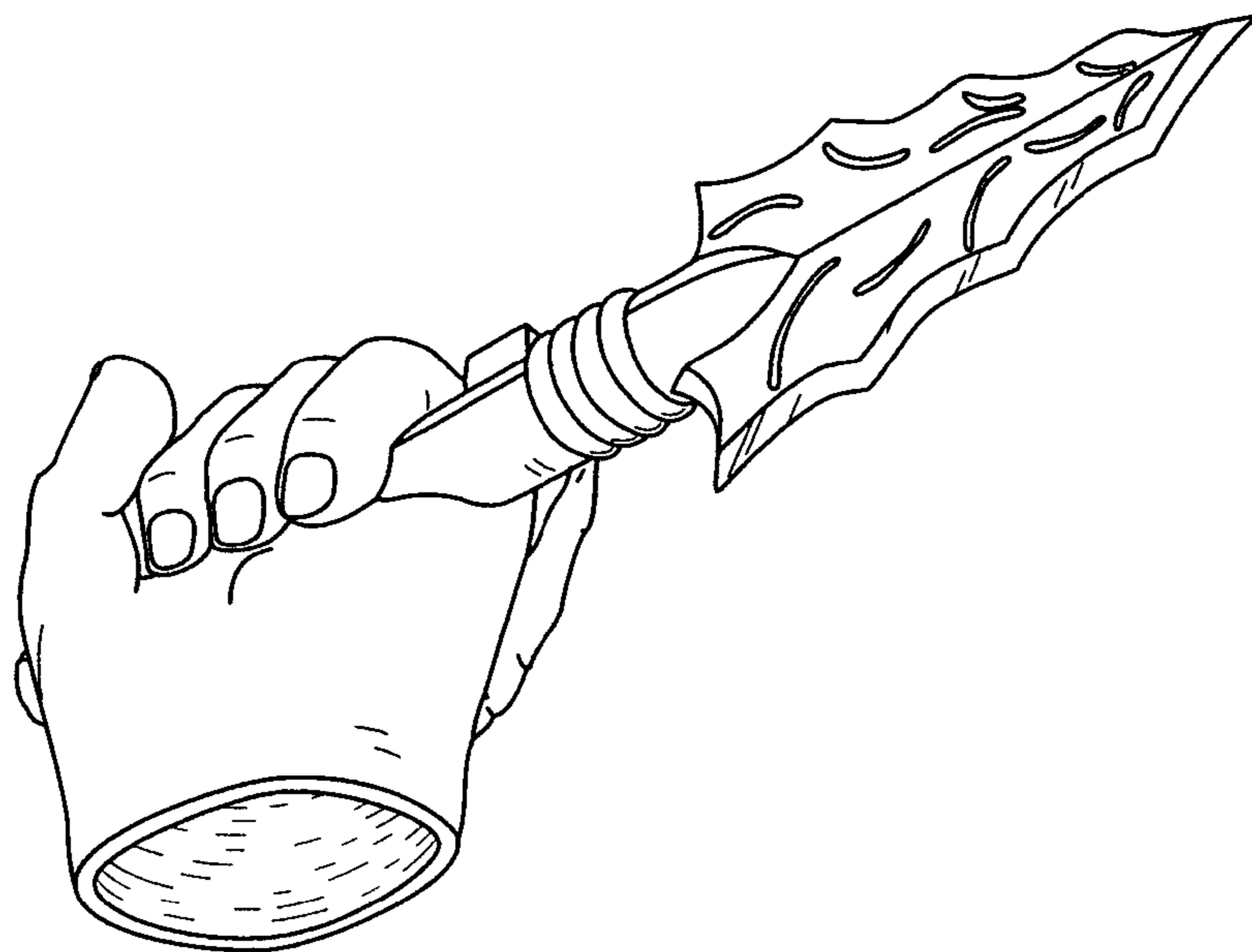

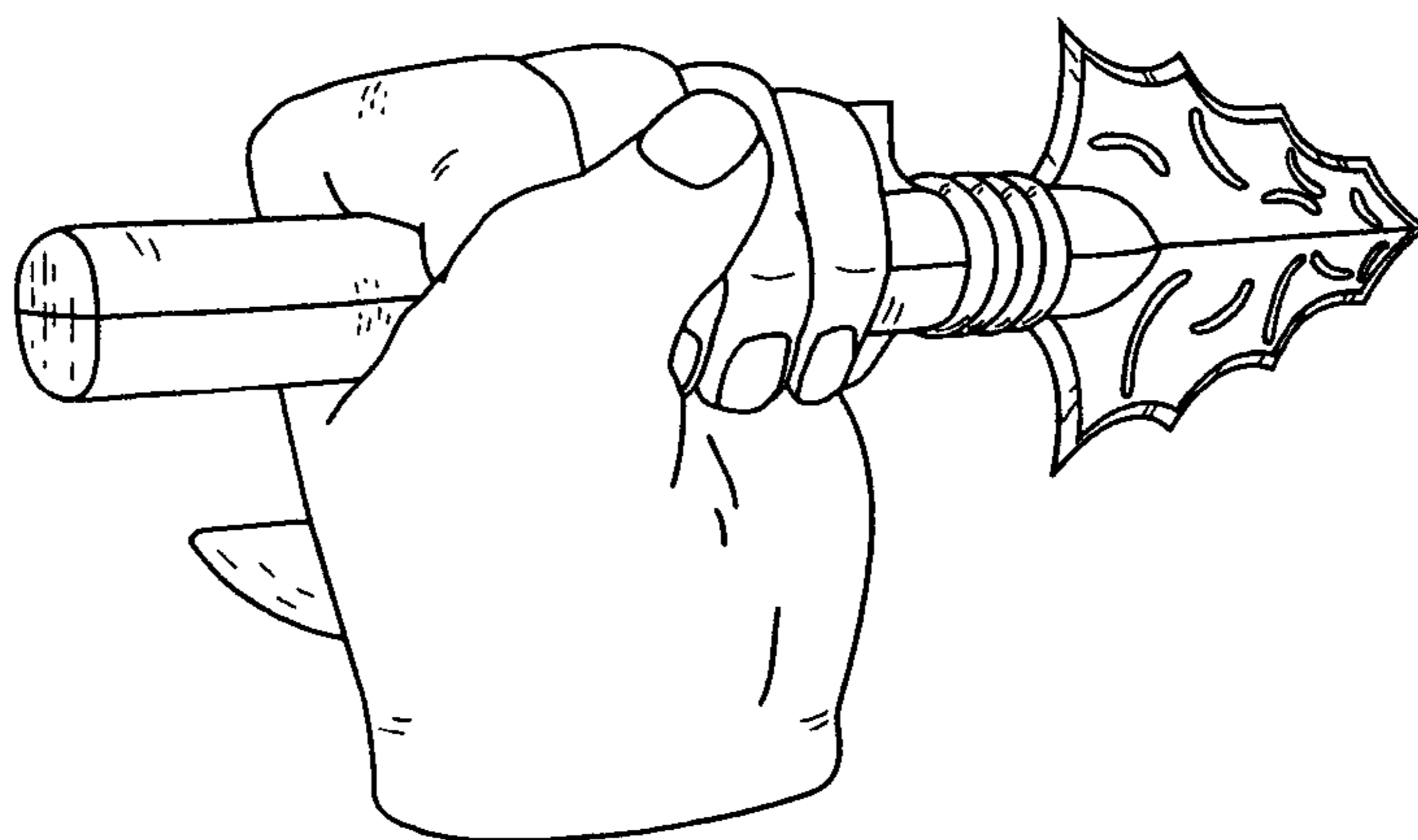

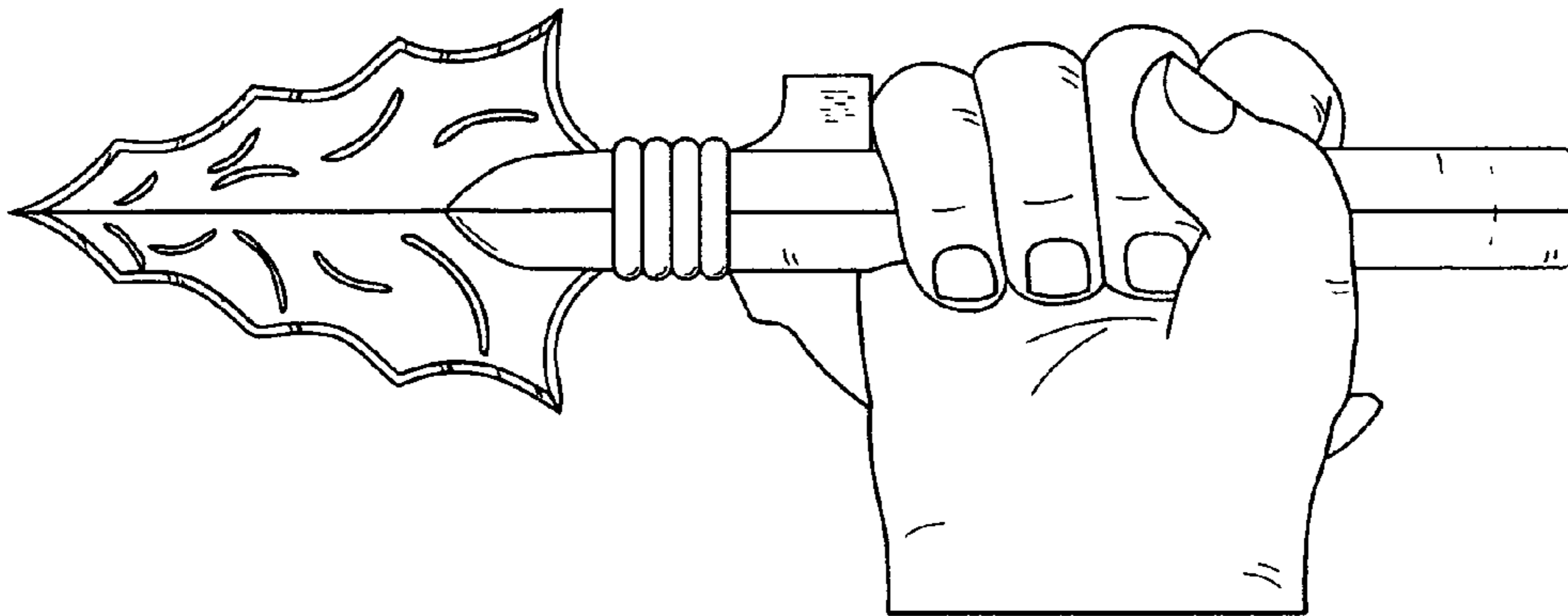

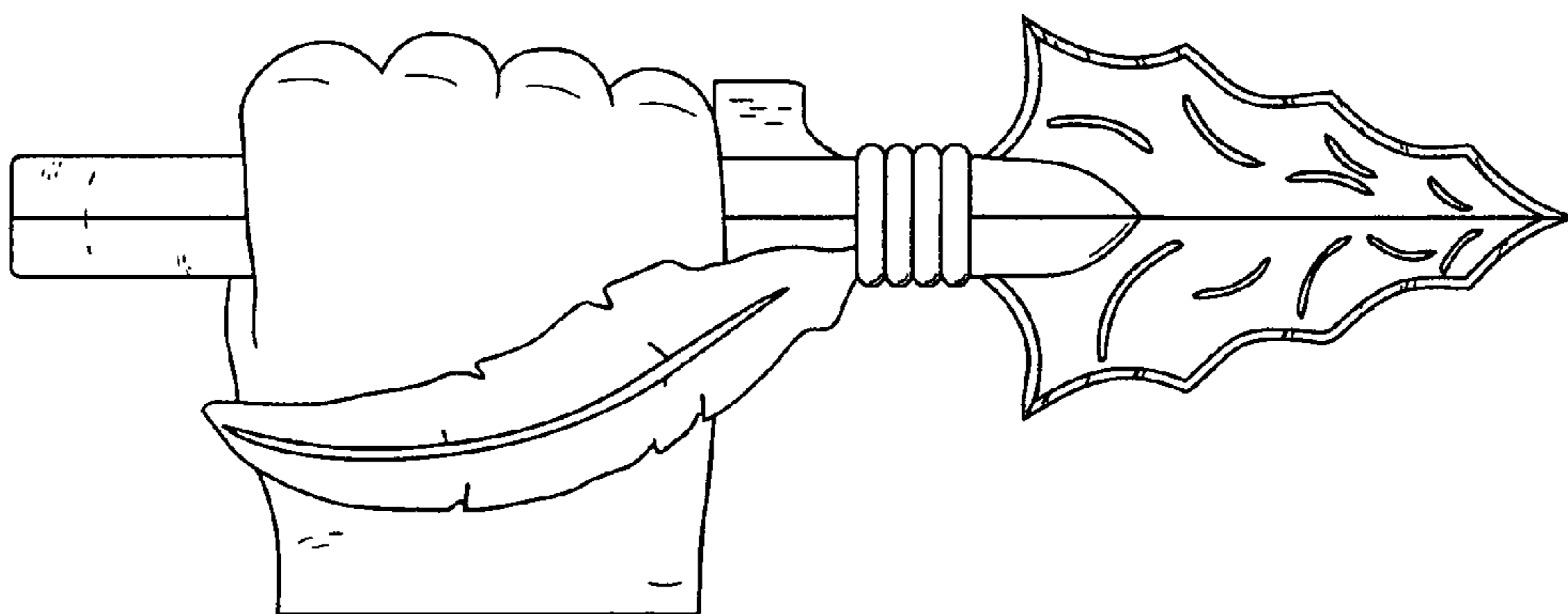

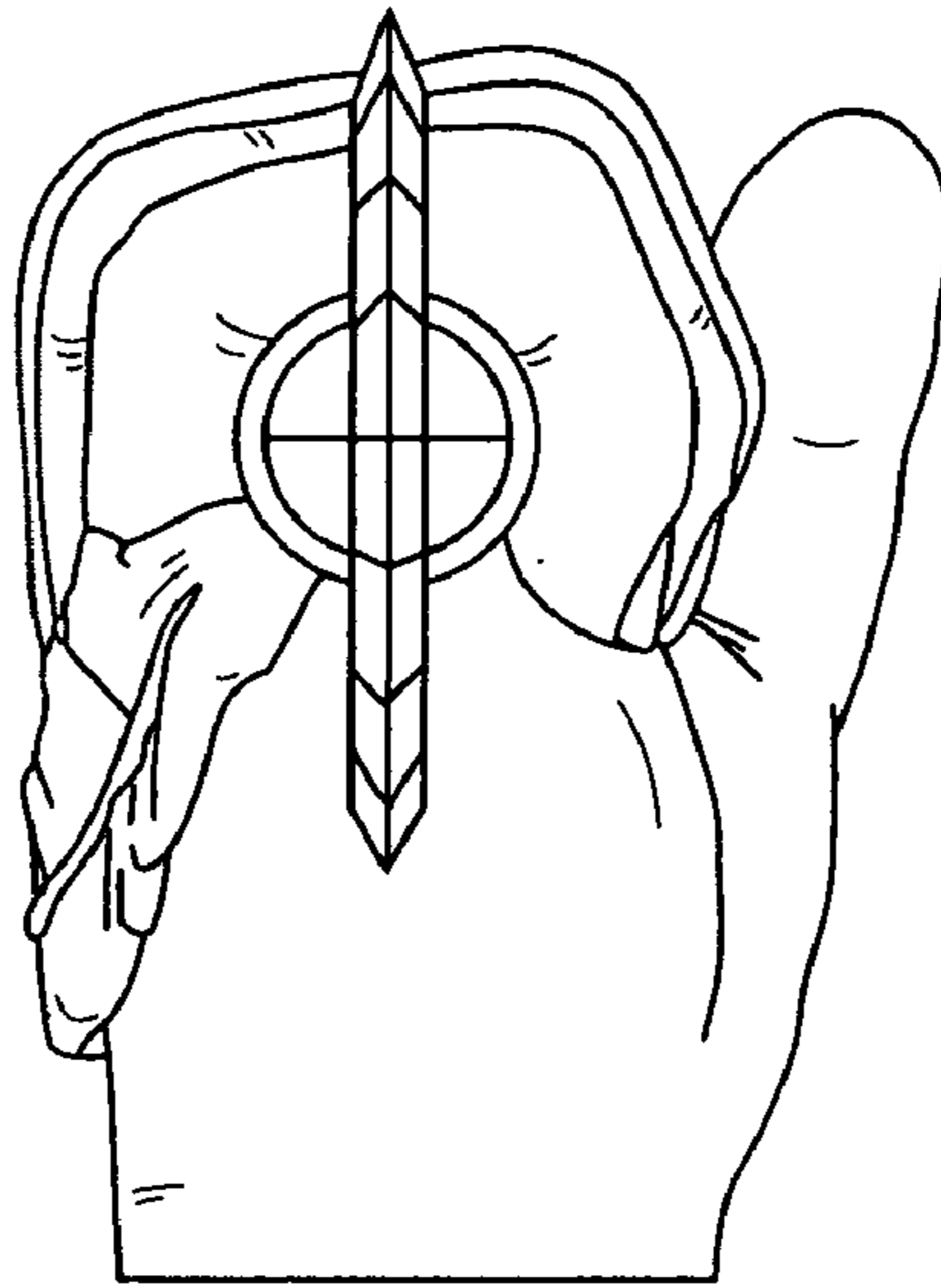

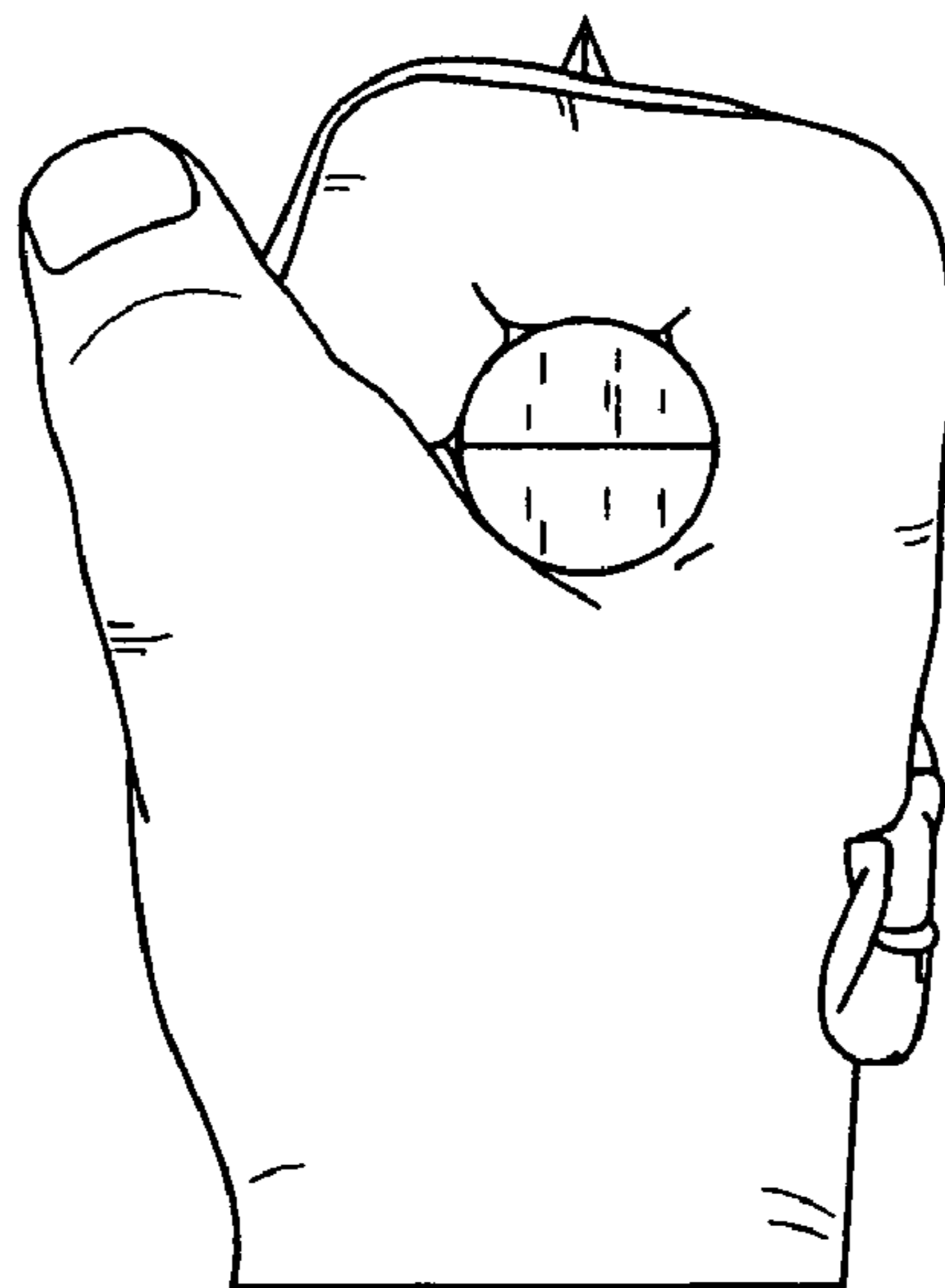

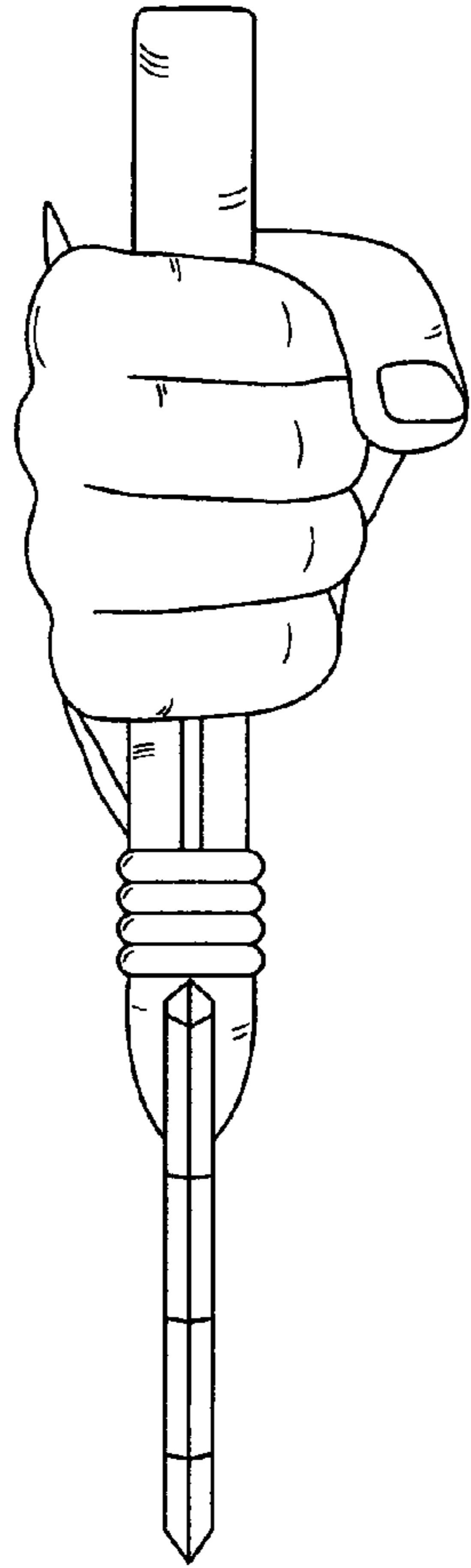

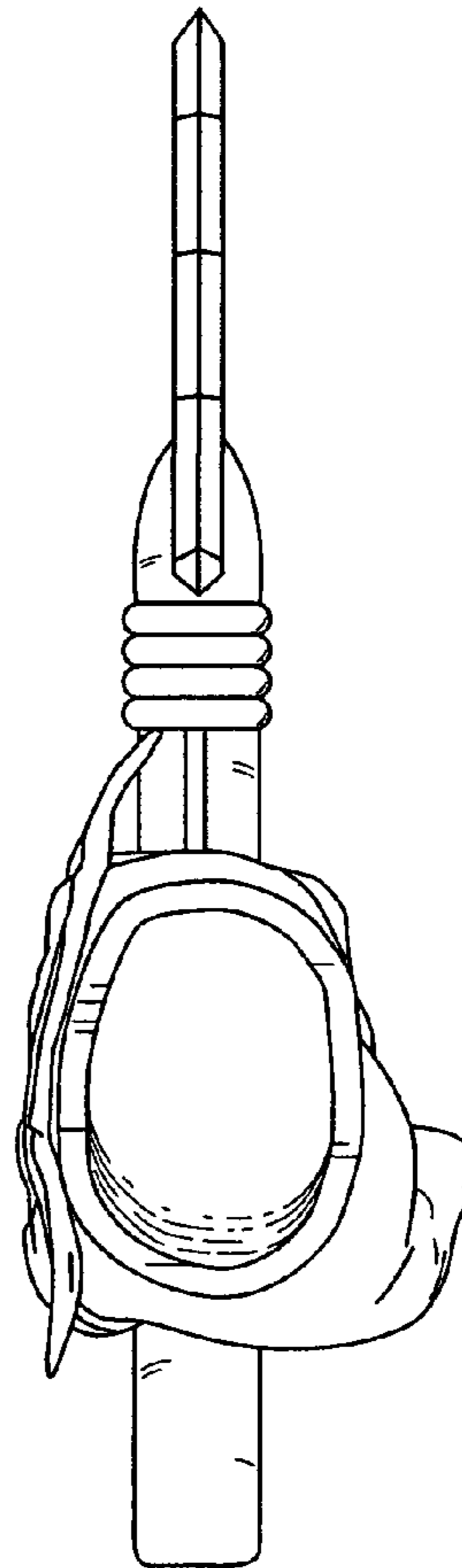

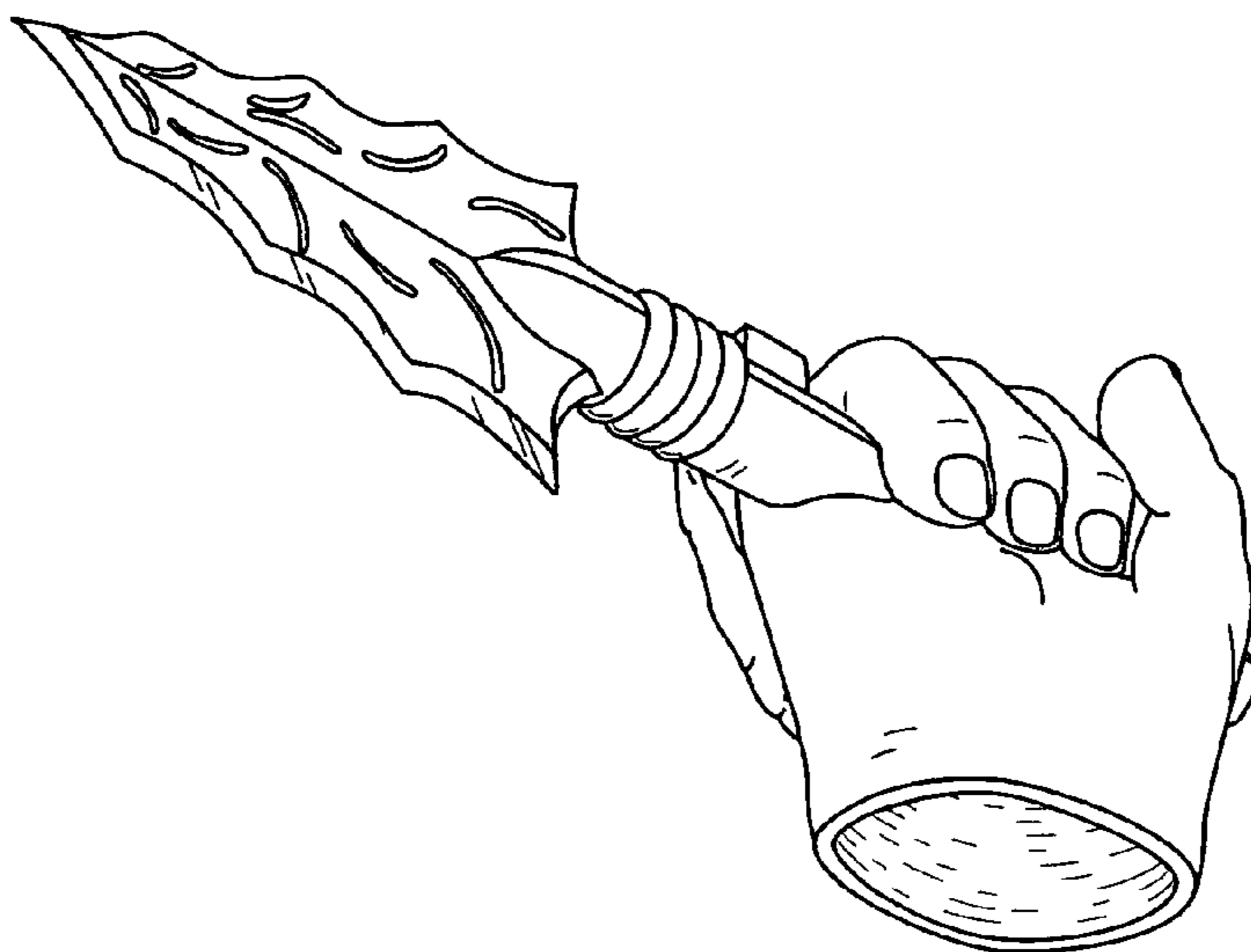

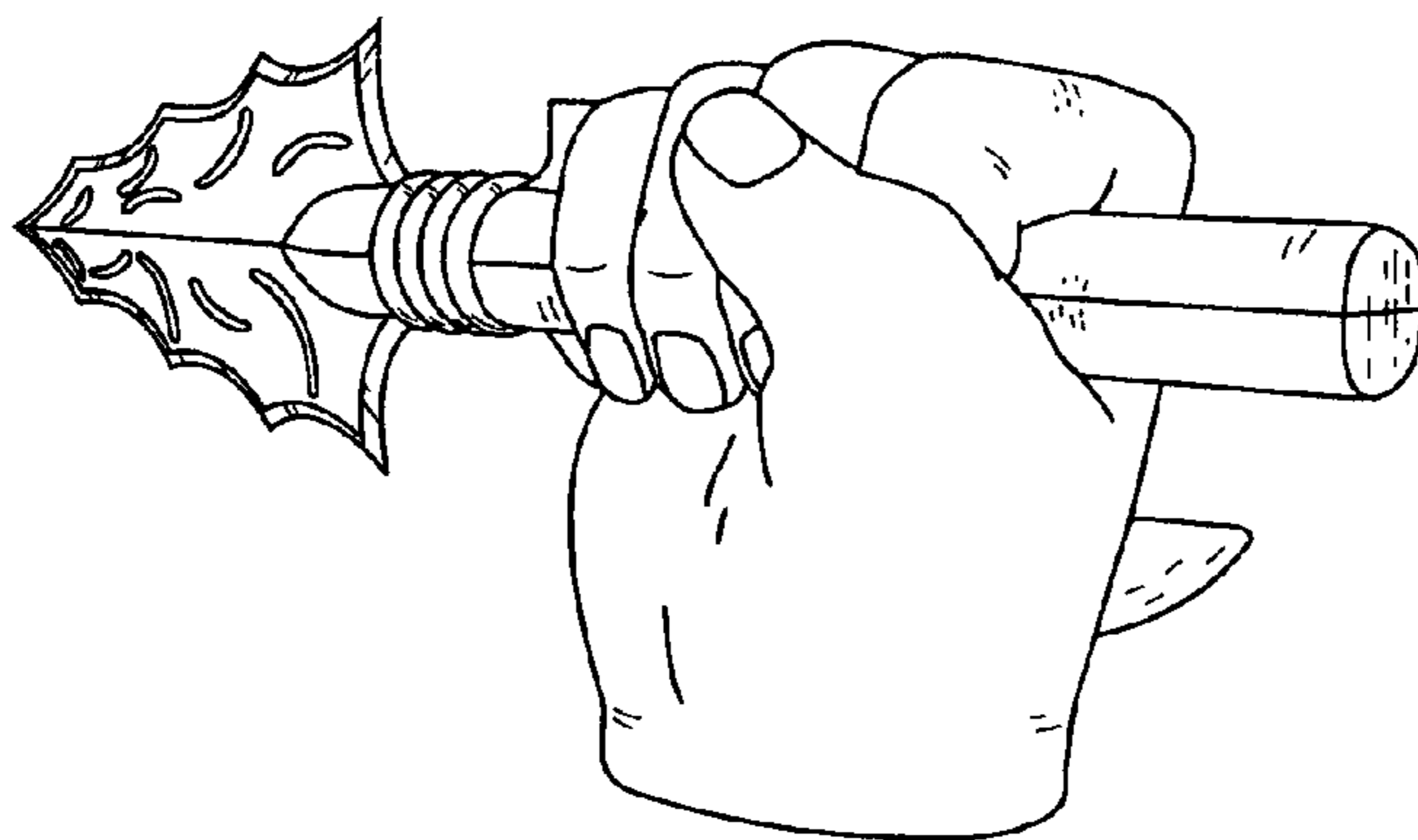
