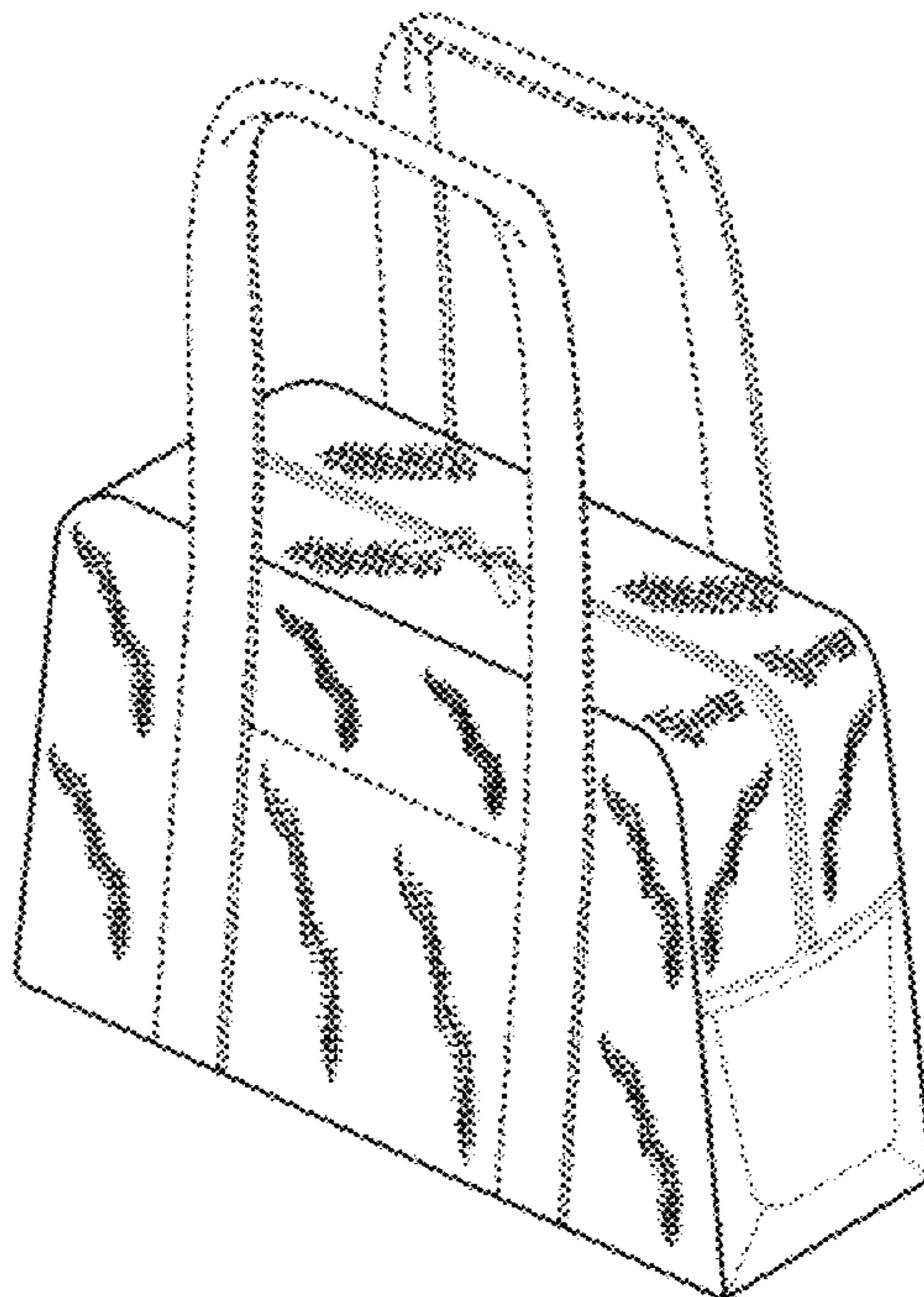
(57) **CLAIM**

The ornamental design for a bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the bag; FIG. 2 is a front view of the bag illustrated in FIG. 1; FIG. 3 is a back view of the bag illustrated in FIG. 1; FIG. 4 is a left side view of the bag illustrated in FIG. 1; FIG. 5 is a right side view of the bag illustrated in FIG. 1; FIG. 6 is a top view of the bag illustrated in FIG. 1; and, FIG. 7 is a bottom view of the bag illustrated in FIG. 1. The broken lines representing stitching are for the purposes of illustrating environment and form no part of the claimed design.

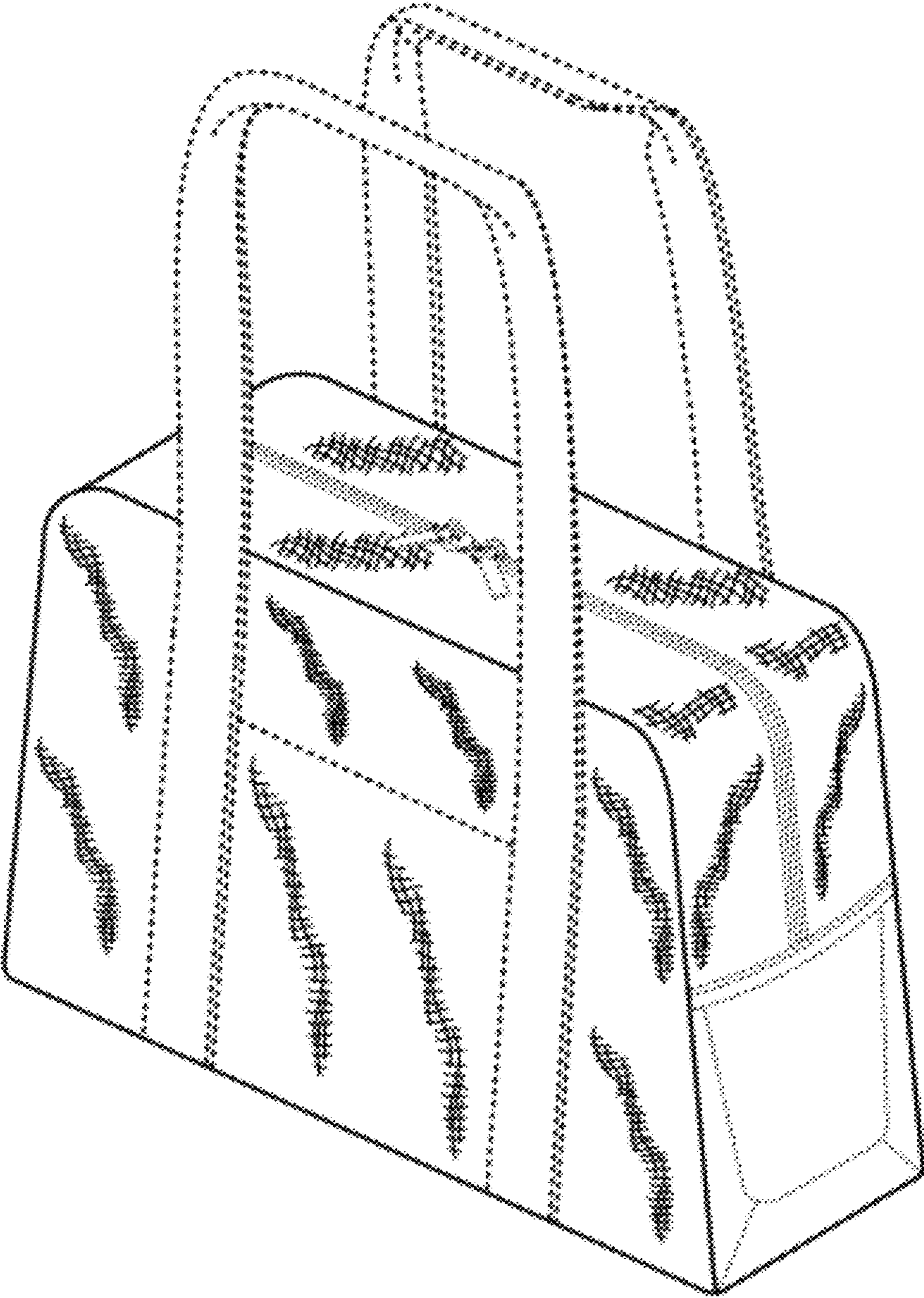

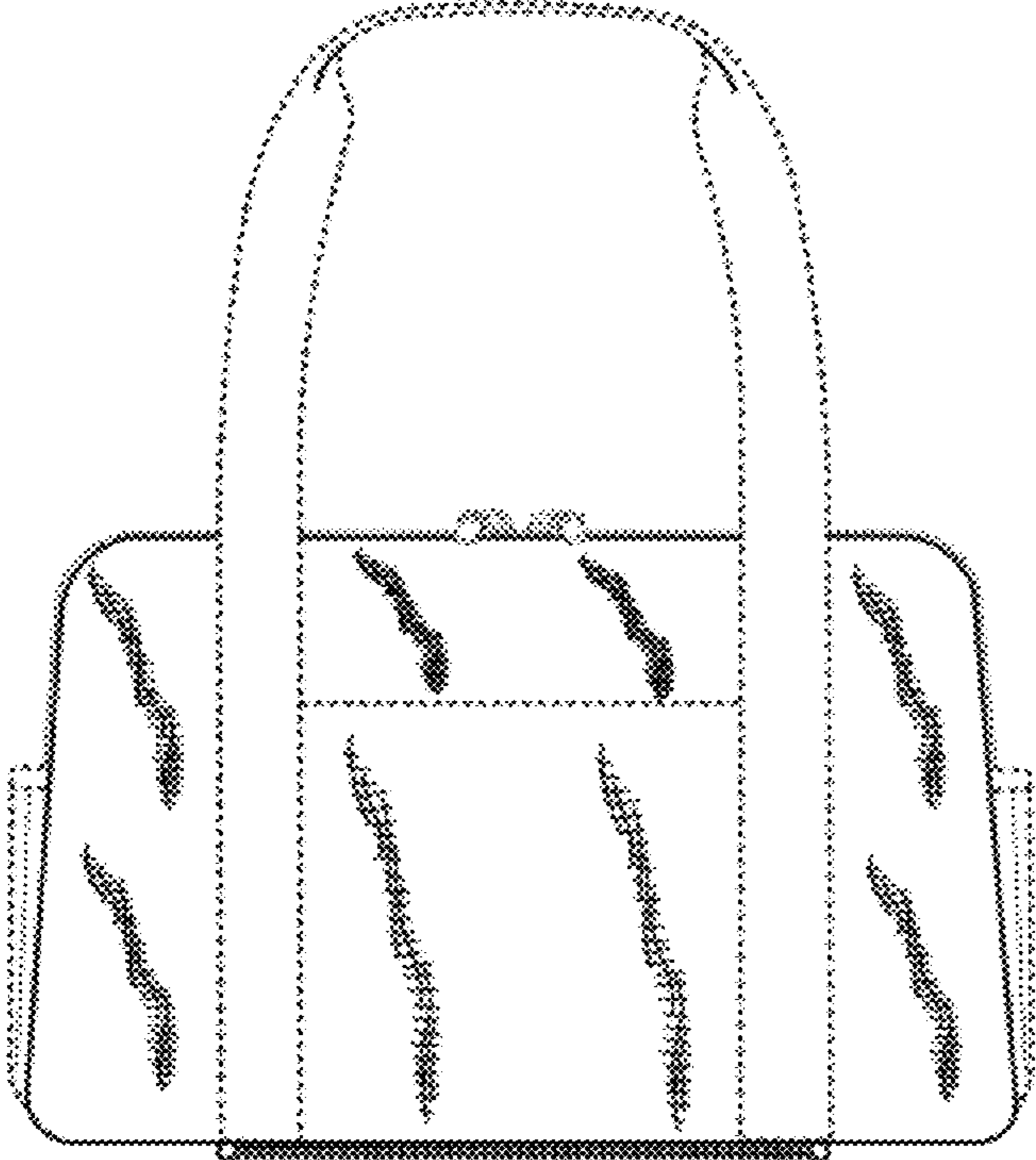
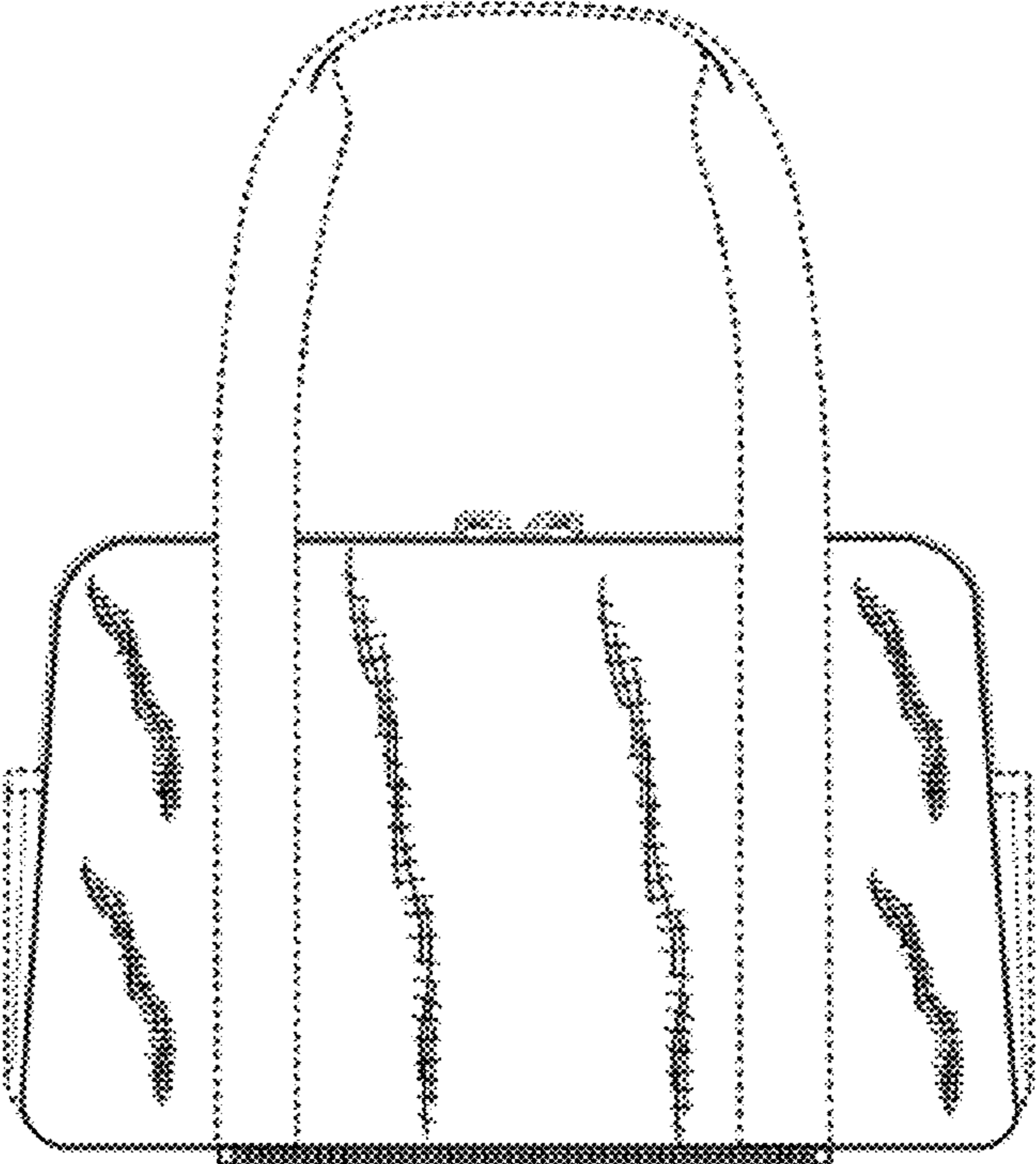

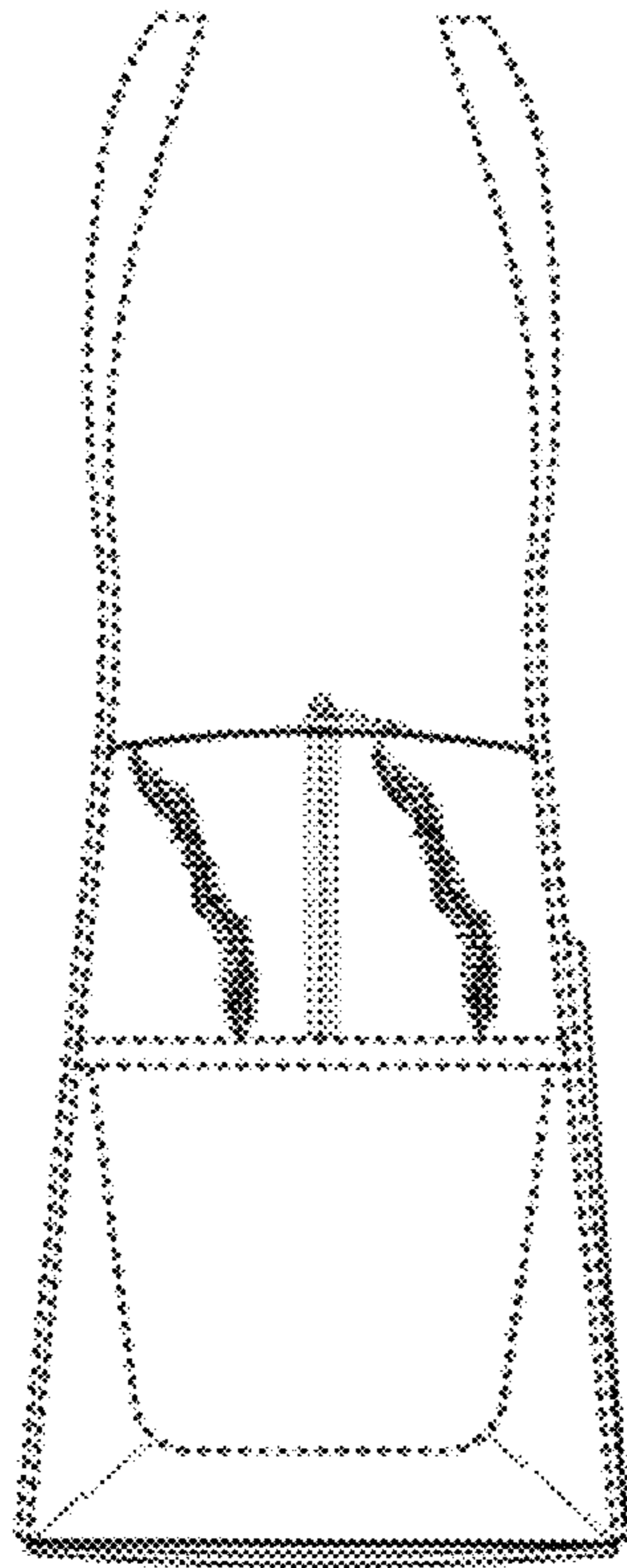
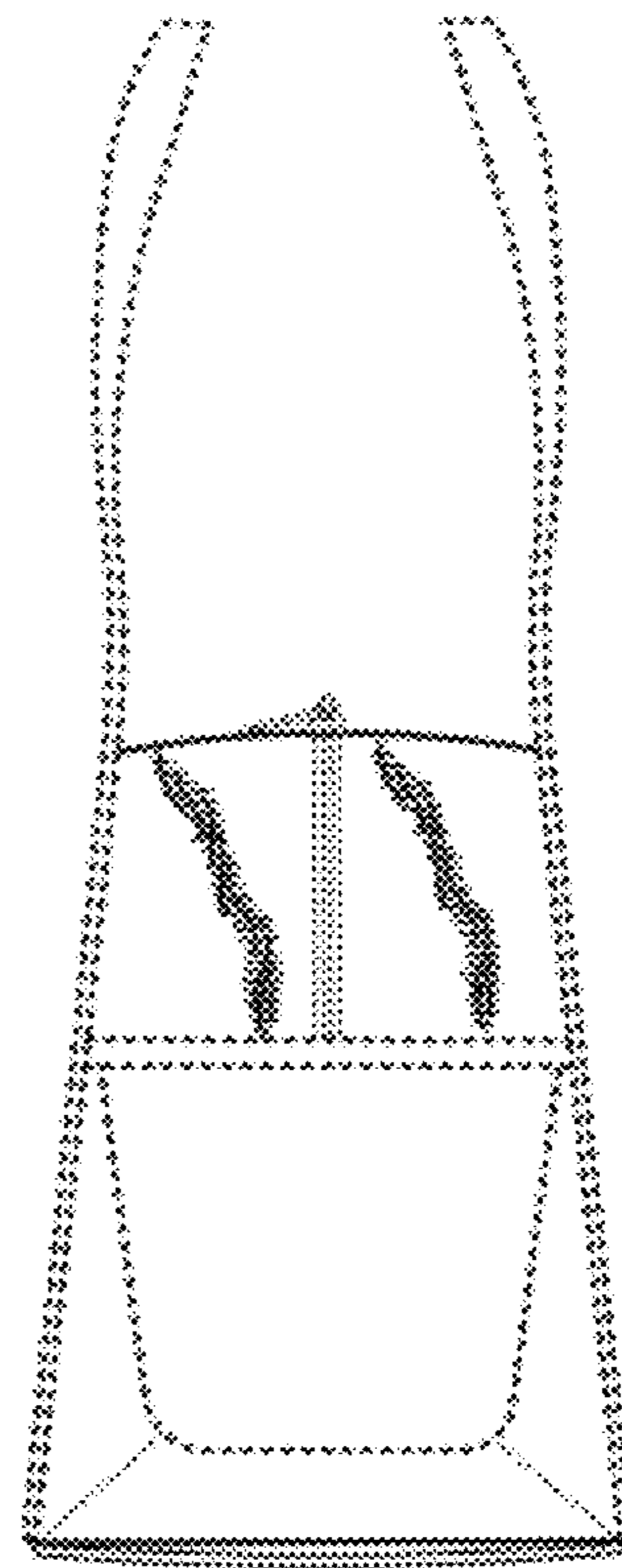

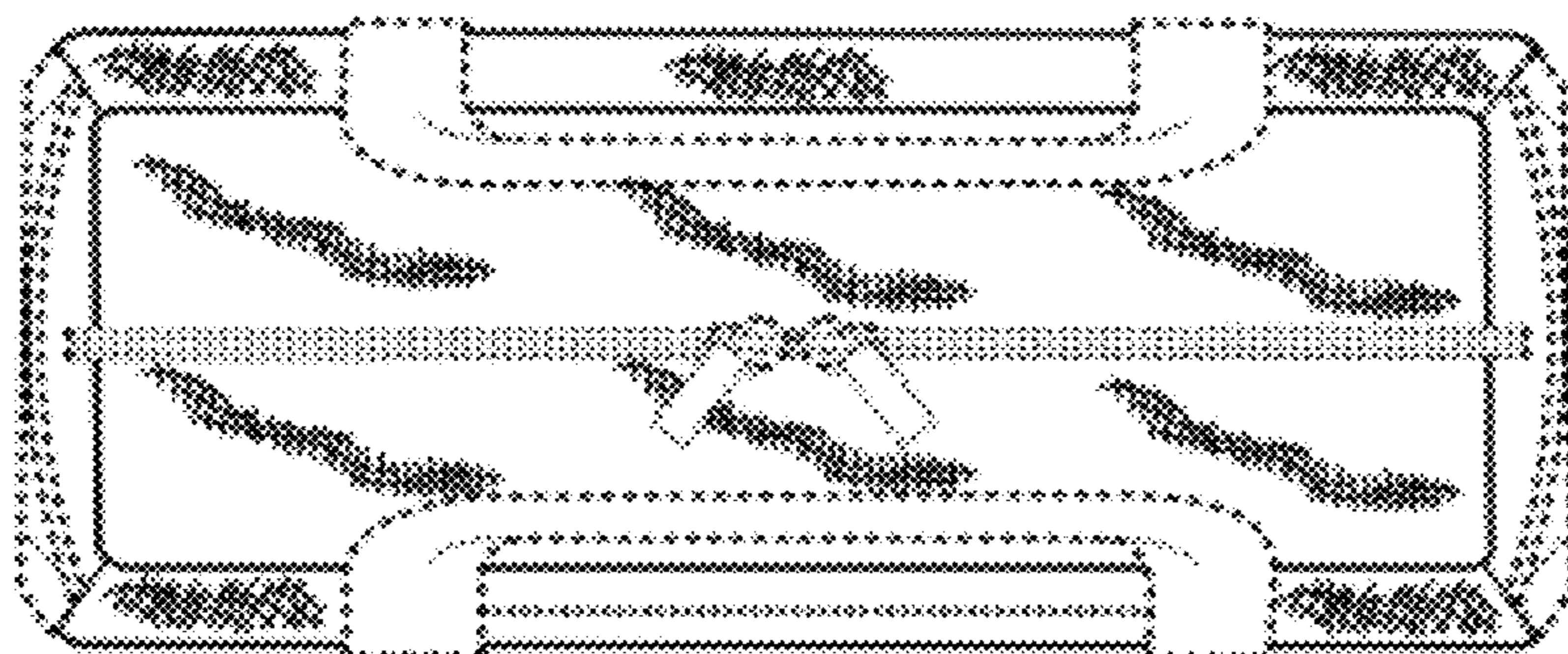

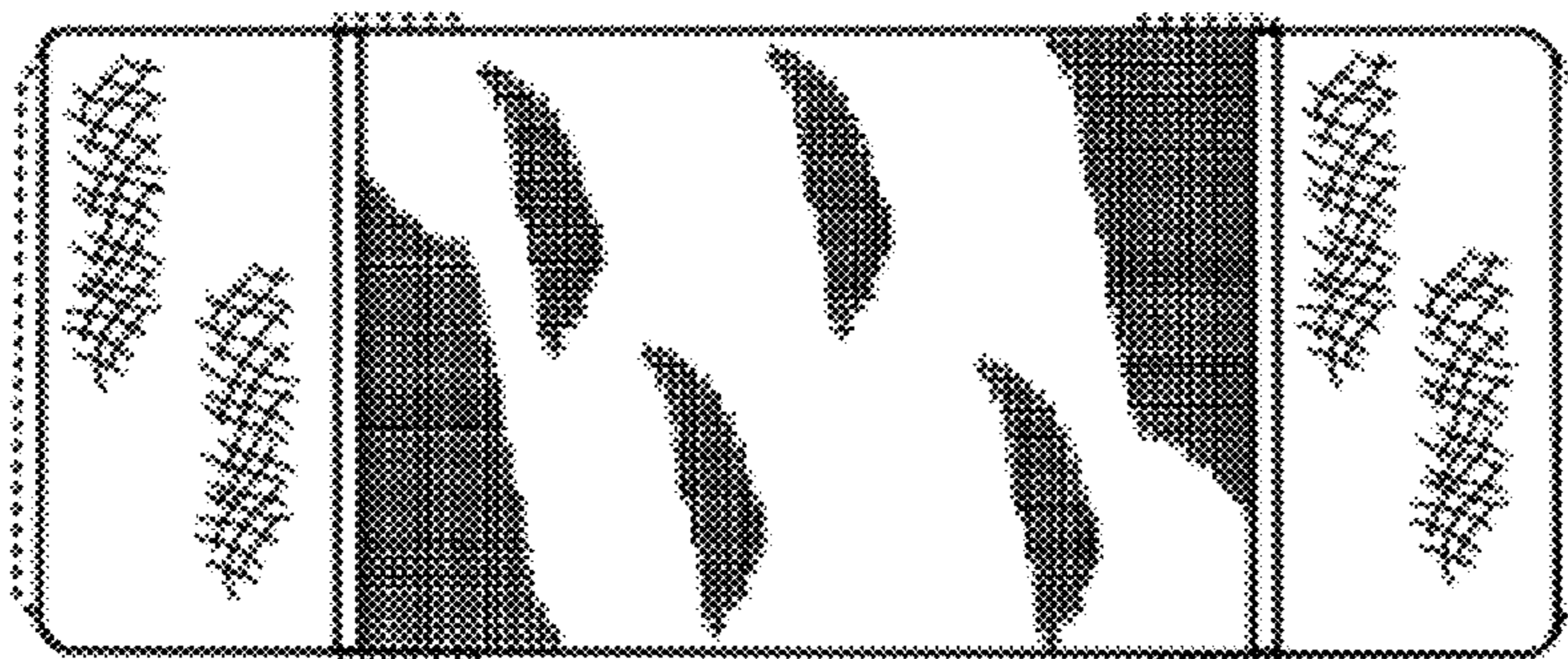
