The ornamental design for a film sheet for use in antiballistic articles, as shown and described.

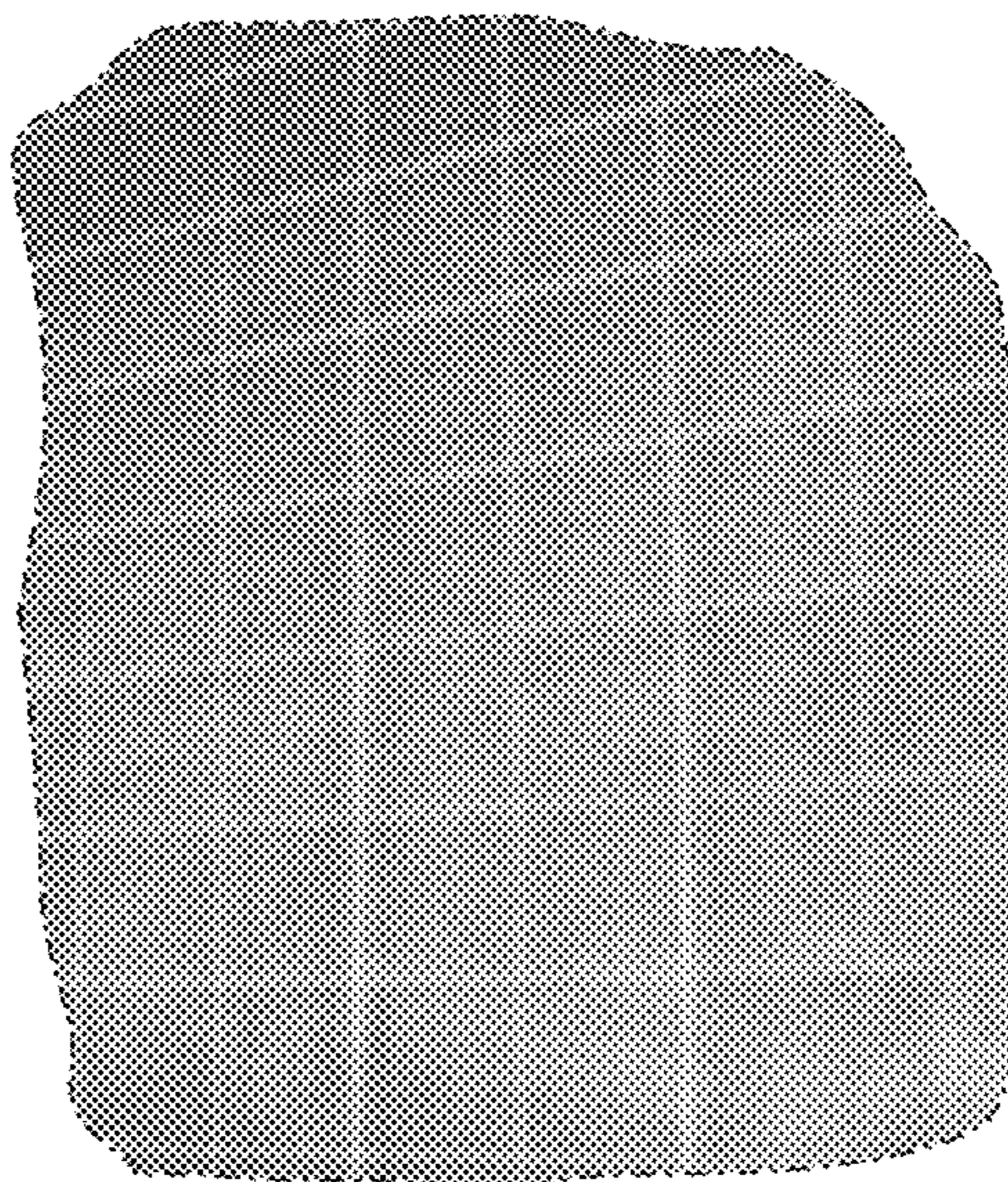
**DESCRIPTION**
