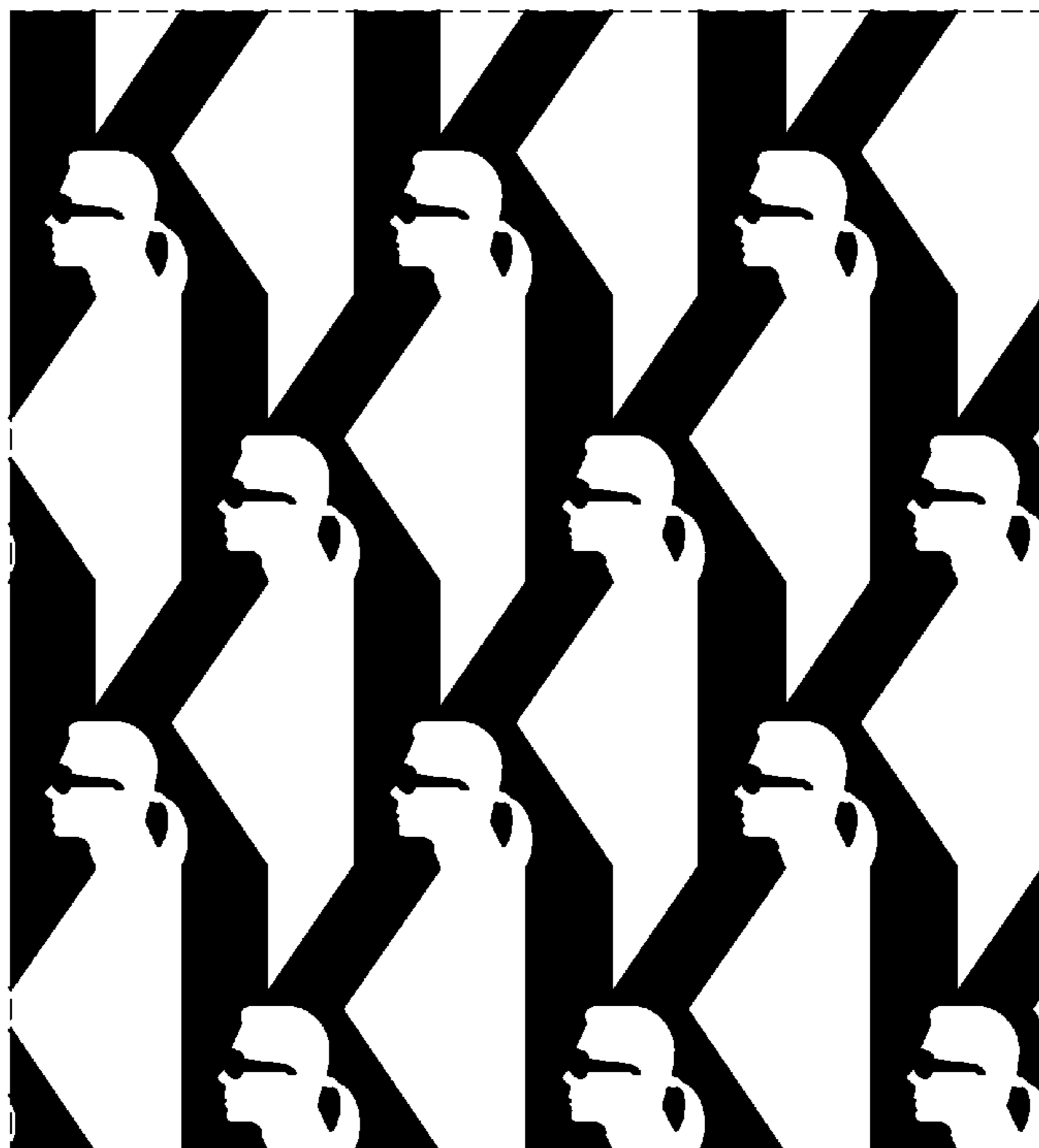
(57) **CLAIM**

The ornamental design for a textile fabric, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of a textile fabric showing our new design in an environment of use; and, FIG. 2 is a plan view of the textile fabric. The broken line perimeter surrounding the design indicates the boundaries of the claim and forms no part thereof. The broken lines in FIG. 1 represent environmental subject matter and form no part of the claimed design.

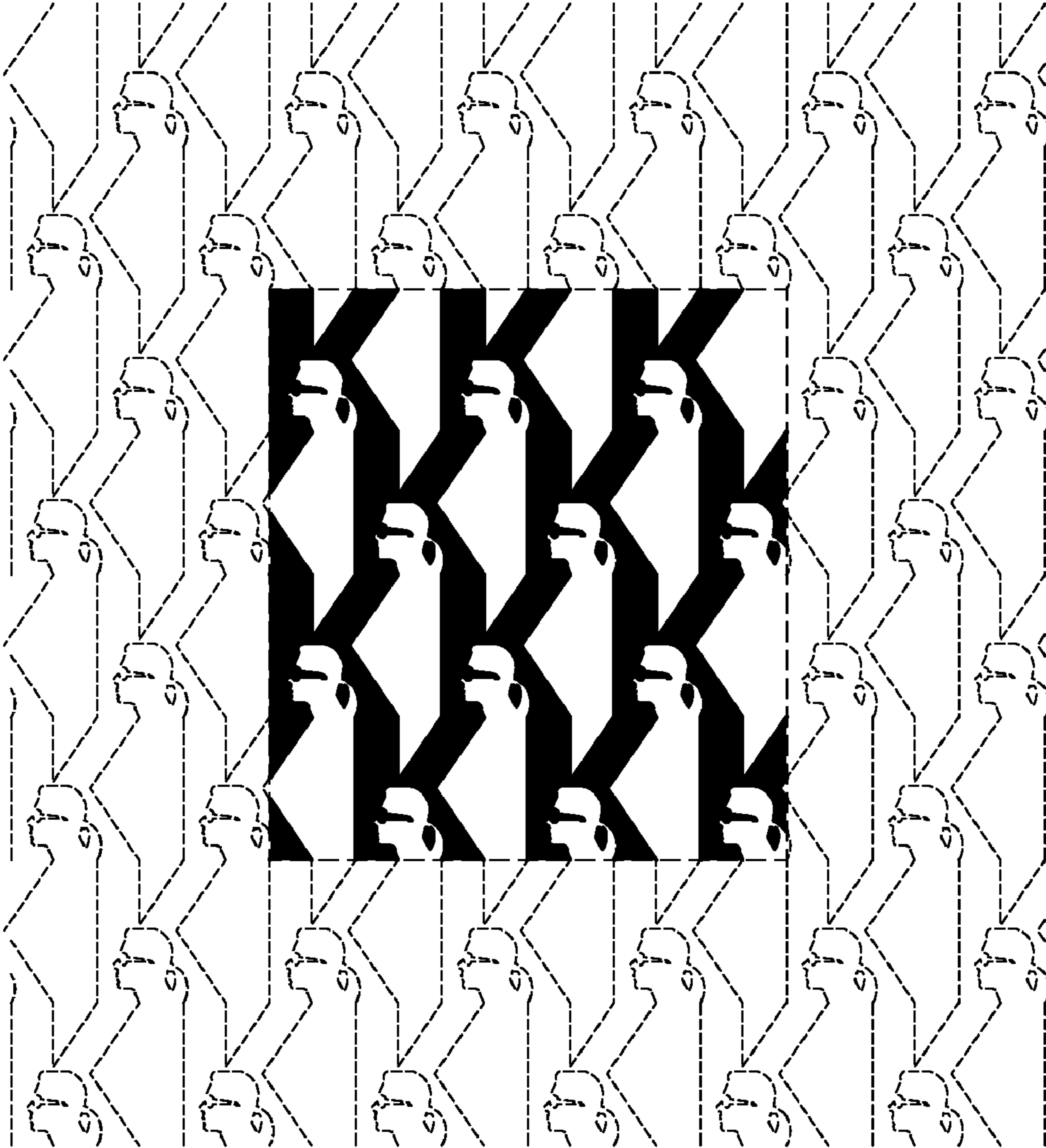

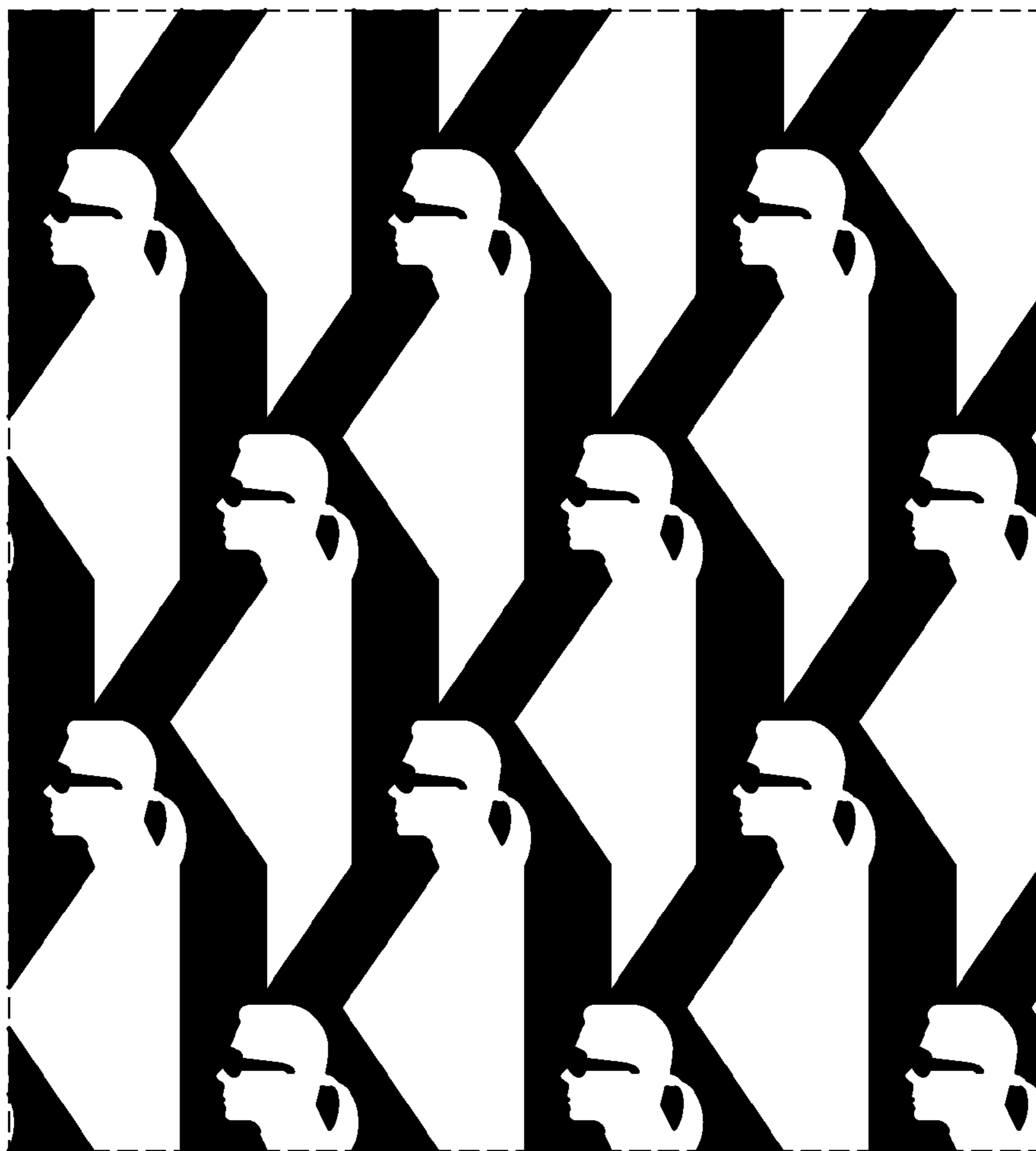
