**DESCRIPTION**

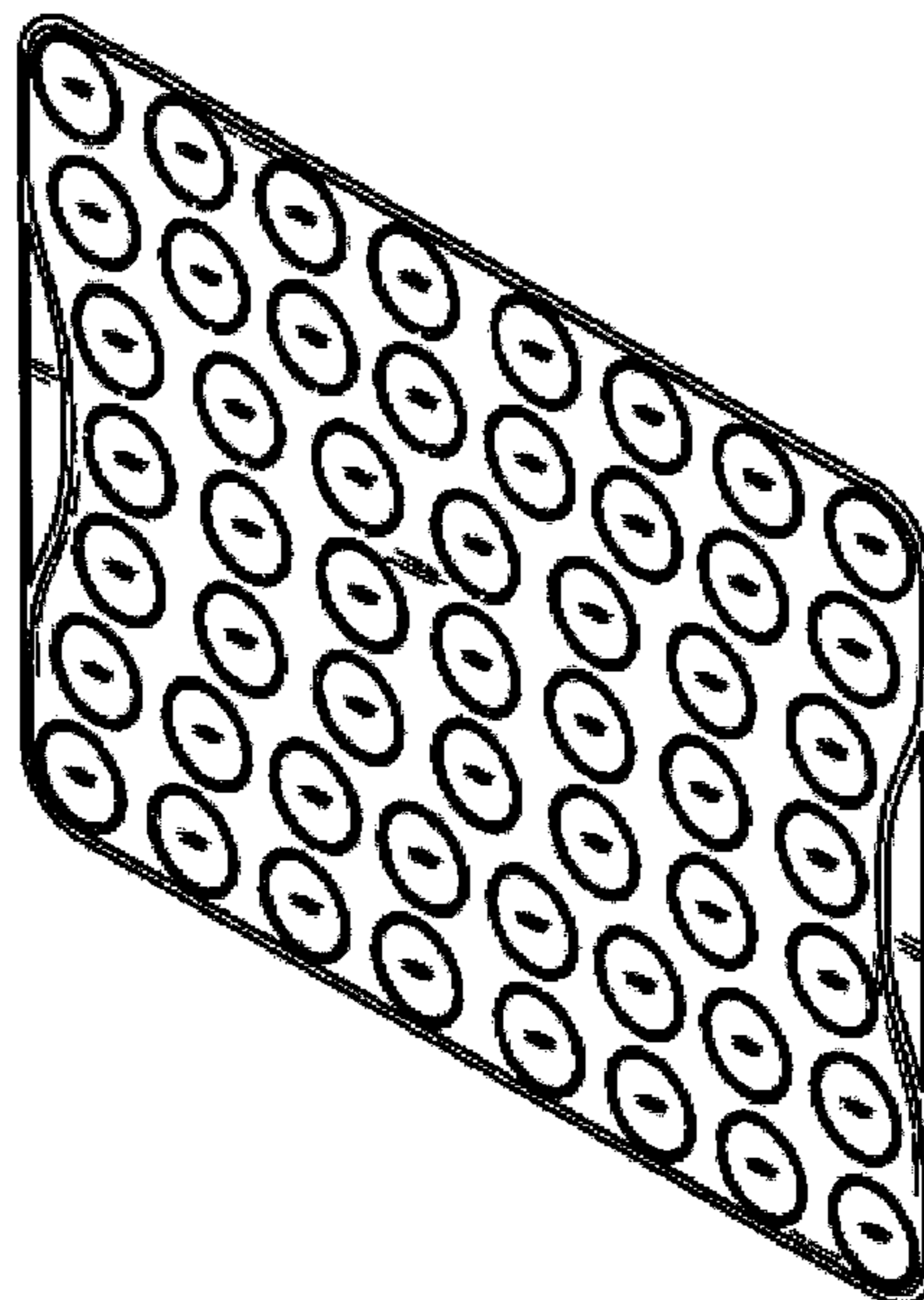
FIG. 1 is a perspective view of the macaroon baking sheet; FIG. 2 is a front elevation view of the macaroon baking sheet; FIG. 3 is a cross-sectional view of the macaroon baking sheet along 3-3 of FIG. 2; FIG. 4 is an enlarged cross sectional view of a segment of the macaroon baking sheet taken from line 4 of FIG. 3 to the end on the right side of the macaroon baking sheet; and, FIG. 5 is a rear elevation view of the macaroon baking sheet.

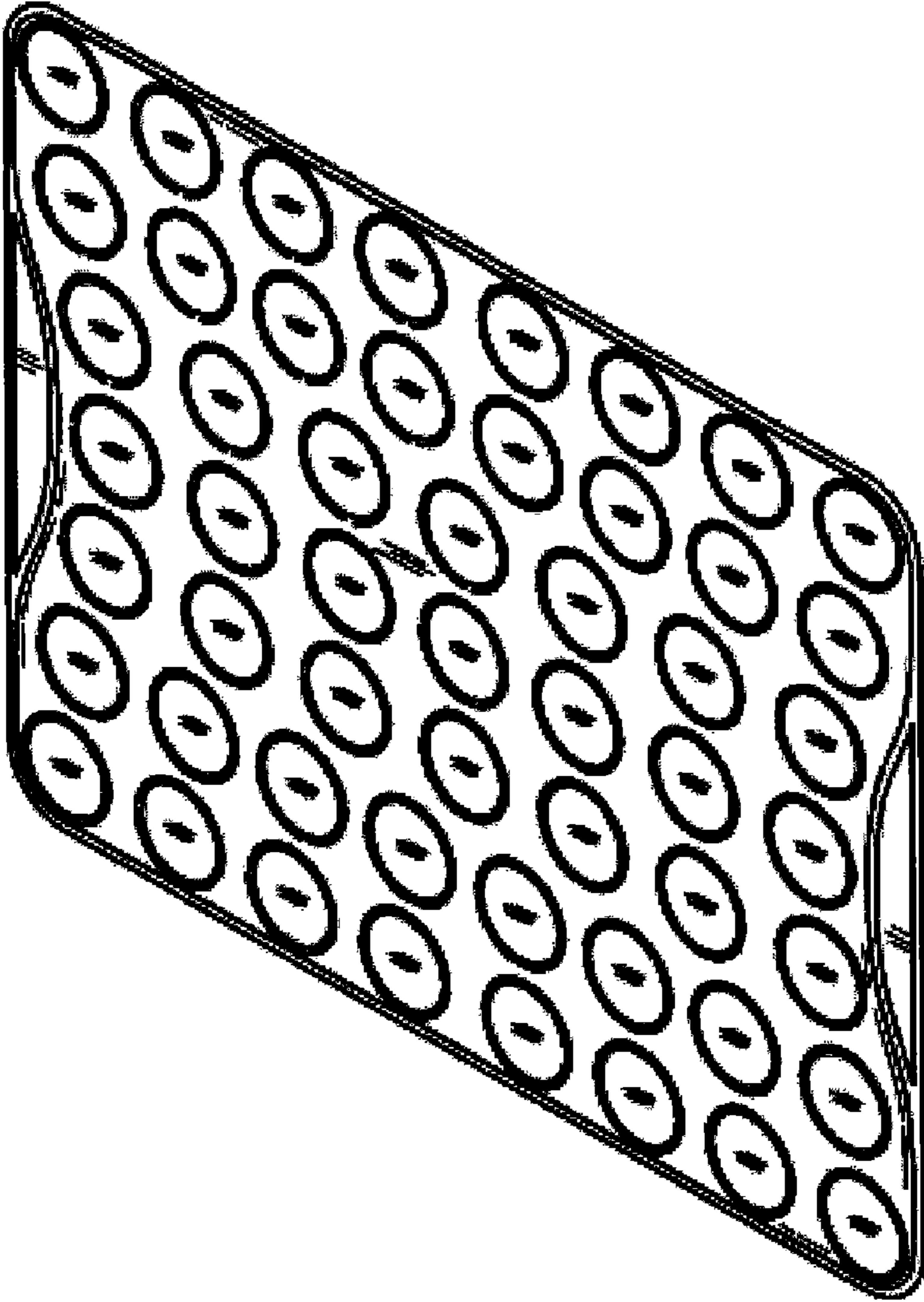

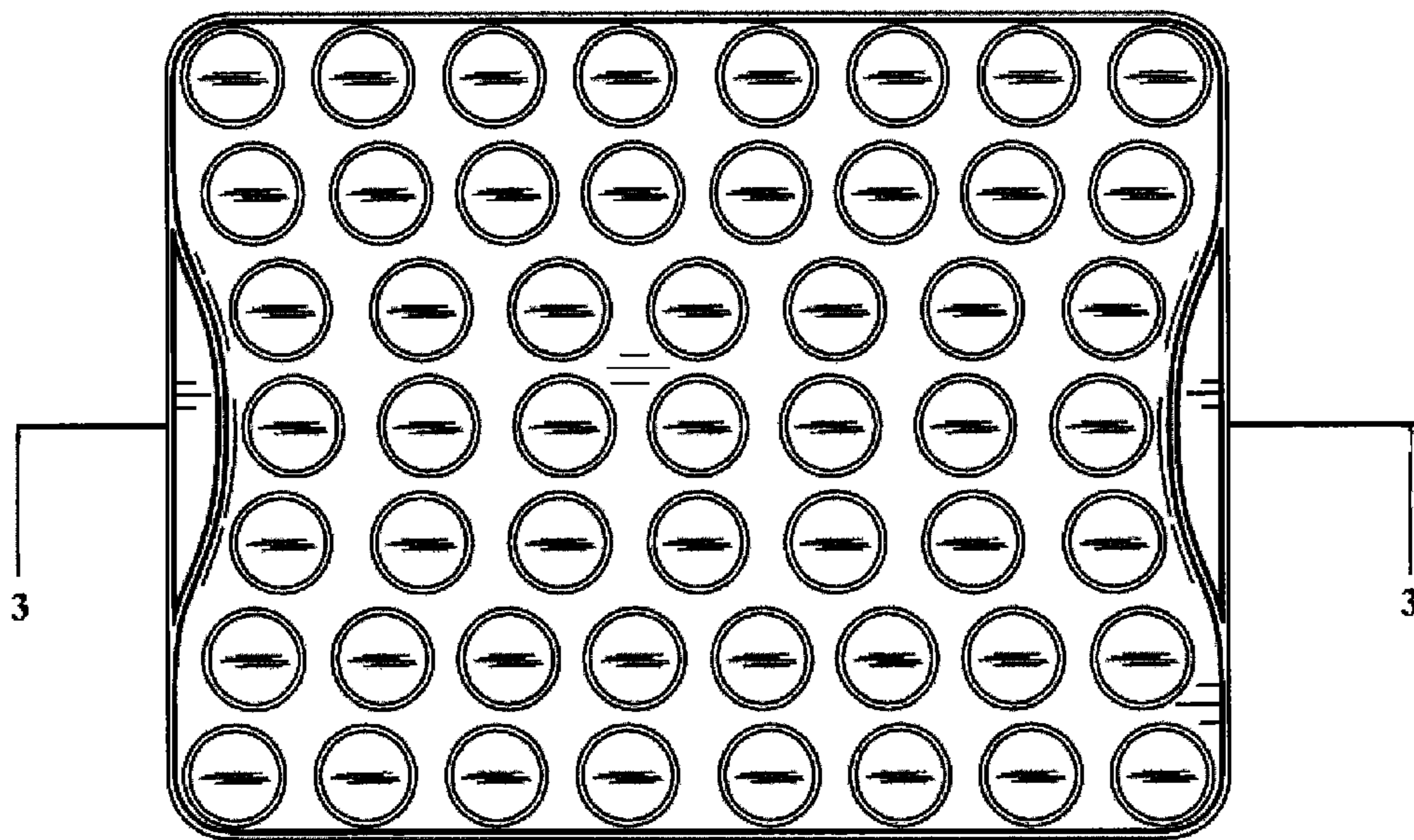

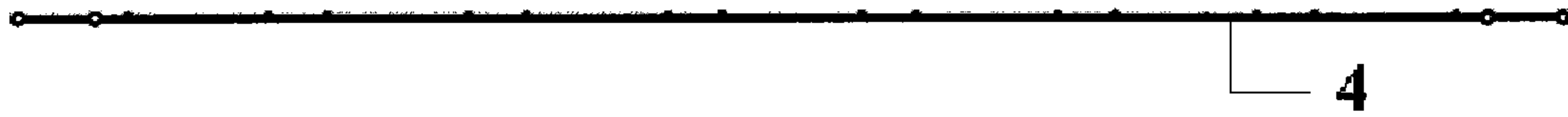




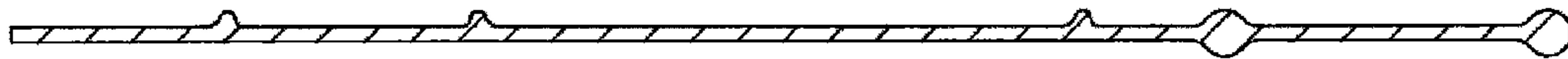

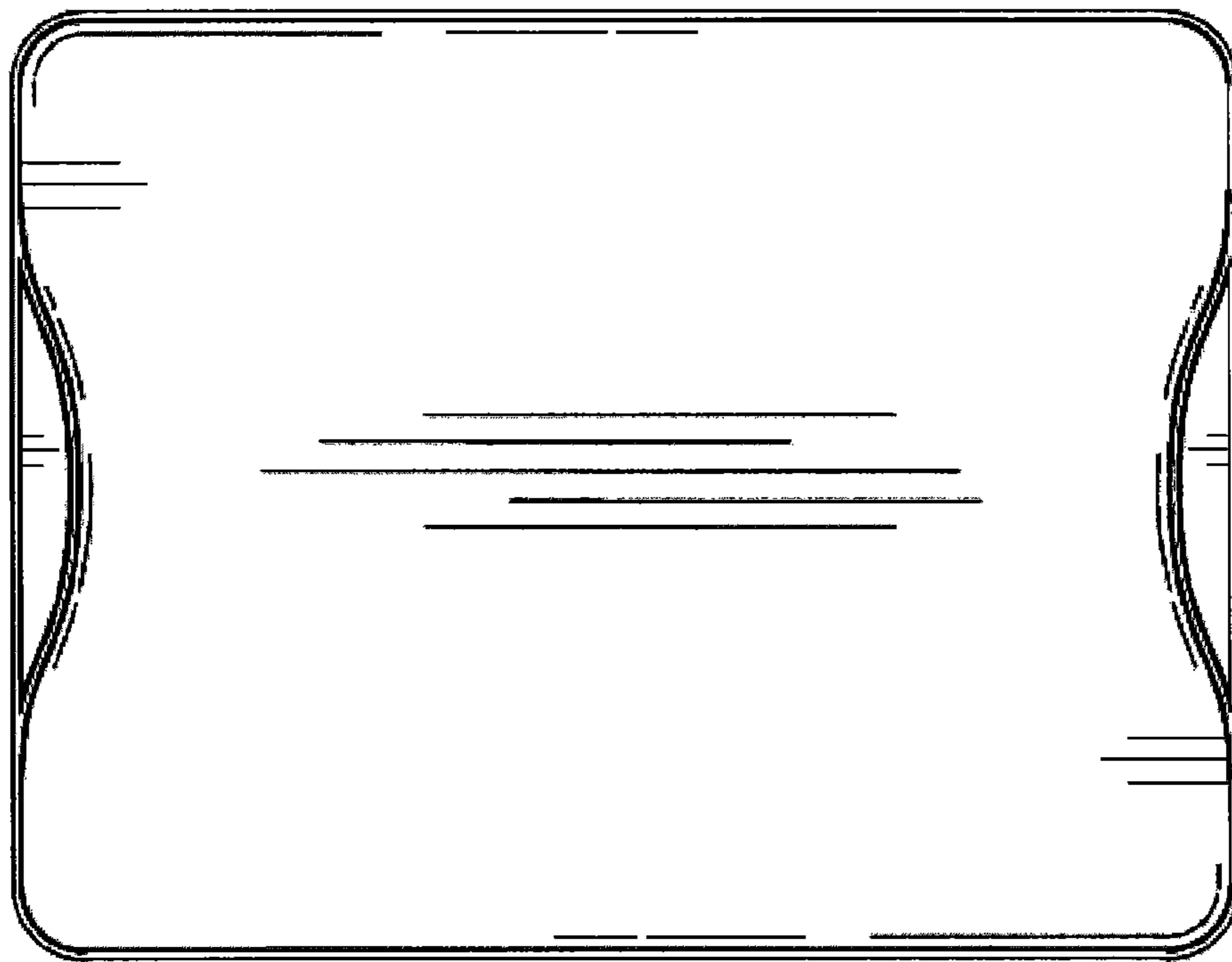
