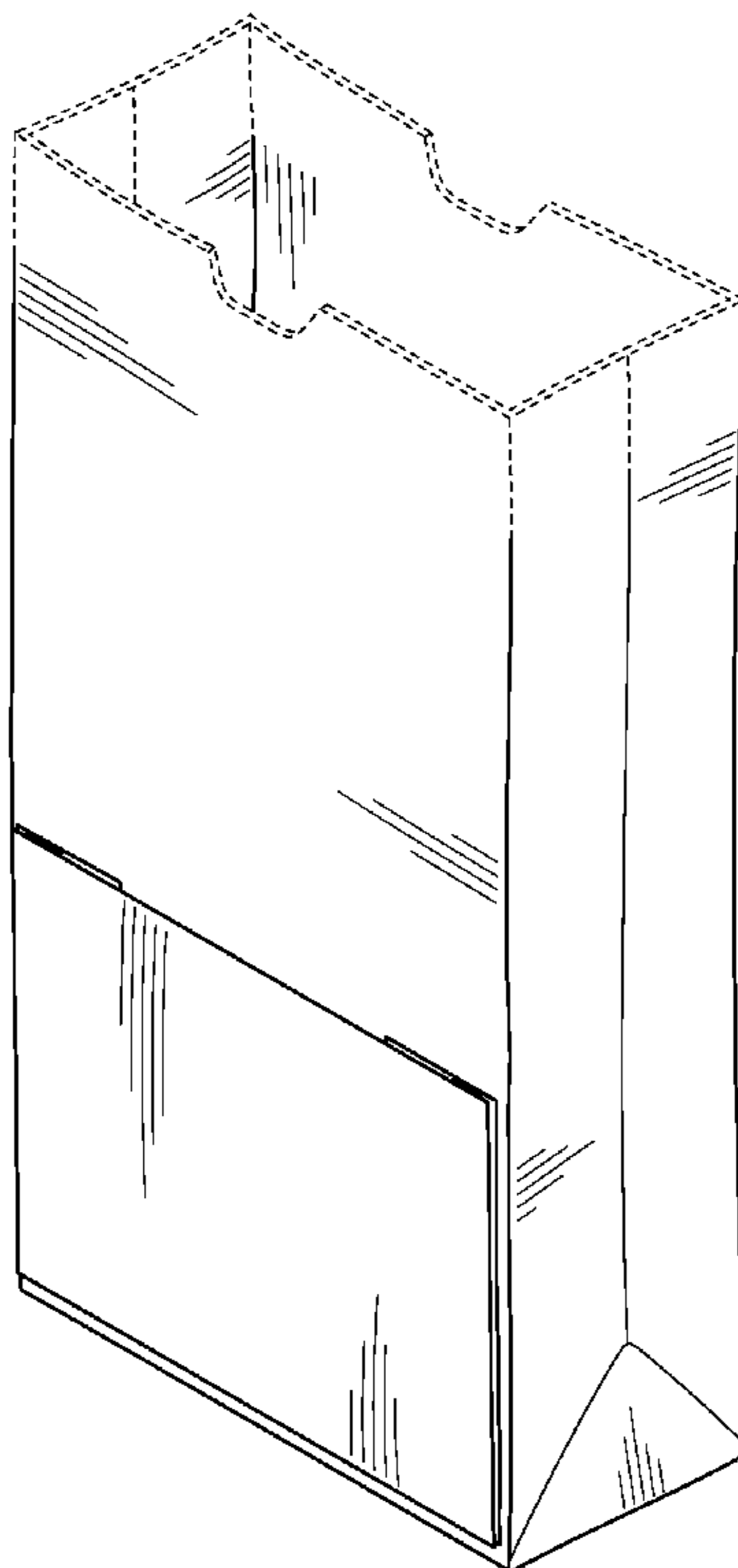
(57) **CLAIM**

The ornamental design for a bag with a side pouch, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side isometric view of the bag with side pouch showing my new design;
 FIG. 2 is a right side elevational view thereof;
 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is top plan view thereof; and,
 FIG. 6 is an isometric view thereof, with the side pouch partially expanded.

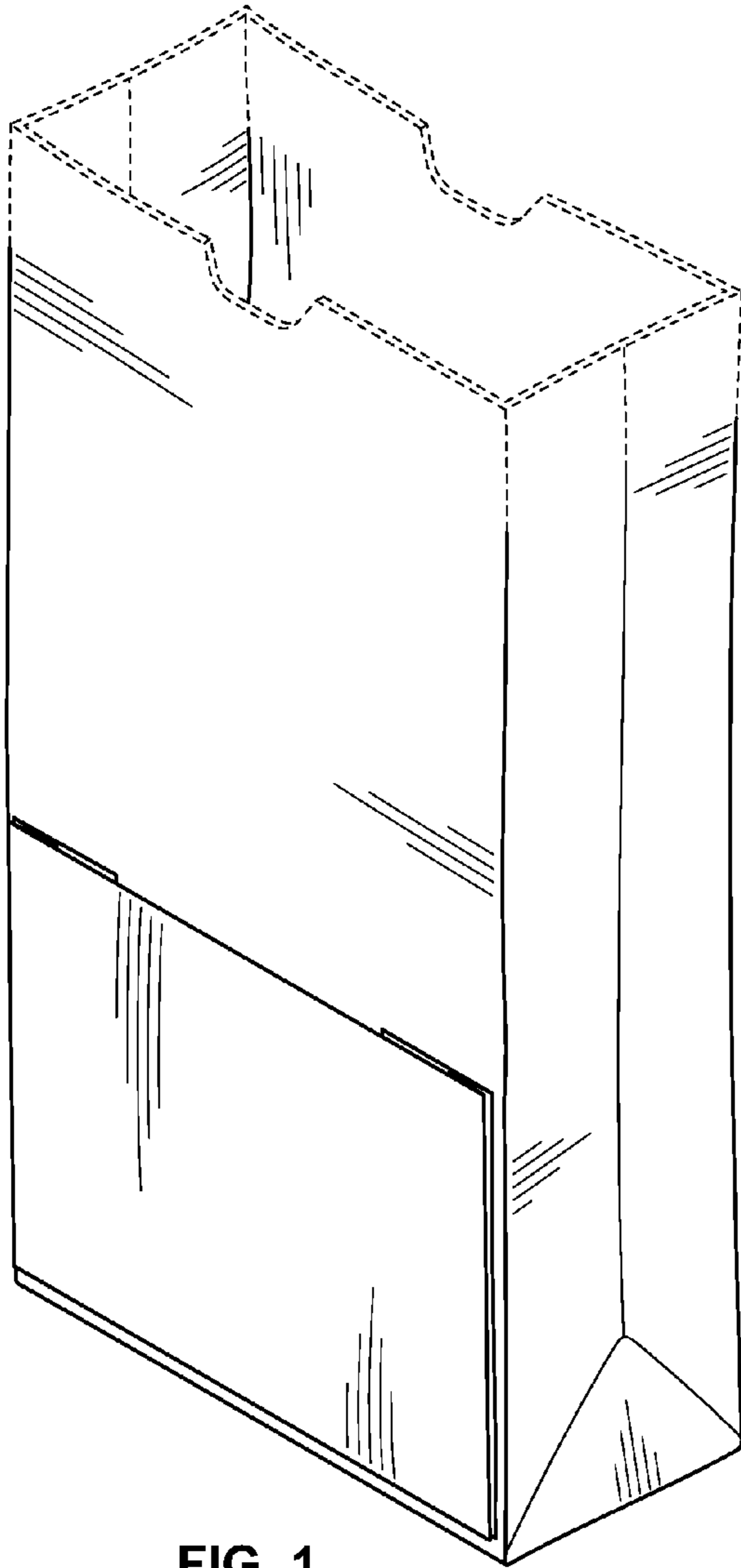

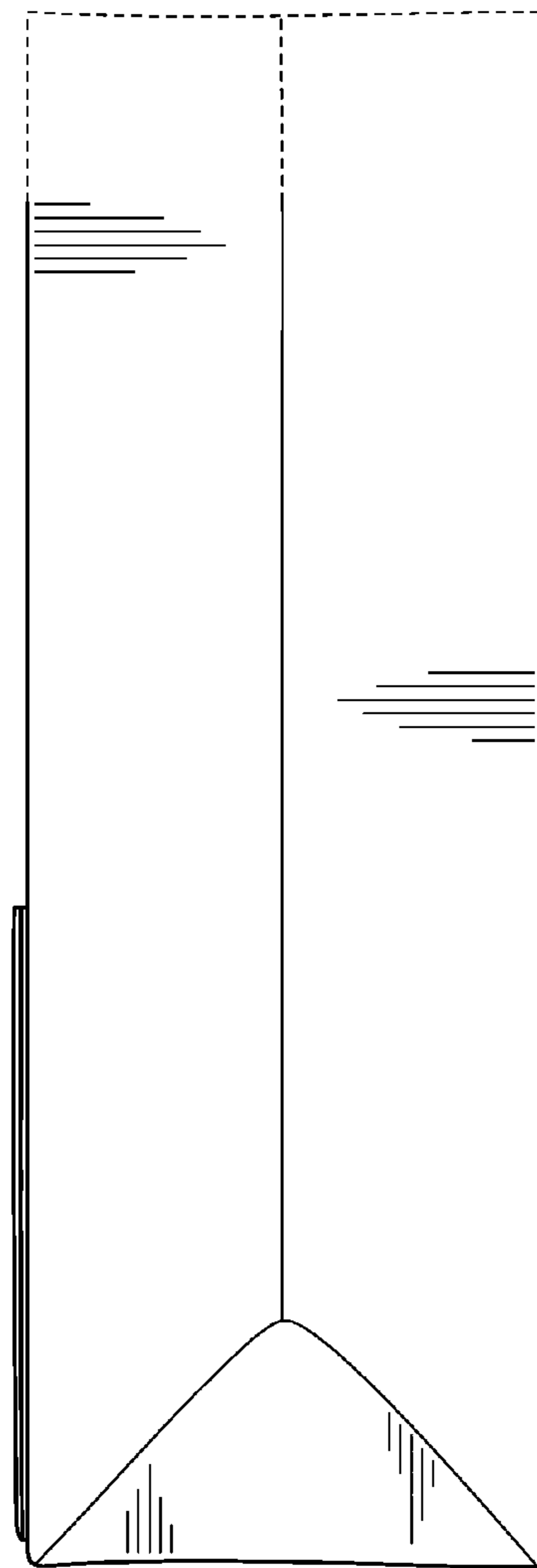

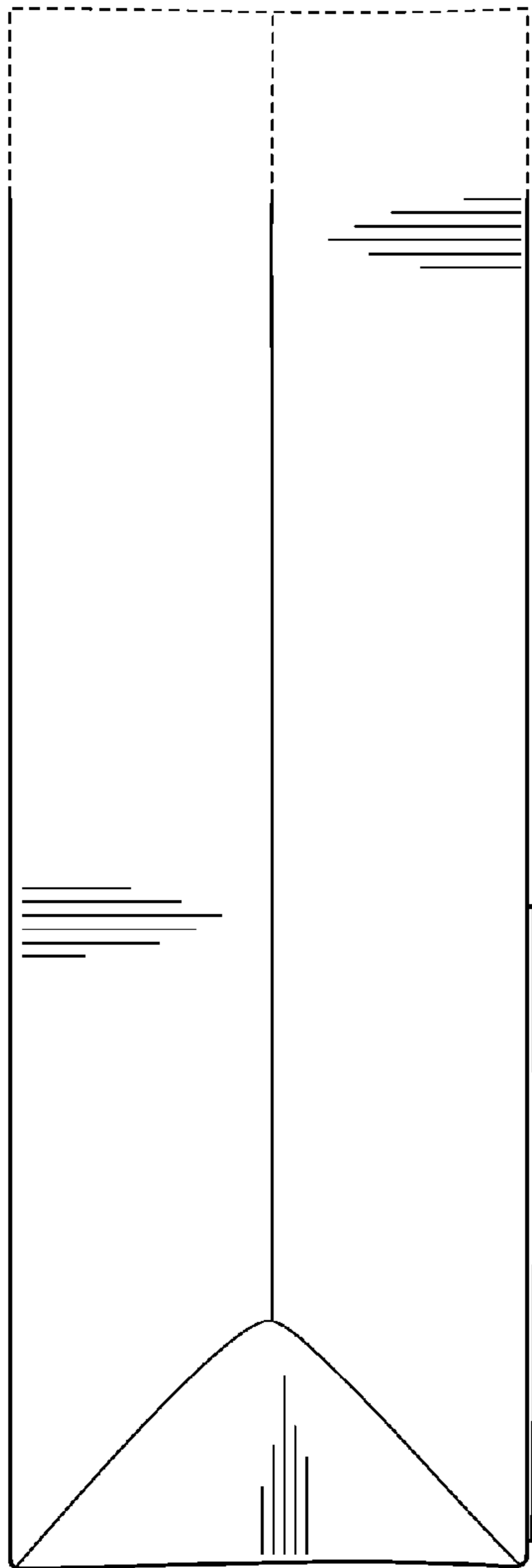

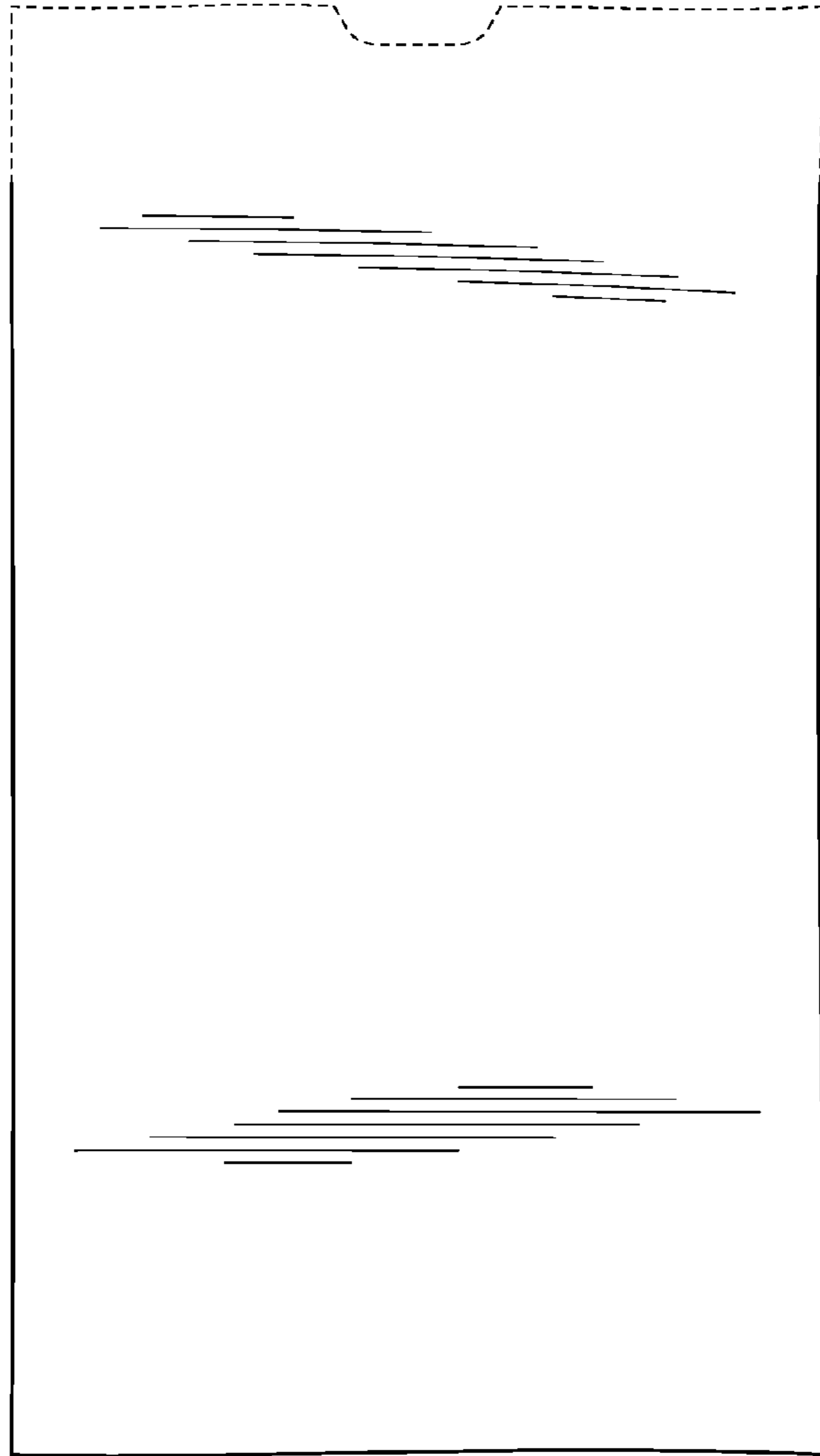

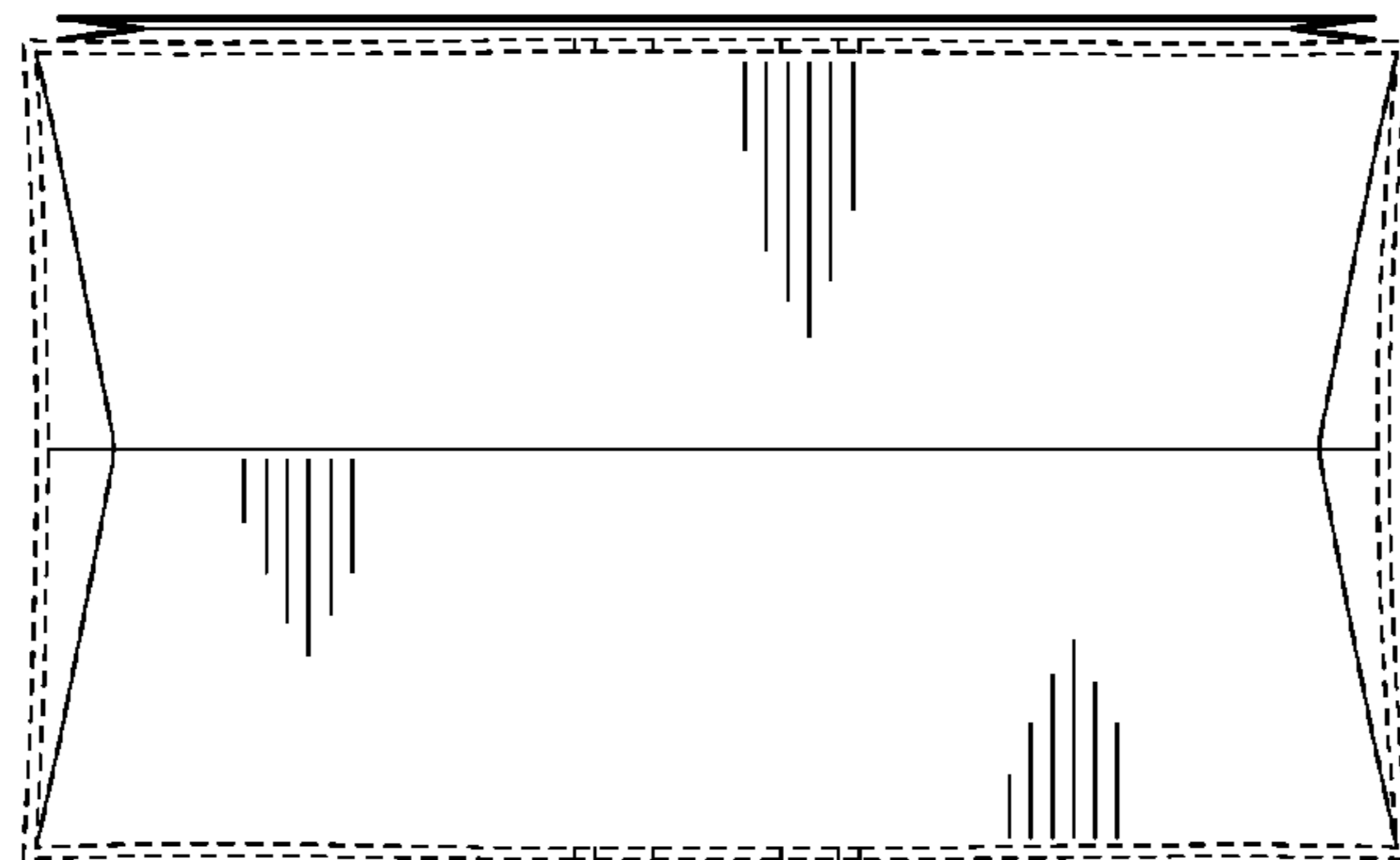

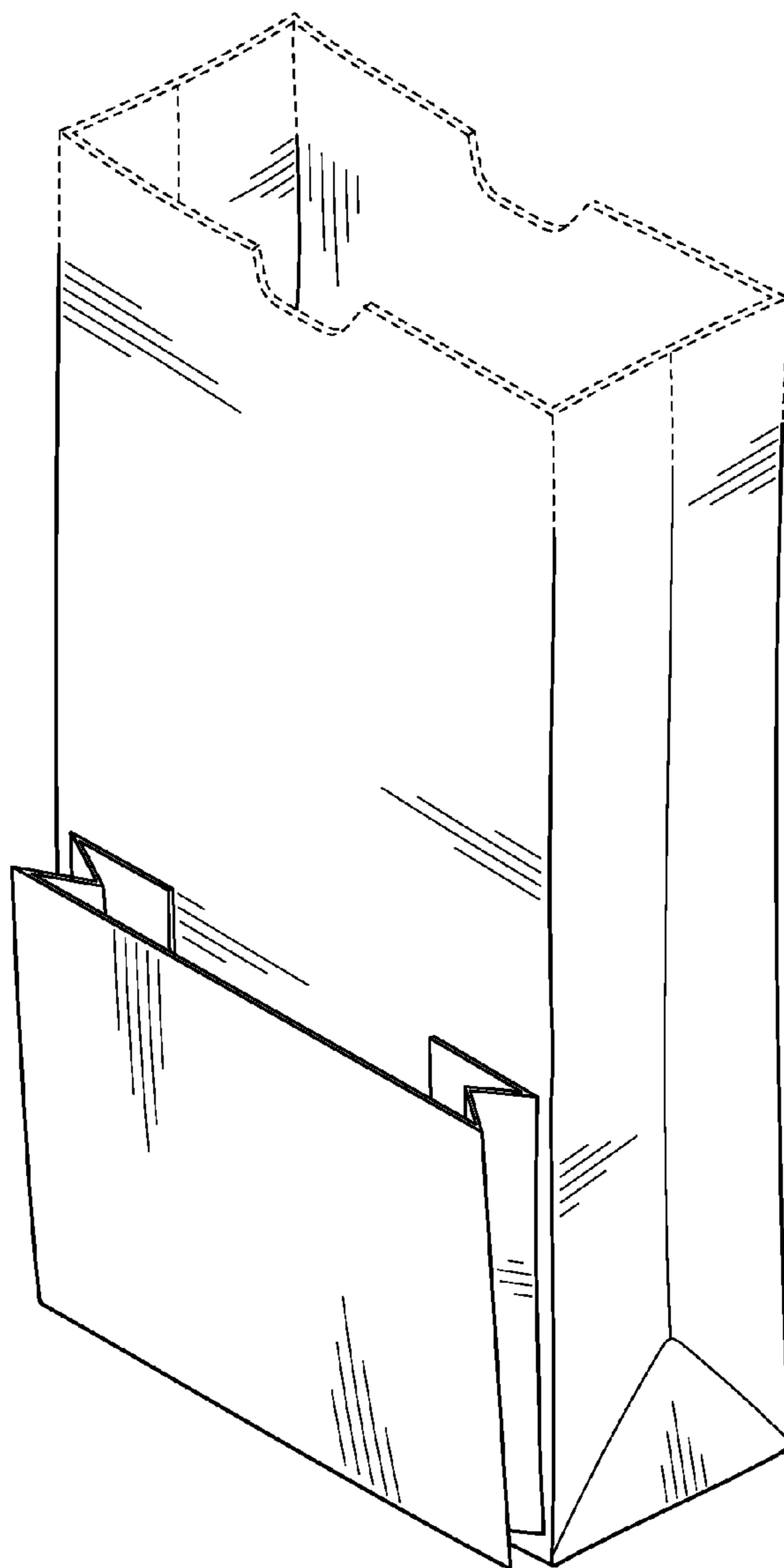
