(57) **CLAIM** The ornamental design for a leveling block wheel chock, as shown and described.

#### DESCRIPTION

FIG. 1 is a front, top right perspective view of a leveling block wheel chock according to the invention;FIG. 2 is a right elevational view according to the invention; and,FIG. 3 is a left elevational view according to the invention; and,

FIG. **4** is a front elevational view according to the invention; and,

FIG. **5** is a rear elevational view according to the invention; and,

FIG. **6** is a top plan view according to the invention; and, FIG. **7** is a bottom plan view according to the invention; and, FIG. **8** is a back, bottom left perspective view according to the invention.
