(57) **CLAIM**

I claim the ornamental design for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a front left-side top perspective view of a mobile phone showing my new design;

FIG. 2 is a front-side elevational view thereof;

FIG. 3 is a rear-side elevational view thereof;

FIG. 4 is a left-side elevational view thereof;

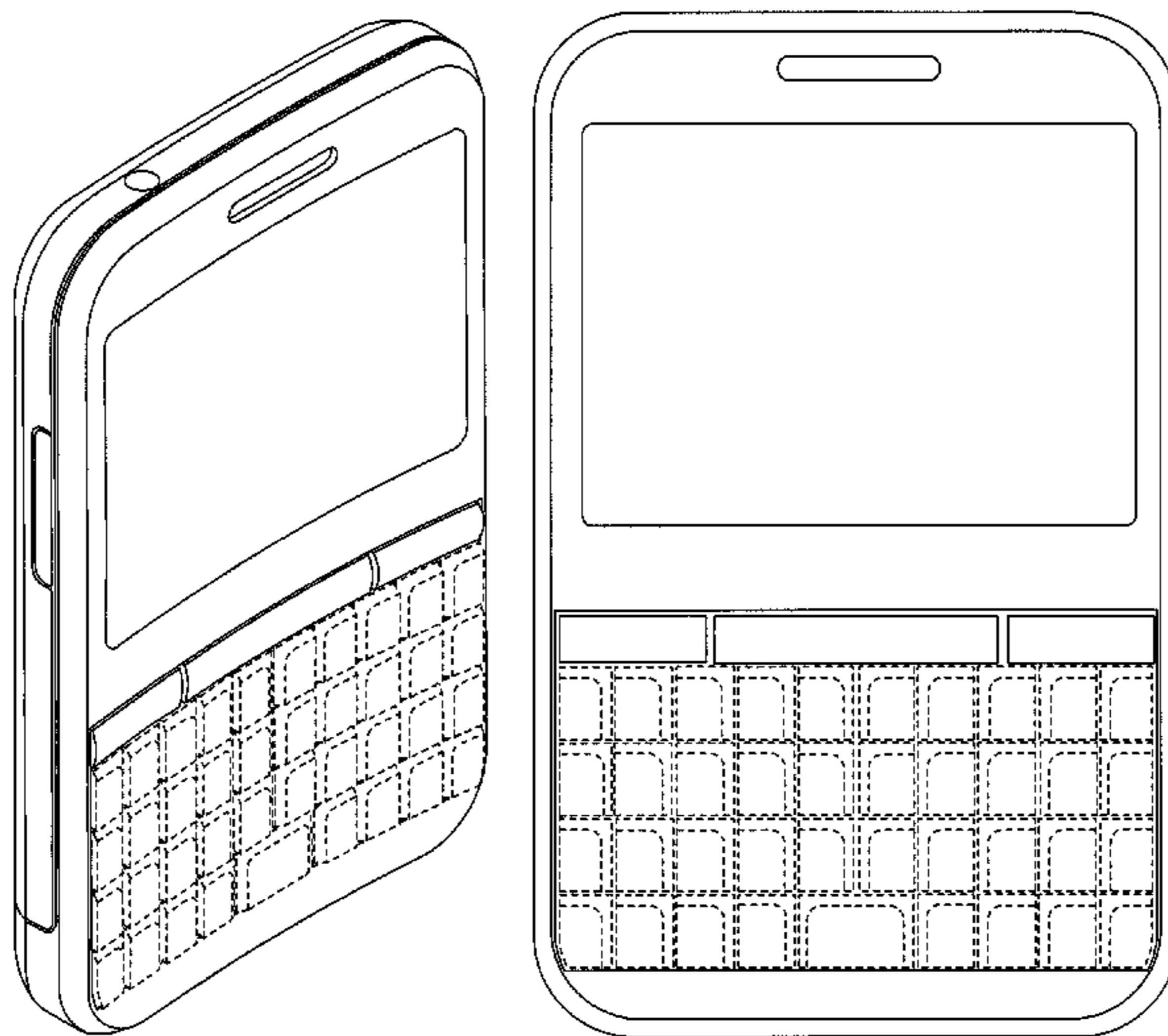
FIG. 5 is a right-side elevational view thereof;

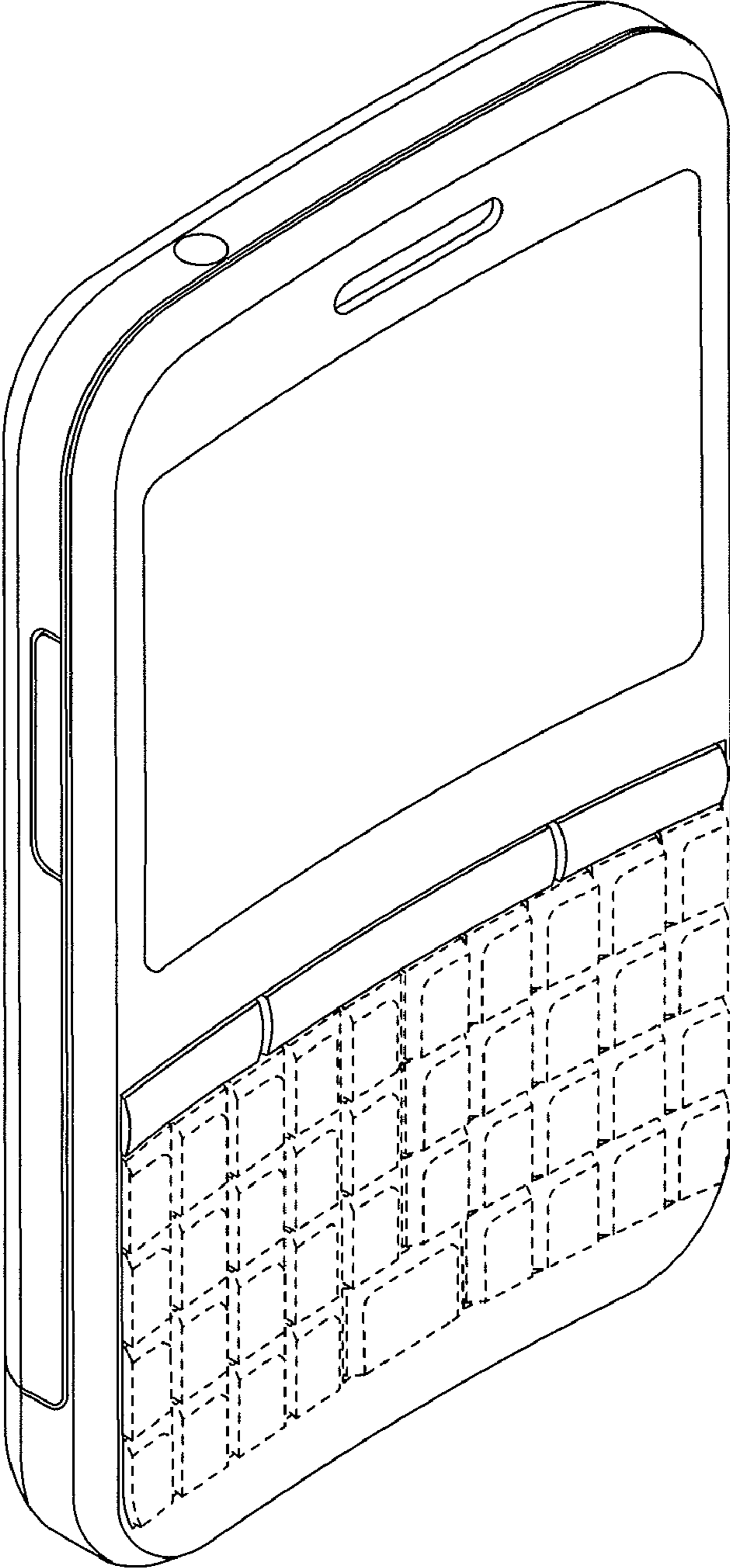

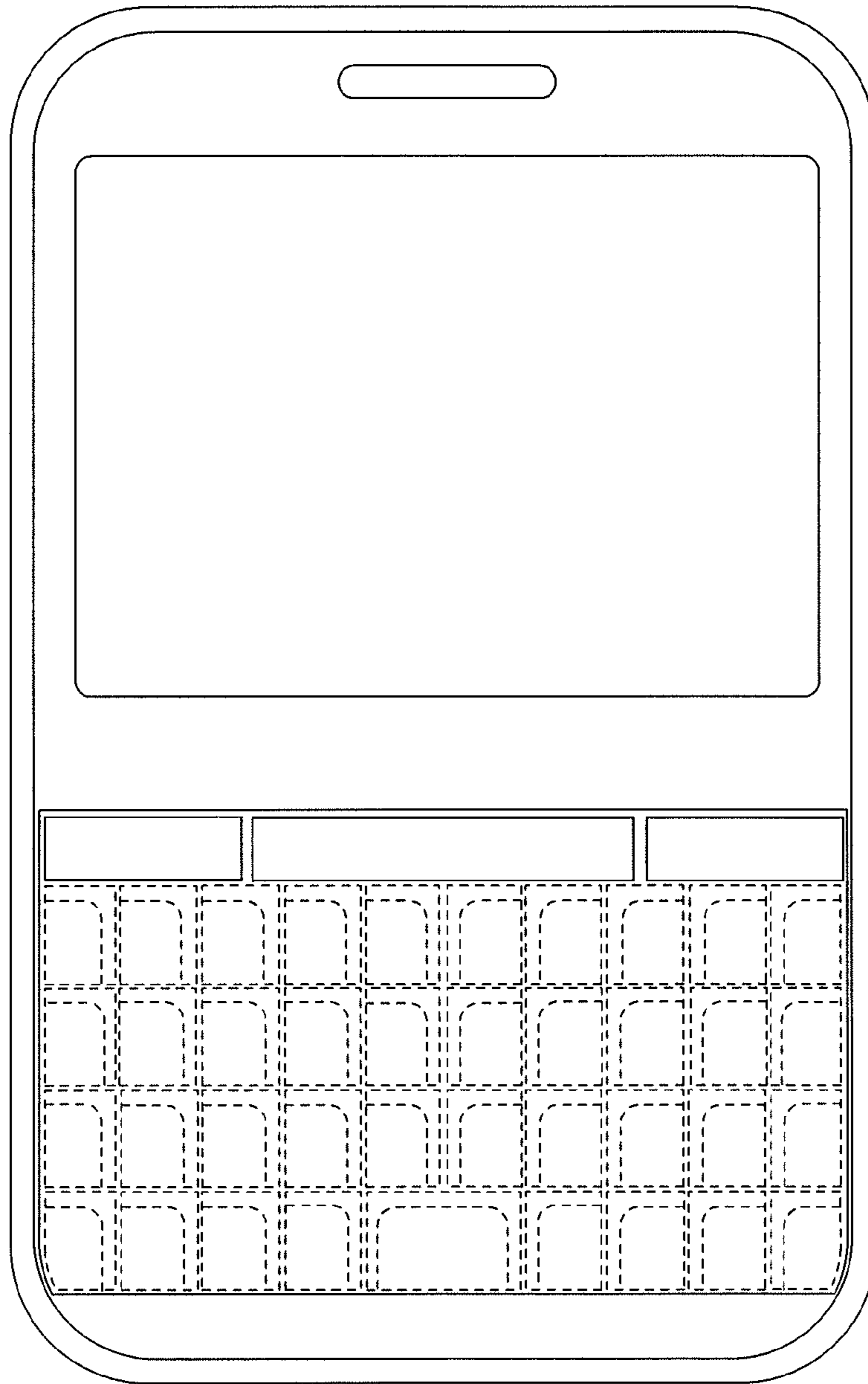

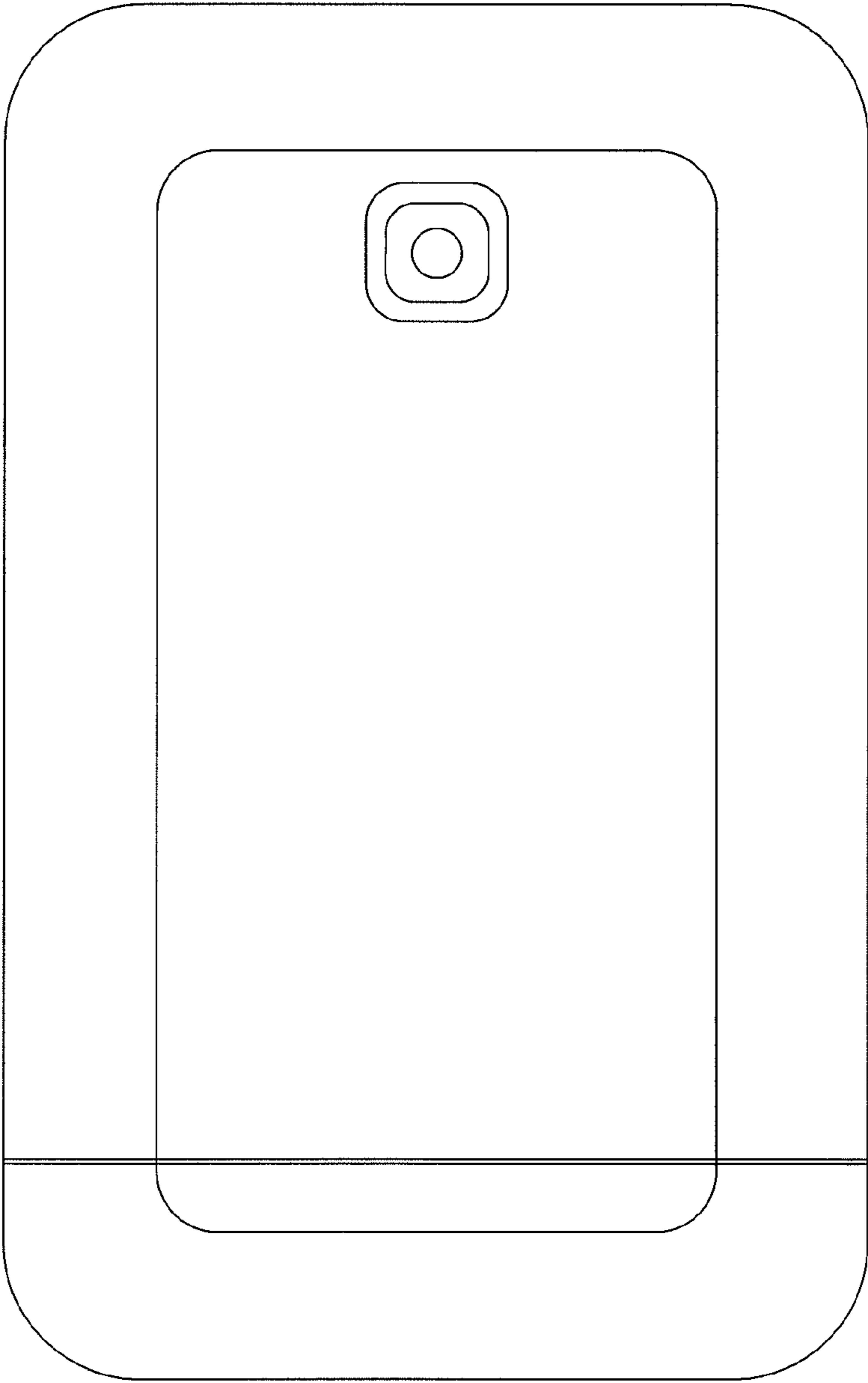

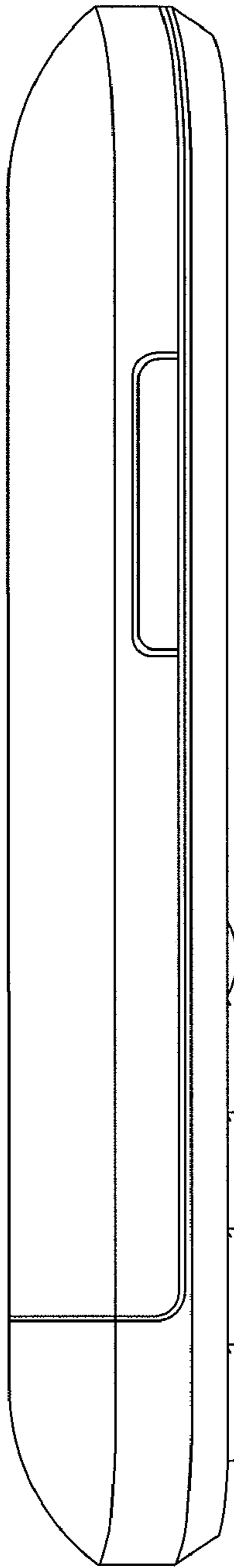

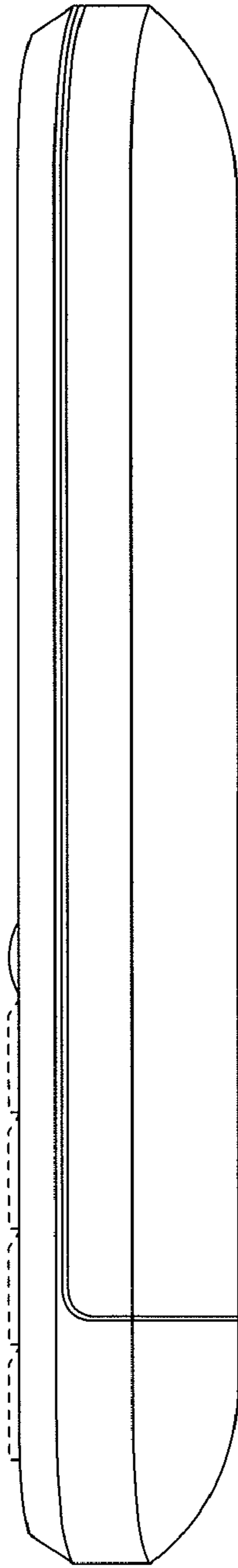

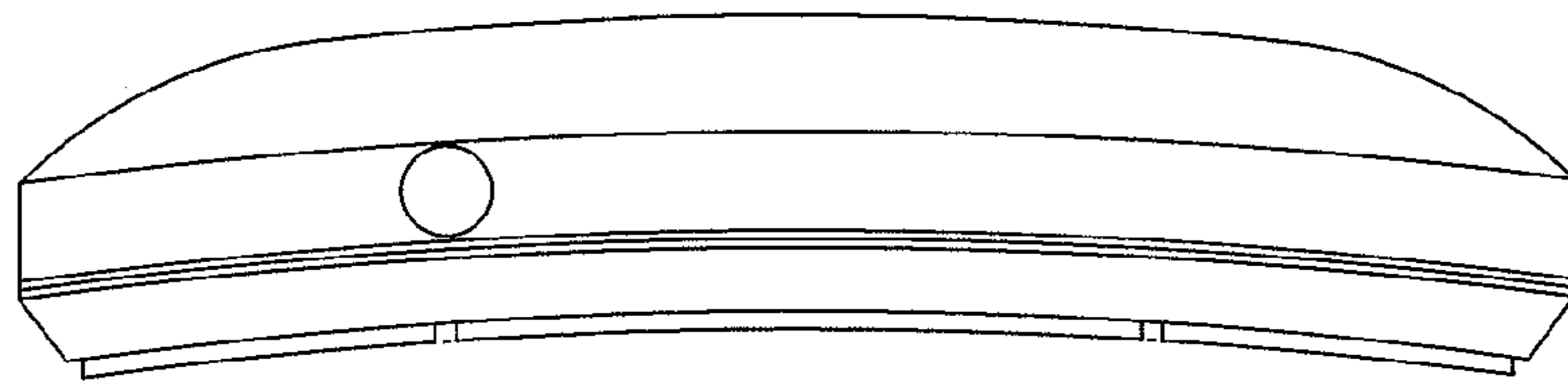

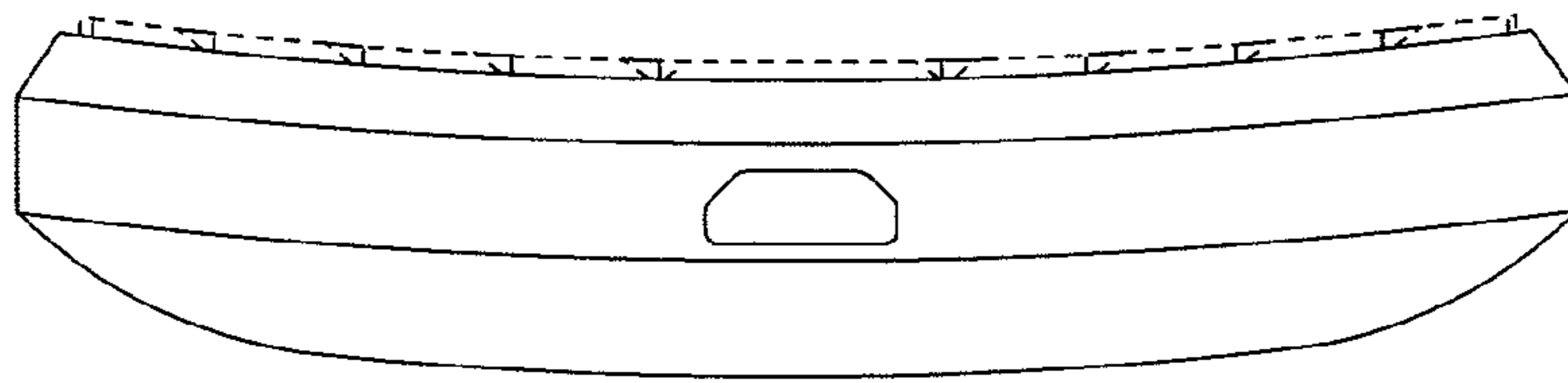
