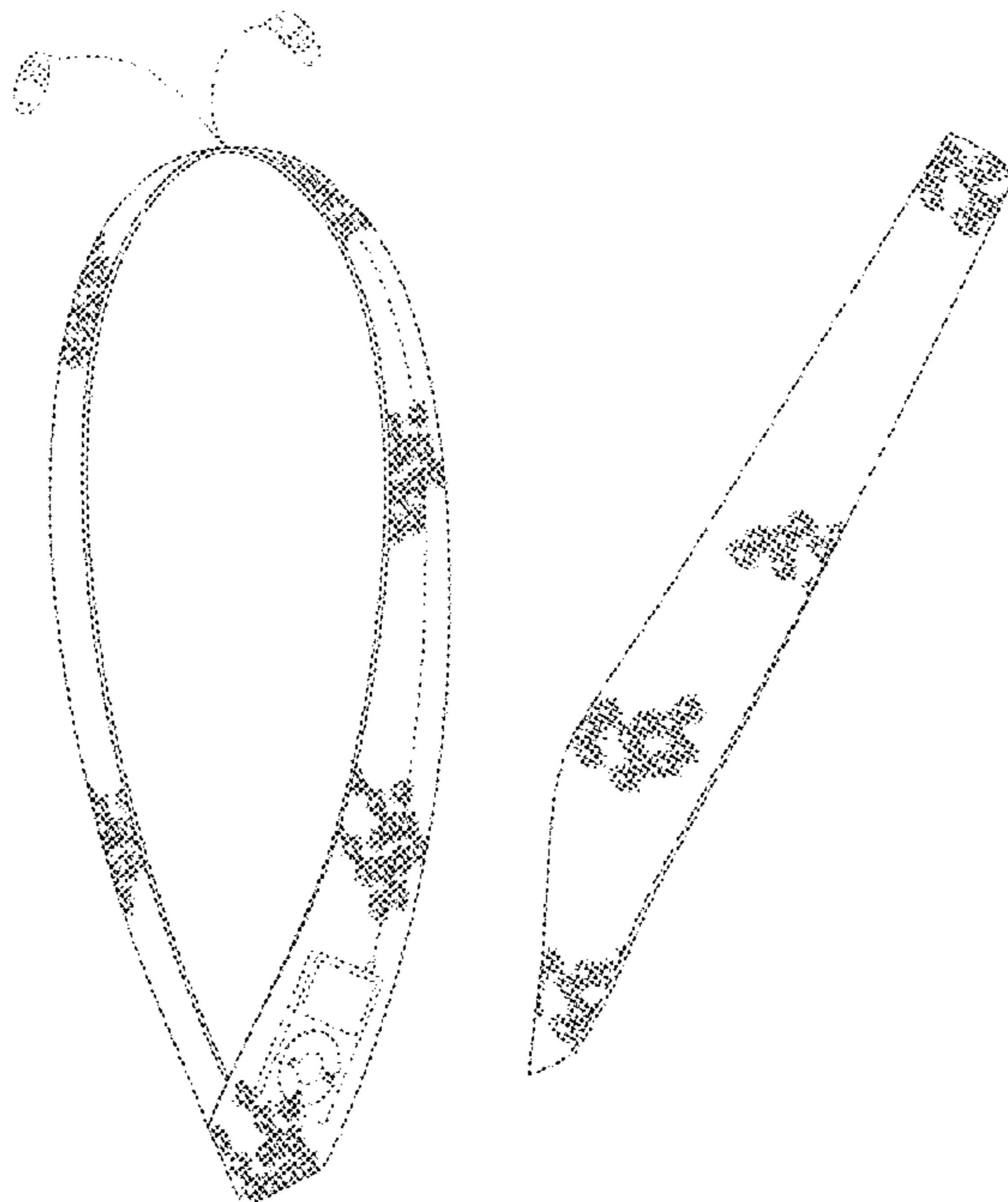
(57) **CLAIM**

The ornamental design for a electronic device and accessory support, as shown and described.

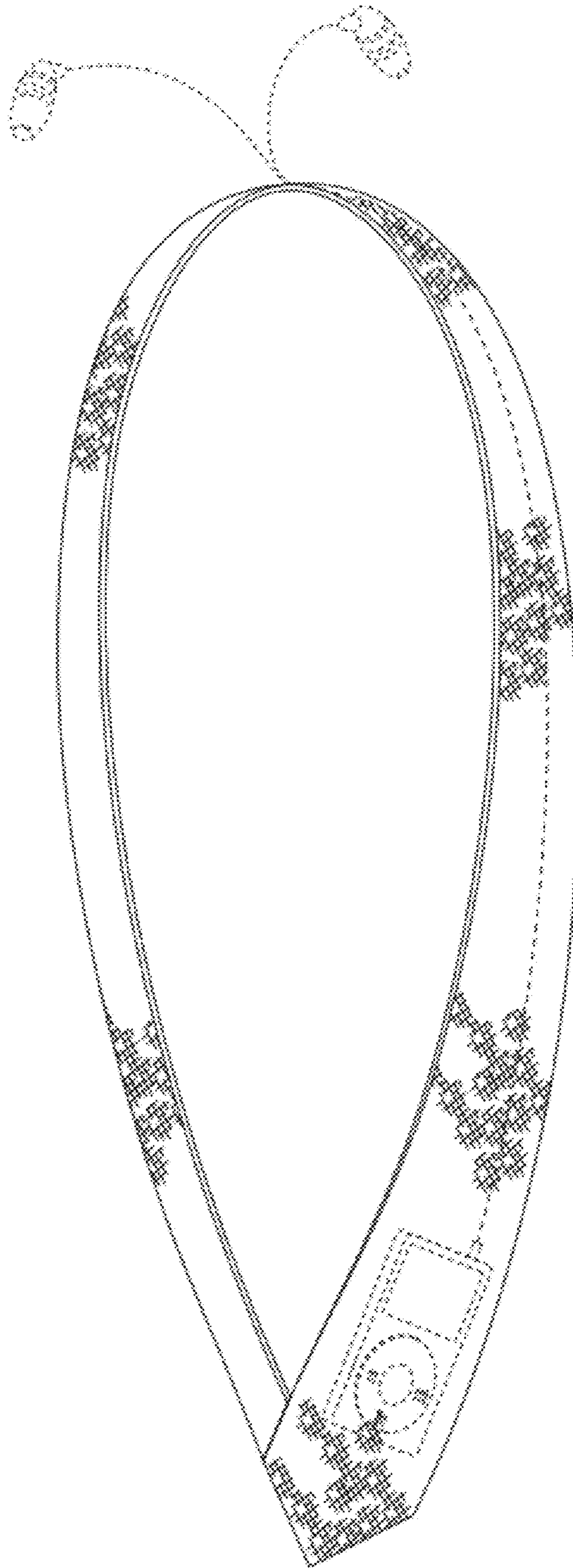
**DESCRIPTION**

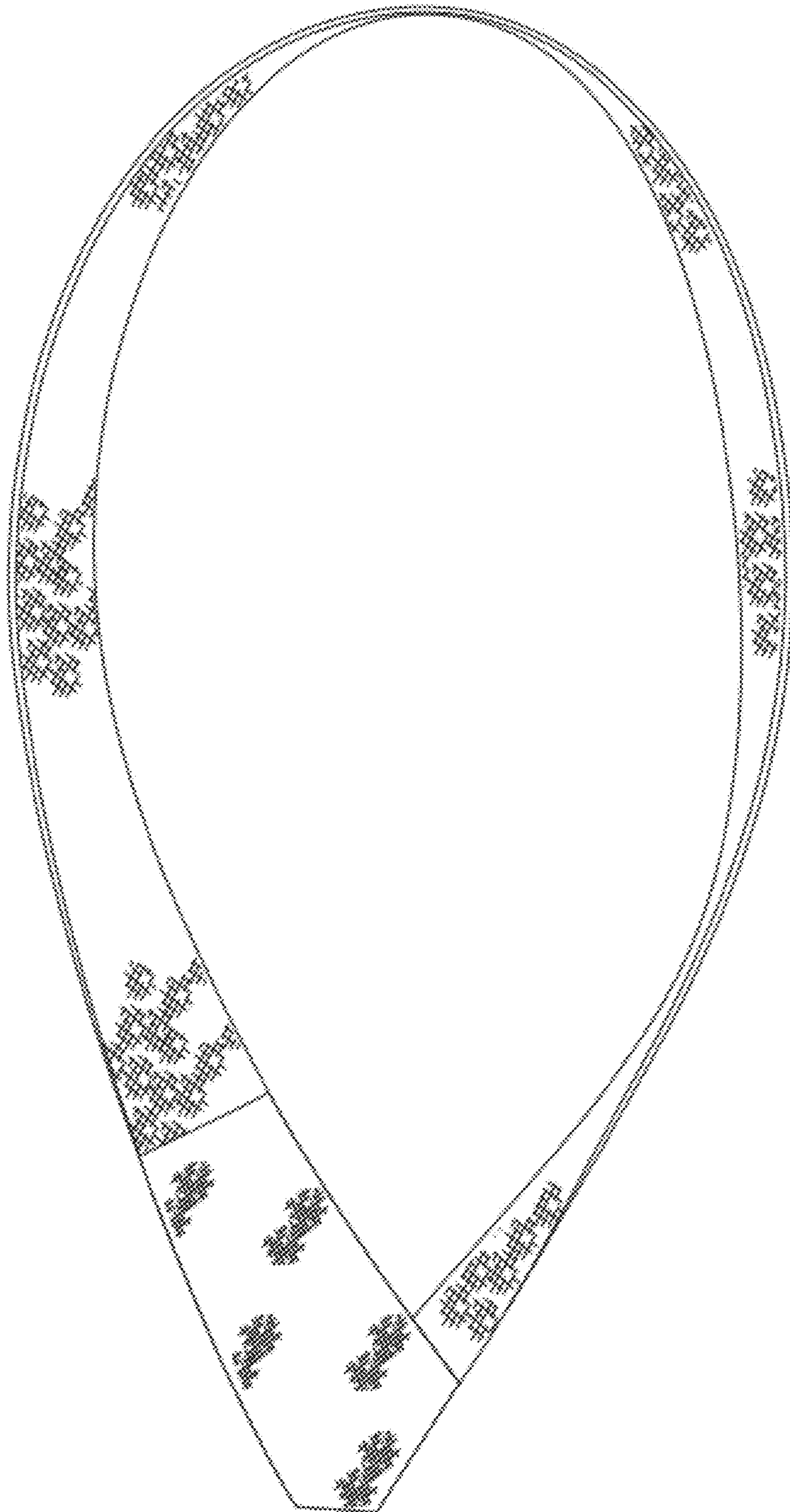

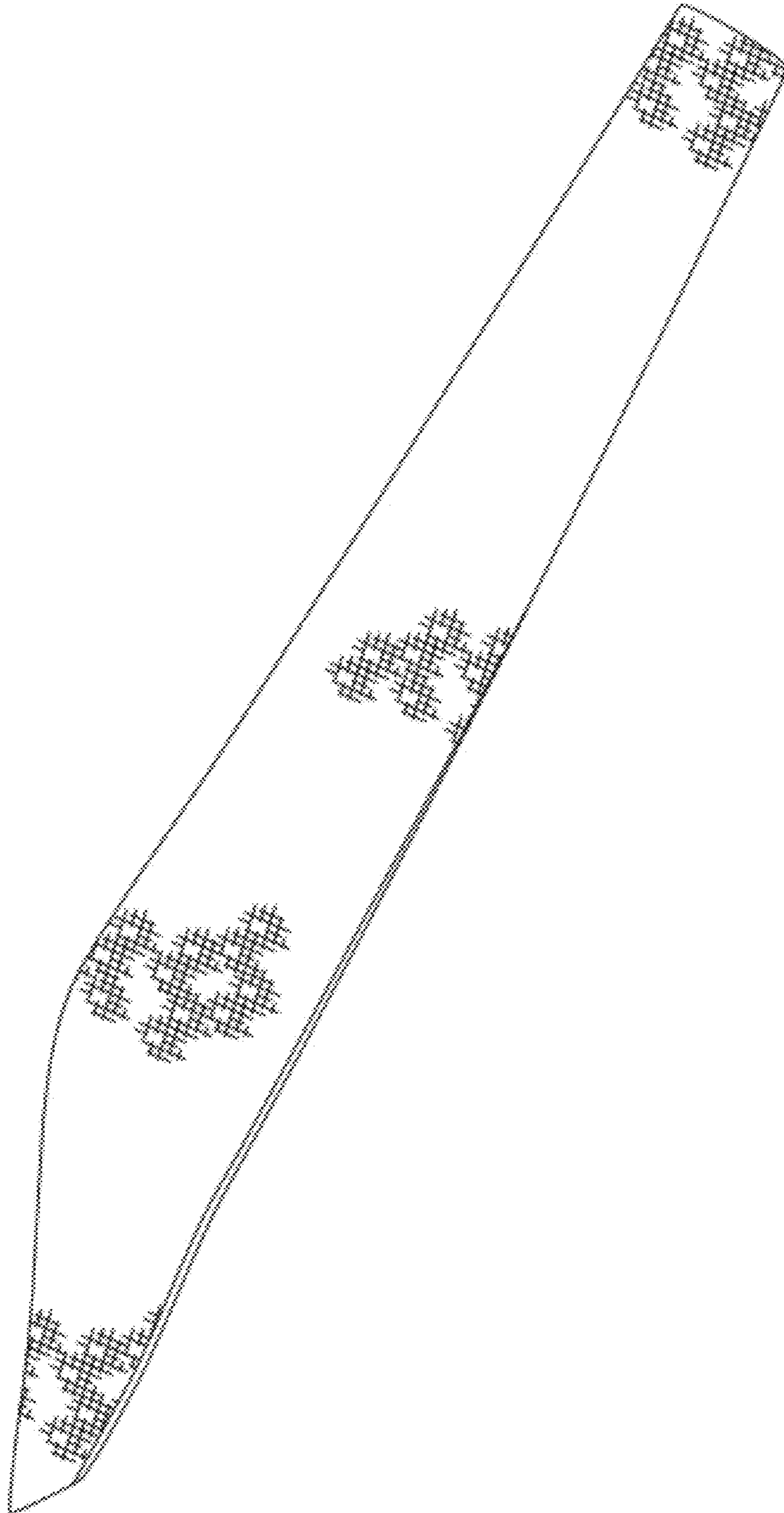




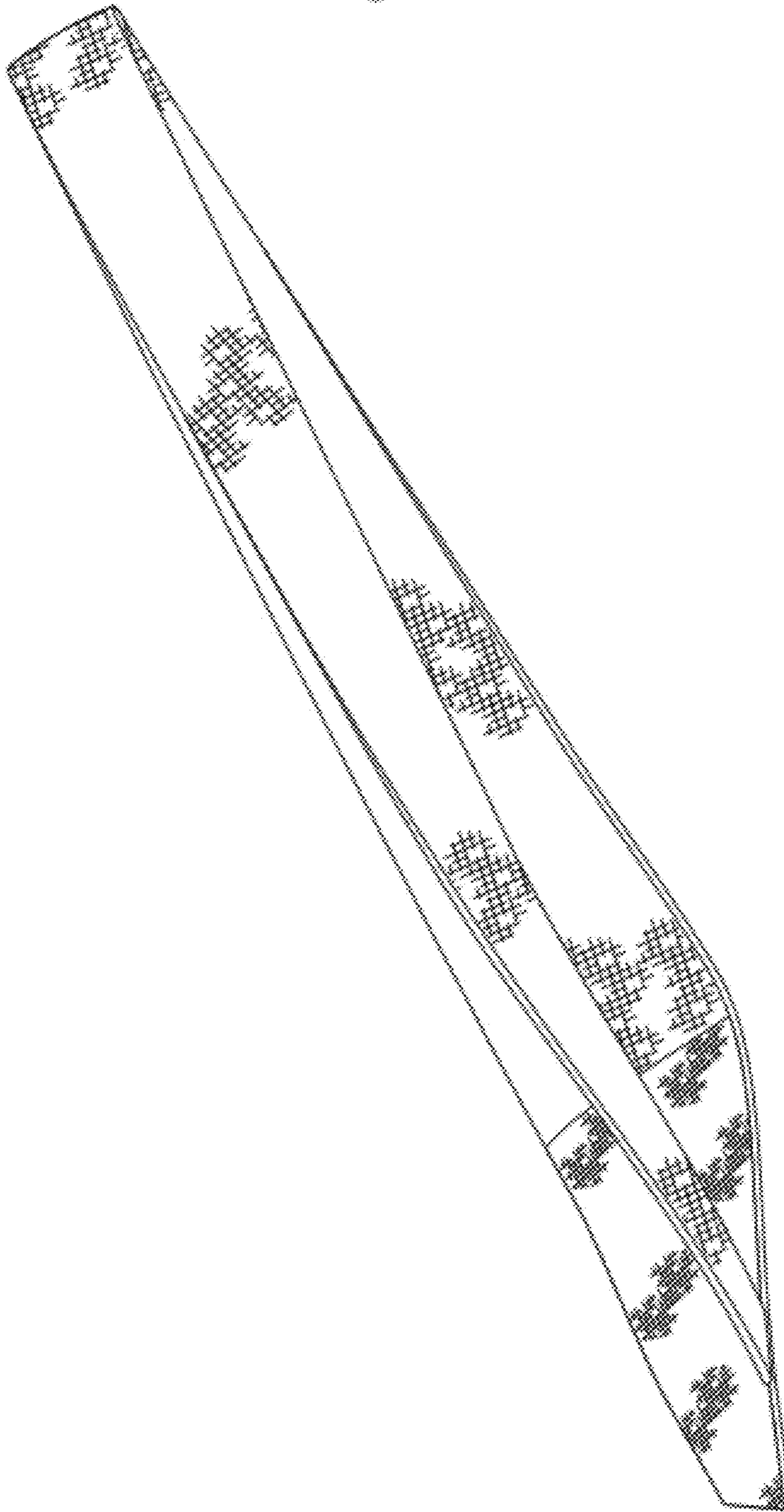

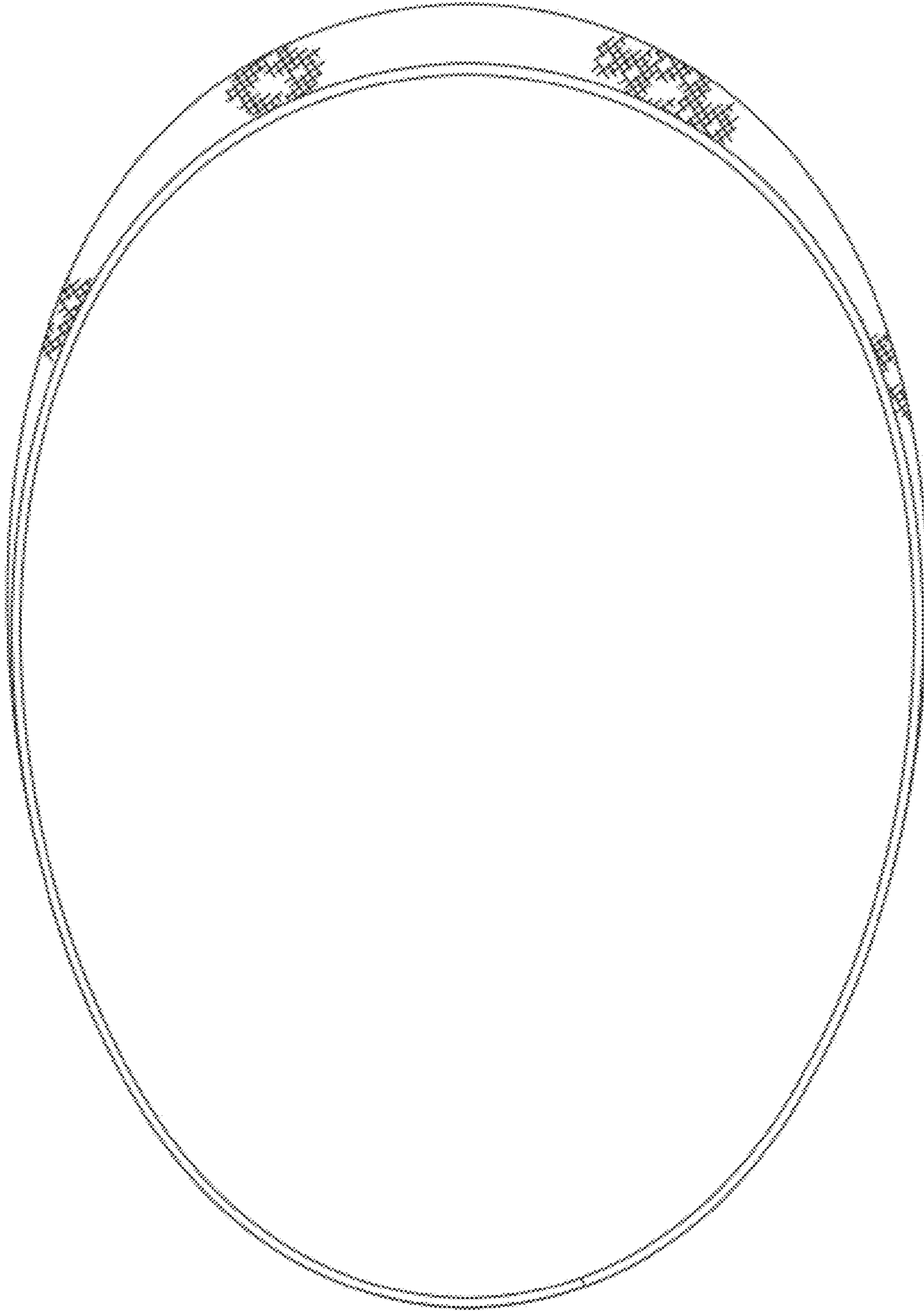
