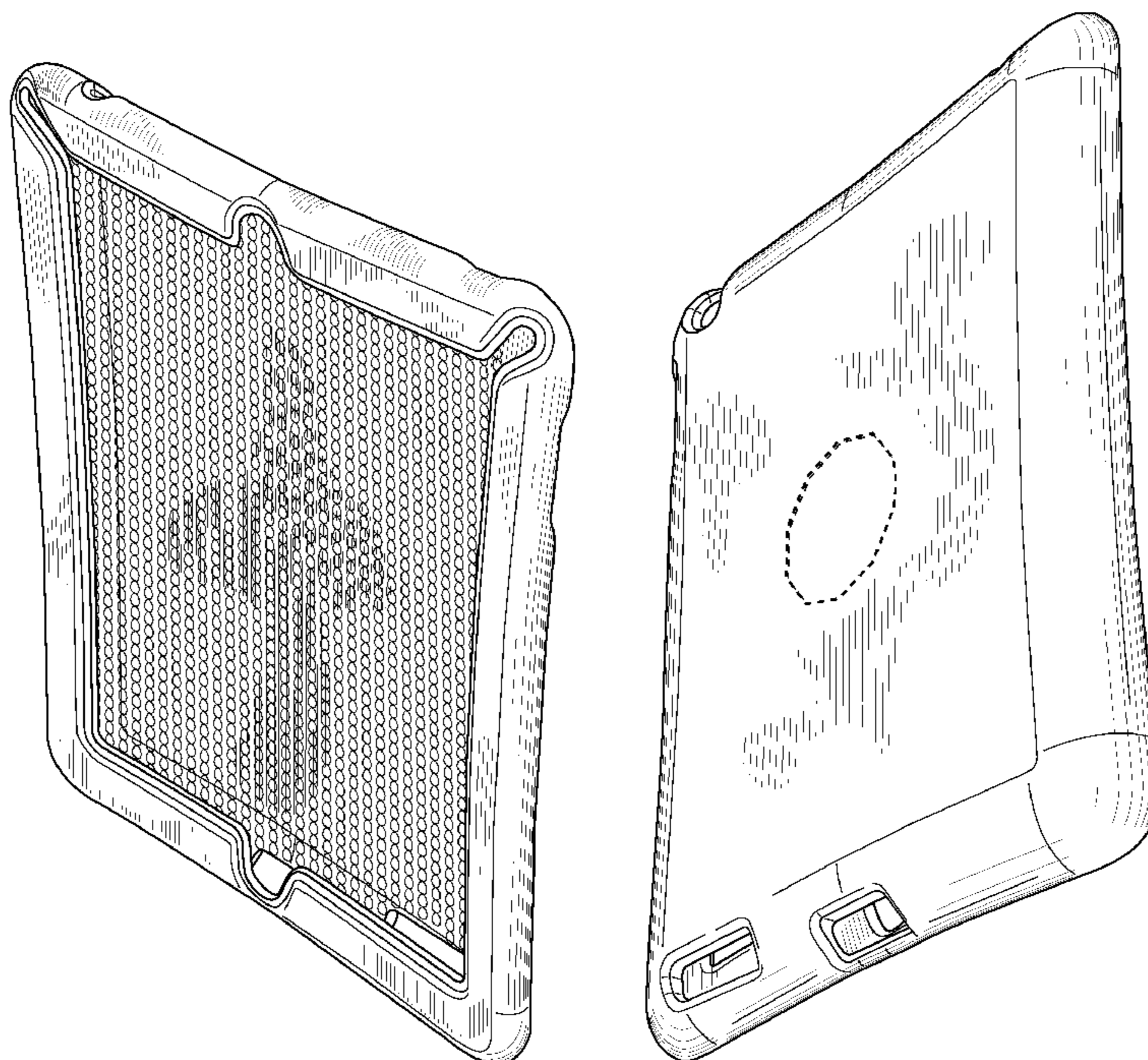
(57) **CLAIM**

The ornamental design for a protective encasing for a mobile computing device, as shown.

**DESCRIPTION**

FIG. 1 is a front perspective view of the protective encasing for a mobile computing device of the present invention, with the central darker area representing shade lines; FIG. 2 is a back perspective view of the protective encasing of FIG. 1; FIG. 3 is a back perspective view of the protective encasing of FIG. 1 as seen from a bottom side of FIG. 2; FIG. 4 is a top plan view in elevation of the protective encasing of FIG. 1, with the central darker area representing shade lines; FIG. 5 is a bottom plan view of the protective encasing of FIG. 1; FIG. 6 is a side view of the protective encasing of FIG. 1, as seen from the left side of FIG. 4; and FIG. 7 is a side view of the protective encasing of FIG. 1, as seen from the right side of FIG. 4. FIG. 8 is a side view of the protective encasing of FIG. 1, as seen from the top side of FIG. 4; and, FIG. 9 is a side view of the protective encasing of FIG. 1, as seen from the bottom side of FIG. 4. The broken line showing a logo design area is for illustrative purposes only and forms no part of the claimed design.

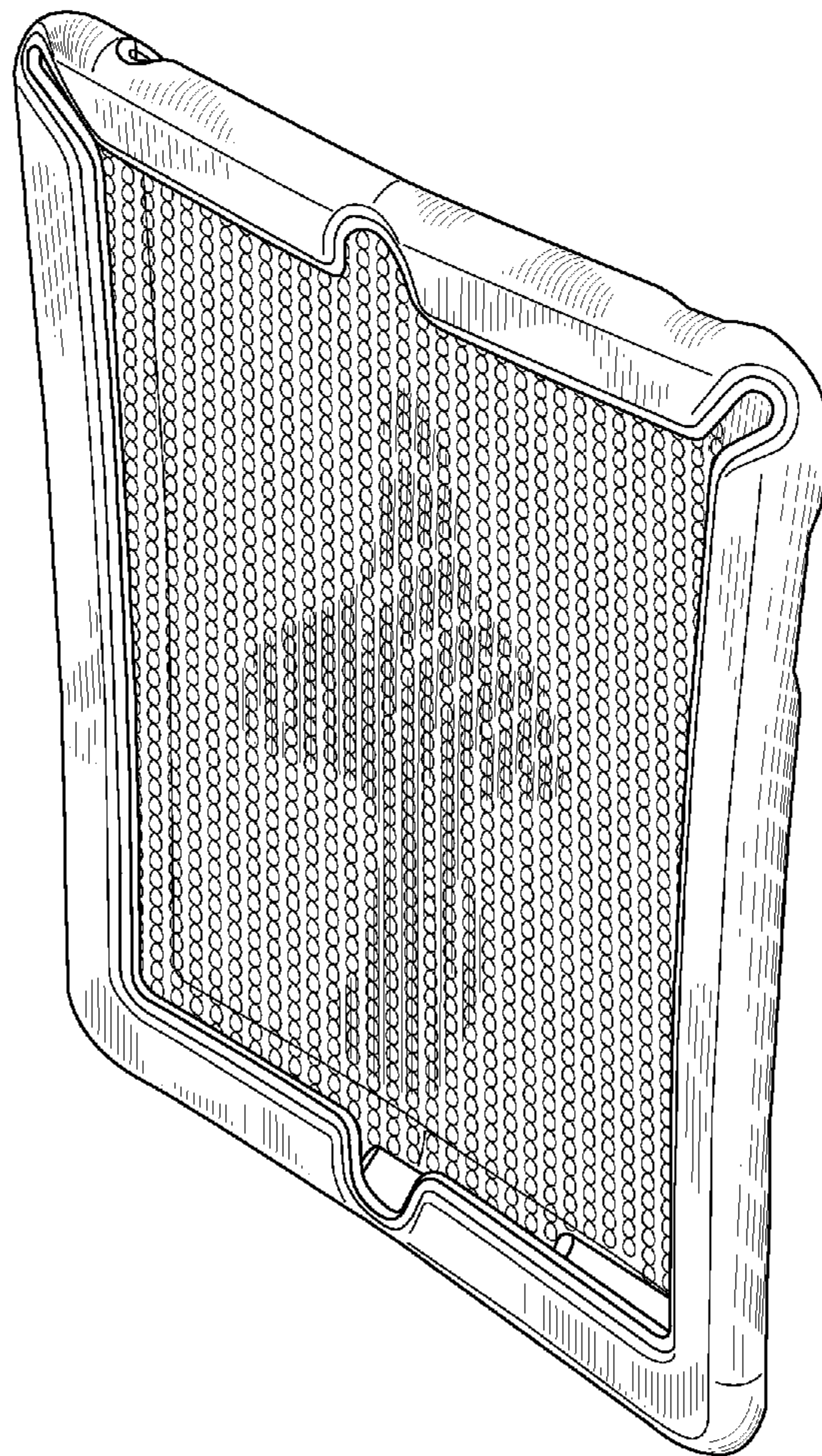

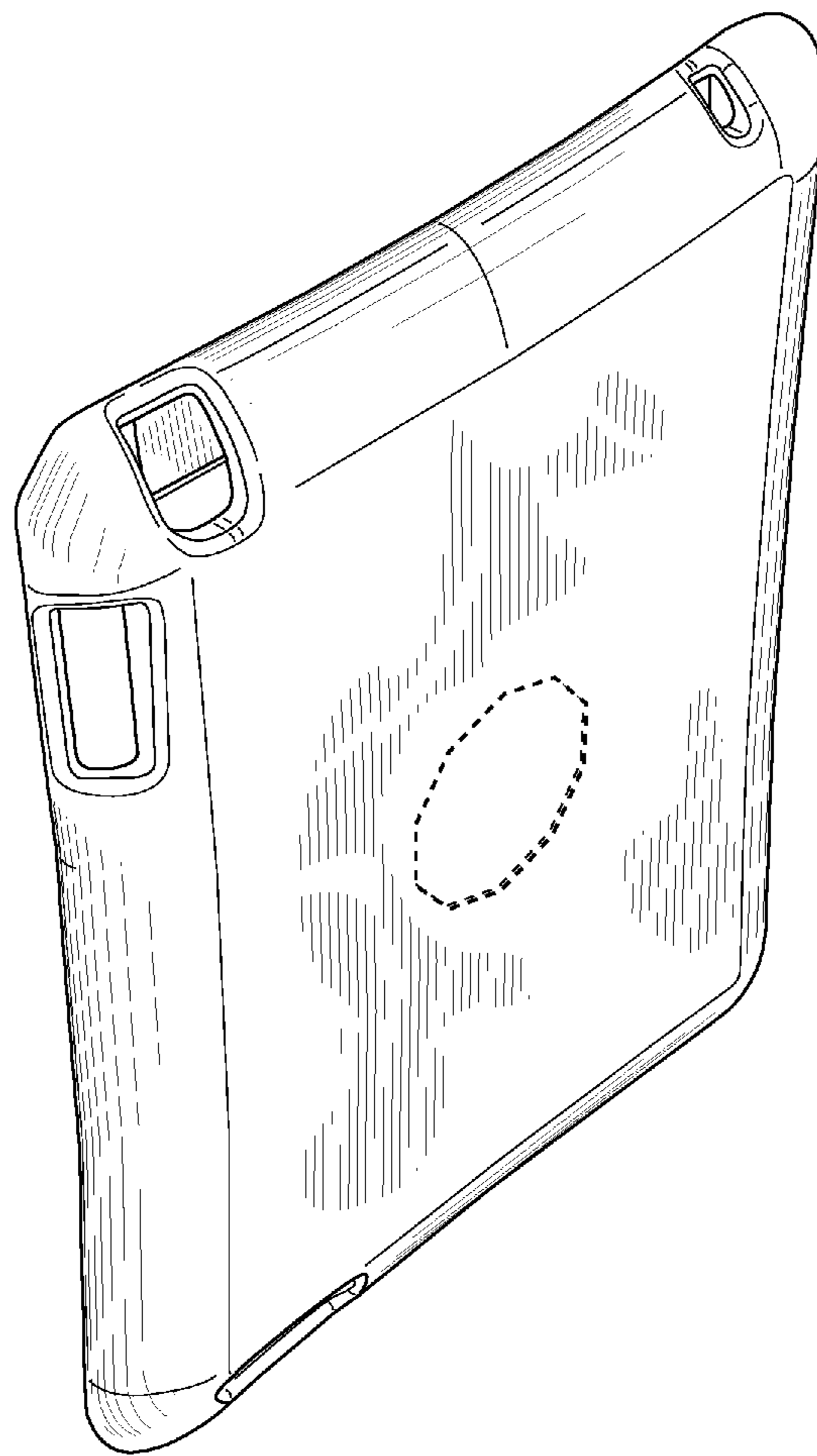

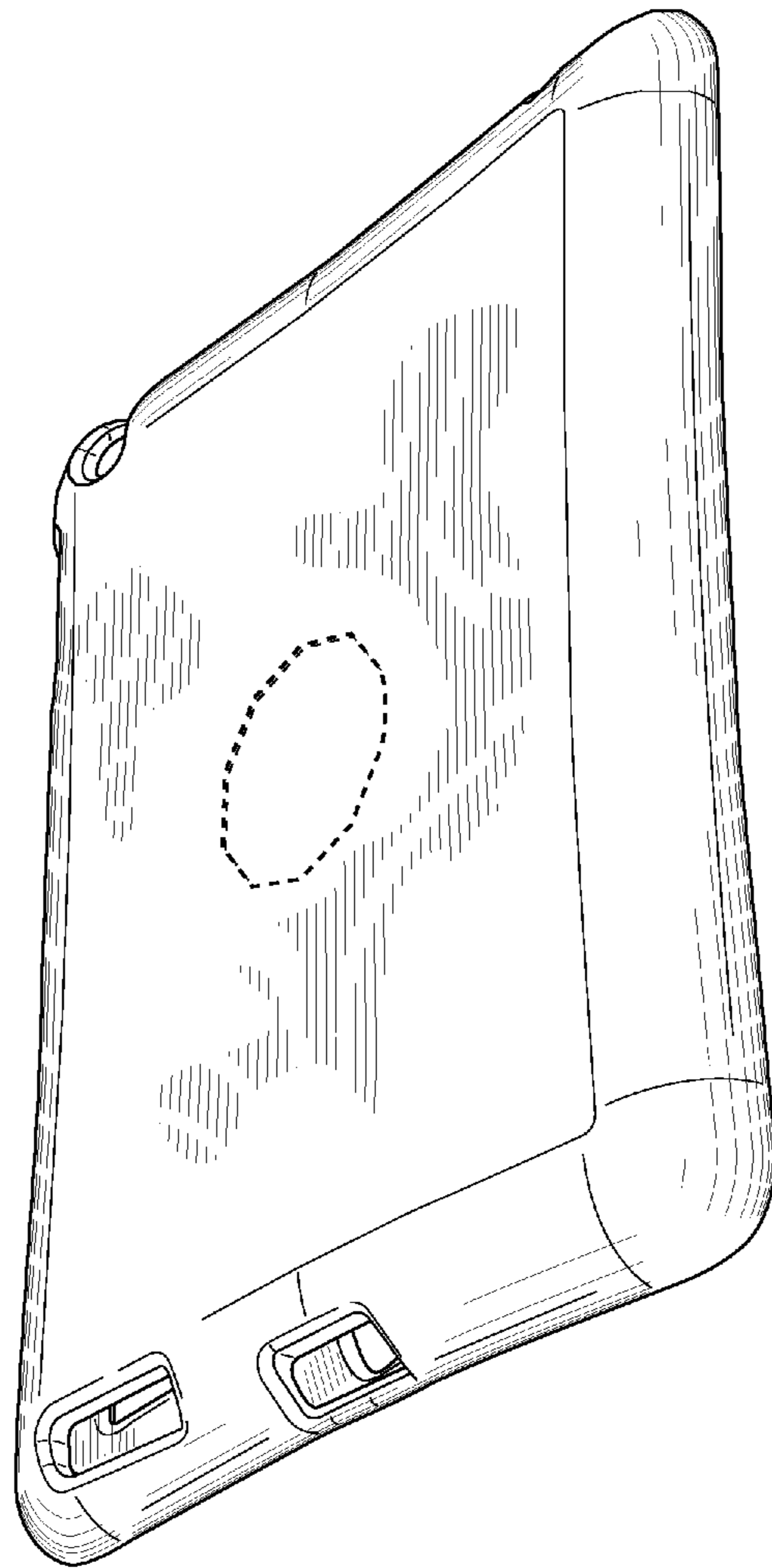

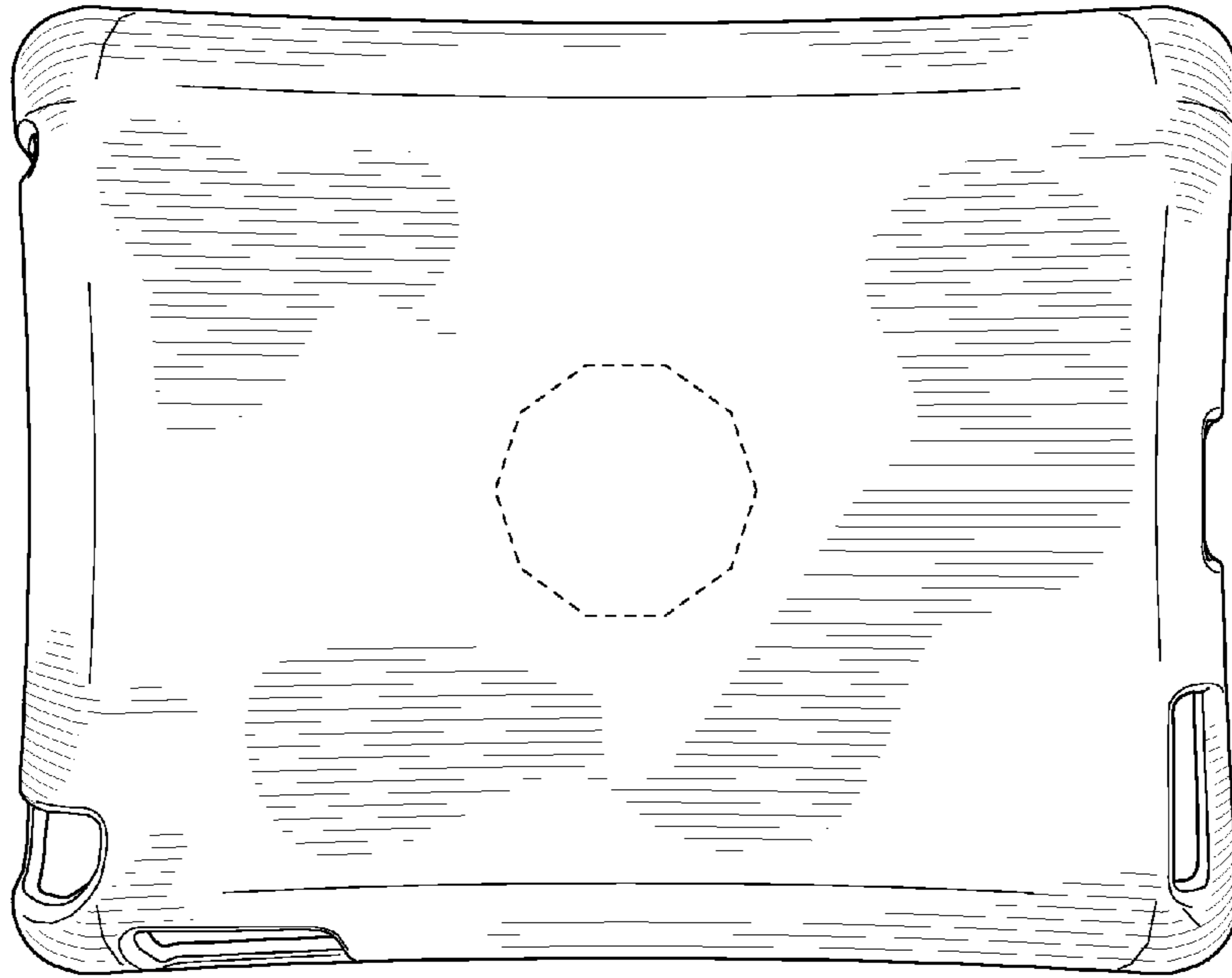

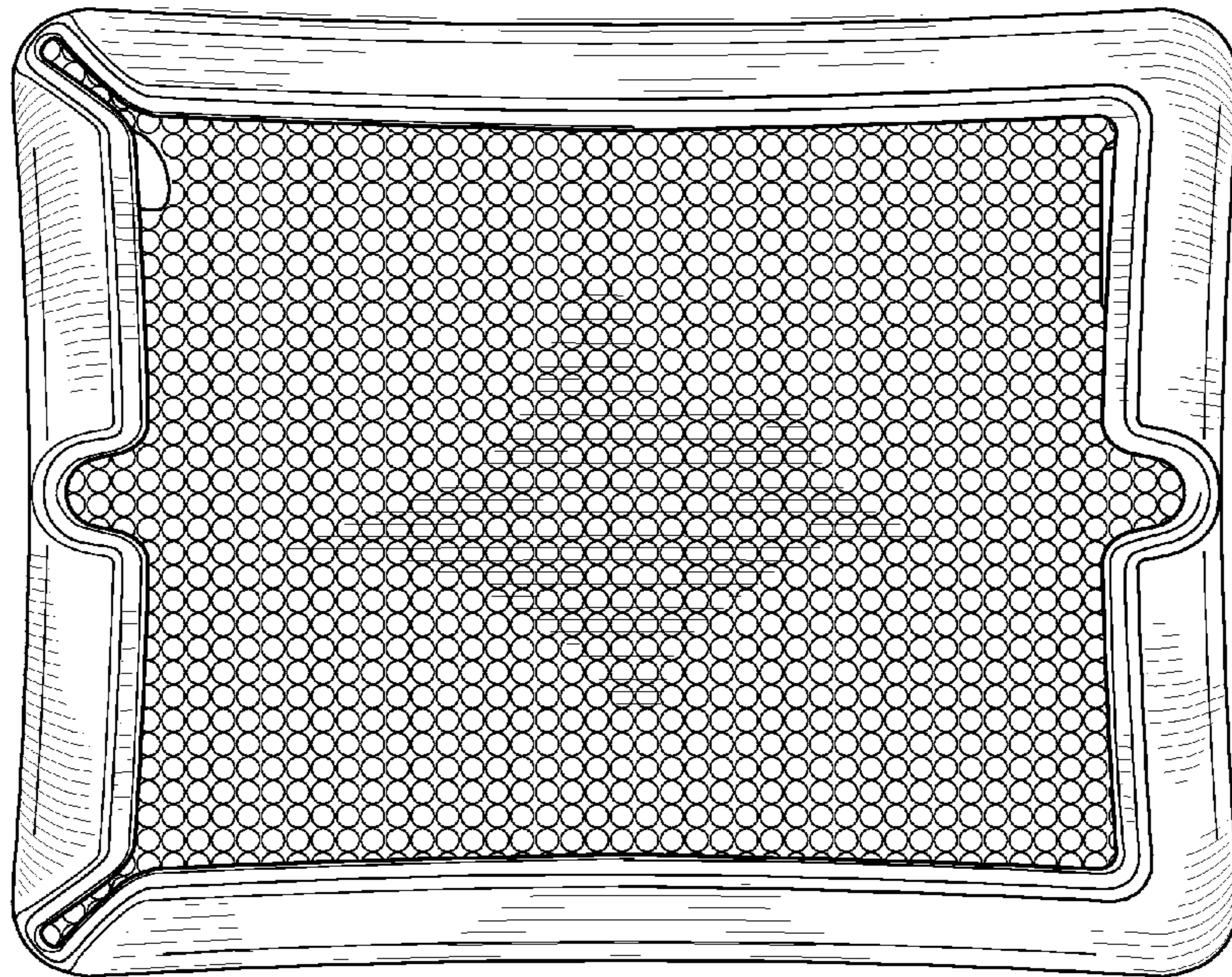

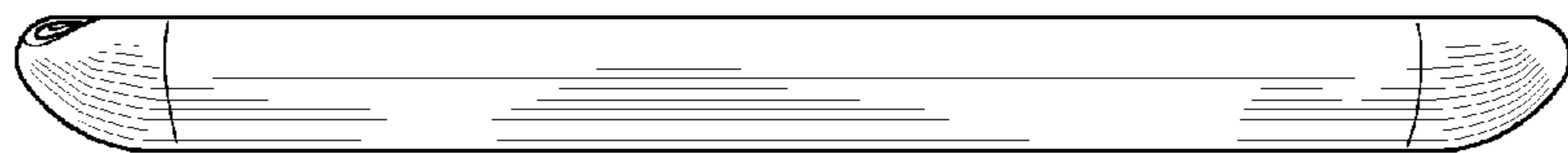

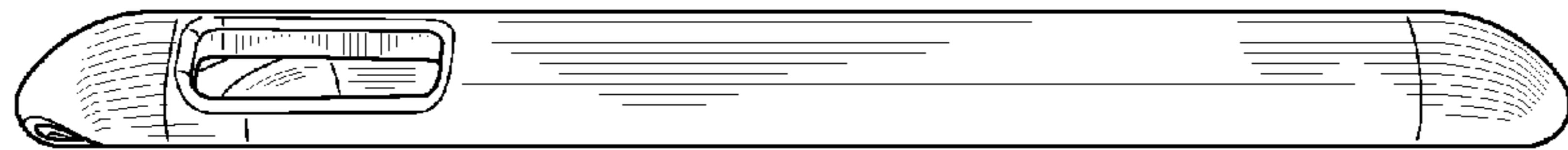

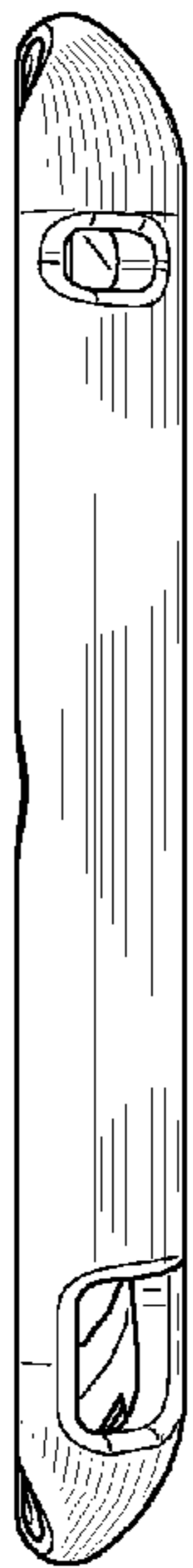

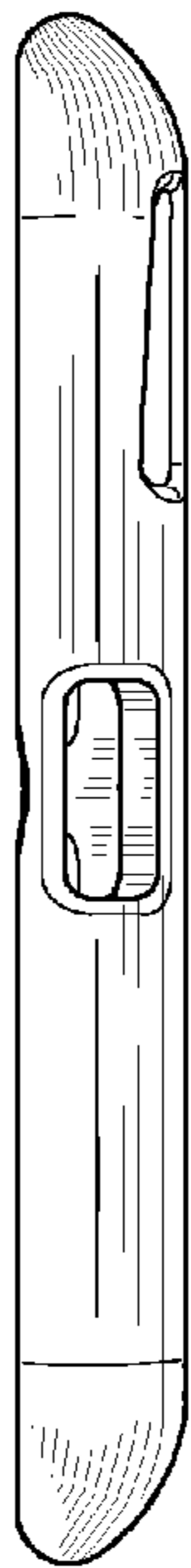
