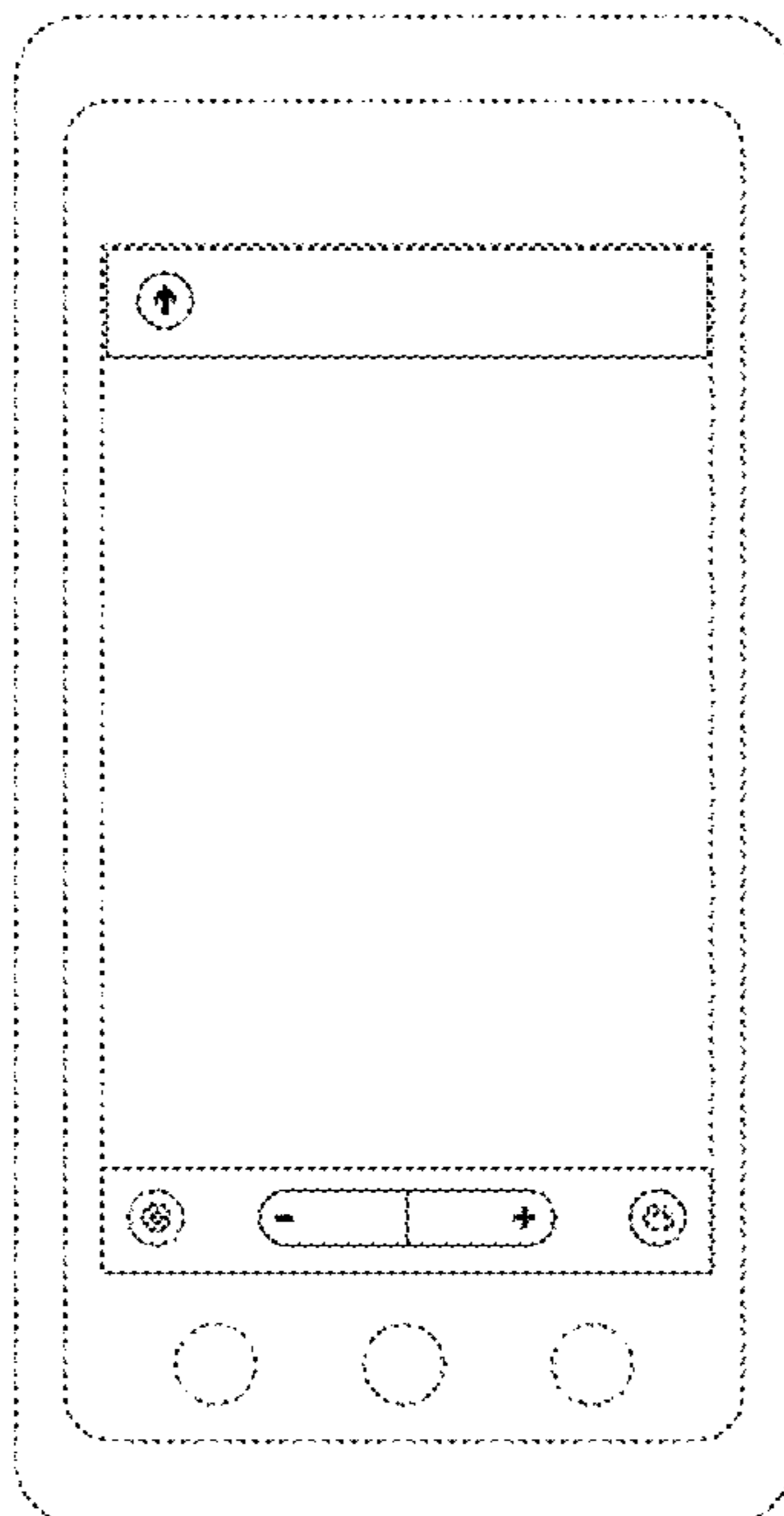
(57) **CLAIM**

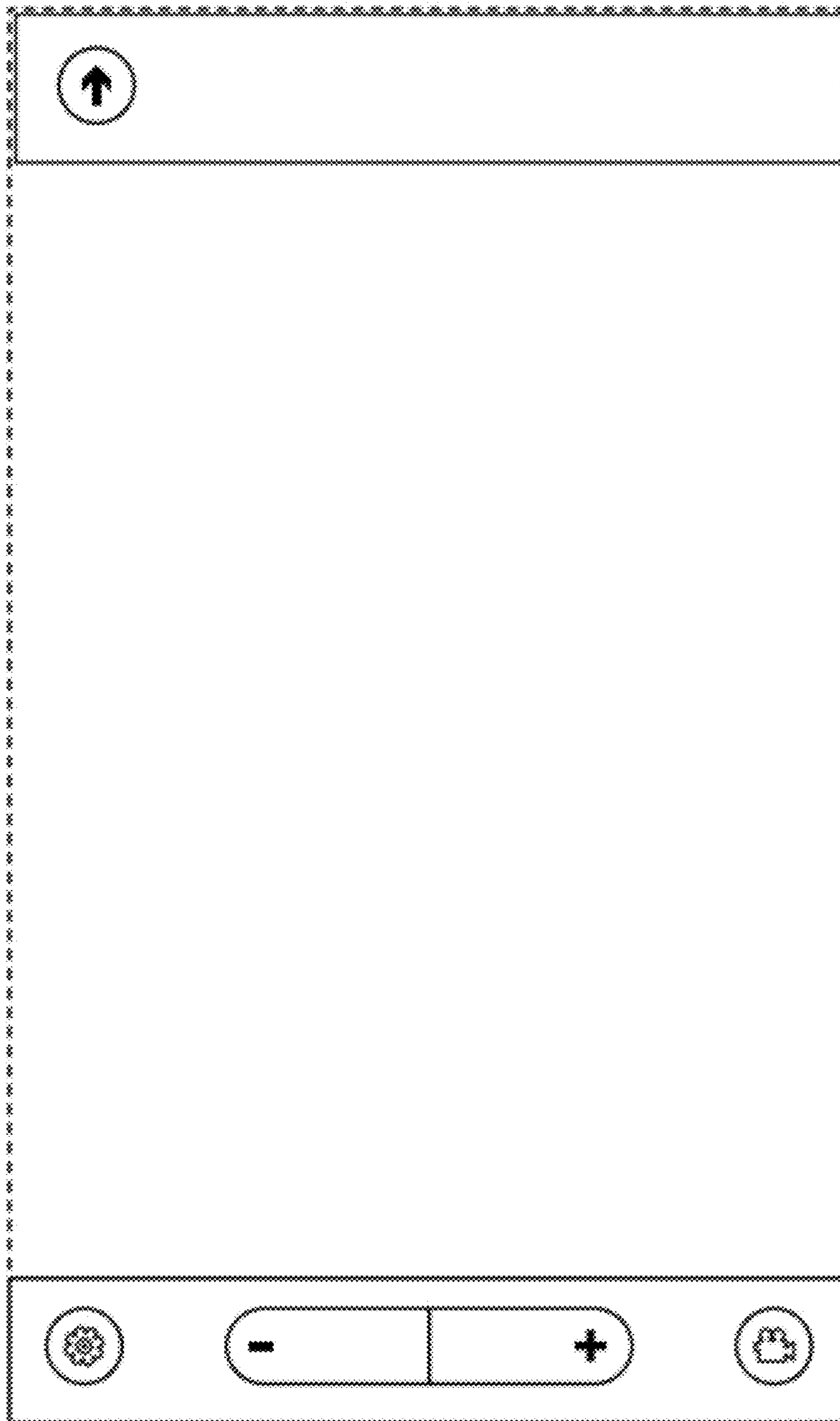

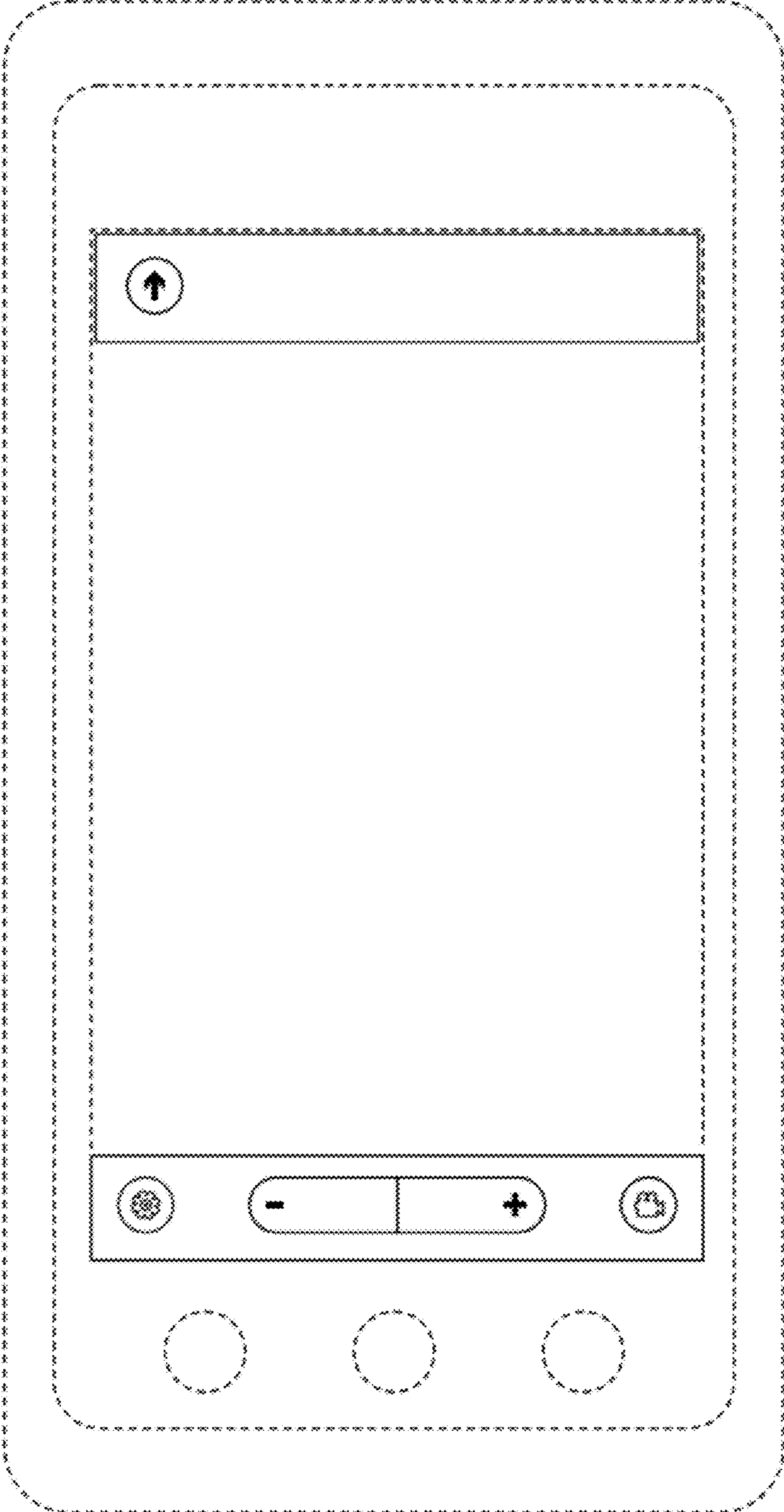

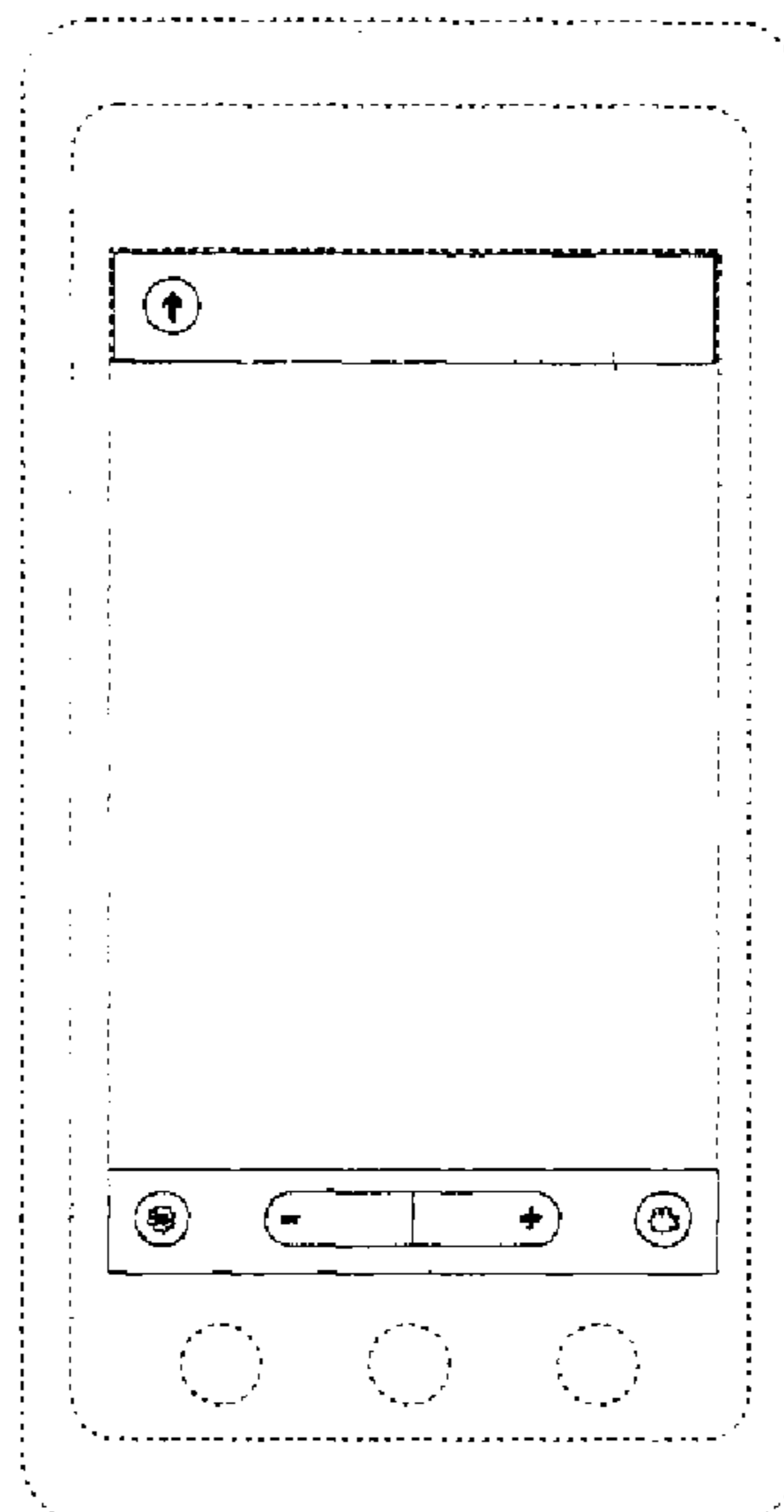
(57) **CLAIM**

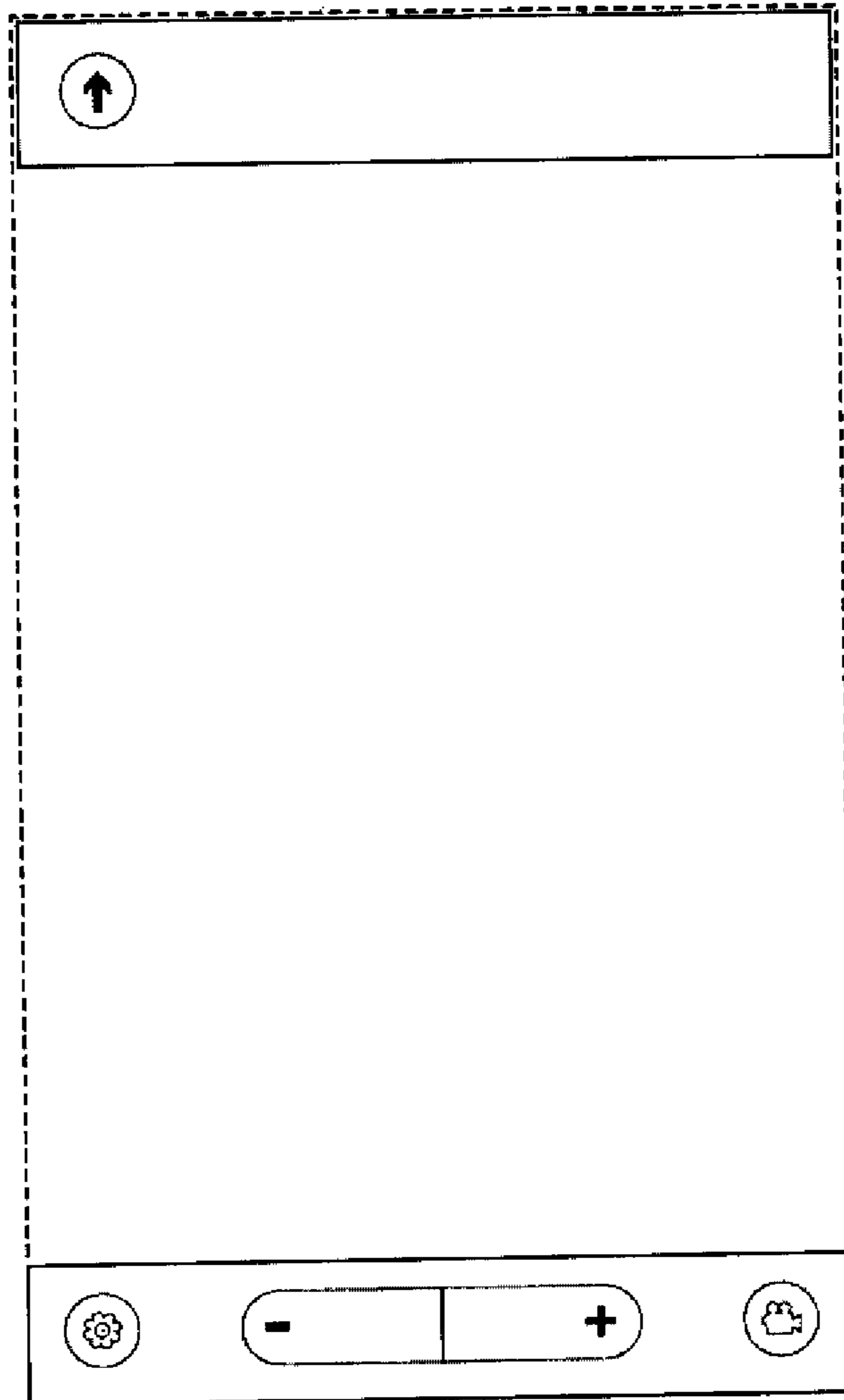

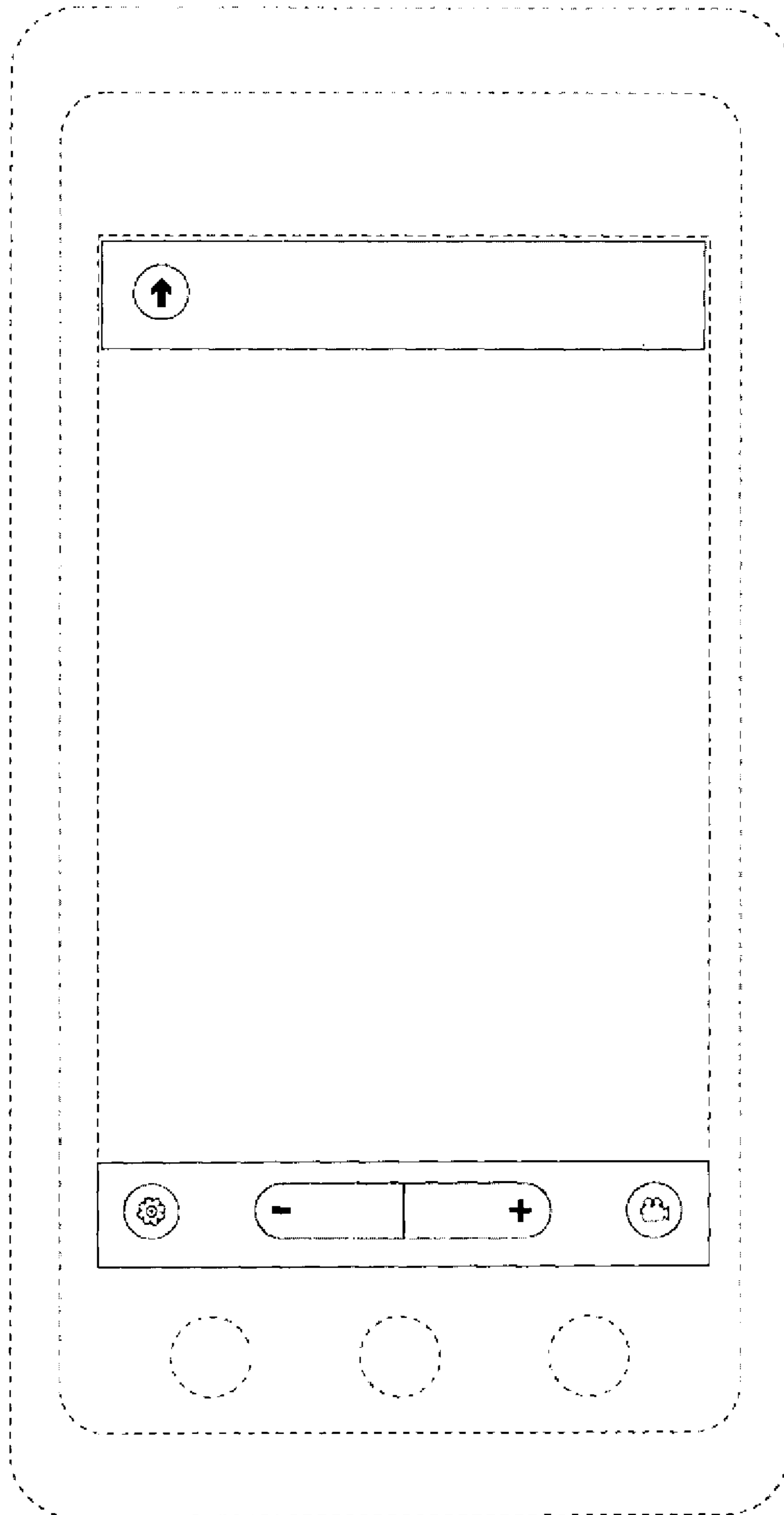
