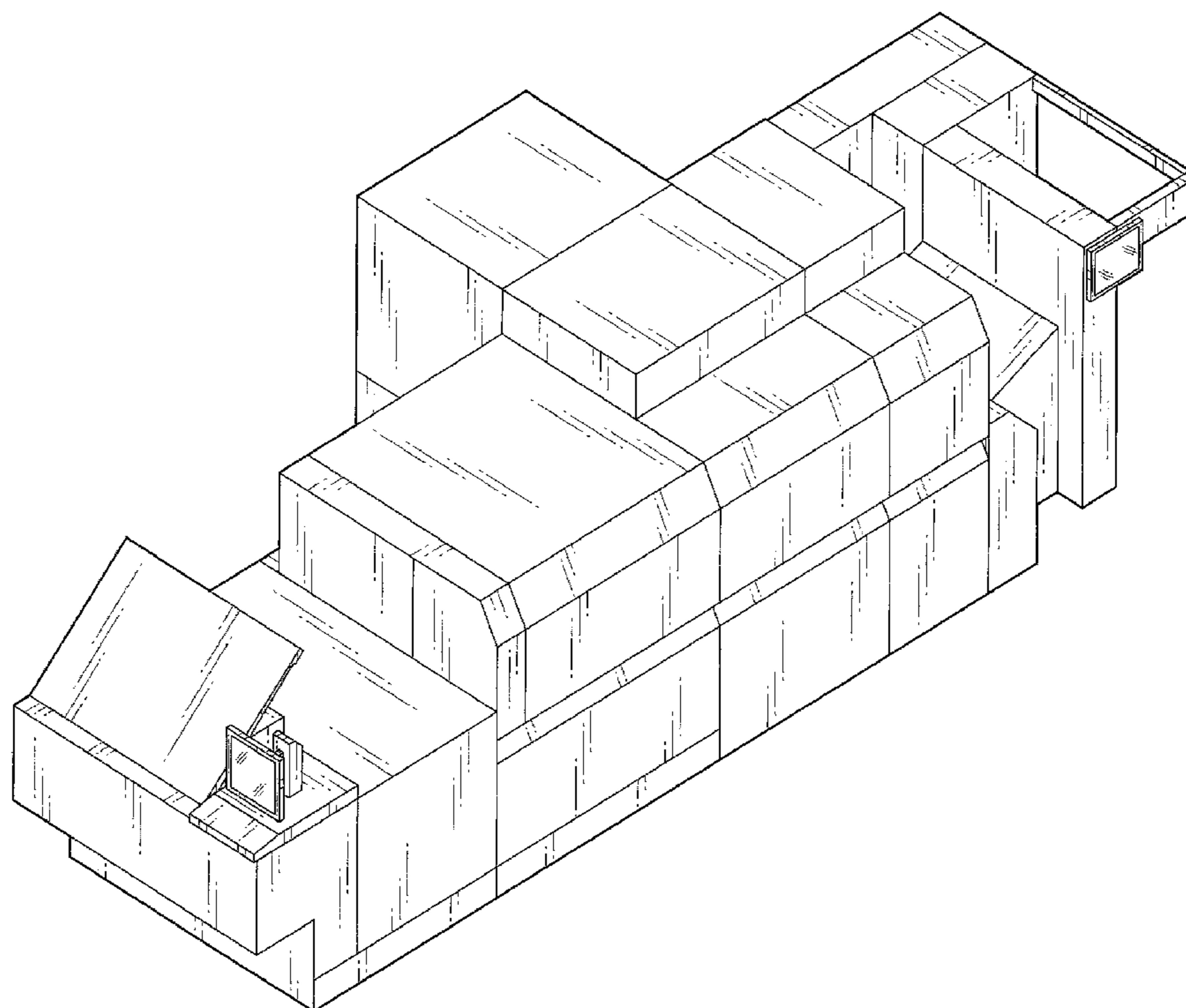
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front and side perspective view seen from left side of a printer showing my new design;

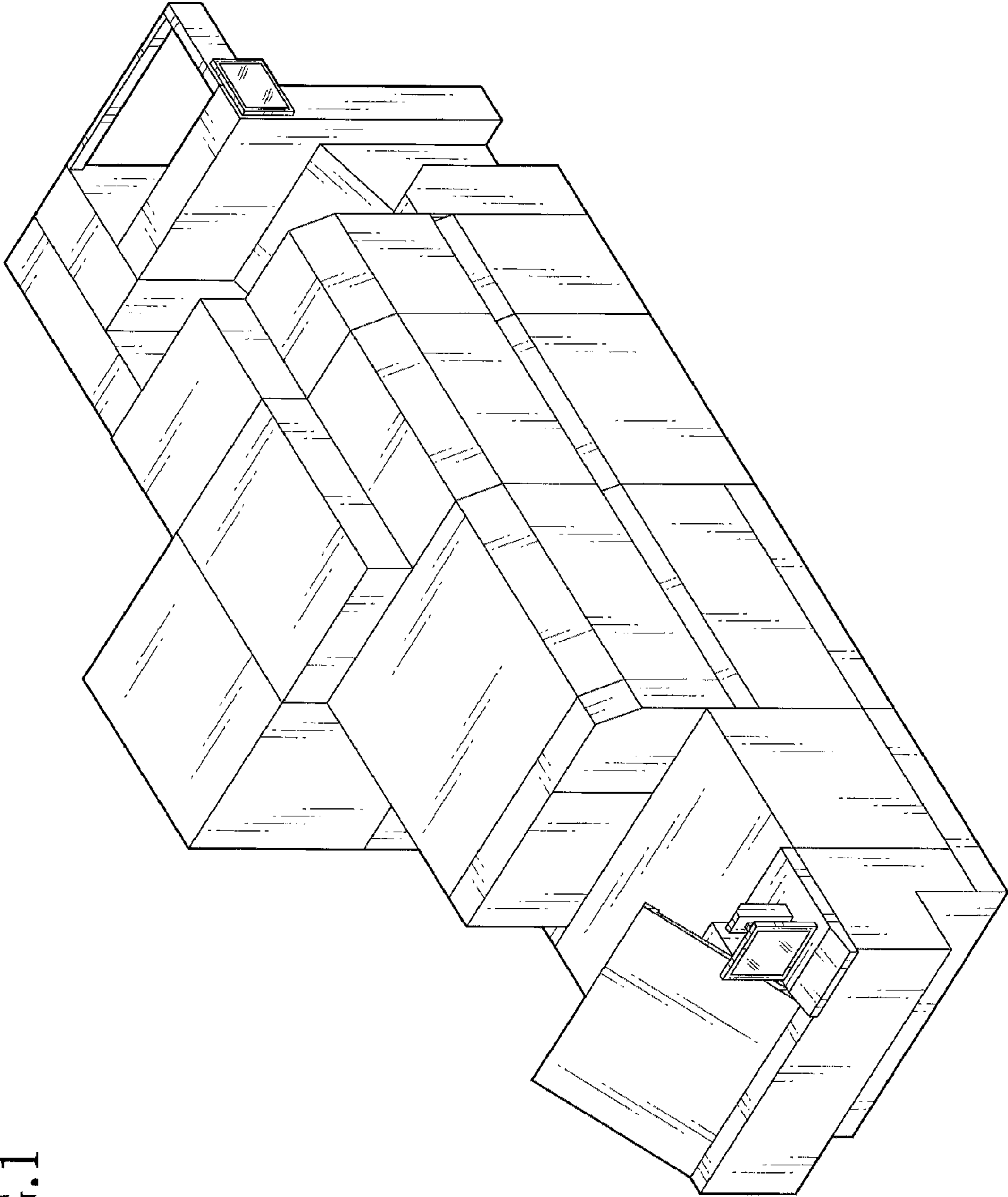

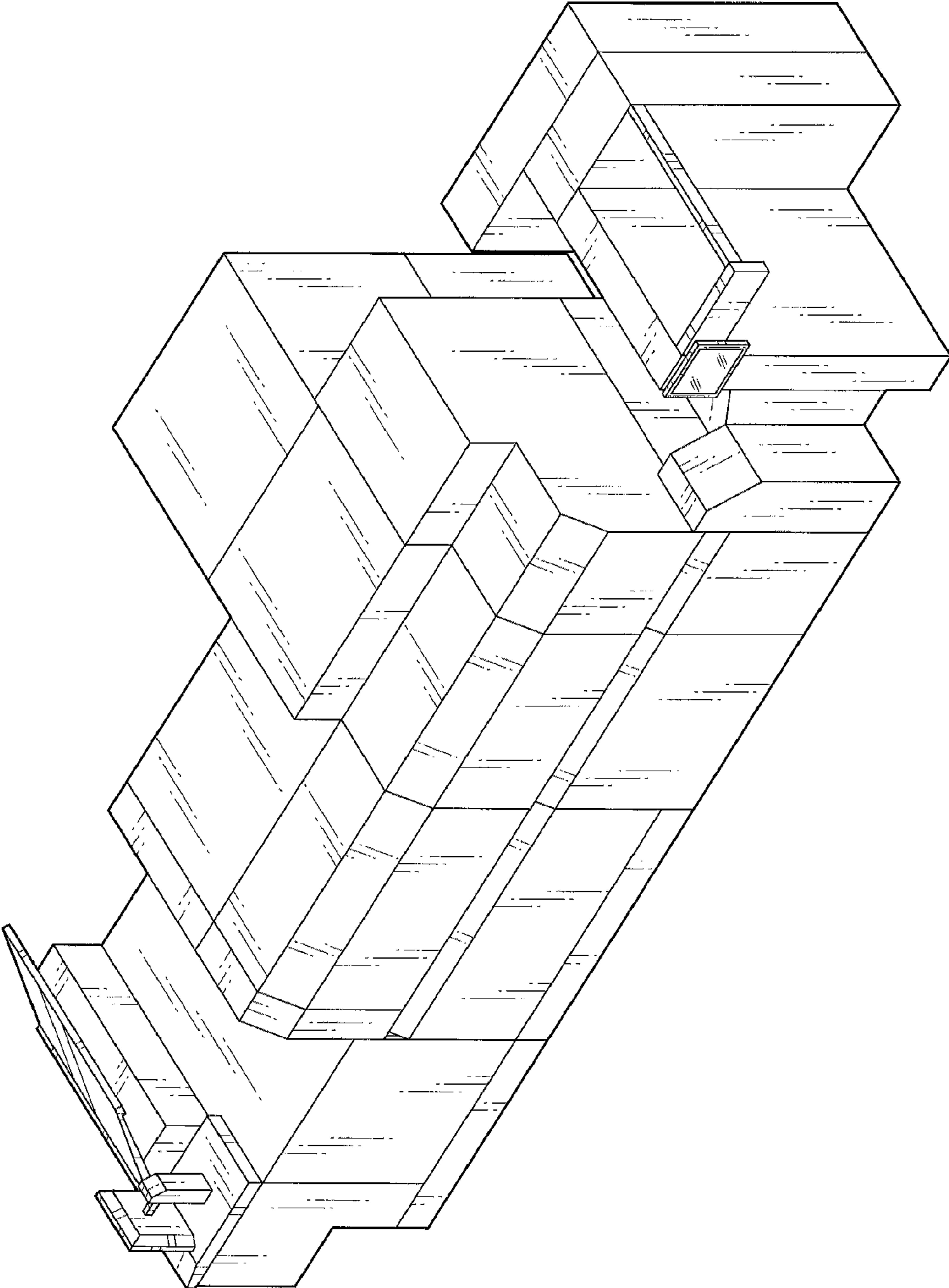

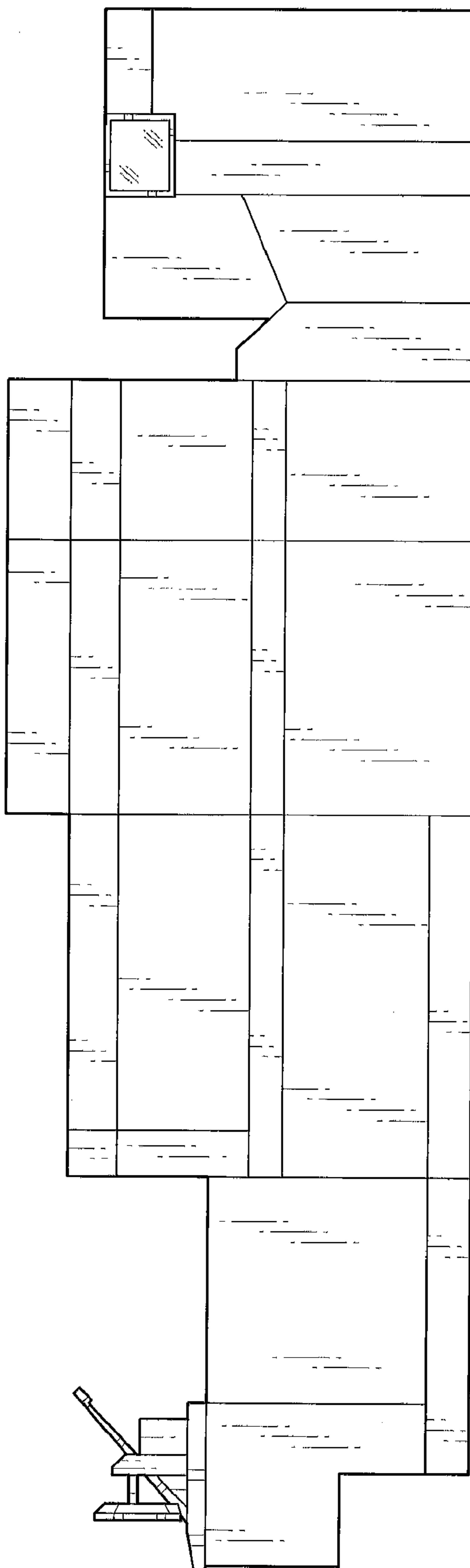

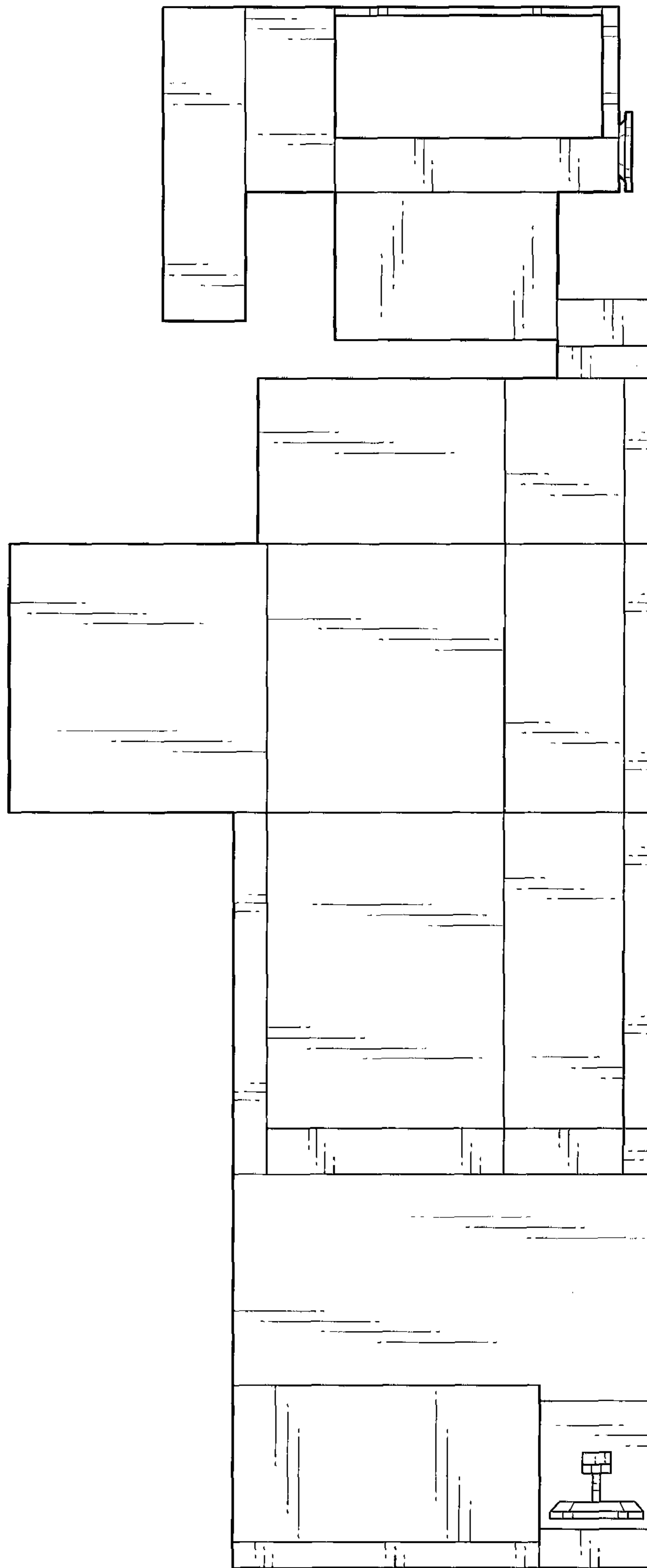

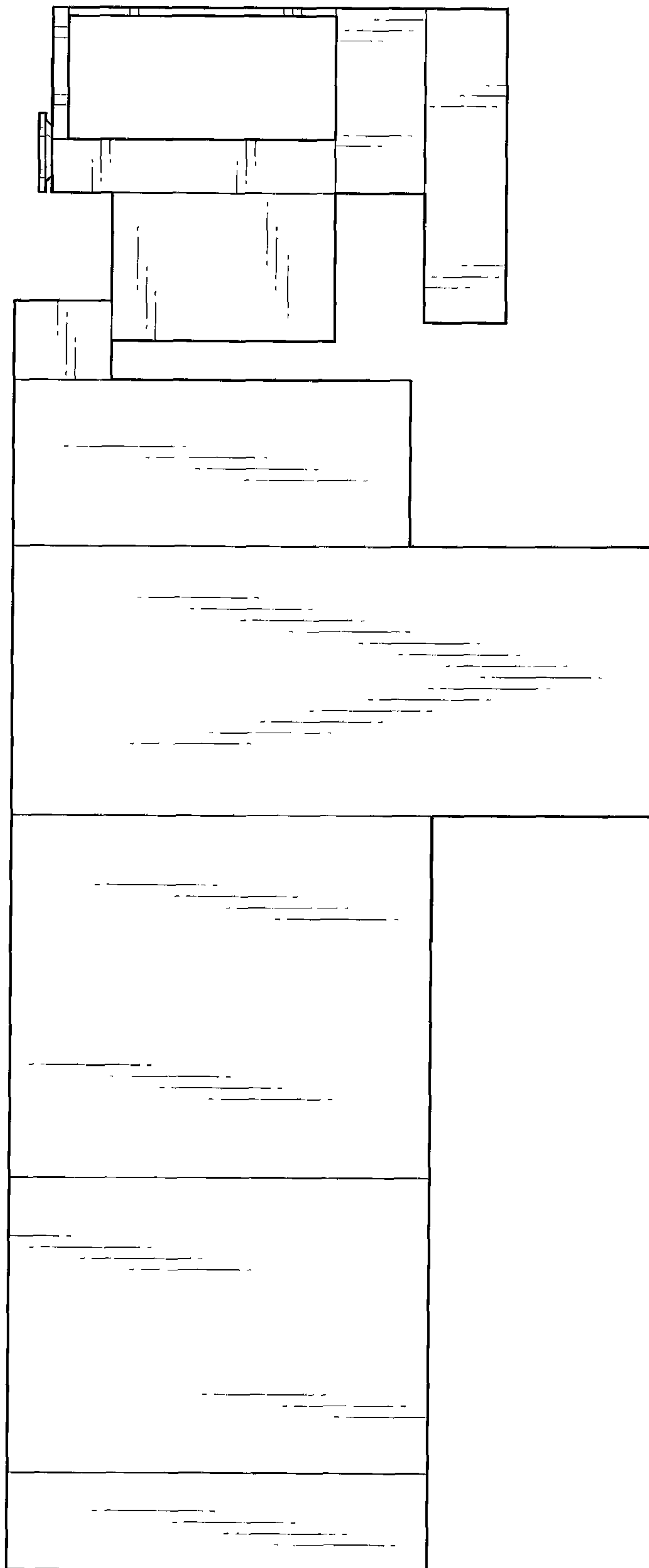

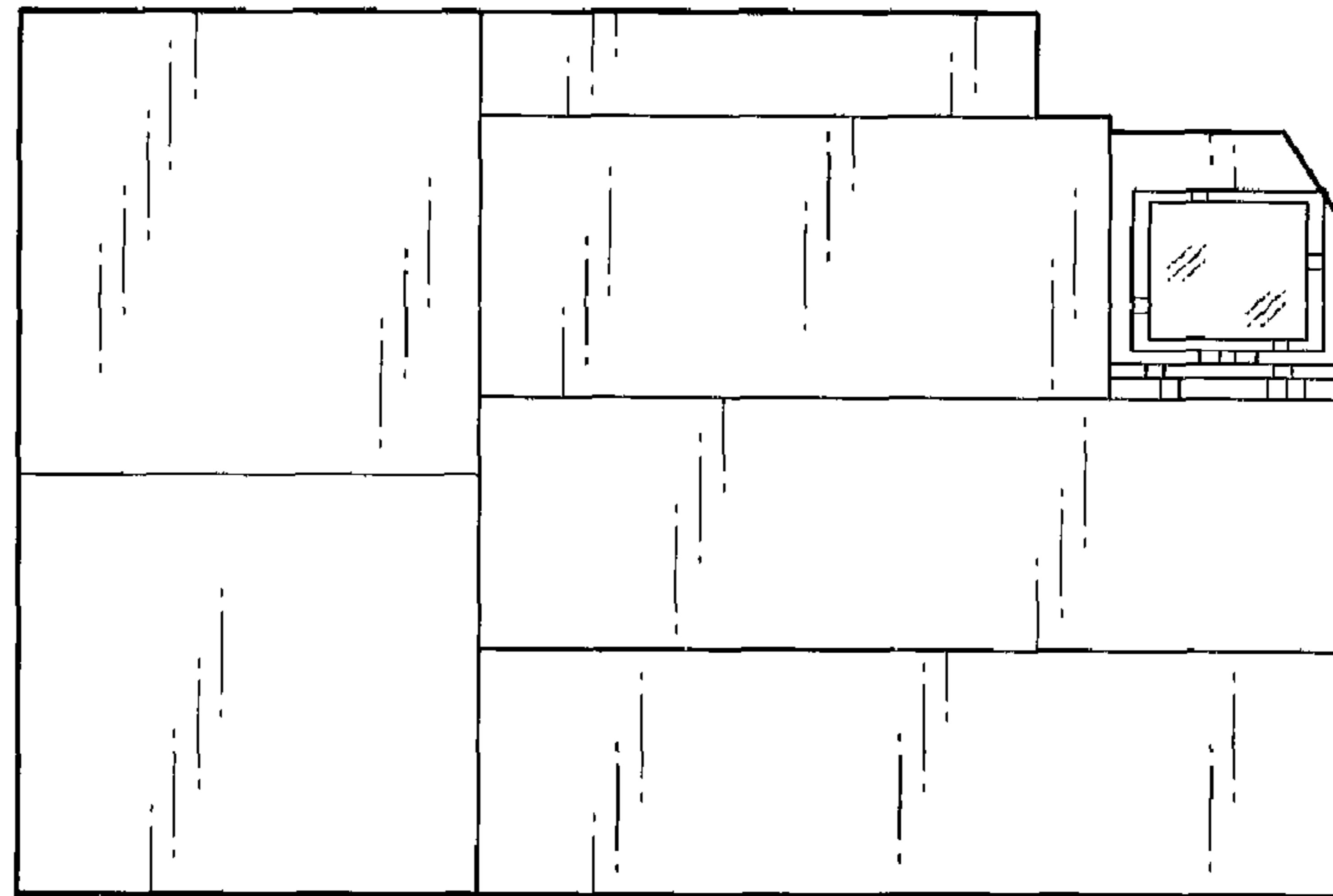
