(57) **CLAIM**

I claim the ornamental design for a cork deck surfboard, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a cork deck surfboard, showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

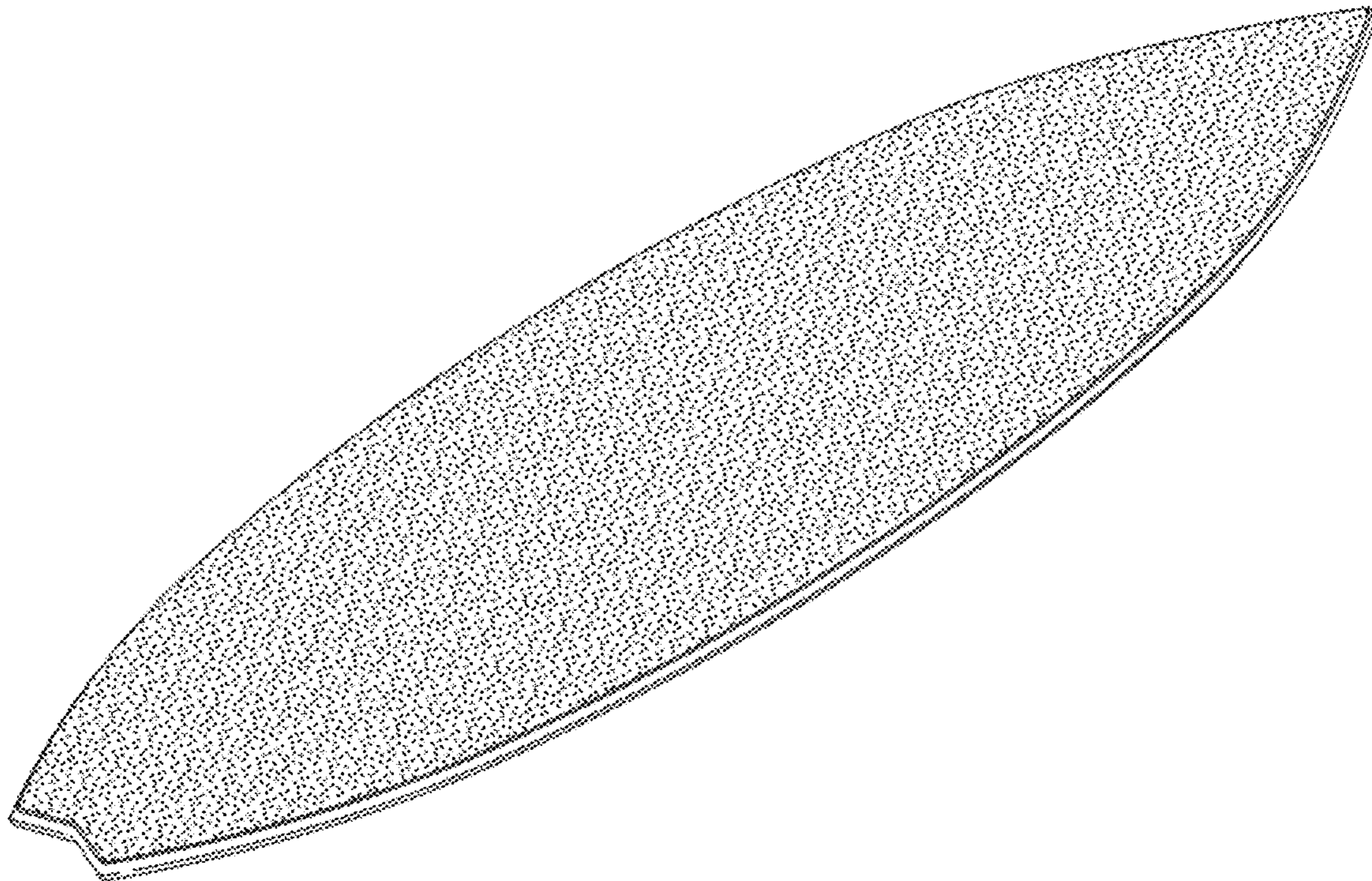
FIG. 4 is a right-side elevational view thereof, the left-side elevational view being a mirror image thereof;

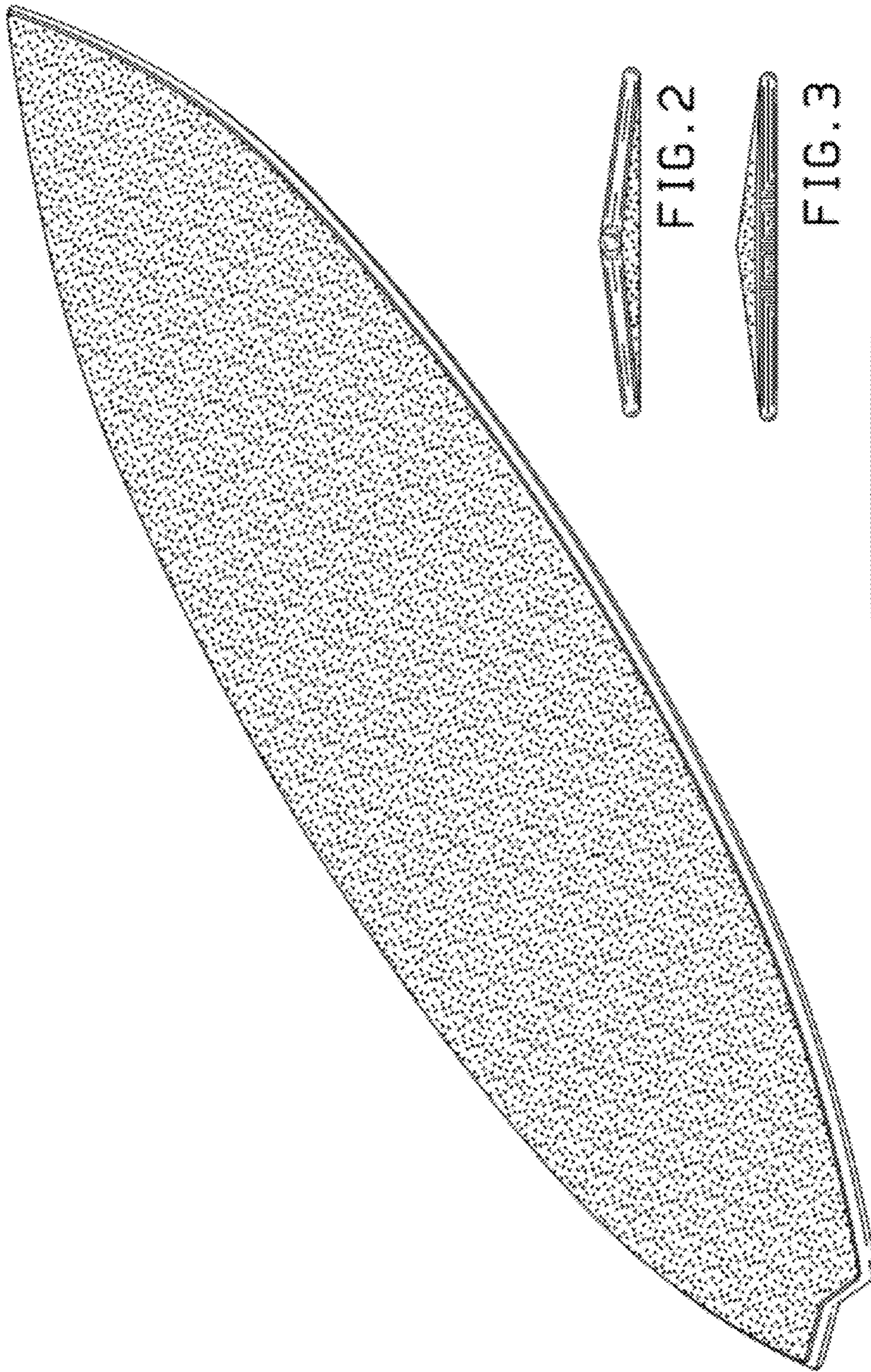

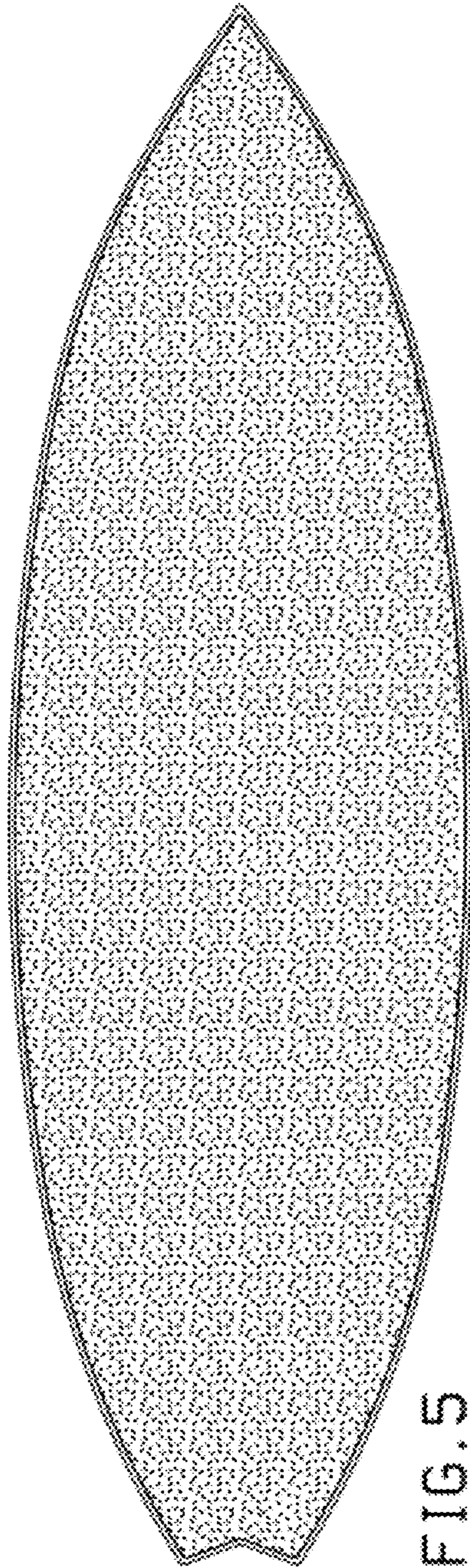

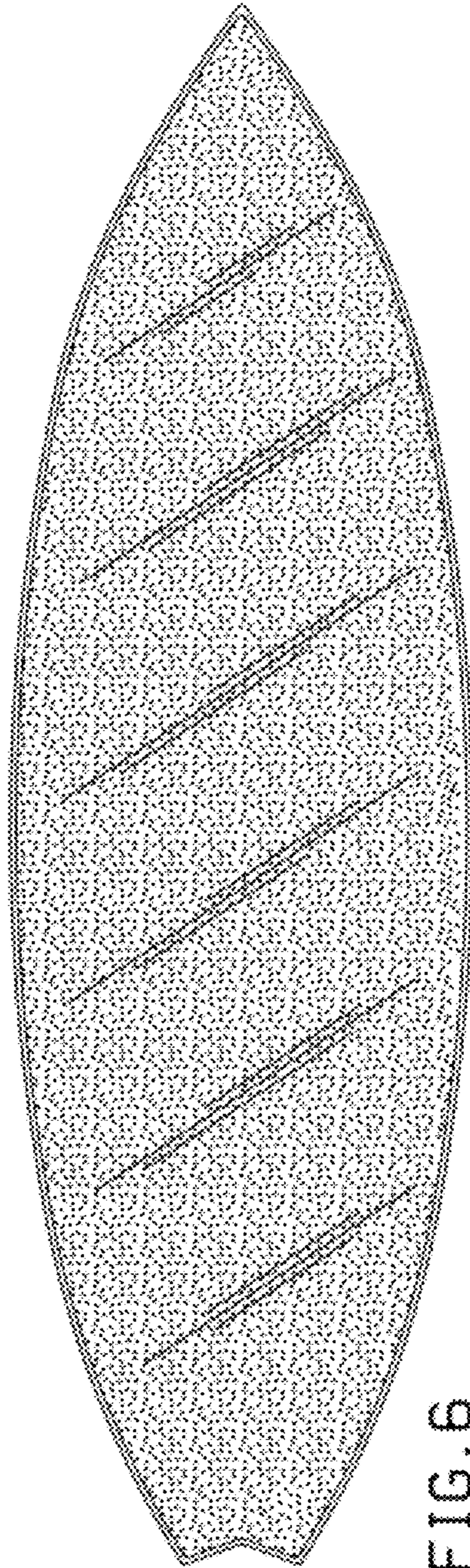
