(57) **CLAIM**

What is claimed is the ornamental design for the climbing wall, as shown.

**DESCRIPTION**

FIG. 1 shows a left side view of a climbing wall embodying the inventive design.

FIG. 2 shows a right side view of a climbing wall embodying the inventive design.

FIG. 3 shows a front side view of a climbing wall embodying the inventive design.

FIG. 4 shows a rear view of a climbing wall embodying the inventive design.

FIG. 5 shows a top view of a climbing wall embodying the inventive design.

FIG. 6 shows a bottom view of a climbing wall embodying the inventive design.

FIG. 7 shows a perspective view (from the left) of a climbing wall embodying the inventive design.

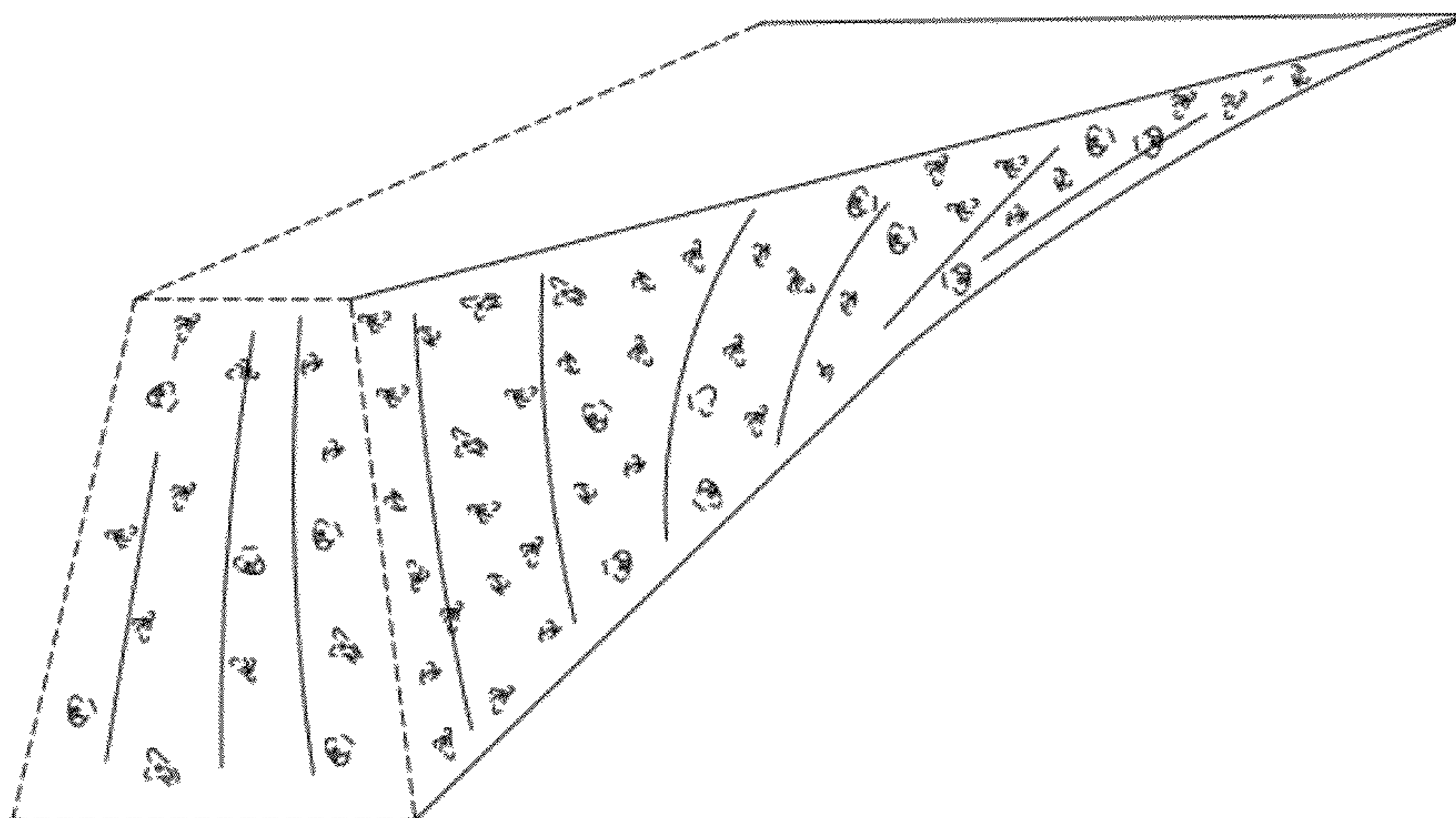
FIG. 8 shows an additional perspective view (from the right) of a climbing wall embodying the inventive design.

FIG. 9 shows another perspective view (from the left) of a climbing wall embodying the inventive design; and,

FIG. 10 shows another perspective view (from the right) of a climbing wall embodying the inventive design.

The design is embodied in an artificial climbing wall, whether for bouldering or roped climbing.

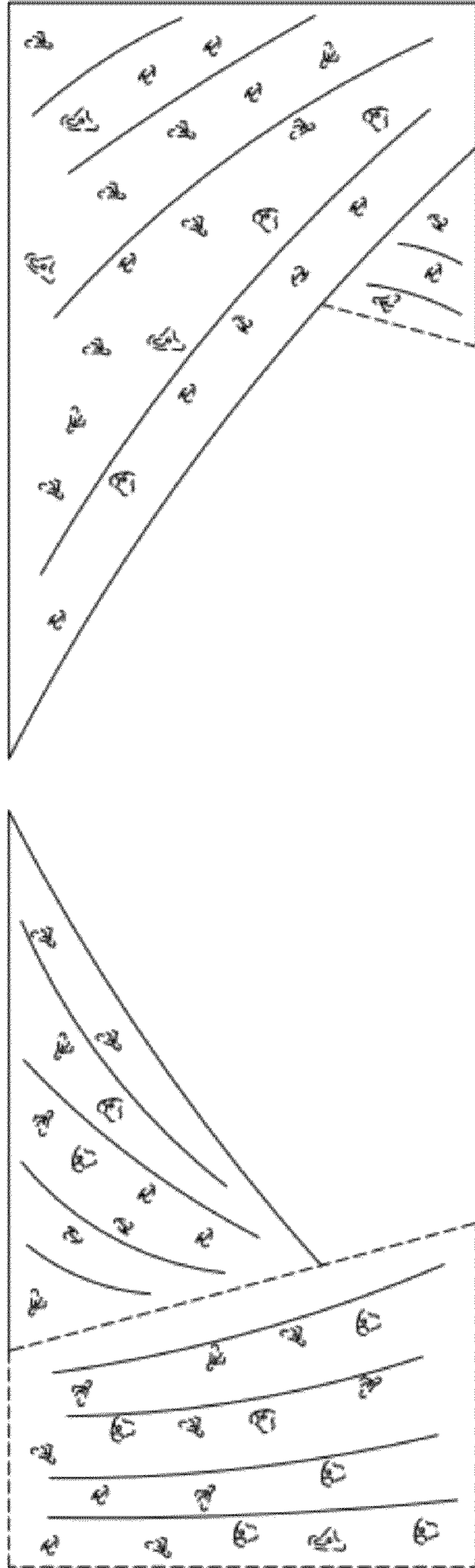

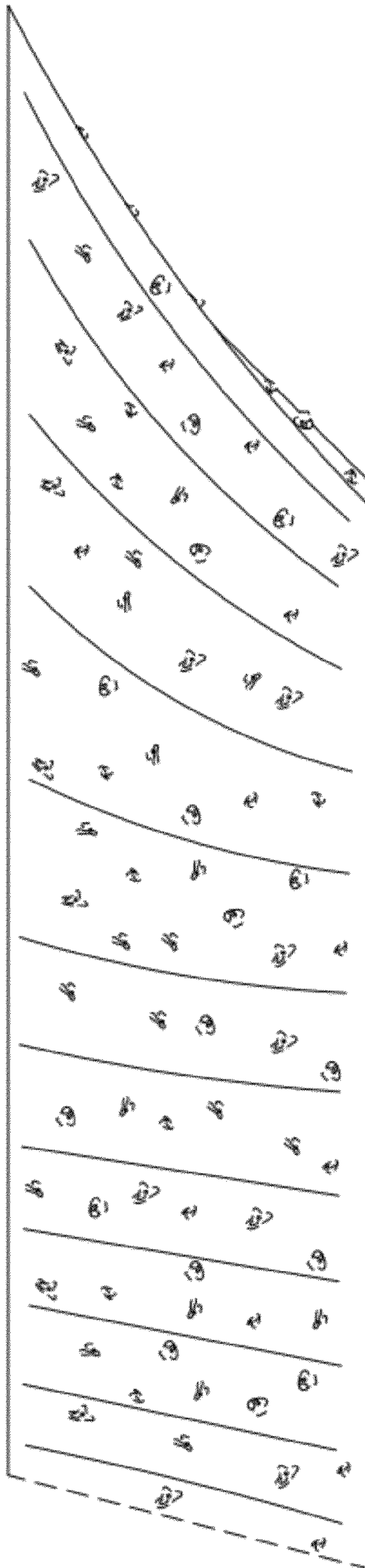

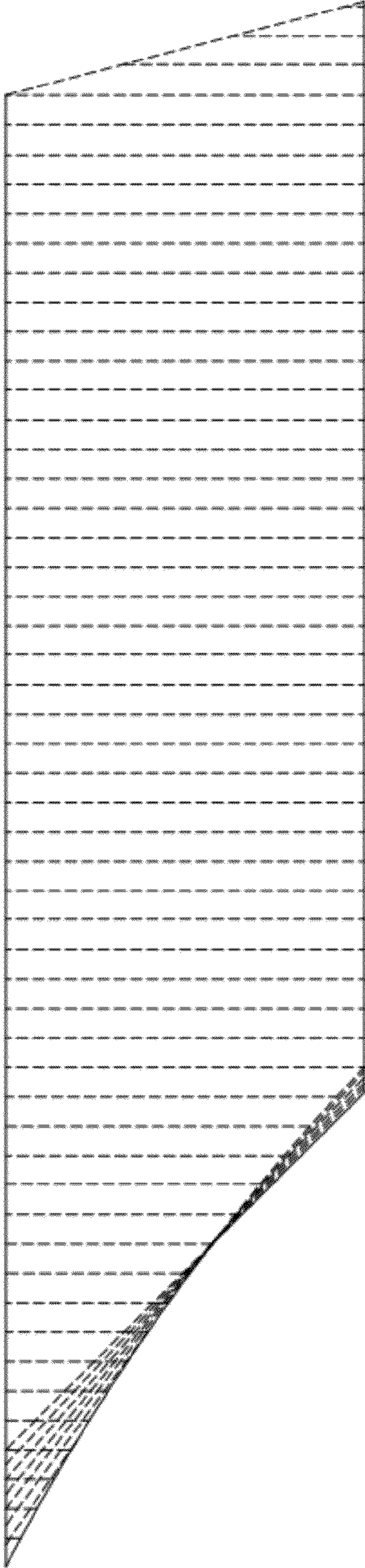

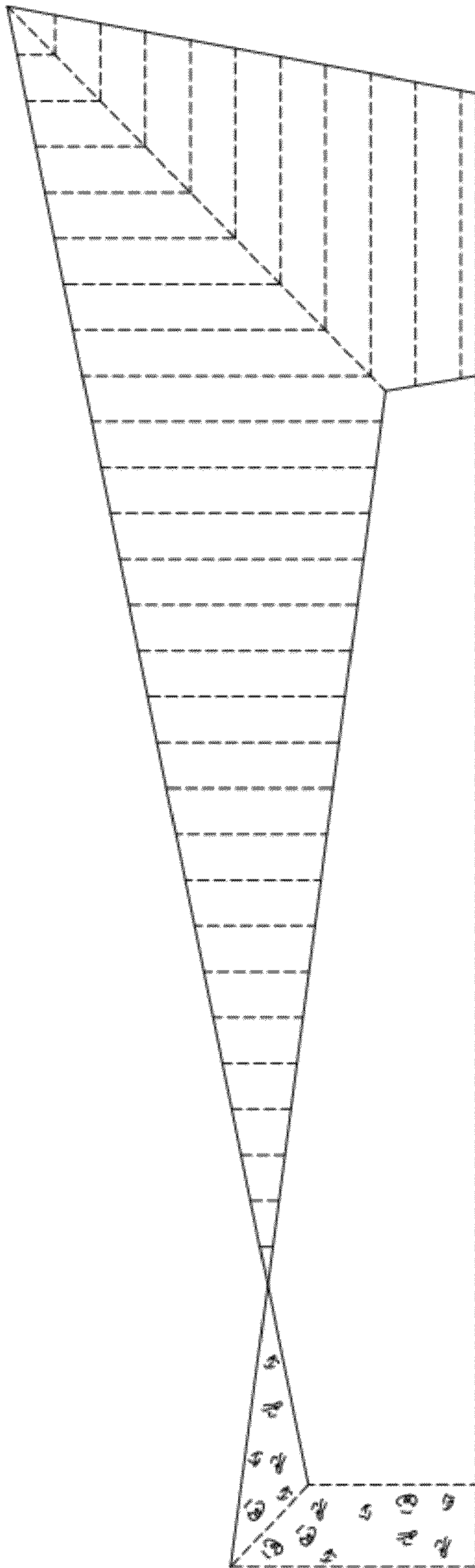

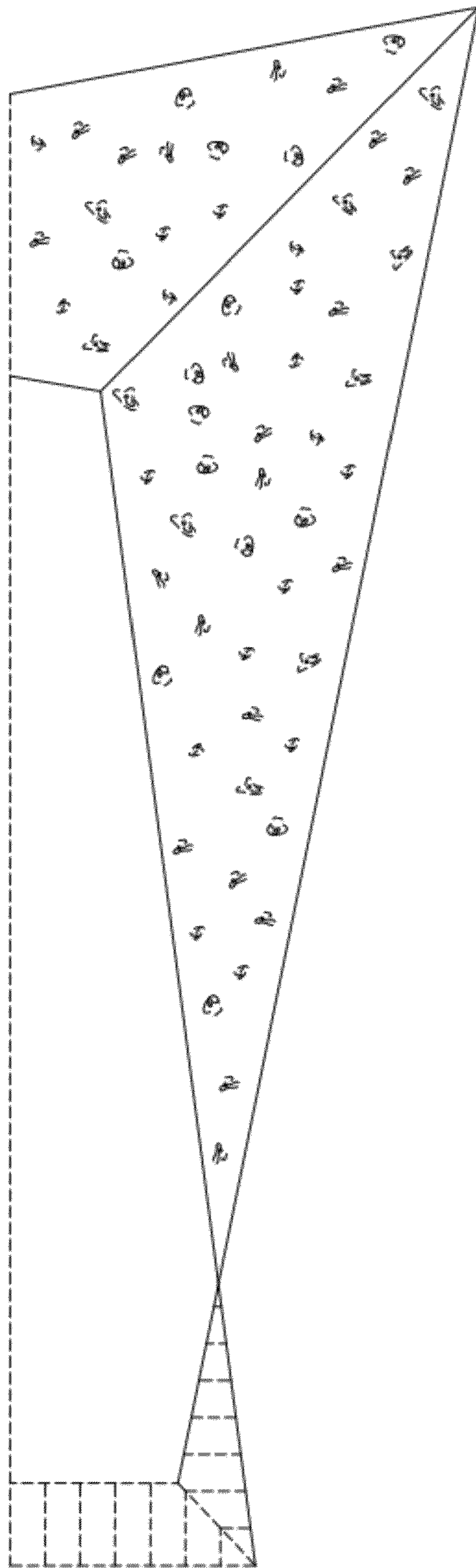

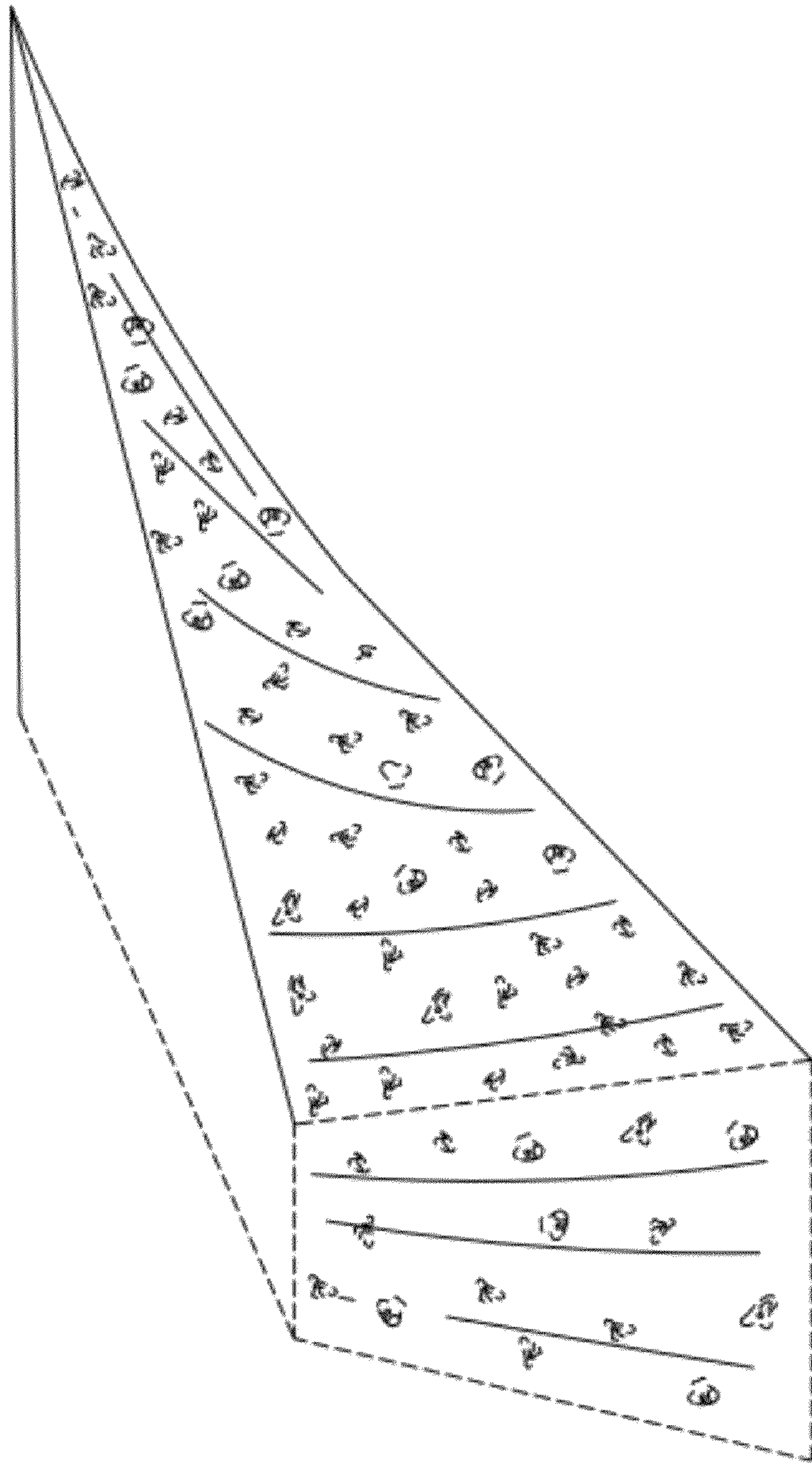

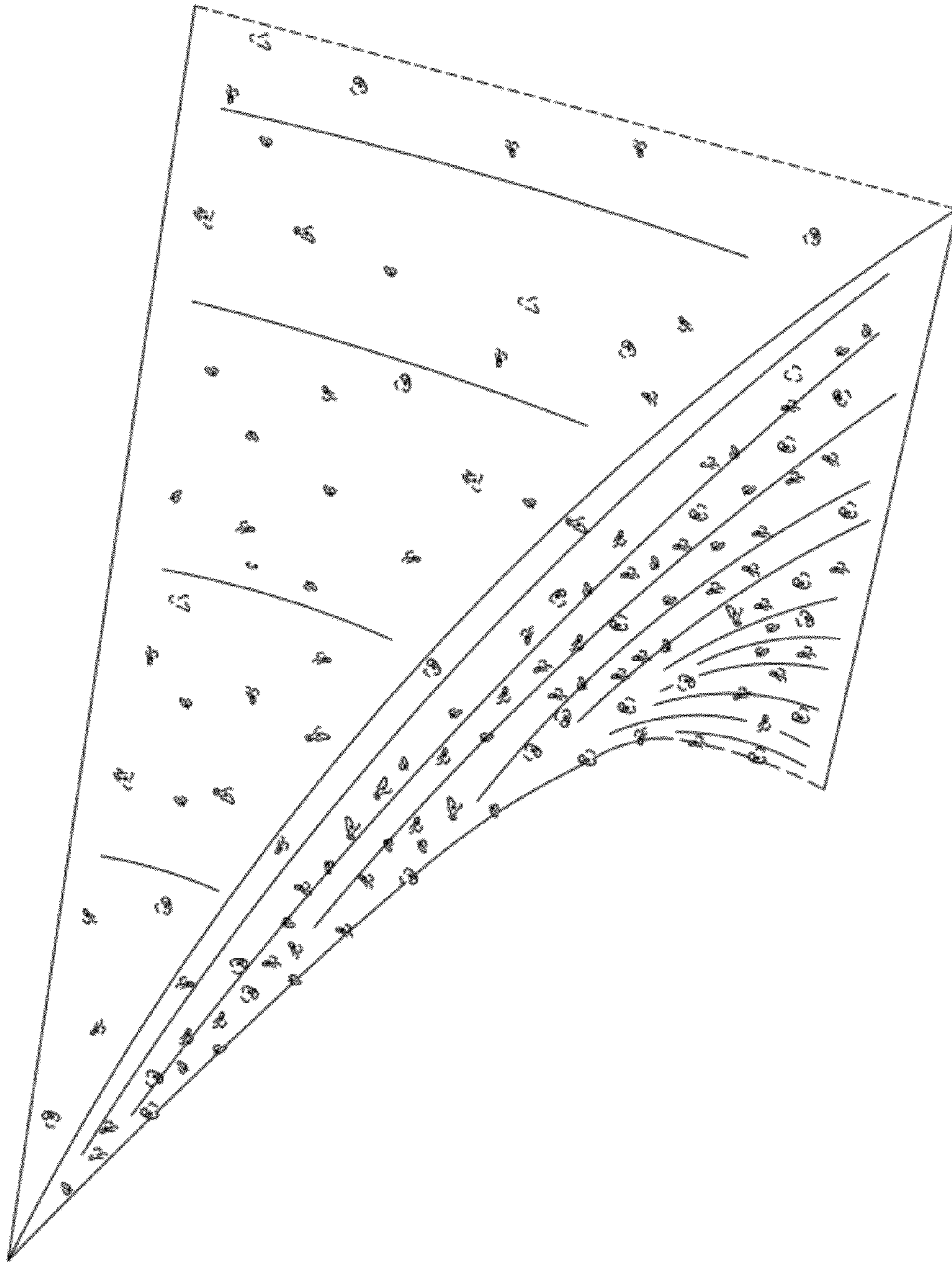

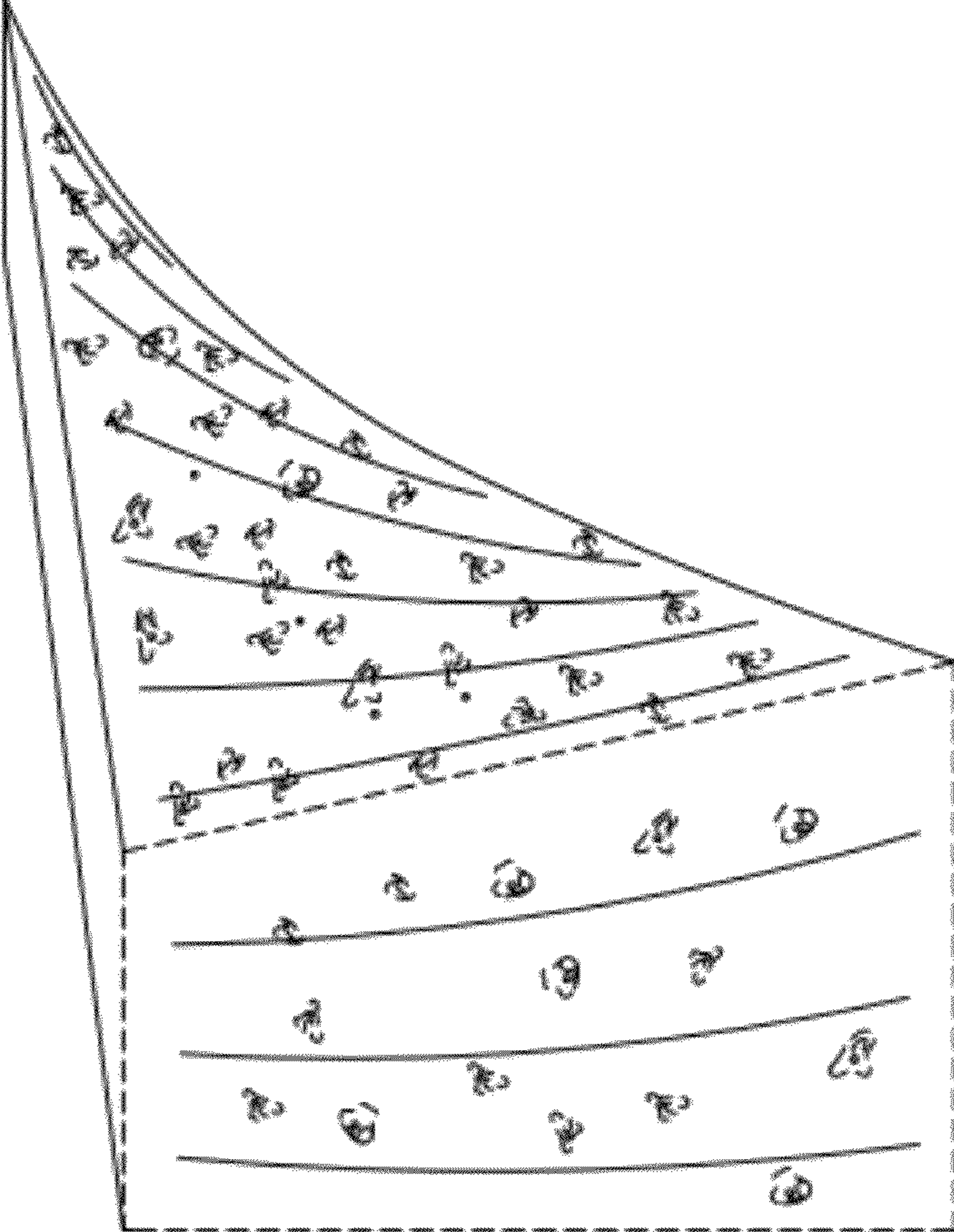

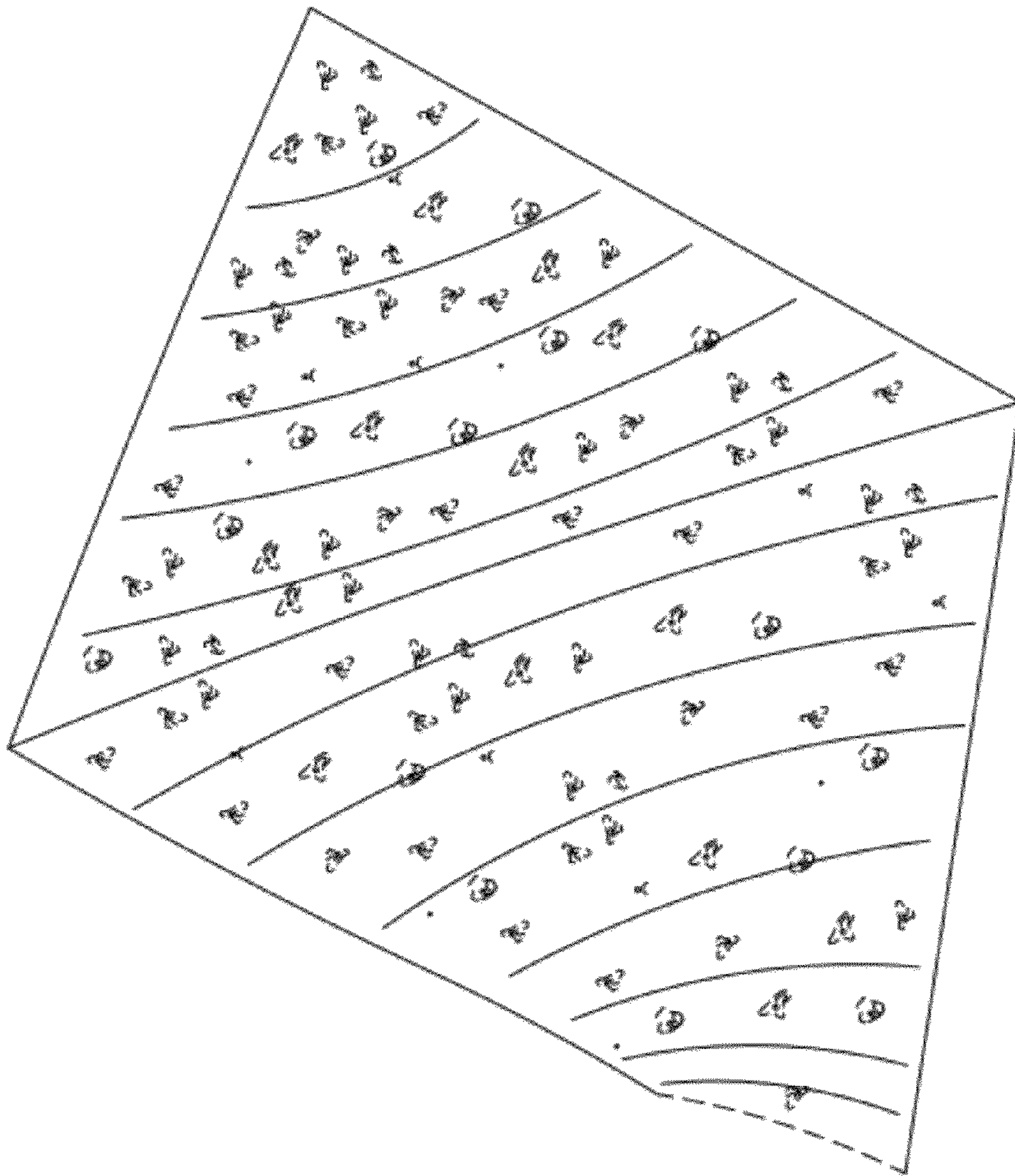
