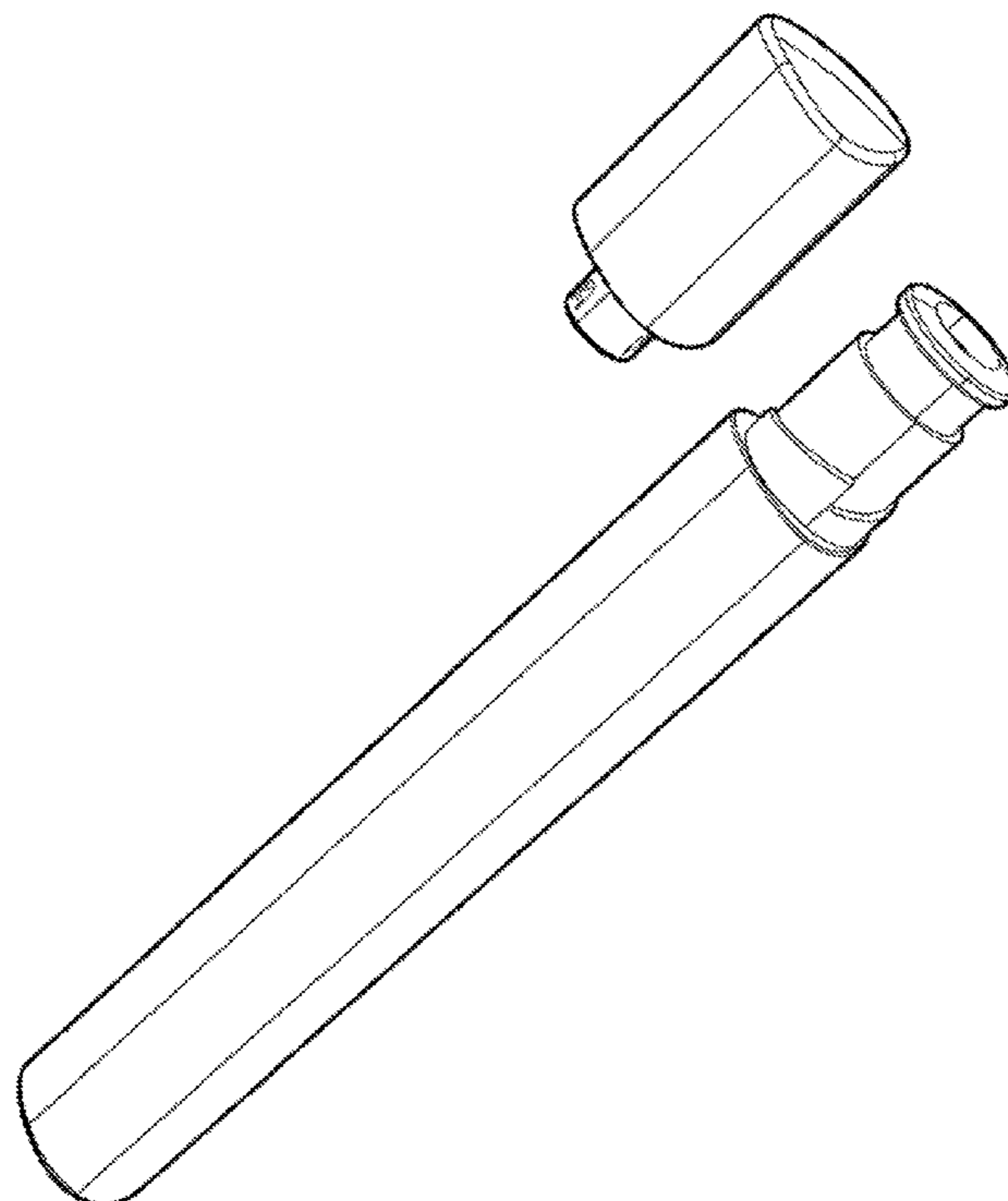
(57) **CLAIM**

The ornamental design for an injector, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of an assembled injector showing my new design;
 FIG. 2 is a side perspective view thereof;
 FIG. 3 is a side elevational view of an unextended first part of a disassembled injector showing my new design;
 FIG. 4 is a rotated side elevational view of an extended first part and a second part of a disassembled injector showing my new design;
 FIG. 5 is a side perspective view thereof;
 FIG. 6 is a rotated elevational view thereof;
 FIG. 7 is an enlarged plan view of the first part of an injector showing my new design; and,
 FIG. 8 is an enlarged plan view of the second part of an injector showing my new design.

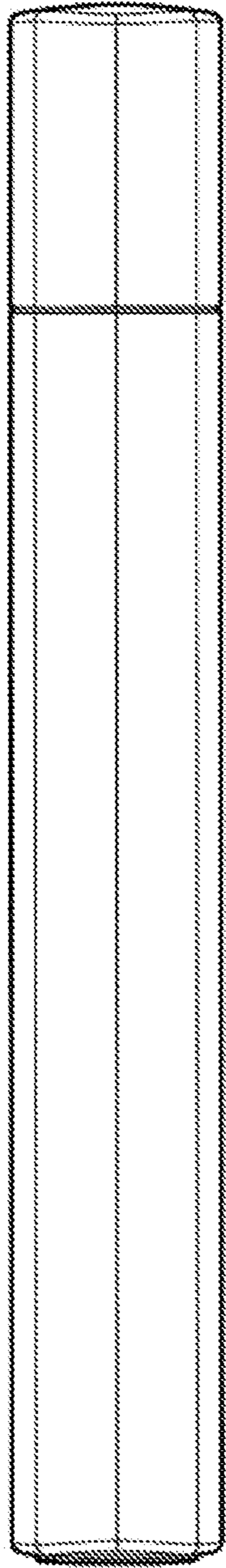

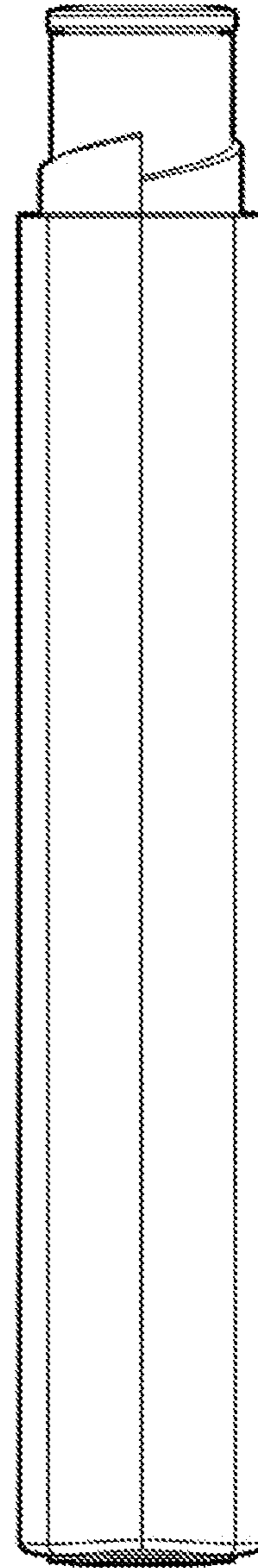

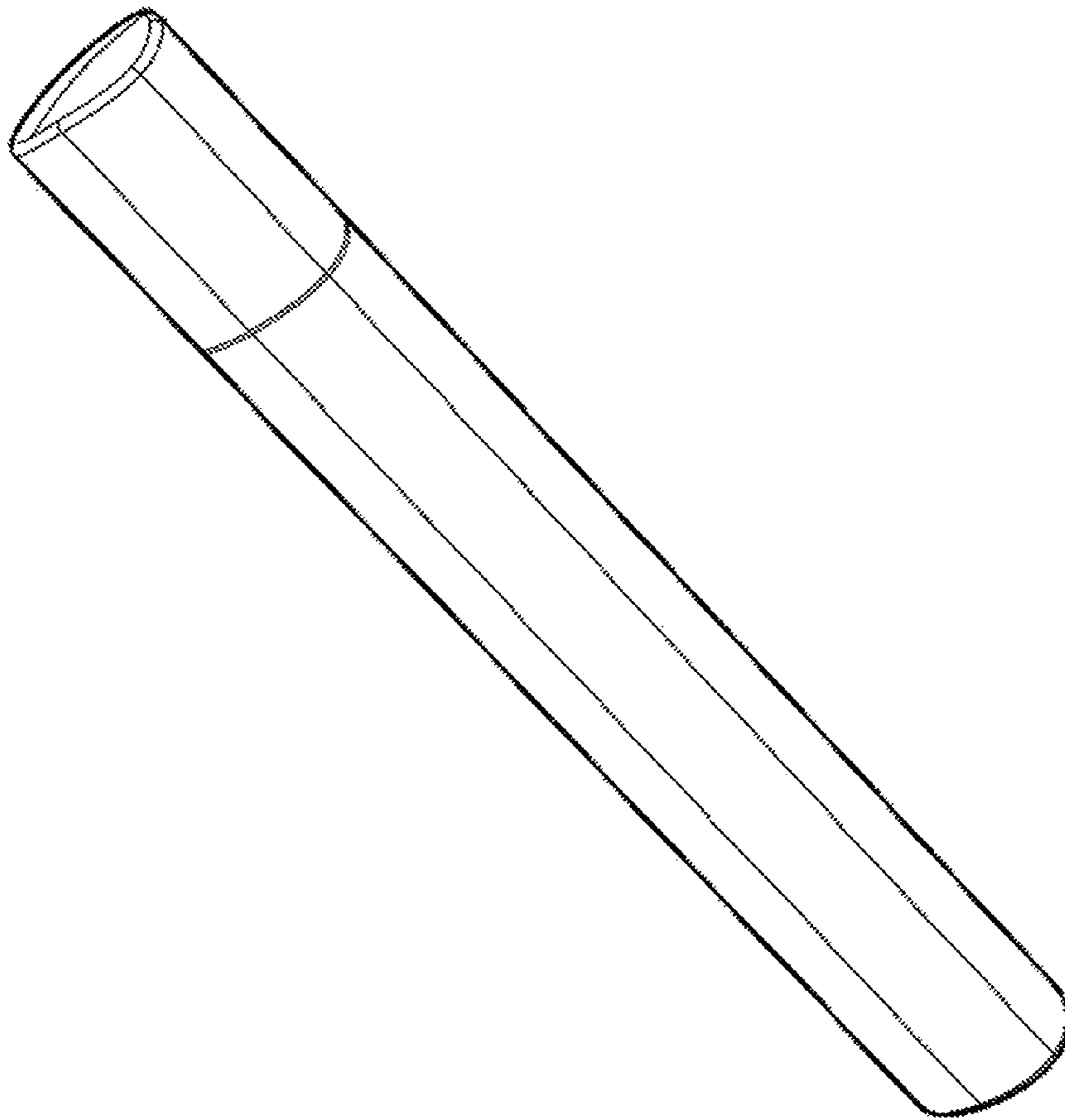

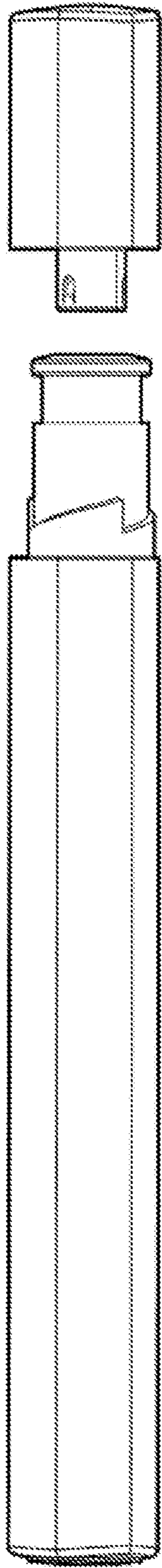

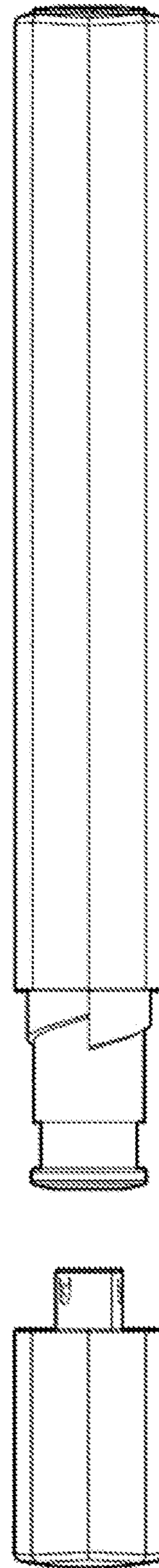

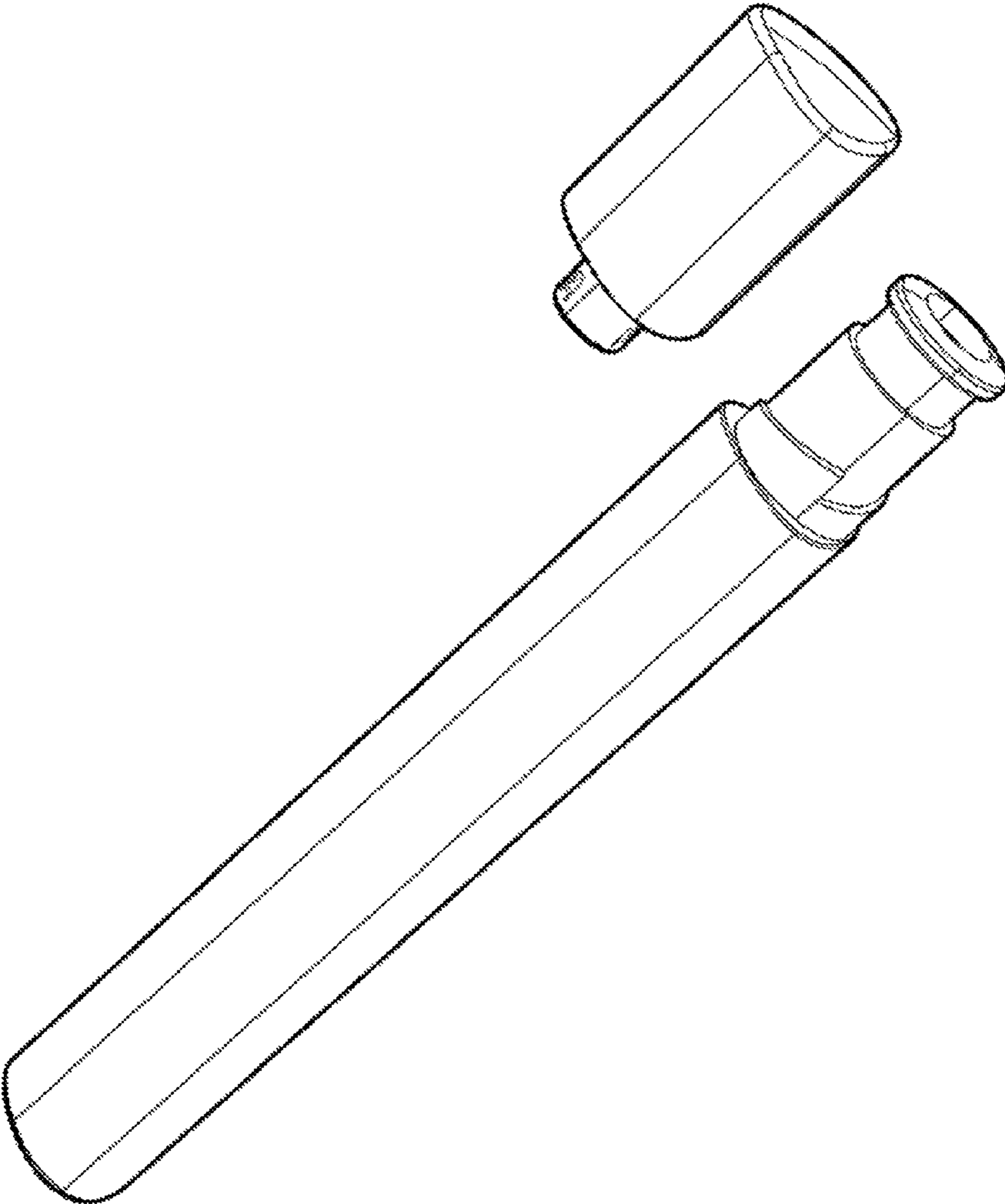

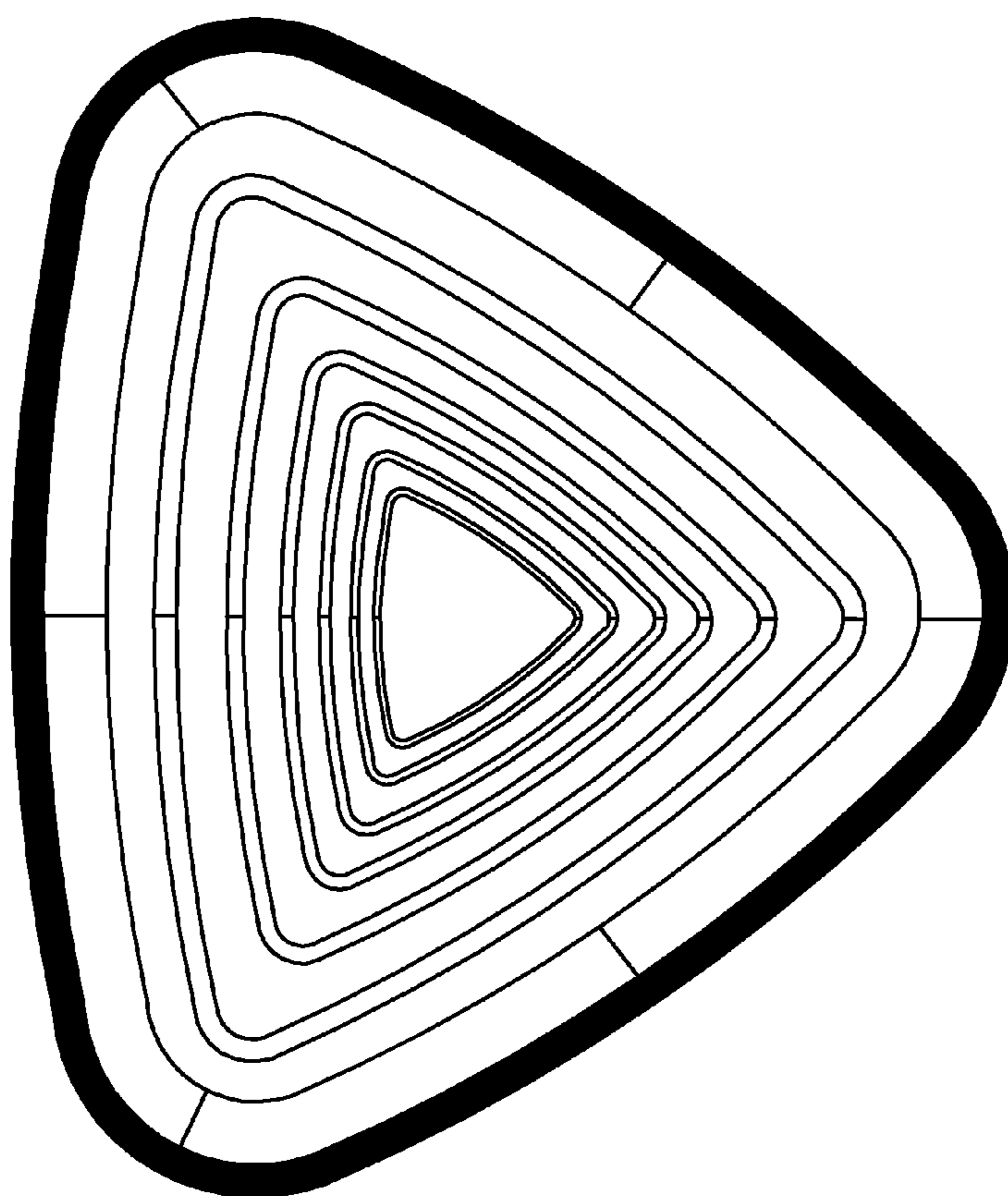

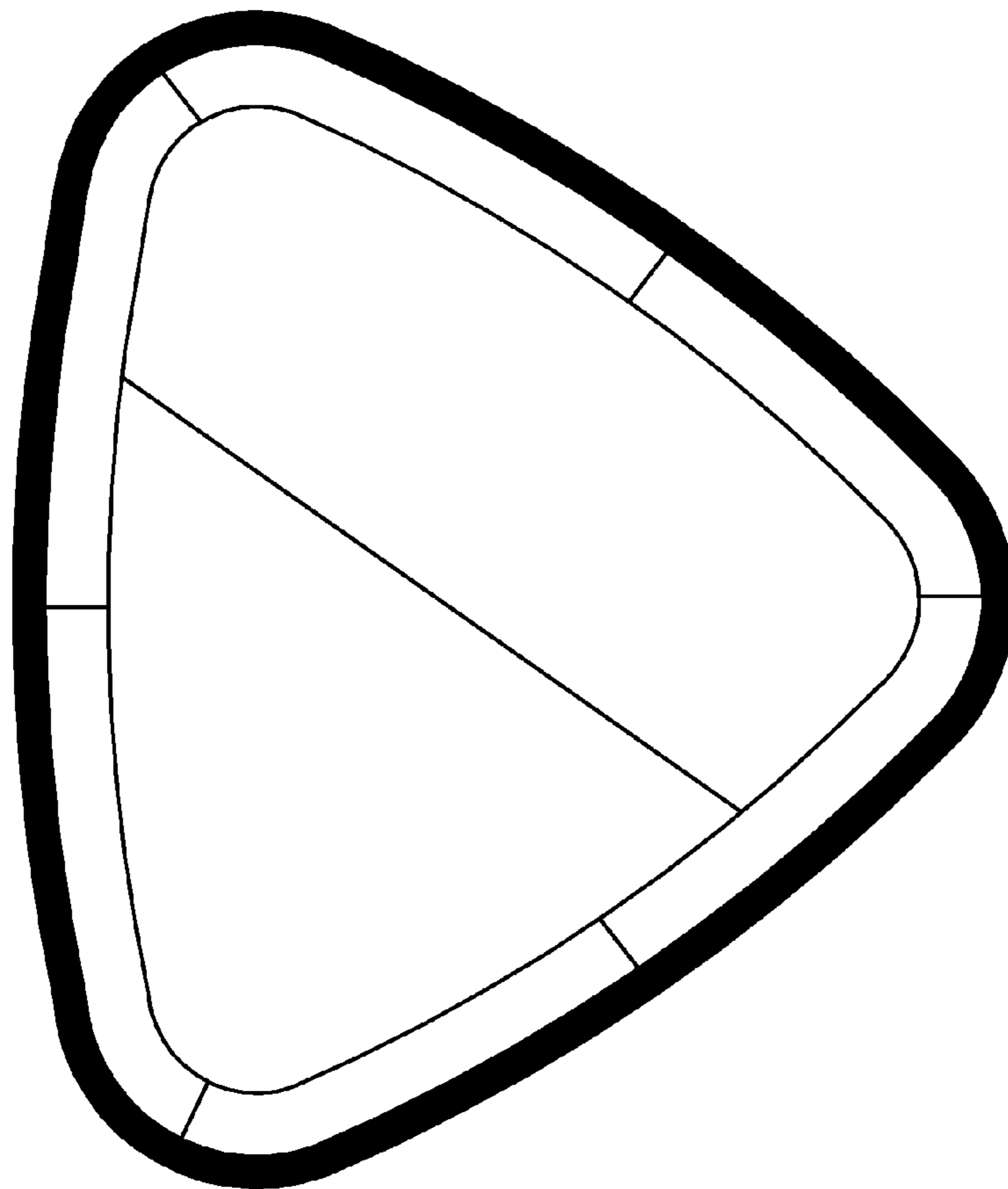
