(57) **CLAIM**

The ornamental design for a wearable leg lifter and leg repositioner, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a design for an implementation of a wearable leg lifter and leg repositioner in use by a user with chairs;

FIG. 2 is another perspective view thereof;

FIG. 3 is a right side view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a back side view thereof;

FIG. 6 is a front side view thereof;

FIG. 7 is a top view thereof; and,

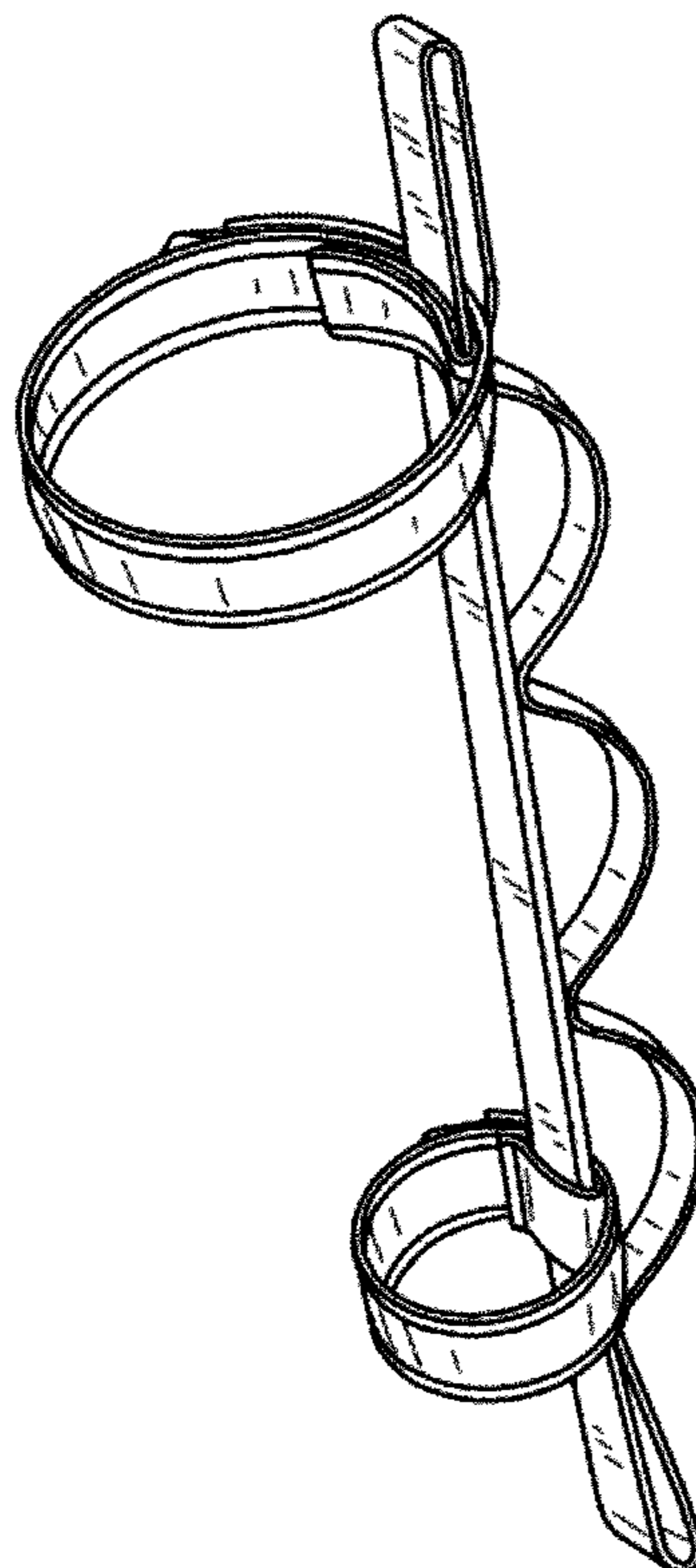

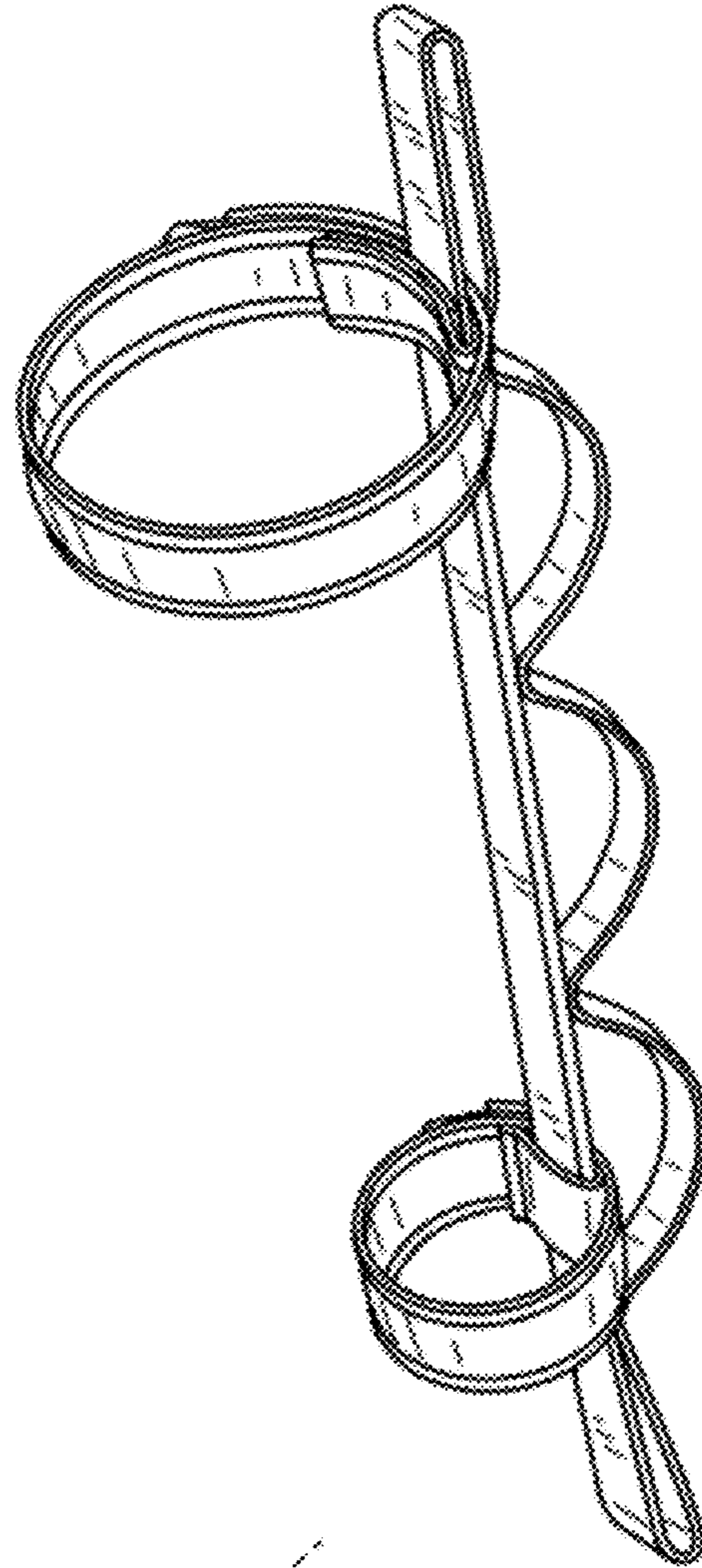
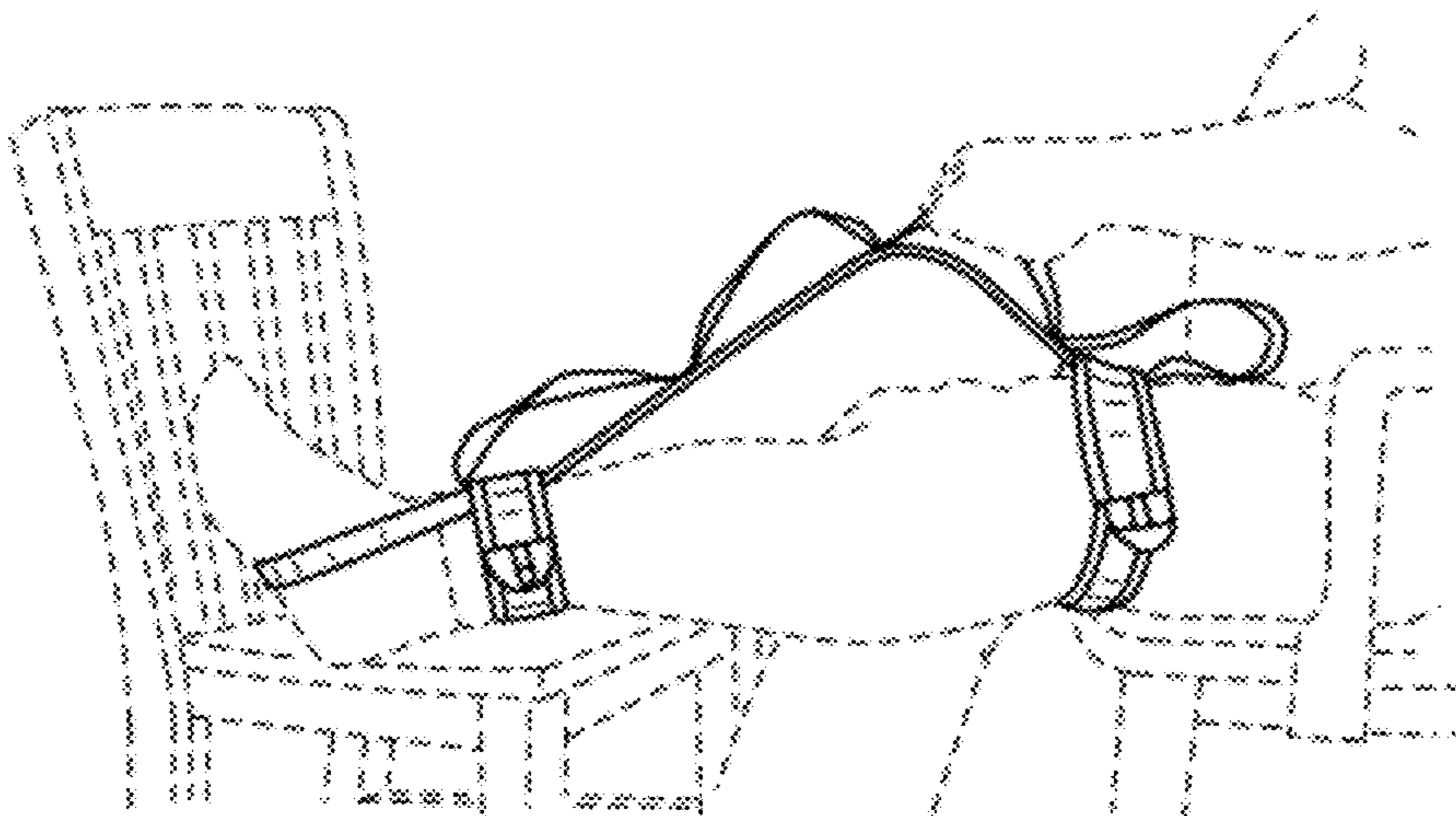

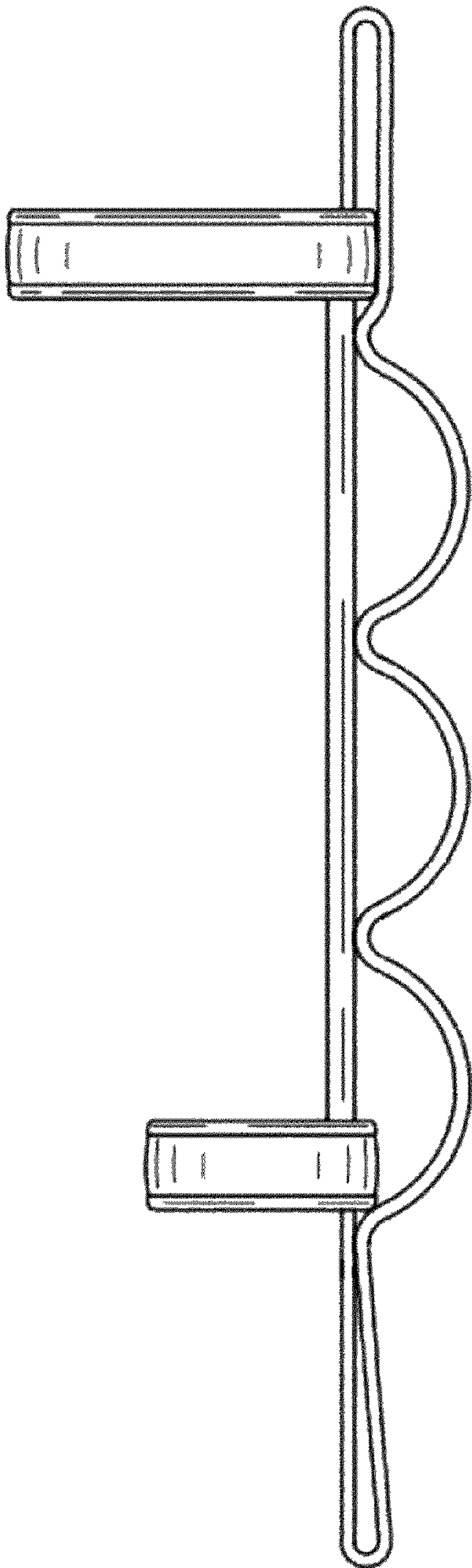

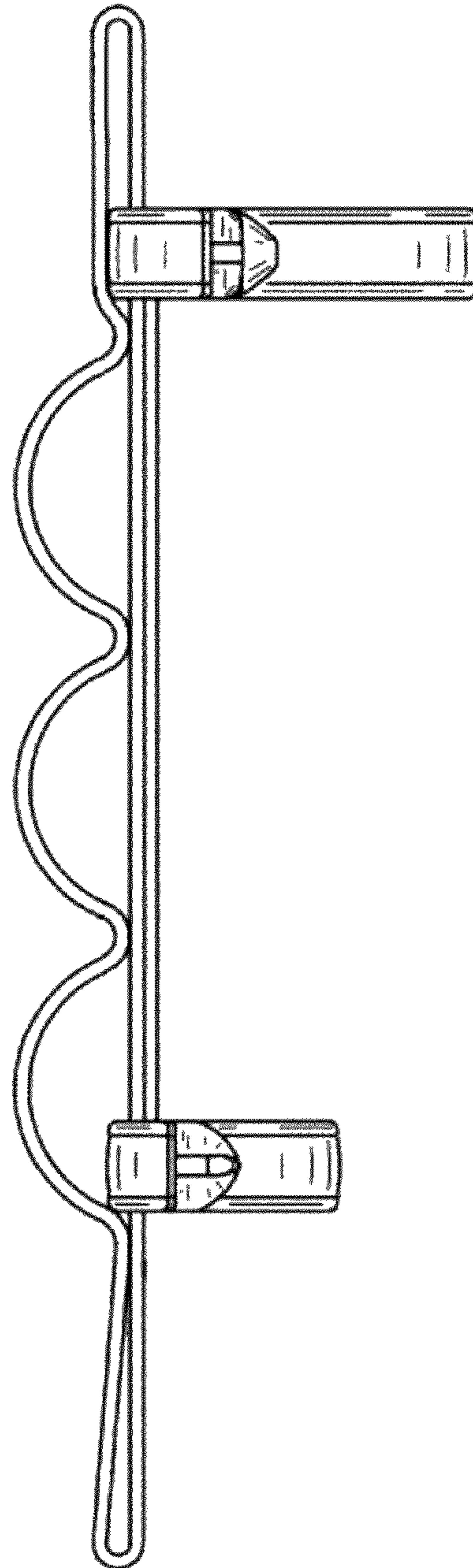

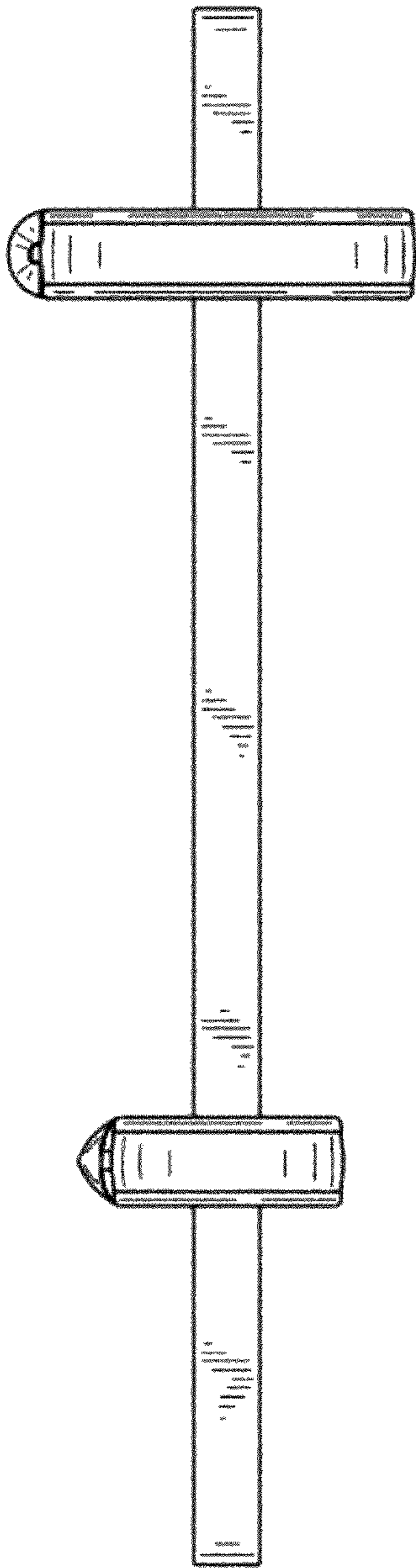

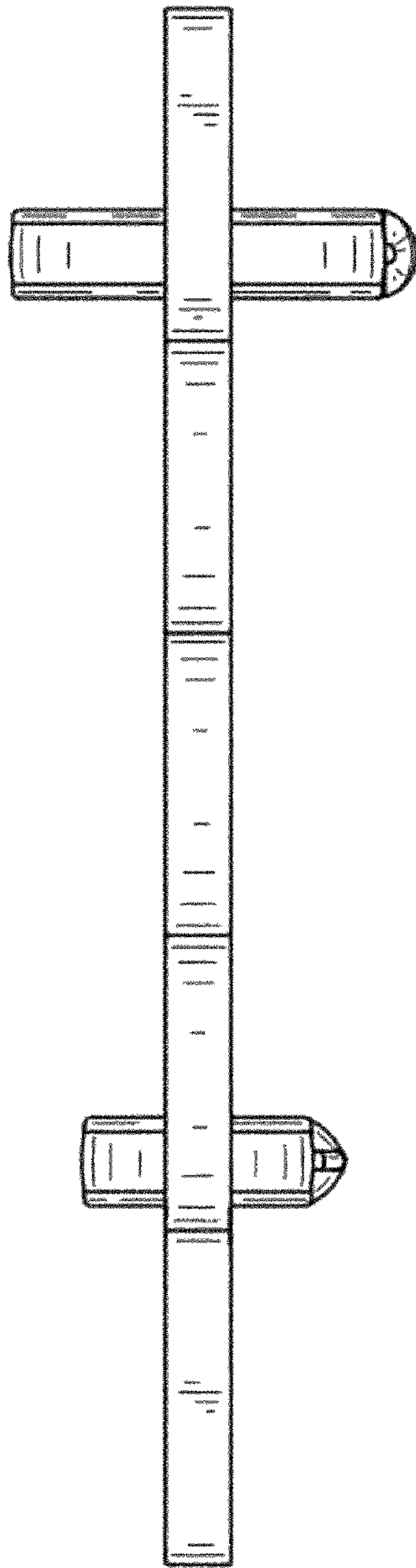

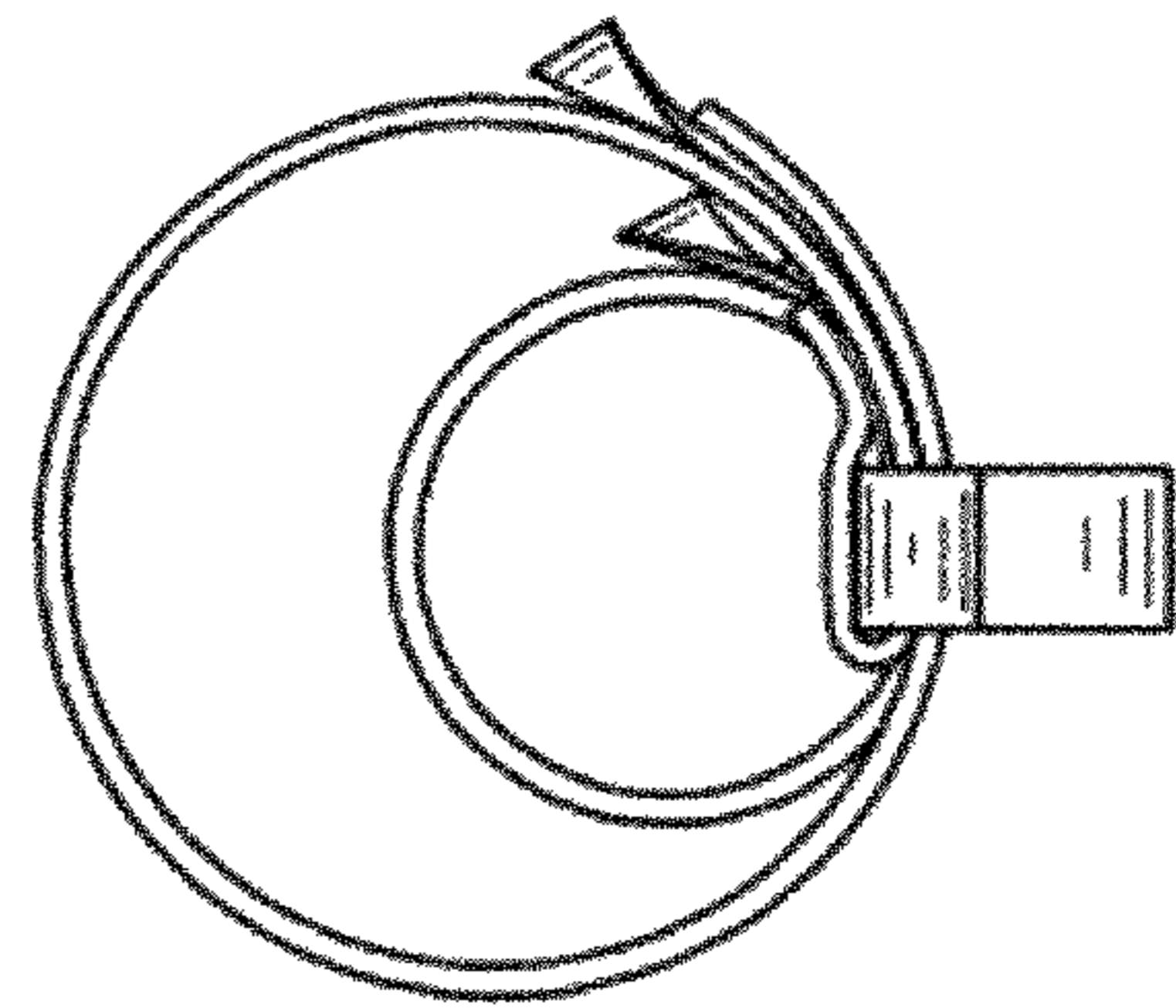

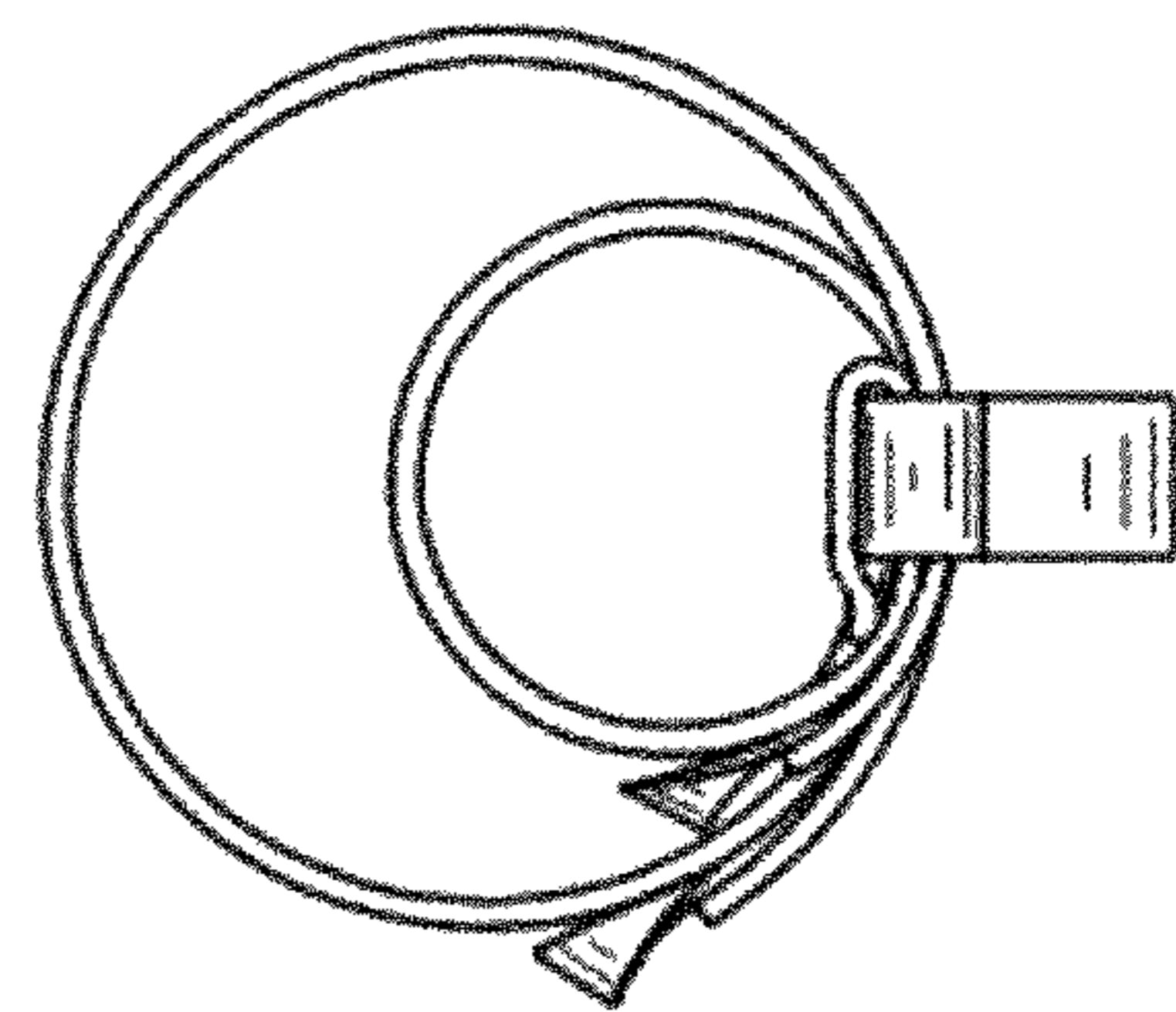
