The ornamental design for a plantar fascia support sleeve, as shown and described.

DESCRIPTION

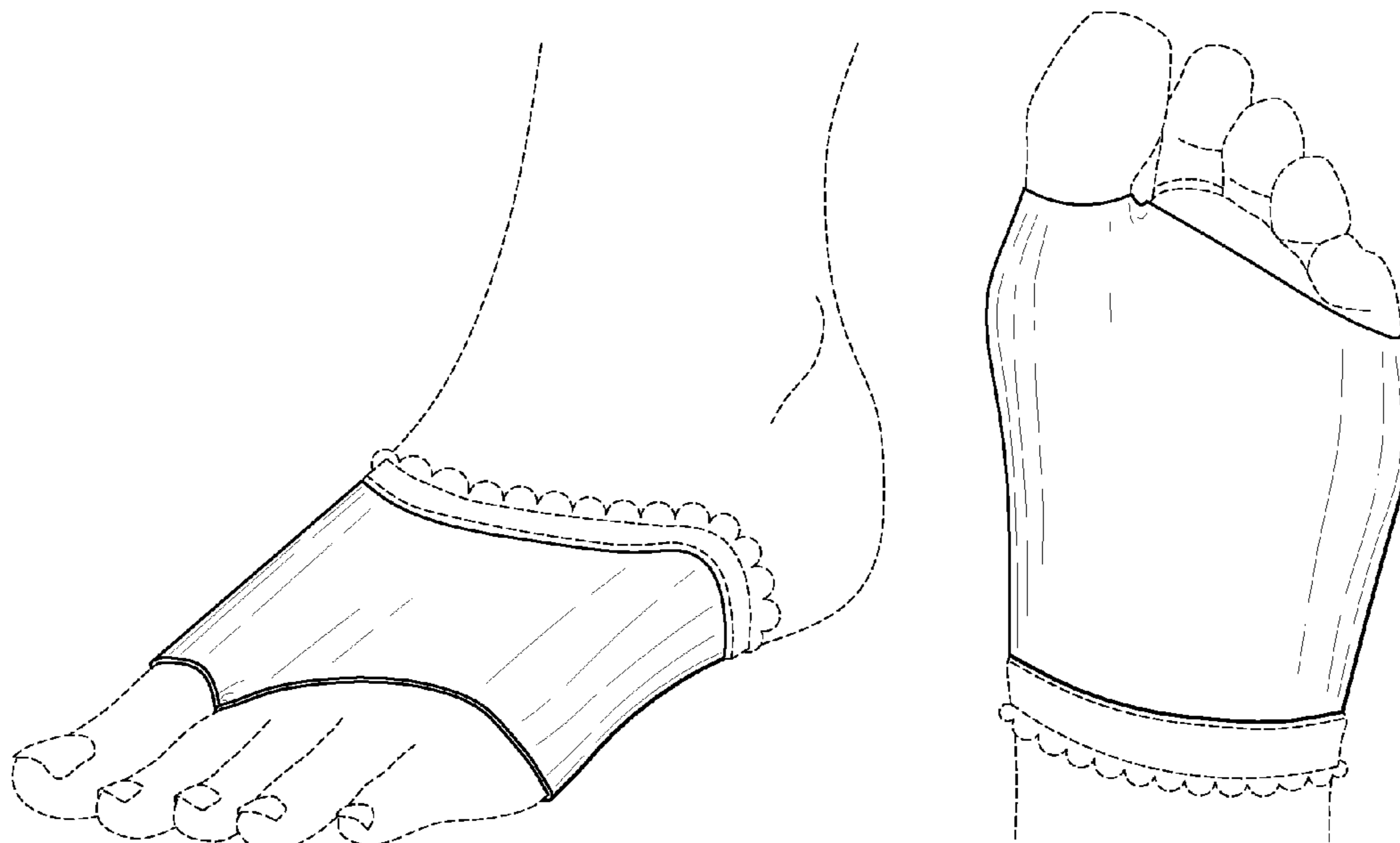
FIG. 1 is a perspective view of a plantar fascia support sleeve showing my new design in condition of use on a human foot; FIG. 2 is a rear view of my new design worn on a human foot; FIG. 3 is a front view of my new design; FIG. 4 is a top view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a rear view thereof; FIG. 7 is a left side view thereof; and, FIG. 8 is a bottom view thereof. The broken lines in FIGS. 1-8 illustrate portions of the plantar fascia support sleeve and environmental structure which form no part of the claimed design.

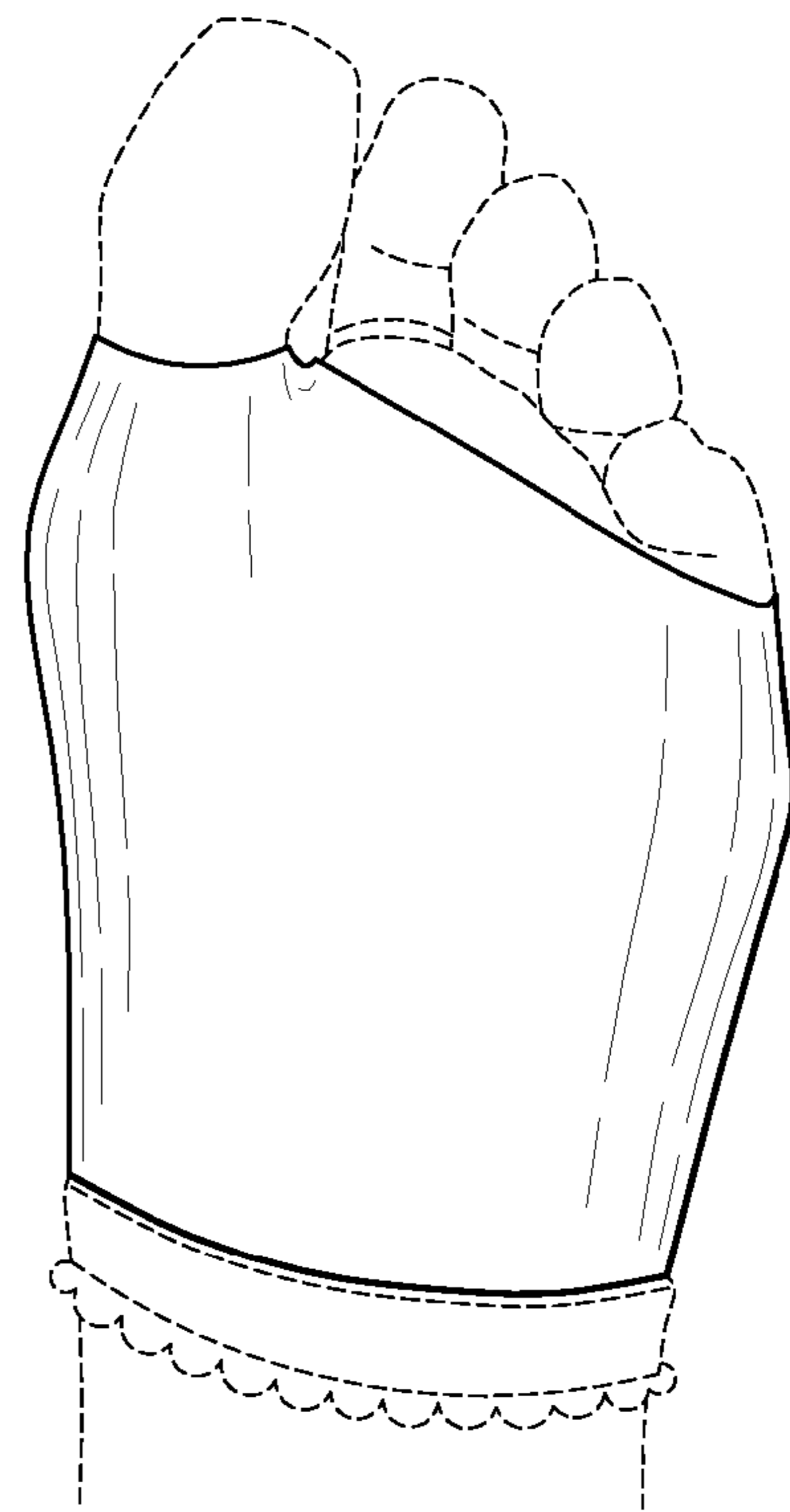
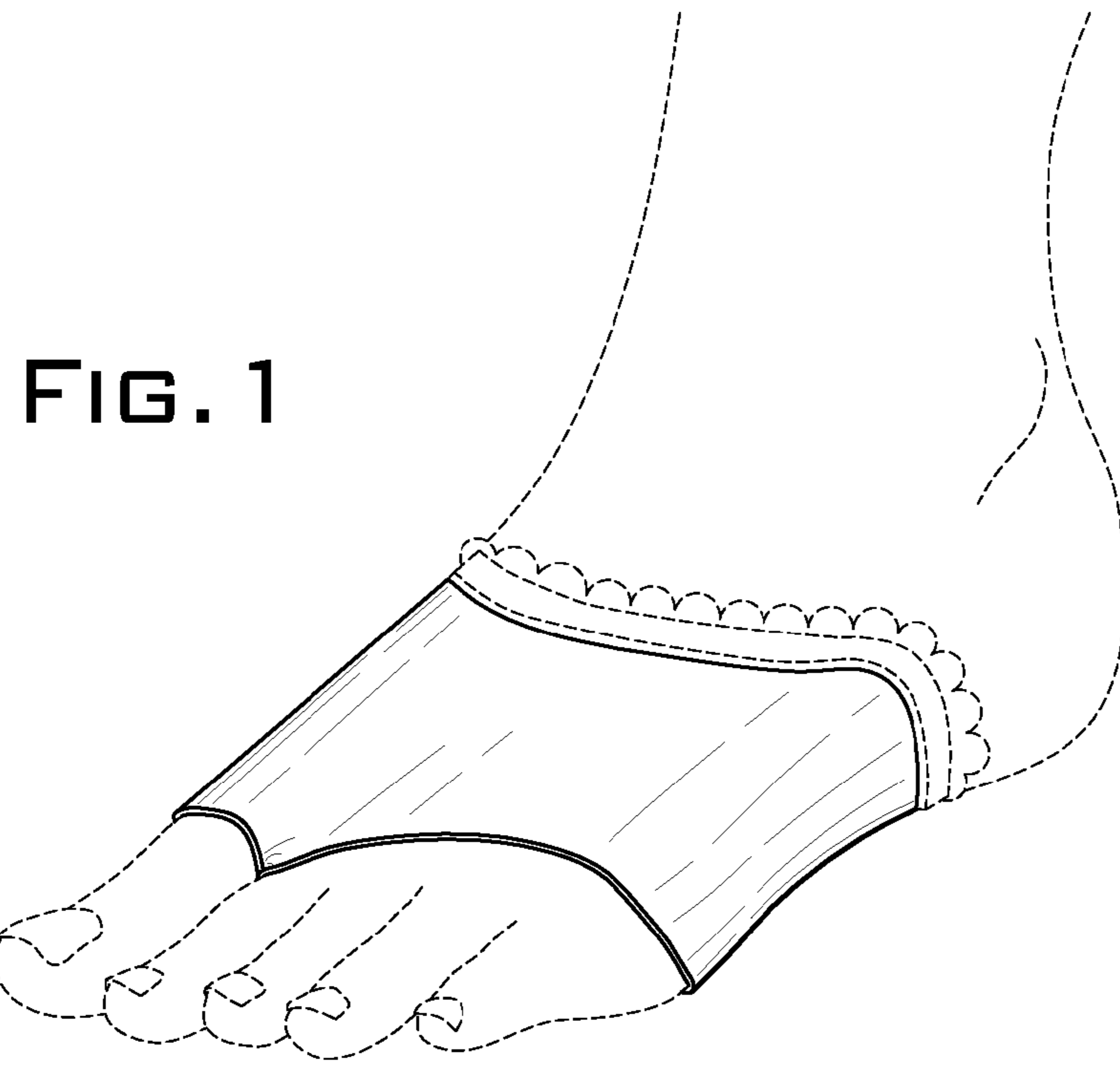

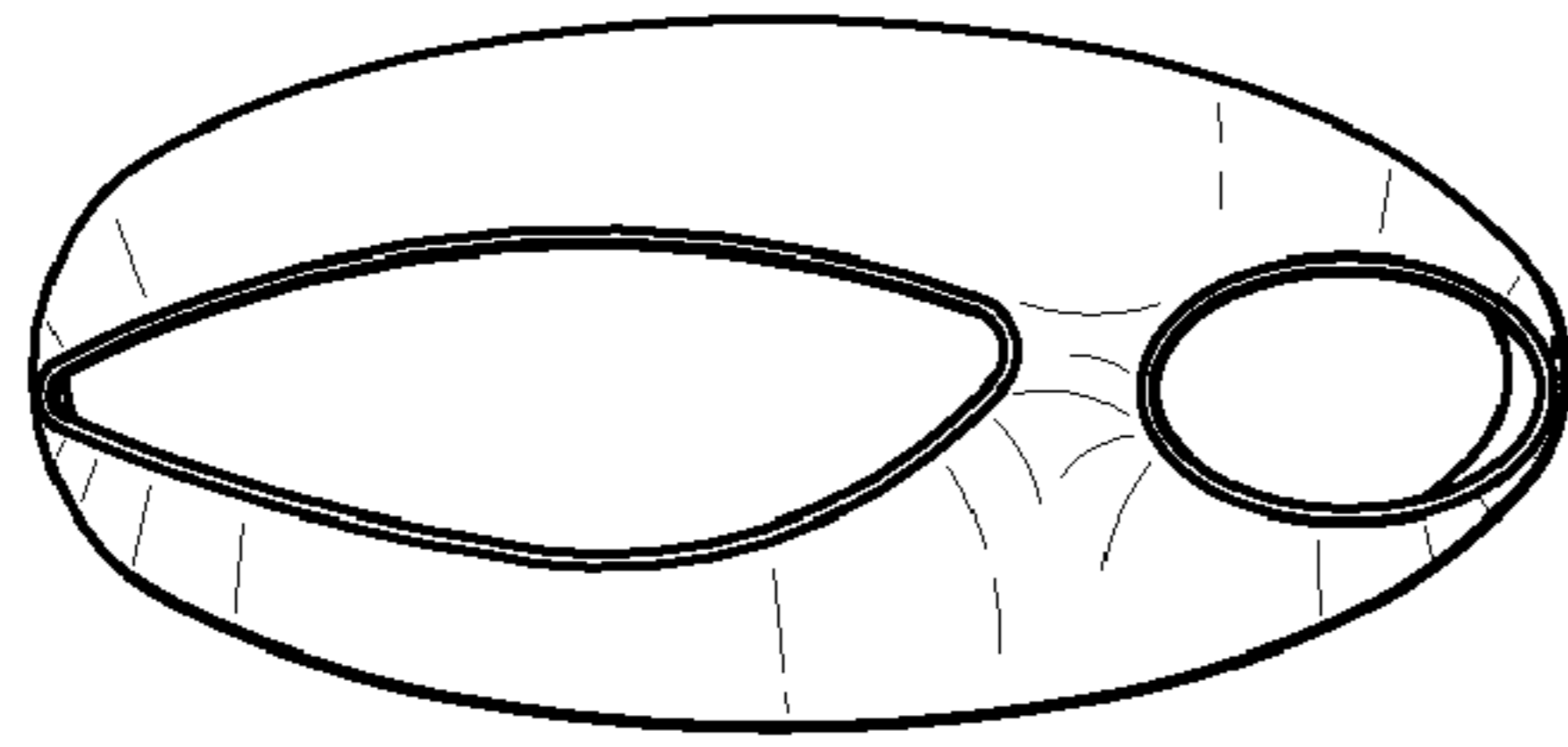

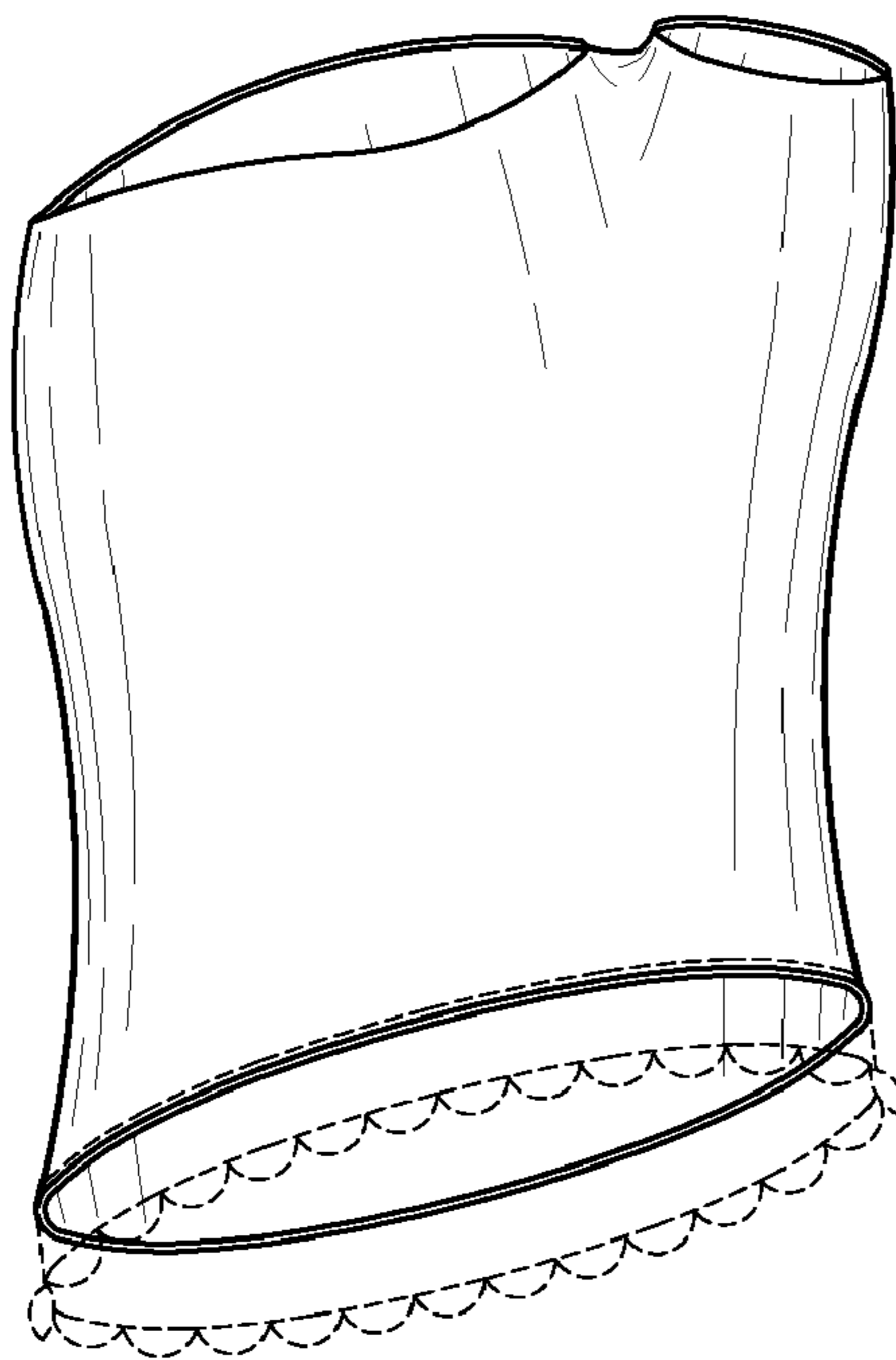

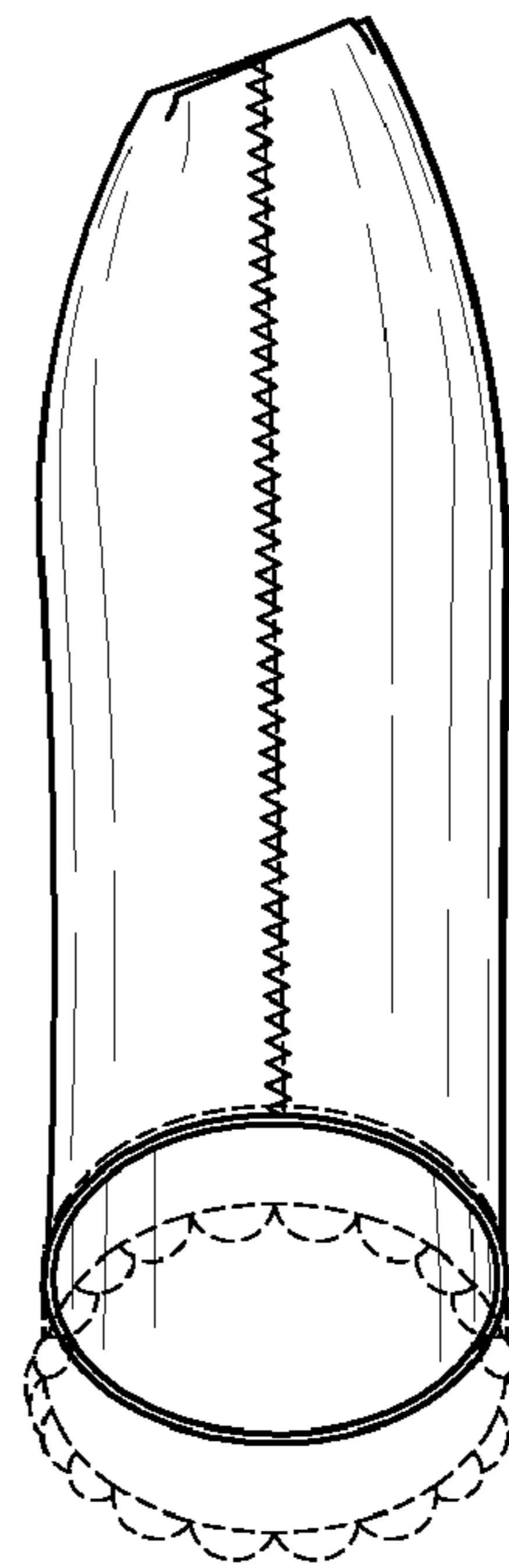

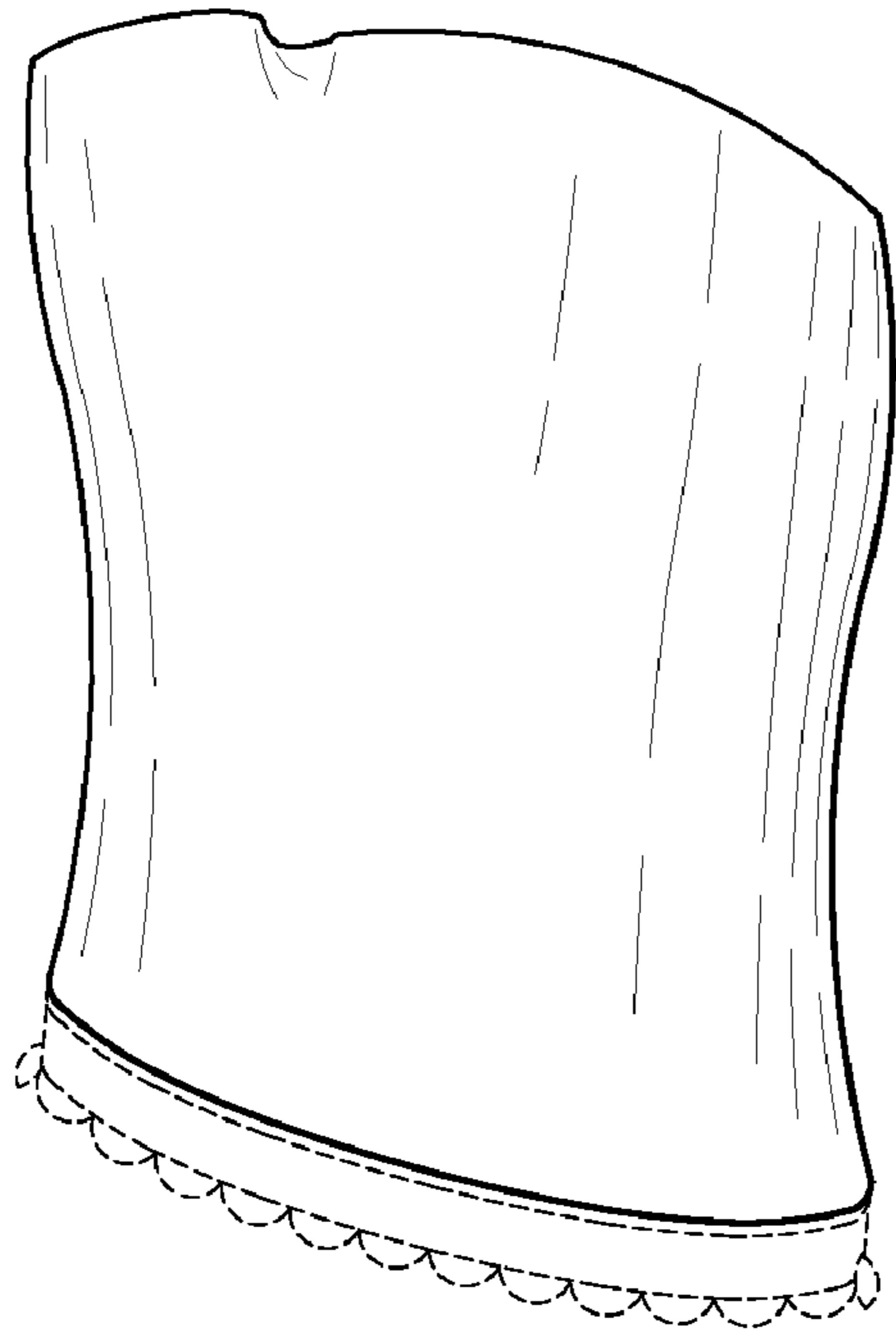

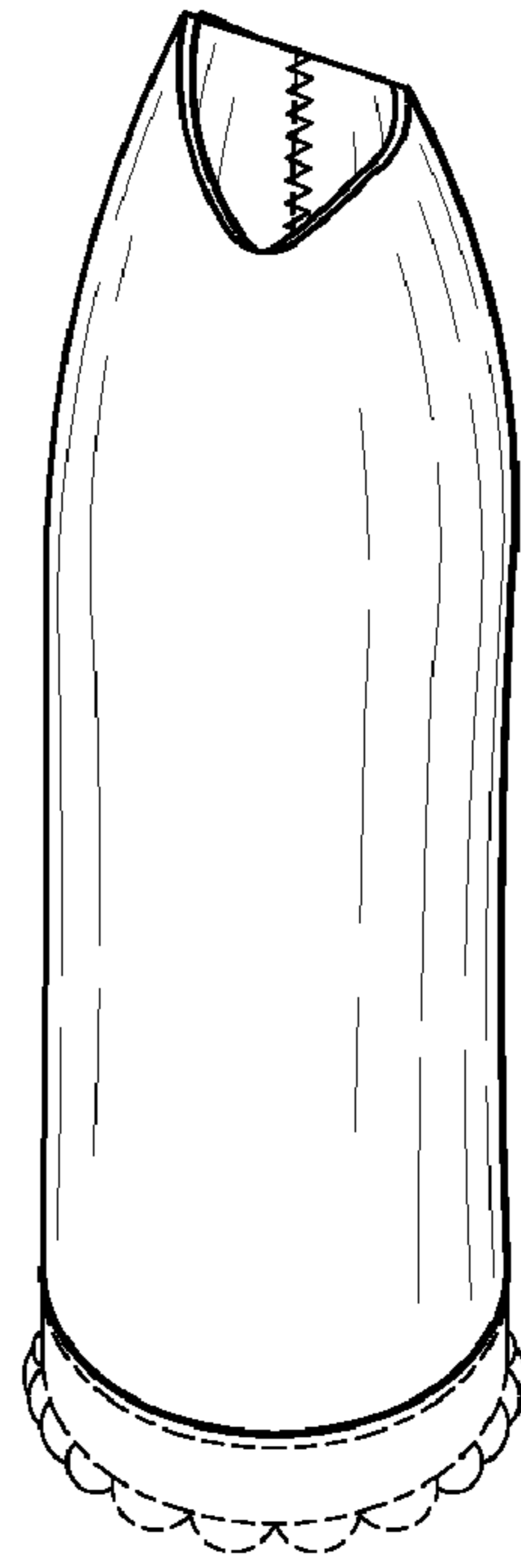

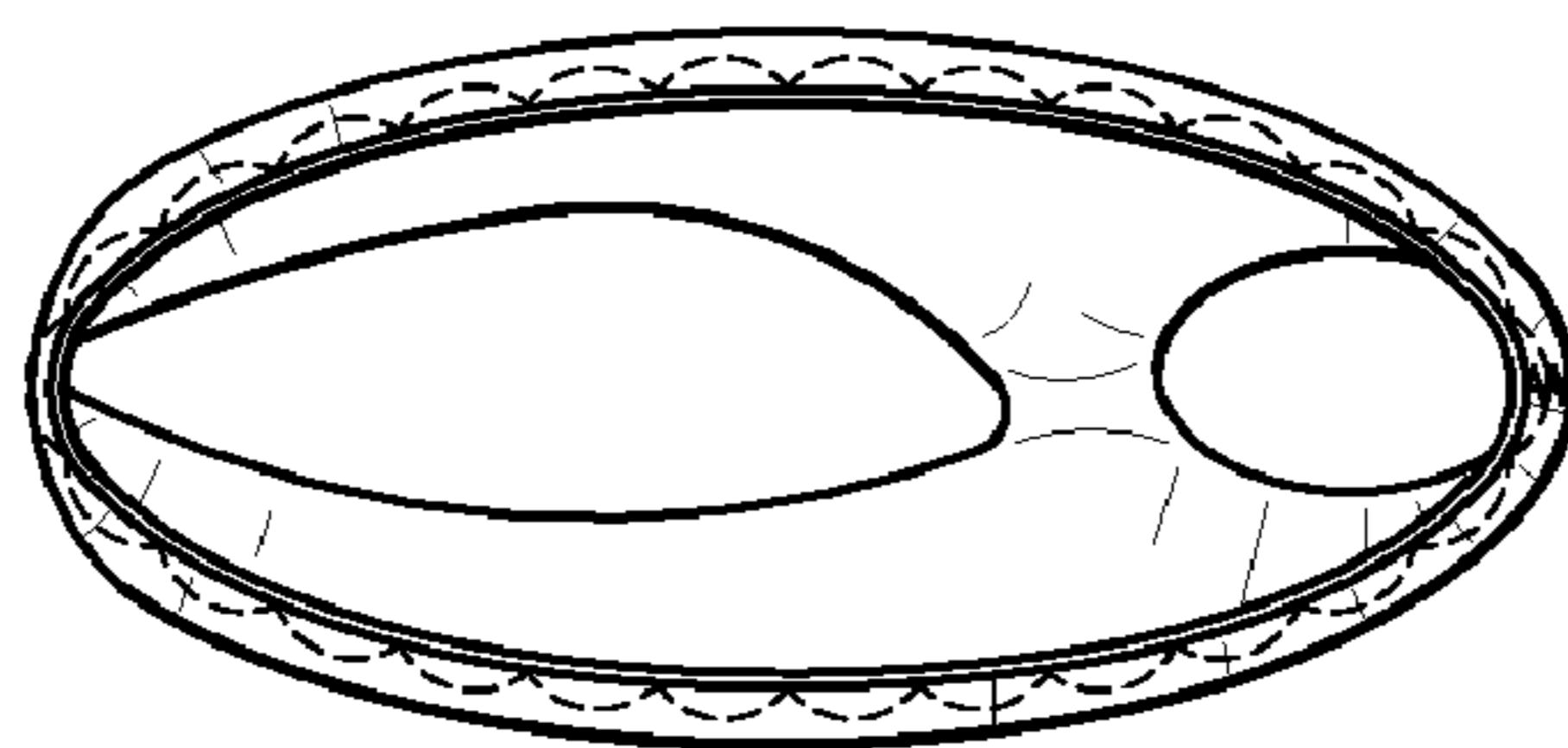
