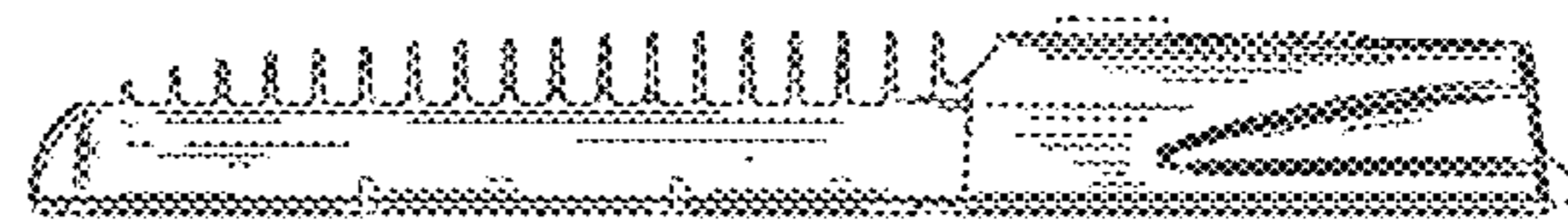
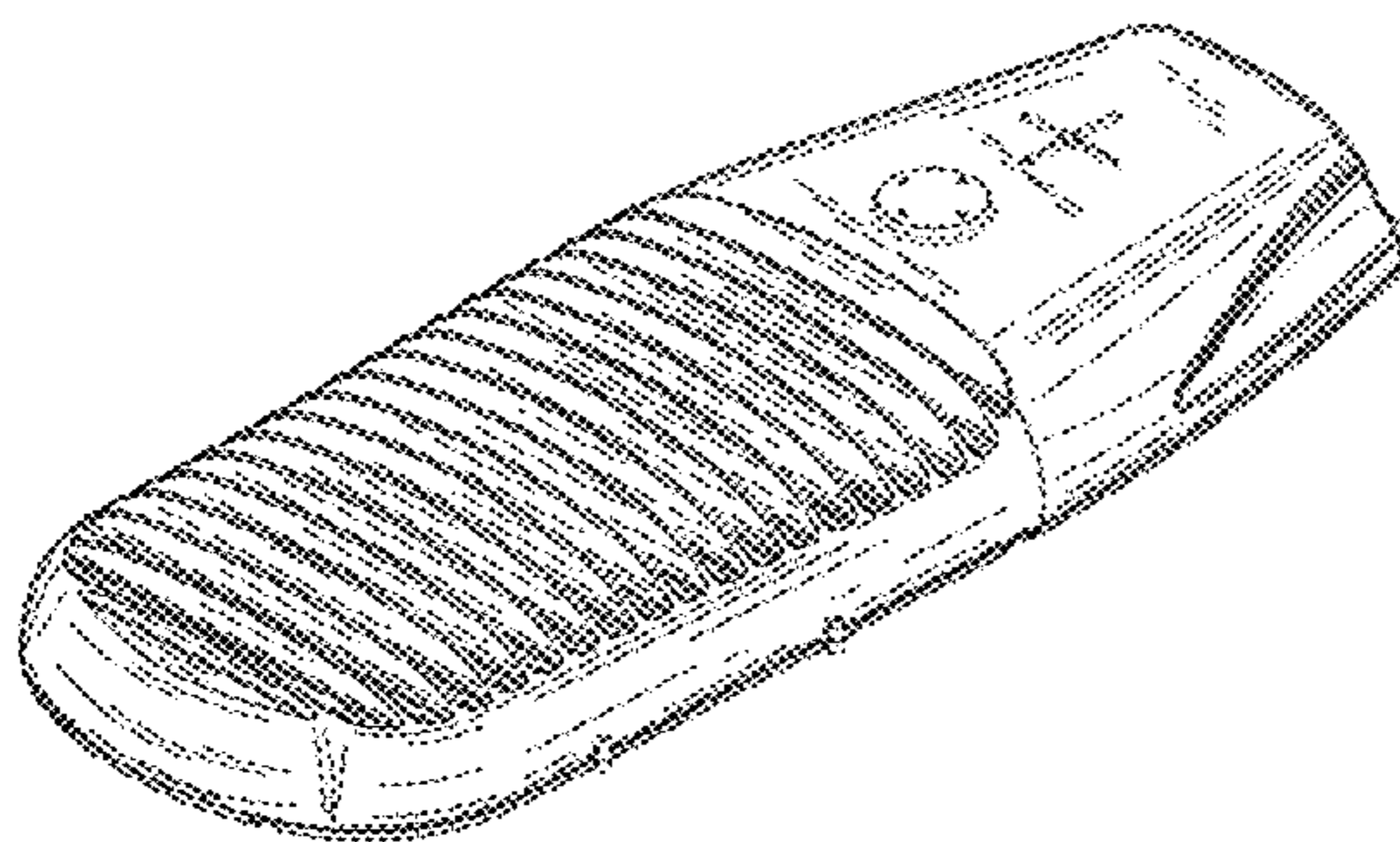
(57) **CLAIM**

The ornamental design for a roadway light fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an roadway light fixture; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image thereof; FIG. 5 is a front elevational view thereof; and, FIG. 6 is a rear elevational view thereof. The broken lines shown on FIGS. 1-6 are for illustrative purposes only and form no part of the claimed design.

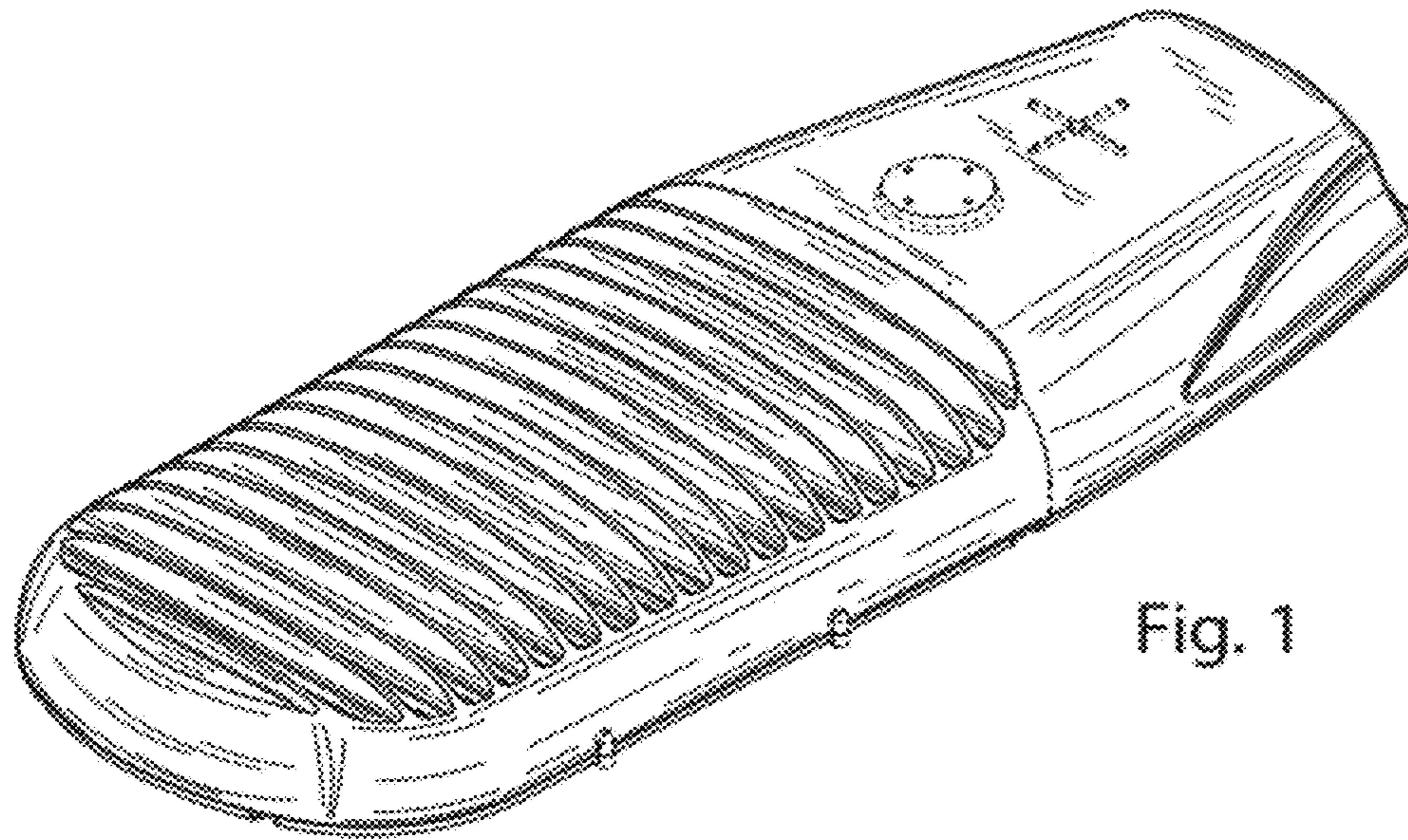

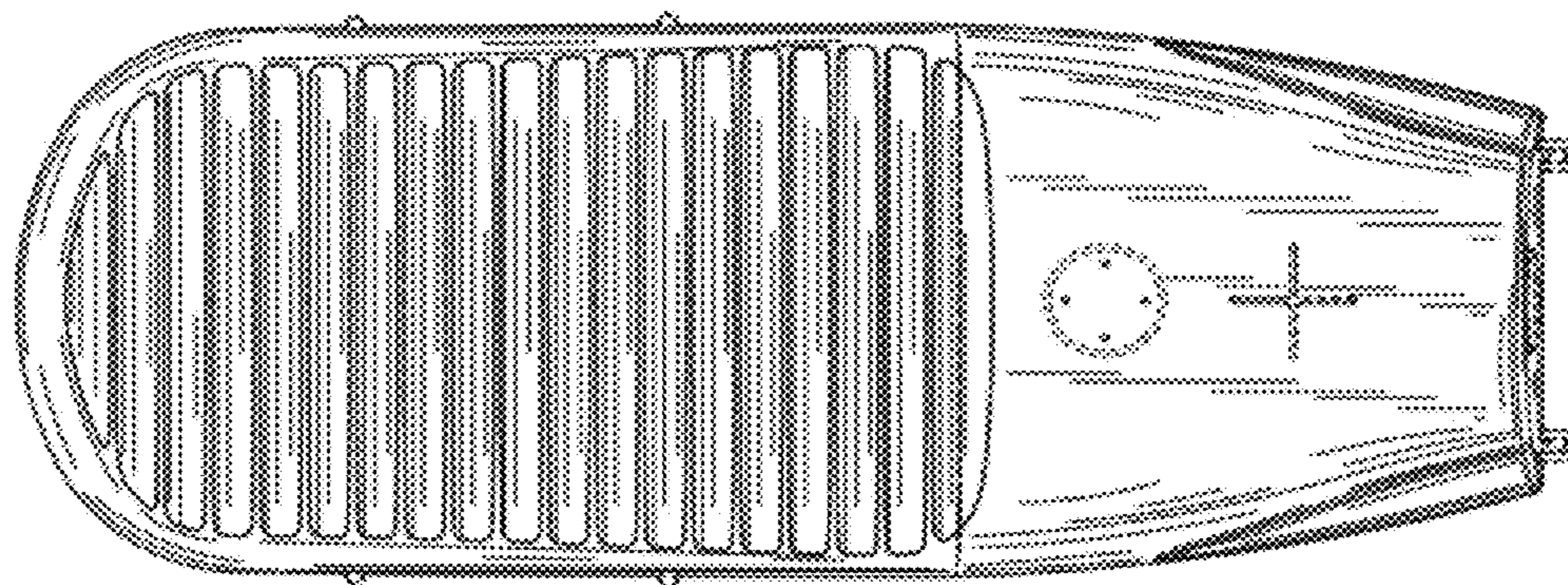

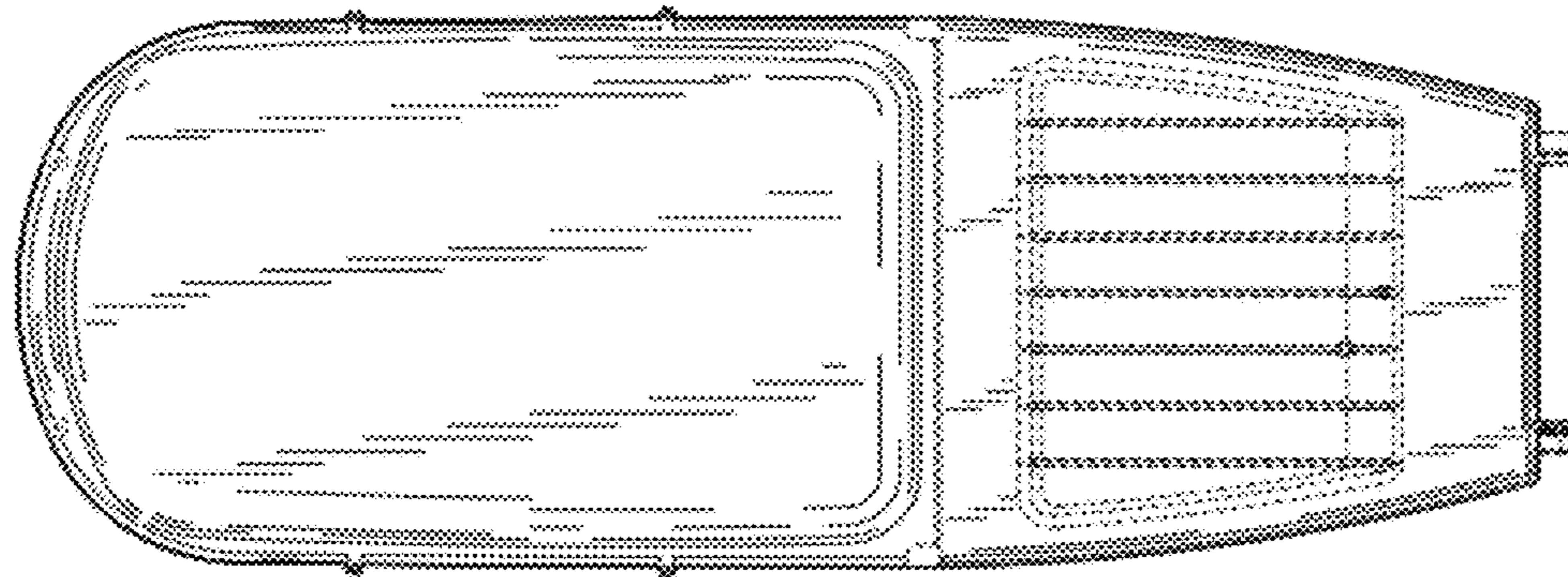

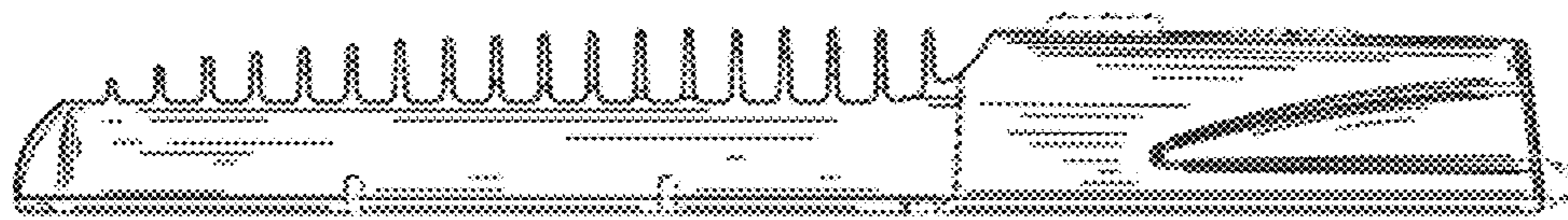

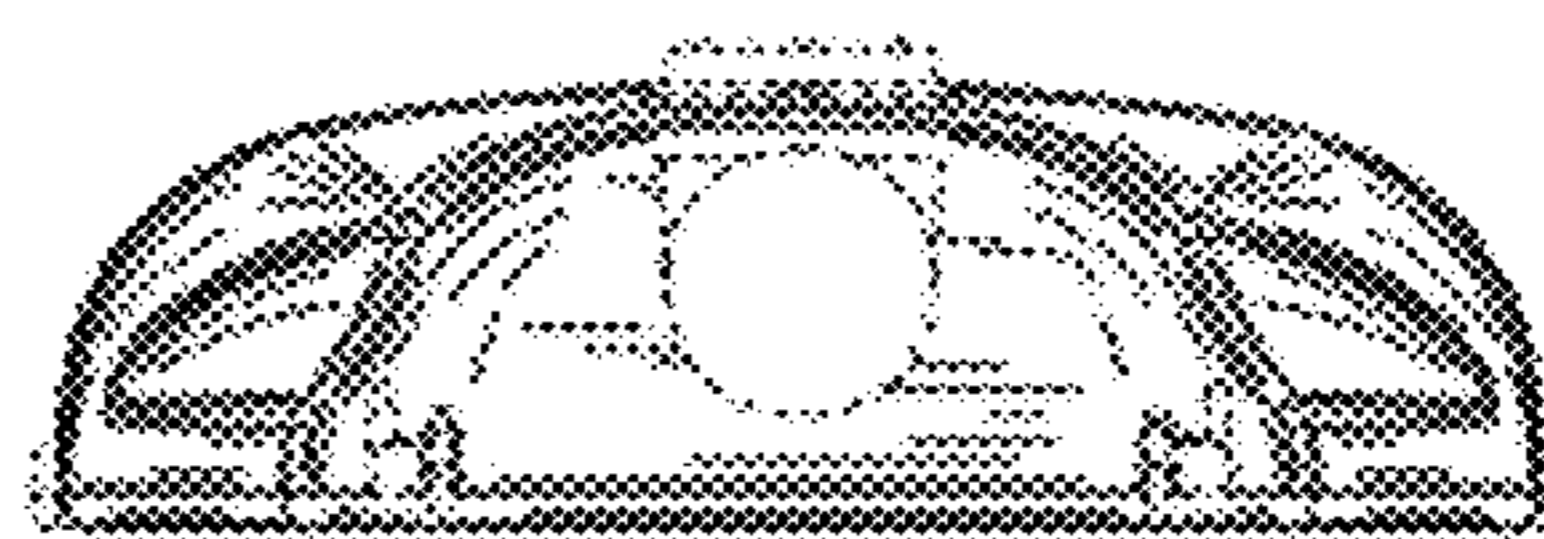
