FIG. 11 is a back view of the dishwashing product of FIG. 8.

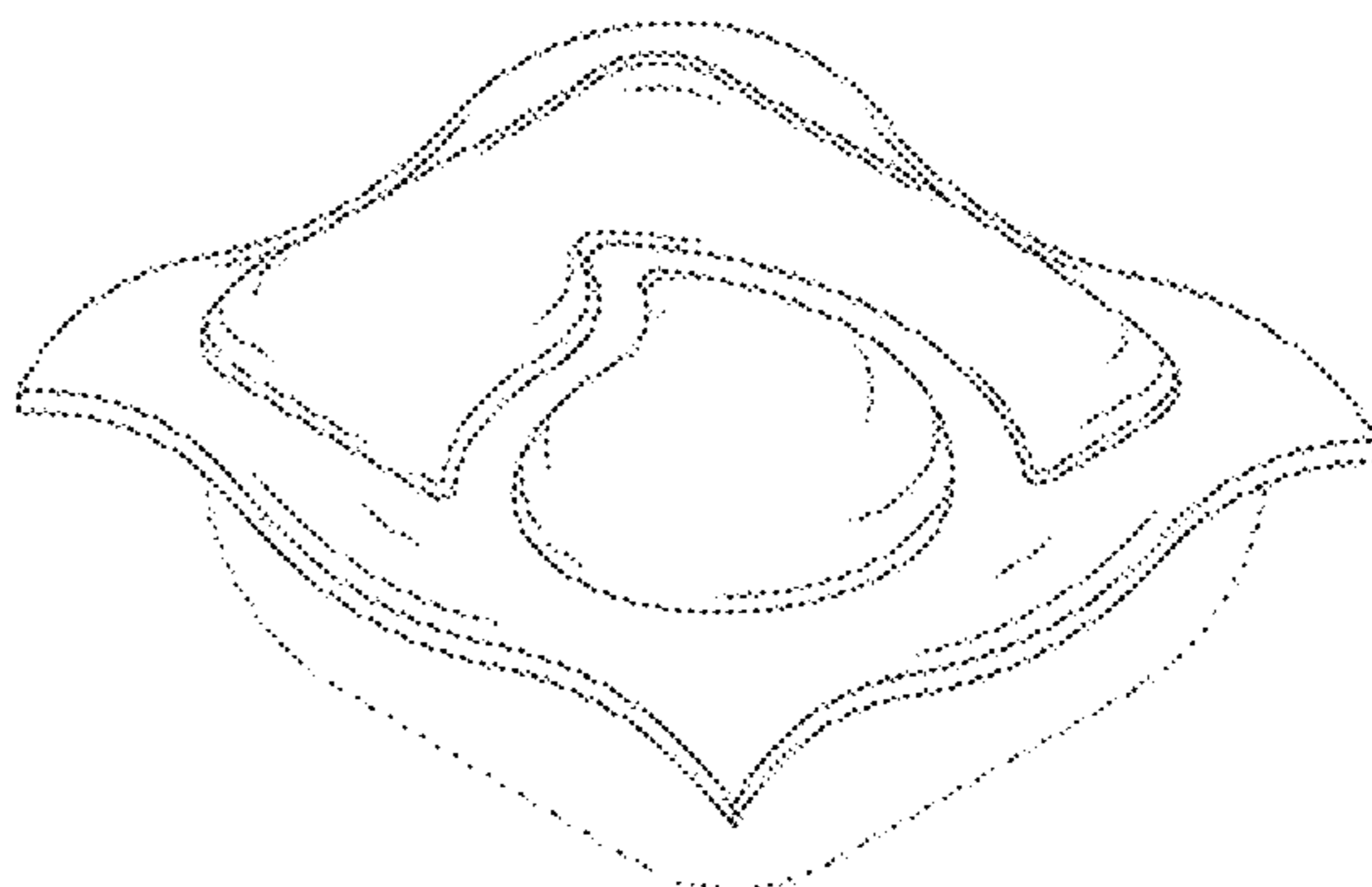
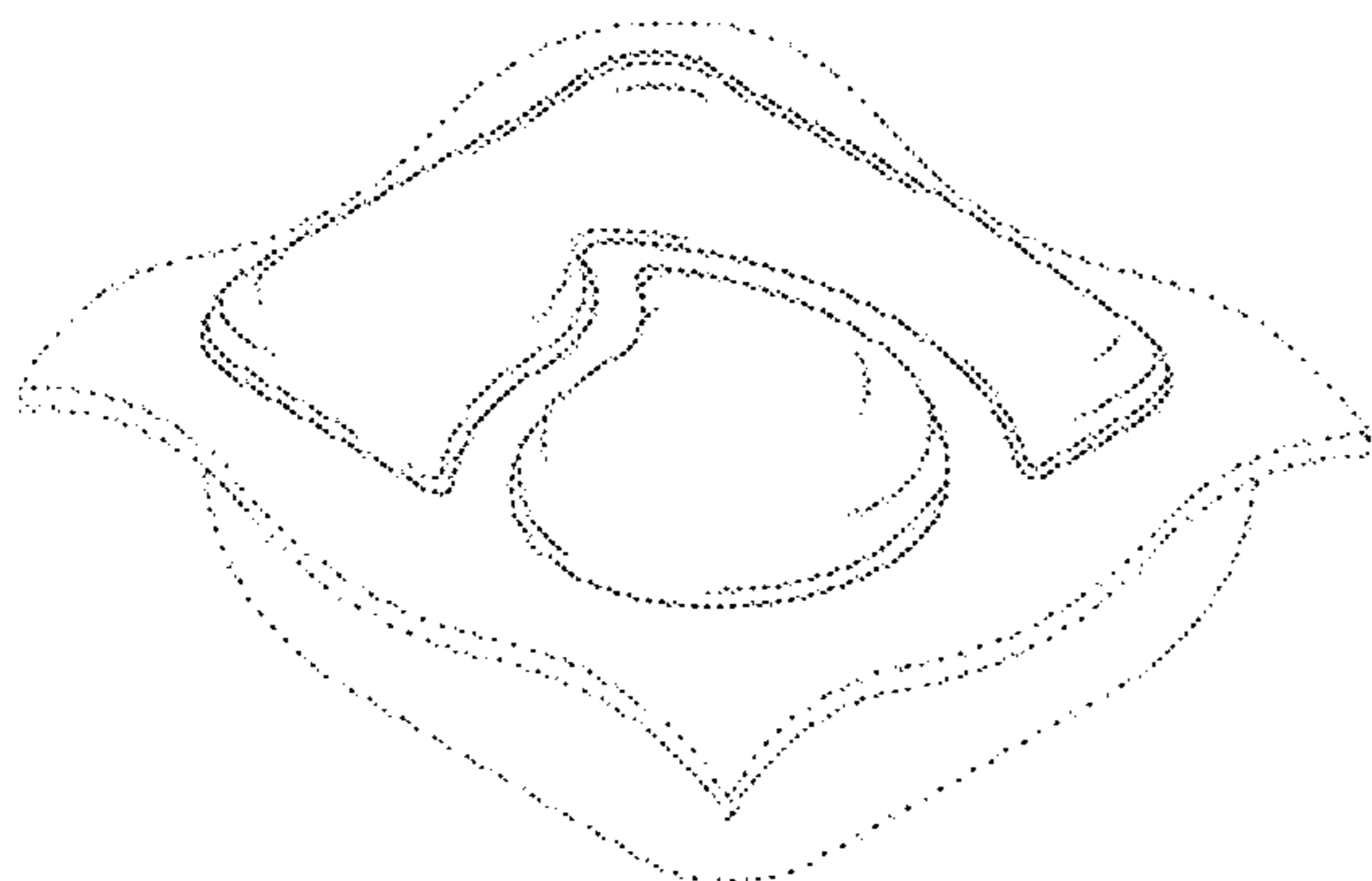
FIG. 12 is a left side view of the dishwashing product of FIG. 8.

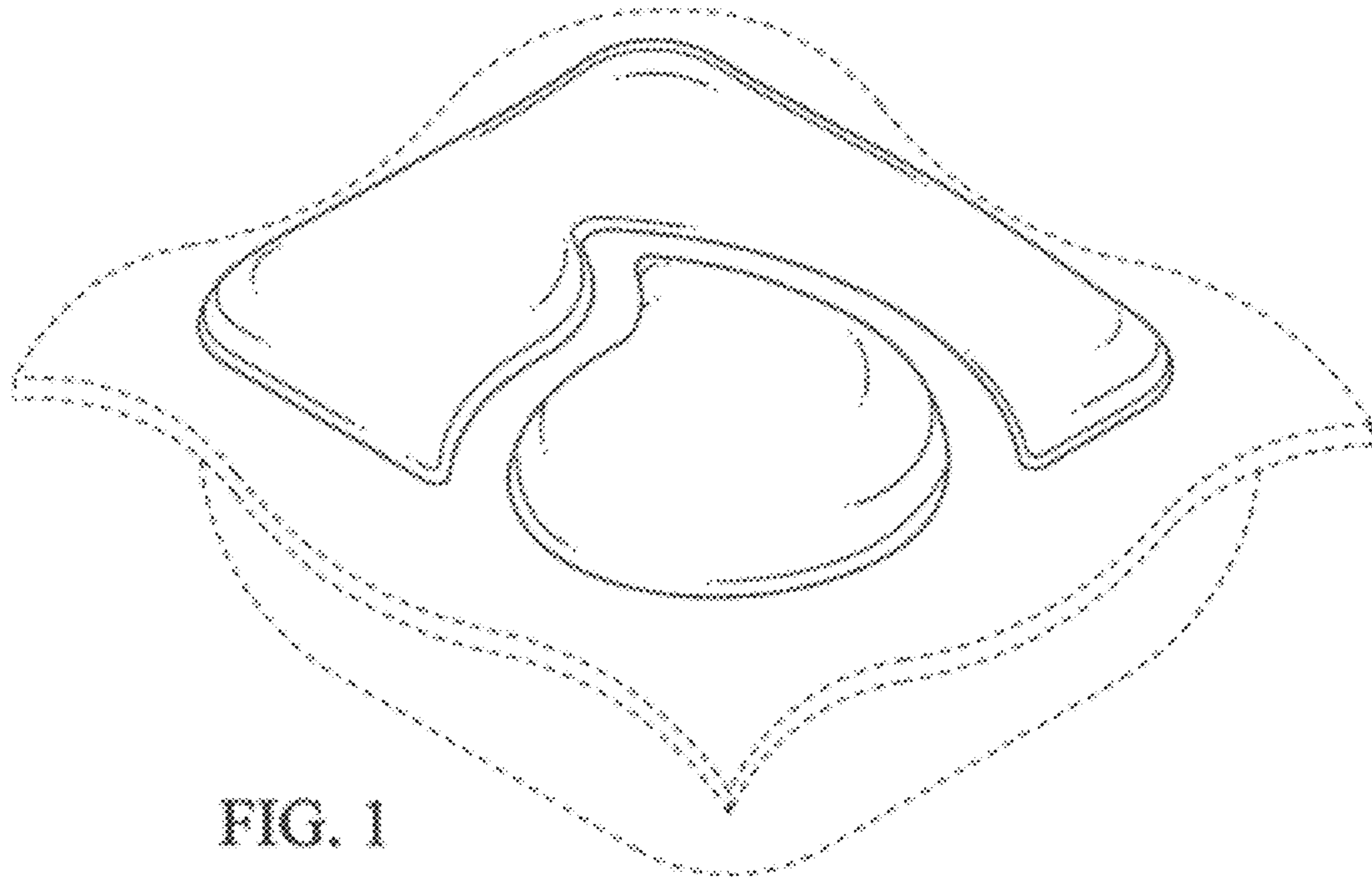

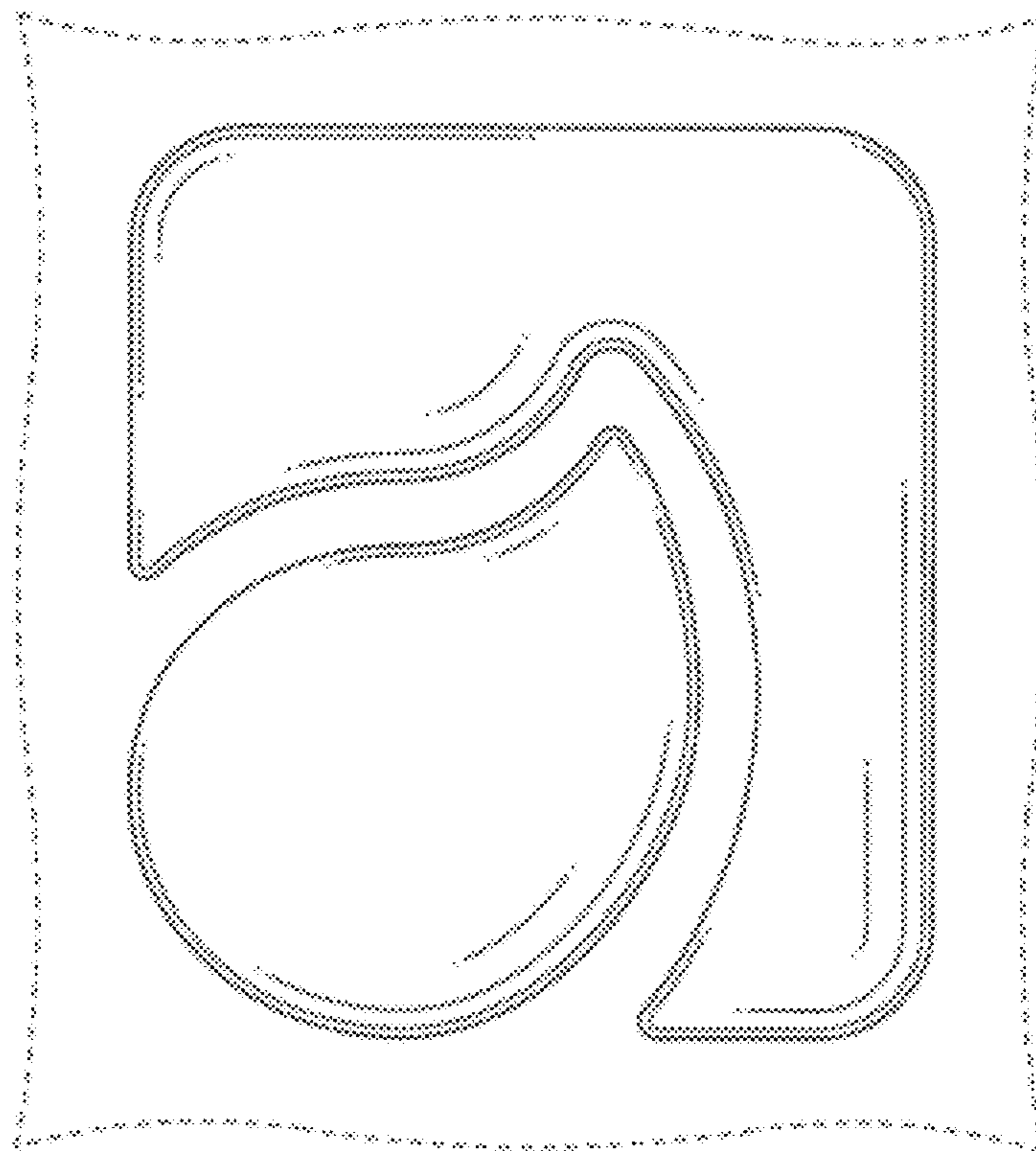

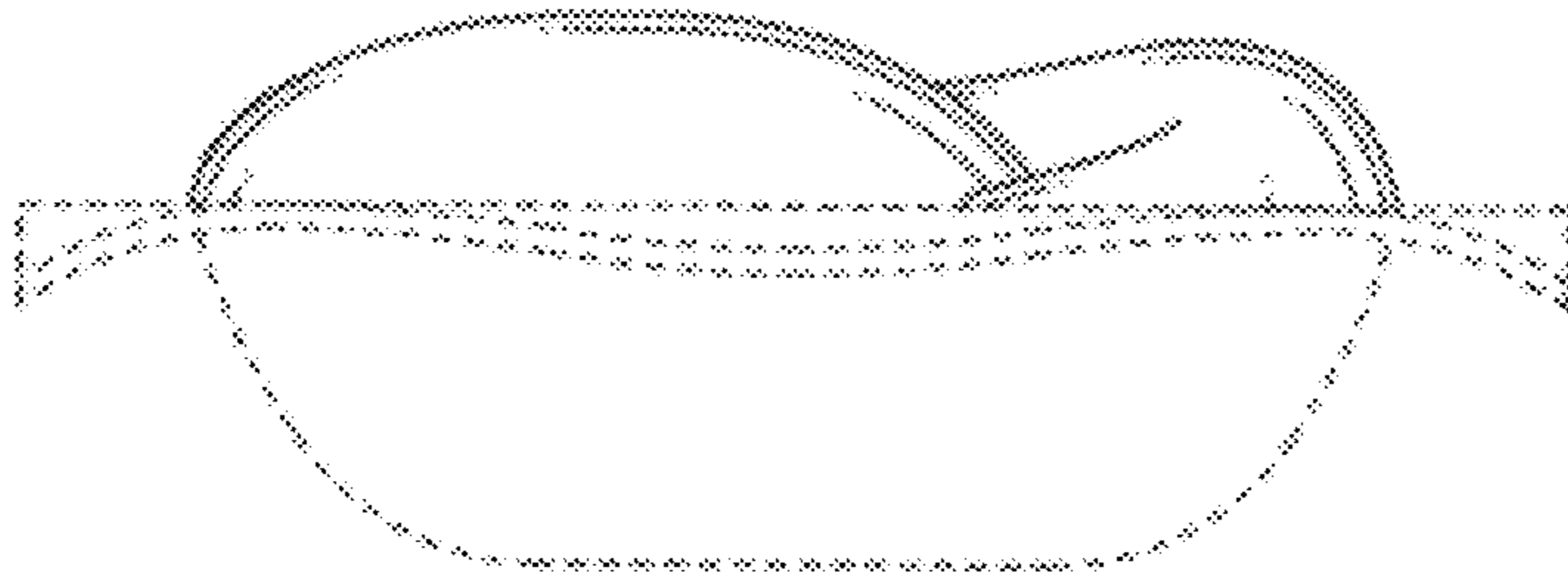

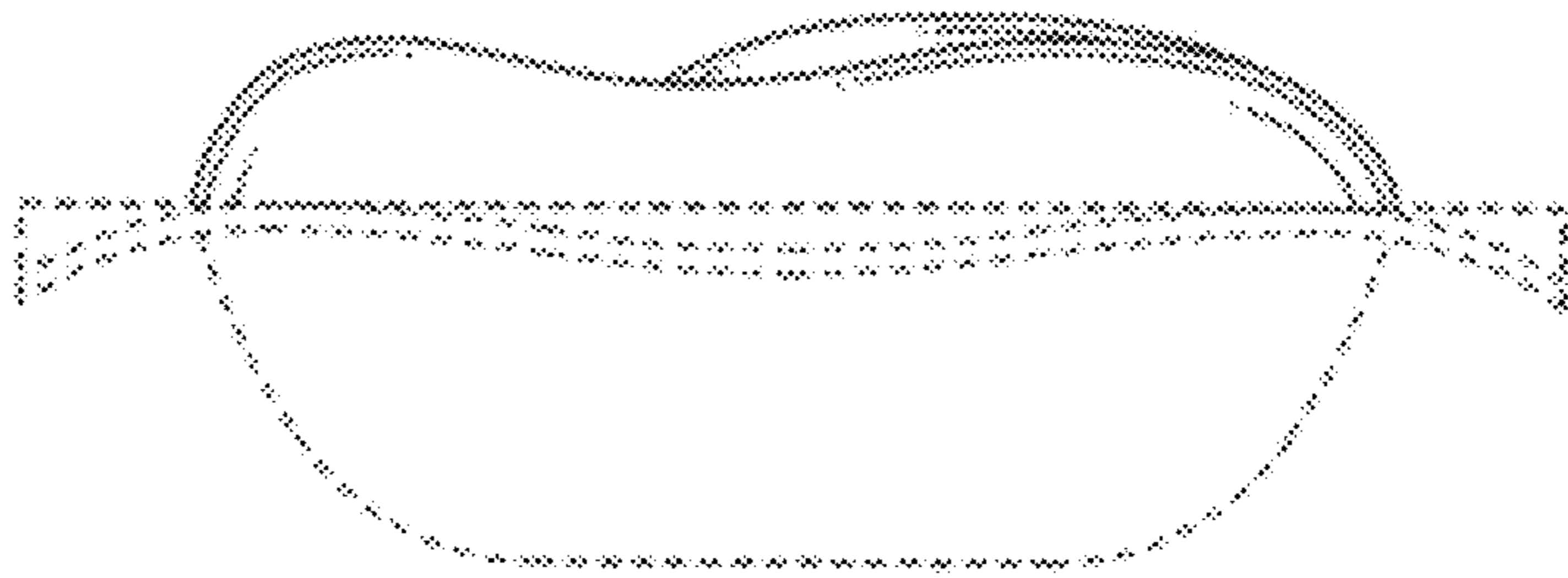

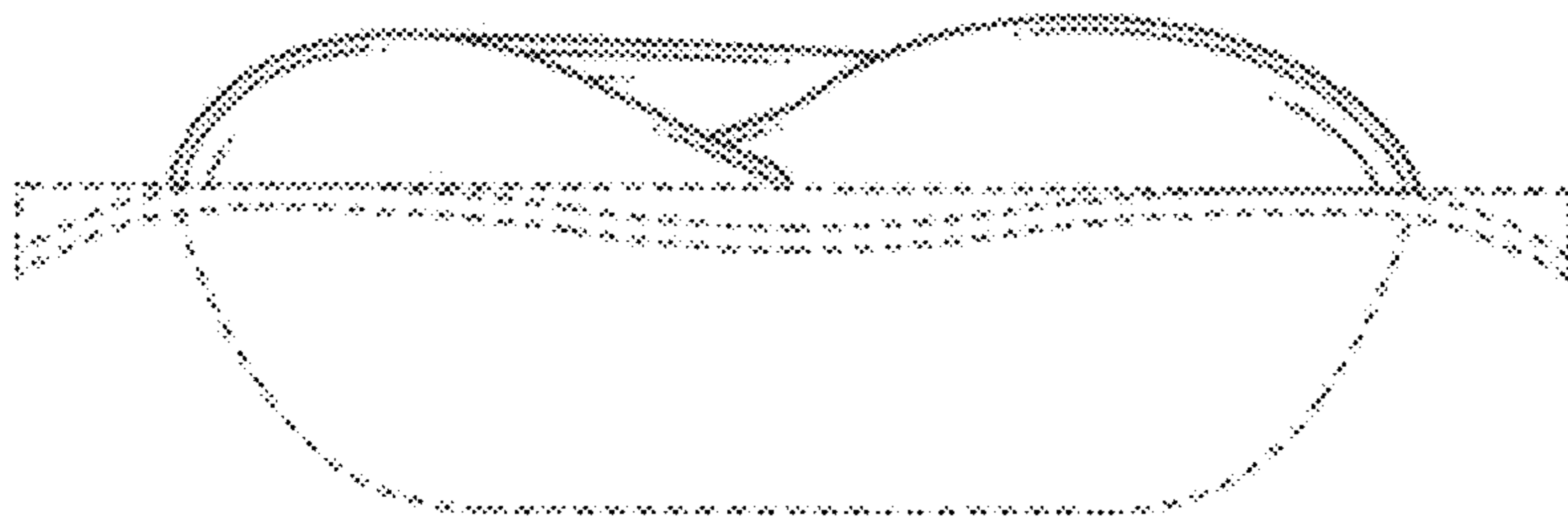

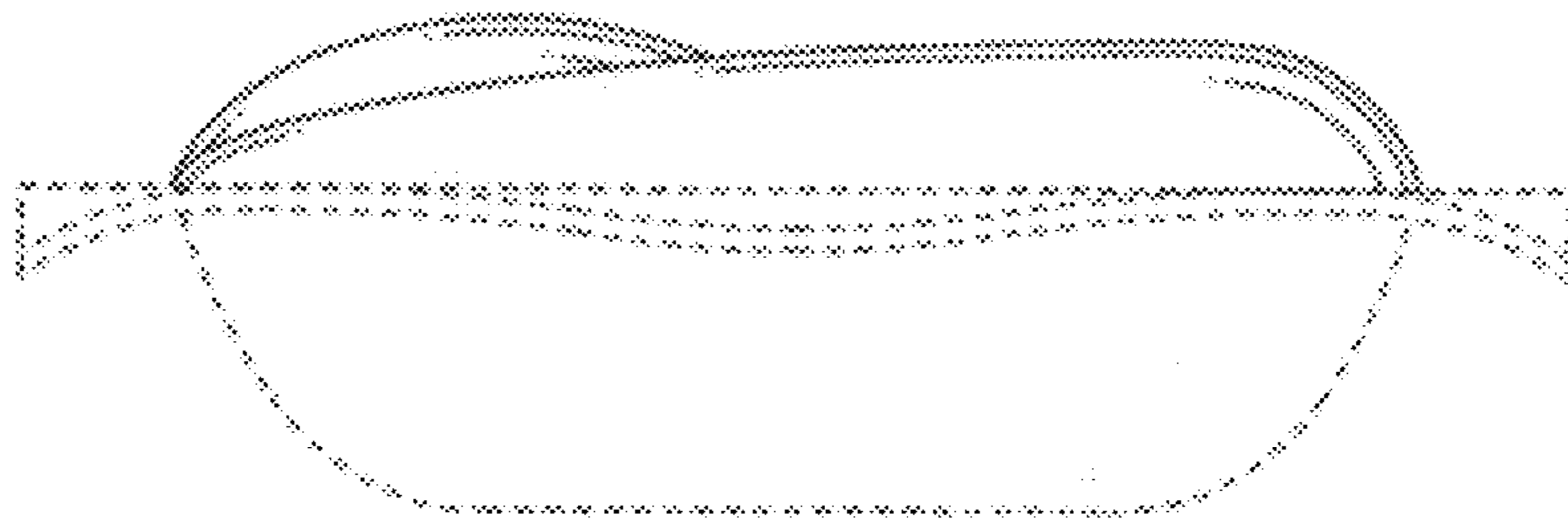

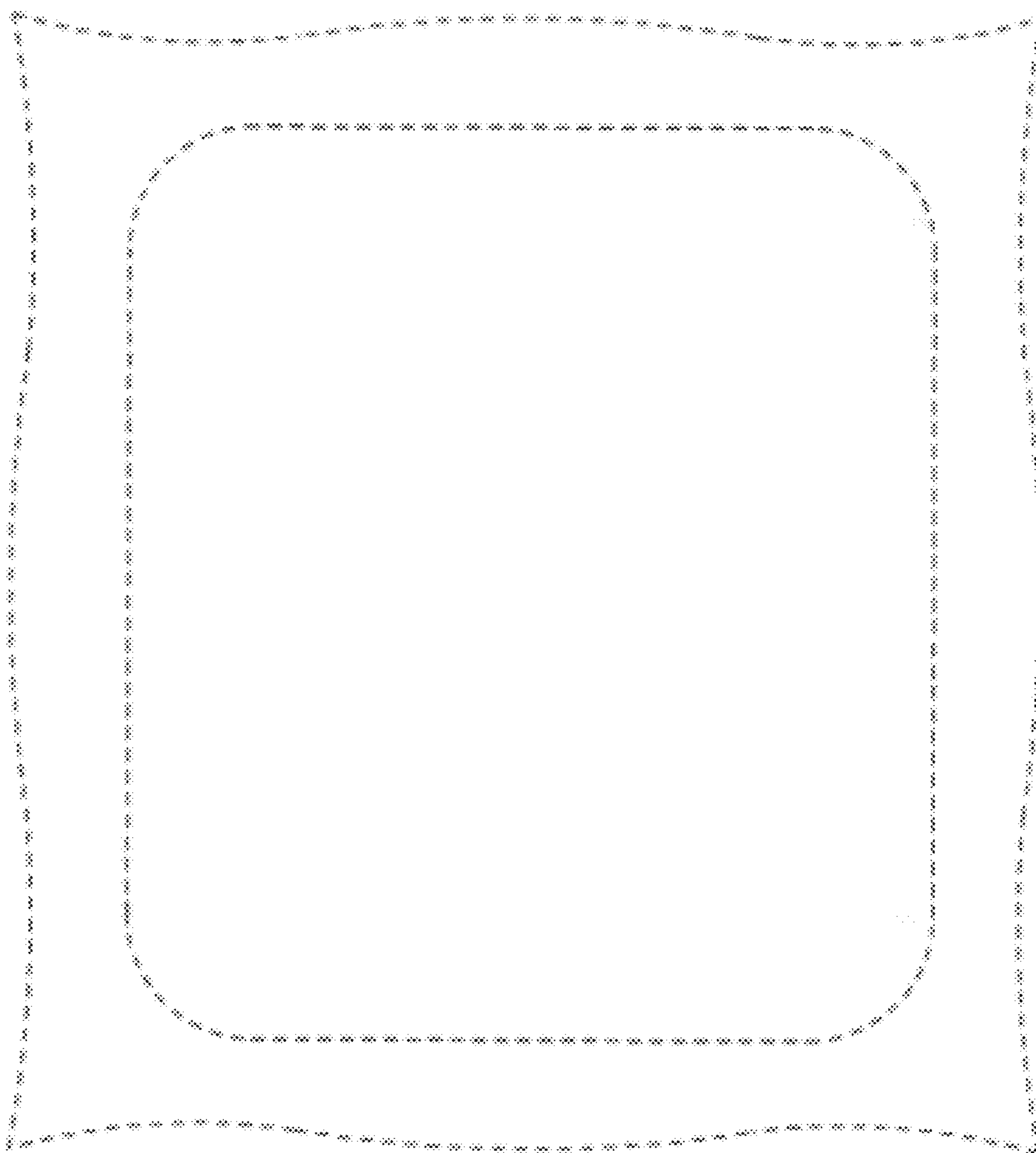

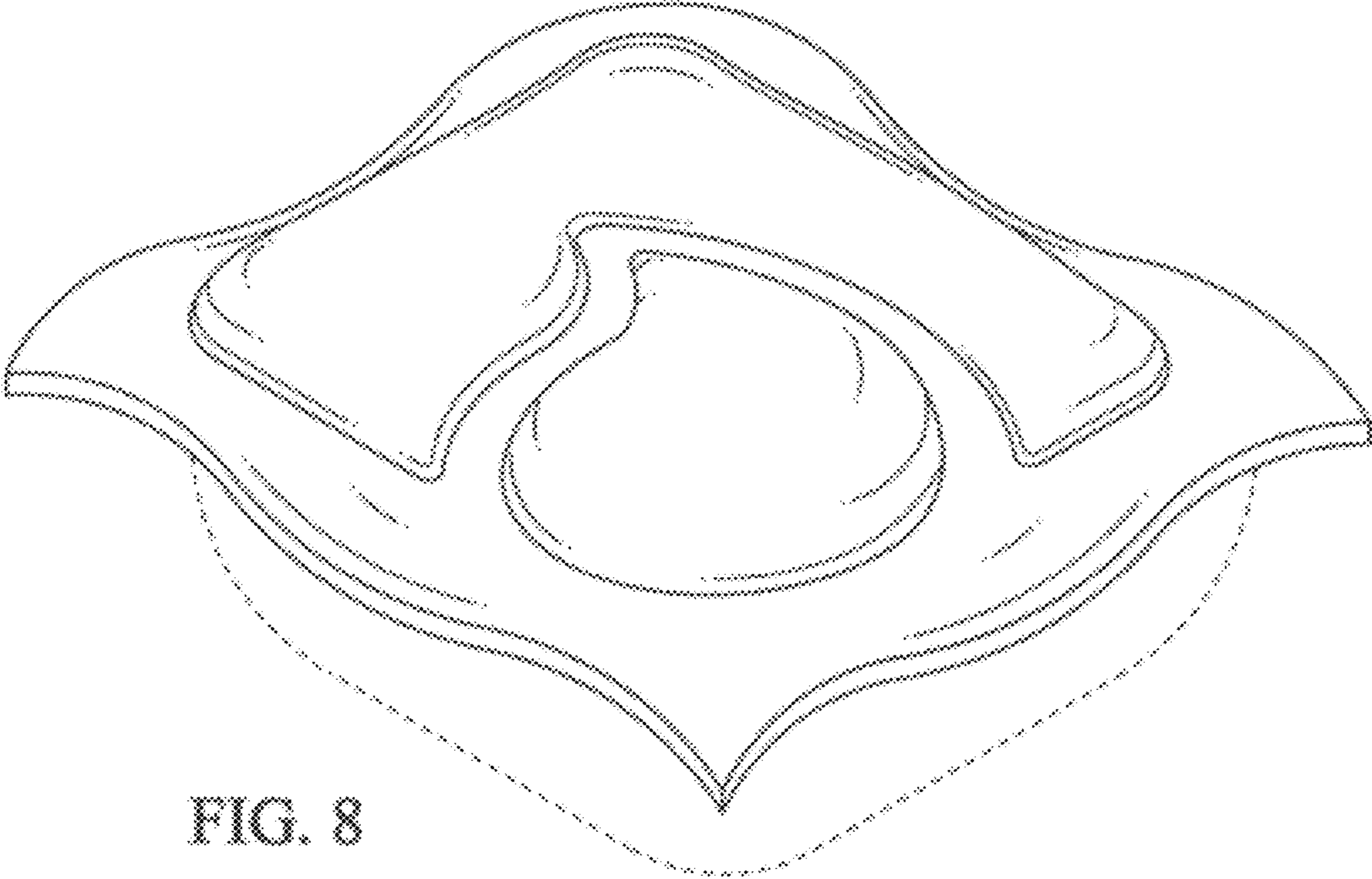

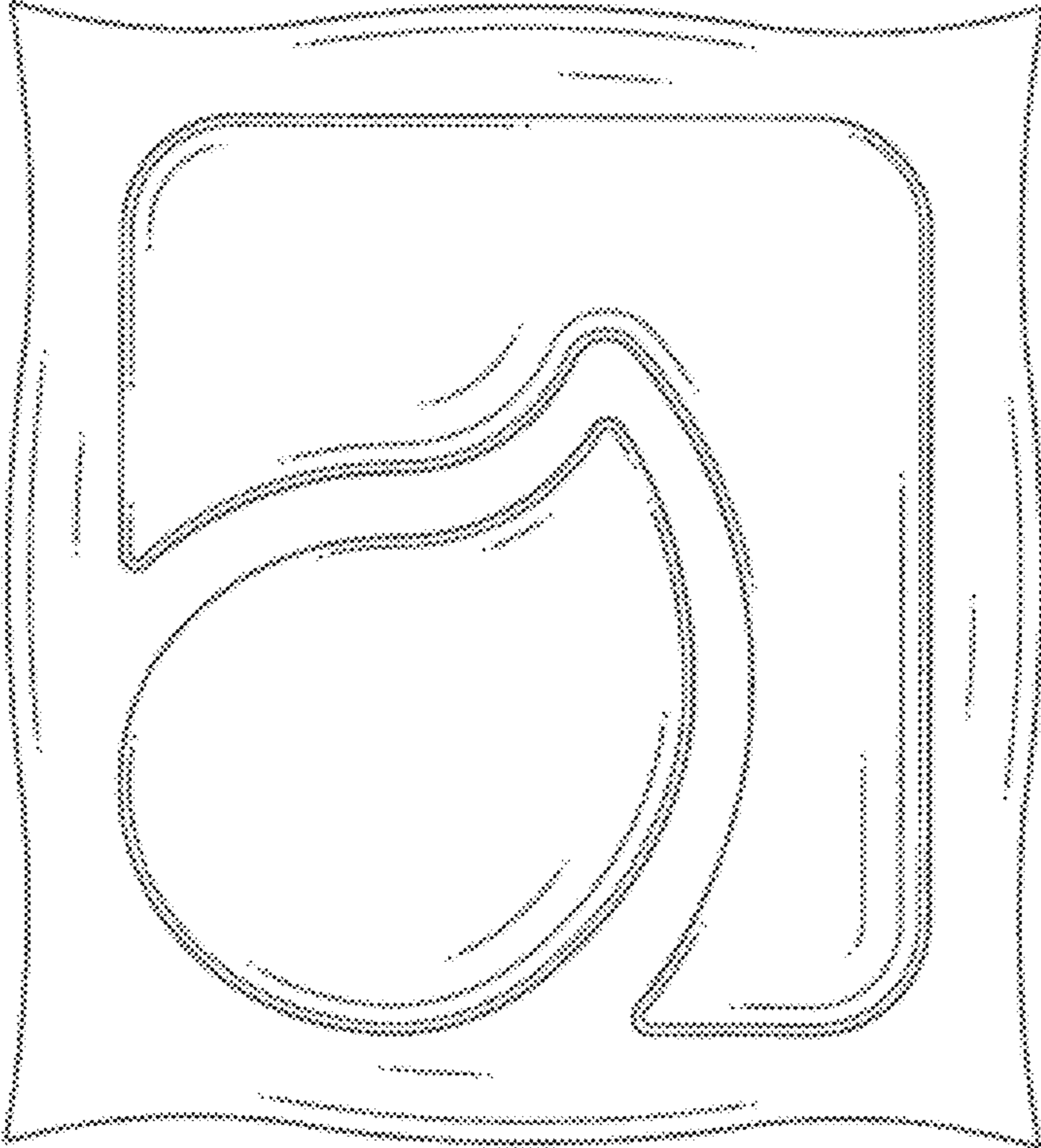

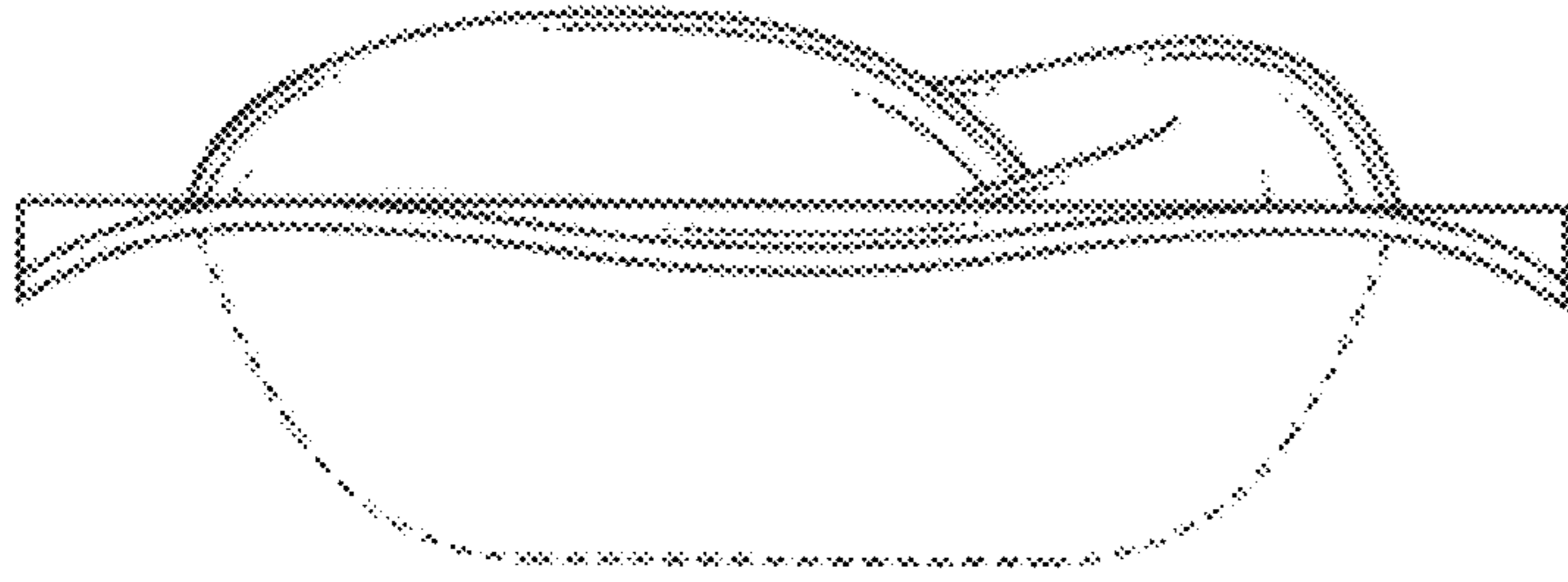

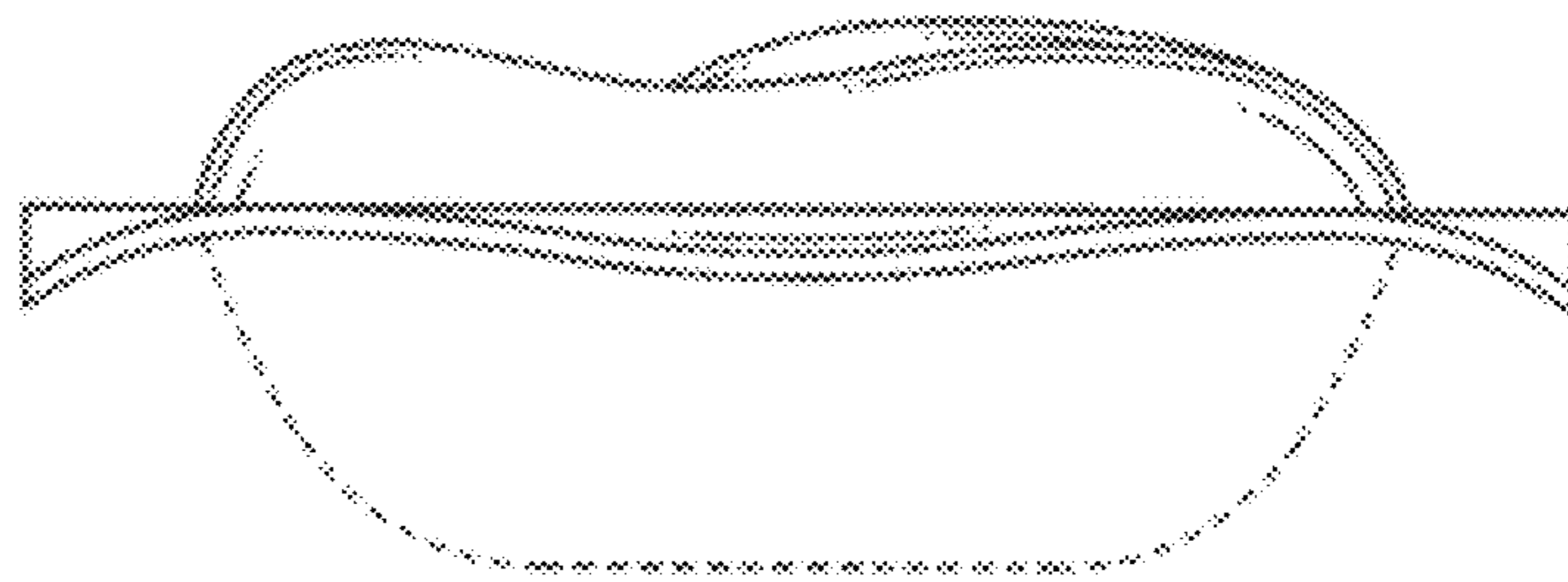

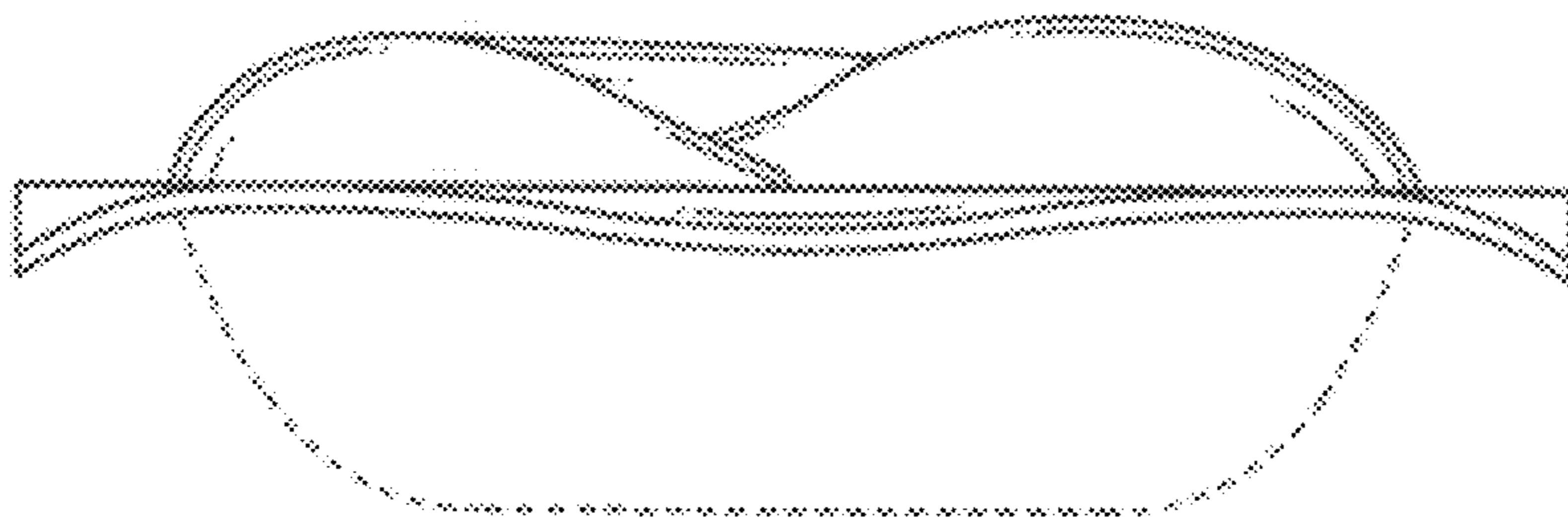

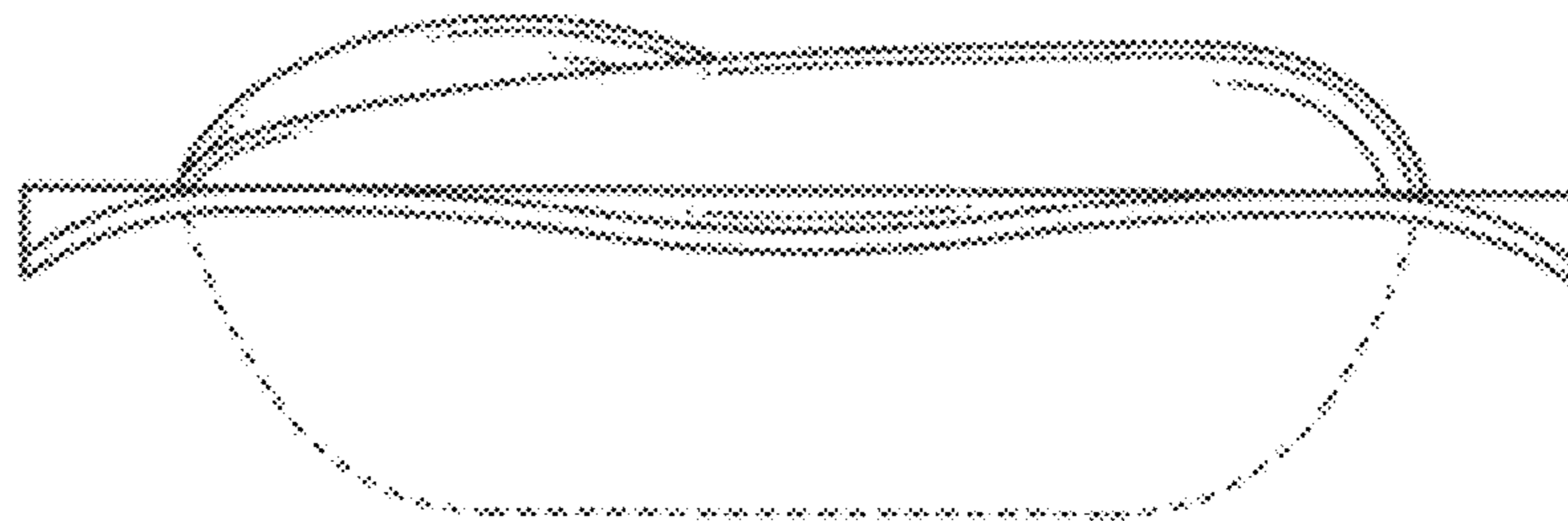

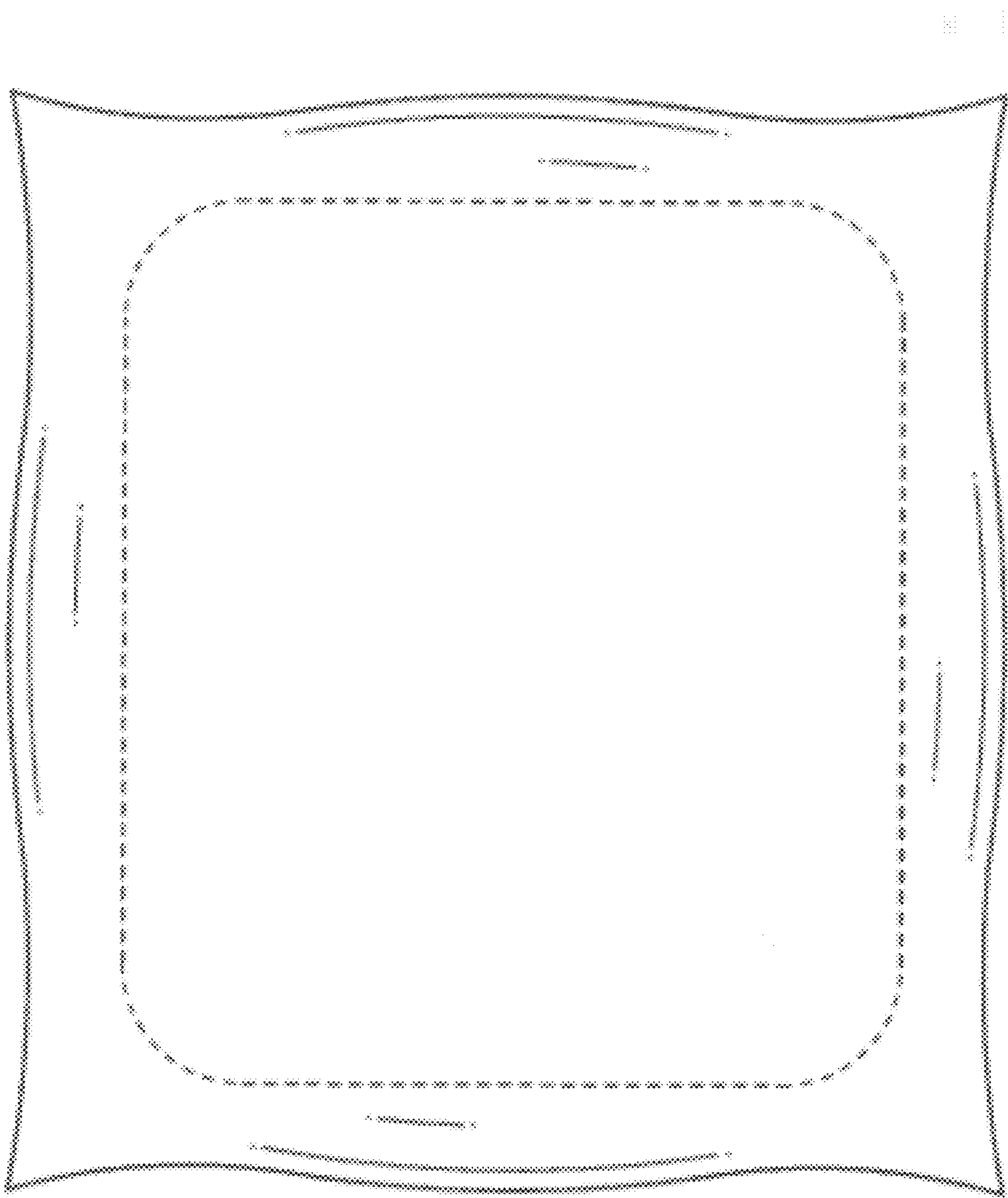
