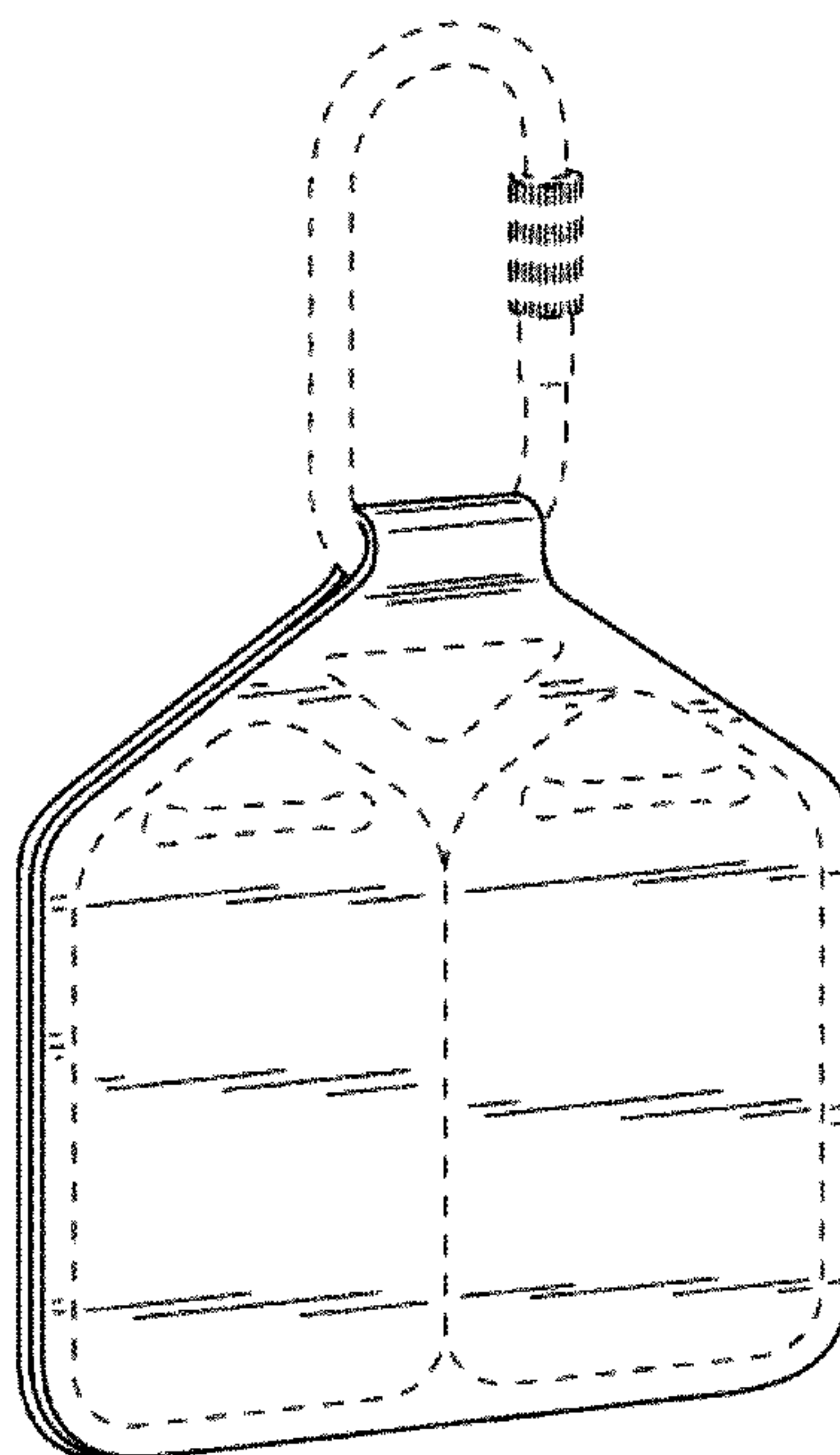
(57) **CLAIM**

The ornamental design for a flexible storage sleeve for holding USB storage devices, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a flexible storage sleeve for holding USB storage devices;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a left elevation view thereof;  
 FIG. 4 is a front elevation view thereof;  
 FIG. 5 is a right elevation view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a rear elevation view thereof;  
 FIG. 8 is a front perspective view of a flexible storage sleeve for holding USB storage devices according to another embodiment;  
 FIG. 9 is a top plan view of the flexible storage sleeve for holding USB storage devices of FIG. 8;  
 FIG. 10 is a left elevation view of the flexible storage sleeve for holding USB storage devices of FIG. 8;  
 FIG. 11 is a front elevation view of the flexible storage sleeve for holding USB storage devices of FIG. 8;  
 FIG. 12 is a right elevation view of the flexible storage sleeve for holding USB storage devices of FIG. 8;  
 FIG. 13 is a bottom plan view of the flexible storage sleeve for holding USB storage devices of FIG. 8; and,  
 FIG. 14 is a rear elevation view of the flexible storage sleeve for holding USB storage devices of FIG. 8.

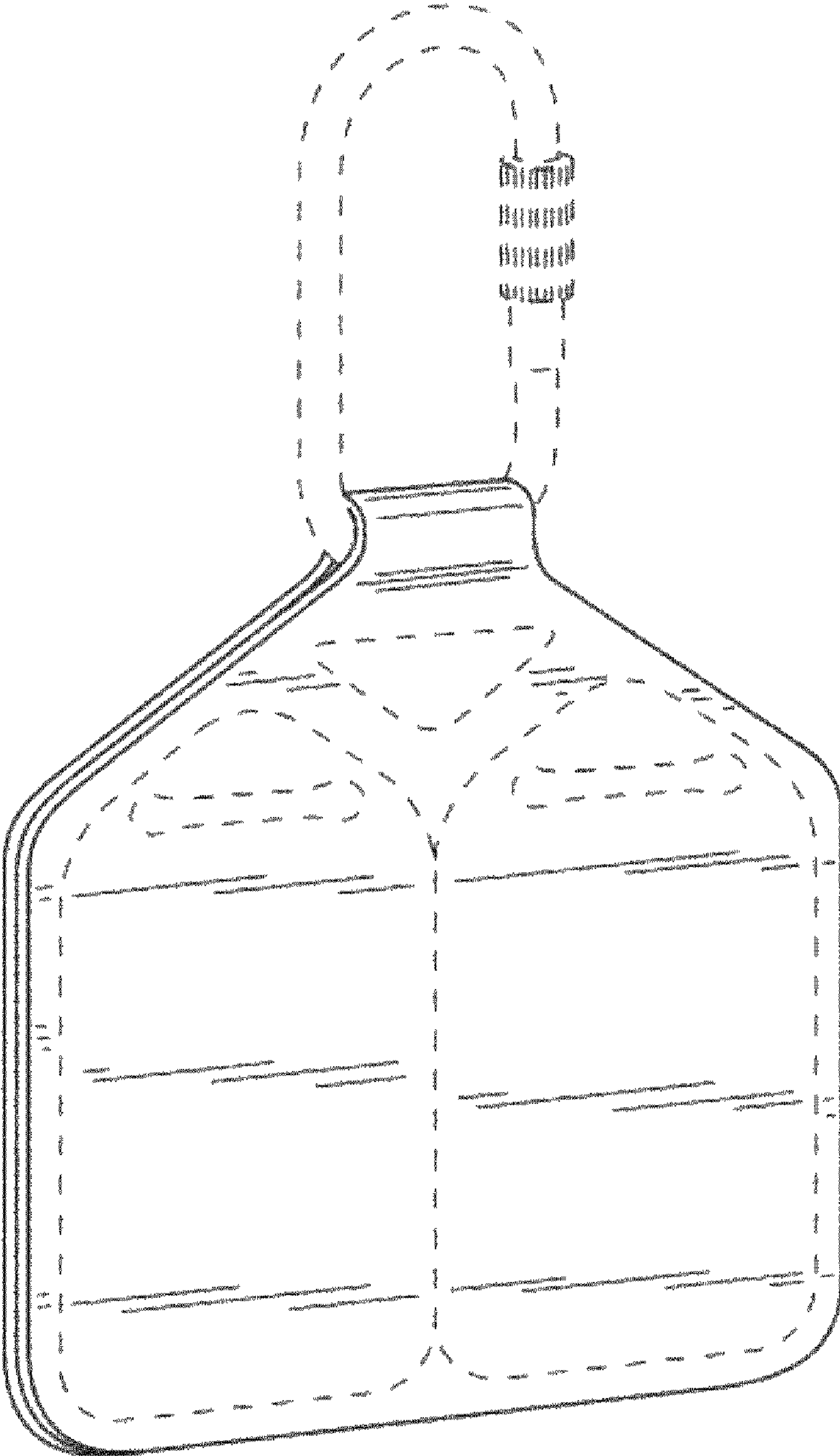

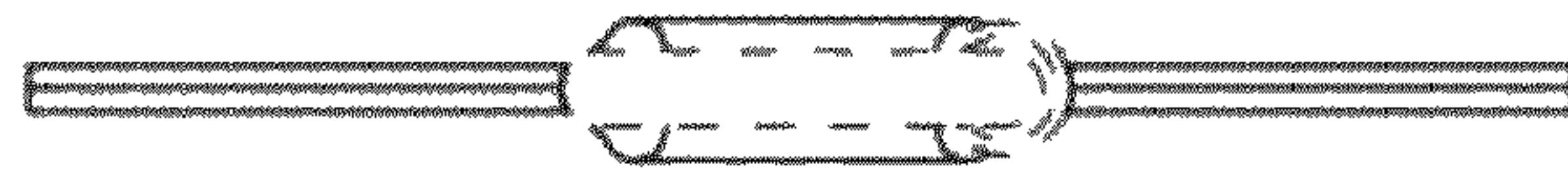

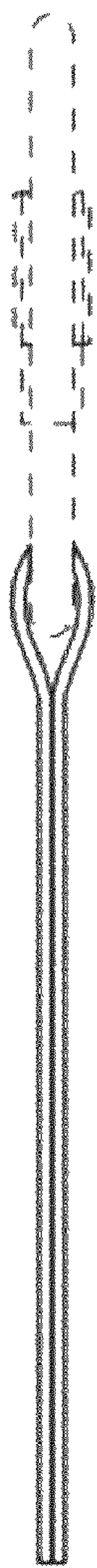

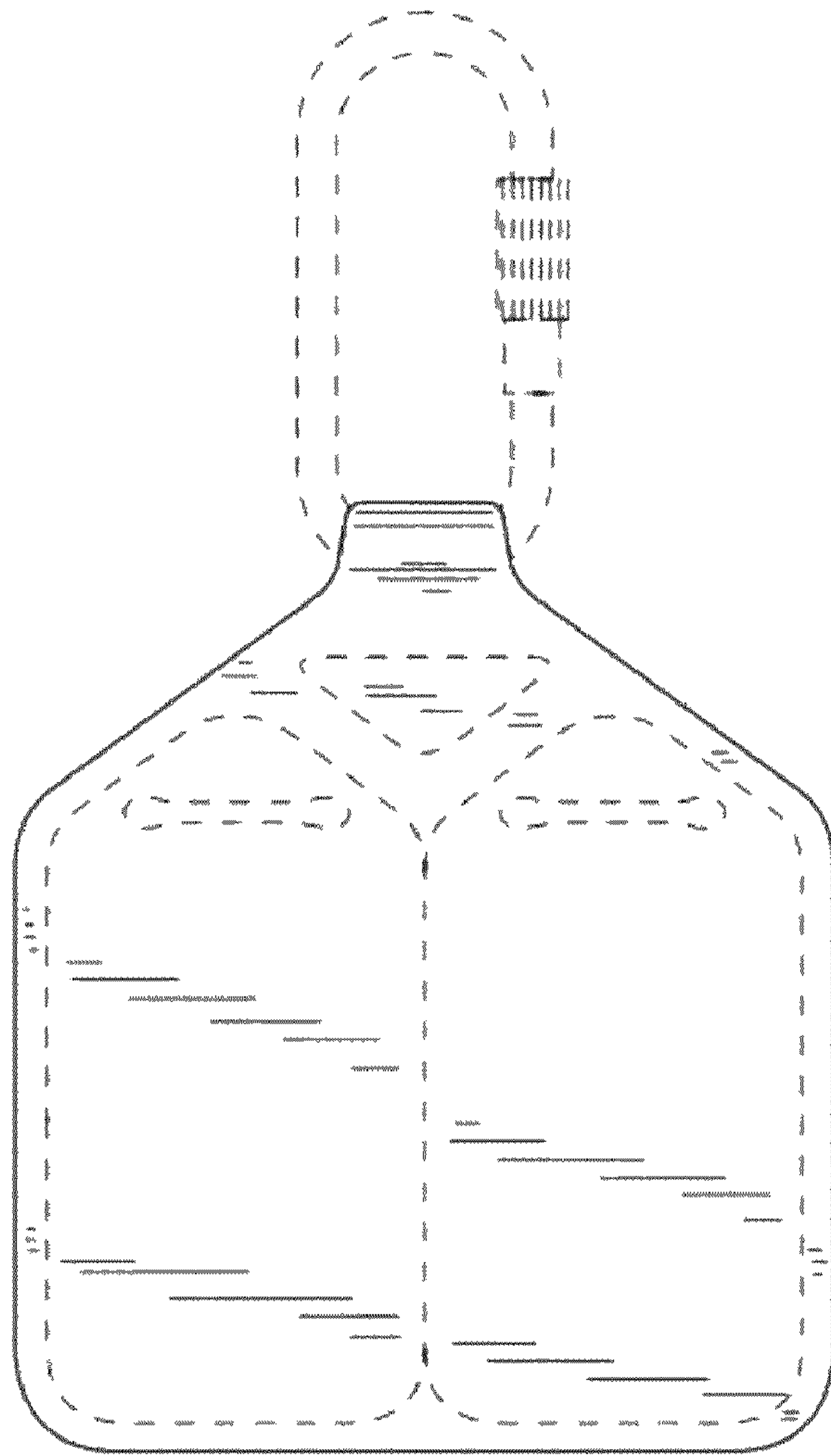

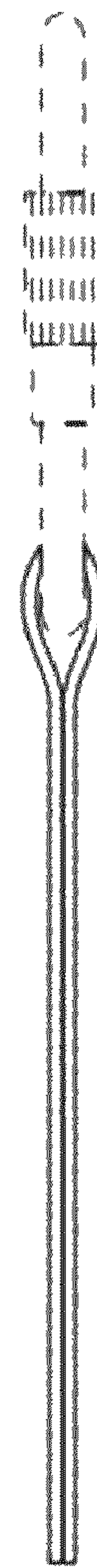

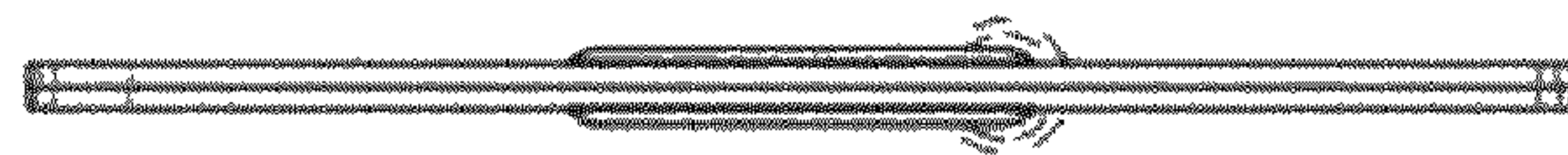

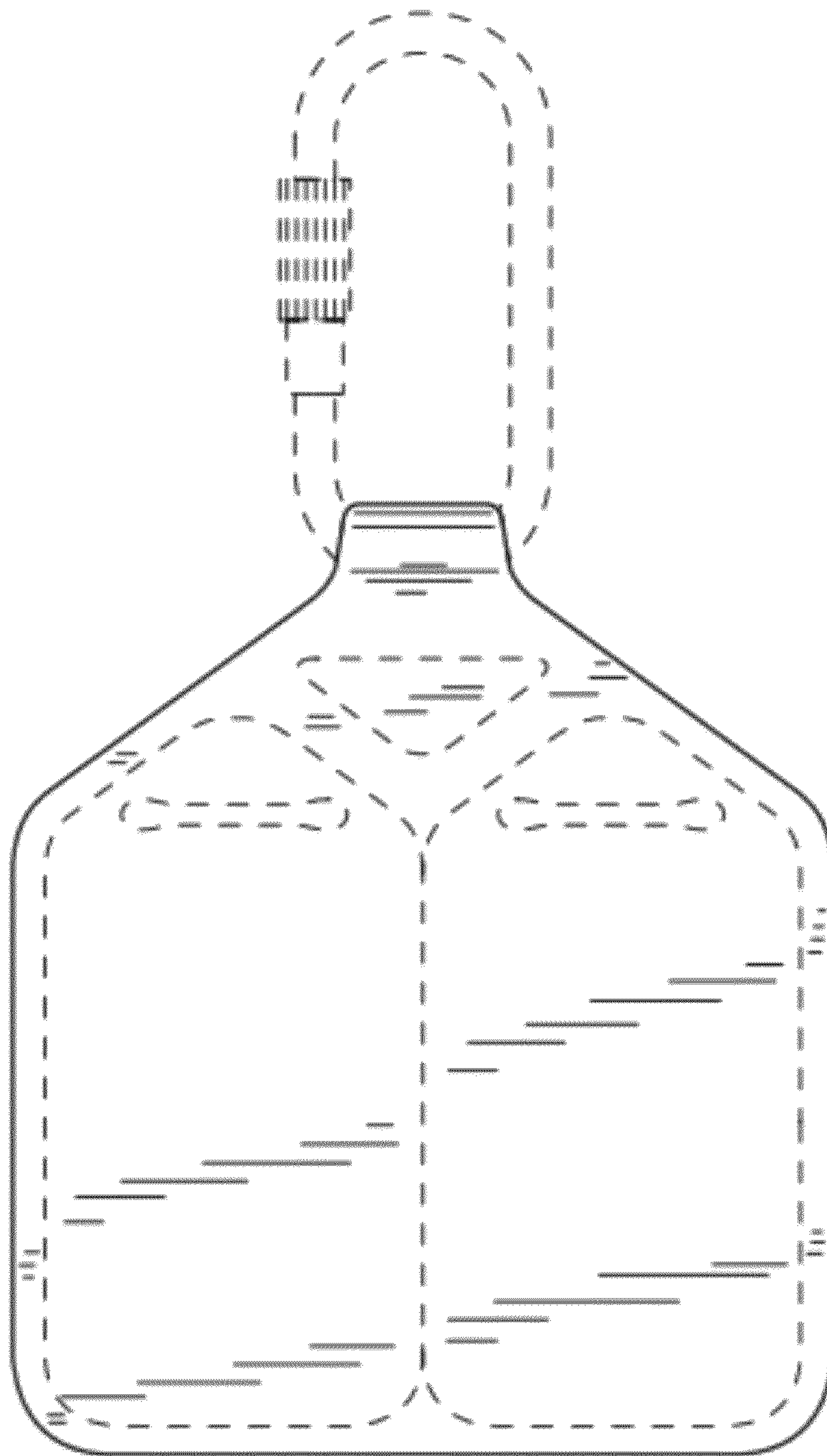

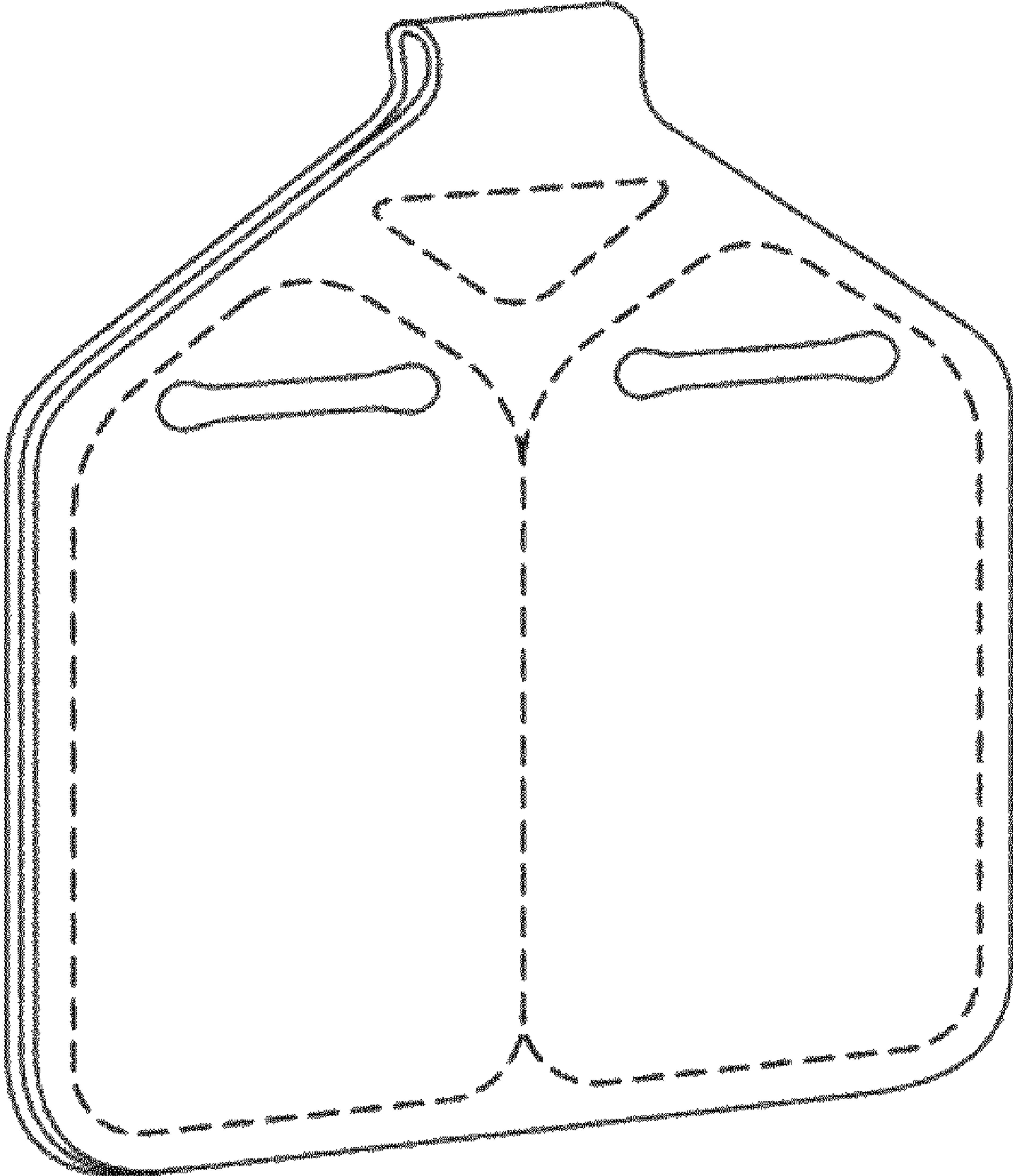

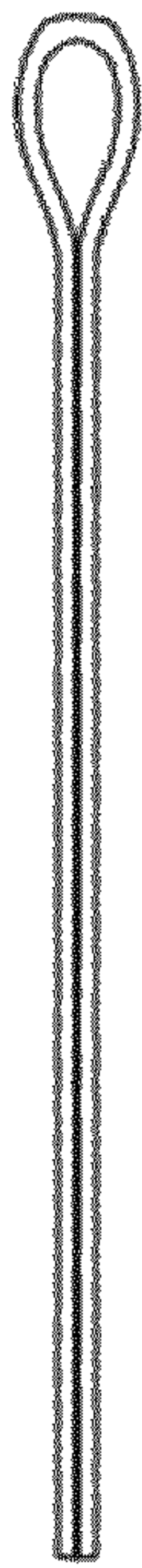

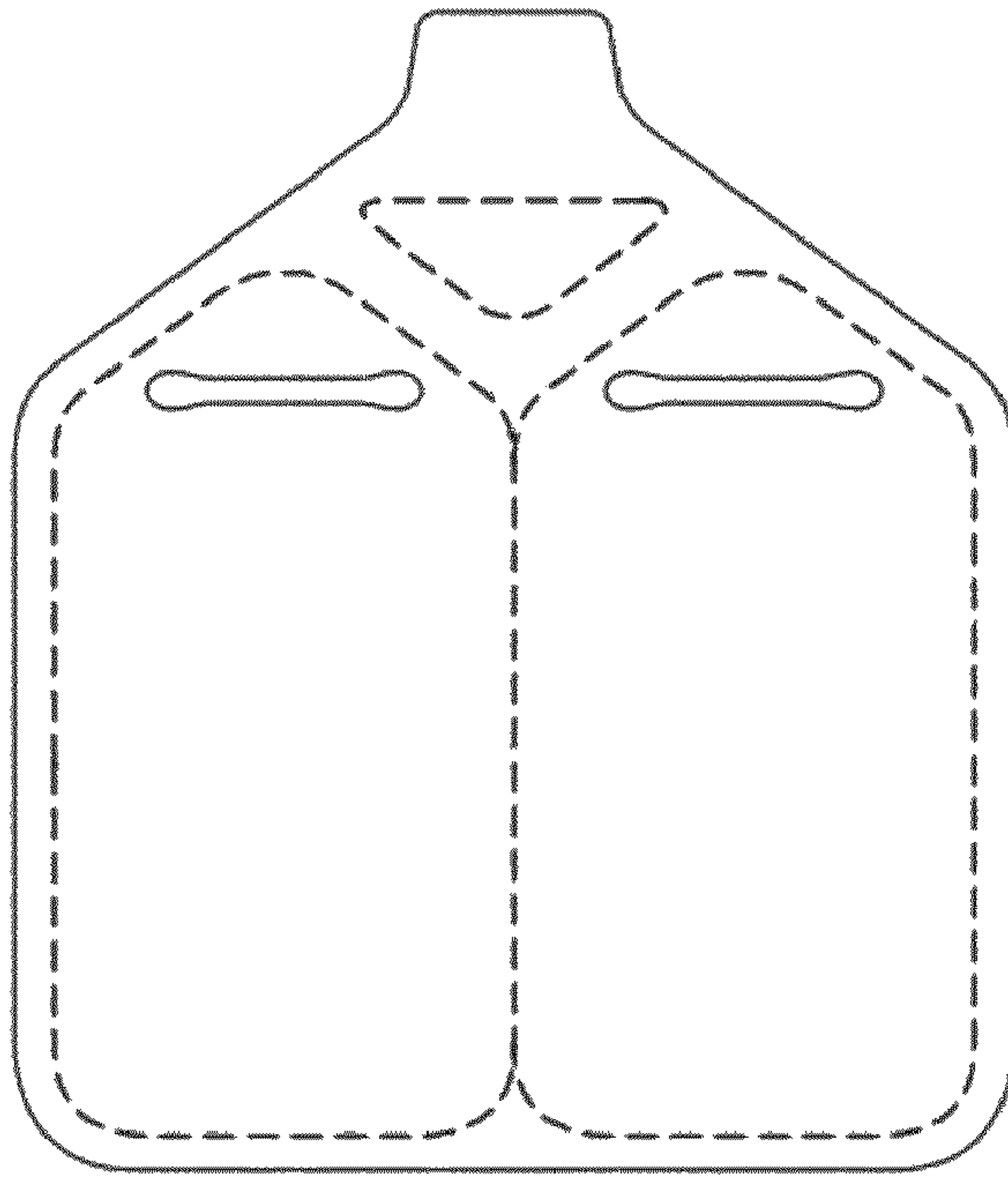

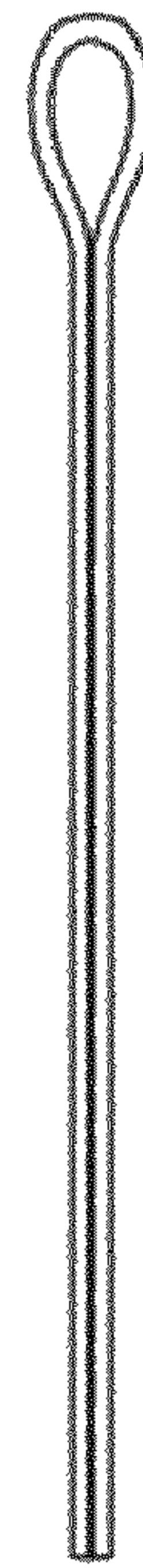

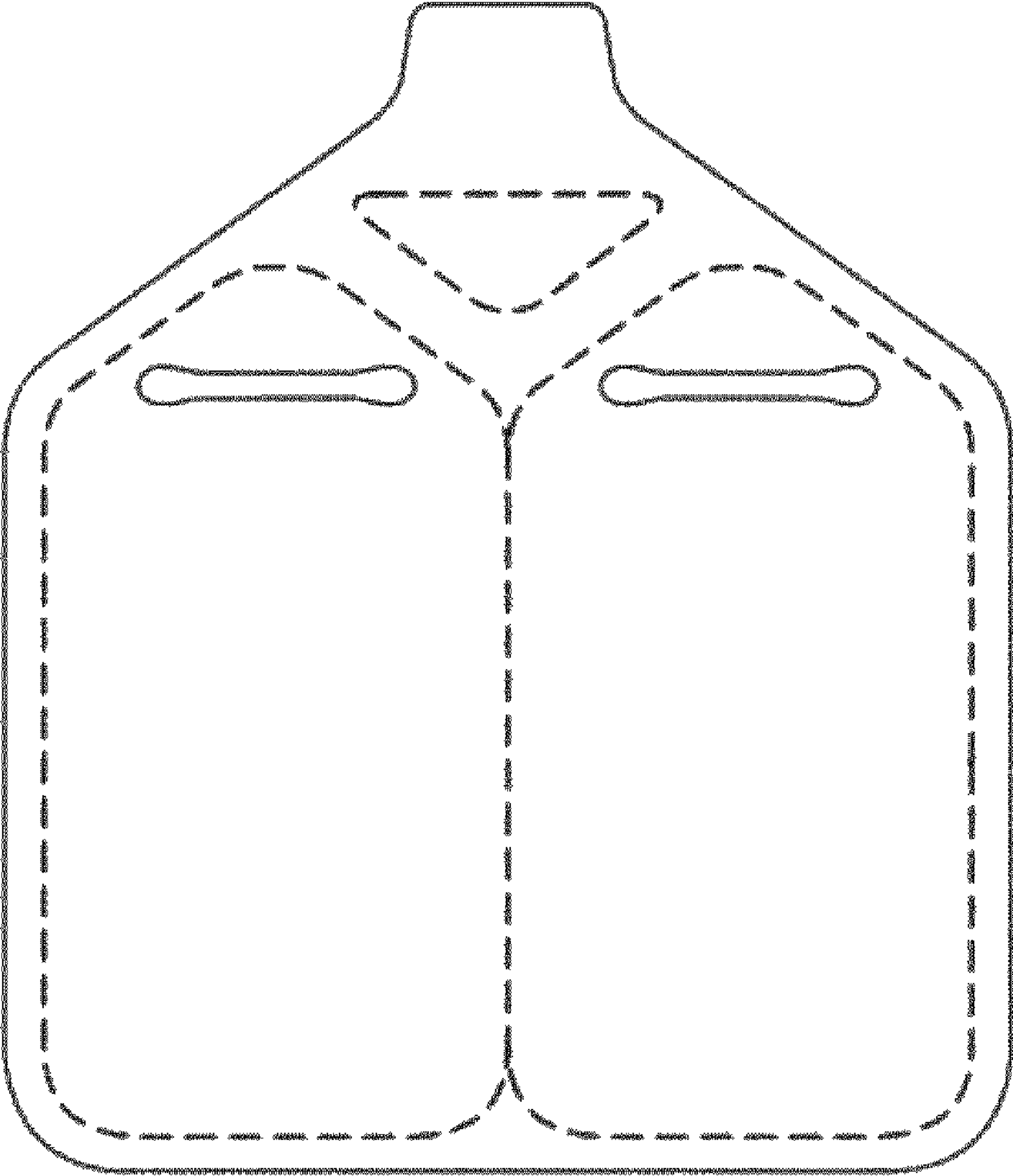
