(57) **CLAIM**

What is claimed is the ornamental design for a substrate with a predator skull camouflage pattern, as shown and described.

DESCRIPTION

The sole FIGURE is a top plan view of a substrate with a predator skull camouflage pattern. The broken line boundary in the drawing shows a single repeat unit.

The broken line perimeter represents the boundaries of the claim and forms no part thereof. The thickness of the design forms no part of the claim.
