(57) **CLAIM**

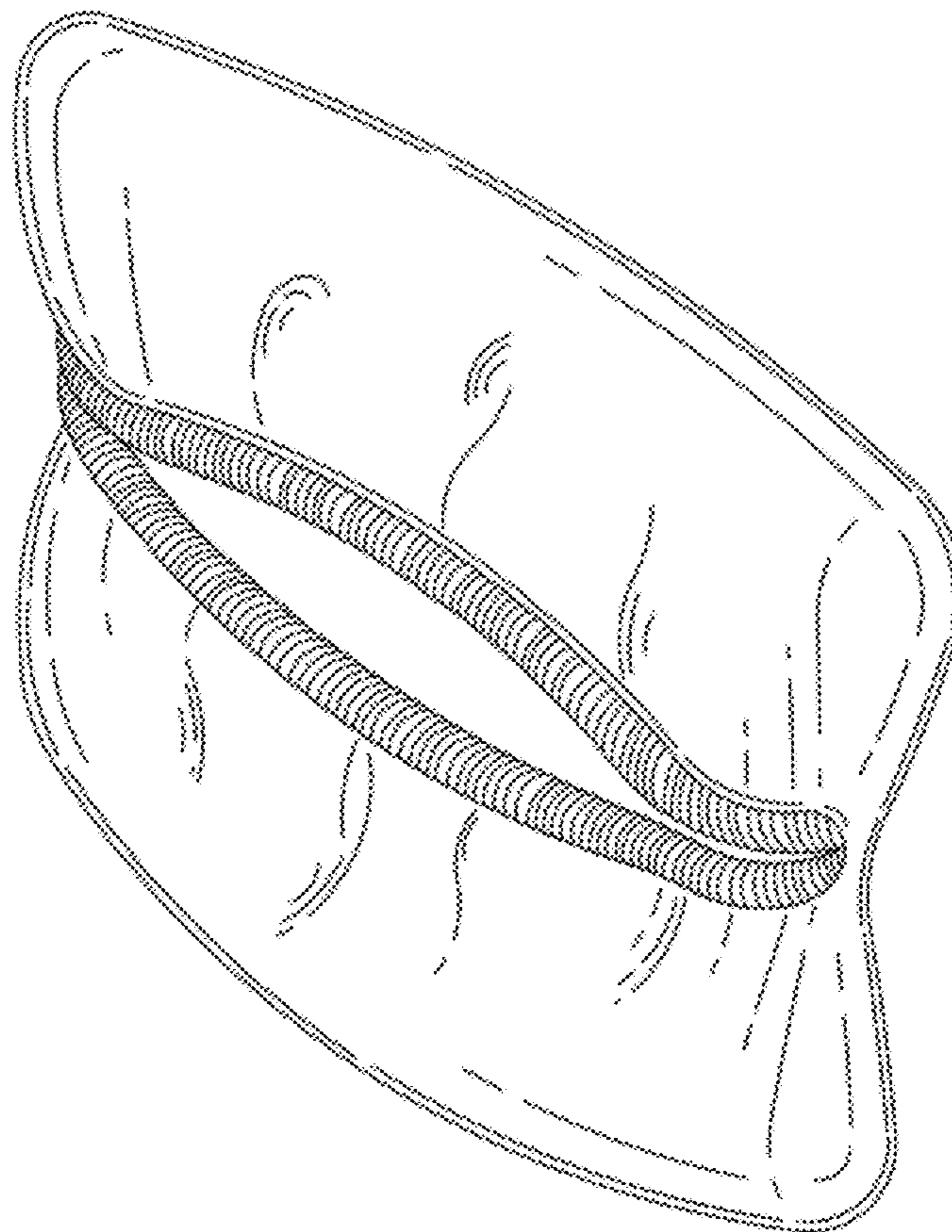
The ornamental design for a pillow cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the pillow cover;  
FIG. 2 is a back view of the pillow cover, taken from the frame of reference of FIG. 1;  
FIG. 3 is a front view of the pillow cover, taken from the frame of reference of FIG. 1;  
FIG. 4 is a left-side view of the pillow cover, taken from the frame of reference of FIG. 1;  
FIG. 5 is a right-side view of the pillow cover, taken from the frame of reference of FIG. 1;  
FIG. 6 is a top view of the pillow cover, taken from the frame of reference of FIG. 1; and,  
FIG. 7 is a bottom view of the pillow cover, taken from the frame of reference of FIG. 1.

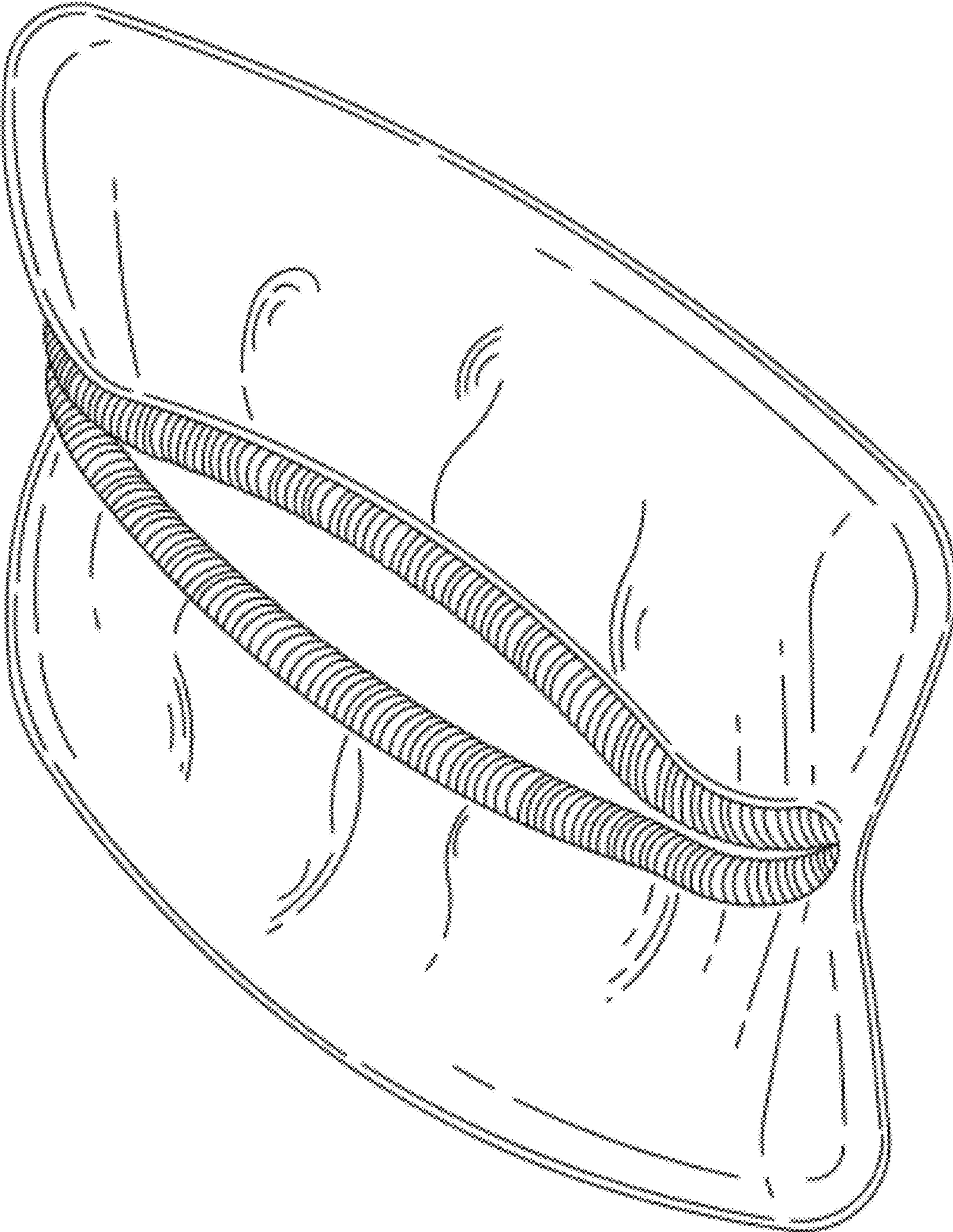

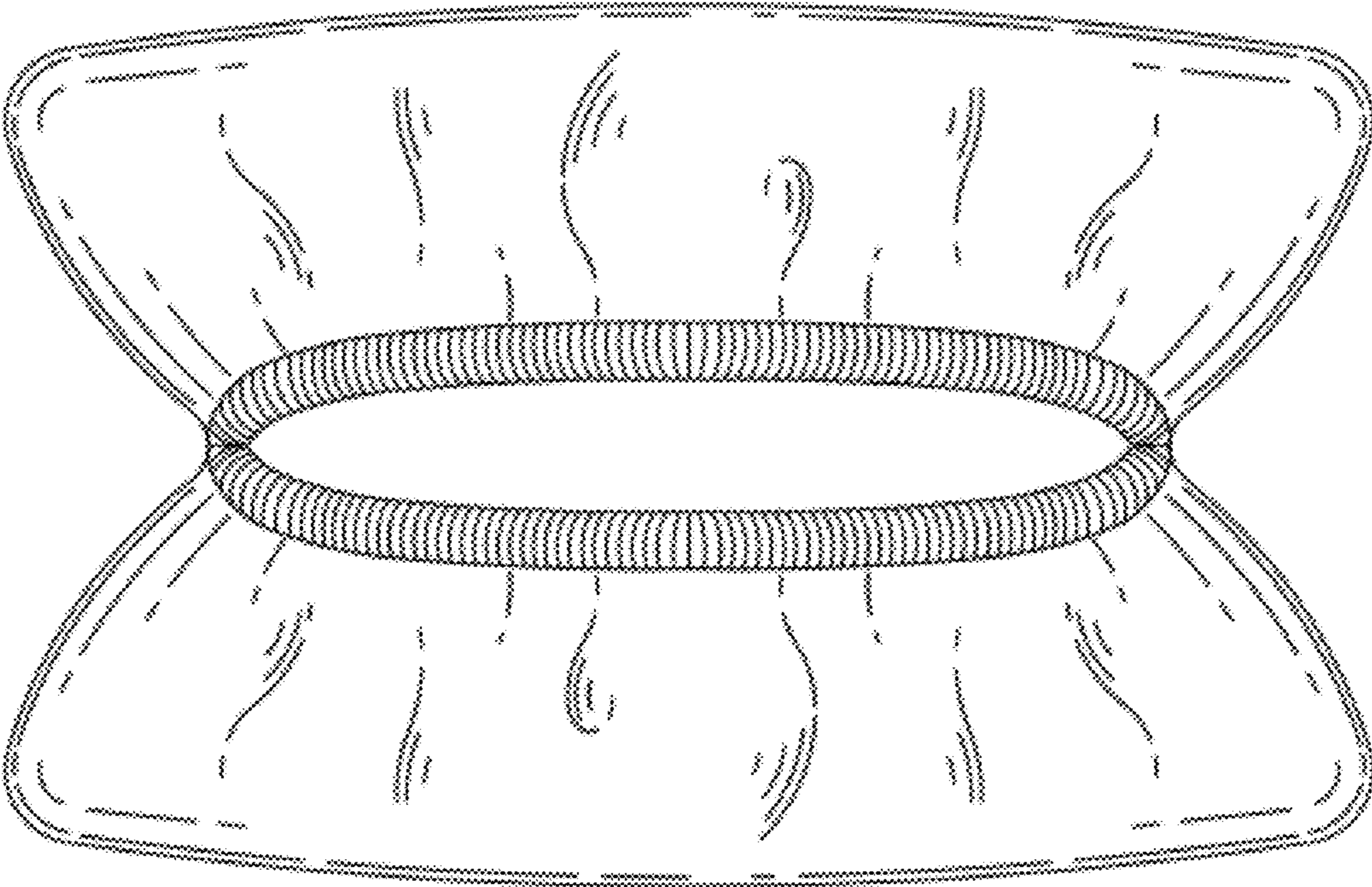

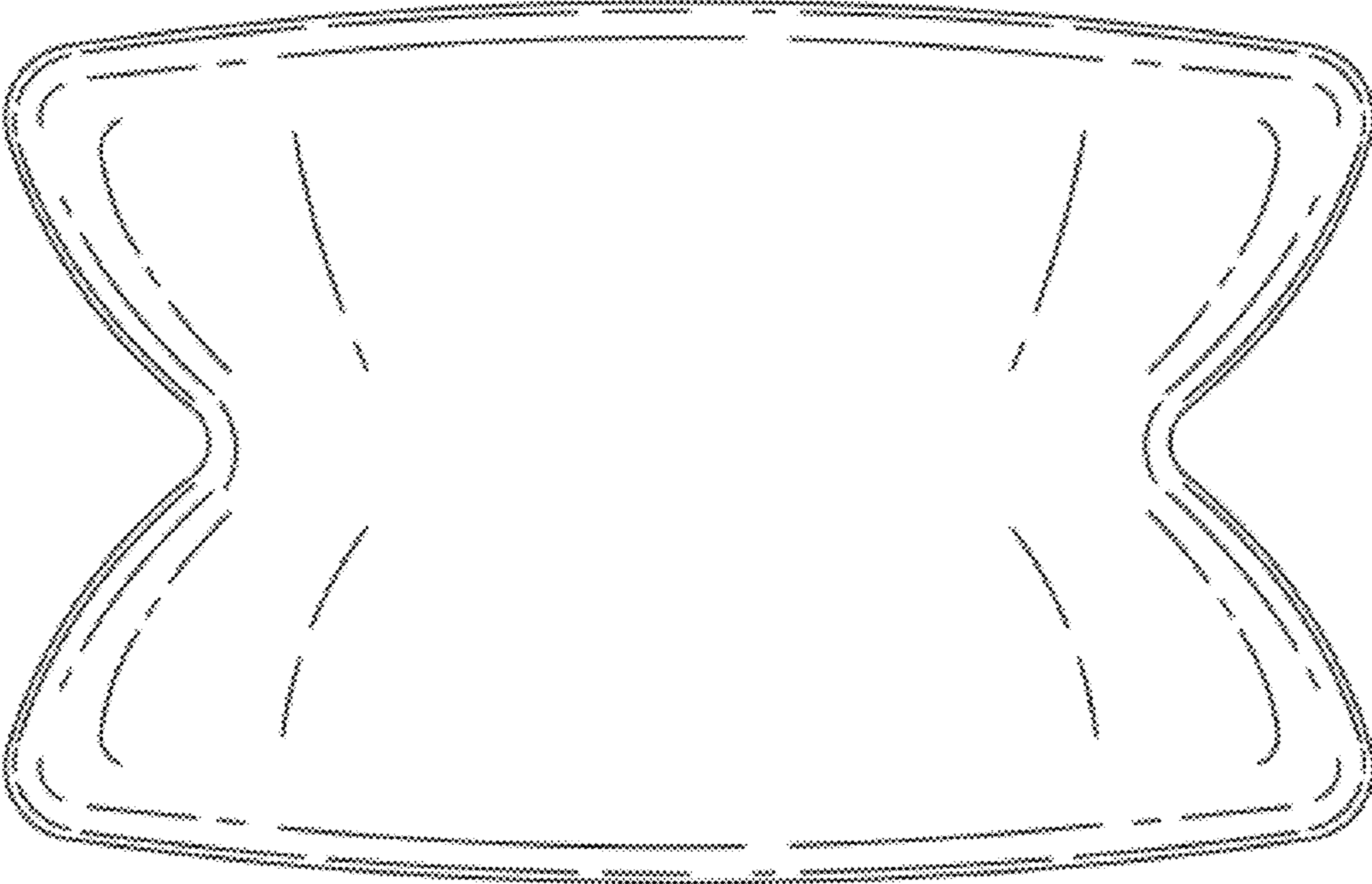

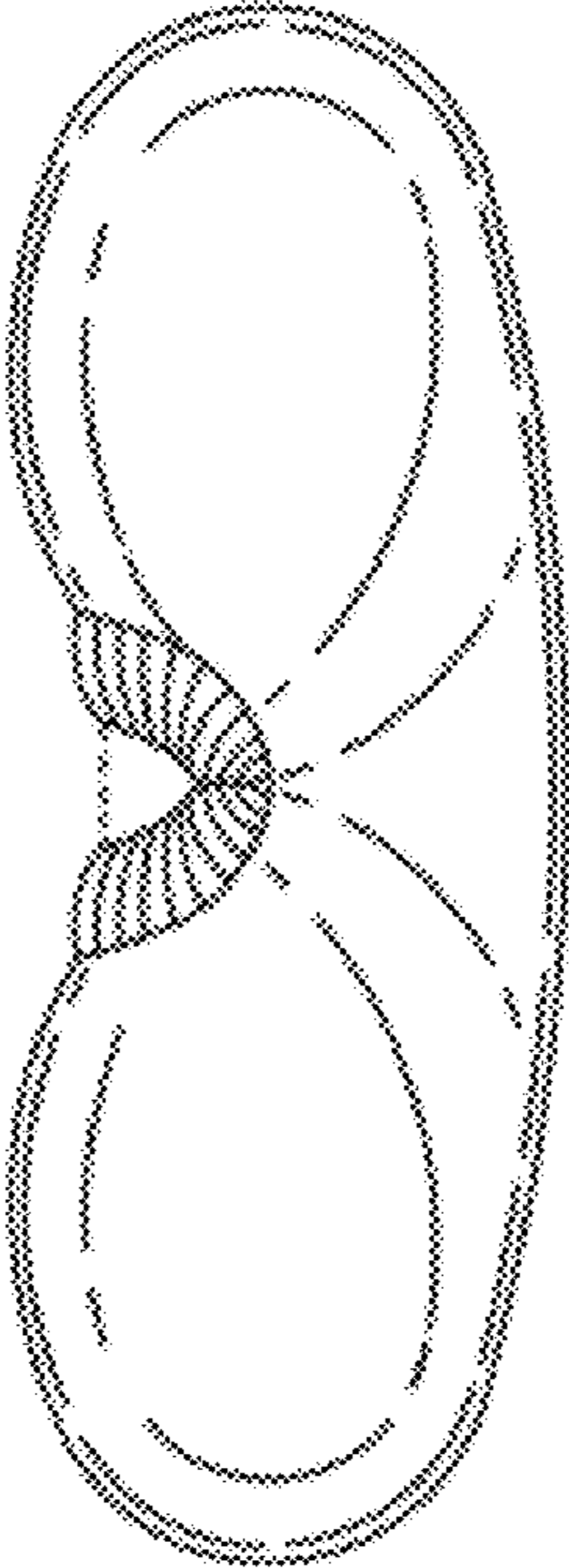

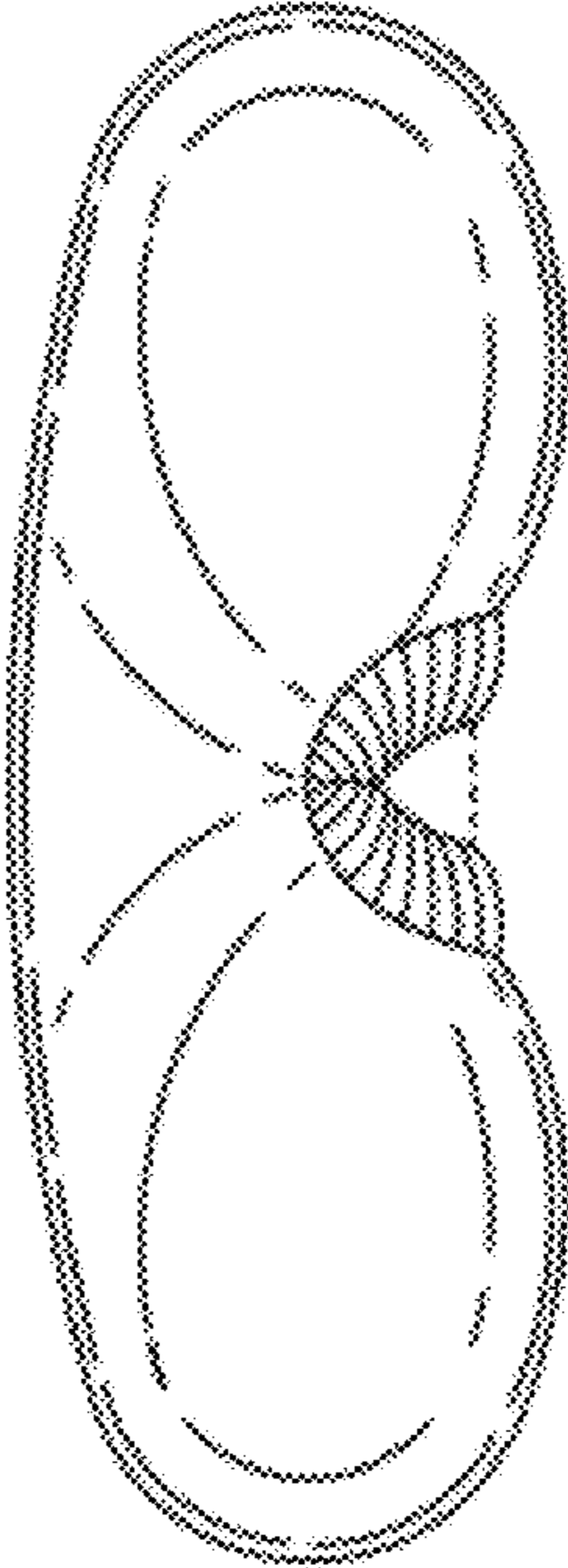

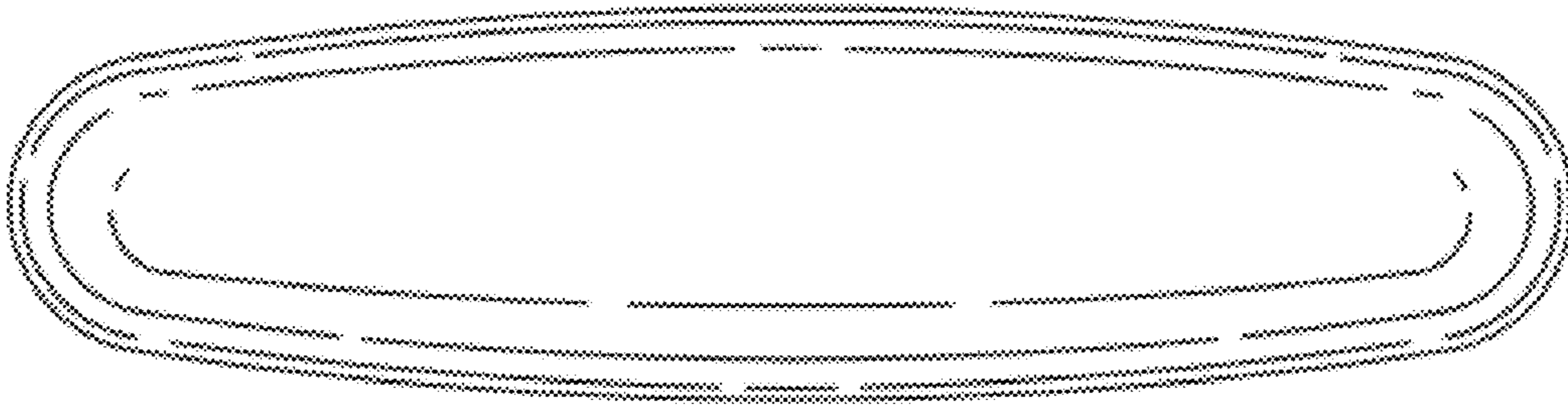
