**DESCRIPTION**

FIG. 1 is a right side of a press nut according to the present invention;

FIG. 2 is a left side view thereof;

FIG. 3 is a top view thereof;

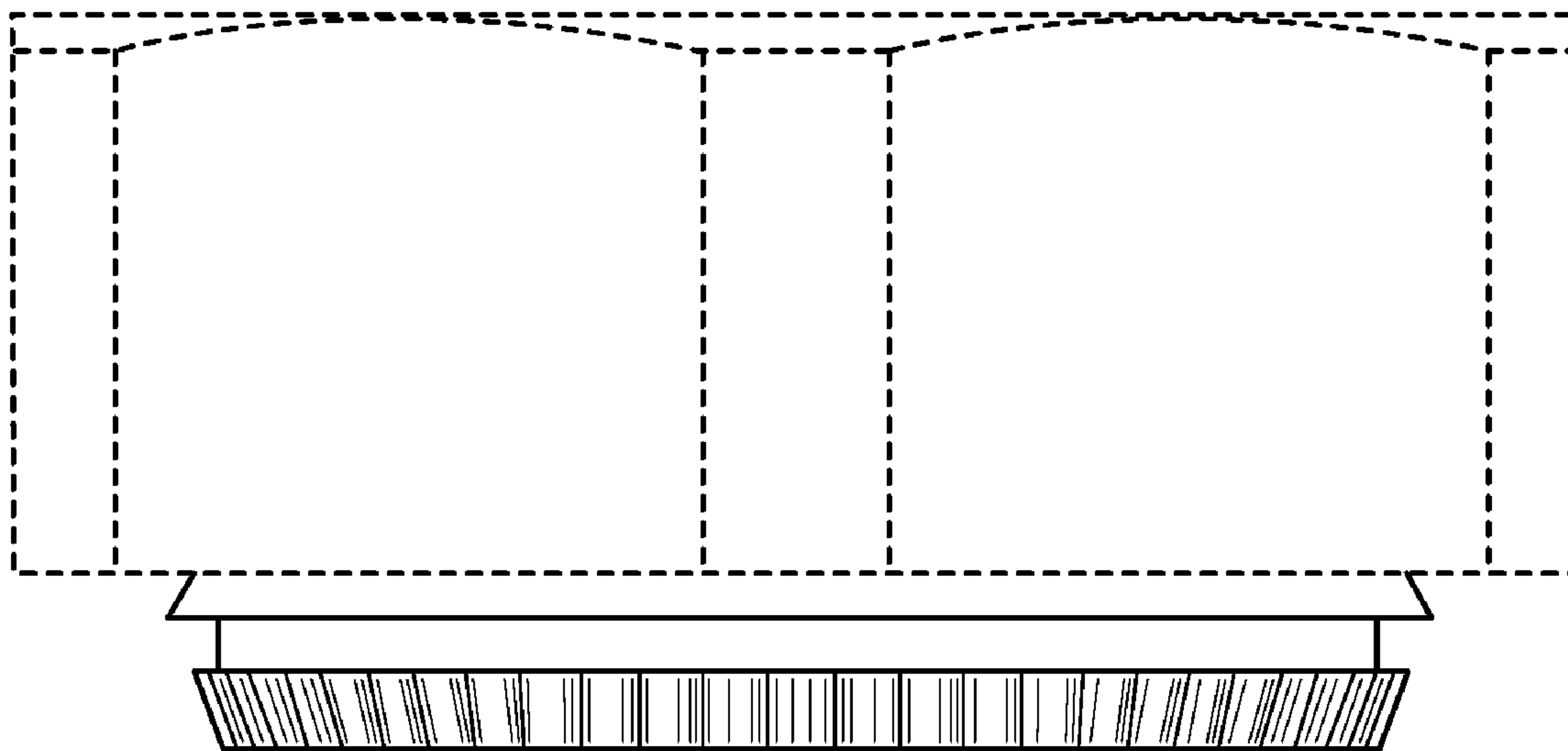
FIG. 4 is a bottom view thereof;

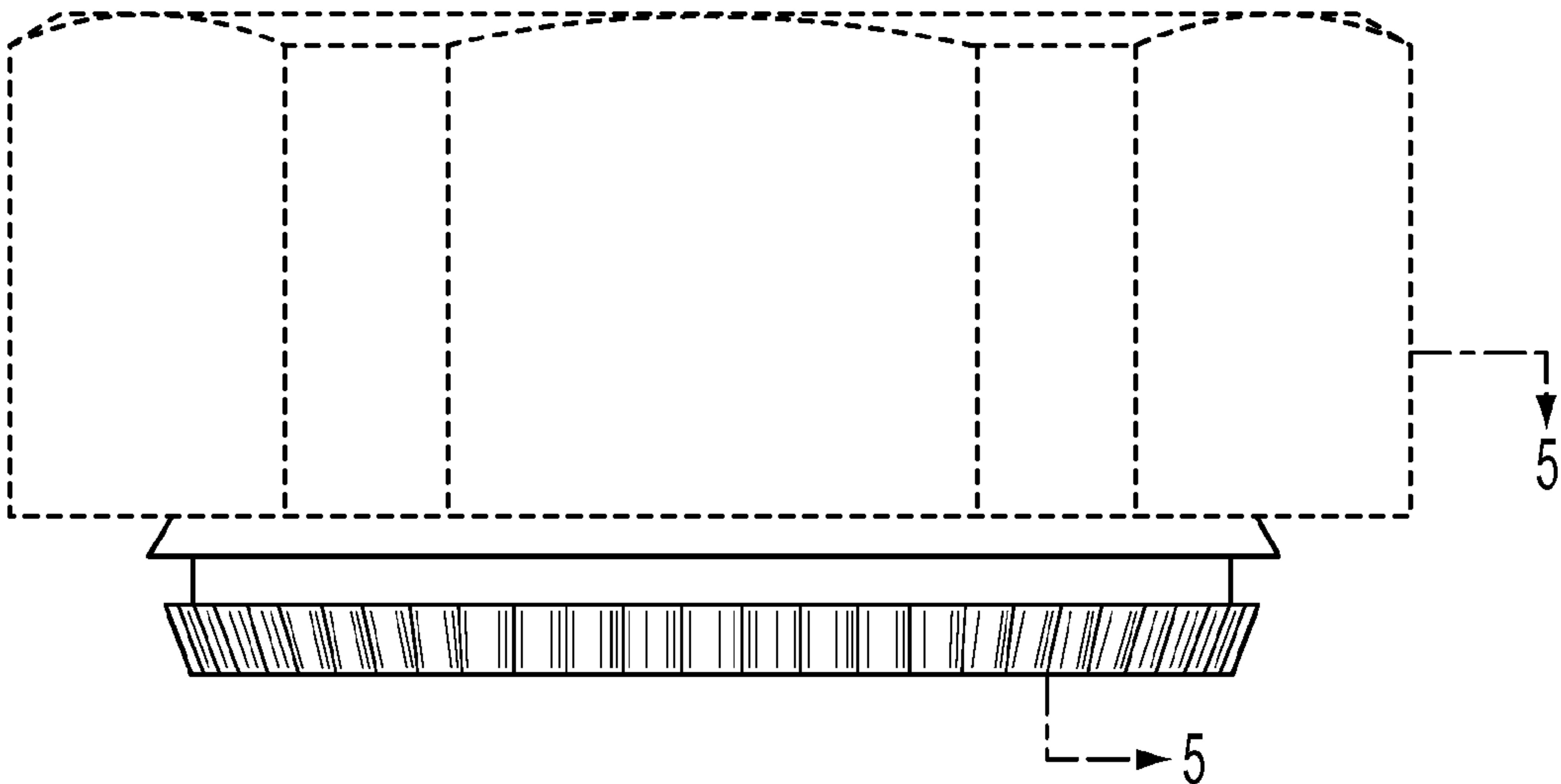

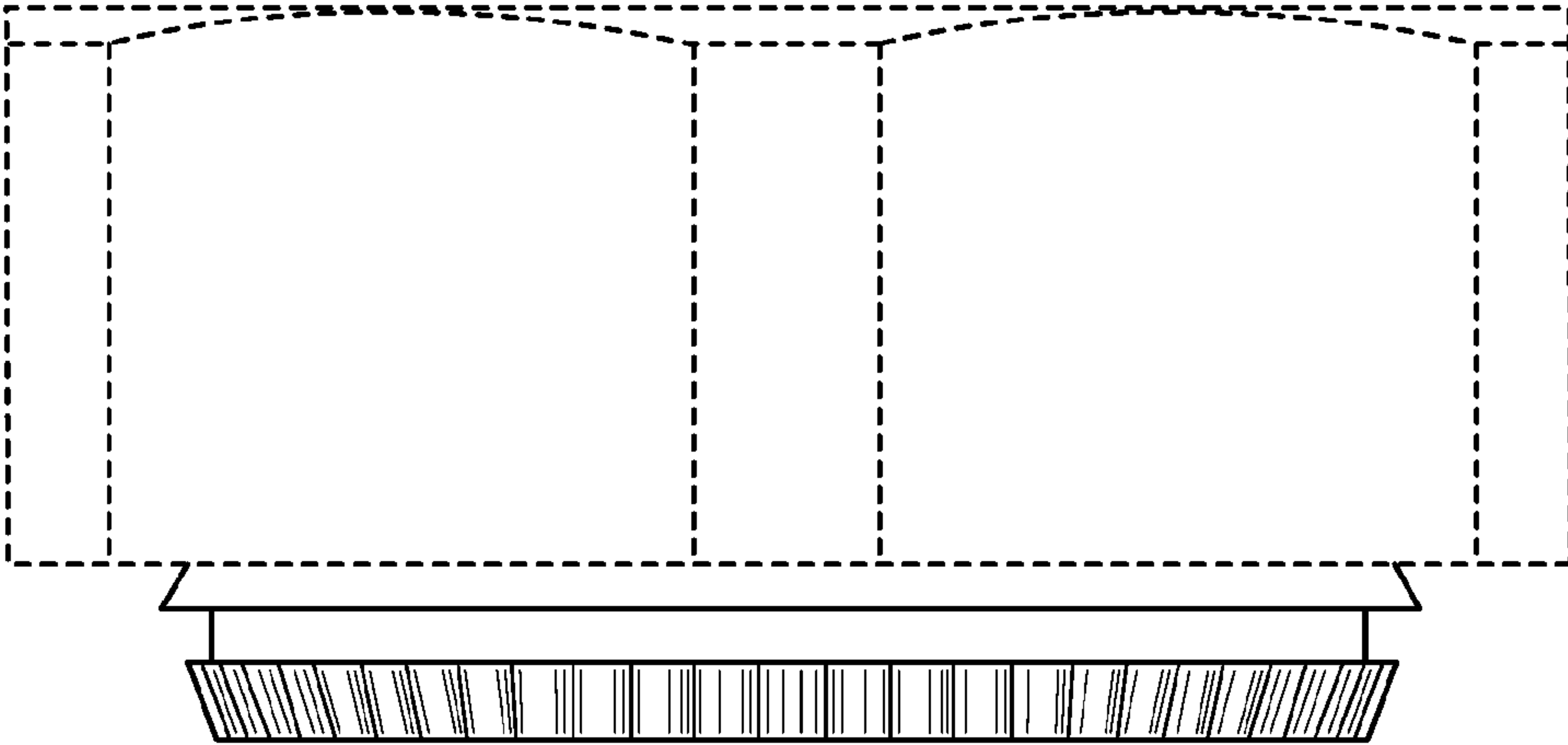

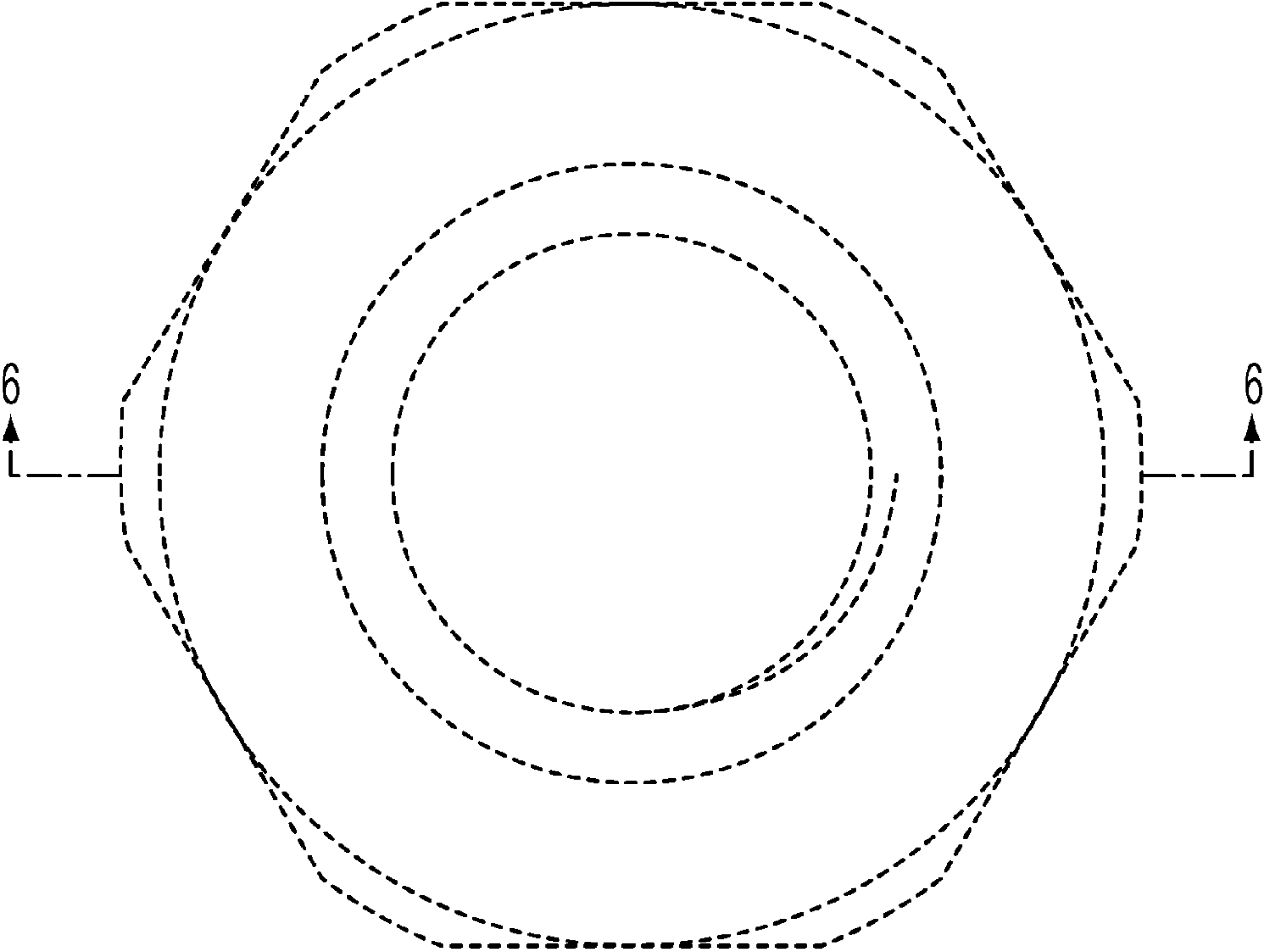

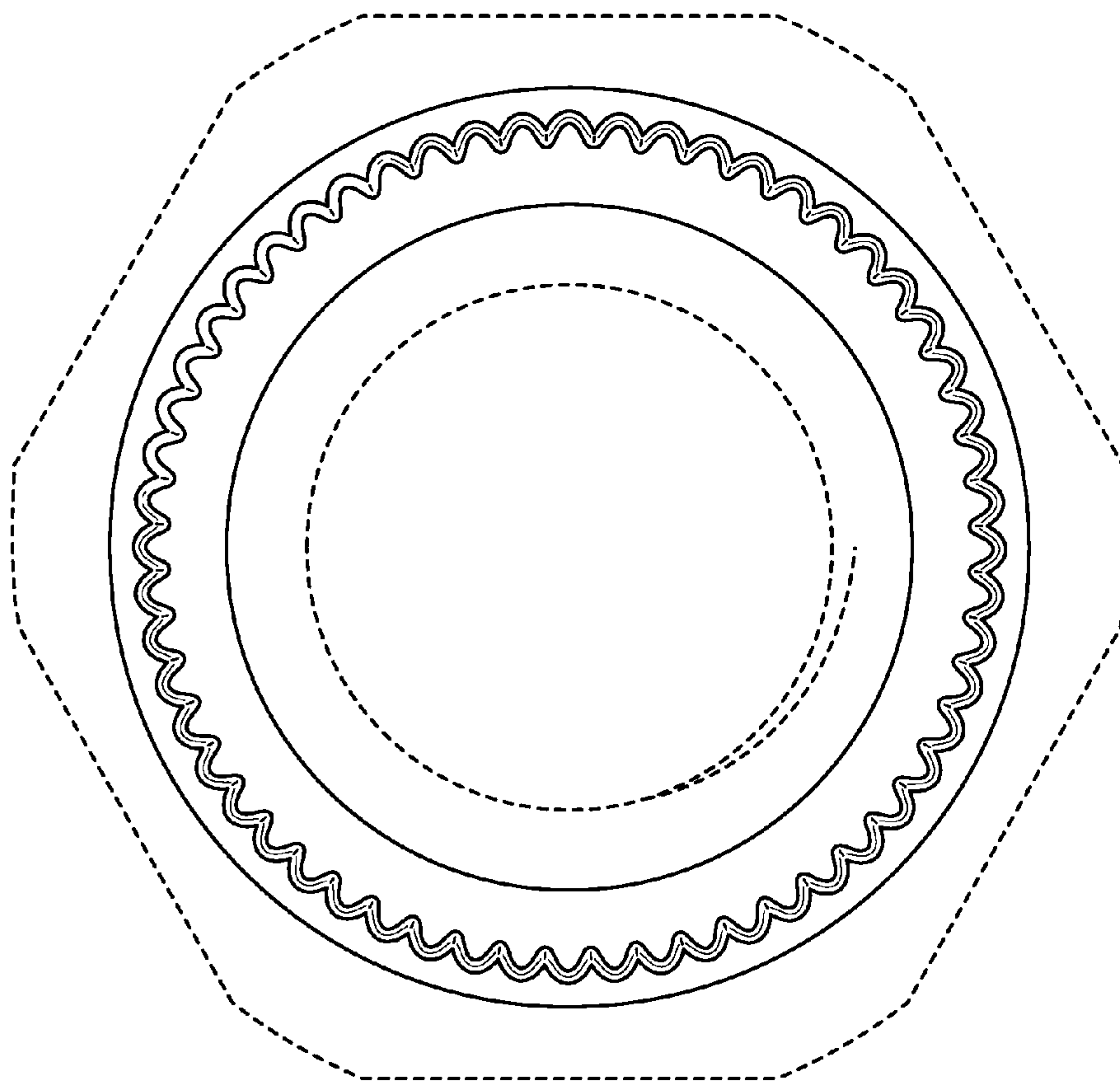

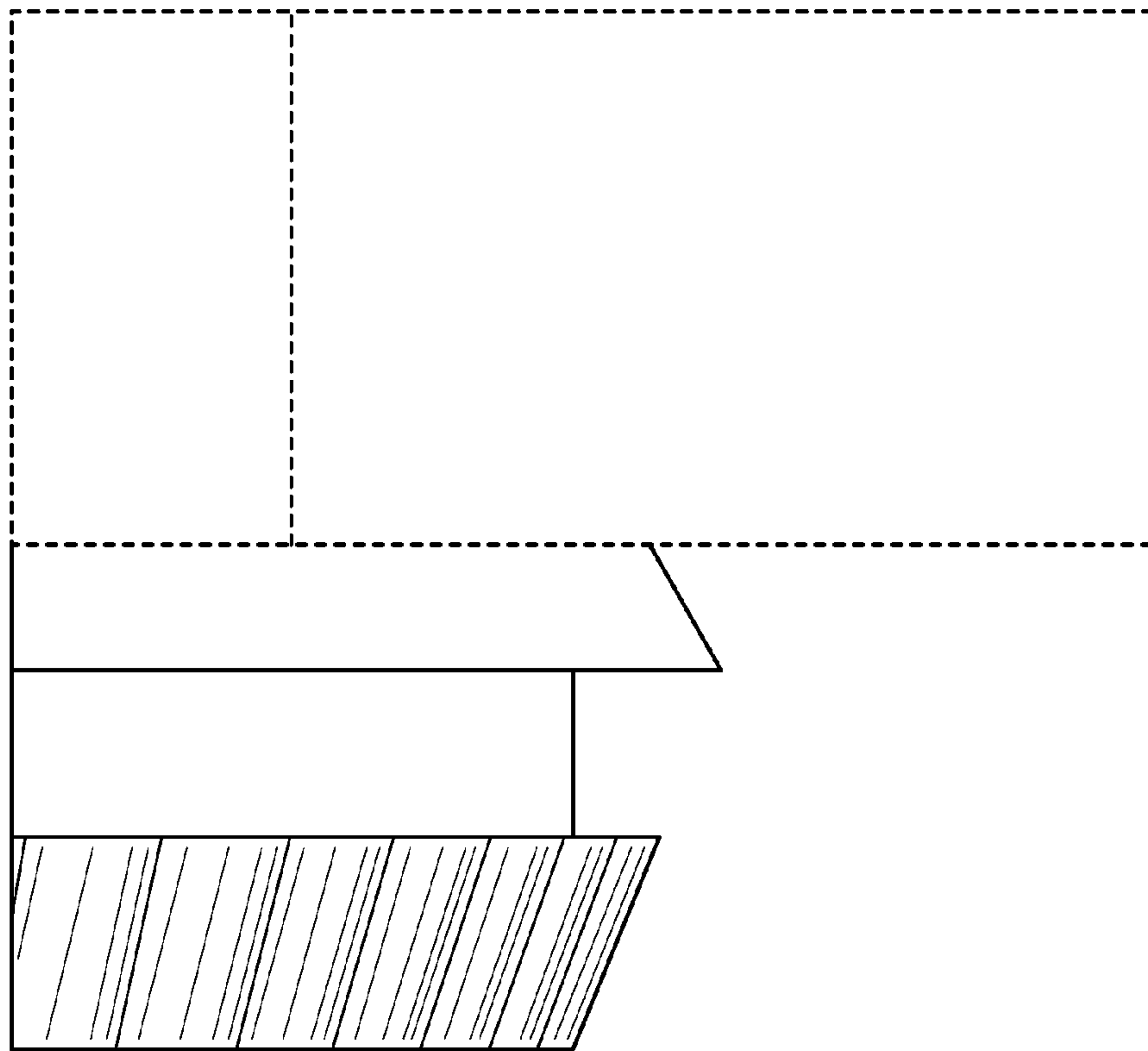

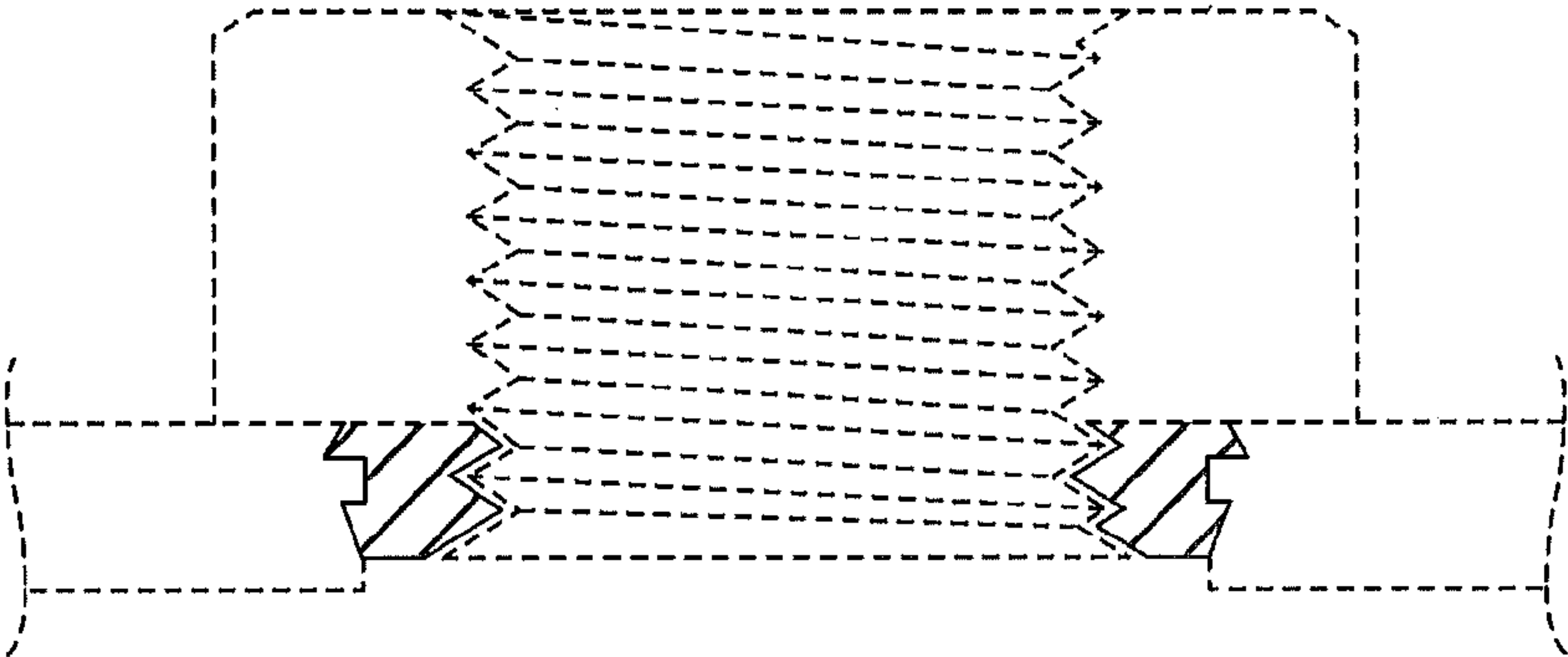
