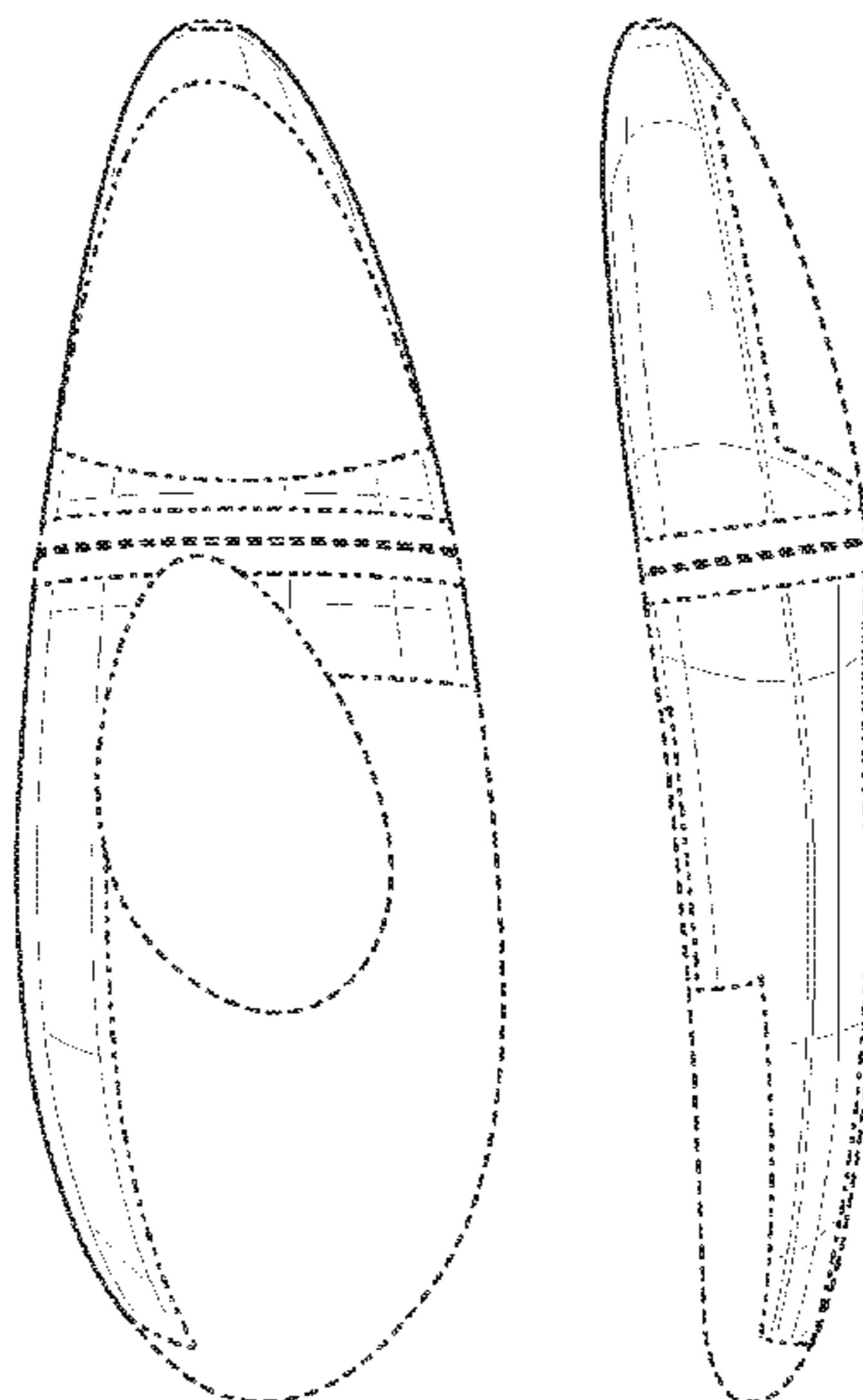
(57) **CLAIM**

We claim the ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, front, right perspective view of a container showing my new design;
FIG. 2 is a back elevational view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a top end view thereof;
FIG. 7 is a bottom end view thereof; and,
FIG. 8 is an exploded view thereof, with the cap removed.
The evenly dashed broken lines in the drawings illustrate the portions of the design that form no part of the claim. The dot-dot-dash broken lines in the drawings define the bounds of the claim and form no part thereof.

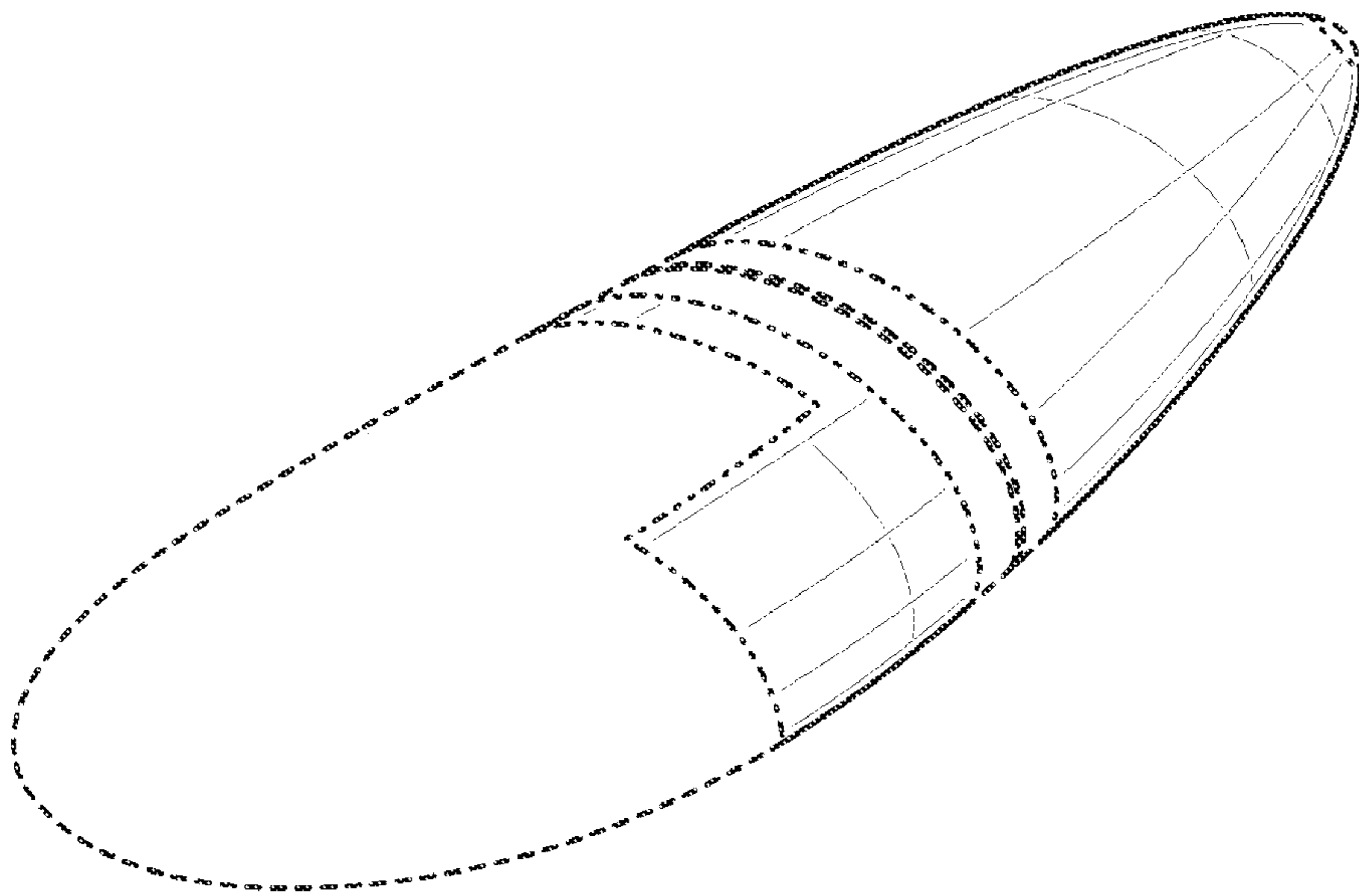

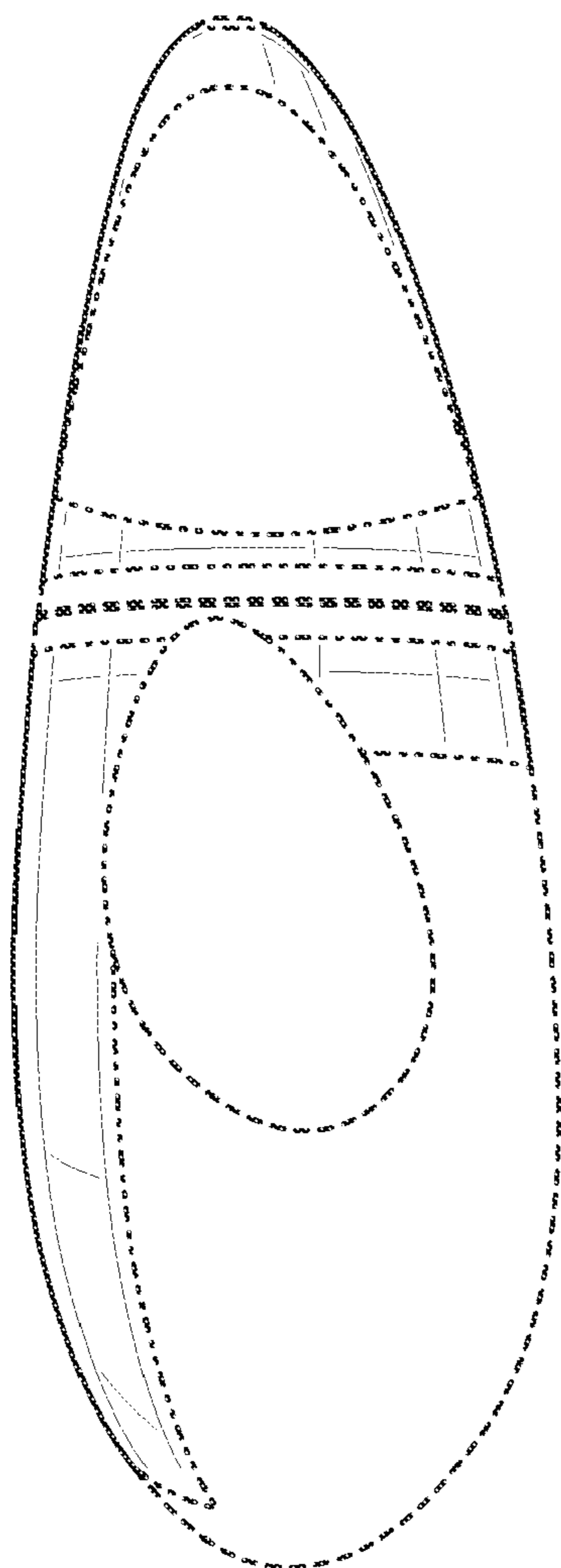

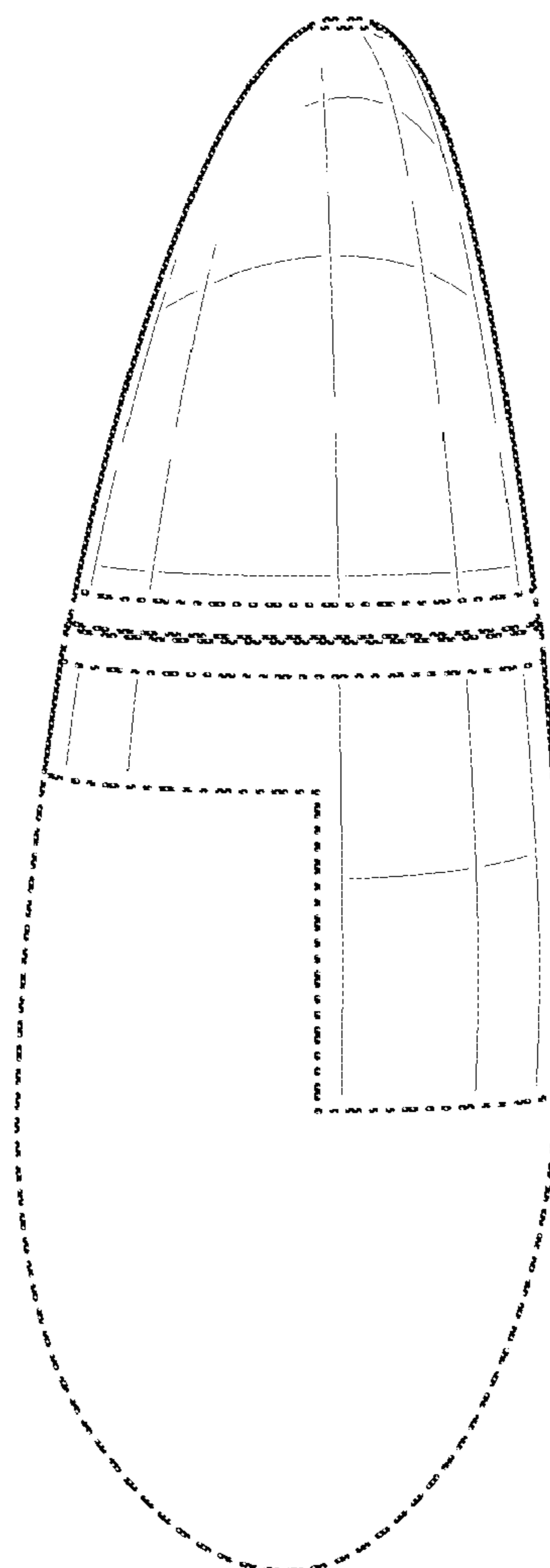

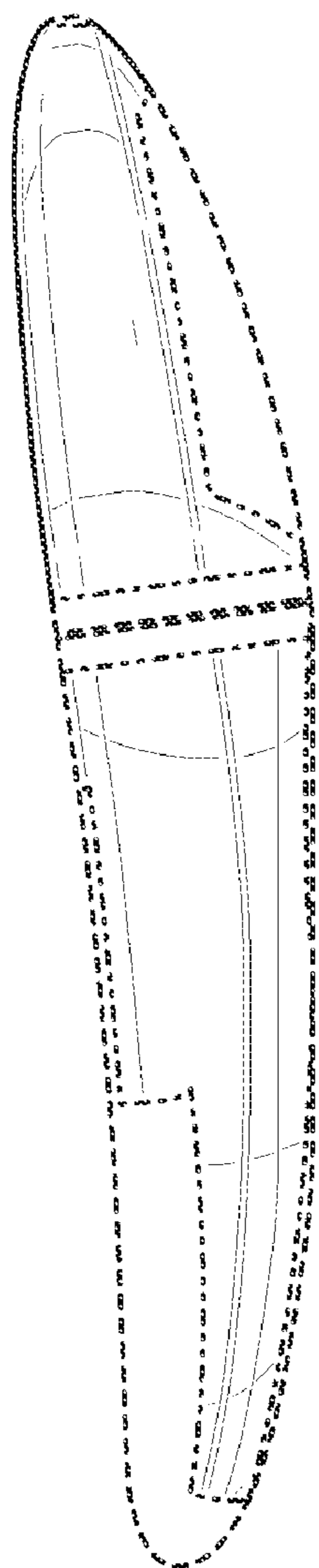

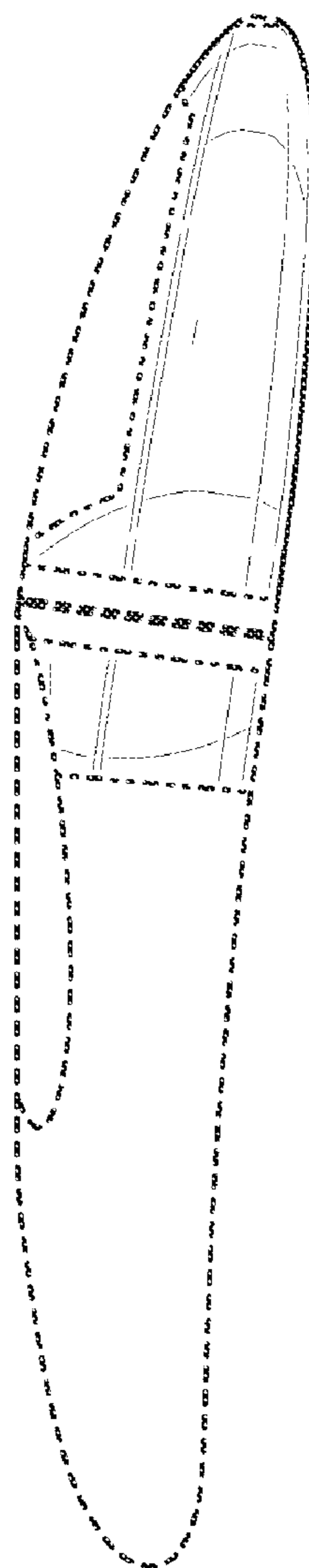

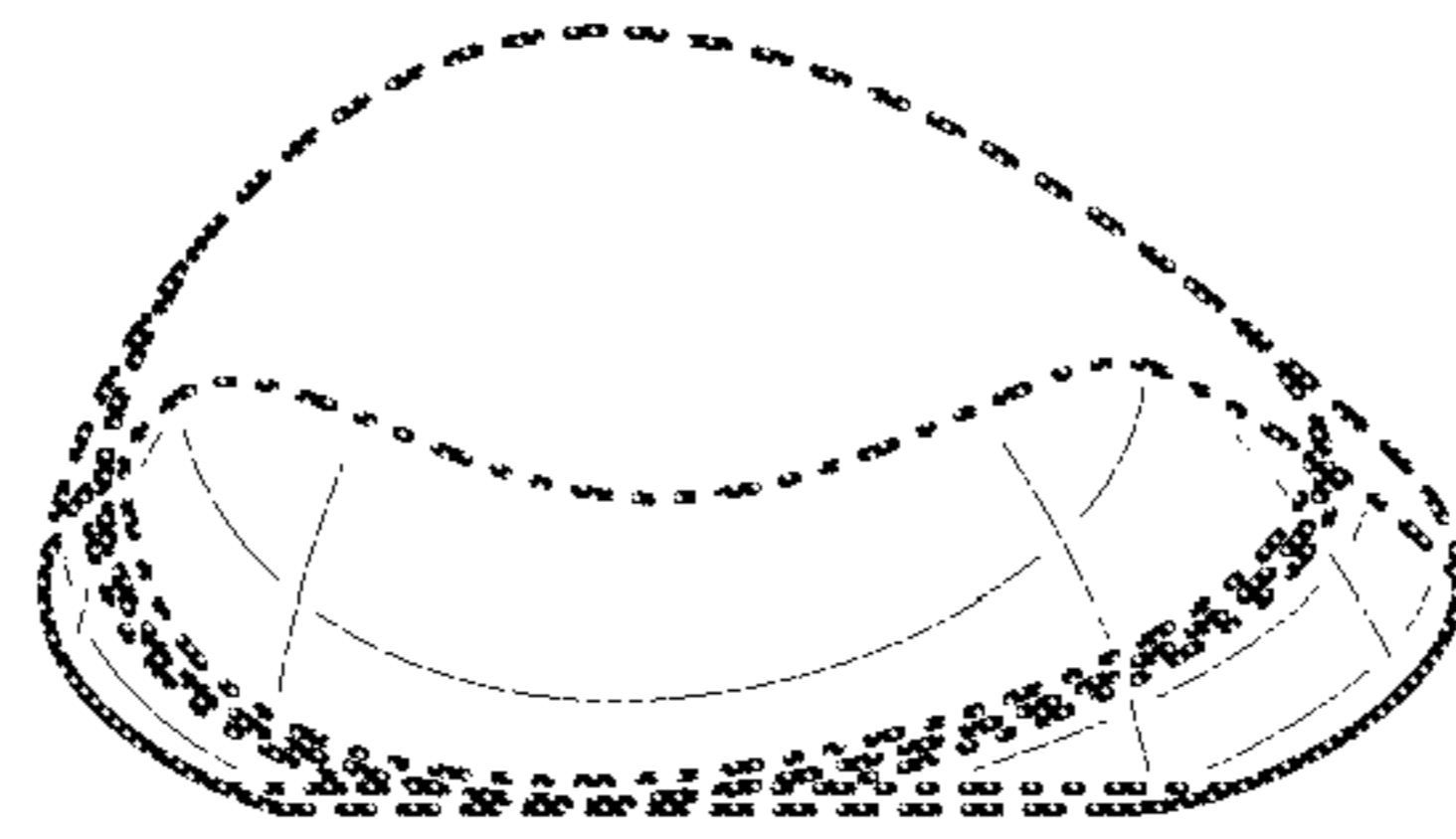

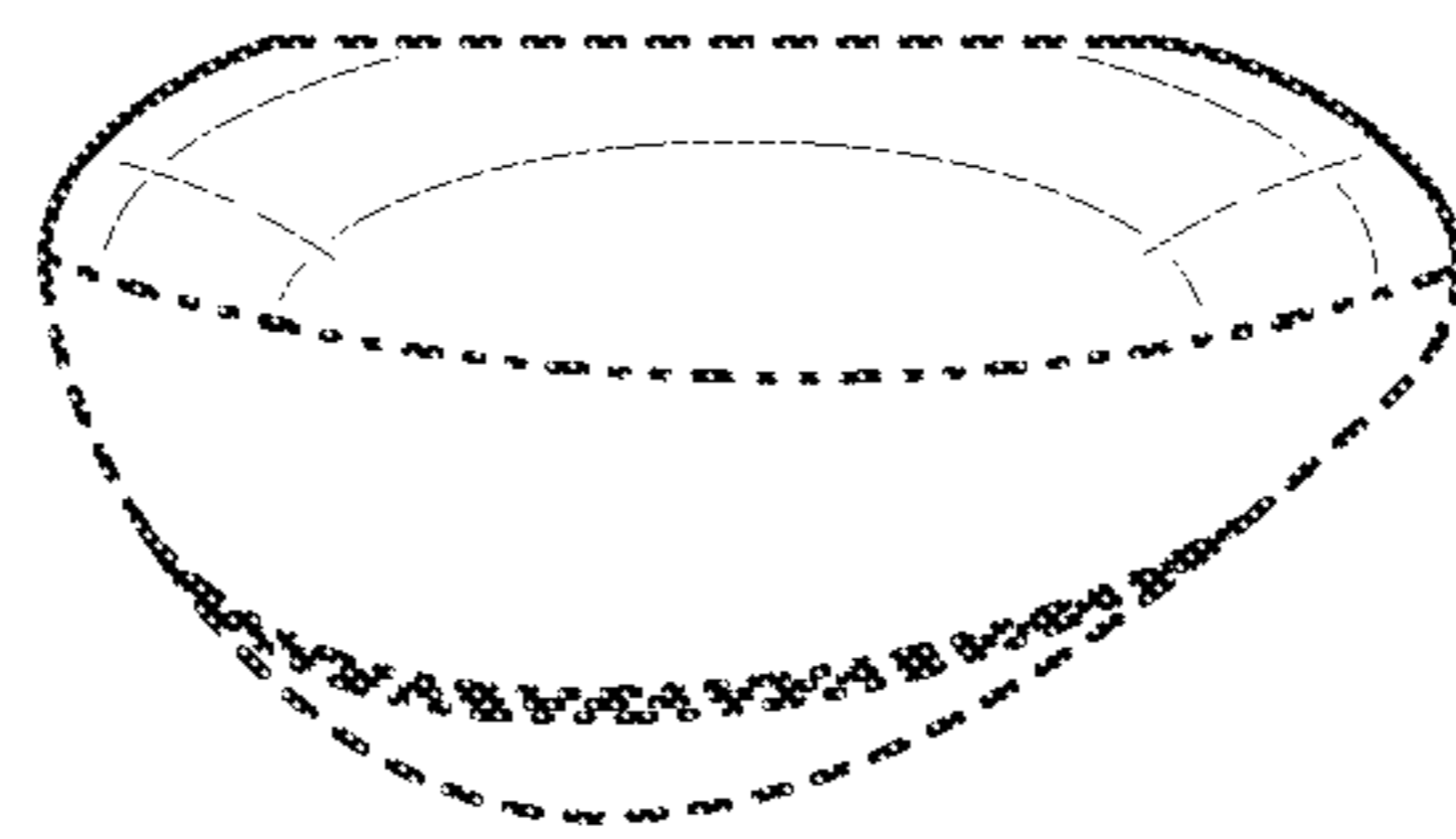

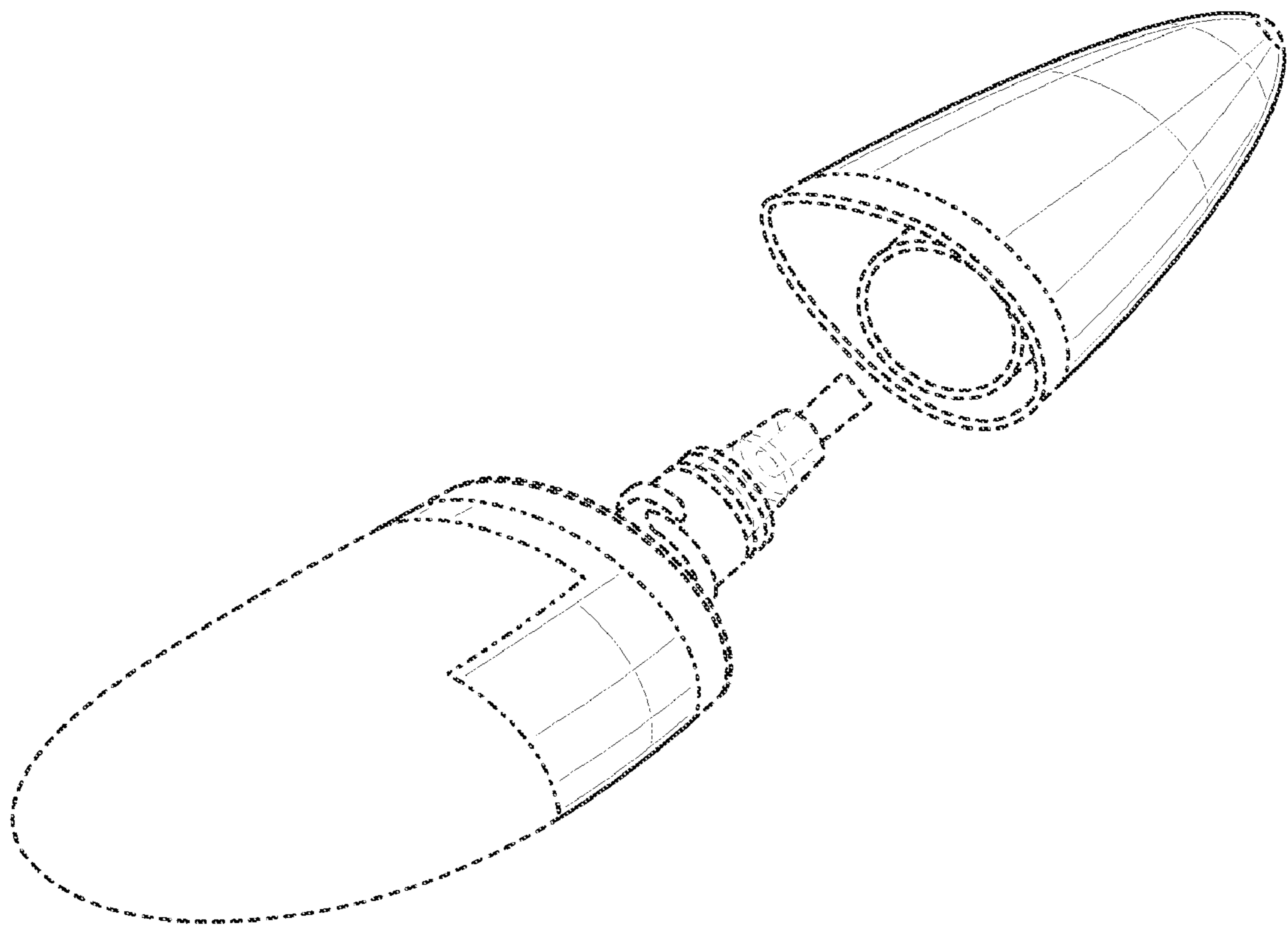
