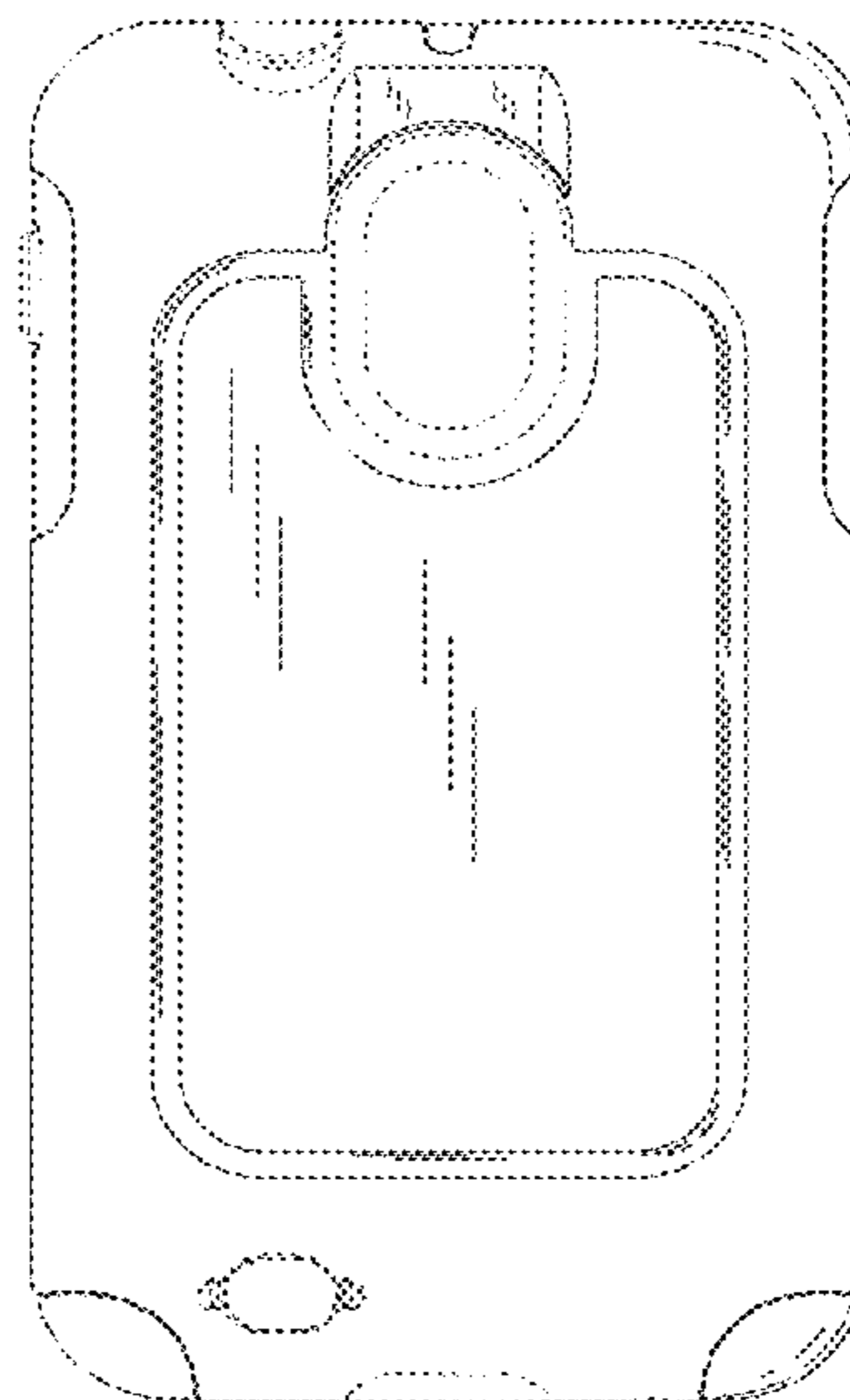
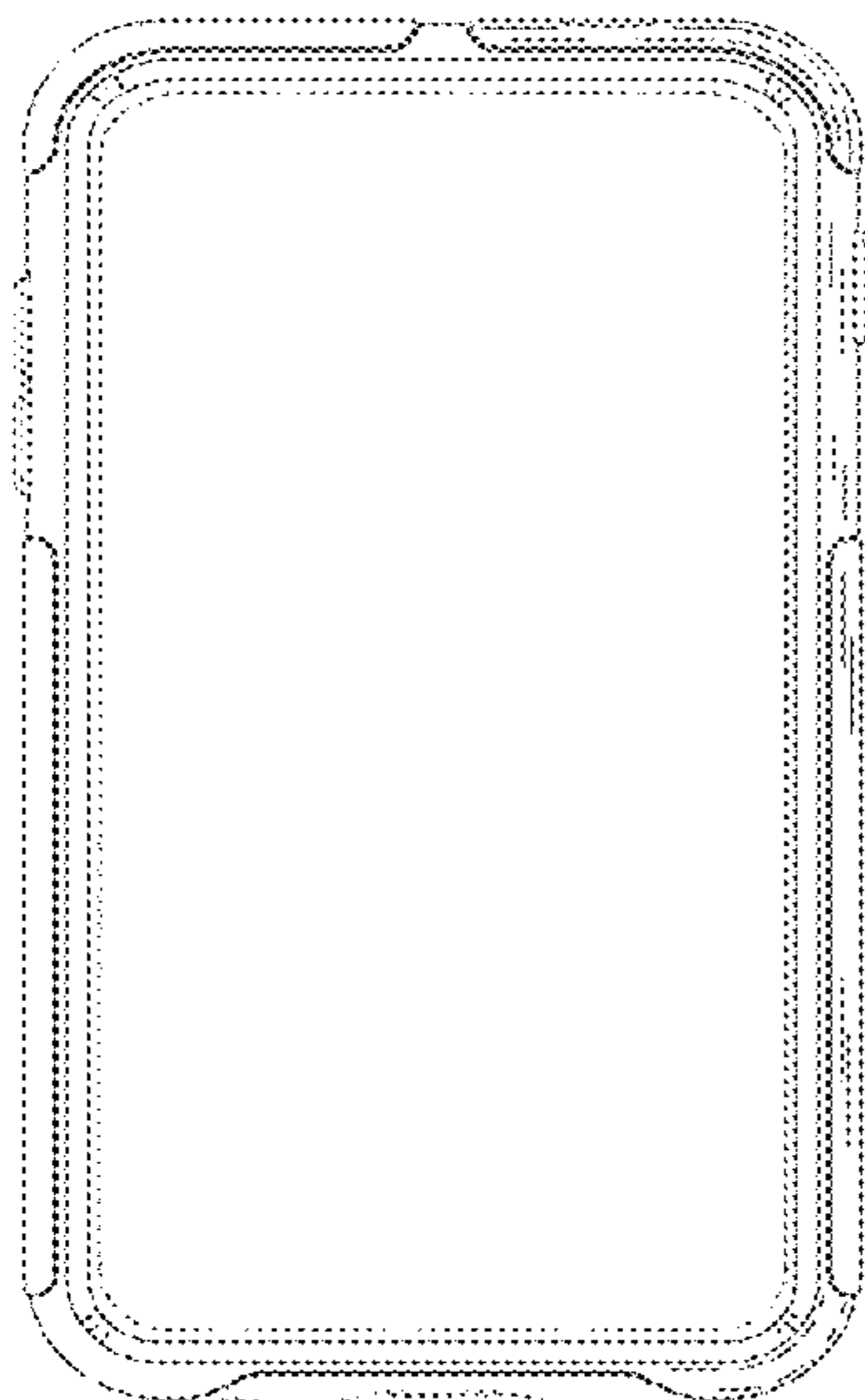
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front isometric view of a case for electronic device showing our new design;

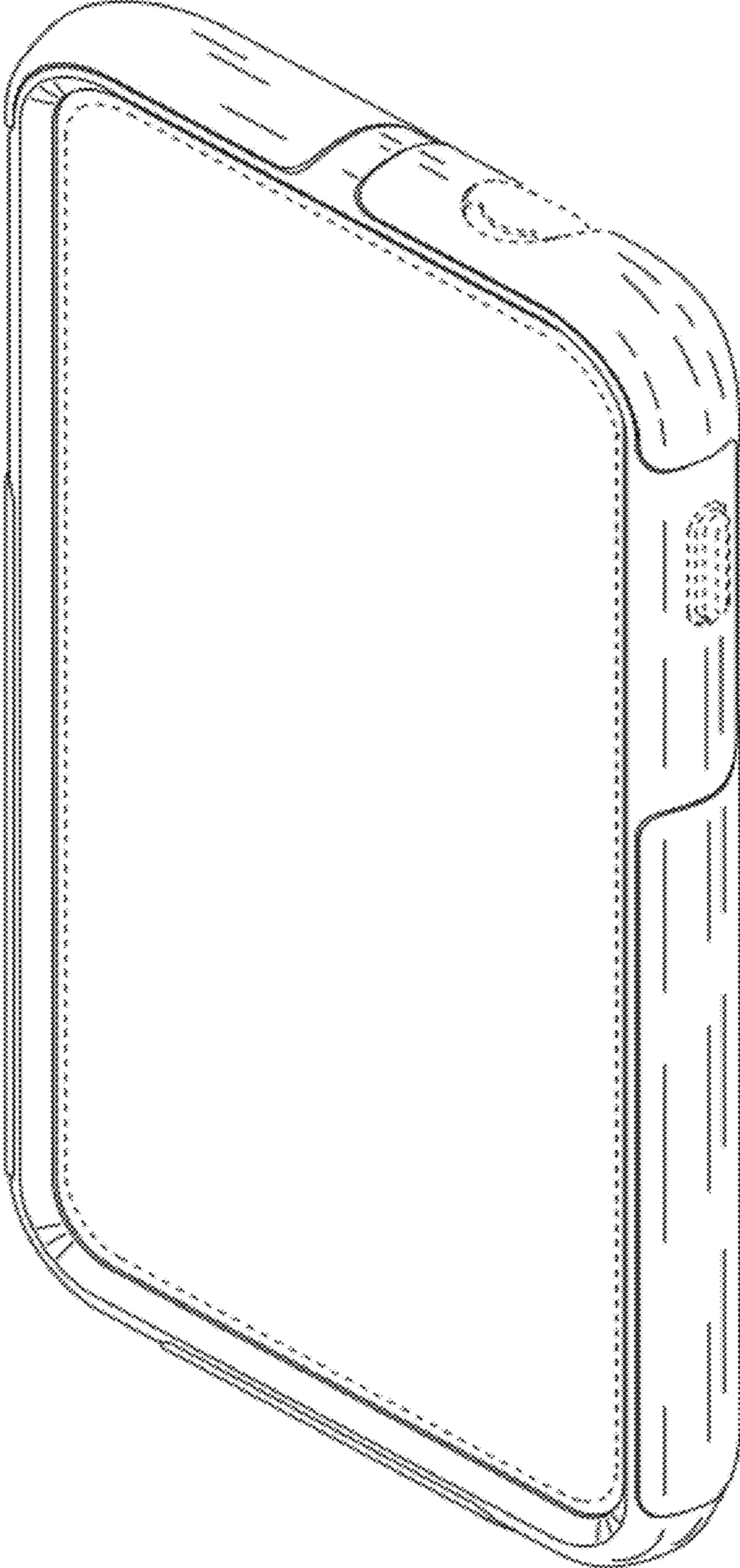

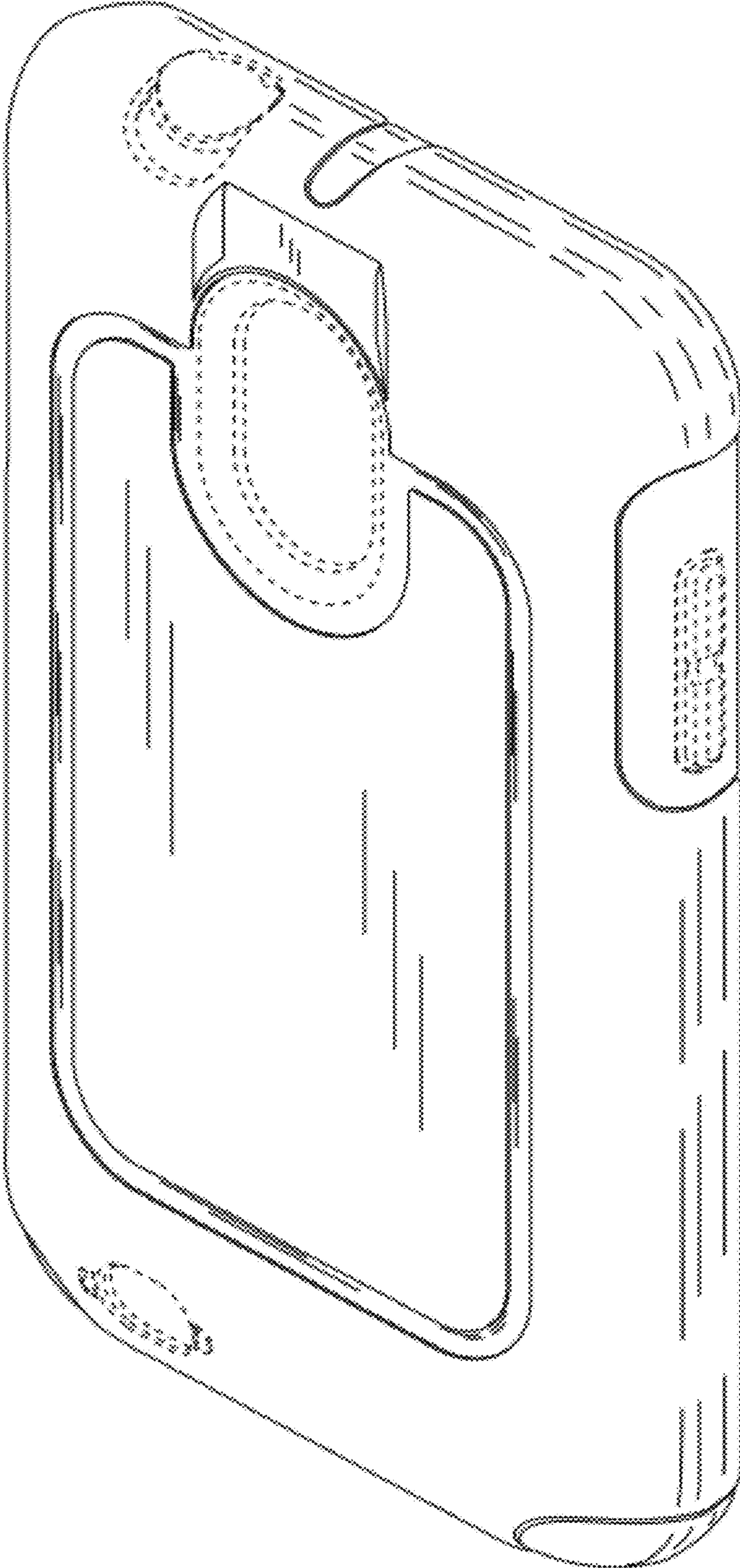

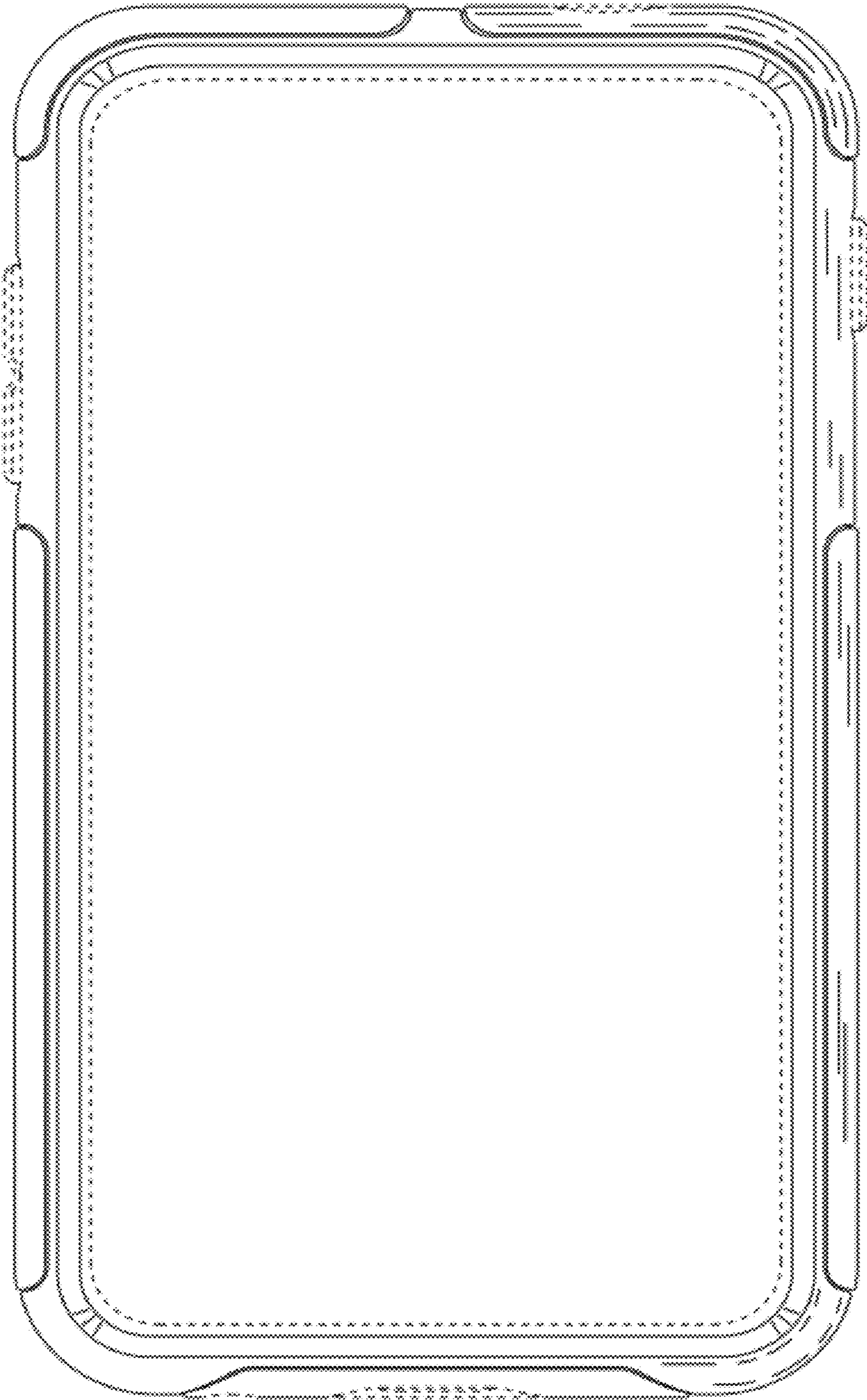

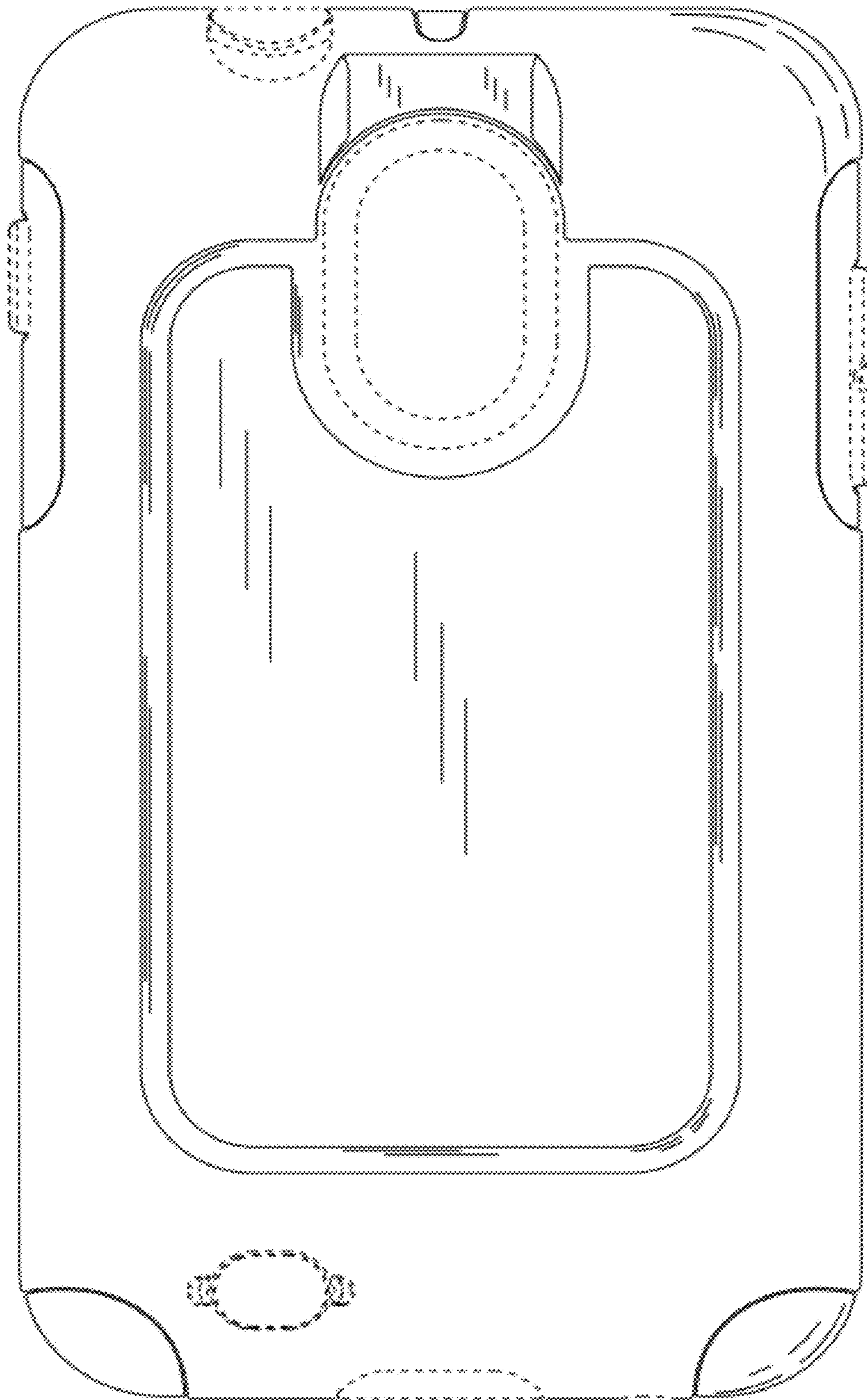

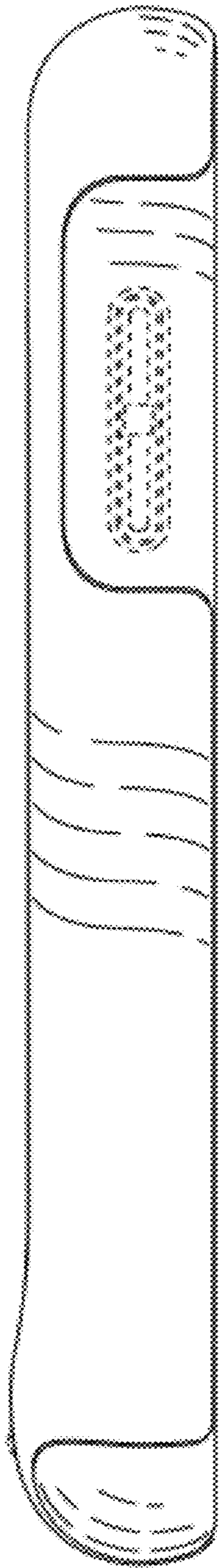

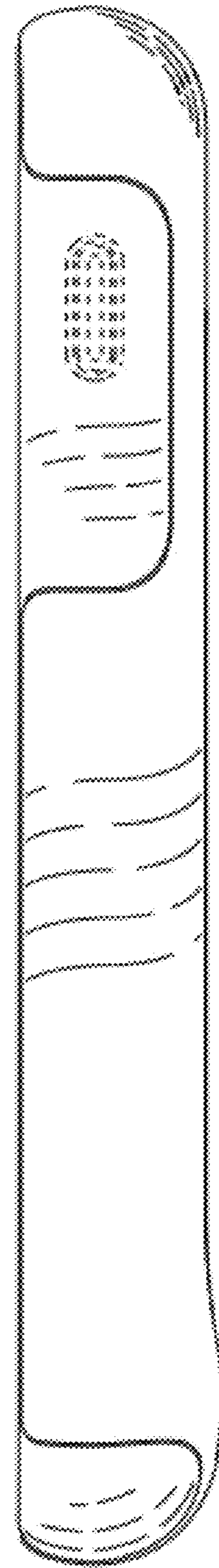

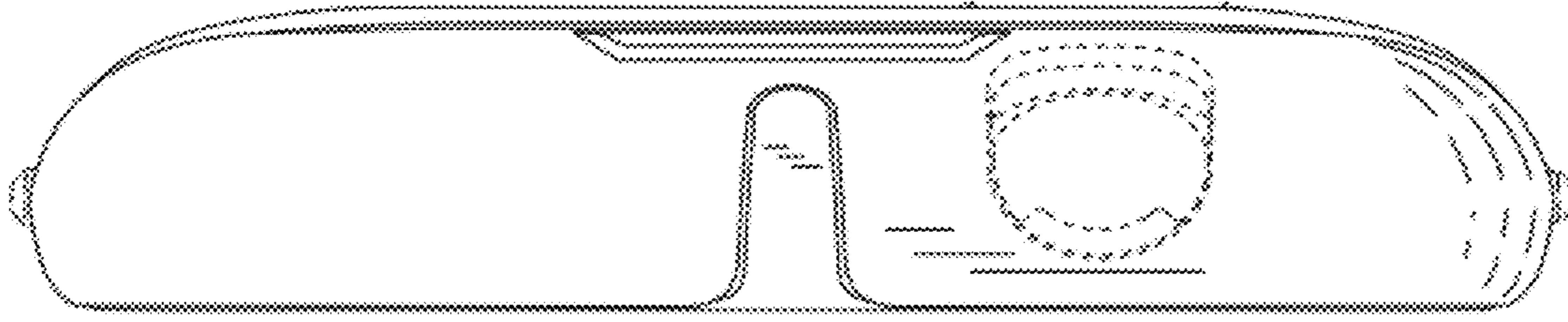

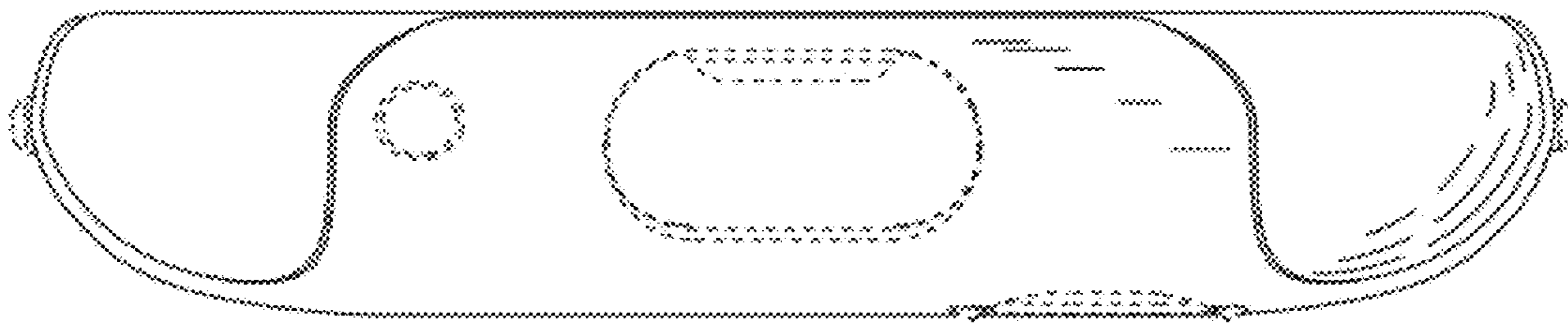
