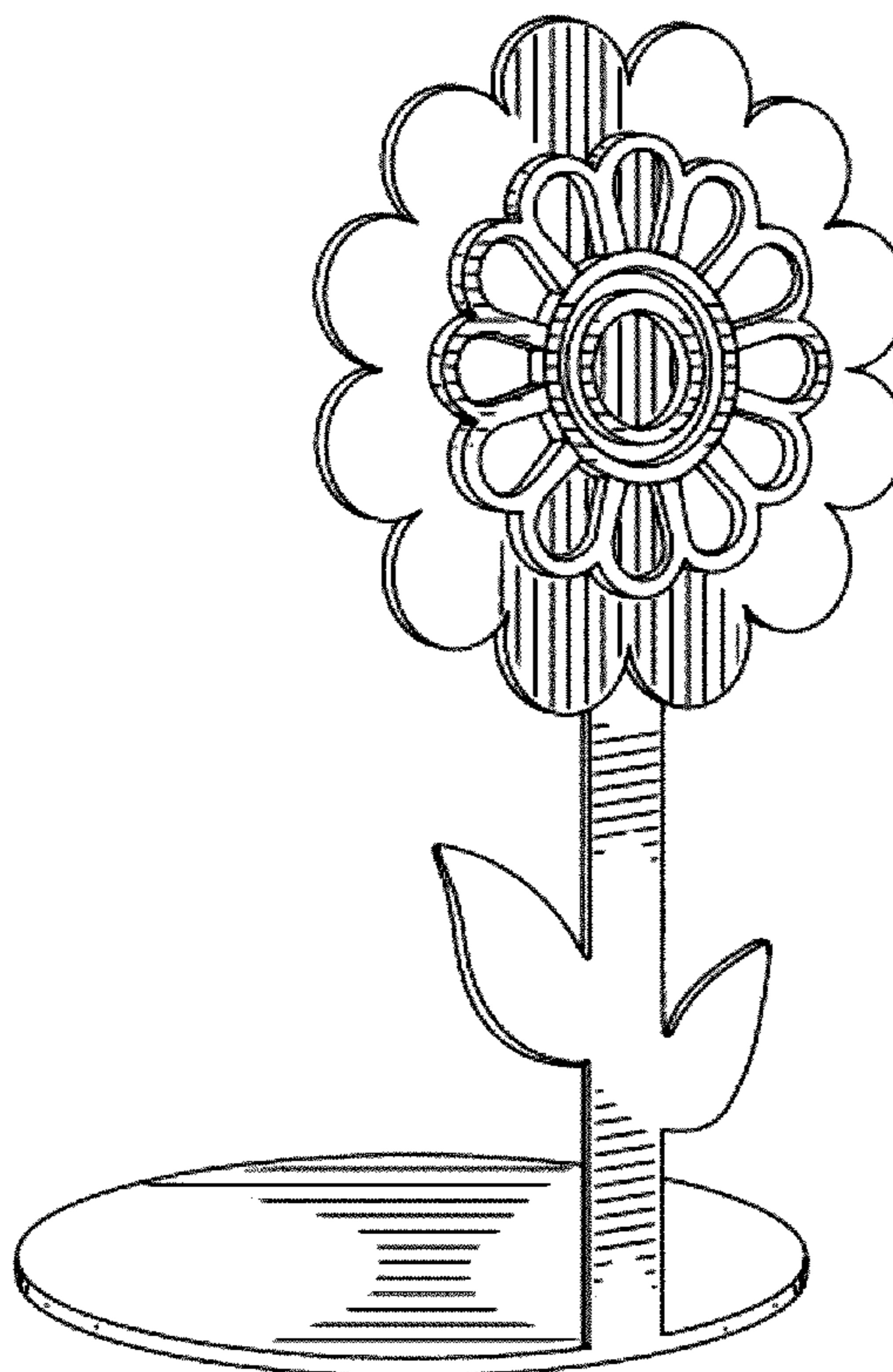

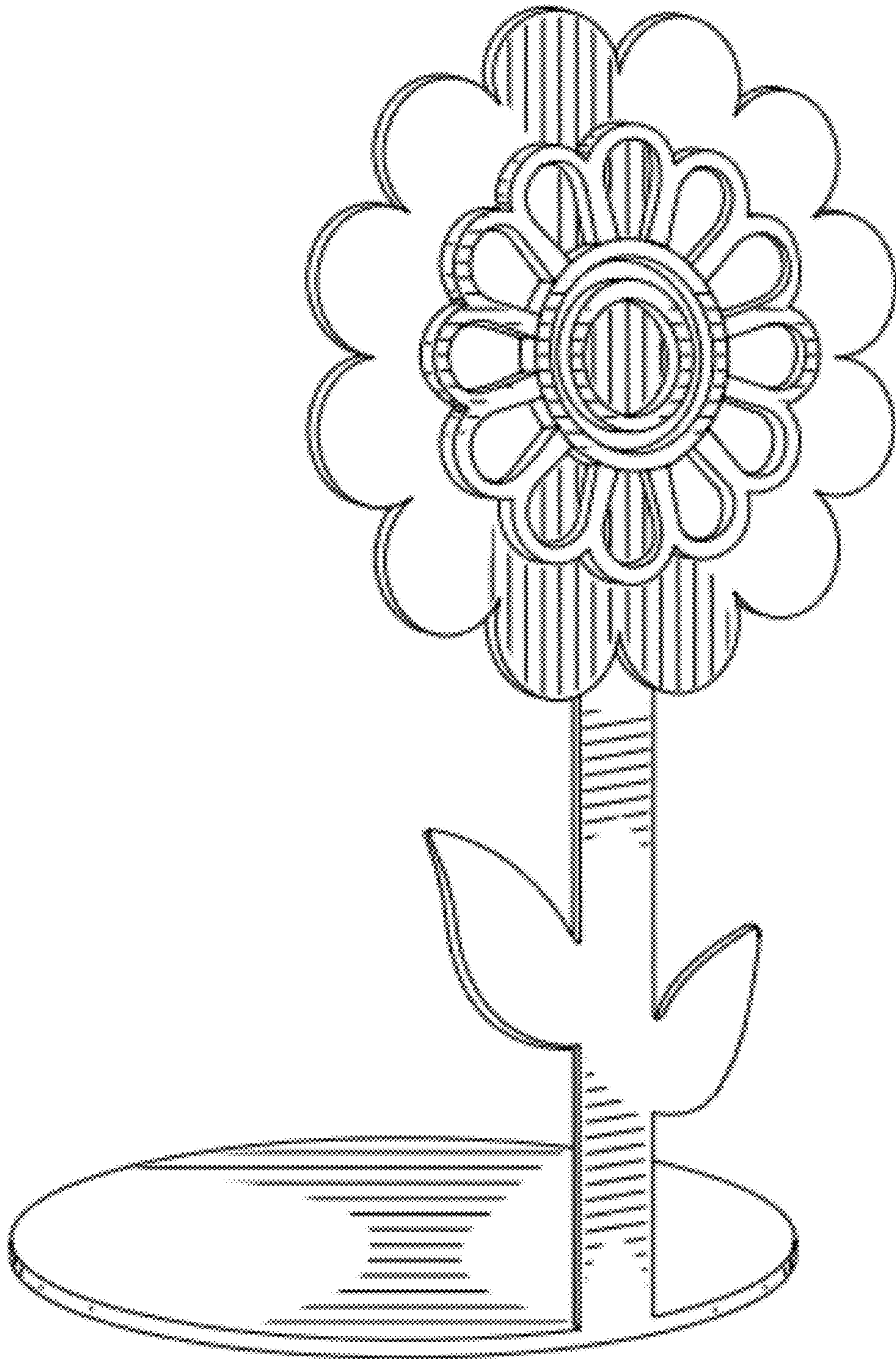
The ornamental design for a book end, as shown and described.

FIG. 7 is a right side elevational view thereof.

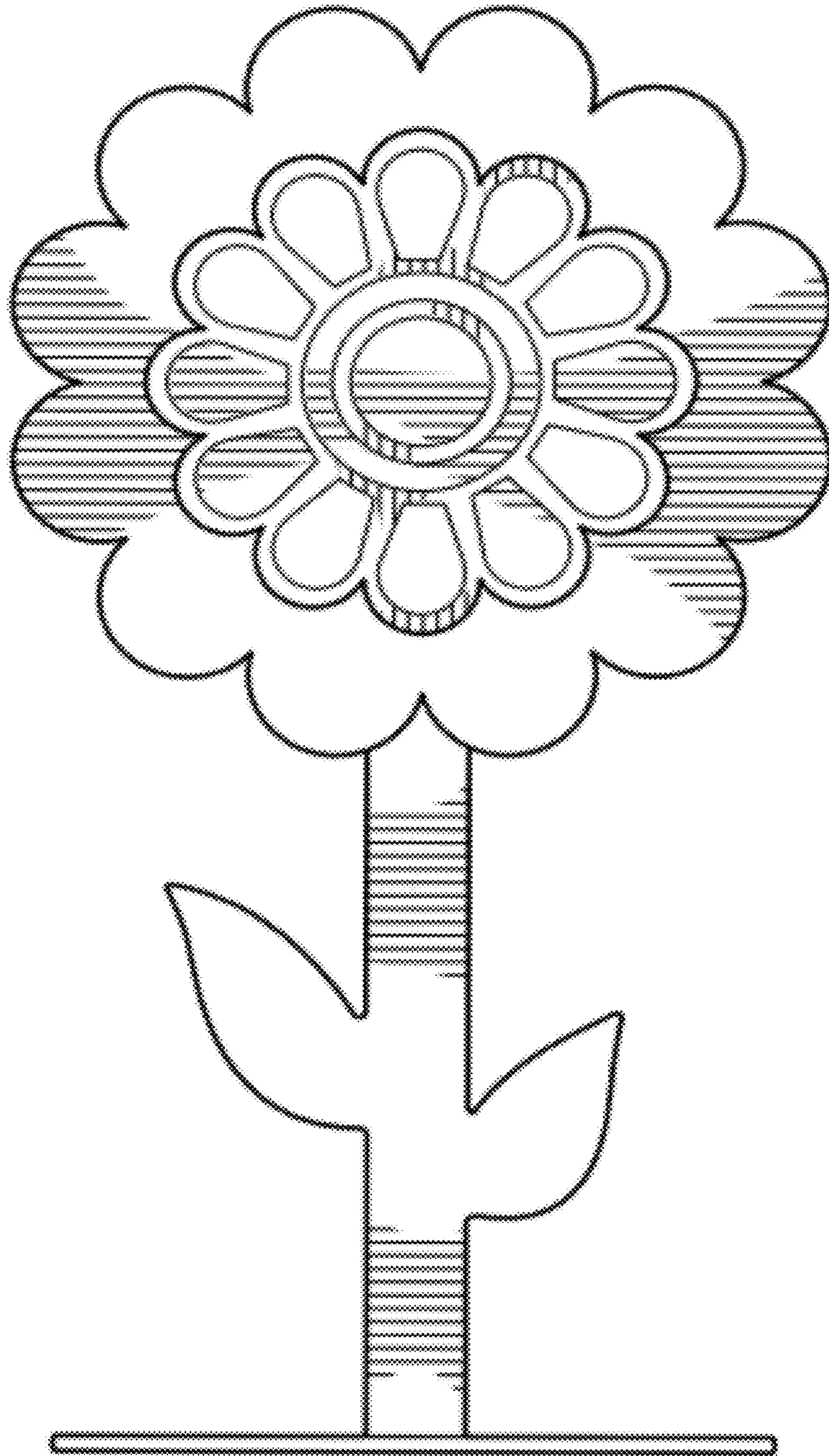

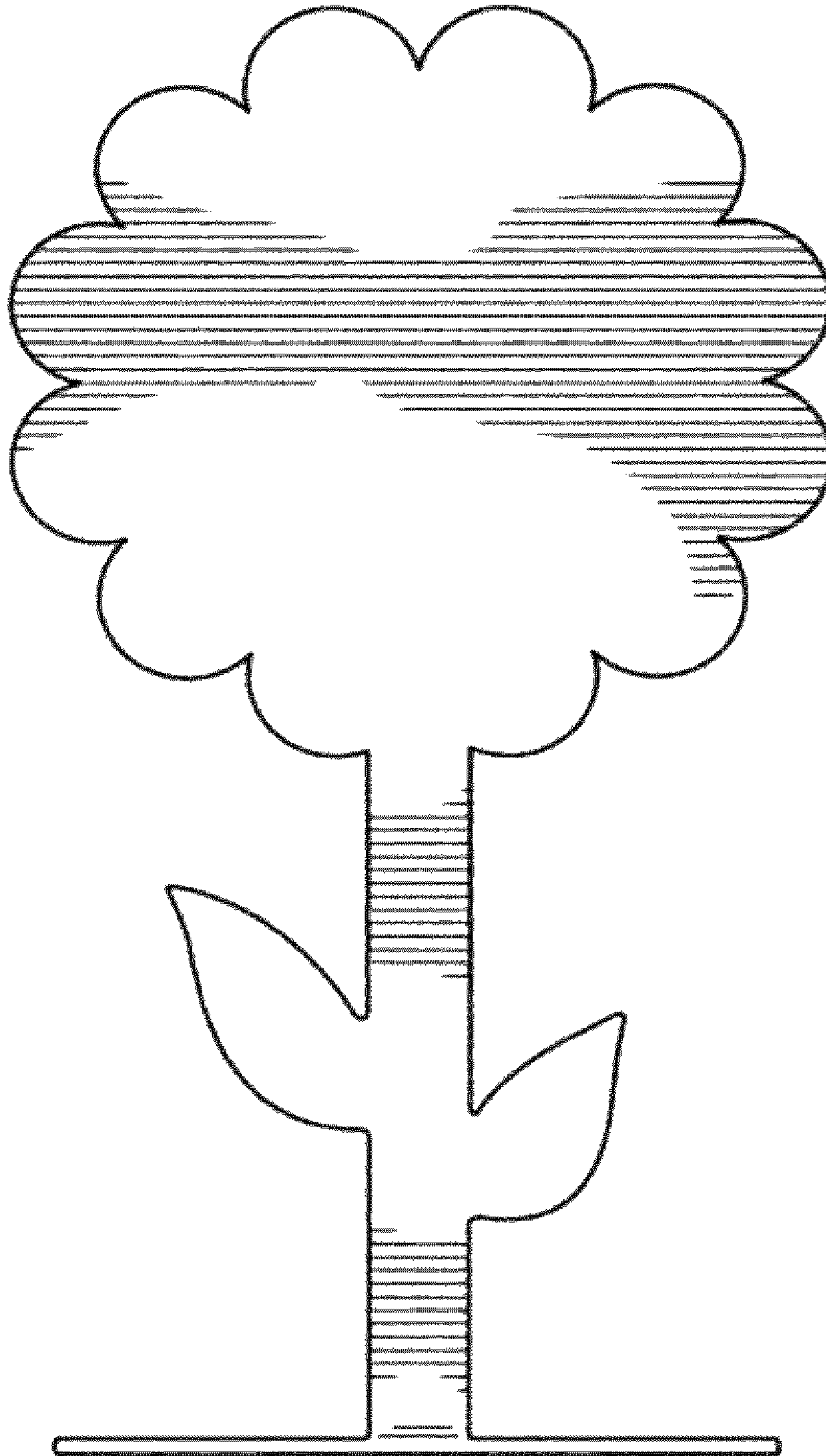

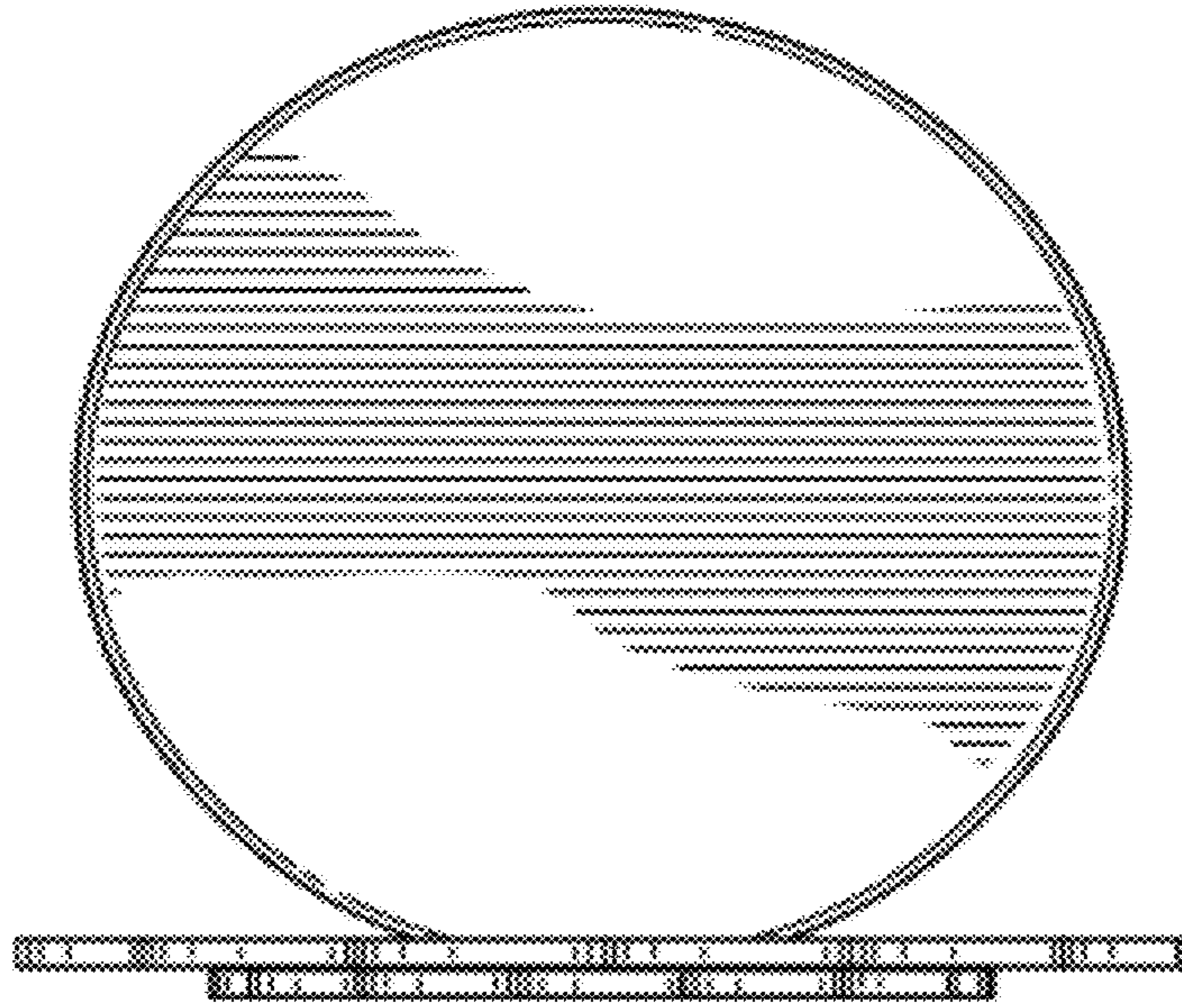

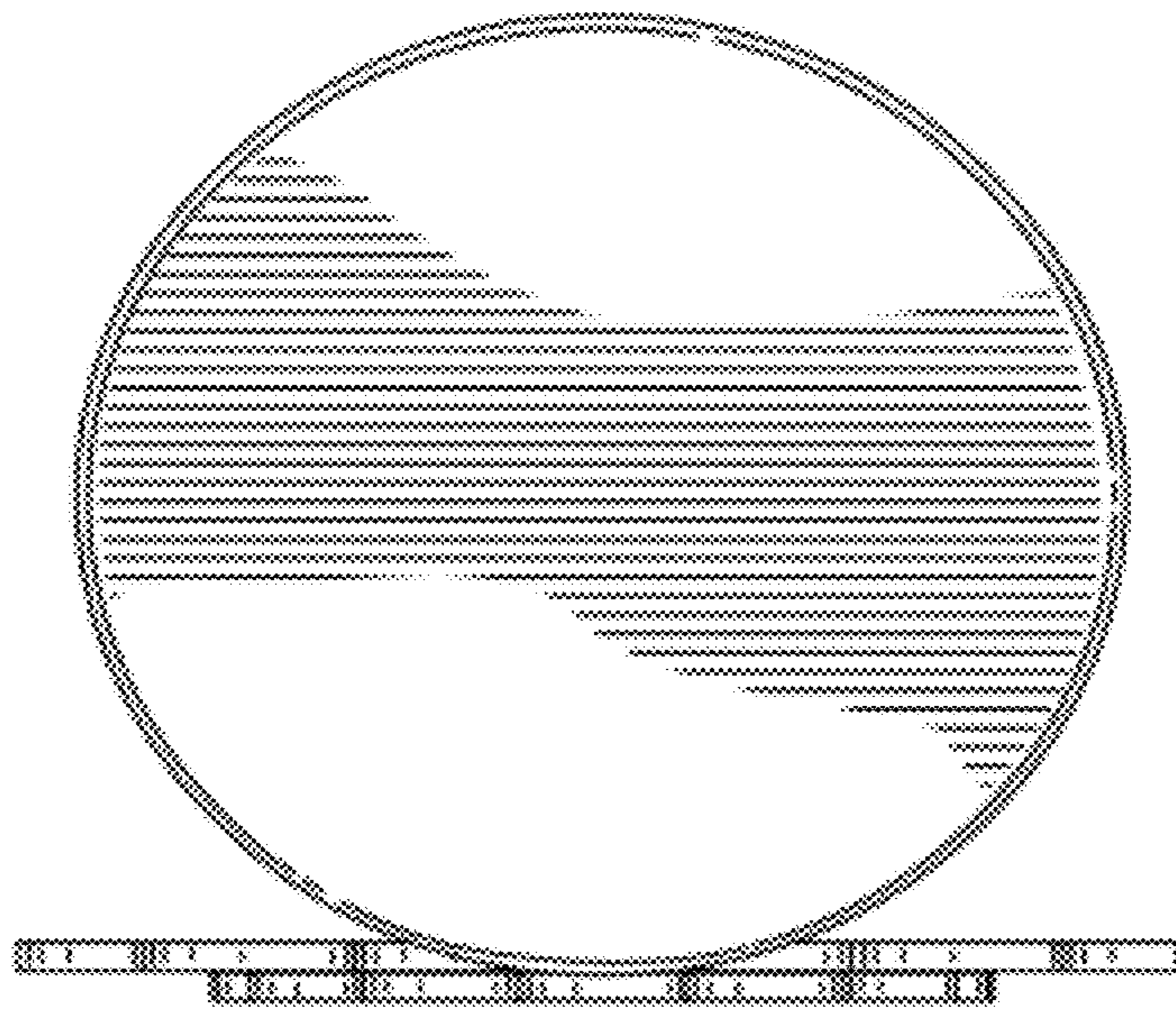
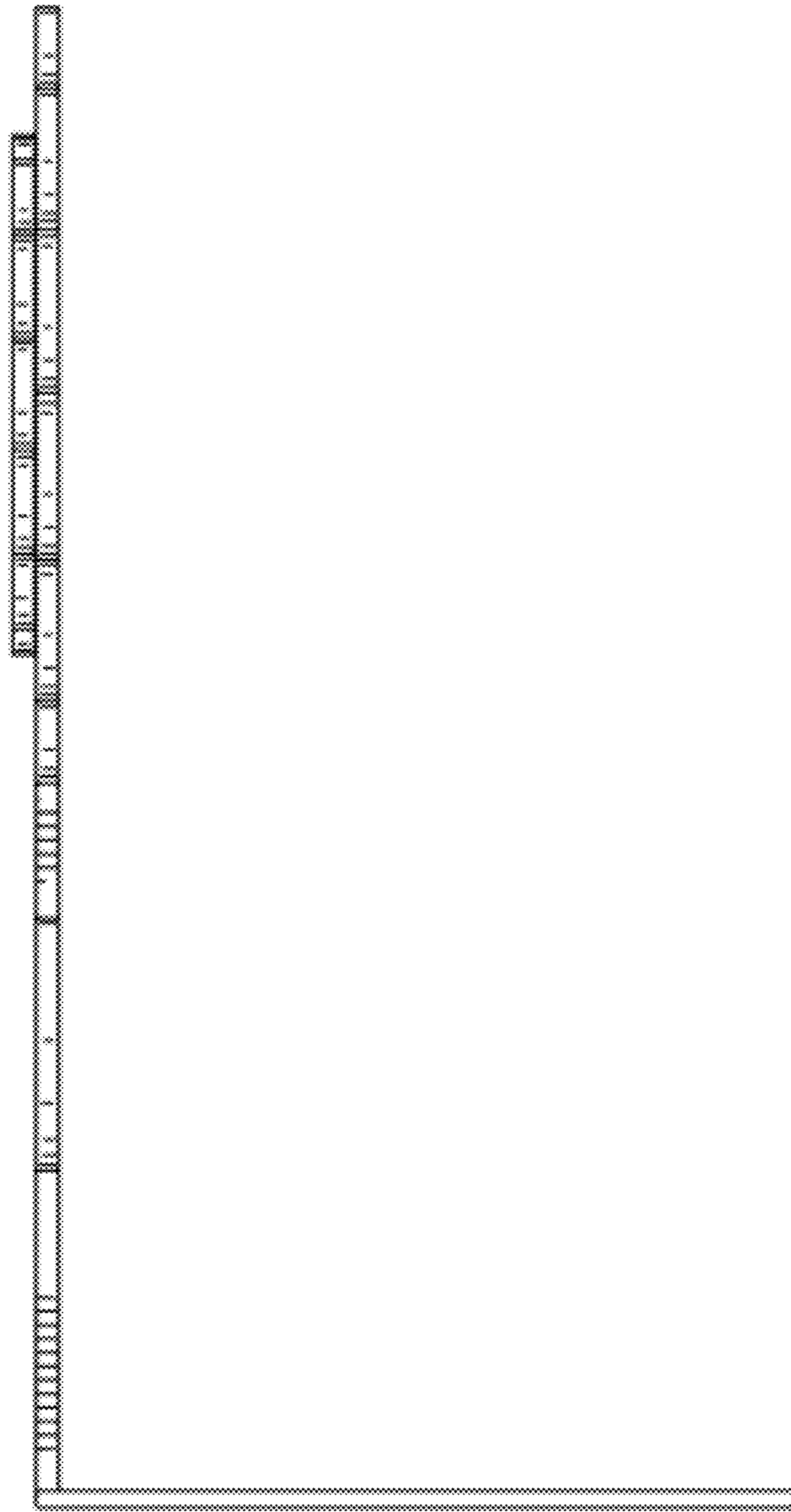
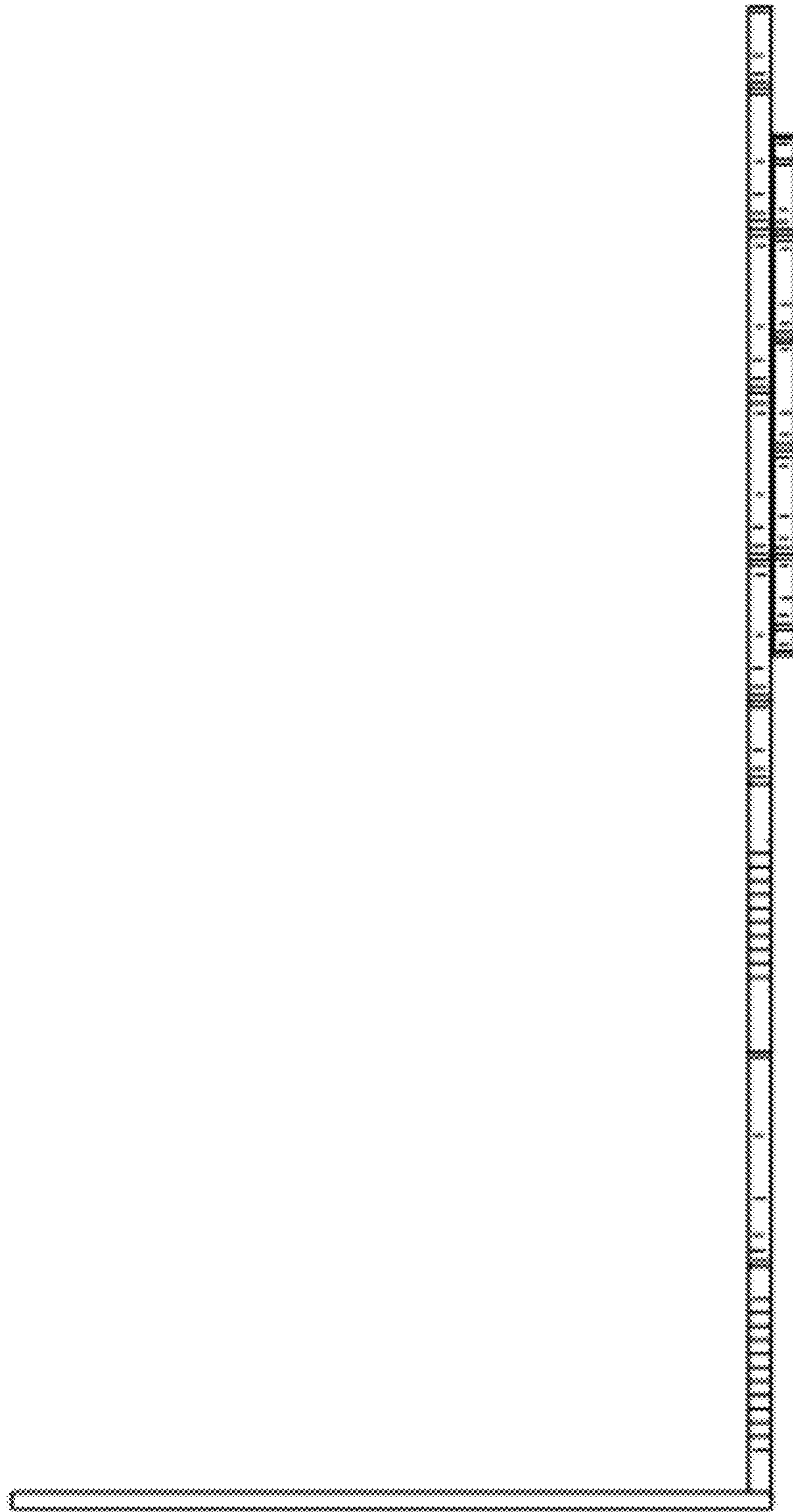
