FIG. 4 is a right side view of the gaming machine shown in FIG. 1.

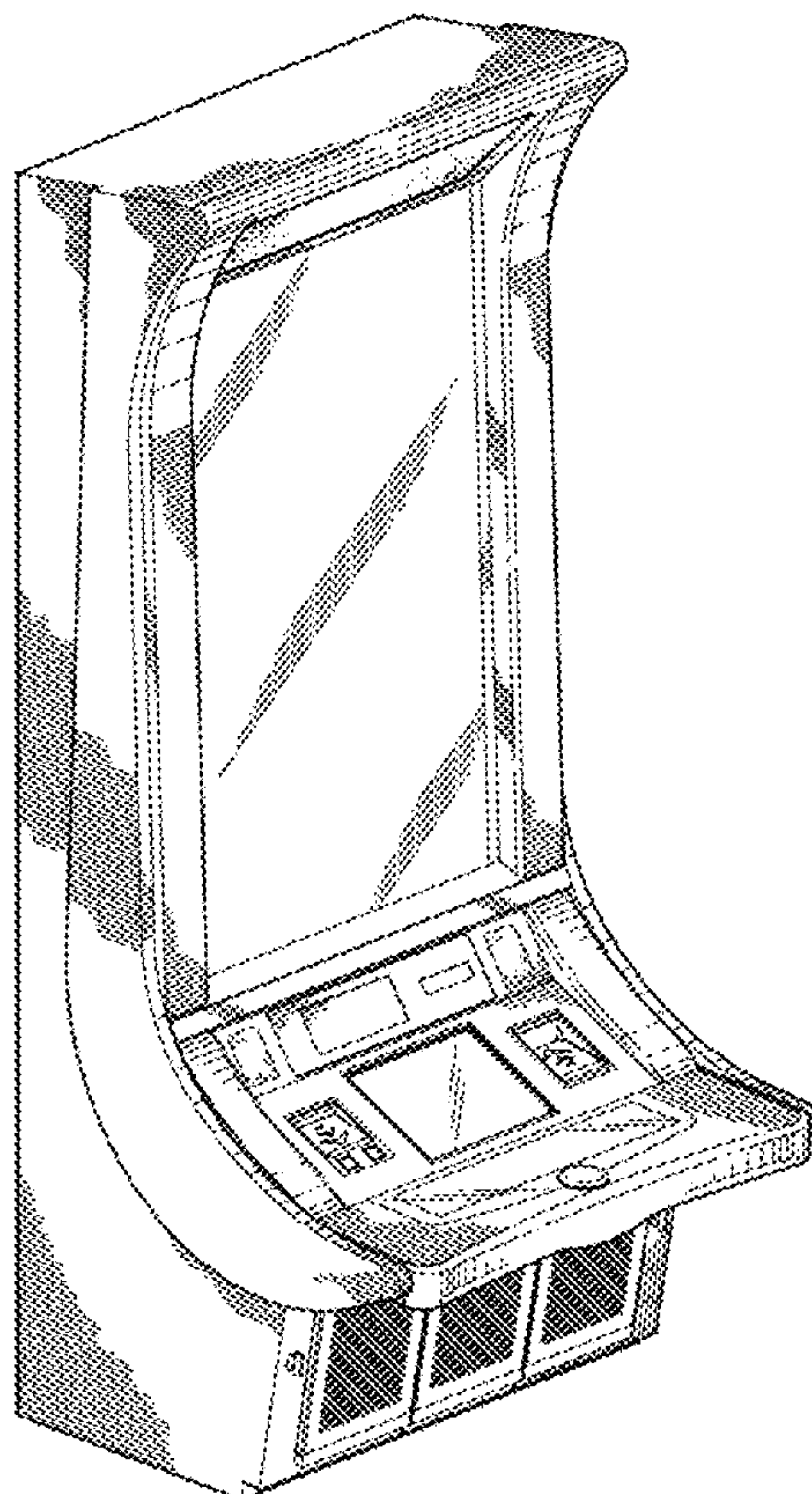
FIG. 5 is a front view of the gaming machine shown in FIG. 1.

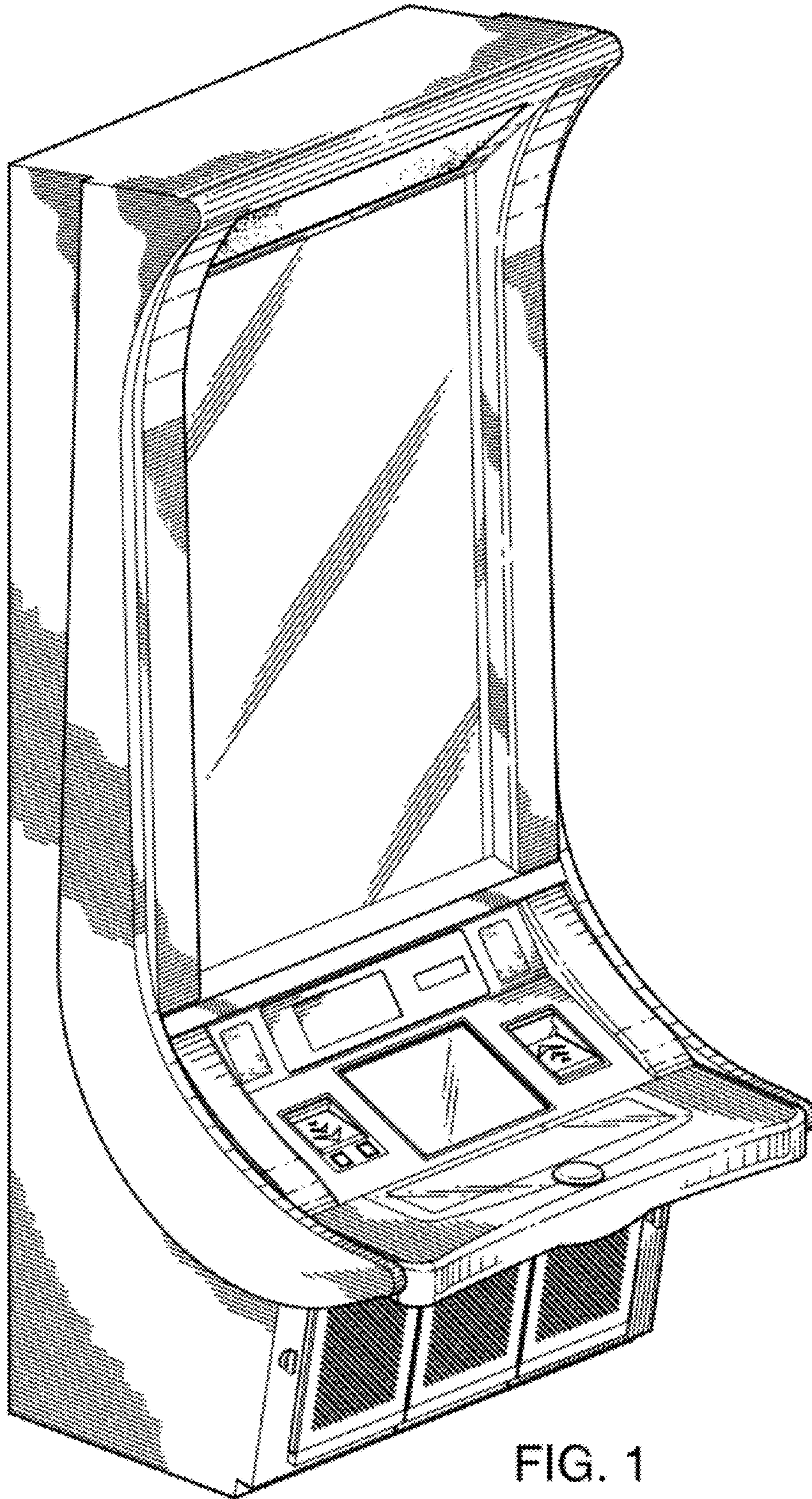

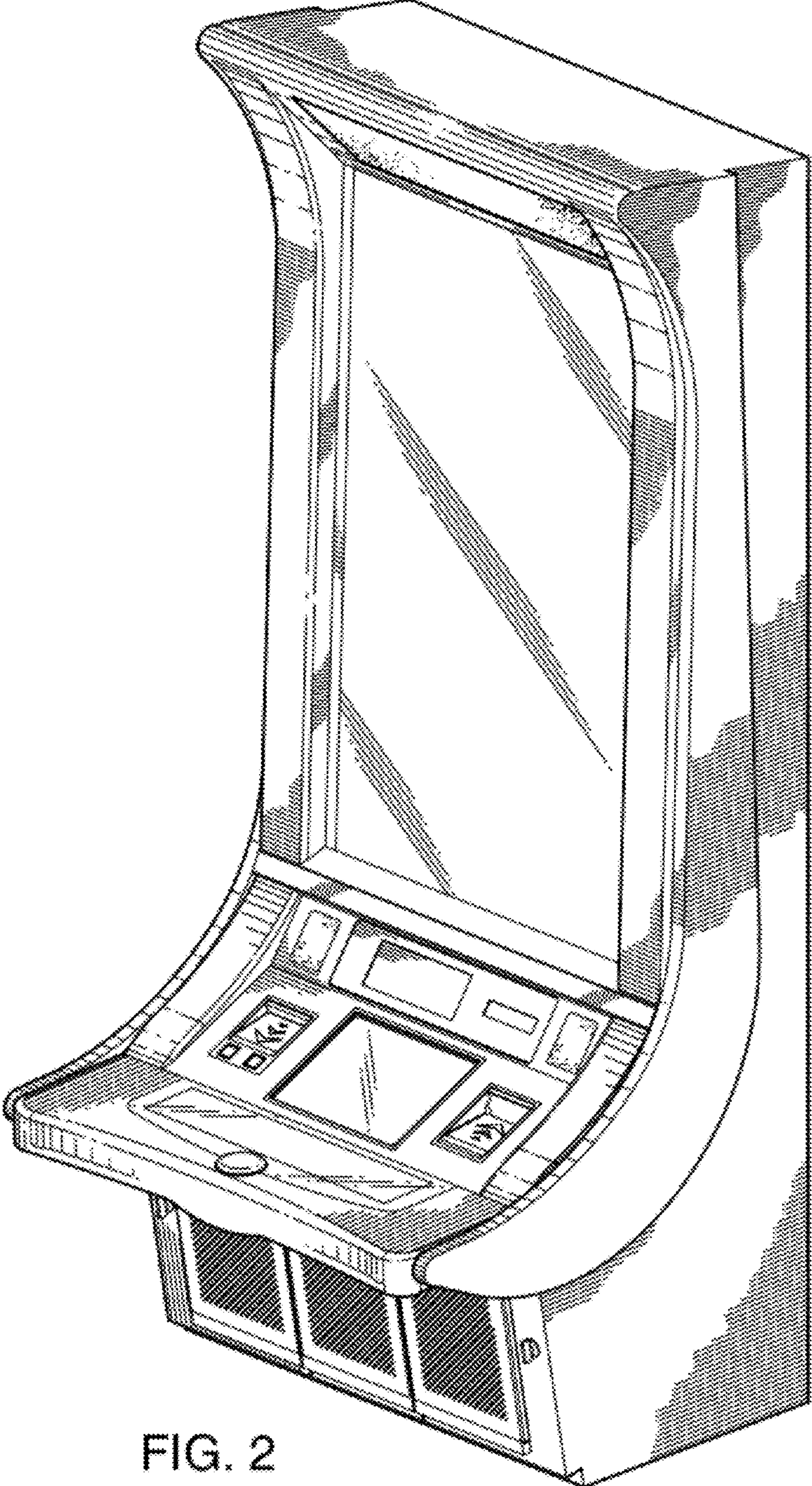

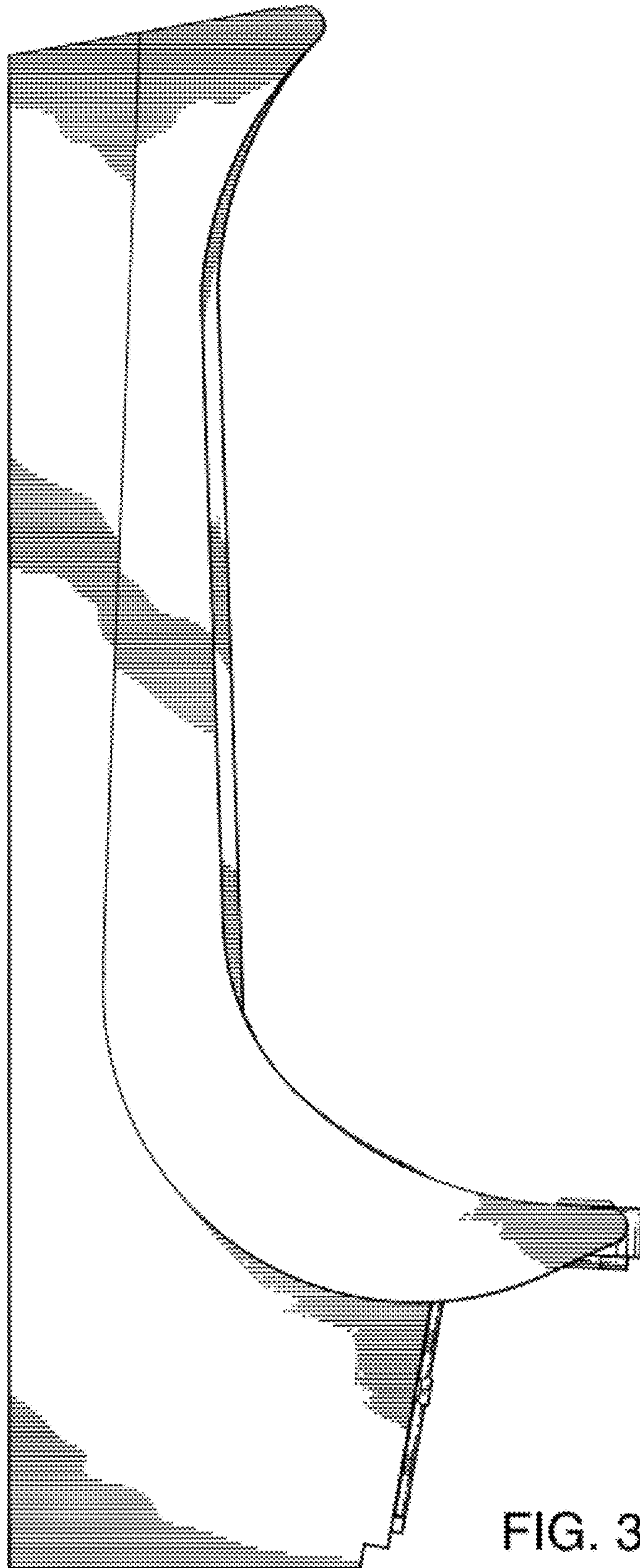

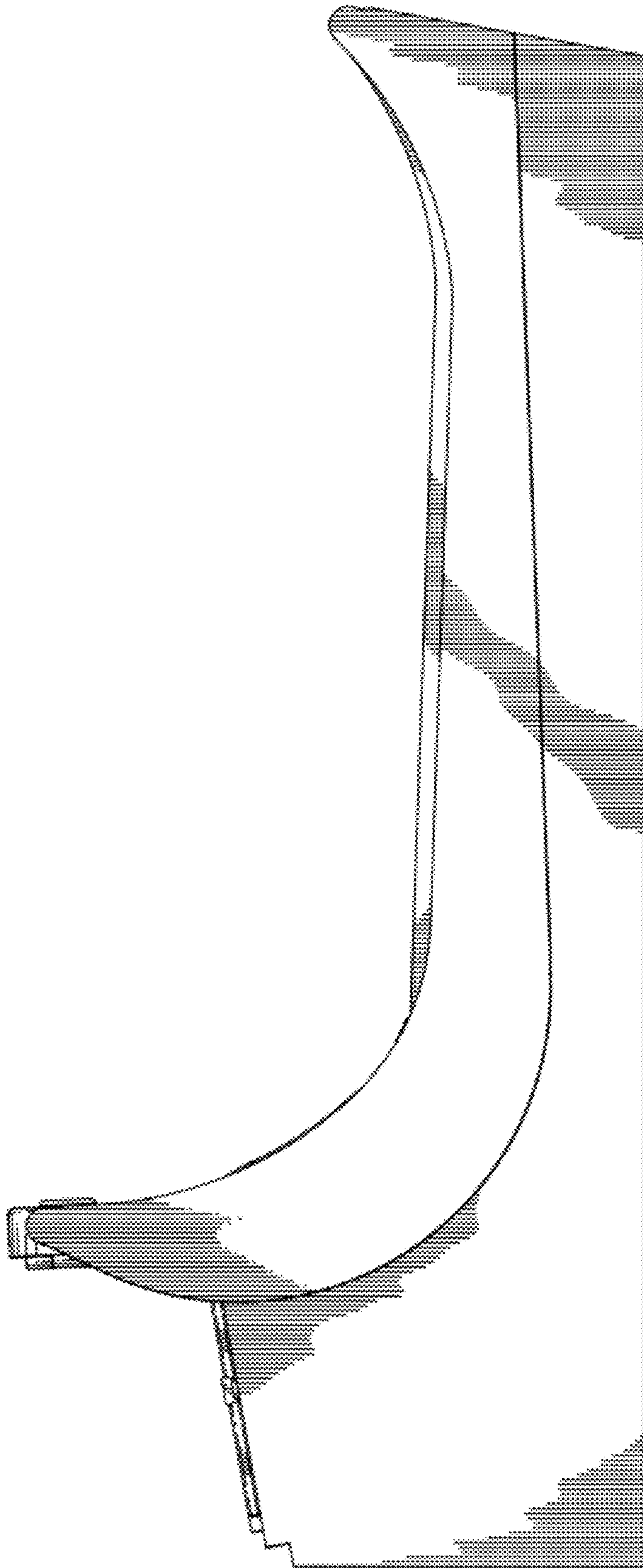

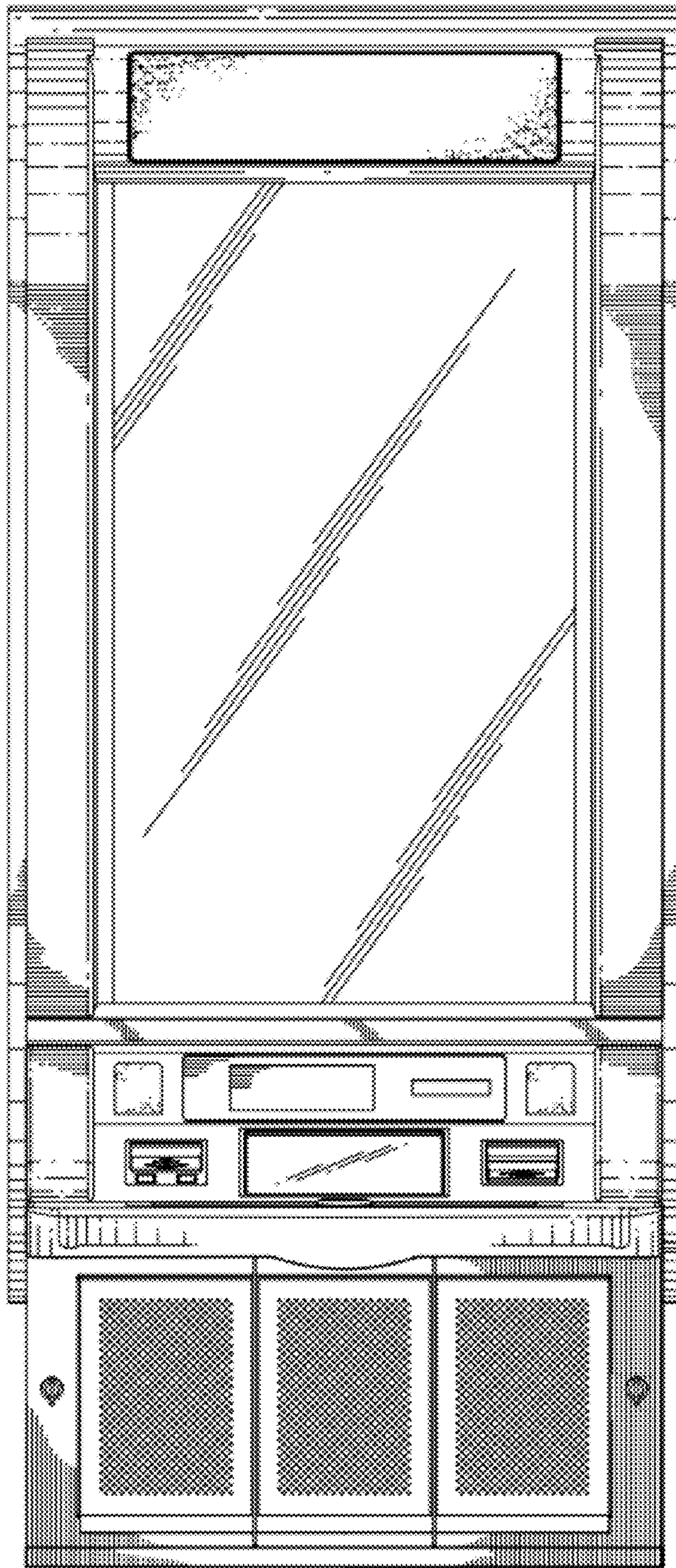

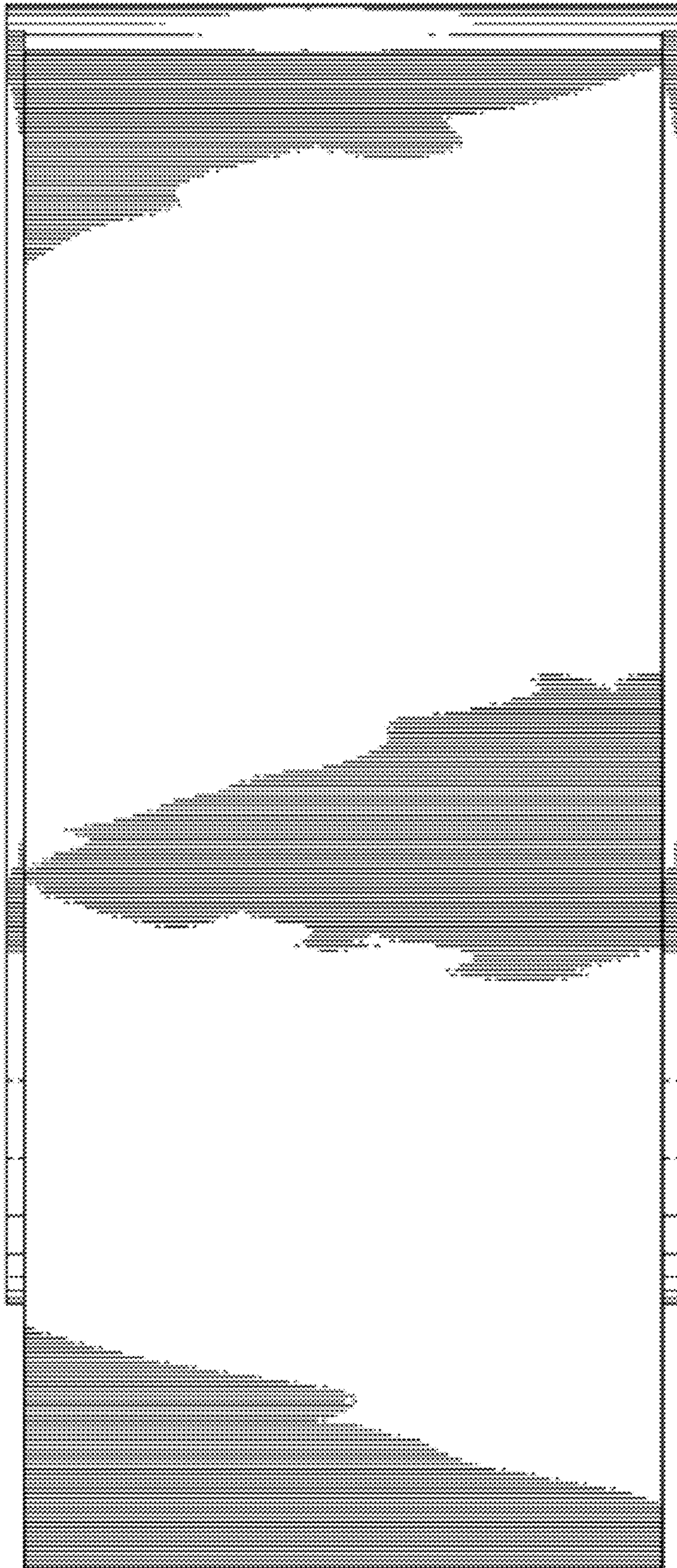

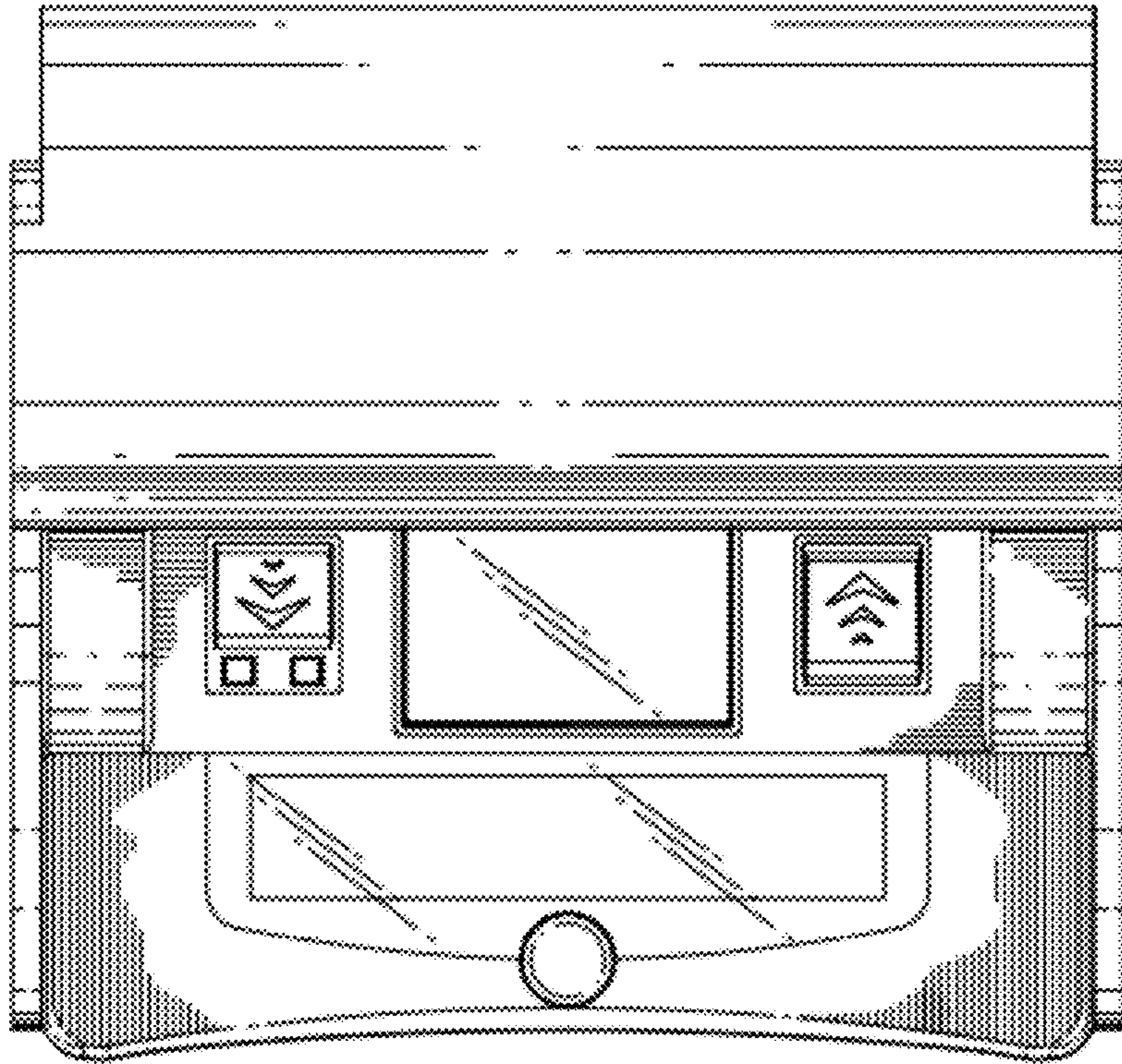

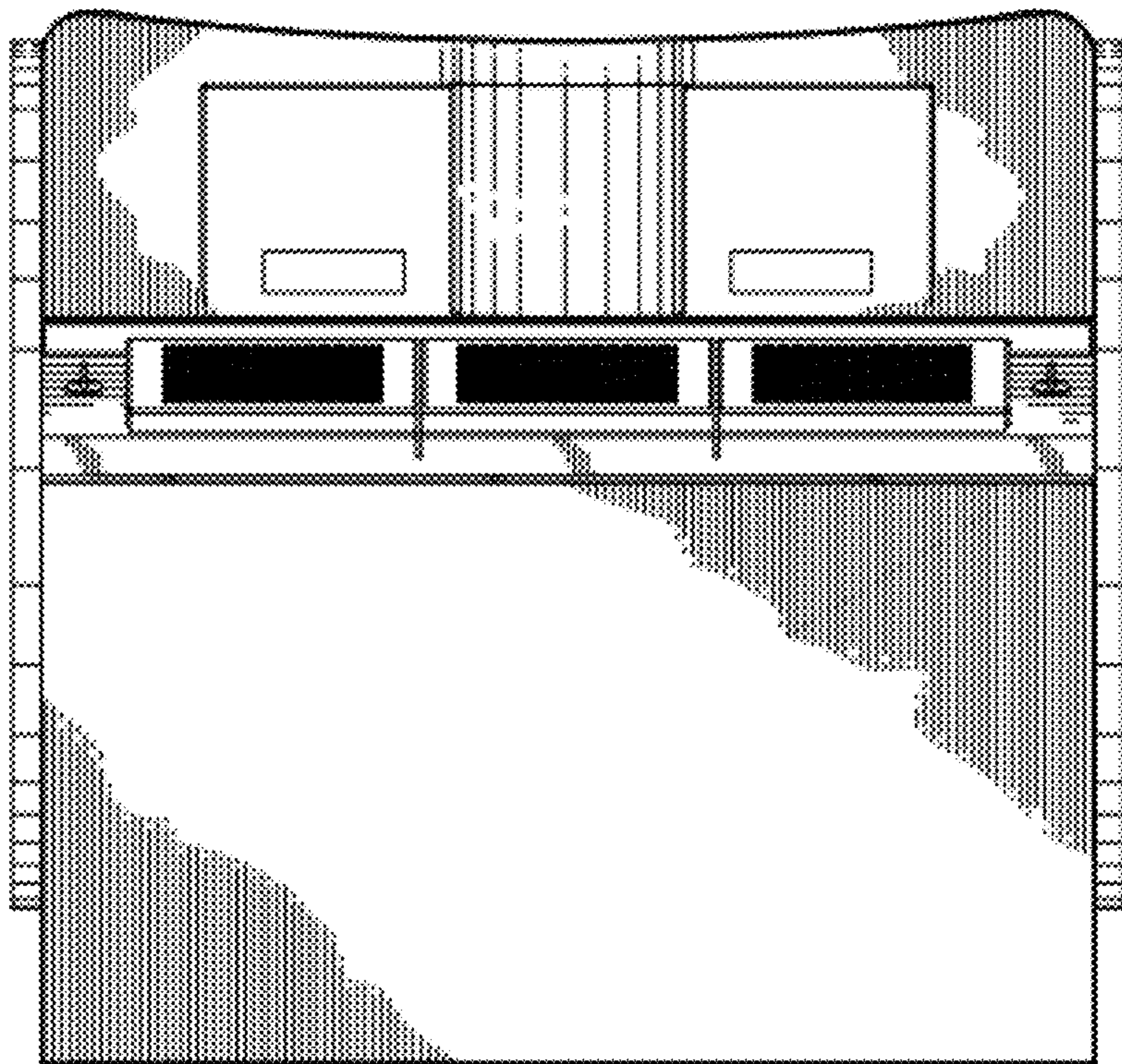
