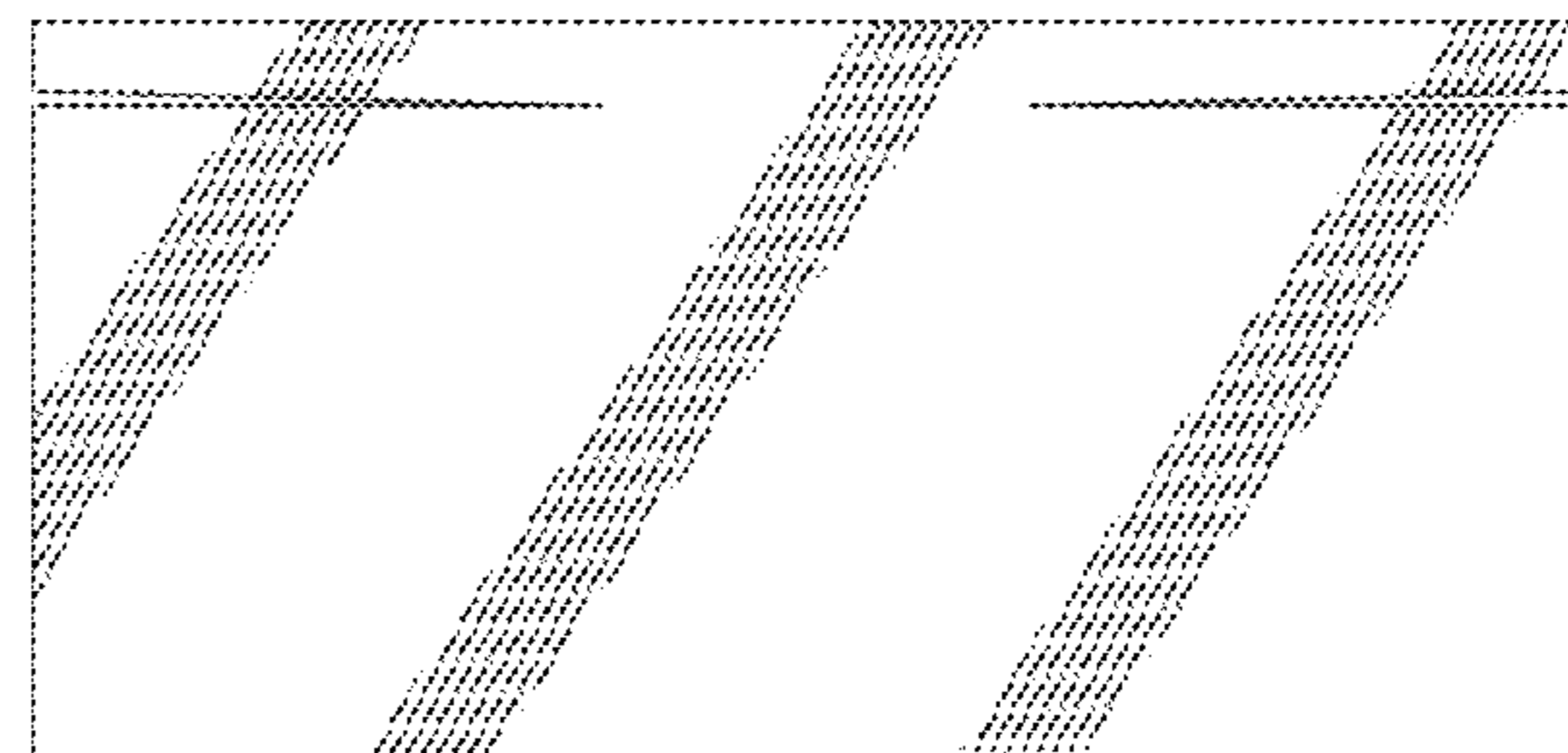
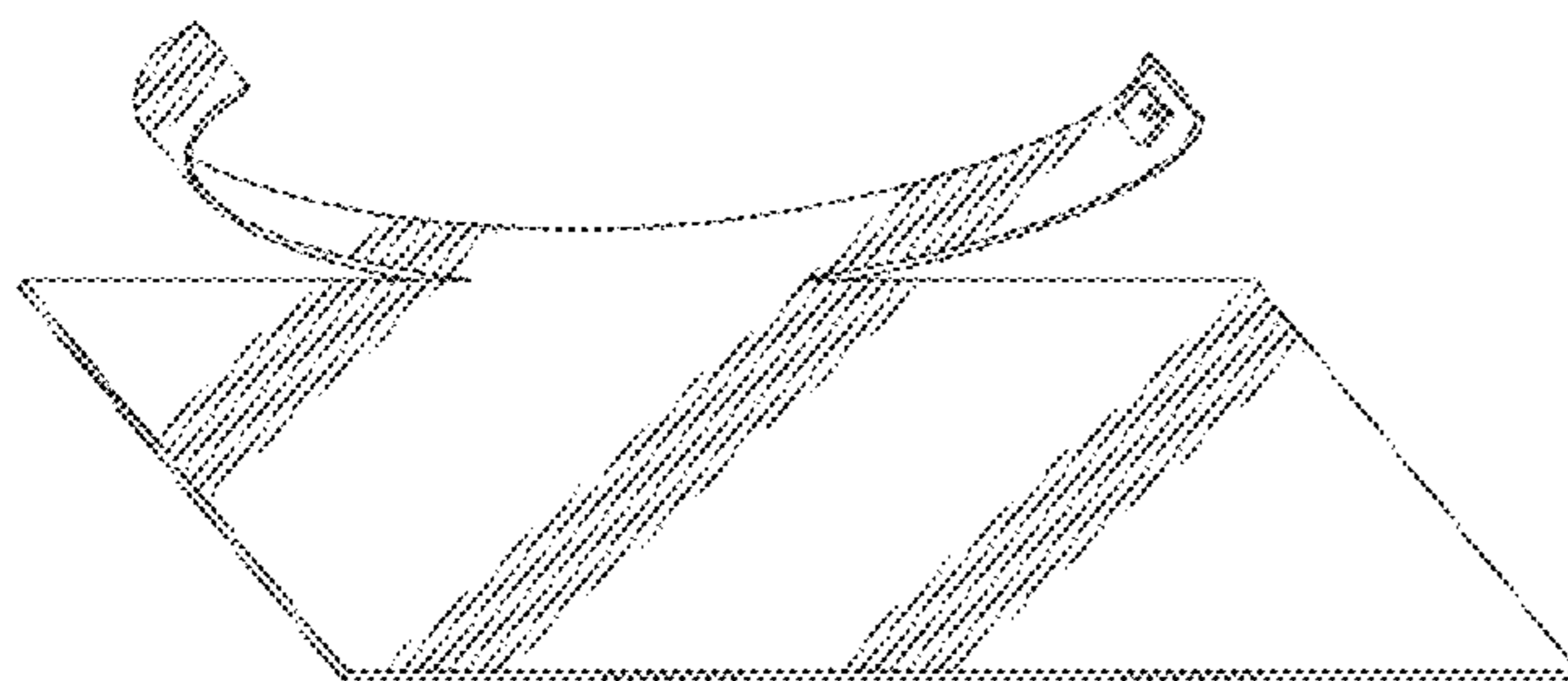
(57) **CLAIM**

I claim the ornamental design for a bib, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a dental bib, showing my new design with two tabs thereof in a slightly curved position; FIG. 2 is a rear elevational view thereof, illustrated with the two tabs in a flat position; FIG. 3 is a front elevational view of FIG. 2; FIG. 4 is a top plan view of FIG. 2, the bottom plan view being a mirror image thereof; and, FIG. 5 is a left-side elevational view of FIG. 2, the right-side elevational view being a mirror image thereof.

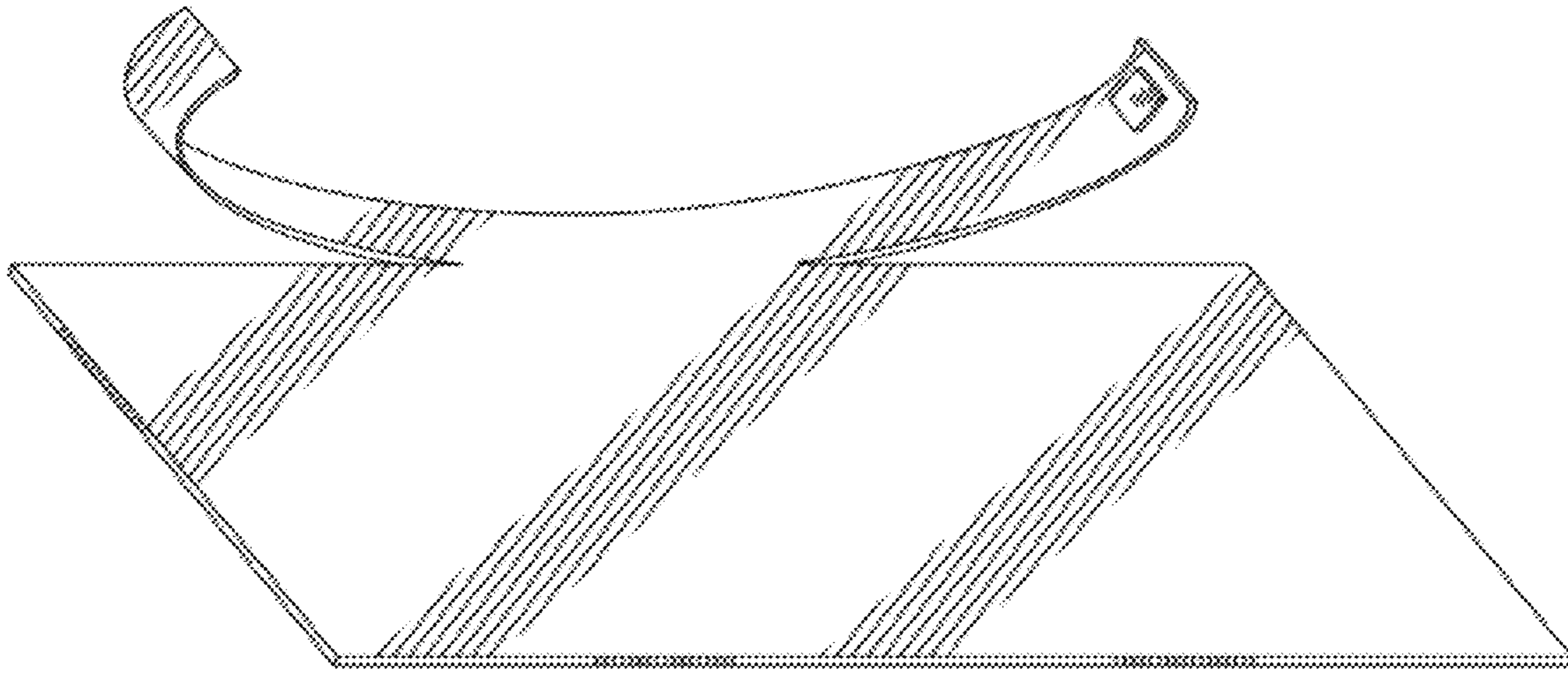

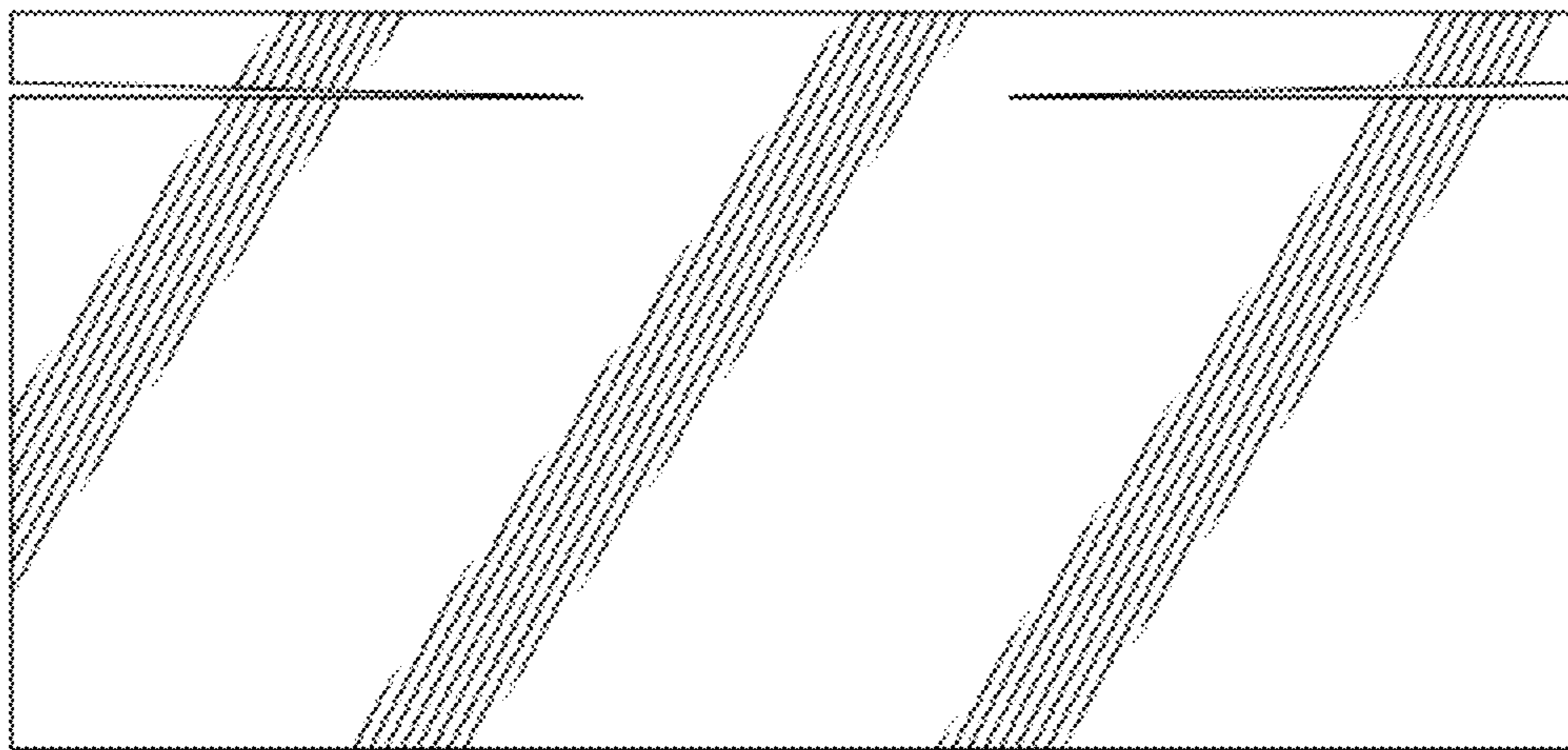

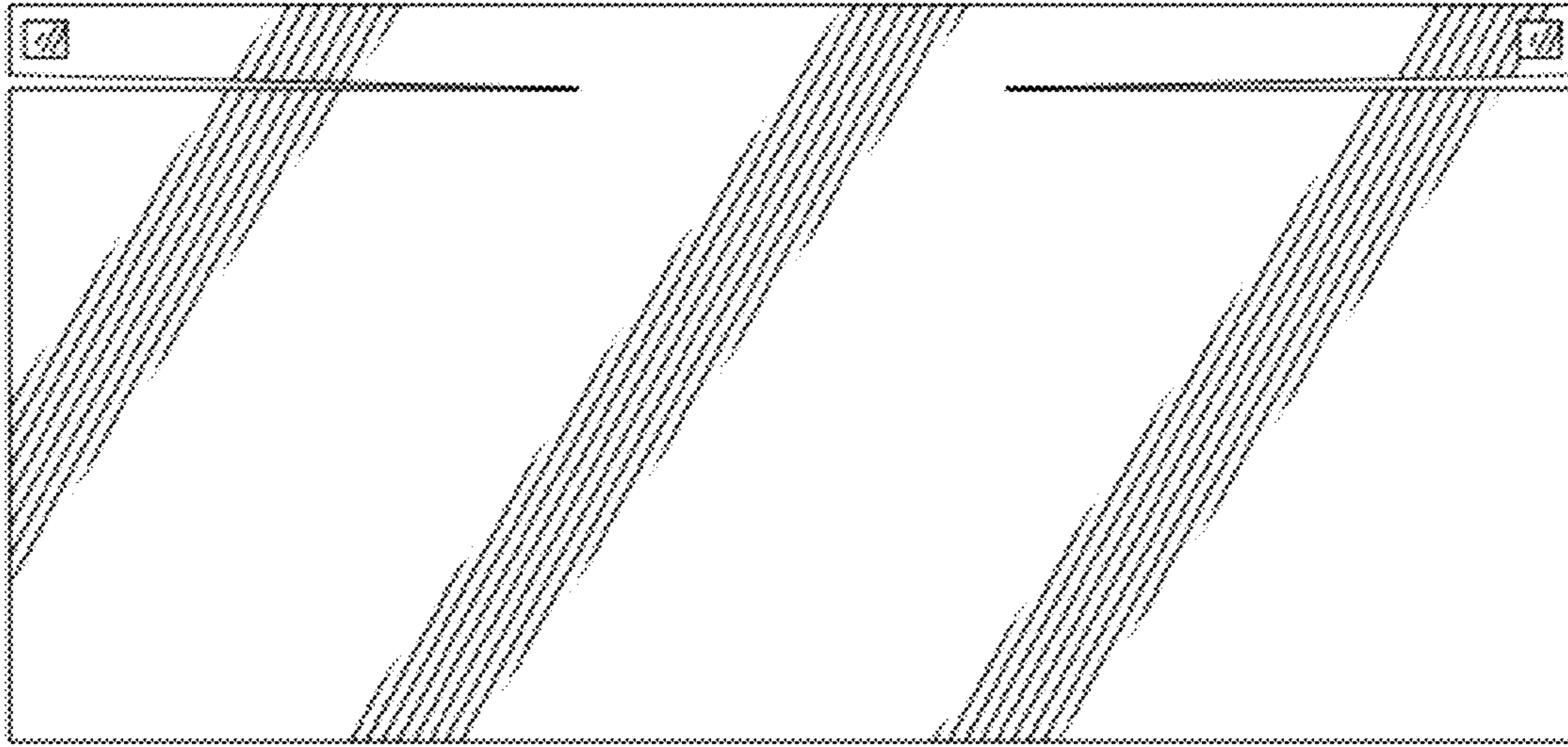
