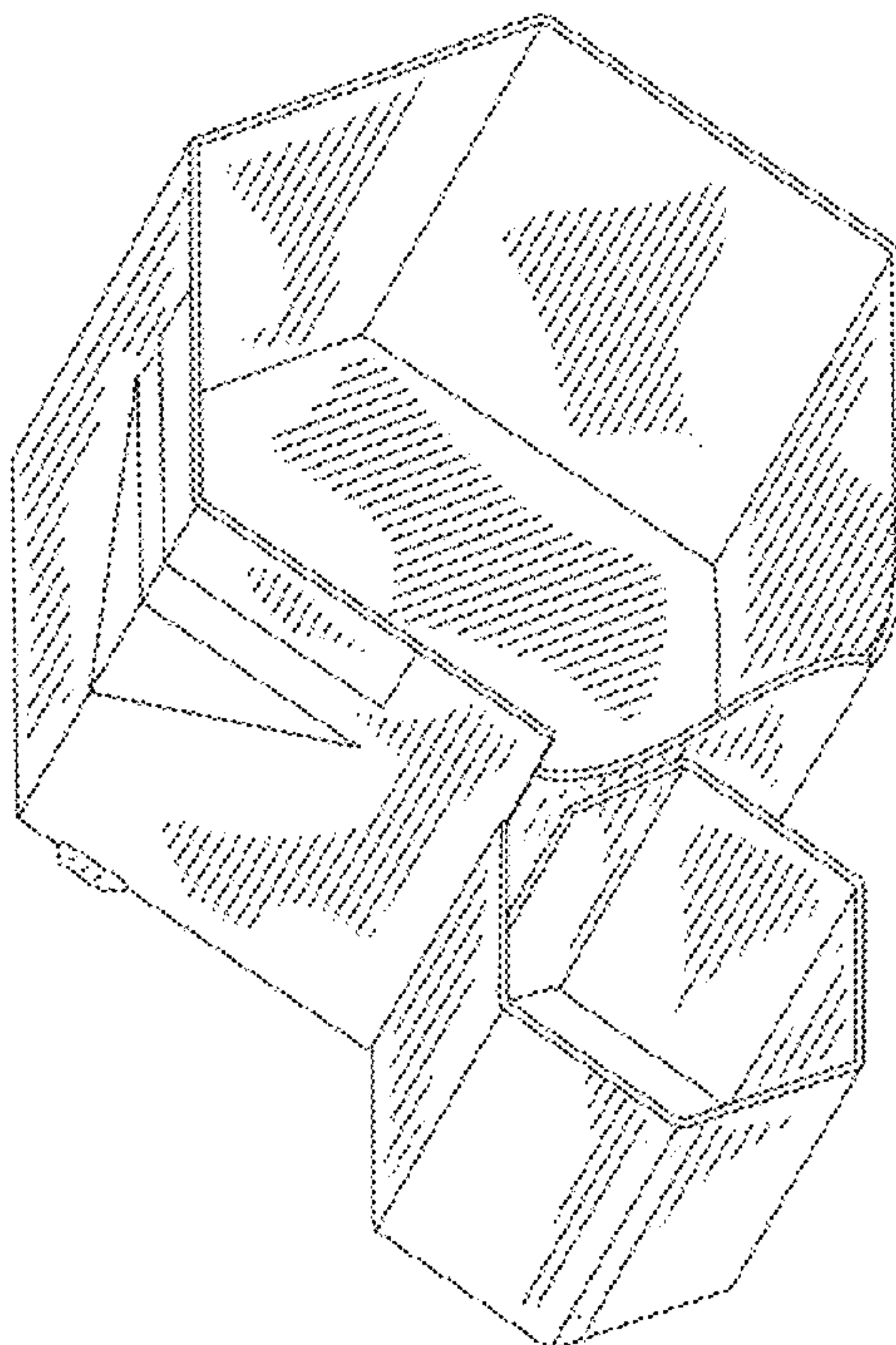
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a combination food and beverage carrier, showing my new design;

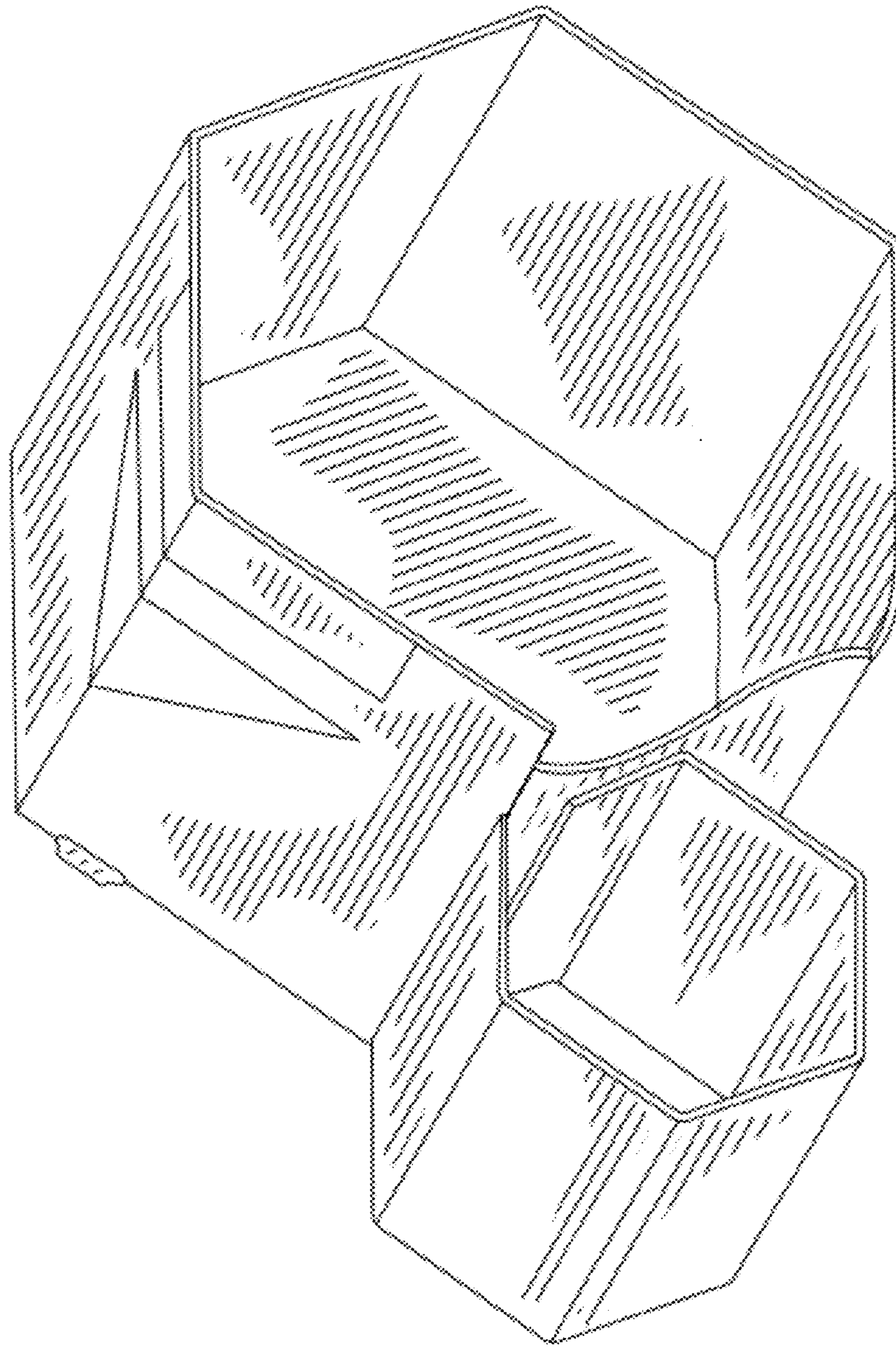

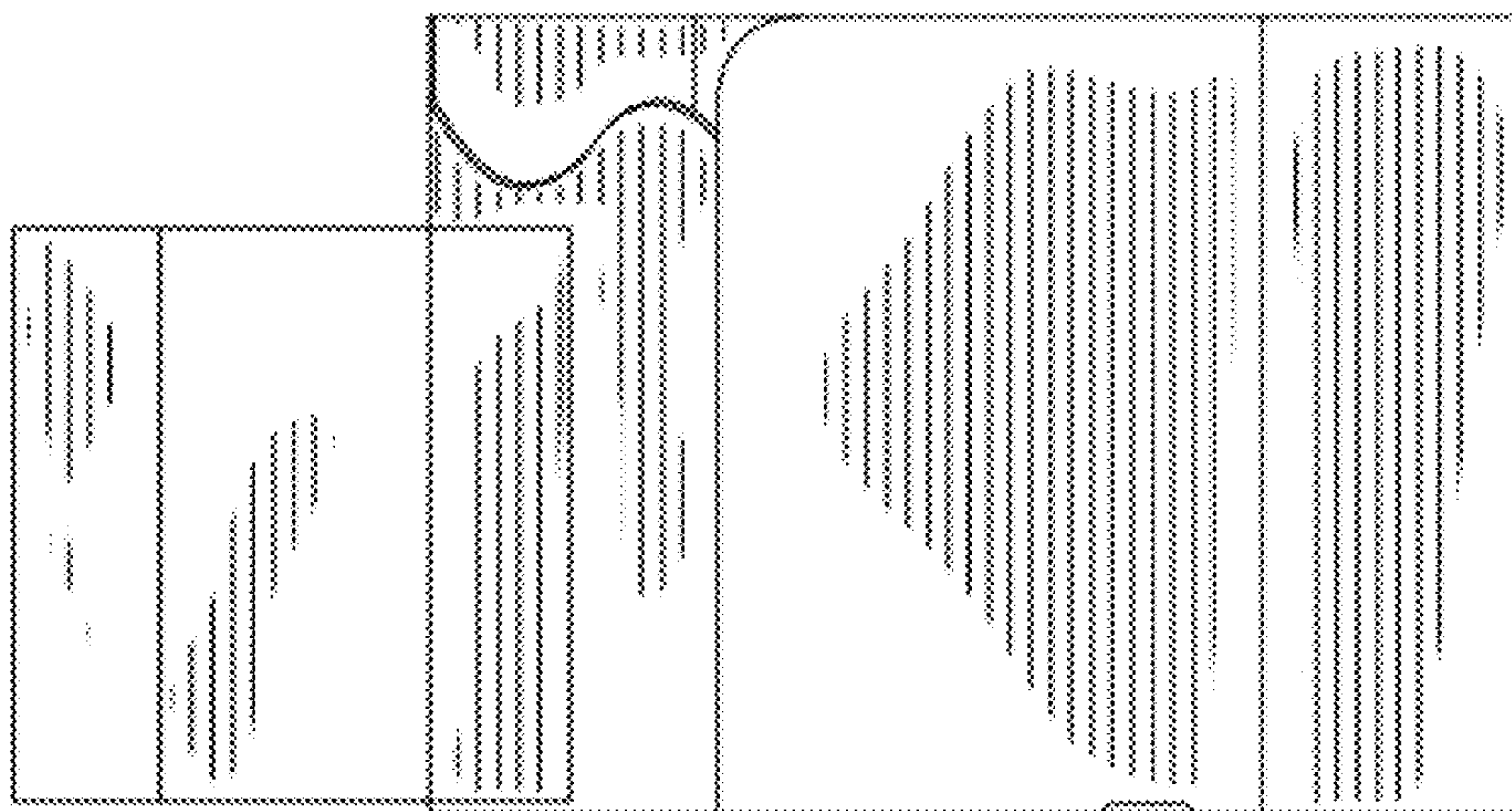

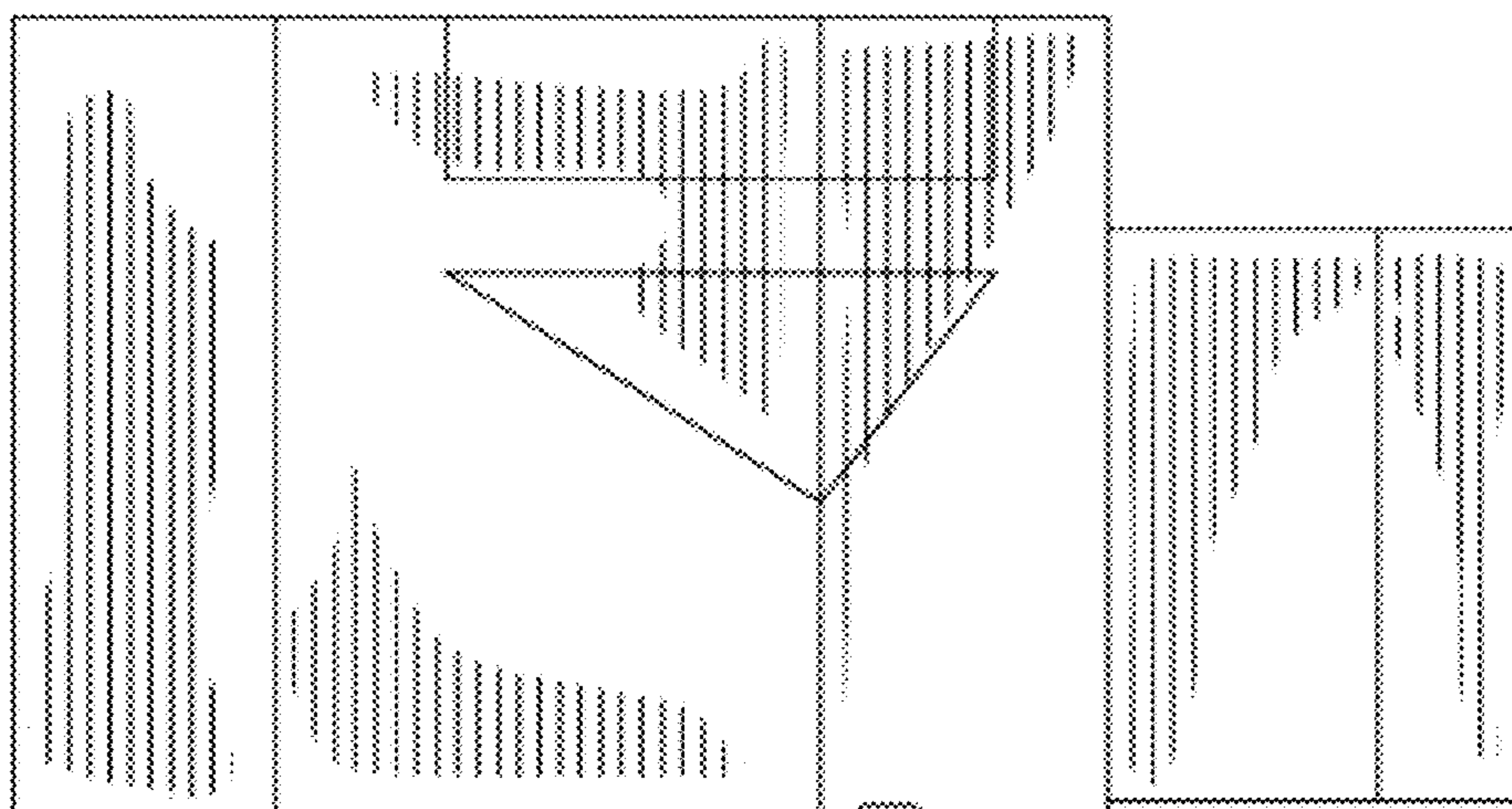

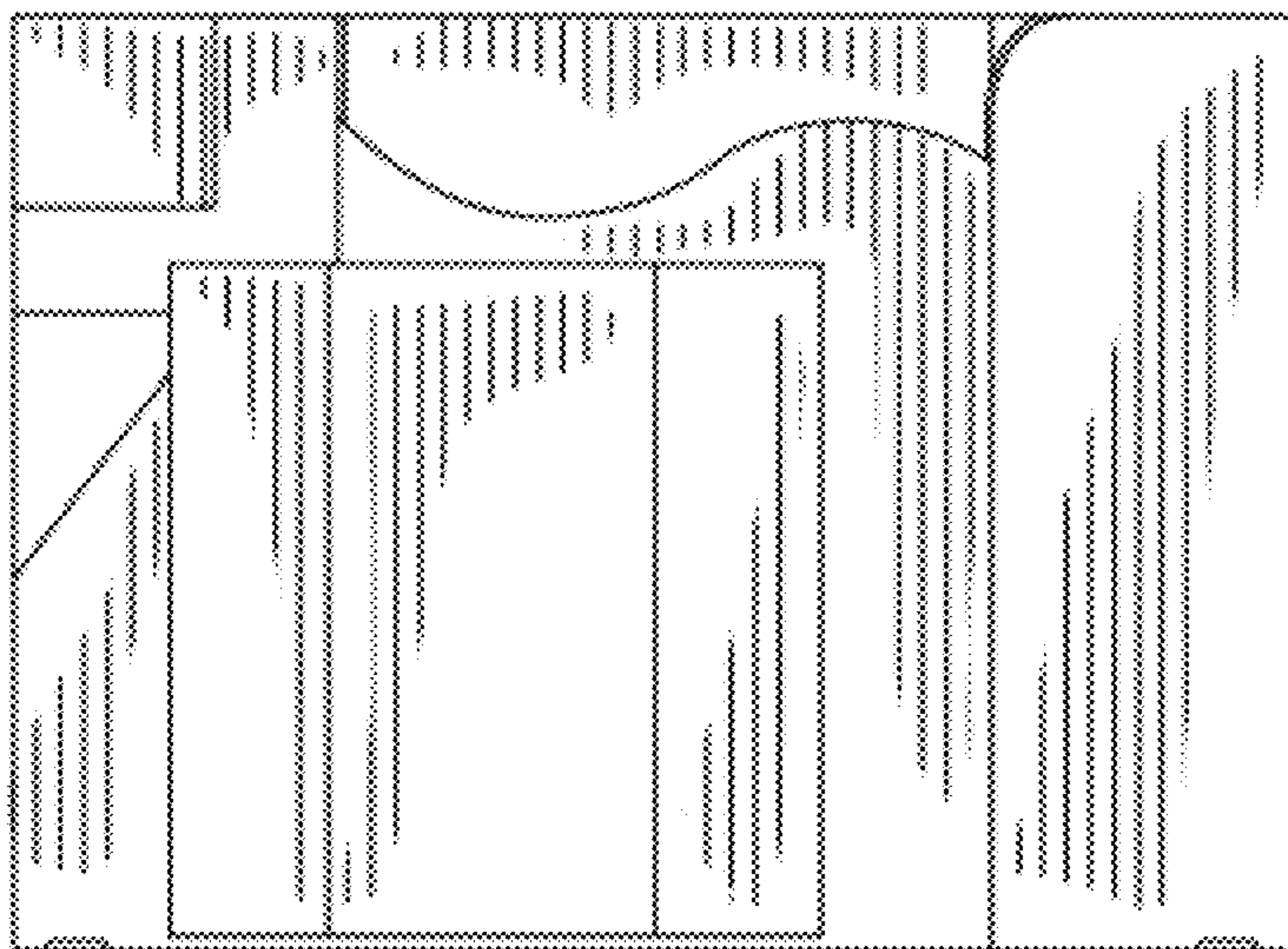

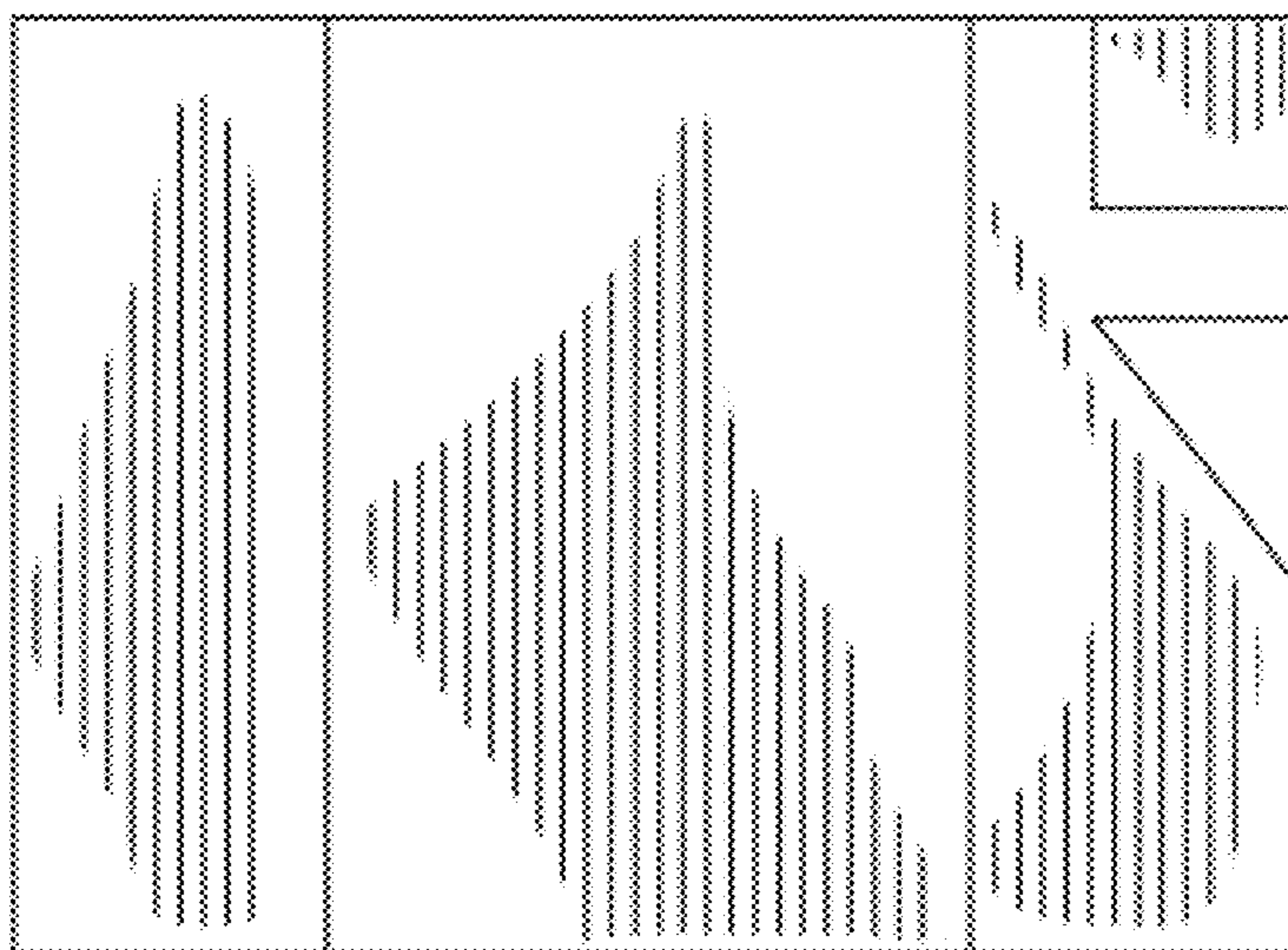

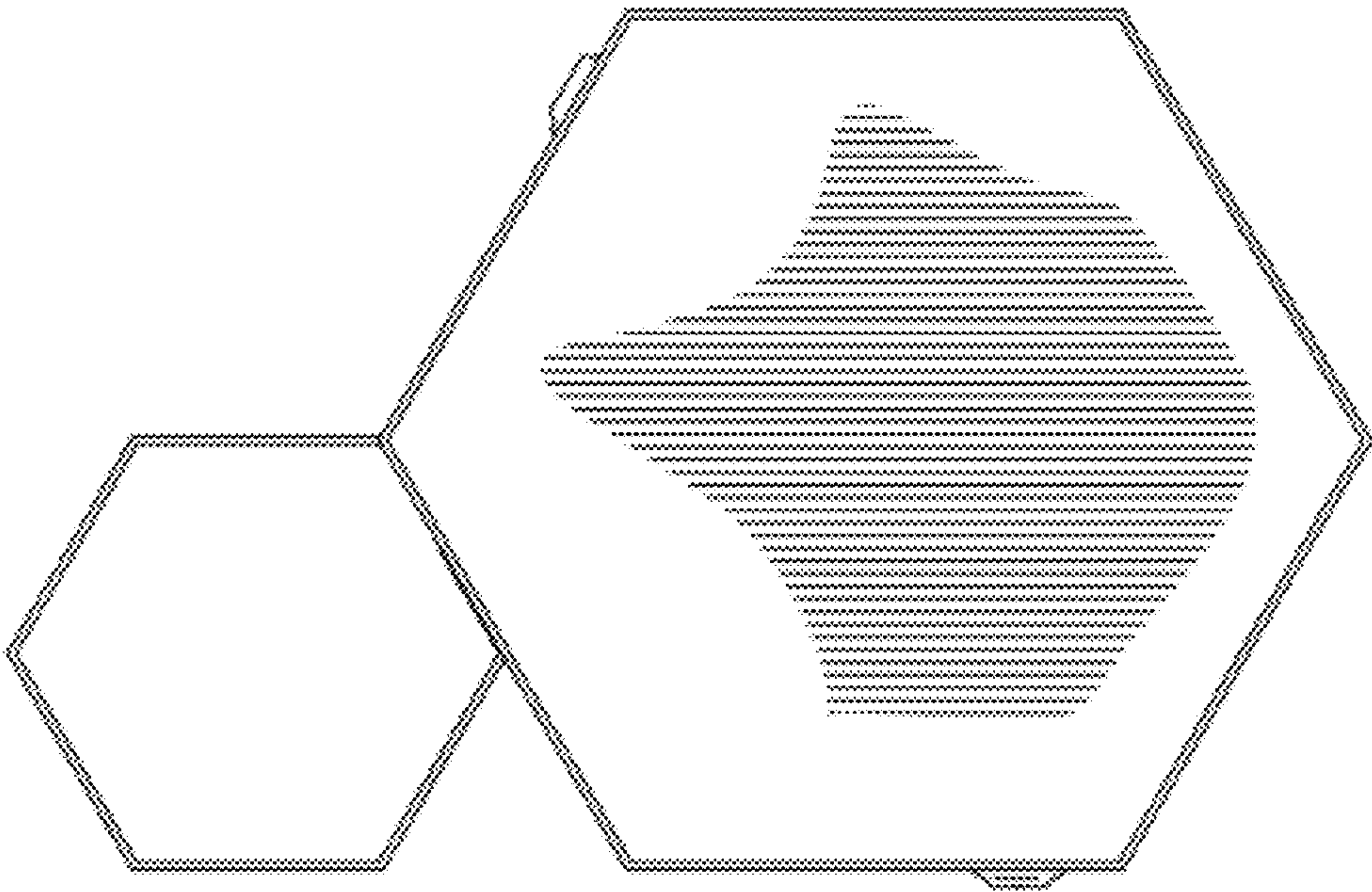

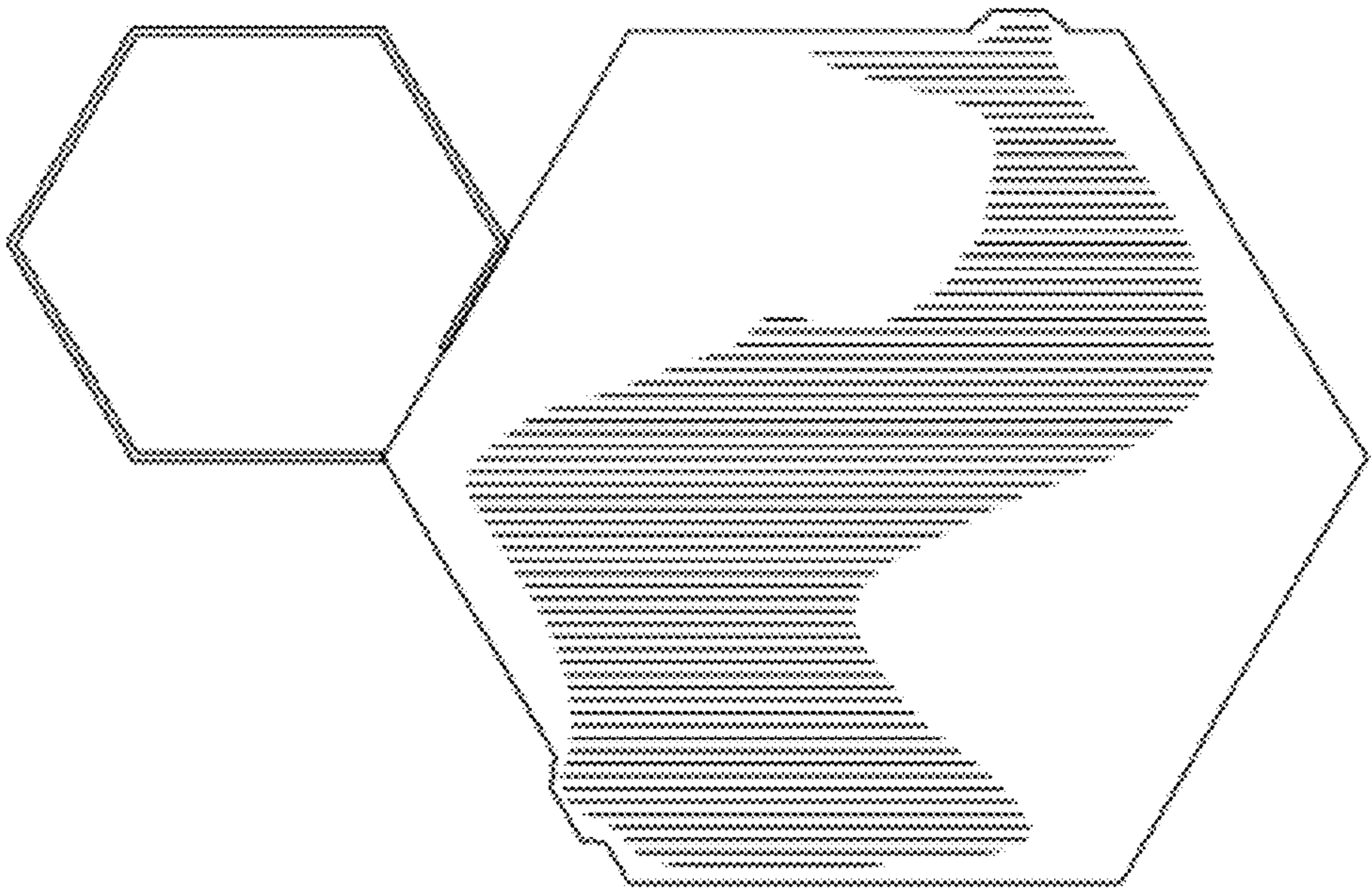
