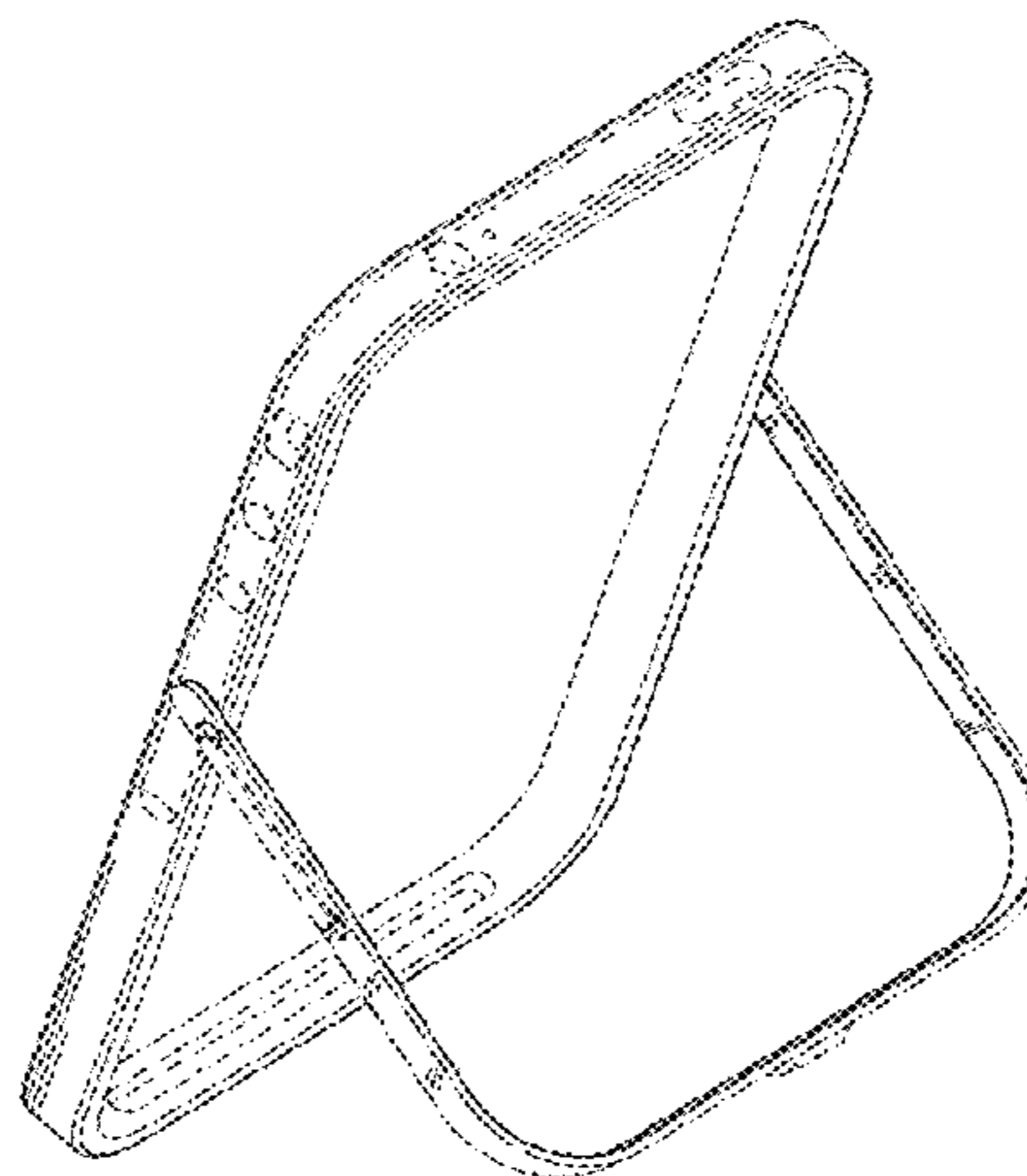
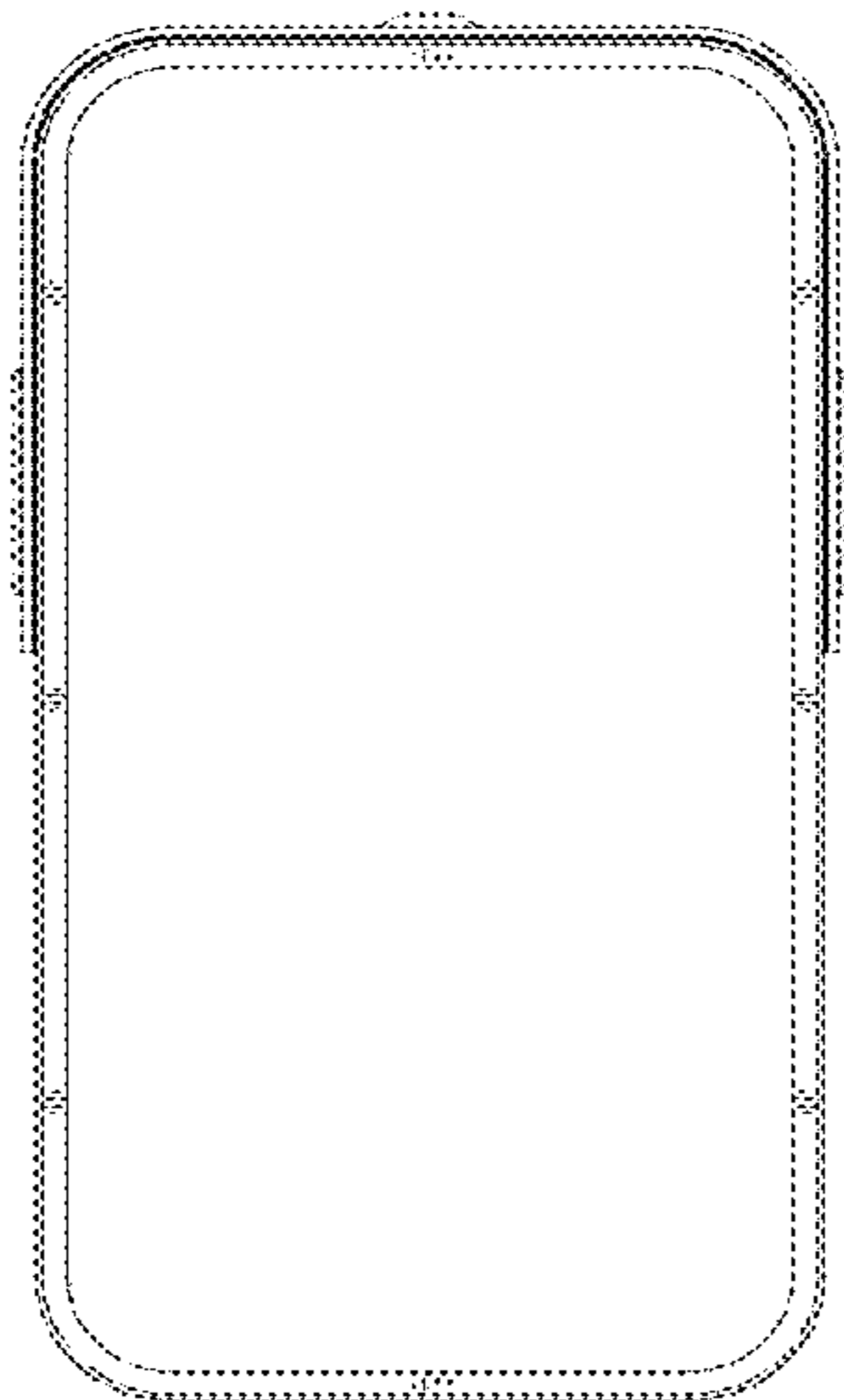
(57) **CLAIM**

The ornamental design for a protective casing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a protective casing showing our design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side, elevational view thereof;
FIG. 5 is a right side, elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is another perspective view of the protective casing in FIG. 1, with a support stand rotated.
The broken lines of all the figures are for the purpose of illustrating environmental structures and form no part of the claimed design.

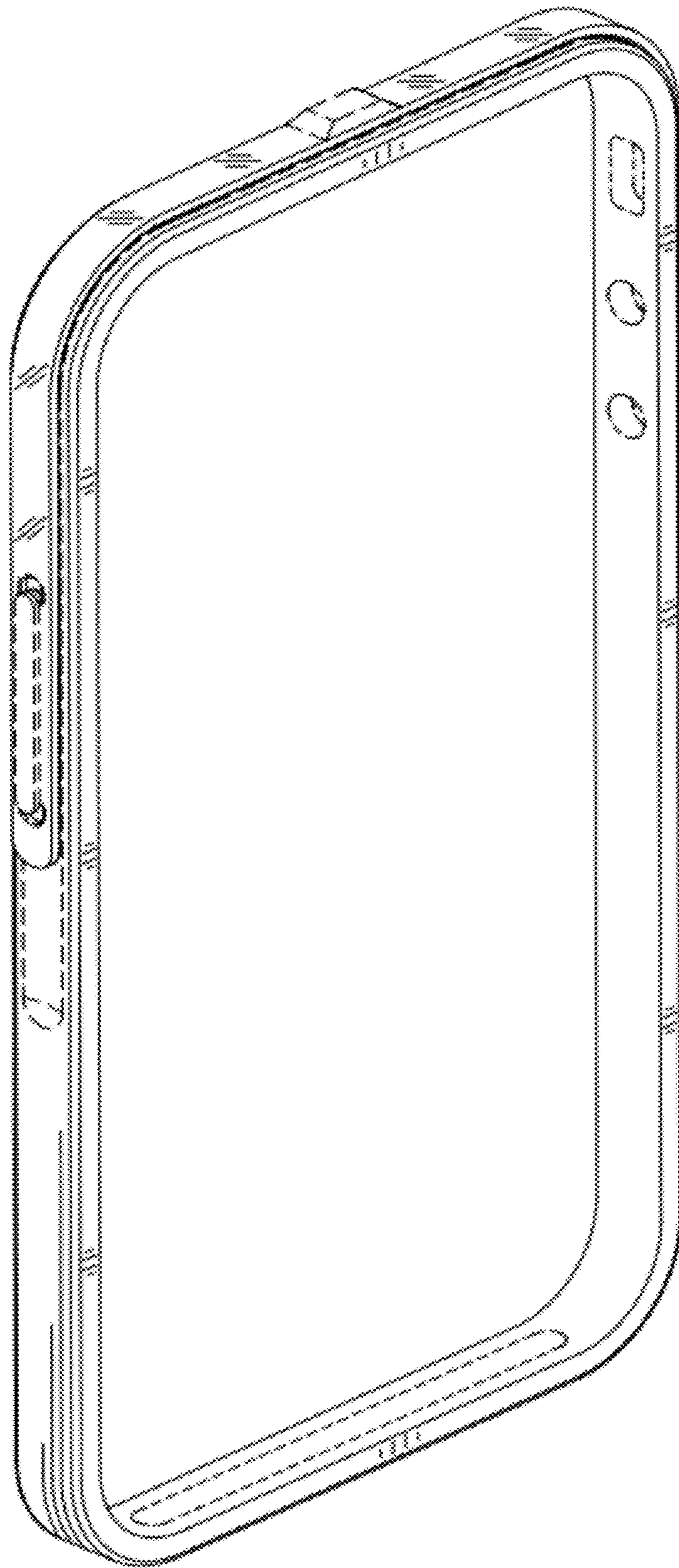

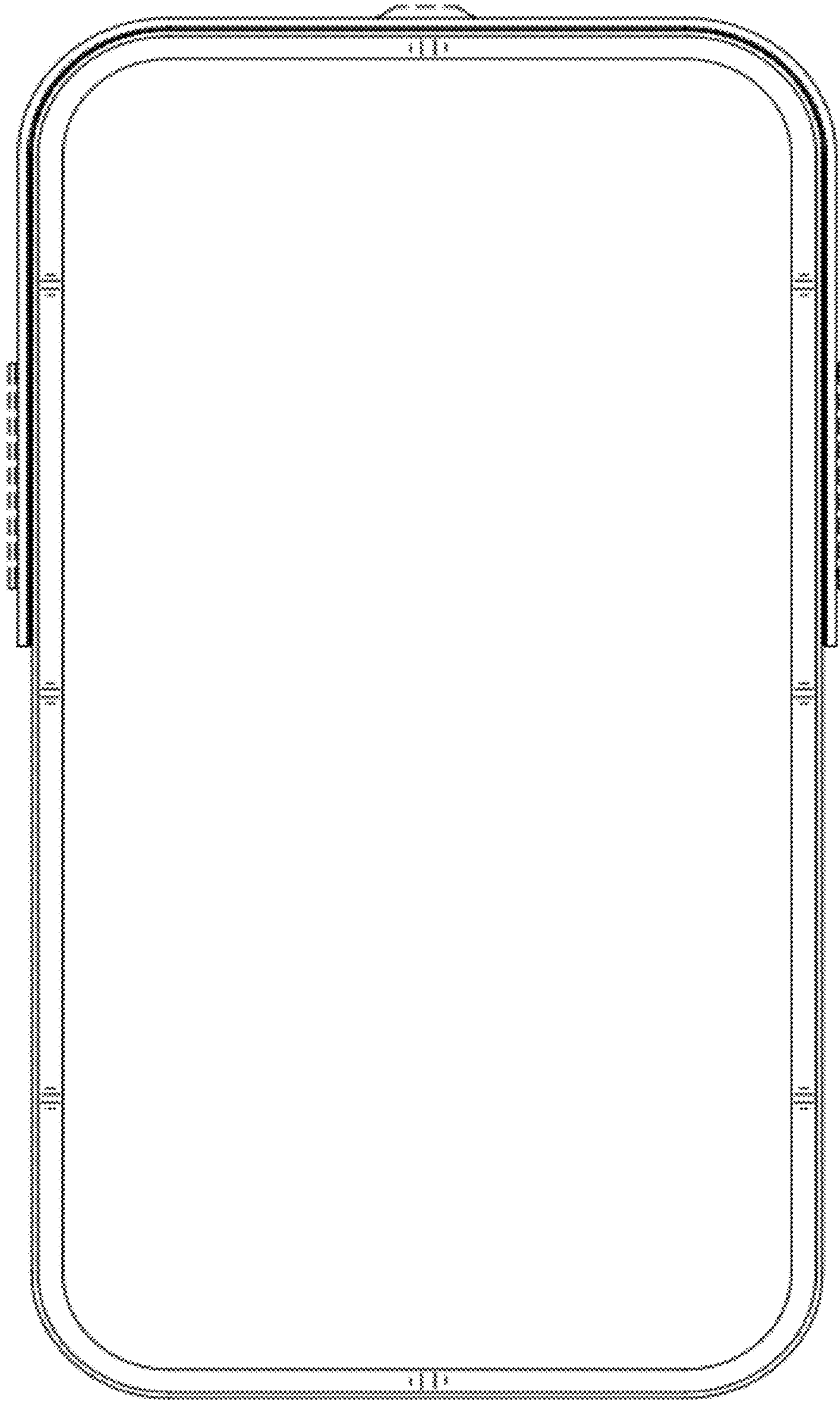

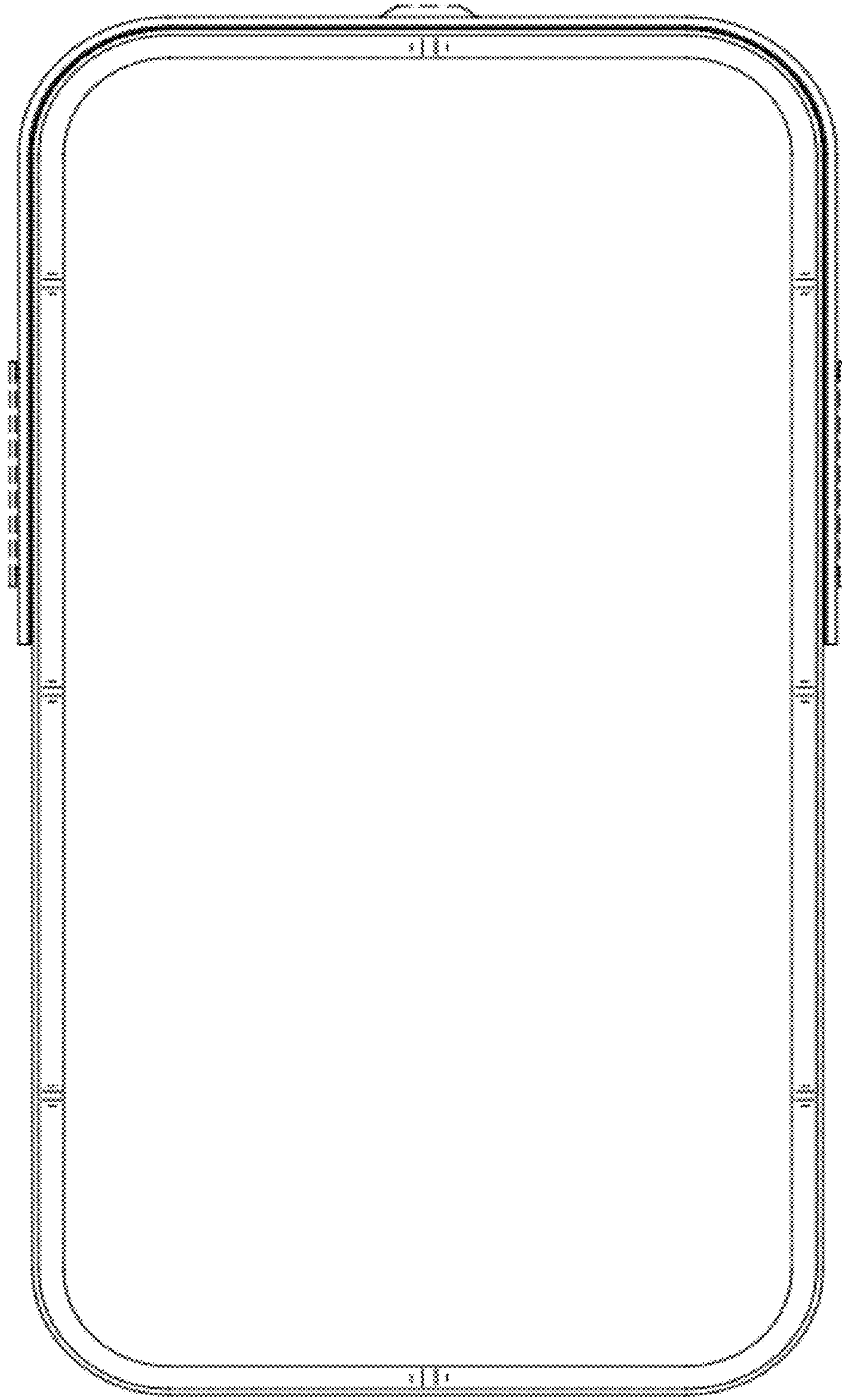

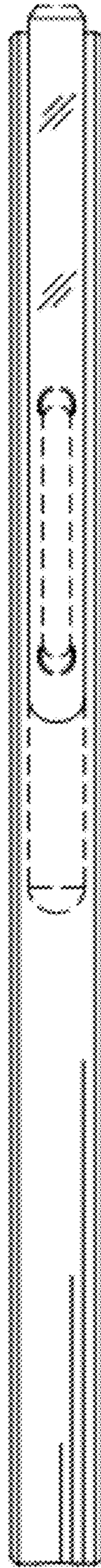

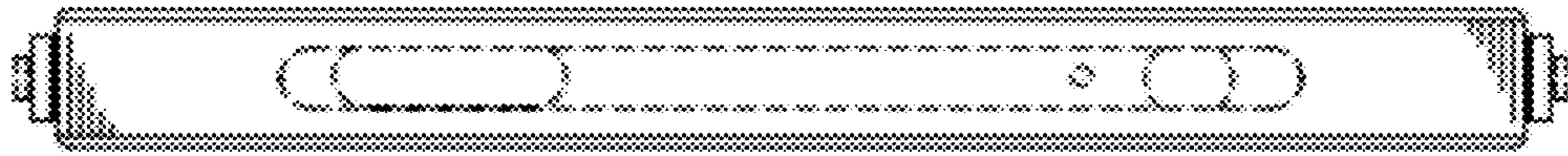

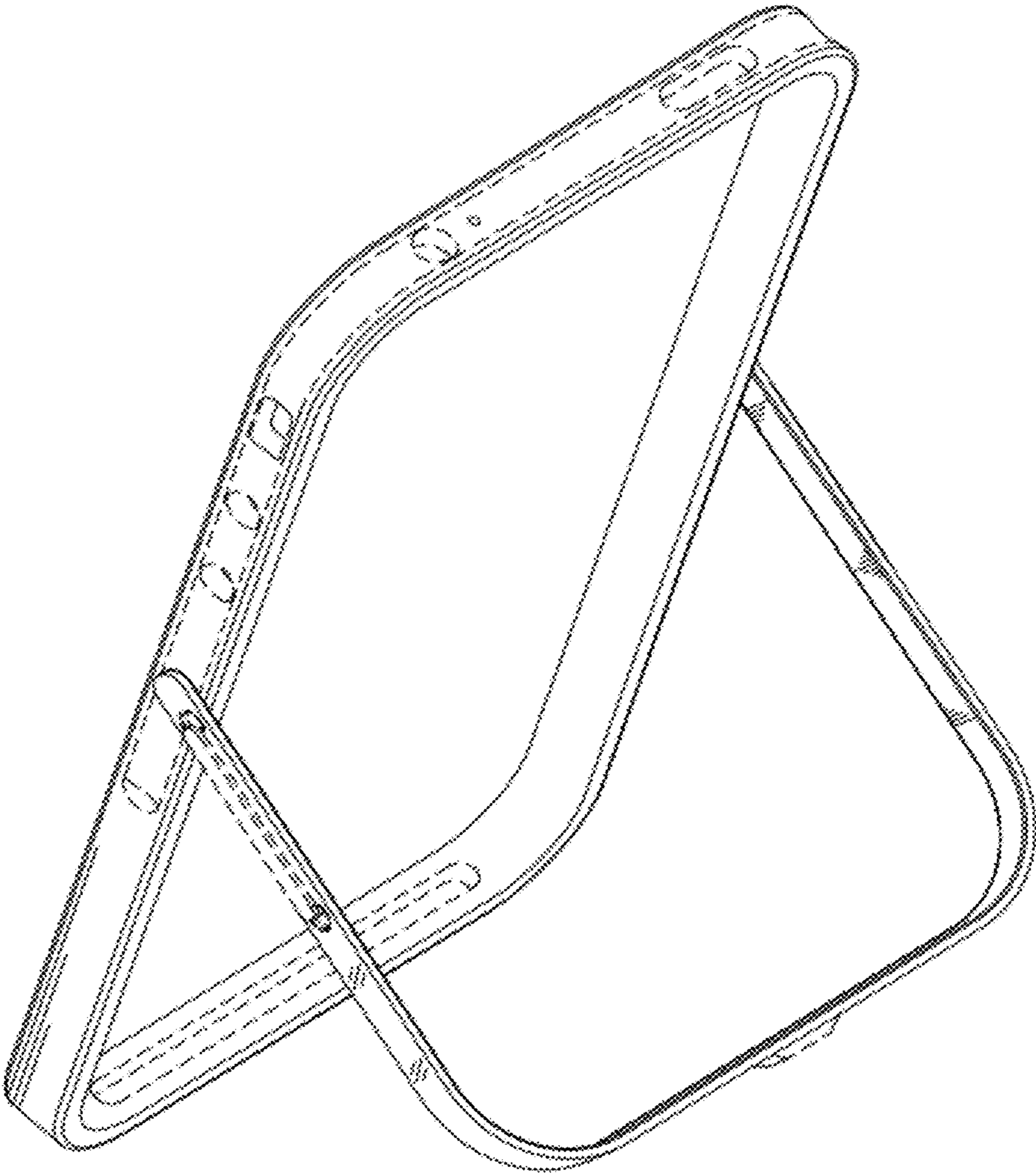
