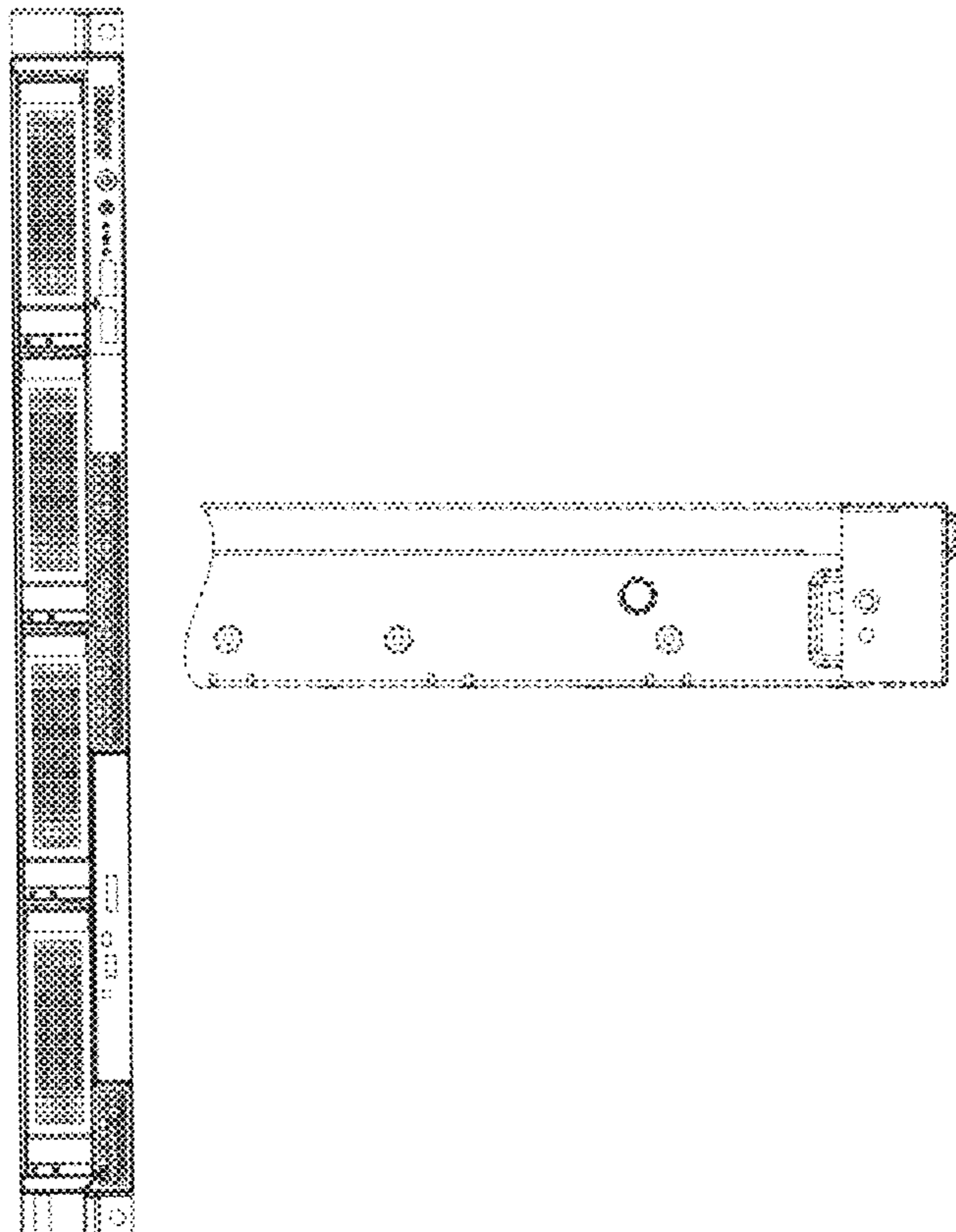
(57) **CLAIM**

The ornamental design for a server unit, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a server unit showing our design; FIG. 2 is a top view thereof; FIG. 3 is a bottom view thereof; FIG. 4 is a first side view thereof; and, FIG. 5 is a second side view thereof, opposite the first side. The broken lines in the drawings illustrate portions of the server unit, or environment, and form no part of the claimed design. 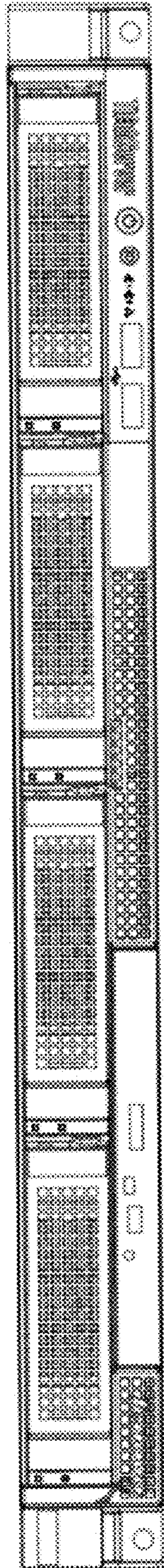

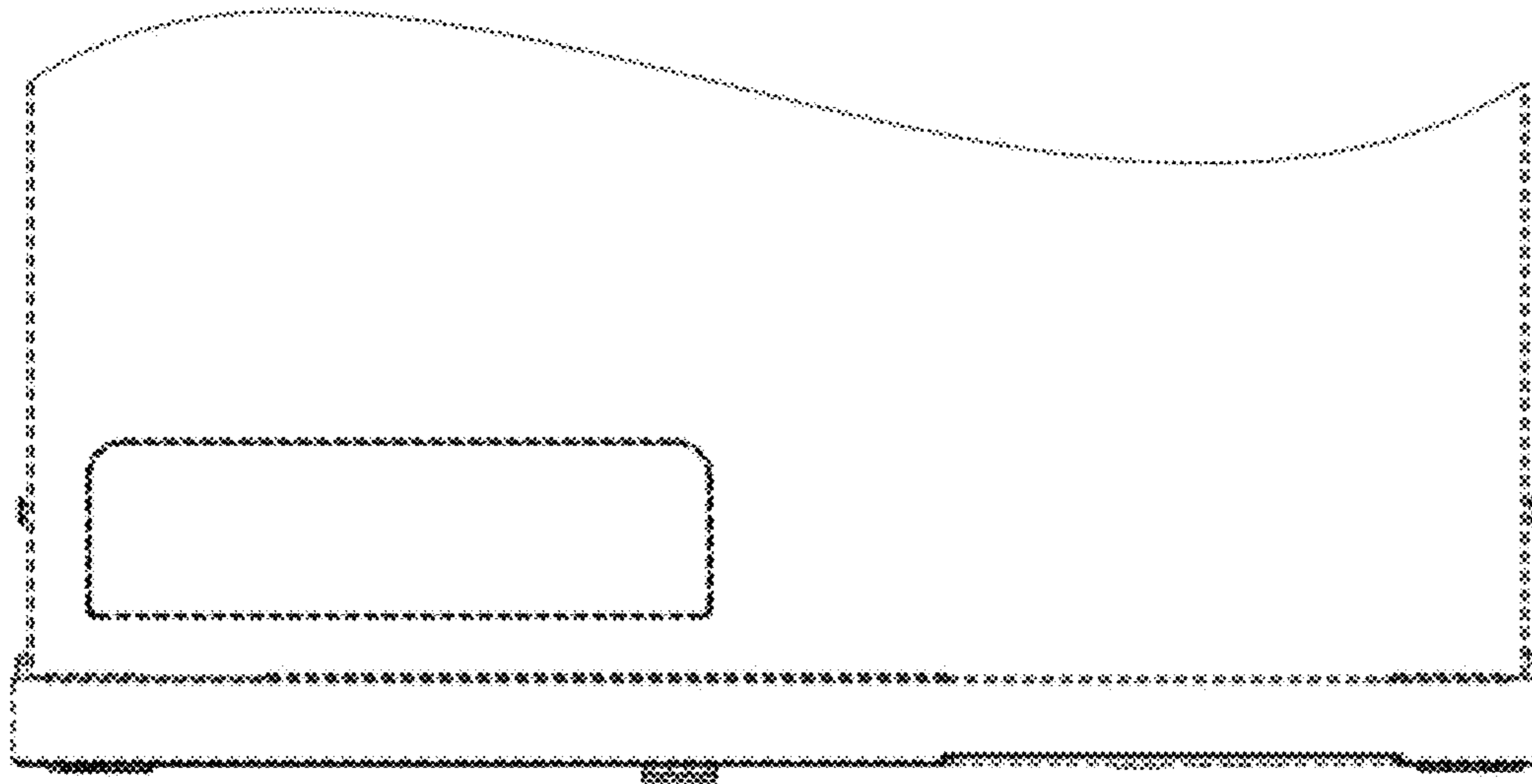

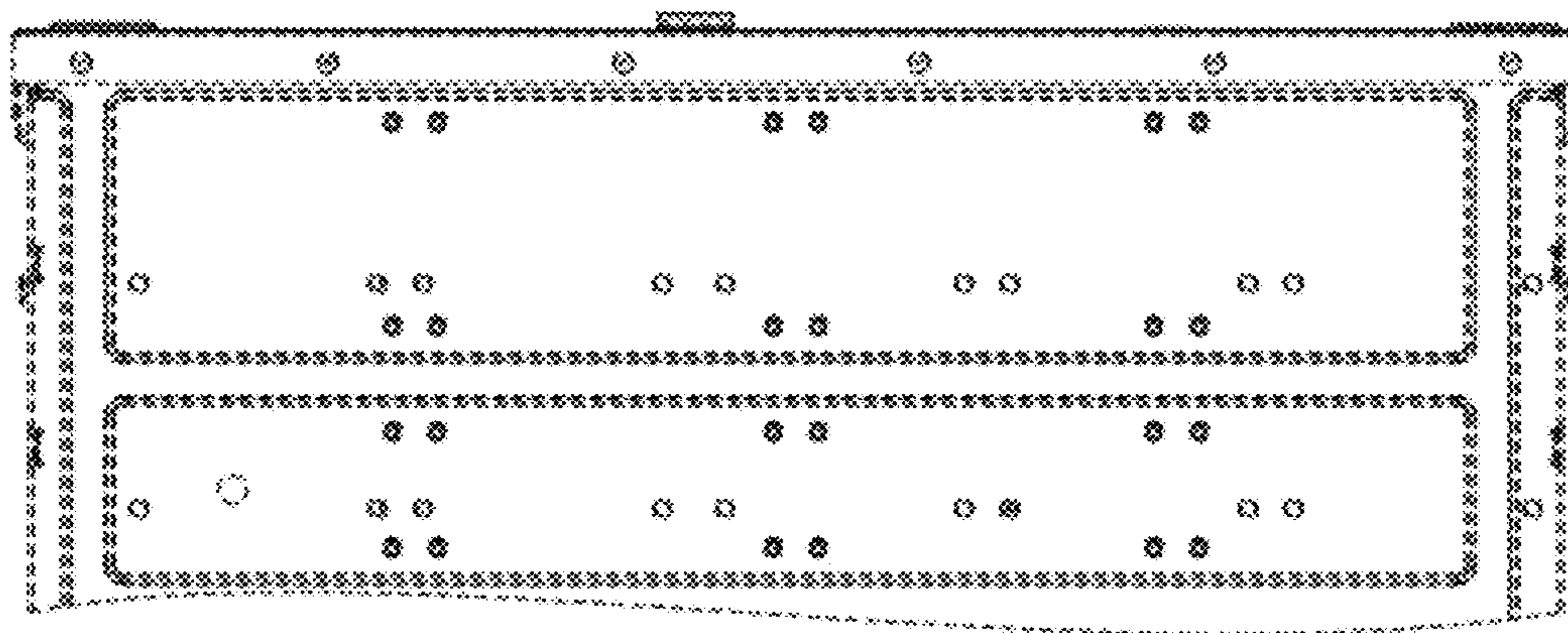

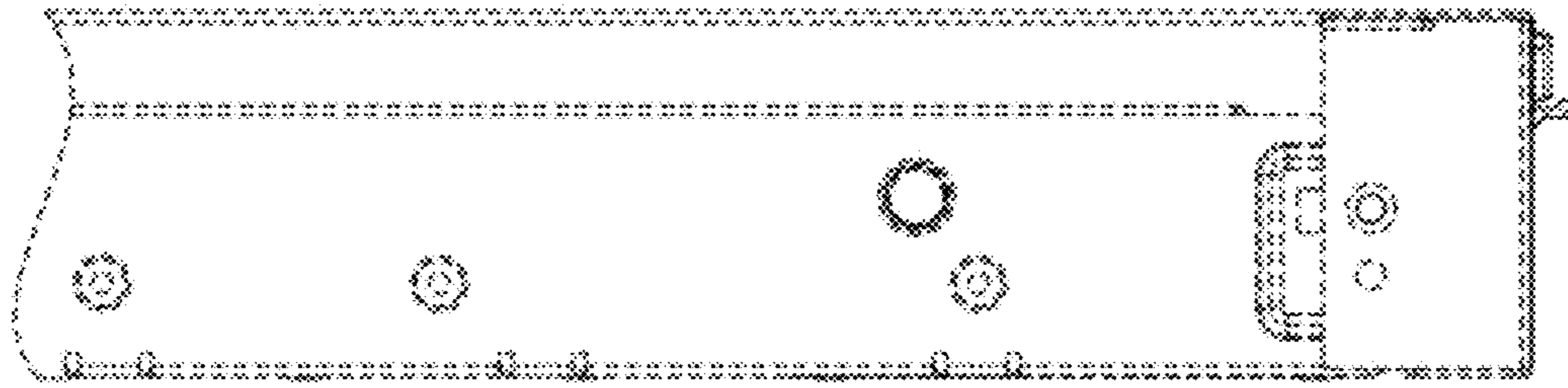

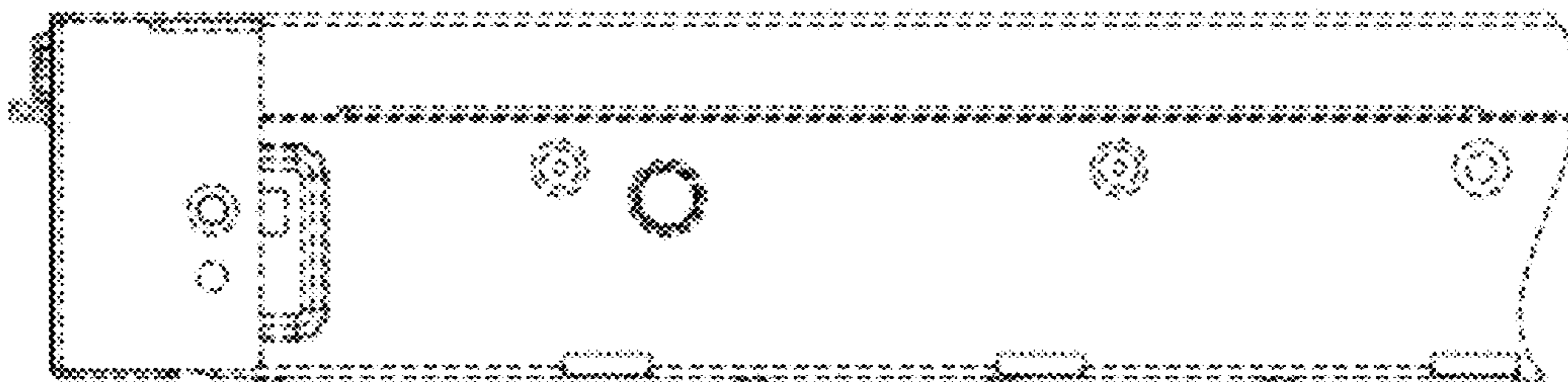
