(57) **CLAIM**

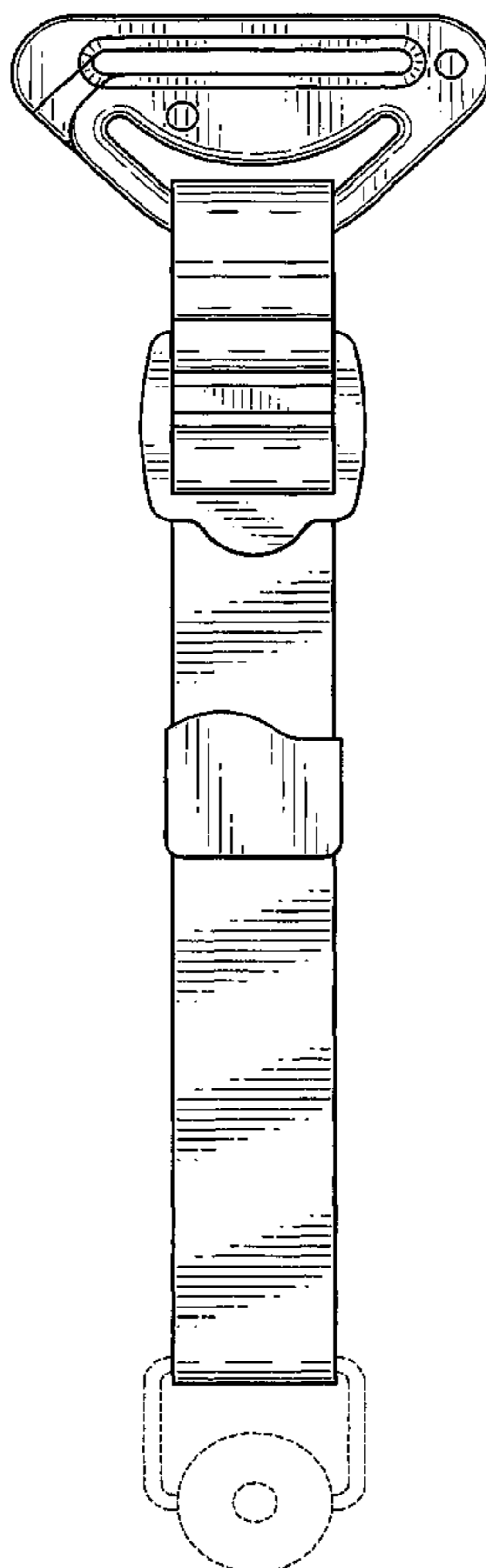
The ornamental design for a camera strap and connector clip for use with the same, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the camera strap and connector clip for use with the same in accordance with the present design; FIG. 2 is a left side view thereof; FIG. 3 is a right side view thereof; and, FIG. 4 is a rear view thereof.

A camera accessory is shown in broken lines for illustrative purposes only and forms no part of the claimed design.

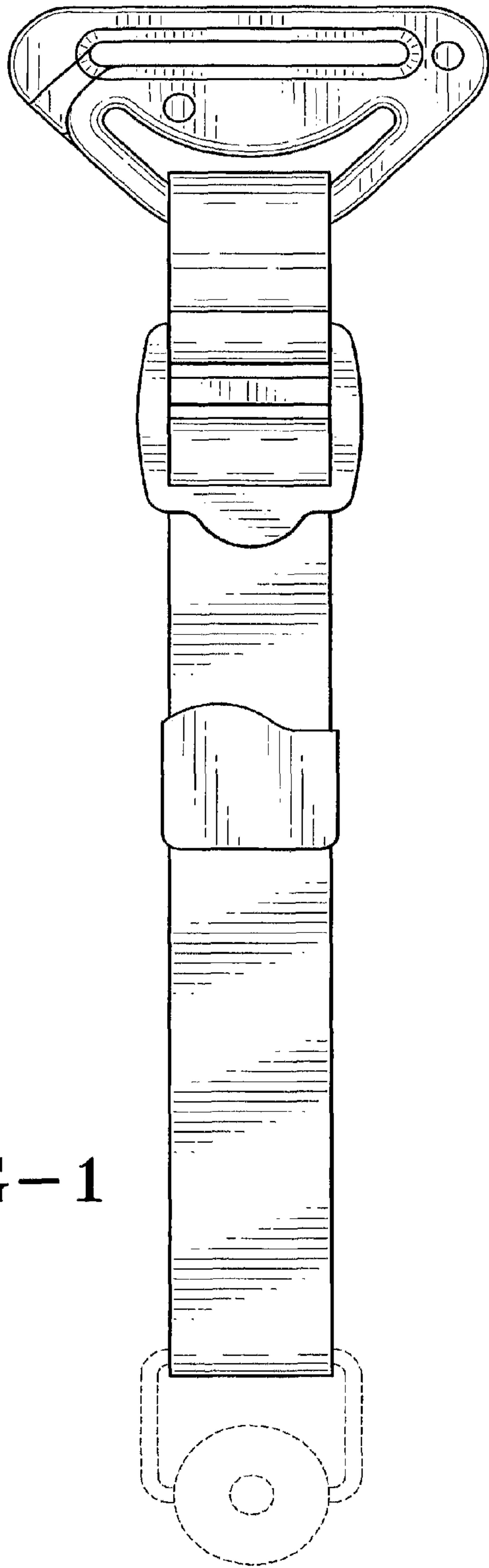

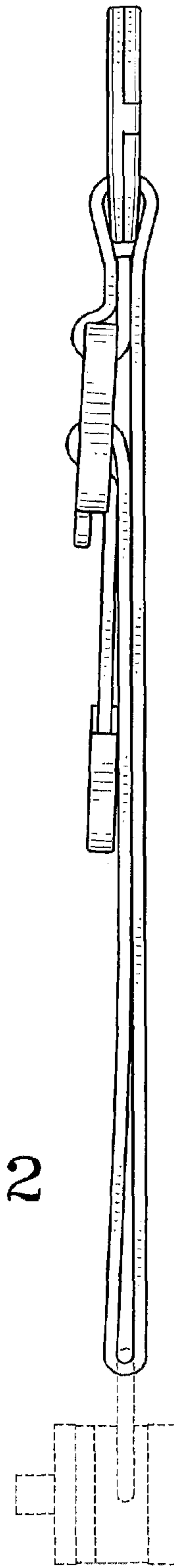
