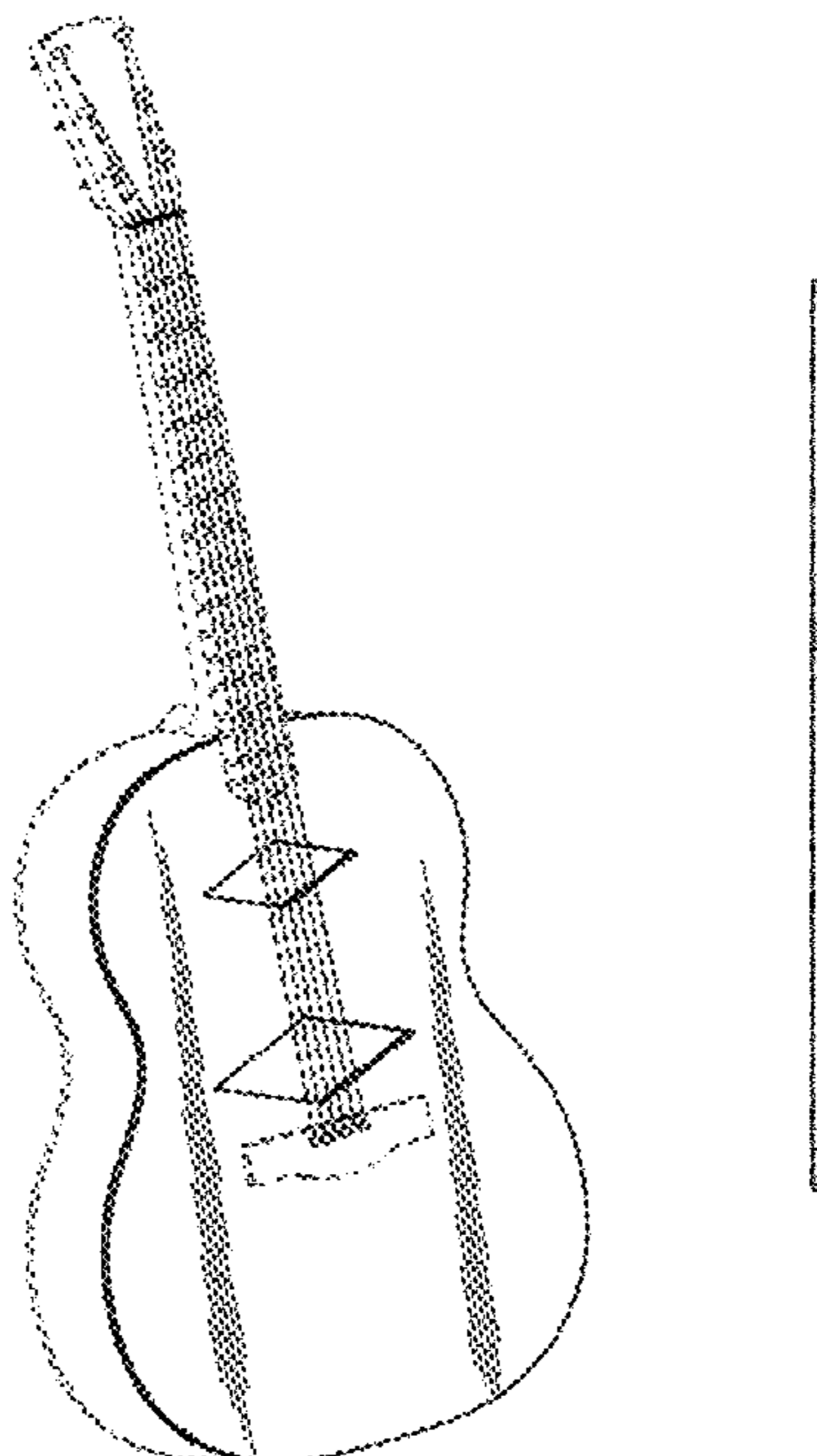
(57) **CLAIM**

I claim the ornamental design for a guitar soundboard, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a guitar soundboard, showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof, the rear elevational view being a mirror image thereof;
FIG. 4 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof; and,
FIG. 5 is a bottom plan view thereof.
The broken lines showing a guitar body, strings and fret board in FIG. 1 depict environmental matter and form no part of the claimed design.

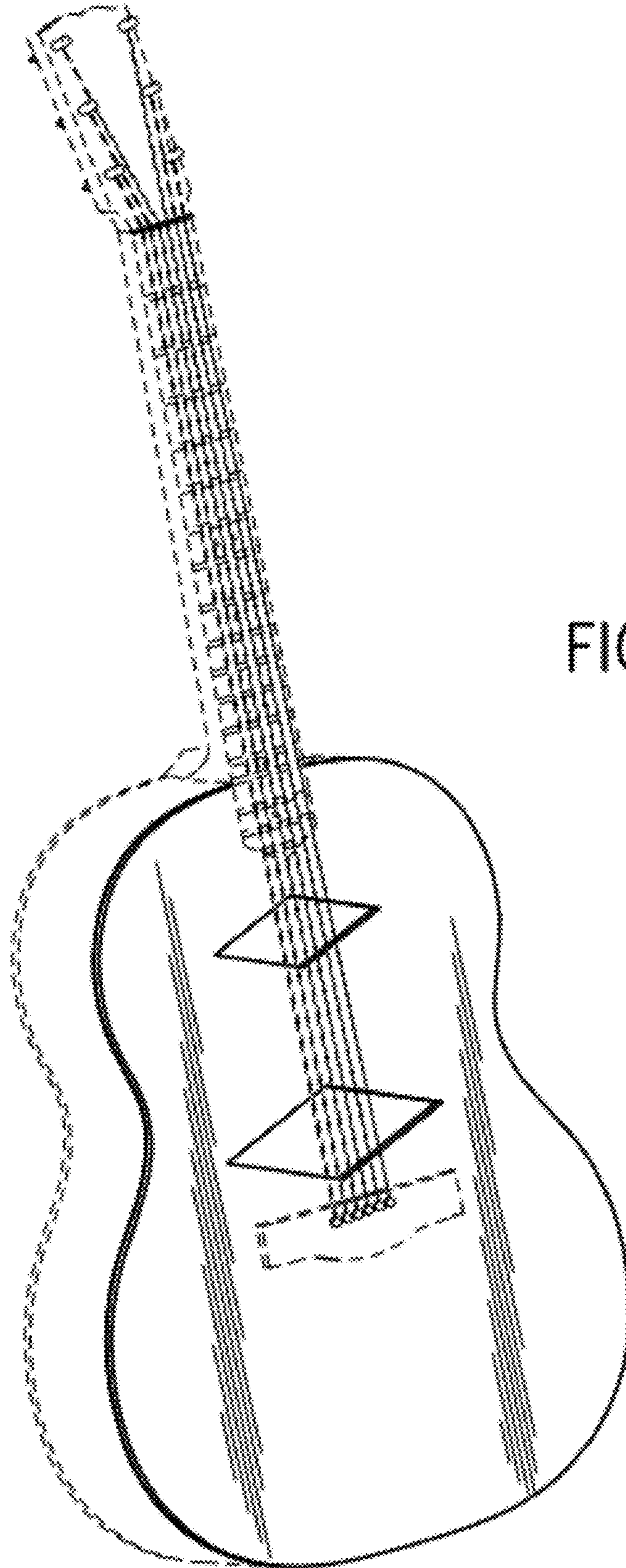

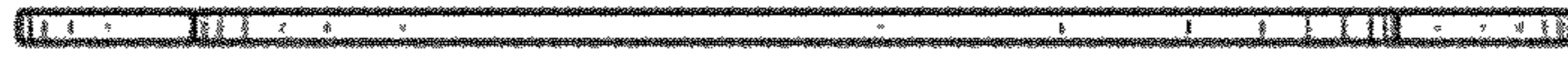

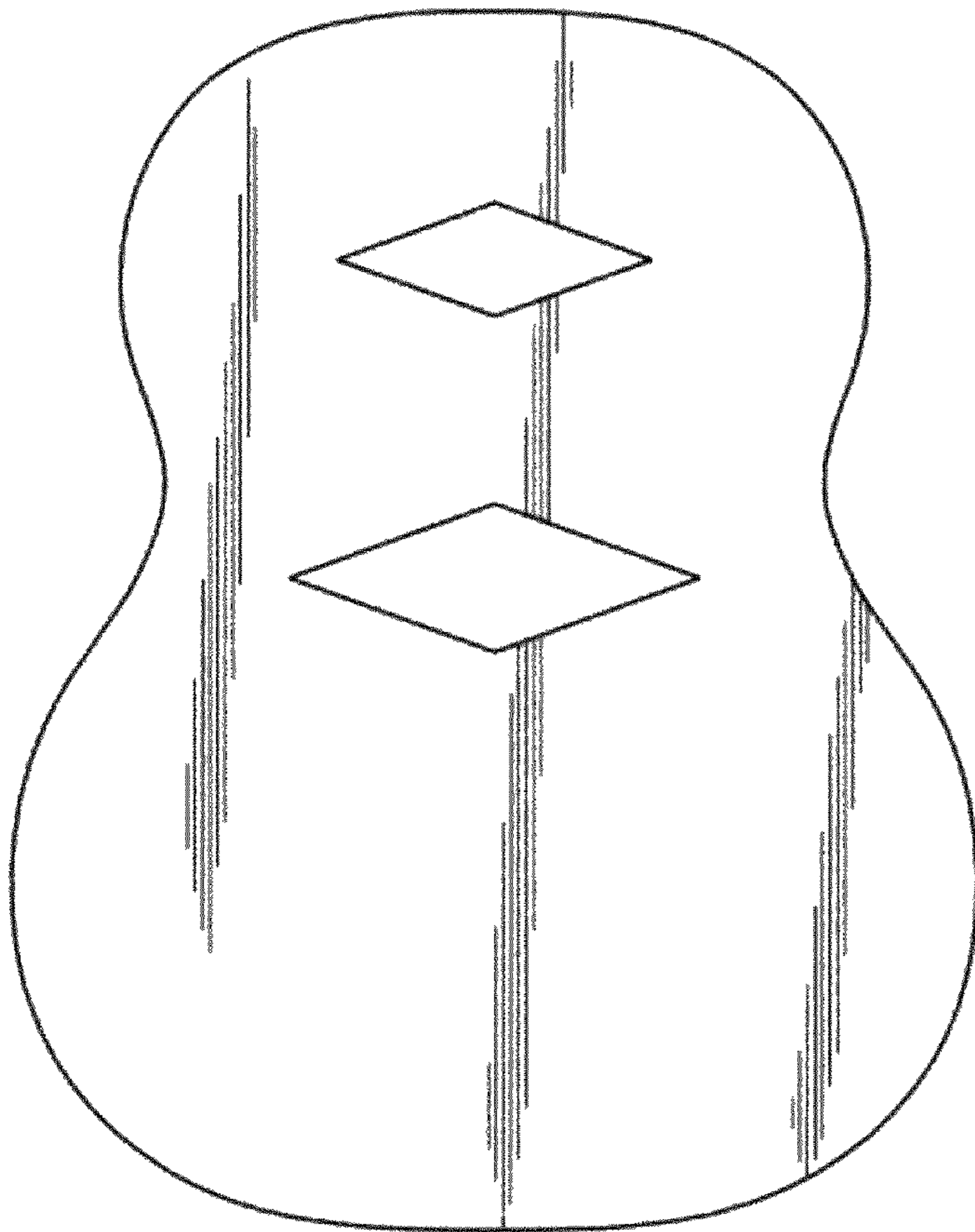
