The ornamental design for a set of pocketed sheets, as shown and described.

**DESCRIPTION**

FIG. 1 is an exploded perspective view of a set of pocketed sheets showing my new design;

FIG. 2 is an enlarged front elevational view of a first sheet thereof;

FIG. 3 is a top plan view of FIG. 2, the bottom plan view being a mirror image thereof;

FIG. 4 is a bottom plan view of FIG. 2;

FIG. 5 is a left-side elevational view of FIG. 2;

FIG. 6 is a right-side elevational view of FIG. 2;

FIG. 7 is an enlarged front elevational view of a second sheet thereof;

FIG. 8 is a top plan view of FIG. 7, the bottom plan view being a mirror image thereof;

FIG. 9 is a bottom plan view of FIG. 7;

FIG. 10 is a left-side elevational view of FIG. 7;

FIG. 11 is a right-side elevational view of FIG. 7;

FIG. 12 is an enlarged front elevational view of a third sheet thereof;

FIG. 13 is a top plan view of FIG. 12, the bottom plan view being a mirror image thereof;

FIG. 14 is a bottom plan view of FIG. 12;

FIG. 15 is a left-side elevational view of FIG. 12;

FIG. 16 is a right-side elevational view of FIG. 12;

FIG. 17 is an enlarged front elevational view of a fourth sheet thereof;

FIG. 18 is a top plan view of FIG. 17, the bottom plan view being a mirror image thereof;

FIG. 19 is a bottom plan view of FIG. 17;

FIG. 20 is a left-side elevational view of FIG. 17;

FIG. 21 is a right-side elevational view of FIG. 17;

FIG. 22 is an enlarged front elevational view of a fifth sheet thereof;

FIG. 23 is a top plan view of FIG. 22, the bottom plan view being a mirror image thereof;

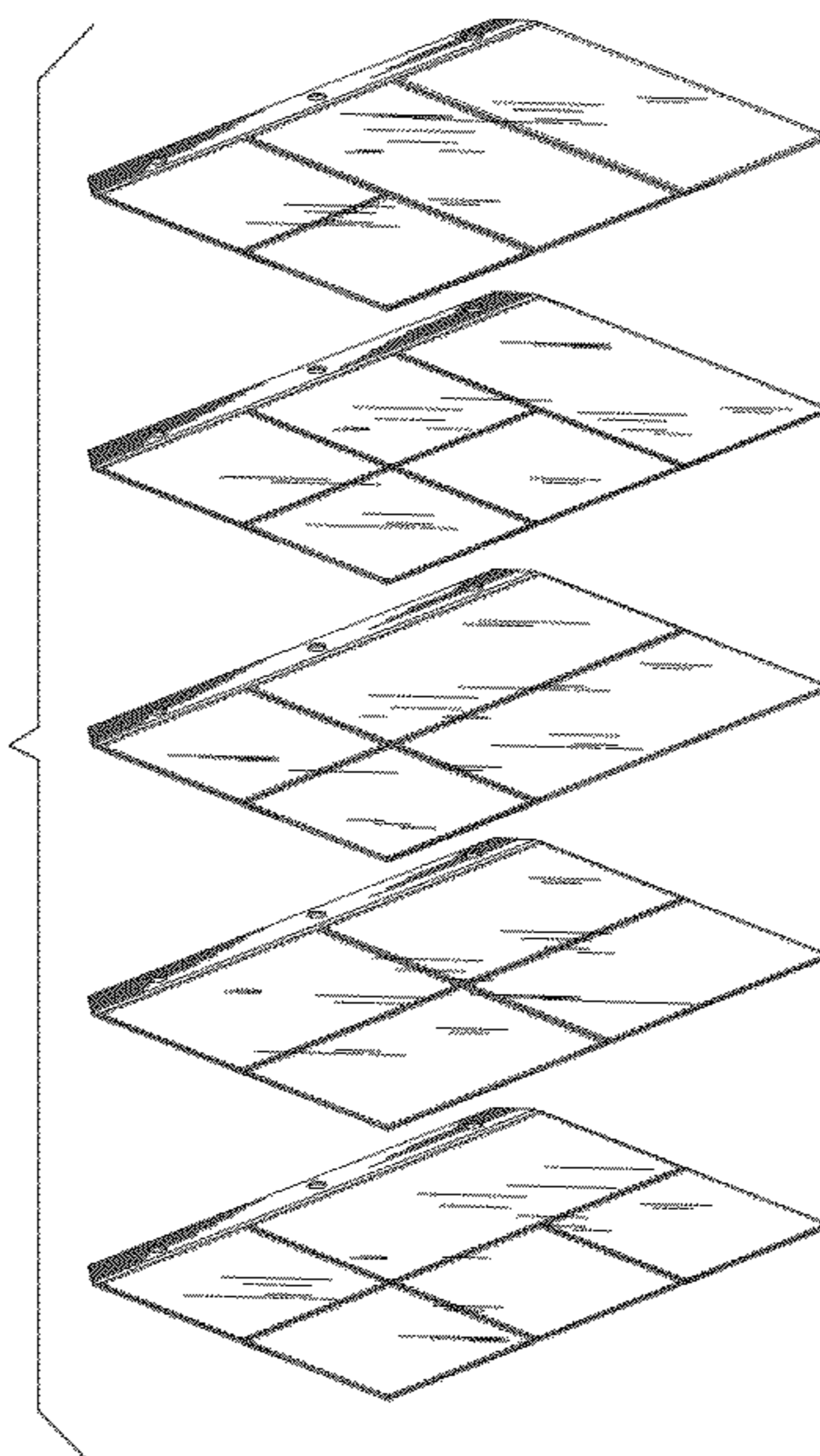
FIG. 24 is a bottom plan view of FIG. 22;

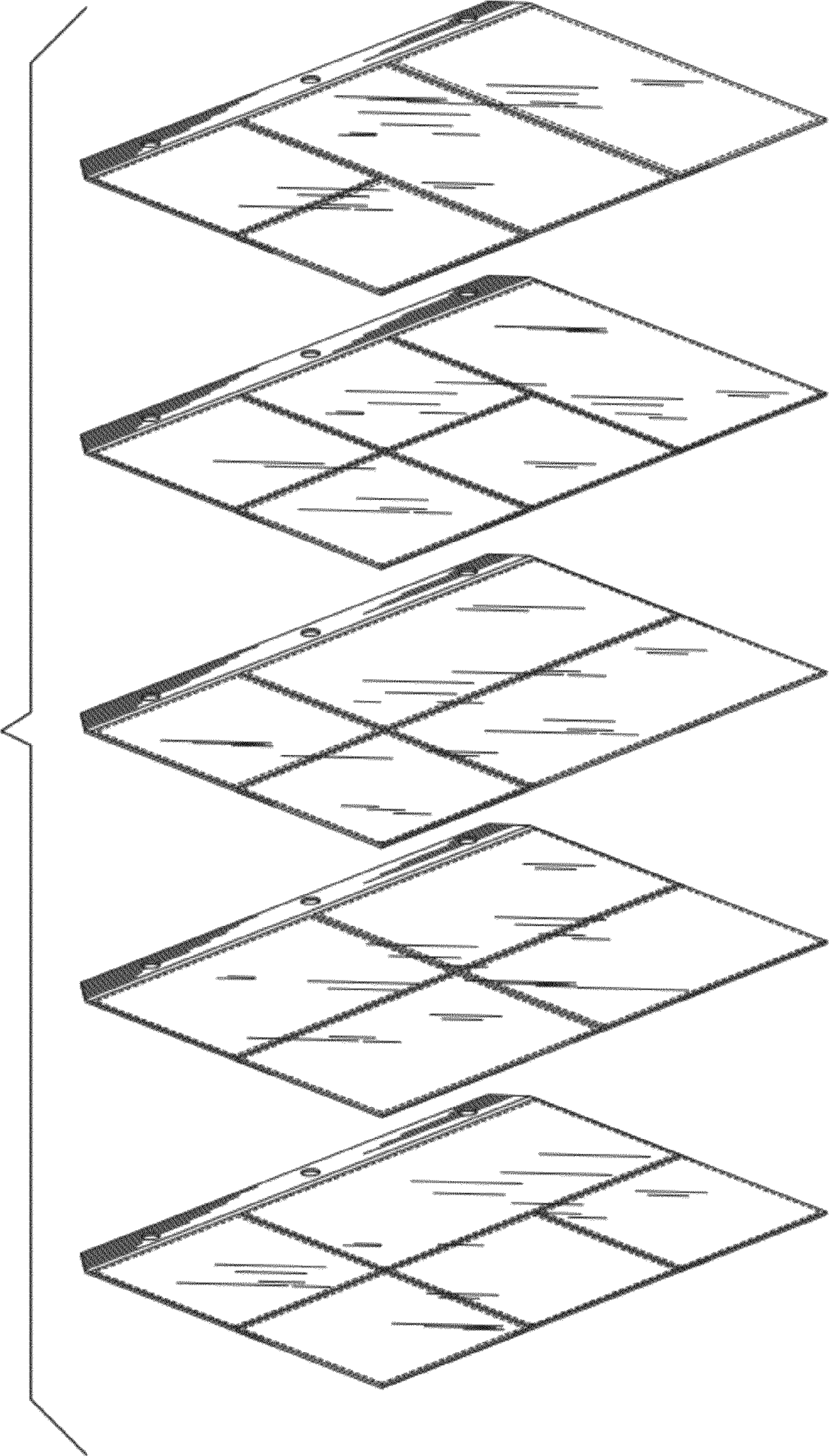

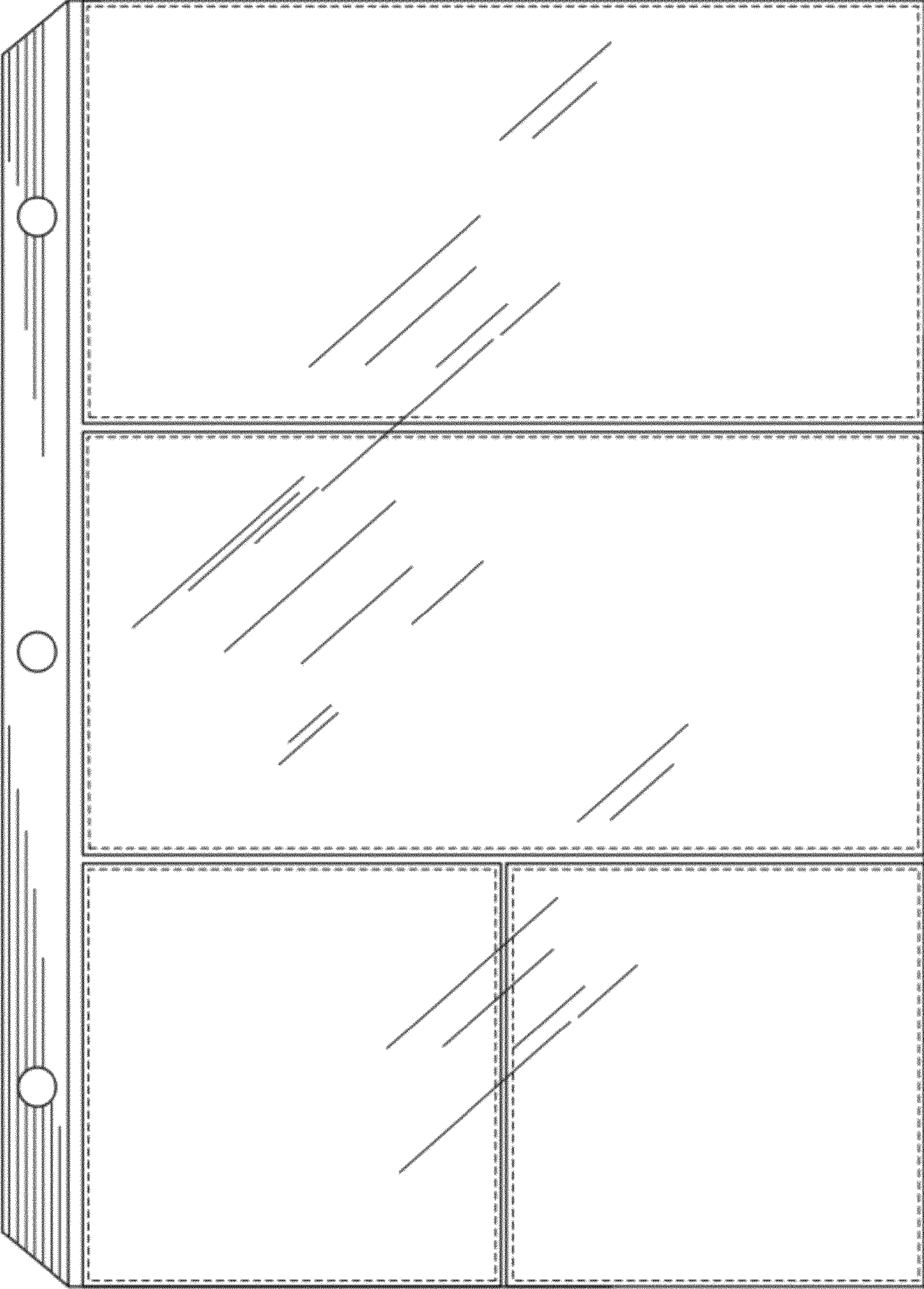

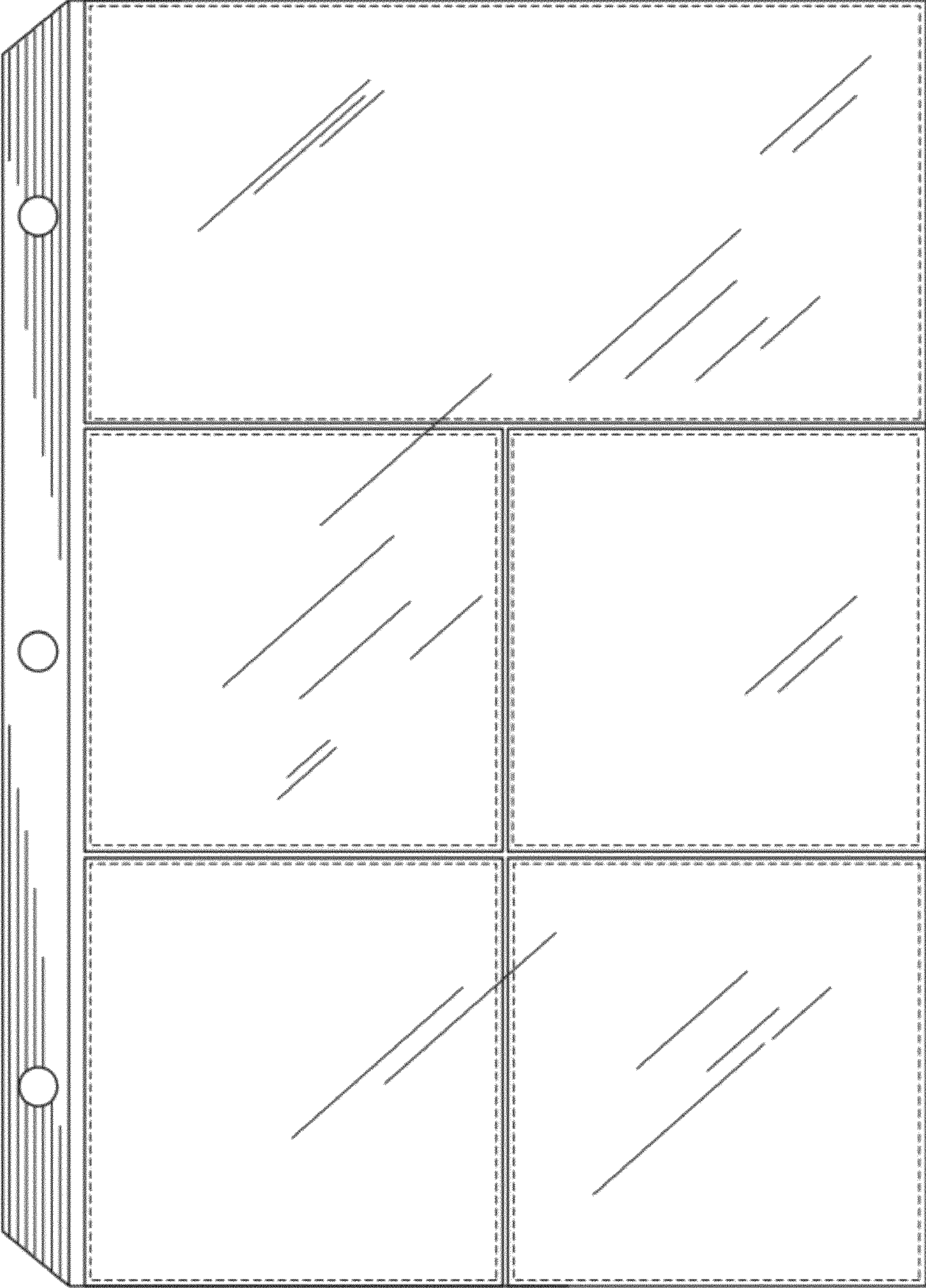

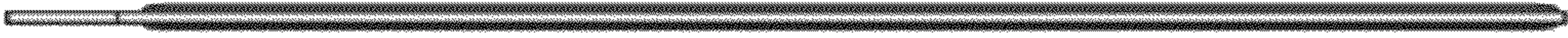

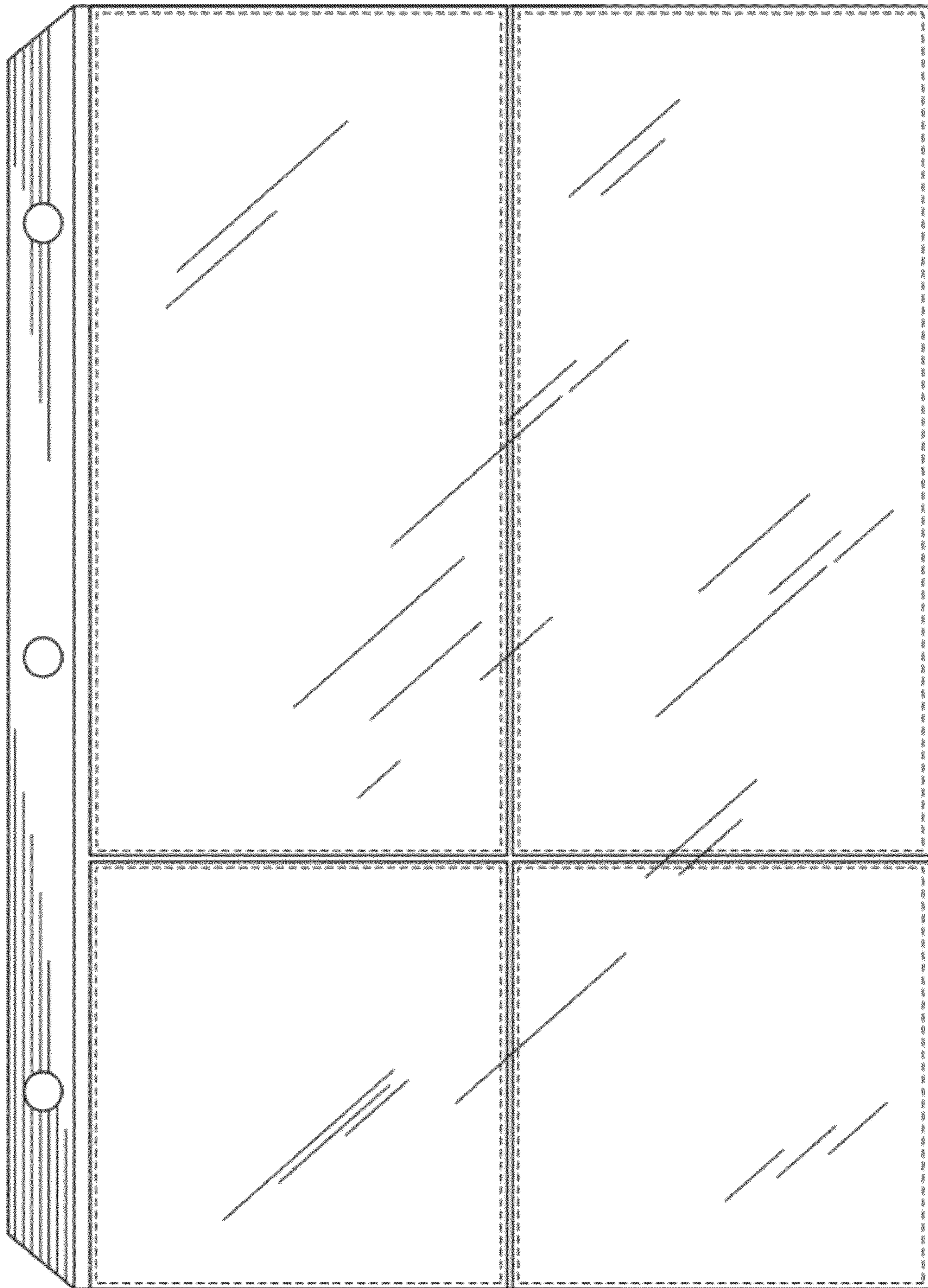

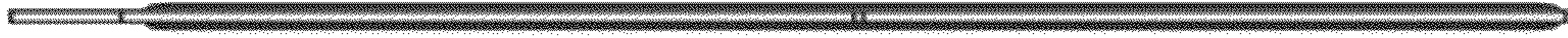

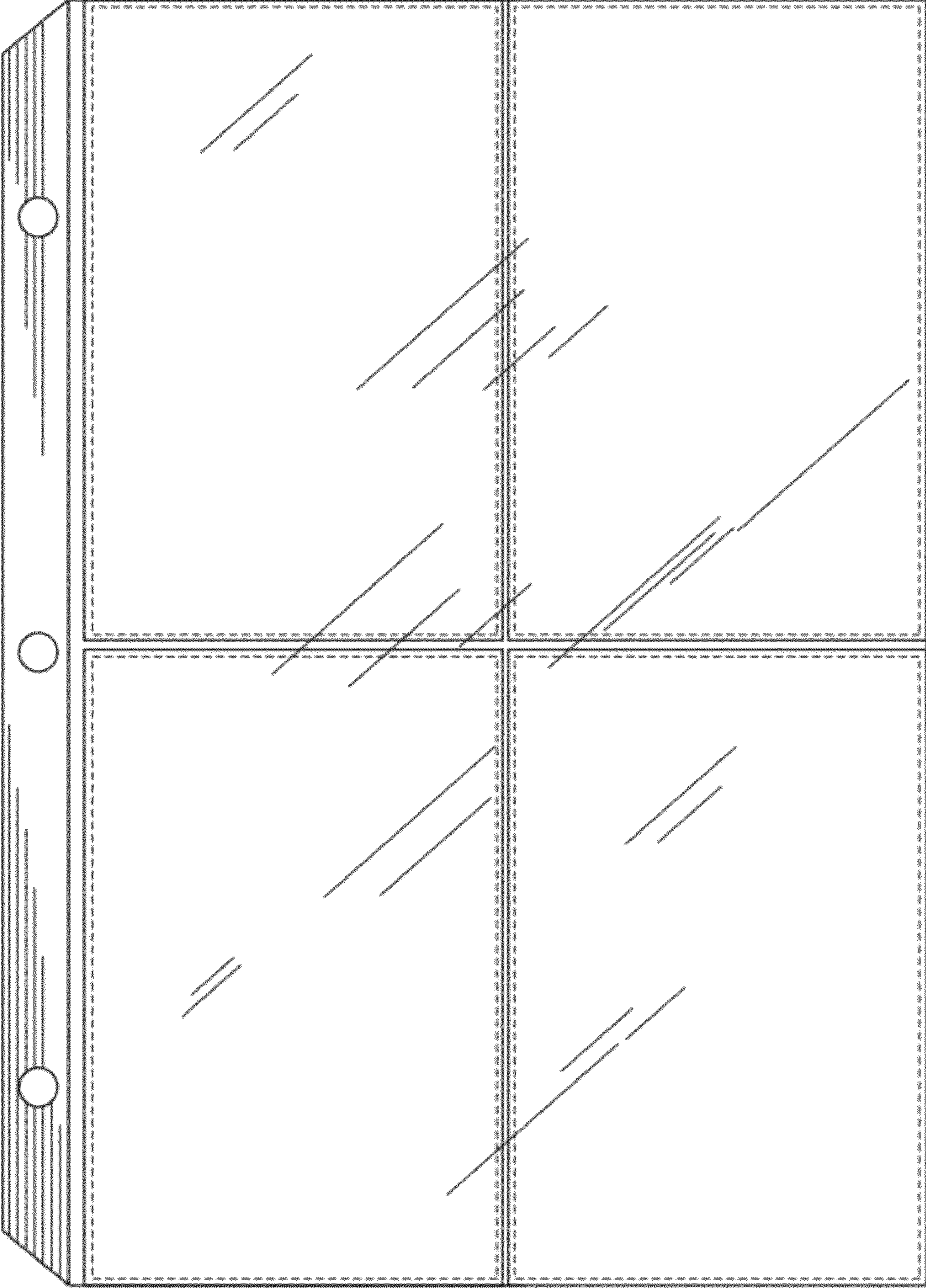

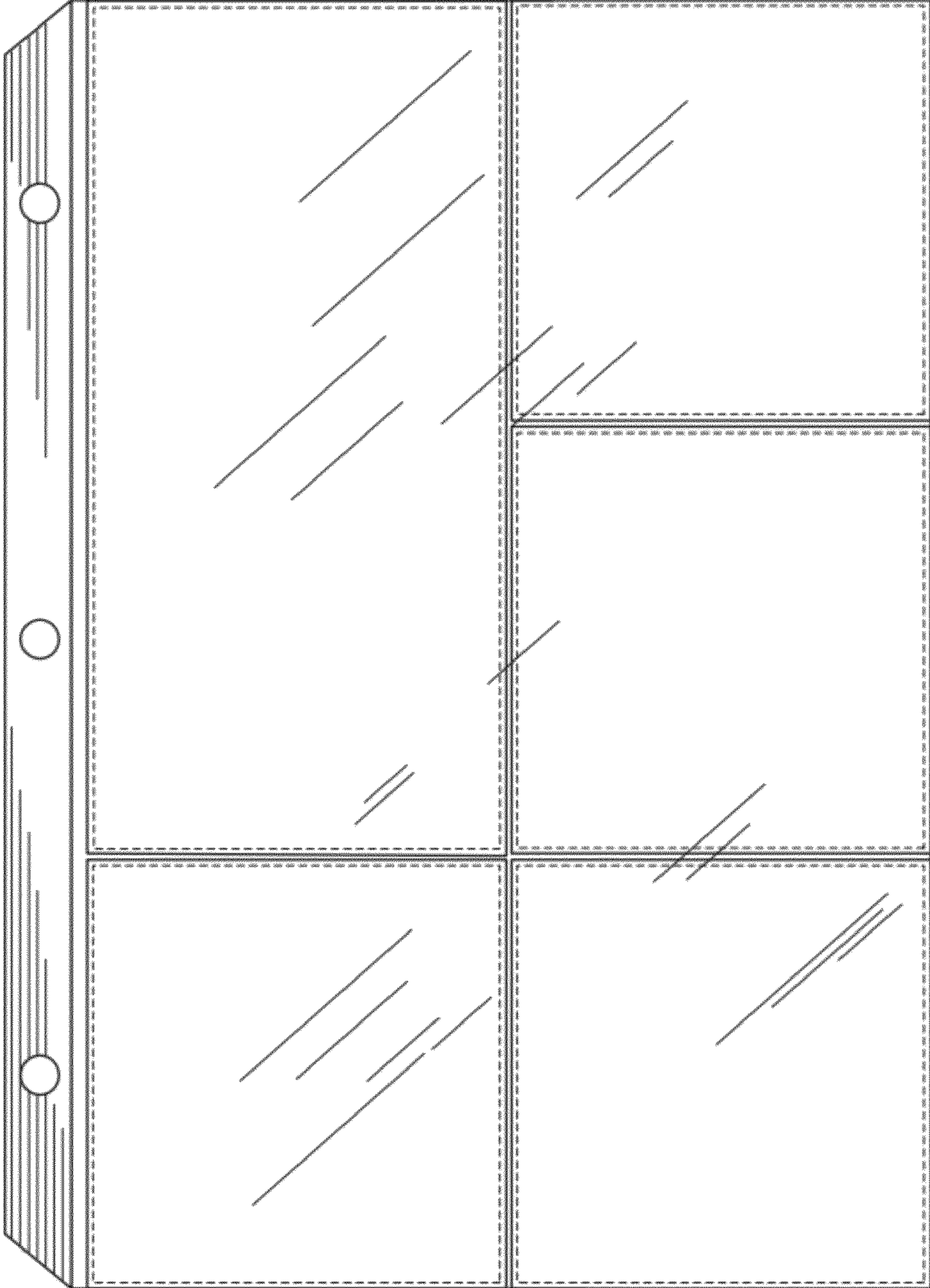
