(57) **CLAIM**

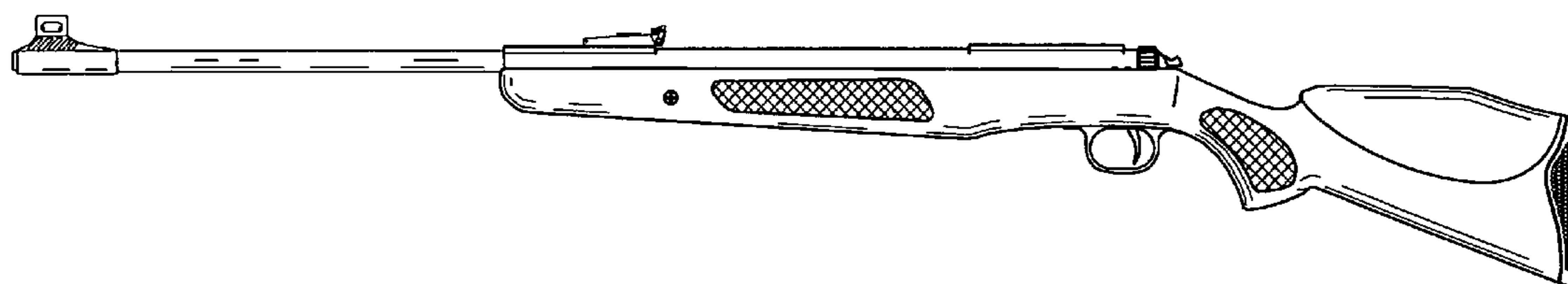
The ornamental design for an air rifle, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevation view of the air rifle, showing my new design;
FIG. 2 is a left side elevation view of the air rifle;
FIG. 3 is a top plan view of the air rifle;
FIG. 4 is a bottom plan view of the air rifle;
FIG. 5 is a front elevation view of the air rifle; and,
FIG. 6 is a rear view of the air rifle.

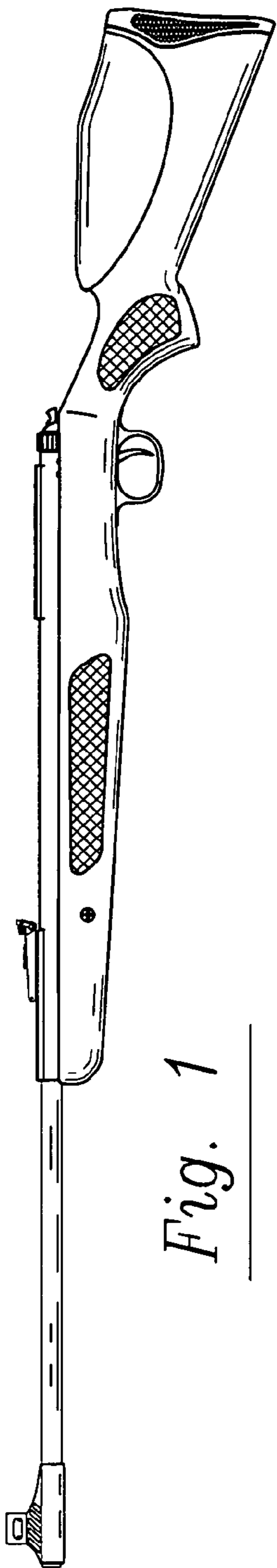

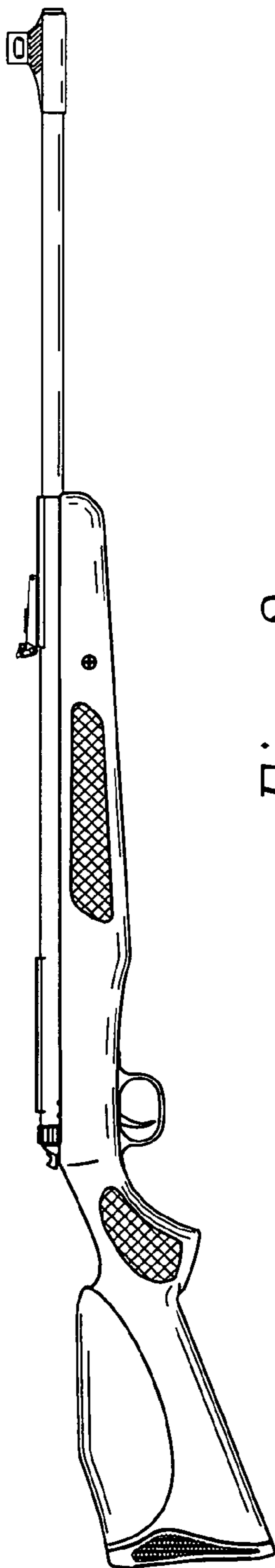

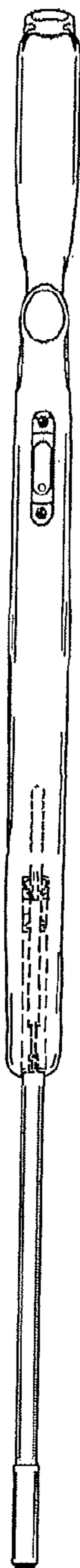

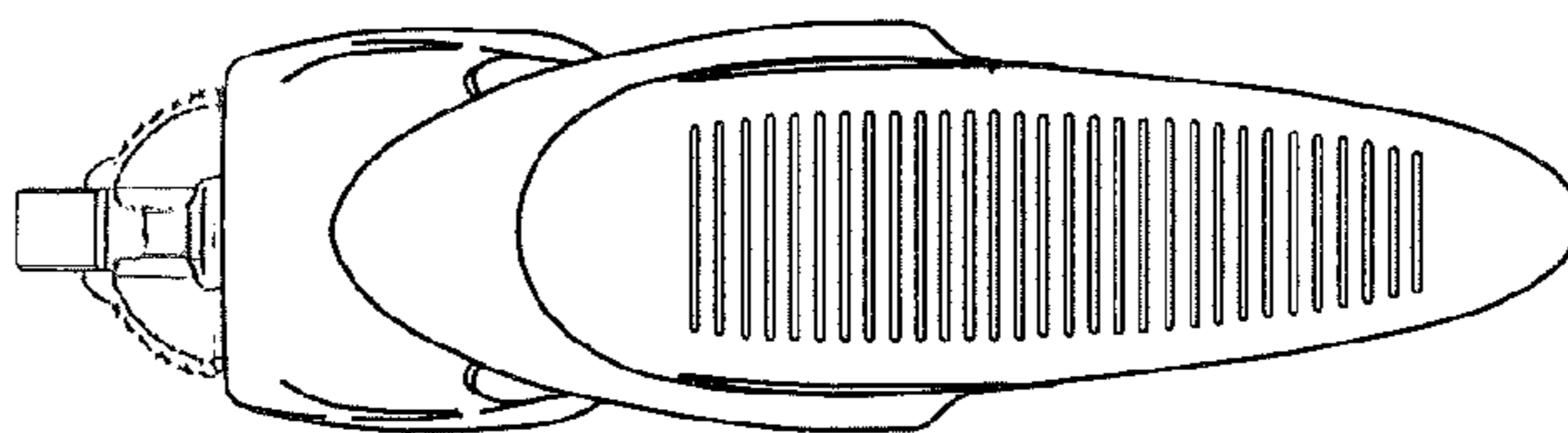

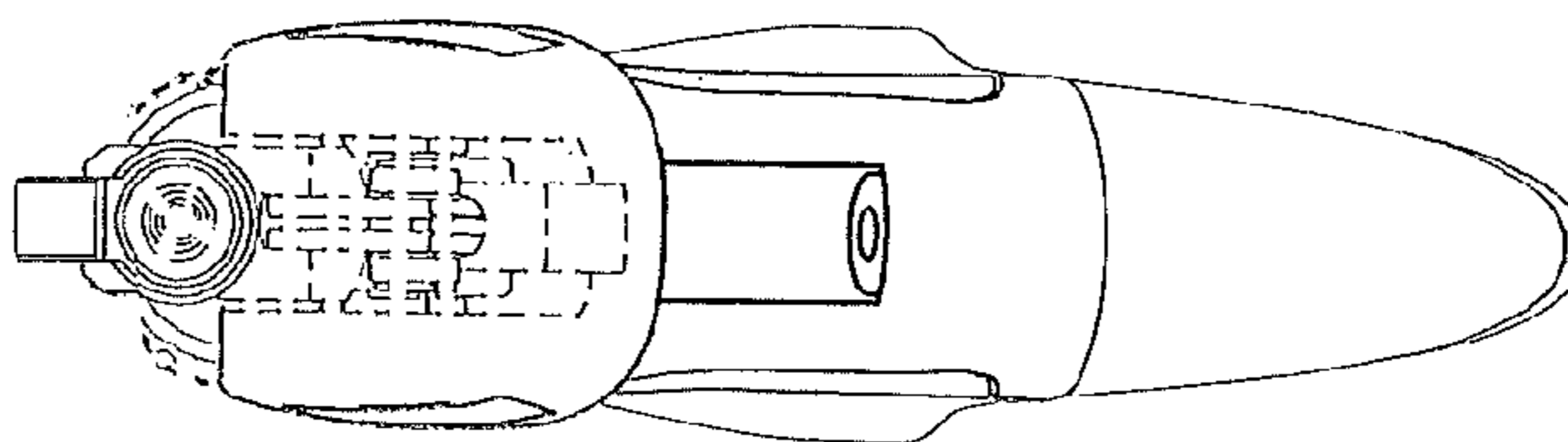
